### **Chandrababu Flags Off HNSS Water Flow, Ends** Rayalaseema's Wait

Andhra Pradesh Chief Minister N. Chandrababu Naidu inaugurated the release of water from the Handri-Neeva Sujala Sravanthi (HNSS) Phase-1 main canal on Thursday, marking a major milestone in addressing irrigation and drinking water needs in the Rayalaseema region. The inaugural event was held at the Malyala Pumping Station in Nandikotkur mandal of Nandyal district, where the Chief Minister switched on two motors to commence the pumping of Krishna river water from the Srisailam backwaters.

Ministers Nimmala Ramanaidu, Payyavula Keshav, BC Janardhan Reddy, and MP Baireddy Shabari were present at the ceremony. Sharing his joy on social media, the Chief Minister stated, "It is a moment of immense satisfaction to provide water to Rayalaseema farmers. We've expedited the expansion works of the HNSS main canal, increasing its capacity from 2,200 to 3,850 cusecs. This will bring significant relief to the region."

The Phase-1 expansion, completed in record time, ensures more than 40 TMC of water is now available to tackle drinking and irrigation

needs in Rayalaseema. Water will be pumped from Malyala in Nandyal to Jeedipalli Reservoir in Anantapur district. The project aims to benefit over 6 lakh acres and provide safe drinking water to 33 lakh people across the four Rayalaseema districts.

The Chief Minister also revealed that the state has spent ₹3,890 crore on this project. He praised the efforts of the coalition government for completing the works within 100 days of assuming office, stating it was a significant step toward solving Rayalaseema's long-standing water woes.

Chandrababu emphasized that water brings prosperity. "By delivering water to every acre, we can turn the region into a land of abundance," he said, thanking all officials and stakeholders who contributed to the project's swift completion. Phase-2 works are also planned to commence shortly, he added.

Officials noted that the release of water from HNSS Phase-1 will help fill reservoirs like Gollapalli, Marala, and Cherlopalli, and support water diversion to the Pennar-Ahobilam Balancing Reservoir from Jeedipalli. The project is expected to be a game-changer for Rayalaseema's irrigation and water security landscape.



### **Gandikota** Murder Mystery..

Kadapa: The sensational murder case of an intermediate student at Gandikota in Kadapa district has taken a dramatic twist. What initially appeared to be a mysterious killing is now showing signs of being a possible honour killing, according to emerging leads.

The student, who skipped college to visit the Gandikota tourist spot with her boyfriend Lokesh, was found dead the next morning in the same area. Following this, Lokesh was taken into custody and questioned by the police. According to Lokesh, the girl's relatives allegedly arrived at Gandikota and forcibly took her away. He claims to have returned alone after the incident. However, medical reports suggest that the girl was murdered sometime after midnight — raising serious doubts about the timeline and Lokesh's version. Importantly, forensic reports ruled out sexual assault, confirming that neither Lokesh nor others had committed

any such act.

The murder of Jana Sena Party Kalahasti in-charge Kota Vinutha has taken a new turn, with the victim's close aide Rayudu's younger sister, Keerthana, coming forward seeking

protection and justice. In an emotional plea at the Kalahasti DSP office on Thursday, Keerthana claimed that her family is under serious threat and urged police officials to provide security. Keerthana alleged that they were offered ₹30 lakh to remain si-

lent about her brother Srinivasulu alias Rayudu's death but refused to take it. "They tried to buy our silence. We didn't accept the money. Now our lives are in danger," she told the DSP. She dismissed the rumours circulating on social media about an illicit relationship between her brother and Kota Vinutha, calling them baseless and defamatory. "My brother was not that kind of person. These allegations are false, and we request action against those spreading such lies," she said. In a direct appeal to Jana Sena Party Chief and Deputy Chief Minister Pawan Kalyan, Keerthana questioned his silence on the matter. "Why is Pawan Kalyan not speaking on this issue? He reacts to small matters, but now he's silent. Please give us a chance to meet him and tell the she aptruth," pealed.



### "Rappa Rappa" Controversy...

A fiery dialogue from the upcoming film Pushpa-2 — "Rappa Rappa" has now become the hottest phrase in Andhra Pradesh politics. But it's not being used to discuss development or governance. Instead, it's sparking debate over political rhetoric and the limits of free speech.

During his recent visit to Rentapalla in Palnadu district, former CM Y.S. Jagan Mohan Reddy was seen endorsing a placard carried by a supporter that read: "Rappa Rappa narukutham" (we'll hack them down). Cases were reportedly filed against the supporter. But what raised eyebrows

further was Jagan himself later using the same phrase in two or three public interactions.

In a press conference held Wednesday, Jagan gave a strong warning to the TDP and its supporters, reiterating the "Rappa Rappa" line. He questioned why dialogues popular in movies can't be used in real life. "If we like the line in films, why not in reality?" he asked, even questioning why the censor board allows such content if it's problematic elsewhere.

While this line of reasoning may find favor with fans, legal and political analysts caution otherwise.





### **Projects, Not Publicity: Ambati**

Former Minister and senior YSRCP leader Ambati Rambabu came down heavily on Chief Minister N. Chandrababu Naidu, alleging that the ongoing foundation ceremonies for irrigation projects in Rayalaseema are nothing more than political drama. Addressing a public meeting near Lavameshwaram, Ambati said Naidu is making grand announcements without any actual work on the ground.

#### "No Progress in 14 Years"

Ambati questioned why, despite holding power for over a decade, Chandrababu Naidu failed to deliver on critical irrigation needs. He highlighted the contradiction in Naidu's claim to lift water from Lavameshwaram (at 42 TMC level) to Banakacharla (at 41 TMC), calling it technically and practically flawed. "Why did he not even initiate proper groundwork during his previous tenure?" he asked, adding that Naidu is now simply recycling old promises to mislead voters again.

Leaders holding influential positions — especially current or former Chief Ministers — are expected to maintain restraint in public remarks. The Indian Penal Code, and now the Bharatiya Nyaya Sanhita (BNS), 2023, clearly outlines boundaries for speech.

Section 351(2) of the BNS criminalizes threats made with the intent to cause harm or fear. Punishment can include up to seven years of imprisonment, a fine, or both. Additionally, Section 152 addresses incitement of violence that disrupts peace or national integrity, making such statements even more serious.

So while the dialogue may light up the screen, using it in real-life political discourse — especially with a violent undertone — is legally and ethically problematic. Analysts argue that all leaders, whether from YSRCP, TDP, or Jana Sena, must think before they speak.

Many netizens felt that instead of defending the "Rappa Rappa" line, Jagan could have condemned it — setting a more responsible example for political conduct.

#### Real Estate Over Rayalaseema?

Ambati accused the TDP government of giving priority to Amaravati real estate while neglecting key backward regions like Yalamanchili. "Naidu's focus is not on resolving drinking water issues or lift irrigation but on staging events and promoting hype," he said. He also questioned the rationale behind planning a massive Rs 1.6 lakh crore project when feasibility studies indicate the current lift requirement is just Rs 0.9 lakh crore.

#### Selective Silence on Dalit Atrocities

Taking a sharp dig at the CM's selective outrage, Ambati asked why Naidu remains silent on SC/ST atrocities, Dalit murders, and the Guntur rape incident. He accused the TDP of ignoring social justice and failing to provide protection to the marginalised.

#### Public Must Remain Alert

Ambati warned the public not to fall for Naidu's "foundation-stone theatrics." He alleged that the CM is reappearing before elections with staged events and false claims. "People should demand real progress, not just stage shows," he said, urging voters to question the TDP's track record and seek genuine solutions.

This adds further weight to the theory that the girl was not killed immediately after reaching Gandikota, but later — possibly after being confronted by family.

Kadapa SP Ashok Kumar confirmed that police are now actively investigating the case under the angle of honour killing. He also said that crucial evidence, including the girl being found partially undressed in the bushes, is being thoroughly examined. Key forensic clues have been collected, and further details will be released soon.

Despite the intensified investigation, the case remains unsolved since the incident on July 14. Lack of solid evidence has forced the police to revisit the crime scene. SP Ashok Kumar has been stationed in Jammalamadugu for three days, leading the probe.

Police have started re-interrogating all suspects from the beginning. Technical teams are scanning CCTV footage from the area again. Though officials hinted at a breakthrough on Wednesday, confirmation is still pending. Lokesh is being questioned again, and guest house owners at Gandikota who rent private rooms are also under the scanner.

# Home Minister Anitha Lays Foundation for Police Academy

Krishna District: The foundation stone for Andhra Pradesh's most advanced police training centre was ceremoniously laid in Krishna district thursday. State Home Minister Vangalapudi Anitha inaugurated the event, marking a significant milestone for the state's police infrastructure. The facility is coming up across 46 acres of land, aimed at becoming a model training hub.

The ceremony witnessed the participation of Excise Minister Kollu Ravindra, APSRTC Chairman Konakalla Narayana, Government Whip and Gannavaram MLA Yarlagadda Venkatarao, Eluru Range IGP GVG Ashok Kumar (IPS), Krishna SP R. Gangadhara Rao (IPS), MLAS Venigandla Ramu, Varla Ku-

mar Raja, Muda Chairman Matta Prasad, AP Warehousing Corporation Chairman Ravi Venkateswara Rao, and other public representatives and officials.

Home Minister Anitha said that Krishna district, known for its cultural legacy, will now host a state-of-the-art training centre that not only focuses on general police training but also prepares officers to tackle rising cybercrime. The new centre replaces the old one taken over for port development and will set a benchmark in training quality.

She added that under the TDP-led government's focus on public safety, 1 lakh CCTV cameras have been installed across the state. Advanced technologies such as drone surveillance are being used to monitor public spaces and prevent

crimes like drug use and harassment.

Excise Minister Kollu Ravindra highlighted the need to strengthen marine policing to prevent smuggling along coastal areas. He stressed on providing separate training facilities for men and women.

IGP Ashok Kumar praised the initiative, stating it would bridge the gap in quality training infrastructure. He confirmed that the new facility will include latest surveillance tools and cybercrime investigation modules.

SP R. Gangadhara Rao said the centre will regularly conduct physical and mental skill development sessions to motivate personnel. He affirmed that construction works will proceed swiftly to make the centre operational at the earliest.

Keerthana also said there is suspicion among locals about a possible role of the MLA in the case, though she did not name anyone specifically. "We don't know for sure, but people are talking," she added.

She stated that when they went to lodge a complaint, the police insisted on specific details before accepting it. "They told us they'll register it only if we provide names. We want justice, but we also need protection to come forward," she said.

With the case drawing political and public attention, her emotional plea is expected to raise more questions about the handling of the investigation and the silence of key political figures.



# Govt Appoints Chairmen for 66 AMCs Across AP

The Andhra Pradesh coalition government has taken a significant step in revamping the state's agricultural market administration by finalizing the appointment of chairmen to 66 Agricultural Market Committees (AMCs). The move is seen as part of the government's broader strategy to ensure effective leadership in rural agri-marketing and improve services for farmers.

Of the total appointments, the Telugu Desam Party (TDP) secured the lion's share with 53 chairman posts, followed by Janasena Party with 9 and the Bharatiya Janata Party (BJP) with 4. The appointments were reportedly made in alignment with coalition strength and seat-sharing arrangements. The government also ensured fair representation of various social groups in the process. A total of 17 chairmen belong to Backward Classes (BCs), 10 from Scheduled Castes (SC), five from Scheduled Tribes (ST), and another five from minority communities. Officials said the decision was made keeping social balance and regional representation in mind.

The coalition government stated that these appointments will help strengthen agricultural market operations across different parts of the state and provide an opportunity for grassroots leadership. By empowering these committees, the government hopes to enhance transparency, efficiency, and farmer-centric functioning in the agricultural sector.

### **Coalition Harassing Employees: YSRCP**

### Don't Seize Phones and Gadgets for Social Media Posts: SC

The Supreme Court on Wednesday came down heavily on the Special Investigation Team (SIT) for seizing the phone and electronic gadgets of Haryana-based Professor Alikhan Mahmudabad, stating that such actions are unnecessary when the case is related only to his social media posts.

Expressing displeasure, the apex court asked, "Why have you taken his devices when the investigation is about what he posted online? All

you have to do is examine his posts—the language used, the manner of expression, and whether anything amounts to an offence under the FIR."

The SIT had earlier seized Professor Alikhan's electronic devices and sent them for forensic examination. However, the court found this action unjustified. "You don't need his phone or gadgets to investigate social media content that's already in the public domain," the bench remarked, adding that the SIT must explain the reason behind confis-



cating his personal devices. The court emphasized that investigations should focus on the alleged content of the posts, not on unnecessary intrusion into personal data. "We want to know what purpose was served by taking away his gadgets," the bench said, warning against overreach.

The strong remarks come amid growing debate over the use of investigative powers in online speech cases. The Supreme Court's intervention highlights the need to balance law enforcement with respect for individual privacy and digital

#### Jagan's Psychos **Golden Chance for Plotting Chaos in AP: Buddha Venkanna**

Vijayawada: TDP leader Buddha Venkanna launched a scathing attack on YSRCP leaders, accusing them of plotting unrest in Andhra Pradesh under Jagan Mohan Reddy's direction. Addressing media in Vijayawada, he alleged that Jagan is in constant contact with "psycho leaders" from Krishna district — Perni Nani, Kodali Nani, Vallabhaneni Vamsi, and Jogi Ramesh — to provoke violence across the state.

He stated that due to Chandrababu Naidu's efforts, many investors are regaining trust in AP and are willing to set up industries. "But YSRCP's cheap politics and conspiracies are threatening the law-and-order environment, which could drive away these investors," he warned.

Venkanna strongly criticized Perni Nani, calling him "a disloyal dog," and questioned his moral right to speak about others. "Weren't you the one who once praised Chandrababu for protecting your wife? Now you shamelessly attack him on Jagan's orders," he said.

He accused YSRCP leaders of looting crores through illegal commissions and extortion from the public. He warned them against using derogatory language against Chandrababu or Lokesh, saying TDP cadres are ready to confront any such insult with equal intensity.

"Calling Chandrababu an old man won't hide your incompetence. Do any of you have the guts to work like him?" he asked. He also questioned Jagan's fake concern for BCs, highlighting the silence after attacks on BC leaders like himself and the murder of Chandrayya.

Venkanna concluded by warning that any move to disrupt peace or block investments will not be tolerated. "If Jagan and his gang continue this path, we are ready to give a fitting reply — both legally and politically," he said.

### **Millers to Supply 10% Broken Rice: Nadendla**

Vijayawada: Civil Supplies Minister Nadendla Manohar has urged rice millers in Andhra Pradesh to seize the golden opportunity of supplying Custom Milled Rice (CMR) with up to 10% broken rice to the Food Corporation of India (FCI) under a central scheme.

In a high-level meeting with rice millers' representatives held at the Civil Supplies Bhavan in Kanuru, Vijayawada, the Minister announced that the pilot project conducted in East Godavari, West Godavari, Eluru, and Konaseema districts was a success, with 10,000 metric tonnes of paddy procured in line with central norms.

The Centre has decided to procure 50 lakh metric tonnes of rice from five states — Andhra Pradesh, Haryana, Punjab, Chhattisgarh, and Odisha — permitting up to 10% broken rice. Minister Manohar appealed to Andhra Pradesh millers to formally submit their proposals expressing readiness to participate in this opportunity.

He emphasized the importance of competing with other states and showcasing "Brand Andhra Pradesh" through quality and timely delivery. Millers were advised to ensure that the broken rice percentage does not exceed 10% and to follow all necessary testing, packing, and transport norms as per FCI requirements.

The Minister instructed that preparations be completed well in advance and the rice be supplied within stipulated deadlines to avoid any delays. Timely, quality supply to the Centre would not only boost the state's reputation but also create more avenues for future procurement contracts. The Civil Supplies Department stressed coordinated efforts between officials and rice millers to ensure a smooth supply chain.

The meeting was attended by Civil Supplies Corporation Commissioner Saurabh Gaur IAS, Managing Director Manaveer Jelani IAS, senior officials, and rice miller representatives.

#### Minister **Parthasaradhi Slams Jagan for Misleading** on Welfare Schemes

Bapatla District In-charge Minister Kolusu Parthasaradhi strongly condemned YSRCP chief Y.S. Jagan Mohan Reddy's remarks against the ruling coalition, accusing him of launching a false campaign against the government's developmental and welfare

Speaking at a wide-ranging meeting of coalition leaders and party workers in Chirala, the Minister said Jagan's statements are baseless and aimed at misleading the public. The event saw the participation of Bapatla MP Tanneti Krishna Prasad and Chirala MLA Kondayya, along with a large gathering of alliance cadre.

The Minister stated that after five years of "destructive, corrupt, and misgoverned" rule under the YSRCP, the new coalition government led by Chief Minister N. Chandrababu Naidu is committed to putting the state back on the path of progress. He accused Jagan of deliberately creating unrest and fear among the people by spreading misinformation.

#### Banakacharla Will Push AP into Darkness: BCY Chief

BCY party chief Bode Ramachandra Yadav launched a scathing attack on Chandrababu Naidu, accusing him of promoting the ₹82,000 crore Banakacharla project for kickbacks rather than public benefit. Speaking at a BC community meeting in Ravulapalem, Yadav questioned the urgency behind Banakacharla when several major projects like Polavaram, Veligonda, Galeru-Nagari, and Handri-Neeva remain incomplete.

Yadav warned that the Banakacharla project would push Andhra Pradesh into darkness, requiring 4,100 MW of power for lift irrigation — equivalent to four Polavaram-scale plants. He asked how Naidu plans to arrange such power when the state already faces electricity shortages.

He also slammed the coalition government for failing all sections in its first year and ridiculed Y.S. Jagan Mohan Reddy for avoiding real issues as opposition leader. "Instead of questioning governance failures, Jagan is busy with movie dialogues," he said.

Yadav demanded clarity on the promised BC Protection Law, warning of intensified protests if legislation isn't introduced within a month. "If coalition leaders and BC ministers remain silent, we'll show what BCs are capable of," he warned, adding that both TDP and YSRCP have failed to protect people's interests.



### Stop Banakacharla, Save **Polavaram: Sharmila**

Rajahmundry: Andhra Pradesh Congress Committee (APCC) President YS Sharmila launched a scathing attack on the state's coalition government, accusing Chief Minister Chandrababu Naidu of prioritizing the Banakacharla link project over the crucial Polavaram project for vested interests and kickbacks.

Speaking to the media, Sharmila said, "Are they trying to bury Polavaram and push Banakacharla just for corruption? Everyone—engineers, experts, even the Polavaram Project Authority—opposes the Banakacharla link, yet the CM is obsessed with it." She said there's no clarity on which water source is being tapped for the link and demanded transparency.

Sharmila accused both TDP and YSRCP of failing the people. "For five years, Jagan Mohan Reddy ignored Polavaram, and in 2022, his government reduced the dam height to 41.15 meters. Now he cries foul? This is pure hypocrisy," she said. She questioned why, despite being YSR's son, Jagan couldn't move even a handful of soil on the iconic Polavaram project.

Citing data, Sharmila claimed that nearly 39 irrigation projects launched under YSR's Jalayagnam are pending. "If ₹40,000 crore is allocated, we can irrigate 50 lakh acres and provide drinking water to a crore people," she added. She demanded that Banakacharla plans be immediately scrapped and the Polavaram project be executed as per the original DPR at a height of 45.7 meters. "Stop misleading people with new projects when older ones are still incomplete," she warned. Calling Jagan a "foster son of BJP," she accused him of mortgaging Andhra's interests to PM Modi. "This coalition has no sincerity. They're playing politics over water," Sharmila concluded, demanding immediate funding and completion of the Jalayagnam projects, starting with Polavaram.

### Minister Satya Kumar Orders Crackdown on Food, Drug Adulteration

Amaravati: Andhra Pradesh Health Minister Satya Kumar Yadav directed immediate strengthening of surveillance mechanisms to curb the supply of adulterated food products and substandard medicines in the state. Reviewing the functioning of key departments under the Health Ministry for over two and a half hours on Thursday at the AP Secretariat in Velagapudi, the Minister emphasized the urgency of filling vacancies in the Institute of Preventive Medicine (IPM) and Drugs Control Administration (DCA).

He noted that these two critical enforcement bodies lacked reg-

ular heads, which has hindered their performance. He instructed the appointment of a Director General-level officer for DCA and the creation of a new Director post for IPM by restructuring vacant sanctioned posts. The Minister stressed the need for routine inspections to create fear among offenders and control adulteration effectively.

He also called for a comprehensive recruitment plan to fill vacant posts across medical services to ensure better public health delivery. Minister Satya Kumar directed officials to expedite hybrid-model Universal Health Insurance implementation, PPP-mode medical colleges, and 100-bed specialty hospitals in every assembly constituency. He reiterated that Chief Minister Chandrababu Naidu's vision includes integrating cutting-edge technologies like Artificial Intelligence and Machine Learning in healthcare delivery.

He instructed that real-time health data collected from the field must be critically evaluated for quality and reliability and steps be taken to enhance their accuracy and usefulness.

#### **MDU** Association **Demands Justice and Compensation**

The Andhra Pradesh MDU Operators Association has strongly condemned the state government's action of removing 9,260 MDU operators, calling it vindictive and baseless. Association State President Kuducheti Kishore and Honorary President Rauthu Suryanarayana addressed a press conference in Vijayawada on Thursday, flanked by other state representatives.

They alleged that Minister Nara Nadendla Manohar's remarks labeling MDU operators as part of a "ration mafia" were deeply insulting and demoralizing. They also expressed distress over TDP chief N. Chandrababu Naidu's critical statements, saying both leaders were targeting them to gain political mileage.

The leaders claimed that over 18,500 families have been affected by the government's move, and accused the coalition of rendering around 3 lakh people jobless after promising 20 lakh jobs. Despite borrowing heavily to sustain livelihoods, operators said the government has failed to respond compassionately.

They demanded immediate alternative employment opportunities, release of pending dues including insurance, mid-day meal balances, and flood relief payments. They also reminded that MDU operators had donated ₹56 lakh during Vijayawada floods. The association has approached the court for justice. Former High Court judge Sravan Kumar will argue the case. Key demands include reimbursement of 90% vehicle subsidy collected over 52 months at ₹3,000 per month, and unpaid salaries for the remaining 20-month contract period.

They also requested the reclassification of vehicles back from mobile canteen status to goods carriers and fitness clearance without penalties.

Representatives from 16 districts including Tirupati, Srikakulam, Palnadu, Kakinada, Visakhapatnam, and others were part of the press meet. Prominent attendees included Chunduru Sambasiva Rao, Satish, Sudhakar Reddy, Venkat Deva, and Purushottam, who all echoed their commitment to continue the legal battle until justice is served.



#### **NCBC Chief Reviews OBC Welfare in AP**

National Commission for Backward Classes (NCBC) Chairman Hansraj Gangaram Ahir emphasized the need for strict implementation of reservations and roster systems for OBCs during his review meetings held in Vijayawada. ## **Bapatla to Expand Aqua Farming: Collector Approves**



TPN | B Madhusudhanarao Bapatla: To promote sustainable aquaculture in Bapatla district, Collector J. Venkata Murali has approved the expansion of aqua farming zones. He chaired the District Level Committee (DLC) meeting at the Collectorate on Thursday to review proposals related to aquaculture development.

The Collector directed fisheries department officials to identify new lands suitable for expanding aqua production beyond the current area. Officials informed that aquaculture is presently practiced on 17,603.80

acres in the district. They also briefed the Collector

that the state government had issued guidelines to re-survey eligible aqua zones, especially in non-notified regions. Based on those directions, a re-survey was conducted in the district. The department reported that 3,067.16 acres are currently unsuitable for aqua farming, while 3,361.14 acres have potential for future expansion.

The Collector enquired into the land classifications and confirmed that the proposed aqua zones comprise only pat-

### **Family of Four Jumps into** Well: Two Dead, One Critical

Tirupati: A major tragedy struck Maddi Nayanapalli village of Pakala mandal, Chandragiri constituency, as a family of four allegedly attempted suicide by jumping into a well near Kommi Reddigari Palli road. The victims belong to Peda Harijanawada village.

According to locals and police, mother Hemalatha and younger daughter Tejasri were found dead and recovered from the well. Father Giri, found alive but in critical condition, was shifted to the hospital in a 108 ambulance. The elder daughter, Tanushri, is still missing,

and police along with local teams are searching the well for her body.

Severe financial difficulties are suspected to have driven the family to take this extreme step. Locals mentioned that the family had been struggling for a long time, and no support had come their way.

Pakala police have registered a case and launched an investigation. They are collecting further information about the family's background and the circumstances that led to this mass suicide attempt.

### **Major Electrical Wire** Scam Busted in Tadipatri

A significant haul of stolen electrical wires worth nearly ₹2,00,000 was uncovered in Tadipatri town. Acting on credible information, AP SPDCL Tadipatri DEE Prabhakar Rao and his team conducted a surprise inspection at a shop near the Anjaneya Swamy statue circle. They found large quantities of electrical wires being loaded into lorries from a shop owned by a person named Gujiri.

The officials immediately seized the wires, unloaded them from the lorry, and shifted them to the electricity department office in an SPDCL vehicle under the supervision of vigilance officials. This seizure comes in the backdrop of several wire thefts recently reported in Brahmanapalli and nearby villages.

Following the seizure, a complaint was lodged at the Tadipatri Rural Upgraded Police Station. The incident has triggered concern among local residents, who fear a larger network behind the theft. Further investigation is underway.





# Journalist Is A Soldier Sans Weapons

When we think of a soldier, we often imagine someone equipped with physical weapons and training to confront immediate threats—whether on the battlefield or in a more symbolic sense, fighting for a cause.

A journalist, in contrast, is not armed with guns, but with knowledge, words, and a deep understanding of how information can influence the world.

But here's where the analogy gets more layered: both soldiers and journalists are often in the field—literally and metaphorically—dealing with the frontlines of their respective domains. While soldiers may be fighting to protect a nation or cause, journalists are fighting to protect the truth, democracy, and the integrity of information.

#### The Battlefield of Truth

A soldier's mission is clear: neutralize the enemy, protect allies, and secure territory. A journalist's mission, while less tangible, is no less vital: uncover the truth, hold power accountable, and inform the public. In war zones, journalists have to navigate the same physical risks as soldiers, but they also face the additional challenge of ensuring that the information they gather and disseminate is accurate and not manipulated by political agendas or propaganda.

In both cases, the "battleground" involves the stakes of power, and those who control the narrative—whether through arms or words—shape the course of events.

#### Tools of Influence

Soldiers use weapons to engage in direct physical conflict, but journalists use the tools of their trade—pen, camera, microphone, and the internet—to influence the perceptions of



the public. The right report, the right photo, or the right documentary can spark social movements, bring down governments, or change the course of

For example, images like the 1972 "Napalm Girl" photo or video footage of police brutality can shift public opinion in ways that armies, politicians, and even the media themselves might not anticipate. These moments serve as a reminder that words and images can be weapons in their own right, and journalists often find themselves on the frontlines of public conscious-

#### Casualties of War

Both soldiers and journalists can become casualties of their respective "wars." Soldiers risk their lives on the battlefield; journalists, particularly in conflict zones, risk imprisonment, torture, or death. Think of the high-profile journalists like Jamal Khashoggi, Daphne Caruana Galizia, or Marie Colvin, who paid the ultimate price for their commitment to truth-telling. These "weaponless soldiers" may not have the armor of a soldier, but they

carry with them an unwavering commitment to documenting the truth even at great personal risk. In the same way that soldiers may be seen as heroes for their sacrifices, journalists who face these risks are often celebrated for their courage in challenging oppressive systems or revealing uncomfortable truths.

#### **Moral and Ethical Frontlines**

Another way the analogy holds is in the moral and ethical decisions both soldiers and journalists must make. A soldier must weigh the cost of their actions—what are the ethical implications of warfare, and when does self-defense become aggression? Similarly, a journalist faces the moral question of "What is the responsibility of reporting the truth?" Is it enough to just report the facts, or should they work to challenge injustice, hold power accountable, and perhaps even become advocates for those who can't speak for themselves?

Both must contend with difficult choices in the face of adversity-whether that's pulling a trigger or deciding whether to publish a sensitive story that could put lives at risk. The line between objectivity and activism can be a thin one for both, but it's often walked in the pursuit of a larger goal.

#### **Resistance and Resilience**

Like soldiers in resistance movements, journalists can be agents of change, even if they're not directly fighting with weapons. Think of investigative journalists who expose corruption, expose environmental hazards, or bring attention to human rights abuses. They're not always appreciated by the powers they challenge, and often face retaliation, yet their work remains crucial for the health of democratic societies.

#### Scribes enjoy more freedom

In countries where freedom of the press is under threat, journalists often face systemic suppression—just like soldiers in authoritarian regimes might be forced to fight battles they don't believe in. However, the resilience of these "weaponless soldiers" can sometimes be even more powerful because the very tools they use to fight are the most difficult to take away: the pen, the voice, and the truth.

So, in sum, the "weaponless soldier" analogy captures how journalists, though unarmed with conventional weapons, engage in a high-stakes battle that requires courage, resilience, and often personal sacrifice. Their power lies in their ability to shape narratives, challenge the status quo, and ultimately, shift the course of history.

### **How Europe Got Rich with Trade Deficits: Piketty's Study Reveals Surprising Global Wealth Patterns**


When former U.S. President Donald Trump complained about America's trade deficits and called for "big, beautiful trade deals," he wasn't the first global leader to focus on trade imbalances. But are today's deficits truly unique in history? A groundbreaking study by economists Gaston Nievas and Thomas Piketty, published by the World Inequality Lab, shows that they are not — and in fact, today's global wealth flows have striking historical echoes.

Their research builds a global balance of payments dataset from 1800 to 2025, revealing how past economic powers, especially Europe, accumulated vast foreign wealth without trade surpluses. During the first wave of globalization (1800–1914), major European powers like Britain, France, and the Netherlands ran consistent trade deficits in primary commodities like food and minerals — up to 4% of world GDP annually. Meanwhile, their trade surpluses in manufacturing were smaller, meaning they imported more than they exported overall.

Despite this, Europe built immense foreign wealth. How? Through invisible flows in the balance of payments: massive income from dividends, interest, royalties, and profits from their colonies. These flows created current account surpluses, allowing Europe to accumulate foreign assets equivalent to 70% of its GDP (30% of world GDP) by 1914 — even without a trade surplus.

Colonial extraction played a central role. Countries like Haiti were forced into punishing debt repayments, while colonies like India and Indonesia sent vast tax revenues back to their European rulers. These financial transfers, rather than trade performance,

#### Foreign Wealth by World Region, 1800-2025





### Why Returning to the **Moon Is More Than Just Rocket Science**

The phrase, "If we can put a man on the moon, why can't we..." has largely faded from popular use. Perhaps that's because it's not clear that 21st-century America can easily send astronauts back to the lunar surface. The Wall Street Journal revived this question in 2018 with a headline that bluntly asked, "If We Can Put a Man on the Moon, Why Can't We Put a Man on the Moon?"—highlighting the challenges facing NASA's Artemis program amid cost overruns and bureaucratic delays.

The first moon landing—Apollo 11 in 1969—was a monumental achievement, realized through President John F. Kennedy's ambitious vision. Since then, technology has advanced dramatically. For perspective, a modern USB-C charger holds more computing power than the entire Apollo 11 onboard computer. Yet, the last crewed moon mission was Apollo 17 in 1972, and despite repeated promises by several presidents, the United States has yet to return.

There are compelling reasons to go back: establishing a scientific base on the moon, answering unresolved questions about lunar geology, and using the moon as a stepping stone for crewed Mars missions. Presidents George H.W. Bush and George W. Bush both advocated returning to the moon, aiming for Mars as the ultimate goal, but both struggled to secure sustained congressional support. President Barack Obama shifted NASA's focus, while President Donald Trump revived the Artemis program, which now faces heavy criticism for delays, technical problems, and ballooning costs—projected to reach \$93 billion. By comparison, the Apollo program cost nearly \$26 billion between 1960 and 1973, about \$260 billion today when adjusted for inflation.

The Apollo era was unique—not just technologically but politically. The space race was a high-stakes contest with the Soviet Union for global prestige and strategic dominance, rallying Americans and Congress alike behind NASA's mission. NASA also benefited from inheriting expert talent from its predecessor, the National Advisory Committee for Aeronautics (NACA), established during World War I.

"The U.S. and the Soviet Union were competing for the hearts and minds of the world," explains Teasel Muir-Harmony, curator of the Apollo Collection at the Smithsonian's Air and Space Museum. Kennedy's 1961 moonshot announcement closely followed the failed Bay of Pigs invasion, underscoring how space exploration was entwined with Cold War politics. Today, NASA faces more competition for talent, with private companies like SpaceX and Blue Origin attracting skilled engineers and innovators. Returning to the moon is no longer just about rocket science—it's about navigating political will, funding, and a competitive, evolving space industry.

#### Indian nurse on death row in Yemen: India in touch with some 'friendly countries', says MEA

India is actively pursuing diplomatic channels, including outreach to "friendly countries," in a bid to save Nimisha Priya, an Indian nurse on death row in Yemen. The government confirmed on Thursday that it is providing all possible support to her family, as her scheduled execution—originally set for July 16—has been temporarily postponed.

"This is a sensitive matter," said Ministry of External Affairs (MEA) spokesperson Randhir Jaiswal during a press briefing. "The Government of India has extended legal assistance, appointed a lawyer, arranged regular consular access, and remained in close contact with Yemeni authorities and the family."

Priya, a native of Kollengode in Kerala's Palakkad district, was convicted for the murder of a Yemeni national and sentenced to death. Her execution was approved by Yemen's President in December 2024. The case has attracted significant attention and appeals from civil society groups, who argue that mitigating circumstances warrant clemency.

Jaiswal declined to name the foreign governments involved but confirmed that diplomatic efforts in recent days have focused on gaining more time for the family to negotiate with the victim's relatives, as is permitted under Yemeni law through the practice of blood money or diyya.

"This includes concerted efforts to facilitate a mutually agreeable resolution," he said. "We are also in contact with some friendly governments who have influence in the region."

India has no diplomatic mission in Yemen due to the ongoing conflict there, and operates its affairs in the country through its embassy in Djibouti. Officials continue to closely monitor the situation and provide support to Priya's family.

The case remains under delicate negotiation as the Indian government pushes for a humanitarian resolution to prevent Priya's execution.

### Amid threats of sanction on Russian oil supplies, India guided by 'best offer': MEA

India pushed back firmly against U.S. threats of secondary sanctions on Russian oil imports, asserting on Thursday that meeting the country's energy needs remains a top priority. The Ministry of External Affairs (MEA) emphasized that India would continue to be guided by the best offers available in the global market, while cautioning against "double standards" in the enforcement of sanctions.

Responding to questions about the U.S. and NATO's warning of punitive tariffs, MEA spokesperson Randhir Jaiswal said, "Securing the energy needs of our people is understandably an overriding priority for us. In this endeavour, we are guided by what is on offer in markets, and by the prevailing global circumstances."

His remarks come amid growing U.S. pressure on countries like India, China, and Brazil to cut ties with Russian oil, with U.S. President Donald Trump announcing potential secondary sanctions that could take effect within 50 days if Russia does not agree to a peace deal in Ukraine.

India currently imports around 2.08 million barrels of Russian crude oil per day, which accounts for 42% of its total crude imports. Much of this oil is refined by Indian facilities and exported, including to G7 nations. However, proposed U.S.



tariffs—potentially as high as 100% on products derived from Russian-origin oil—could make Indian exports uncompetitive.

India also questioned the fairness of the proposed sanctions, highlighting that several NATO members and European Union countries plan to remain reliant on Russian gas until 2027. "It's double speak...so will Europe face these additional tariffs too?" said an Indian offi-

India has consistently maintained a position of strategic autonomy and insists that its crude oil decisions are based on affordability and availability, not geopolitical alignment. With over 85% of its oil requirements imported, New Delhi warned that any disruption could spike domestic fuel prices and strain the economy.

### **Ahmedabad Declared Cleanest City** as Indore, Surat Move to 'Super Swachh League'



In a significant shift in the Swachh Survekshan 2024-25 rankings, Ahmedabad has been named the cleanest city in India in the category of cities with over 10 lakh population. The announcement was made at an awards ceremony in New Delhi, where President Droupadi Murmu presented the top honours.

The recognition comes as Indore and Surat, both consistent winners in past years, were elevated to a newly created 'Super Swachh League', a category that honours cities that have maintained top-tier cleanliness standards for three consecutive years. As a result, they

were excluded from this year's main rankings to allow newer cities to be recognized.

Ahmedabad secured the 'Swachh Shehar – Rank 1' title, with Bhopal and Lucknow taking second and third places respectively in the 10 lakh-plus population category.

Union Minister for Housing and Urban Affairs Manohar Lal and MoS Tokhan Sahu were also present at the event, applauding the achievements of the winning cities.

This year's survey placed strong emphasis on sustainability, waste segregation, public feedback, and technological innovation in urban

# Trump Rakes in \$50 Billion as Global **Powers Hold Back on Tariff Retaliation**

Four months into U.S. President Donald Trump's aggressive new tariff regime, the U.S. has reaped nearly \$50 billion in revenue — while much of the world has hesitated to retaliate, opting instead for restraint amid fears of economic escala-

New U.S. Treasury data reveals a dramatic surge in customs revenue to \$64 billion in the second quarter of 2025 — a \$47 billion jump from the same period last year. This comes as Trump's sweeping trade policy — featuring a 10% global tariff baseline, 50% duties on steel and aluminum, and 25% tariffs on automobile imports — took full effect.

Despite fears of a global trade war, only China and Canada have responded with significant countermeasures. China's response, while the most robust, has yielded limited results; customs revenue in Beijing rose only 1.9% in May 2025 yearon-year. Canada imposed C\$155 billion in retaliatory tariffs but rolled many back under domestic economic pressure.

"Many countries learned from the 2018– 2019 trade war that retaliation often leads to counter-retaliation rather than resolution," said Marta Bengoa, an economics professor at City University of New York.

Major economies including the Europe-



an Union, Mexico, and Japan have so far avoided tit-for-tat responses. The EU has readied a €72 billion retaliatory package but is holding off until after Trump's August 1 deadline for trade negotiations, with geopolitical issues — such as U.S. backing for Ukraine — playing a role in its delay. Meanwhile, global corporations like Apple, Mercedes-Benz, and Adidas are

shifting supply chains or absorbing tariff costs to maintain U.S. market stability.

With tariff rates at levels not seen since the 1930s Smoot-Hawley era, Trump's trade strategy is reshaping global economics — with most allies treading carefully rather than confronting Washington head-on.

### **Syria, Druze Leaders Agree to Fragile New Ceasefire**

Syrian government officials and Druze minority leaders announced a renewed ceasefire on July 16, 2025, following days of intense clashes in the southern city of Sweida. The violence threatened Syria's fragile postwar political transition and drew military intervention from neighboring Israel. While government convoys began withdrawing from Sweida, the durability of the ceasefire remains uncertain, especially after a previous truce announced just a day earlier collapsed, with prominent Druze leader Sheikh Hikmat Al-Hijri rejecting the agreement.

The conflict escalated from tit-for-tat attacks between local Sunni Bedouin tribes and Druze armed factions, compounded by clashes between Syrian government forces and Druze militias. Civilians have also suffered amid the unrest. The situation worsened with Israeli airstrikes targeting military sites in Damascus and near the presidential palace, part of Israel's campaign to push Islamist militants away from its border and protect the Druze community, which is significant both in Syria and Israel. Interim Syrian President Ahmad al-Sharaa condemned the Israeli strikes, calling for unity among Syria's diverse communities and vowing to protect Druze rights. He tasked local factions and Druze spiritual leaders with maintaining security in Sweida to prevent further violence.

The conflict has resulted in heavy casualties. The Syrian Observatory for Human Rights reported over 300 deaths by July 16, including civilians, security forces, and children. Reports of atrocities, including field executions and destruction of homes, surfaced amid ongoing violence. Druze communities in Syria and the Golan Heights protested the violence, while the U.S. expressed concern and urged calm. The fragile ceasefire signals a critical moment for Syria's stability, as tensions between ethnic and religious groups, alongside foreign interventions, continue to challenge the country's recovery.

### Pakistan Declares Rain Emergency in Punjab after 30 Dead in 24 Hours

Torrential monsoon rains have wreaked havoc in Pakistan's Punjab province, claiming at least 30 lives within a span of 24 hours, prompting authorities to declare a "rain emergency" across multiple districts, officials said on Thursday, July 17, 2025.

The most severely impacted area was Chakwal, located in the Salt Range about 300 km from Lahore, where a staggering 423 mm of rainfall led to severe flash flooding. The Provincial Disaster Management Authority (PDMA) confirmed that military units

and local administration are engaged more than 300 people were injured in rescue operations to evacuate residents trapped by rising waters.

Rainfall is forecasted to continue across Punjab, heightening fears of river and stream overflows. An official alert has been issued for possible flooding in low-lying and riverine ar-

Deputy Prime Minister Angela Rayner said in a statement, "We are taking action to break down barriers to participation that will ensure more people have the opportunity to engage in UK democracy."

### "Where Is Phase 2": Musk Stirs Epstein **Pot Again After Trump Fires Prosecutor**

Billionaire Elon Musk has reignited controversy surrounding the Jeffrey Epstein case by publicly criticizing the Trump administration's refusal to release key documents. Musk's remarks appear to suggest that President Donald Trump's name might be mentioned in the sealed files, raising concerns about transparency and political motivations.

The outspoken Tesla and SpaceX CEO responded to a post on X (formerly Twitter) asking, "What happened to all the evidence against Epstein?" Musk replied, "Yeah, where is it?" He followed up by questioning the delay in "Phase 2" of the declassified Epstein files, initially released by Attorney General Pamela Bondi in February 2025.

This renewed scrutiny comes after the Trump administration abruptly fired federal prosecutor Maurene Comey, who played a significant role in prosecuting Epstein and his accomplice, Ghislaine Maxwell. The dismissal has intensified suspicions about the administration's intentions, especially as Trump faces mounting pressure from within his own MAGA base to

fully disclose Epstein's alleged ties to powerful individuals.

Epstein, a disgraced financier and convicted sex offender, was charged with sex trafficking minors before dying by suicide in jail in 2019. Maxwell is currently serving a 20-year prison sentence after being convicted in 2021 for aiding Epstein's abuse.

Trump's past social ties to Epstein, including documented instances of flying on Epstein's private jet, have fueled conspiracy theories. However, Trump has denied any involvement, and no charges have been brought against him.

The backlash intensified after the administration reversed its earlier promise to release more Epstein-related files. According to Reuters, Trump officials are now considering damage control measures, including unsealing additional documents and appointing a special prosecutor.

As public frustration grows, even pro-Trump influencers have begun criticizing the administration's handling of the case, forcing a recalibration of strategy to maintain support within the MAGA movement.



## Warning Signs? India's **High-Frequency Economic Indicators Point to Slowdown**

Recent data from high-frequency economic indicators reveal signs of a slowdown in the Indian economy, according to a report by Nuvama. Despite the Reserve Bank of India's efforts to boost growth through interest rate cuts and liquidity measures, key sectors are showing weakening

The report highlights that many economic indicators which recorded double-digit growth a year ago have now slipped into single digits—levels similar to those seen before the COVID-19 pandemic. It notes, "India's high frequency data are now slowing with most of them moving to single digits," signaling a loss of economic momentum.

Bank credit growth, an important gauge of borrowing and demand, has fallen sharply from 16% a year ago to just 9% in June 2025. This decline reflects weaker borrowing by businesses and consumers. Sim-



ilarly, GST collections, a proxy for consumption and business activity, have slowed from 11% growth to only 6.2% in June, indicating reduced economic spending.

Export growth remains subdued as well, with goods and services exports rising just 6%—a sharp drop from the double-digit growth experienced in fiscal year 2023.

Other consumption indicators also show signs of weakness. Passenger vehicle sales slowed to 2% growth, down from 7% last year, while property sales value in the top seven cities dropped from 28% growth to just 4%. Wage growth, as measured by BSE500 companies, has halved from

Industrial growth is similarly affected. Growth across eight core sectors declined to 3% from 8% last year. Diesel consumption grew by just 1%, and medium and heavy commercial vehicle sales fell by 3%. Profit growth for BSE500 companies (excluding oil marketing) has dropped from 21% to

Overall, the report concludes that most high-frequency indicators have returned to pre-pandemic single-digit growth rates, signaling a broad economic slowdown. This trend persists despite ongoing policy support, suggesting the need for further stimulus measures to revive growth across sectors.


