## **AP to Become a Quantum Tech Hub**

- National Quantum Valley workshop held in Vijayawada
- Amaravati to get a dedicated quantum technology park
- · AP to lead in future tech innovation, says CM

In a major step towards turning Andhra Pradesh into a future-ready state, Chief Minister N. Chandrababu Naidu announced that a dedicated Quantum Park will be established in Amaravati. Speaking at the national-level workshop on 'Quantum Valley' in Vijayawada on Monday, CM Naidu said the initiative is aimed at transforming the state into a global leader in quantum computing and advanced technology.

Highlighting the government's ambition to make Amaravati more than just an administrative capital, Chandrababu declared, "We are developing Amaravati into a world-class technology hub. Our focus now is on quantum computing — the technology of the future."

He expressed happiness that tech giants like TCS, IBM, and L&T have extended their support and are partnering with the government in this



ambitious project. The Quantum Park in Amaravati is expected to foster innovation, attract startups, and create a conducive ecosystem for tech-driven development.

Reflecting on his earlier contributions to the IT sector, CM Naidu recalled, "During my first tenure as Chief Minister, I met Microsoft founder Bill Gates and promoted the idea of IT in ture.

India. I initiated the High-Tech City in Hyderabad with the PPP model. With the same spirit, we are building the Quantum Valley in Amaravati."

Chandrababu stressed that adopting new technologies is key to development. "Quantum computing will redefine industries like pharma, commerce, and infrastructure. Andhra Pradesh must lead this change," he said.

He also extended an open invitation to the youth and startups across the country, encouraging them to come to Amaravati and be part of this transformative journey. "Technology is our most powerful development tool, and Amaravati will soon be a landmark on the global innovation map," CM Naidu affirmed.

The workshop witnessed participation from top industrialists, academicians, researchers, and central government officials, marking a significant beginning to Andhra Pradesh's quantum fu-

Water Resources Minister Nimmala Ramanaidu has announced that critical infrastructure works to prevent flooding from the Budameru drain in Vijayawada have been completed on a record-fast timeline. Speaking after an inspection on Monday, the minister said a 365-meter-long concrete wall connecting three separate embankments has been built, with the goal of avoiding a repeat of the devastating floods that submerged parts of the city last year. Financial clearance for the CC wall was received in April, and tenders were finalized in May. "We ensured that the work was completed before the onset of the season," Ramanaidu noted, adding that the Budameru's left embankment is also being elevated by half a meter across a 7-kilometer stretch. The minister strongly criticized the previous government's negligence, pointing out that the Velagaleru regulator's gates were inoperable during last year's floods due to lack of maintenance. "Not even basic greasing was done in

five years," he stated. During the emergency, JCBs had to be deployed to forcefully open the gates, with the help of local farmers. Now, 12 new gates have been installed at a cost of ₹1.8 crore to ensure operational readiness.



Education and IT Minister Nara Lokesh announced an ambitious roadmap to transform Amaravati into South Asia's first Quantum Valley, marking the next phase of Andhra Pradesh's technological transformation. Speaking at the Amaravati Quantum Valley workshop held at the Novatel Hotel in Vijayawada alongside Chief Minister Chandrababu Naidu, Lokesh unveiled the government's long-term vision to lead the global quantum technology revolution.

Lokesh stated that this initiative represents the "second chapter" of CM Chandrababu's technological revolution—the first being the rise of IT in united Andhra Pradesh. "This is not a one-day event; it's a movement. The Amaravati Quan- A key highlight of the announcement was that tum Valley will become the epicenter of India's quantum future, and Andhra Pradesh will soon be recognised as a brain capital," Lokesh assert-

He outlined plans to generate over one lakh jobs in the next five years and develop more than 50 unicorn startups through a strong innovation ecosystem. From building expertise in qubit architecture to cryoelectronics, from algorithm development to setting international quantum standards, Amaravati will house comprehensive quantum capabilities.



India's most advanced 156-qubit IBM Quantum System-2 will soon be installed in Amaravati. In addition, Asia's first quantum standards testbed will be established in collaboration with NPL, IEEE, SEAC, and AWS.

Lokesh emphasized strategic collaborations with global and national institutions including IBM, TCS, HCL, Tech Mahindra, IITs, IISc, and even international universities such as Tokyo University.



### Point News Director Arrested Following MLA Balaraju's Complaint

In a major upgrade, the current 4,000 cusecs capacity of the Budameru old channel and Enikepadu UT is being expanded to 20,000 cusecs. Simultaneously, desilting work is ongoing along the entire 57-kilometer Budameru stretch, from Enikepadu to Kolleru, to enable smoother water discharge. Additionally, ₹9 crore has been allocated for dredging at Upputeru, to ensure floodwater from Kolleru reaches the sea efficiently.

Minister Ramanaidu stated that a comprehensive and permanent solution under 'Operation Budameru' will take another 3–4 years, but emphasized that Chief Minister Chandrababu Naidu is making determined efforts to accelerate the project with central government and disaster management collaboration.

"As per the CM's directions, we've completed all essential flood prevention work for Vijayawada on a war footing," he affirmed. Irrigation Advisor M. Venkateswara Rao, ENC Narasimhamurthy, Krishna Delta CE Rambabu, and other senior irrigation officials accompanied the minister during the site inspection.

# **Previous Govt Drained State** Finances: Minister Narayana

- · Minister accuses YSRCP of emptying treasury

Andhra Pradesh Municipal Administration Minister Dr. P. Narayana launched a strong attack on the previous YSRCP government, alleging that it diverted ₹3,000 crore worth of municipal department funds and burdened the state with a staggering ₹10 lakh crore debt. He made these remarks during an inspection of canal desilting works in the 45th division of Nellore city on Monday.

Speaking to the media, Narayana said the financial condition of the state had worsened due to the gross mismanagement of the previous administration. "The YSRCP government emptied the treasury and left the people with massive debt. Now, with the experience and leadership of CM Chandrababu Naidu, we are working to reverse that damage," he said.

He revealed that the government has resumed numerous development programs stalled by the previous regime. In Nellore city, desilting works have begun on a 6.7 km stretch of canals, with the target to complete the work within 15 days. Narayana instructed municipal officials to strictly maintain quality standards in sanitation and drainage projects, emphasizing the need for clean water and proper infrastructure



across urban areas.

The minister also shared that classes have begun at the newly upgraded VR High School, designed to offer international-standard education to underprivileged children. He said this move reflects the government's focus on im-

proving education access and quality. Narayana reaffirmed the coalition government's commitment to bringing stalled development back on track. "We are determined to restore the state's progress and provide better civic amenities to the people," he concluded.

## 15 MLAs Absence at Key TDP Meeting...

### CM questions if foreign trips are more important than party duties

Chief Minister and TDP chief N. Chandrababu Naidu expressed serious dissatisfaction over the absence of several party MLAs during a largescale Telugu Desam Party meeting held on Monday. Of the total invitees, 15 MLAs skipped the meeting, many citing foreign travel and personal reasons, which drew strong remarks from the party leadership.

Speaking at the conclusion of the meeting, which ran from 11 a.m. to 6:30 p.m., Chandrababu openly questioned whether these MLAs considered other engagements more important than participating in crucial party programs. "Are foreign trips and other tasks more important than connecting with the people and strengthening the party?" he asked, expressing his displeasure.

sentees were abroad and specifically pointed out

(Telugu Association of North America) and other international events. In a stern tone, he said, "Those who frequently go abroad should just stay abroad."

Chandrababu also revealed that out of the full list of invitees, 56 people failed to attend the meeting or left early after signing in. He made it clear that he had full records of attendance and warned of consequences for repeated negligence. "I know who came in the morning and who walked out after signing. Don't assume this will go unnoticed," he said.

The Chief Minister emphasized that public representatives have a duty to stay connected with their constituencies and be available to their people. "There is no future without standing with the public," he said, signaling that the party will be taking a stricter stance on commitment and accountability going forward.

### Chandrababu lost control of Party, governance

Political tensions have once again escalated in Tadipatri, Anantapur district, as senior YSRCP leaders filed a formal complaint with District SP Jagadish against Tadipatri Municipal Chairman and senior TDP leader JC Prabhakar Reddy. The YSRCP delegation included district president Ananth Venkatrami Reddy, former MLA Kethireddy Peddareddy, former MLA Vishweshwar Reddy, and former MP Gorantla Madhav.

Addressing the media after submitting the complaint, former MLA Kethireddy Peddareddy expressed frustration over being denied entry into Tadipatri despite the High Court granting him permission to return. "The High Court directed the police to provide me security two months ago. Even now, those orders remain unimplemented," he alleged.

Kethireddy further accused JC Prabhakar Reddy of instigating violence and threatening to kill YSRCP workers. "When I was MLA, there was peace in Tadipatri. But now, due to JC's 'mundamopi politics', the region is being pushed into unrest," he said. He demanded accountability from the police for allegedly ignoring attacks on his supporters, claiming that the police were acting under pressure from the municipal chairman.



YSRCP district president Ananth Venkatrami Reddy echoed these concerns, stating it was unjust for police to deny an elected former MLA his rightful access to the constituency. He insisted that any restrictions should be issued in writing and called for immediate implementation of court orders. "The dictatorial rule of JC Prabhakar continues in Tadipatri. Kethireddy should be allowed to conduct party programs," he demanded.

Venkatrami also mentioned the ongoing YSRCP campaign "Recalling Chandrababu Manifesto" being held across the state, and insisted the program must be conducted in Tadipatri without obstruction.

According to YSRCP leaders, the SP responded positively to their appeal and assured them that suitable action would be taken.

## **Kakani in Police Custody Again** for Two Days

A local court has granted two-day custody to the police to interrogate him further in connection with an illegal toll gate operation case. Officials expect that key information related to the toll gate operations may come to light during the interrogation. Meanwhile, Kakani is also under the scanner in another case related to illegal quartz mining. He had previously been taken into custody and questioned in that matter. Sources suggest that the police may also touch upon aspects of the quartz case during the current round of questioning. The dual investigations indicate growing le-

gal troubles for the senior YSRCP leader. With fresh questioning underway, all eyes are now on whether significant evidence or leads will emerge from the custody interrogation.

Kethireddy further accused JC Prabhakar Reddy of instigating violence and threatening to kill YSRCP workers. "When I was MLA, there was peace in Tadipatri. But now, due to JC's 'mundamopi politics', the region is being pushed into unrest," he said. He demanded accountability from the police for allegedly ignoring attacks on his supporters, claiming that the police were acting under pressure from the municipal chairman.

YSRCP district president Ananth Venkatrami Reddy echoed these concerns, stating it was unjust for police to deny an elected former MLA his rightful access to the constituency. He insisted that any restrictions should be issued in writing and called for immediate implementation of court orders. "The dictatorial rule of JC Prabhakar continues in Tadipatri. Kethireddy should be allowed to conduct party programs," he demanded.

Venkatrami also mentioned the ongoing YSRCP campaign "Recalling Chandrababu Manifesto" being held across the state, and insisted the program must be conducted in Tadipatri without obstruction.





### **Exit Ramp Sanctioned for AIIMS Mangalagiri Access from NH-16**

In a major boost to accessibility for patients and visitors to AIIMS Mangalagiri, the Central Government has approved the construction of a dedicated exit ramp on National Highway-16 (NH-16). Union Minister of State for Rural Development and Communications Dr. Chandra Sekhar Pemmasani announced the sanction on Sunday, expressing gratitude to Prime Minister Narendra Modi and Union Road Transport Minister Nitin Gadkari for their support.

# OPINION OPINION IN July, 2025 DOCT RS' DAY OPINION India's Growing Cancer Burden: Why Awareness, **Early Detection and Prevention Are Vital**

Cancer is emerging as one of the most pressing public health challenges in India. According to the Global Cancer Observatory (GLOBOCAN) projections, India is expected to record an estimated 1.57 million new cancer cases in 2025, a significant rise from 1.39 million in 2020. If current trends continue, this number could climb to over 2 million by 2040. Notably, cancer deaths among women are rising at a faster pace than men, underscoring the urgency for gender-sensitive prevention and care strategies.


#### **Most Common Cancers in** India

Among women, breast and cervical cancers top the list. Breast cancer has an age-standardized incidence rate of 26.6 per 100,000, making it the most common. Risk factors include increasing age, obesity, late childbirth, family history, and genetic mutations like BRCA1/2. Early detection through breast self-examinations (BSE) and clinical breast exams can be life-saving. Women over 40 are encouraged to undergo annual mammograms.

Cervical cancer, caused largely by persistent infection with high-risk HPV strains, is preventable with regular Pap smears or HPV testing. Warning signs such as abnormal bleeding, pelvic pain, or unusual discharge should never be ignored. The HPV vaccine, if administered between ages 9–14, can prevent nearly 90% of cervical cancers — yet awareness and uptake remain low.







**Cancers Among Men** 

Among Indian men, lung cancer continues to be a leading cause of death. Strongly linked to tobacco use, it is also fueled by air pollution, occupational exposure to carcinogens, and family history. Symptoms such as

persistent cough, chest pain, and unexplained weight loss warrant immediate medical attention.

Another growing concern is prostate cancer, especially with increasing life expectancy. Often silent in the ear-

ly stages, it may later present with urinary symptoms or bone pain. PSA blood tests and digital rectal exams (DRE) are useful screening tools for men over 50 or younger if at high risk. **Major Risk Factors** 

Nearly 40% of all cancer cases in India are linked to modifiable risk fac-

tors, including tobacco, infections (like HPV and HBV), obesity, poor diet, and sedentary lifestyles. Tobacco use alone accounts for a major share of oral and lung cancers, particularly among men.

Environmental exposures such as air pollution and chemical carcinogens are also contributing to the rise in cases. Infections like HPV (for cervical cancer) and Hepatitis B (for liver cancer) are preventable through vaccination, yet coverage remains inadequate.

#### The Way Forward

While treatment facilities are expanding, prevention and early detection remain the most cost-effective tools. India needs to boost public awareness, improve vaccination coverage, and scale up screening programs, especially in rural and underserved ar-

The government's inclusion of cancer screenings in public health missions, visual oral checks for tobacco users, and routine breast and cervical cancer screenings are positive steps. But more needs to be done to promote regular health checkups, dismantle stigma, and invest in trained health workers for early detection.

A healthier India will be built not just in hospitals, but in homes, schools, and community centers—where awareness can lead to early action, and early action can save lives.

### **China's Sabotage Game and India's Steadfast Shift Away from Old Equations**

China's ongoing attempts to undermine India's rise as a global power reveal its deep insecurity about India's growing influence and self-reliance. From diplomatic maneuvering at multilateral forums to economic sabotage and military backing of Pakistan, Beijing is deploying every tool in its arsenal to contain India's ambitions. But New Delhi is no longer willing to play by the old rules; instead, it is charting a new course that prioritizes strategic autonomy and resilience.

A stark example of China's diplomatic gamesmanship unfolded at the recent Shanghai Cooperation Organisation (SCO) meeting. India refused to endorse the joint statement after China and its ally Pakistan pushed a narrative that selectively condemned terrorism in Balochistan while ignoring terror attacks in Jammu and Kashmir, such as the one near Pahalgam. Defence Minister Rajnath Singh's decision to withhold his signature exposed China's attempt to shield Pakistan's terror proxies under the SCO's anti-terror mandate, undermining the very purpose of the organisation.

Founded by China, Russia, and Central Asian states, the SCO was meant to tackle terrorism, extremism, and regional security. However, China has transformed it into a platform for advancing its geopolitical agenda—supporting Pakistan, suppressing inconvenient truths, and challenging Western influence. India's dissent reveals the limitations of China's leadership and the contradictions within the SCO framework, preventing China from fully dominating the bloc.

On the global stage, Beijing's unease with India is also evident in the upcoming BRICS Summit in Brazil. For the first time in 12 years, President Xi Jinping is expected to skip the summit, reportedly due to Modi's invitation to a state dinner—a subtle diplomatic snub. Officially, China cites scheduling conflicts, but the underlying tension is clear: Beijing fears being



overshadowed by India's rising stature.

Behind the scenes, the India-China relationship remains tense post-Galwan clashes. While there has been a mild thaw with ongoing border disengagement talks and economic normalization efforts, negotiations remain exhaustive. China is aggressively using its economic leverage to stall India's progress, particularly through control of strategic supplies like rare earth magnets crucial for defence, electric vehicles, and electronics manufacturing.

China's export restrictions on key materials such as samarium and neodymium have disrupted supply chains globally. In response, India is ramping up efforts to mine and produce rare earth elements domestically, offering production-linked incentives and forging partnerships with Australia and Quad countries to diversify sources. India's assertiveness at the recent G7 summit—calling out China's unreliable supply practices—has rattled Beijing, which fears a coordinated effort to curb its rare earth dominance.

Chinese tactics extend beyond trade. Reports of delayed shipments of specialty fertilisers and tunnel boring machines, despite contracts being settled, highlight China's use of non-tariff barriers

as economic coercion. Such moves aim to pressure India into reopening its markets to Chinese investment and resuming direct flights, but New Delhi remains cautious, unwilling to compromise its strategic goals.

Meanwhile, Beijing's ple-to-people gestures like resuming the Kailash Mansarovar pilgrimage mask its continued military support to Pakistan. Chinese missiles, drones, and fighter jets have been used in recent Indian operations against Pakistan, and intelligence sharing between China and Islamabad further complicates the security landscape.

Despite these multifaceted challenges, India is steadfast. Rejecting any return to outdated equations, New Delhi is focused on building a future where Chinese attempts to undermine Indian interests will be ineffective. The push for self-reliance, military preparedness, and diversified partnerships signals a strategic shift that China cannot easily counter.

India's approach balances firm diplomacy with clear military and economic priorities, reflecting a mature, calculated response to Beijing's provocations. While challenges remain, India's unrelenting resolve positions it well to emerge stronger in a rapidly changing geopolitical environment.

## The Complex Reality of Language in India

How Trains, Venn Diagrams, K.L. Rahul and Kneecap Can Help Us Understand Shah's Anti-English Remark

Indian languages are vibrant, thriving, and deeply woven into the fabric of everyday life. Contrary to claims that English threatens India's cultural identity, the multilingual reality of the country reveals a far more nuanced picture—one where languages coexist, overlap, and evolve naturally.

At a book launch in New Delhi, Home Minister Amit Shah declared that in the

He praised In- es the limits of Shah's vision. dia's native tongues as ornaments of its To offer another metaphor, languages culture, essential to understanding the country's history, dharma, and identity. But this perspective, rooted in a rigid, exclusionary mindset, overlooks the reality of India's linguistic diversity and the organic multilingualism practiced by millions.

Instead of viewing languages as separate, isolated circles, a more accurate metaphor is the Venn diagram, where languages overlap and interact. Take my own experience: I scored highly in both English and Hindi in school, was a Sanskrit topper for years, and grew up in a household where Hindi, Marathi, Gujarati, Vaghri, and English were spoken interchangeably. My linguistic environment was a complex weave, not isolated strands.

Similarly, Indian cricketer K.L. Rahul's multilingual communication with teammates—switching seamlessly between Hindi, Kannada, Tamil, and English—illustrates this natural linguistic overlap. These are not acts of forced assimilation but spontaneous responses to social realities, reflecting India's linguistic plural-

Shah's anti-English rhetoric also ignores a critical paradox within his own ideological circle. Hindu right-wing intellectuals, many writing revisionist histories and biographies in English, have cultivated a vibrant English-language publishing ecosystem. If English truly undermines "Bhartiyata," why do these ideologues embrace and propagate their views through



in India resemble railway tracks: sometimes diverging, sometimes converging, but always supporting the journey forward. The train of Indian culture moves steadily along this vast network, adapting to changing routes but never derailed. English is not a foreign intruder but an established track on which the train runs. The comparison with Northern Ireland's

Irish language revival, championed by the rap group Kneecap, highlights a key difference. Irish is spoken daily by a tiny minority and is at risk of extinction, necessitating strong preservation efforts. In contrast, Indian languages thrive across millions, embedded in cinema, literature, music, and daily conversation—no official legitimisation required.

Moreover, Kneecap's use of English alongside Irish emphasizes that bilingual or multilingual identities are not contradictory but complementary. Similarly, Indian speakers fluidly navigate multiple languages depending on context, not ideology.

Finally, the idea that English speakers should feel ashamed ignores a broader linguistic reality: Indian English is its own distinct variant, rich but imperfect, reflecting the country's diverse influences. Many English speakers in India struggle with the language, and this is evident in media and literature alike. The shame is not about English itself but often about linguistic insecurity, something universal across languages and cultures.



## **India and Brazil Explore Joint Defence Production, Eye Strategic Collaboration**

India and Brazil are deepening defence ties, with both nations exploring opportunities for joint production, mutual procurement, and co-development of military systems. The two countries are increasingly recognizing the strategic potential in leveraging each other's defence manufacturing strengths to build a more self-reliant and cooperative security framework.

Brazil has expressed strong interest in acquiring Indian-made Akash surface-to-air missiles, artillery guns, coastal radar systems, and secure communication technologies for battlefield use. The Akash missile system notably demonstrated its operational capability during a brief but intense skirmish with Pakistan from May 7-10, 2025.

India, on the other hand, is looking to collaborate with Brazil on the development of an Airborne (AWACS) based on Brazil's Embraer aircraft platform. AWACS is a critical capability for airborne surveillance and command operations.

have signed a Memorandum of Understanding (MoU) to col-



Warning and Control System C-390 Millennium multi-mission transport aircraft. India is actively evaluating this platform as a potential replacement for its aging fleet of Soviet-origin AN-32 transport planes.

In a significant move, Embraer The upcoming BRICS Summit, and Indian company Mahindra scheduled for July 5–8 in Brazil, will serve as a platform for further discussions when Prime laborate on manufacturing the Minister Narendra Modi meets

Brazilian President Lula da Silva. Modi's visit will include bilateral talks in addition to his participation in the 17th BRICS summit.

India's Ministry of External Affairs highlighted the momentum behind these efforts. Secretary (East) P. Kumaran noted that the two nations are actively considering joint ventures, joint research, and co-development projects, particularly involving Embraer platforms for reconnaissance and surveillance missions.Brazil's interest extends to joint maintenance of the French-origin Scorpene-class submarines, used by both navies, and potential collaboration in offshore patrol vessel production.

The Joint Defence Committee (JDC), established in 2003, has facilitated 14 high-level exchanges between military leadership. Since 2007, 134 defence officers (70 Indian, 64 Brazilian) have trained in each other's institutions. In 2024, India and Brazil launched a 2+2 Political-Military Dialogue, further cementing defence cooperation.

Both countries are strategic partners across global forums including BRICS, the G20, and the India-Brazil-South Africa (IBSA) Dialogue Forum, signaling a growing convergence in global security and development agen-



### **Kolkata Gangrape Case: SIT** Reveals Assault Was Pre-Planned, **Over 25 Eyewitnesses Identified**

In a disturbing development in the Kolkata law college gangrape case, police revealed on Monday that the assault on a female student was premeditated by three of the four accused. The Special Investigation Team (SIT) investigating the case has uncovered evidence suggesting that the trio had a history of sexually harassing fellow students and had plotted the crime days in advance. The accused — Monojit Mishra, Pratim Mukherjee, and Zaid Ahmed — allegedly targeted the victim from her first day at South Calcutta Law College. The fourth arrested individual is a security guard at the institution.

According to a senior officer, the three main accused often recorded their acts of harassment on their mobile phones and used the footage to blackmail victims. "This was not a spontaneous act. The trio had planned the assault well in advance. The victim was being closely watched by them from the day she joined," the officer said.

The SIT is currently searching for mobile phone videos that may have been recorded during the incident. Police conducted raids at the homes of Mukherjee and Ahmed on Sunday and are examining devices for incriminating footage. Investigators suspect a video clip of the June 25 gangrape may have been shared with others.

"We're working to determine if the footage was forwarded to other individuals or groups. If so, we will identify and question all those who received it," the officer added. The SIT has compiled a list of more than 25 people, mostly students, who were present on the college campus the evening of the incident. Each will be questioned to piece together the sequence of events and identify any additional witnesses or accomplices.

The case has triggered widespread outrage, with student protests erupting across the city demanding swift justice.

## India "Would Love A Big, Good, Beautiful" Trade Pact With US: Nirmala Sitharaman



With a crucial July 9 deadline approaching to avoid US retaliatory tariffs, Finance Minister Nirmala Sitharaman has expressed India's strong interest in finalizing a comprehensive trade pact with the United States. In an interview with Financial Express, she stated, "Yes, we would love to have an agreement, a big, good, beautiful one; why not?" — echoing former US President Donald Trump's own phrasing.

Sitharaman emphasized that India is eager for a mutually beneficial trade deal but will remain firm on key domestic interests, India is currently negotiating for especially in sensitive sectors relief from US tariffs on steel, like agriculture and dairy. "Agriculture and dairy have been among the very big red lines,"

she said, highlighting that negotiators have carefully safeguarded the concerns of Indian farmers and livestock breeders during discussions.

Her comments come in response to Trump's recent claims that a bilateral trade agreement would "open up" India's markets for US goods. While India is open to deeper trade relations, Sitharaman clarified that full market access, particularly in agriculture and retail, is not negotiable due to India's regulatory protec-

aluminium, and certain agricultural exports. Additionally, it is pushing for visa liberalisation and greater access for its services sector. In contrast, the US seeks expanded access to India's agricultural and technology markets, stricter enforcement of intellectual property rights, and greater data flow commitments. Sitharaman also dismissed Trump's earlier label of India as a "tariff king," calling it unjustified. She noted that India's effective tariff rates are significantly below WTO thresholds, with only eight applicable duties including zero tariffs. Customs duties, she added, account for just around 4% of the value of imported goods — lower than global averages.

India remains hopeful of concluding a balanced deal before the looming tariff deadline.



### **Sri Lankan Navy Arrests 8 Indian** Fishermen for Alleged Illegal **Fishing in Mannar Waters**

The Sri Lankan Navy on Sunday arrested eight Indian fishermen and seized their trawler for allegedly engaging in illegal fishing within Sri Lankan territorial waters near the northern region of Mannar. The arrests were made during a maritime search operation carried out by naval personnel, according to an official statement released by the Sri Lankan Navy. The fishermen were apprehended for allegedly poaching in Sri Lankan waters — a recurring issue that has long been a source of diplomatic tension between India and Sri Lanka. The arrested individuals, along with their trawler, are set to be handed over to the Fisheries Inspectorate in Mannar for further legal proceedings.

Incidents involving the arrest of Indian and Sri Lankan fishermen have become common, as both sides often inadvertently cross the International Maritime Boundary Line (IMBL) due to the proximity of fishing zones in the Palk Strait and the Gulf of Mannar. The narrow stretch of water between Tamil Nadu and northern Sri Lanka is rich in marine resources, making it a frequent site of contention.

Authorities in Sri Lanka have repeatedly emphasized their commitment to protecting the country's marine resources from illegal fishing practices, particularly bottom trawling, which is banned under Sri Lankan law but often used by some Indian fishermen.

India has called for the humane treatment of its fishermen and has also sought mechanisms for the early release of detained nationals. Diplomatic channels between the two countries remain active, with discussions aimed at finding long-term solutions to the recurring maritime disputes.

The latest arrest is expected to reignite calls for bilateral talks to strengthen cooperation in fisheries management and to prevent such incidents through clearly defined and jointly monitored maritime boundaries.

### Char Dham Yatra Resumes After 24-Hour Ban Amid Cloudburst Tragedy

The 24-hour suspension of the Char Dham Yatra was lifted on Monday, following a temporary halt prompted by severe weather conditions, officials confirmed. Garhwal Divisional Commissioner Vinay Shankar Pandey stated that the ban had been revoked, though District Magistrates along the route

have been instructed to regulate vehicular movement based on local weather assessments.

The Yatra was suspended on Sunday after a heavy rain alert was issued. Soon after, a devastating cloudburst triggered a massive landslide near Barkot on the Yamunotri route in Uttarakashi district, resulting in the deaths of two workers and leaving seven others missing.

According to Uttarkashi District Magistrate Prashant Arya, the Barkot-Yamunotri road — which suffered a major washout before Silai Band — has been repaired and made passable. Restoration work on other damaged segments continues. Additionally, the 33 KV power supply line in the affected region has been restored, with ongoing efforts to repair the 11 KV line.

The search operation for the seven missing workers is being conducted by the National Disaster Response Force (NDRF), State Disaster Response Force (SDRF), police, and revenue teams. The landslide occurred approximately four kilometers ahead of Paligad on the Yamunotri National Highway near Silai Band. The two deceased have been identified as Kewal Bisht (43) from Kar-

mamohani in Nepal's Rajapur District and Duje Lal (55) from Pilibhit, Uttar Pradesh. Meanwhile, Chamba town and nearby regions continue to experience heavy rainfall.

Authorities are urging pilgrims to remain cautious and cooperate with local administration during the ongoing Yatra, especially in areas prone to landslides and flash floods.



## 'God Bless America': Trump's 'One Big Beautiful **Bill' Clears First Senate Hurdle Amid Uproar**

In a tense late-night vote, the U.S. Senate took a critical step toward advancing former President Donald Trump's flagship legislative effort—the expansive 940-page "One Big Beautiful Bill Act." The Republican-controlled Senate narrowly approved a key procedural motion Saturday by a slim 51-49 margin, setting the stage for further debate in the coming days.

The bill, which Trump is pushing to pass before the July 4 deadline, seeks a massive \$150 billion increase in military spending, alongside billions for border wall construction and intensified deportations—core elements of Trump's political agenda. However, to fund these initiatives, the bill proposes steep cuts to domestic programs, including significant Medicaid reductions and the elimination of clean energy incentives, sparking sharp criticism across party lines.

Behind the scenes, Republican leaders worked intensely to secure support. Vice President JD Vance's pressure reportedly convinced Senator Ron Johnson of Wisconsin to switch his vote, giving Republicans the necessary edge. Yet dissent remained, with Senators Rand Paul and Thom Tillis joining all



47 Democrats in opposition.

Senate Majority Leader Chuck Schumer condemned the GOP's late-night maneuvering, demanding a full, word-byword reading of the bill—a marathon session expected to last 15 hours.

Key provisions have drawn widespread backlash. Critics warn Medicaid cuts could jeopardize rural hospitals and leave millions uninsured. The bill also rescinds electric vehicle tax credits and climate incentives, drawing ire from with its fate hanging in the balance.

## Nationwide Outrage in Bangladesh After **Brutal Rape of Hindu Woman in Cumilla**

## "Utterly Insane": Elon Musk **Criticises Donald Trump's** 'Big, Beautiful Bill' Again

Billionaire entrepreneur Elon Musk launched a fierce critique of the Senate's latest draft of former President Donald Trump's expansive tax-andspending bill, just as the chamber prepared to debate the nearly 1,000page proposal. Musk warned that the legislation would "destroy millions of jobs in America" and cause severe strategic damage to the country.

Calling the bill "utterly insane and destructive," Musk criticized it for handing out support to outdated industries while harming sectors crucial to the future economy. His remarks added to growing tensions between Musk and Trump's political circle, especially after Musk recently stepped down as head of the Department of Government Efficiency (Doge). Republican Senate leaders are under pressure to pass the bill by Trump's self-imposed July 4 deadline, and Musk's outspoken opposition complicates those efforts.

Earlier this month, Musk also condemned the House version of the bill, calling it a "disgusting abomination" filled with excessive spending. His harsh comments triggered a public rift with Trump, though Musk has since attempted to reopen dialogue with the former president.

On Saturday, Musk doubled down on his opposition, highlighting concerns about the bill's energy policies and economic impact. He shared criticism from Princeton energy systems engineer Jesse Jenkins, who argued that the energy provisions in the bill are rejected by automakers, electric utilities, data centers, and manufacturers alike. Musk responded bluntly, "Good question. Who?"

Musk further criticized the bill for raising the US debt ceiling by \$5 trillion — the largest increase in history — warning this would accelerate the country's "fast lane to debt slavery."

The bill, spanning 940 pages, proposes major cuts to social programs like Medicaid and food stamps, while increasing defense and immigration enforcement funding. Central to the legislation is Trump's \$350 billion border and security plan, including billions for border wall expansion, migrant detention facilities, and hiring thousands of new ICE officers, aimed at supporting a massive deportation initiative.



### **Iran's Top Shiite Cleric Issues Fatwa Against Trump and Netanyahu, Calling Them 'Enemies of God'**

Iran's leading Shiite cleric, Grand Ayatollah Naser Makarem Shirazi, has issued a powerful fatwa—a religious decree—against former US President Donald Trump and Israeli Prime Minister Benjamin Netanyahu, labeling them "enemies of God." The fatwa calls on Muslims worldwide to unite against these leaders for threatening Iran's Islamic republic leadership. According to Mehr News Agency, Makarem declared that anyone threatening the country's supreme leaders is a "warlord" or "mohareb"—a term in Iranian law meaning a person who wages war against God. Those labeled mohareb face severe punishments, including execution, crucifixion, limb amputation, or exile. The decree further states that any Muslim or Islamic state that cooperates with these enemies is committing a forbidden (haram) act.

The fatwa urges Muslims globally to make Trump and Netanyahu regret their actions, promising divine rewards to those who suffer hardships or losses while acting in defense of Islam.

This decree comes after a 12-day conflict sparked by an Israeli bombing campaign on June 13 targeting Iranian military commanders and scientists linked to Iran's nuclear program. Iran retaliated with ballistic missile strikes on Israeli cities. The violence escalated after the US joined Israel in striking Iran's nuclear facilities, prompting Iran to attack an American military base in Qatar.

A fatwa, issued by a Marja—the highest authority in Twelver Shia Islam is a religious ruling that calls for enforcement by Muslim individuals and governments. Iran has a history of using fatwas to justify violence; the most infamous example being the 1989 fatwa against British author Salman Rushdie, who faced assassination attempts after his novel The Satanic Verses was deemed offensive. Rushdie's ordeal included a 2023 stabbing attack in New York, which left him seriously injured.

This latest fatwa highlights the continued tension between Iran, the US, and Israel amid escalating conflicts in the region.

## **Private Banks Now Hold** Majority Share of NPAs in **Unsecured Retail Loans**



Private sector banks now account for the largest share of gross non-performing assets (NPAs) in unsecured retail loans, according to the Reserve Bank of India's (RBI) Financial Stability Report (FSR) released for the year ended March 2025. The report reveals that private banks held 52.6% of gross NPAs in unsecured loans, a significant increase from below 50% two years ago. In contrast, public sector banks (PSBs) accounted for 40.5% of NPAs in this category.

Unsecured loans, which include credit cards, personal loans, and education loans, are issued without any collateral. These loans gained popularity following the pandemic, as banks—especially in the private sector—pursued aggres-

sive retail lending strategies. However, this growth has led to elevated risks, particularly around loan defaults.

The FSR highlights that private banks have seen persistently high slippages in their unsecured retail portfolios. "Slippages in unsecured retail loans remain elevated for private banks. Fresh slippage in this segment continues to dominate the overall slippage," the report said. This has also led to higher write-offs, which continue to be a significant factor in managing NPAs, especially for private lenders.

Although there has been some moderation in the growth of unsecured lending, the asset quality in this segment has weakened relative to the broader retail loan portfolio.

As of March 2025, the gross NPA (GNPA) ratio for unsecured retail loans stood at 1.8%, compared to 1.2% for the overall retail segment.

Following the COVID-19 pandemic, much of the banking sector's credit growth was fueled by lending to the retail and services sectors, particularly through unsecured loans and loans to non-banking financial companies (NBFCs).

Currently, unsecured retail loans constitute 25% of the total retail loan book and account for 8.3% of banks' gross advances. The rising share of NPAs in this segment is raising concerns about the sustainability and risk management practices of banks, especially in the private sector.

## **Indian Stock Market Opens Flat Amid Positive Global Cues**

Mumbai: The Indian stock market opened flat on Monday, buoyed by positive global cues and early buying interest in the PSU bank and IT sectors. At 9:27 am IST, the Sensex edged up marginally by 1.35 points to 84,057.55, while the Nifty rose 6.50 points, or 0.03%, to 25,644.30. Nifty Bank showed slight gains, up 15.15 points or 0.03% at 57,459.05 in early trade.

Market analysts pointed to easing geopolitical tensions in West Asia and a sharp decline in Brent crude prices to \$67 as key factors supporting the market sentiment. Additionally, reports suggesting positive developments in trade negotiations between the US and China, as well as the US and India, have boosted investor confidence.

Dr. VK Vijayakumar, Chief Investment Strategist at Geojit Investments, noted that re-



cent market rallies have been driven by large-cap stocks like HDFC Bank, ICICI Bank, Reliance Industries (RIL), and Larsen & Toubro (L&T), which have seen strong institutional buy-

The Nifty Midcap 100 index climbed 220.90 points (0.37%) to 59,606.05, while the Nifty Smallcap 100 index rose 153.35 points (0.81%) to 19,130.15.

Among the Sensex constituents, M&M, Kotak Mahindra Bank, Bharti Airtel, HDFC Bank, NTPC, and UltraTech Cement were the top losers. On the other hand, Trent, SBI, L&T, Axis Bank, and Hindustan Unilever Limited led the gains.

Weakness in the US dollar index continues to encourage foreign institutional investor (FII) inflows, alongside ongoing retail optimism supporting domestic fund investments. Experts advise that while staying invested in this bullish market makes sense, caution should be exercised when making fresh investments at current high valuations.

On June 27, FIIs were net buyers, acquiring equities worth ₹1,397.02 crore, while domestic institutional investors (DIIs) were net sellers, offloading

shares worth ₹588.93 crore. Asian markets also showed mixed trends, with China, Bangkok, Japan, Seoul, and Jakarta trading in green, while Hong Kong slipped into the red.

In the US, the Dow Jones closed Friday at 43,819.27, up 1%, with the S&P 500 and Nasdaq also posting solid gains.

## India's Trade Deficit Could Rise to \$300 Billion in FY26 Despite Moderate Oil Prices: ICICI Bank

ICICI Bank has forecast that India's trade deficit will widen to USD 300 billion in the financial year 2025-26, even though oil prices are expected to remain moderate. This would mark an increase from the USD 287 billion deficit recorded in FY25 and USD 245 billion in FY24, representing 7.0% of the country's

According to the bank's report, the main driver of the growing trade deficit is the weak performance of India's non-oil exports, which have struggled to keep pace with rising imports. On the other hand, strong domestic economic growth is expected to sustain high import levels, further widening the gap between imports and exports. Despite the widening trade deficit, ICICI Bank projects that steady inflows from services exports and remittances will help maintain the current account deficit (CAD) at a manageable USD 30 billion, or approximately 0.7% of GDP. The current account deficit includes not only the trade balance but

A trade deficit occurs when a country imports more goods than it exports, and India's persistent deficit highlights ongoing challenges in boosting export competitiveness outside of the oil sector. Meanwhile, imports remain robust, driven by strong domestic demand and



## Fans Celebrate Final Season with Real-Life Squid Game Parade in South Korea



After early first-round exits in 2008 and 2009, she reached the semifinals in 2010 before capturing her first title in 2011 by defeating Maria Sharapova. She claimed her second trophy in 2014, beating Eugenie Bouchard decisively. Her journey at Wimbledon is also

deeply personal. Kvitova's coachturned-husband, Jiri Vanek, proposed to her at Centre Court, and their son Petr was born during the 2024 tournament fortnight.

Balancing motherhood and professional tennis has been challenging, especially with the logistics of travel and being away from her young son, but Kvitova described her 17-month hiatus from the tour as more of a break than a quit. "My mindset is still in a good place," she said, sharing the bittersweet joy of returning to Grand Slam competition and her beloved Wimbledon, known affectionately as "Wimby."



### Marc Marquez Wins Dutch GP, Equals **Agostini's Record with 68th MotoGP Victory**

Marguez delivered a masterclass at the historic TT Circuit Assen, fending off a fierce challenge from Marco Bezzecchi to win the Dutch Grand Prix and claim his 68th MotoGP victory. With this triumph, Marquez equals the legendary Giacomo Agostini's record for premier class wins, capping off an unforgettable weekend at the 100th anniversary of racing at Assen. Starting from P3, Marquez quickly worked his way past title rival Alex Marquez and teammate Francesco Bagnaia (Pecco), taking the lead on Lap 5. The #93 maintained his composure under relentless pressure from Bezzecchi (Aprilia Racing), who stayed within striking distance for most of the race but couldn't find a way past. Marquez extended the gap to 0.7 seconds in the final laps to seal a dramatic win.

Bezzecchi's second-place finish handed Aprilia a double podium weekend, while Bagnaia recovered from a mid-race drop

Assen, Netherlands | June 30, 2025: Marc to secure P3. The race wasn't without drama—Alex Marquez crashed out after contact with Pedro Acosta, later diagnosed with a fractured left hand. Fermin Aldeguer also crashed out, triggering a chain reaction that affected Fabio Quartararo and Joan Mir.

Acosta finished a strong P4 for Red Bull KTM, followed by Maverick Viñales (P5) and Fabio Di Giannantonio (P6). Franco Morbidelli took P7 despite a Long Lap penalty, while Raul Fernandez claimed P8, his third consecutive top-10 finish. Enea Bastianini and Quartararo rounded out the top 10.

Brad Binder, Johann Zarco, Alex Rins, Jack Miller, and Somkiat Chantra completed the points-scoring positions, with Chantra earning Thailand's first-ever MotoGP point. As the championship battle intensifies, the paddock now heads to Sachsenring for Round 11, with Marquez firmly reestablished as a title contender in the 2025 season.



### **Ayush Shetty Clinches First BWF World Tour Title** at US Open; Tanvi Sharma **Finishes Runner-Up**

Rising Indian badminton star Ayush Shetty claimed his maiden BWF World Tour title with an impressive straight-games win over Canada's Brian Yang in the men's singles final of the US Open Super 300. The 20-year-old secured the victory 21-18, 21-13 in just 47 minutes, ending India's title drought on the World Tour this season.

Seeded fourth, Shetty dominated from the outset, showcasing a mix of attacking flair and solid defense. After a close start at 6-6, the Mangalore shuttler pulled ahead to lead 11-6 at the mid-game break. Though Yang leveled at 16-16, Shetty's sharp placement and a decisive jump smash helped him close out the first game. In the second, Shetty raced to a 7-2 lead and maintained his momentum with a combination of cross-court punches and smashes, ultimately sealing the match.

This marks Shetty's third win over Yang in 2025, following earlier victories at the Malaysia and Taipei Opens. It also adds to his growing resume, which includes finals appearances at the 2023 Odisha Masters, Bahrain International, and the 2024 Dutch Open.

Meanwhile, in the women's singles final, 16-year-old Tanvi Sharma delivered a valiant performance but settled for runner-up in her first World Tour final. Facing top-seeded Beiwen Zhang of the USA, Tanvi lost 11-21, 21-16, 10-21 in a 46-minute contest.

Zhang took control early in the first game, but Tanvi bounced back strongly in the second, attacking from the start and forcing errors with aggressive play. However, Zhang regained her rhythm in the decider, pulling away with an 11-4 lead and closing the match without further resistance.

Despite the loss, Tanvi's breakthrough performance signals a promising future for the young Indian shuttler on the global stage.

### **Pakistan's Participation** in 2025 Men's Asia Cup in India Uncertain Amid **Security Concerns**



Pakistan's involvement in the upcoming 2025 Men's Asia Cup hockey tournament, scheduled to be held in Rajgir, Bihar, from August 29 to September 9, remains uncertain following recent security concerns. The hesitation comes in the wake of the deadly terror attack in Pahalgam that claimed 26 lives, raising serious questions about allowing the Pakistan men's hockey team to compete on Indian soil. Hockey India officials have confirmed that they are in close consultation with the Indian government before finalizing Pakistan's participation. "We are in contact with the government, and we will follow whatever instructions it provides. As for the current situation, I don't think the Pakistan team will be allowed to participate," a Hockey India spokesperson told the Indo-Asian News Service (IANS).

The Men's Asia Cup 2025 is a critical tournament as it acts as a qualifier for the 2026 FIH Men's Hockey World Cup, to be co-hosted by Belgium and the Netherlands. The winner of the Asia Cup secures a coveted spot in the World Cup, raising the stakes for all competing nations.

In addition to the Asia Cup, India is also set to host the FIH Hockey Men's Junior World Cup later this year, from November 28 to December 10, across Chennai and Madurai. Pakistan's participation in this junior event is also under question due to similar security and political concerns following the Pahalgam attack. The Pakistani junior team has been placed in the same group as India in the 24-team tournament.

Pakistan last participated in a major hockey event in India in 2023, during the Asian Champions Trophy in Chennai, where India secured a record fourth title by defeating Malaysia 4-3 in the final. However, given the current tense atmosphere, the prospect of Pakistan's teams playing in India this year appears doubtful.



## **Tanvi Sharma Falls Short Against Beiwen Zhang in US Open Final**

Sixteen-year-old Tanvi Sharma showed immense promise at the US Open 2025 badminton tournament in Iowa but fell to experienced American Beiwen Zhang in a hard-fought final, losing 11-21, 21-16, 21-10. Despite a strong middle-game performance, Sharma struggled to adapt to the faster court conditions on one side, which ultimately affected her shuttle control and consistency.

Sharma, following in the footsteps of Indian greats like Saina Nehwal and PV Sindhu, both of whom achieved significant milestones as teenagers, demonstrated that she has the talent and temperament to compete at the highest levels. Her ability to craft rallies and keep opponents on the move was evident, especially in the mid-game where she fought back impressively to take the second set.

However, the faster drift on one side of the court proved tricky for the young player. Sharma's shuttlecock control faltered on that side, with shots sailing long more frequently than she would have preferred. This inconsistency gave Zhang, a 34-year-old seasoned pro, the upper hand to seize crucial points.

Sharma's gameplan typically relies on her strong criss-cross play, using a wide range of shots to make her opponents run across the court. She also possesses dependable smashes and drop shots, allowing her to exploit open spaces once she creates opportunities with flank attacks. Yet, against Zhang's steady baseline play and tactical awareness, Sharma couldn't fully impose her style.

Despite the loss, Sharma's journey to her first big Super 300 final signals a bright future. With more experience and adjustments to different playing conditions, she looks poised to become a formidable force in international badminton in the years to come.
