Chief Minister N. Chandrababu Naidu on Monday reviewed the newly formulated Electronics Components Manufacturing Policy 4.0 at the Secretariat, asserting that Andhra Pradesh, especially the Rayalaseema region, is strategically positioned to emerge as a hub for electronics production. He directed officials to focus on attracting investments to electronics manufacturing clusters at Sri City, Hindupur, and Kopparthy.

The new policy, aimed at attracting investments between 2025 and 2030, is designed to reduce imports, boost domestic production, and scale up exports. Officials briefed the CM that India imported electronic circuit boards lition government's vision: "One entreber one knowledge economy.

ing the enormous demand in this sector. The CM emphasized achieving "self-reliance" and "Made in India" goals through proactive action plans and policy support.

He also underlined the importance of creating strong domestic brands and setting up a robust ecosystem for manufacturing. The government aims to attract \$100 billion in investments in the electronics sector. With land availability becoming scarce in Bengaluru and Chennai, AP's industrial-friendly regions like Orvakal near Kurnool, Sri City near Tirupati, and Hindupur offer excellent alternatives. Three Regions Ideal for IT Growth

Naidu further noted that Visakhapatnam, Amaravati, and Tirupati are well-suited for IT development. Allotting space to 500 IT firms in these regions would generate substantial employment. He also proposed setting up coworking spaces and emphasized expanding IT and manufacturing sectors from Lepakshi to Orvakal.

To meet future workforce demands, the CM directed integration of the Skills Portal with others and curriculum updates in the education sector.

Double Fine for Traffic Violations Involving Minors

In a move aimed at enhancing road safety for children, the Union Road Transport Ministry has proposed to double fines for motorists found violating traffic rules while traveling with minors. The proposal is part of a broader set of amendments being considered for the Motor Vehicles Act. Official sources indicate that the Ministry has circulated the draft proposal to other central ministries, seeking their opinions on the new measures. The proposed penalty is intended to instill greater responsibility among drivers, especially parents, family members, and school transport operators, who often neglect road safety norms while ferrying children.

growing concern that minors are being put at risk due to traffic violations by adult drivers. By imposing stricter penalties, the government aims to increase compliance and reduce accidents involving children. In addition to the increased fines, the proposal includes the introduction of a 'merit and demerit' point system for drivers. This system would reward rule-abiding motorists and penalize repeat offenders, thereby promoting long-term behavioral change on the roads. The final decision on these amendments will be taken after the consultation process is complete. If approved, the measures could be included in the next round of reforms under the Motor Vehicles Act.

Avinash Reddy's Bail **Under Review**

The Supreme Court on Monday heard petitions seeking the cancellation of bail granted to YSRCP MP Y.S. Avinash Reddy and other accused in the murder case of former minister Y.S. Vivekananda Reddy. The apex court sought the Central Bureau of Investigation's (CBI) views on three specific aspects related to the case before proceeding further. The court clarified that it would consider the plea for cancellation of bail only after receiving the CBI's response. Following this, the bench adjourned the matter to a later date. The bail cancellation petitions were filed by Sunitha Reddy, the daughter of the slain leader, and officials from the CBI. The petitioners challenged the Telangana High Court's decision to grant bail to Avinash Reddy and several others accused in the high-profile case.

Y.S. Vivekananda Reddy, the younger brother of former Chief Minister Y.S. Rajasekhara Reddy, was found murdered at his residence in Kadapa in 2019. The case took several turns over the years, with the CBI taking over the investigation and naming several accused, including Kadapa MP Avinash Reddy.



False Cases Filed for Supporting Jagan

Former ministers Ambati Rambabu and Vidudala Rajini have accused Chief Minister N. Chandrababu Naidu and Minister Nara Lokesh of deliberately filing false cases against them for their support to Y.S. Jagan Mohan Reddy. Addressing the media in Sattenapalli, the leaders said they appeared before the local police following notices issued in connection with recent political events.

Ambati claimed that attending Jagan's public meetings has become the reason for harassment under the new coalition government. "They are targeting us for political revenge. They want to suppress us by dragging us to police stations and courts," he said. He also mentioned the arrest of YSRCP MP Mithun Reddy, alleging that similar false cases are being used to stifle opposition voices. He questioned whether the police system now exists only to file cases against former ministers and MLAs. "Why are police not acting against rowdies or anti-social elements? Why only political leaders who are serving

the public?" he asked.



Mithun Reddy **Demands Jail Facilities**

YSRCP MP Mithun Reddy, currently in remand in connection with the Andhra Pradesh liquor scam, filed a petition requesting basic facilities in Rajahmundry Central Jail. His lawyers informed the ACB court on July 21 that he had been made to sleep on the floor without a bed.

The defense counsel emphasized that despite his status as a Member of Parliament, Mithun Reddy had not been provided with appropriate accommodations. They noted that a bed was not given, leading to uncomfortable conditions. Government lawyers countered by stating that a bed had been provided. The court directed Superintendent Rahul of Rajahmundry Central Jail to appear and clarify the matter. Superinten-



dent Rahul responded that a Deputy Superintendent of Police (DSP) would represent the jail's administration before the court.

Later, the jail superintendent issued an official statement confirming that Mithun Reddy was admitted on July 20 at 8:50 PM. A medical evaluation upon his arrival showed normal vital signs—blood pressure, heart rate, and oxygen saturation. Following the examination, Mithun Reddy was placed in a

barrack cell.

His statements, which included provocative phrases such as "rappa rappa kaadhu, ratriki ratri cheseyaalante," stirred political and public uproar, with multiple police complaints filed against him across the state.

Several political and civil groups alleged that Nani's comments incited violence and posed a threat to public order. In response to the growing pressure and potential legal action, Nani approached the Andhra Pradesh High Court seeking anticipatory bail. However, the court rejected his interim plea and posted the next hearing for July 22, further intensifying the legal heat on the former minister. According to sources, anticipating arrest, Nani has gone incommunicado and is currently untraceable. Police teams are reportedly searching at various locations to track him down. His sudden disappearance has added a layer of mystery to the ongoing controversy and led to speculation about his next legal move.

Legal experts believe Nani might appear after the High Court's next hearing on Monday, hoping for a favorable order. Until then, police teams are on alert in key areas linked to the leader. This episode comes at a time when the YSRCP is already under scrutiny over several issues, including the liquor scam and allegations of misuse of power. The party leadership has not made any official statement on Nani's whereabouts or the nature of his remarks, but political observers see this as another blow to the party's image.

Mithun Reddy is designated as "A 4" in the CID liquor scam case (Cr.No. 21/2024, CID PS Mangalagiri, Andhra Pradesh). The charges against him include IPC sections 420 (cheating), 409 (criminal breach of trust), 384 (extortion), 201 (destruction of evidence), and 120B (criminal conspiracy), along with additional provisions under the Prevention of Corruption Act, 1988. Amaravati Ready in 3 Years: Minister Narayana

Municipal Administration and Urban Development Minister P. Narayana has asserted that the construction of Amaravati capital city will be completed within three years. Speaking to the media after reviewing ongoing works in the capital region, the Minister said government buildings currently under construction will be ready by March 2026.

He visited key construction sites along with CRDA engineers and reviewed progress of quarters for ministers, All India Services officers, judges, and officials. Narayana interacted with representatives of construction companies, inquired about workforce numbers, materials used, and machinery in place. He emphasized that the previous government had halted all construction works and created difficulties for both farmers and contractors.



According to the Minister, a total of 12 towers with 288 flats are being built for MLAs and MLCs, while 6 towers with 144 flats are under construction for All India Services

officers. Additionally, 25 bungalows for principal secretaries, 90 for secretaries, 35 for ministers, and 36 for judges are also in progress. For non-gazetted officers, 21 towers

with 1,968 flats are being built. Four towers with 384 flats for Type-1 gazetted officers, four towers with 336 flats for Type-2, and six towers with 720 flats for Group-D staff are under construction. The HappyNest project is adding 1,200 flats in 6 towers. Minister Narayana said most of the MLA, MLC, and AIS quarters will be completed by December this year, while the rest will be finished by March. Talks are underway between contractors and UK-based design firm Norman Fosters on the iconic buildings project, which will also begin soon.

The Minister also announced that 72 private companies allotted land in Amaravati will begin construction by this December. The Chief Minister has already signed agreements with most firms.

A decision on the second phase of land pooling will be made in the cabinet sub-committee and then finalized in the cabinet.

YS Jagan Condemns Arrest of Ramesh

YSR Congress Party (YSRCP) President and former Chief Minister YS Jagan Mohan Reddy has strongly condemned the arrest of party leader Reddappagari Ramesh Kumar Reddy. The YSRCP chief spoke over the phone with Ramesh Kumar Reddy—who also serves as the party's State Official Representative, Hindupur Parliament Observer, and a former MLA to learn the details surrounding the case and his arrest.

According to party sources, Ramesh Kumar Reddy was taken into custody following a complaint lodged by a TDP leader from Lakkireddipalle. The complaint alleged that Reddy made critical political remarks against Andhra Pradesh Chief Minister N. reportedly registered a case and proceeded with the arrest.

YS Jagan expressed serious concern over what he described as misuse of police machinery to target political



opponents. "Filing false cases and intimidating individuals under the pretext of the so-called 'Red Book' guidelines is deplorable," said Jagan, referring to the government's alleged tactics to suppress dissent.

He criticized the arrest as a blatant Chandrababu Naidu and Transport violation of democratic principles Minister Mandipalli Ramprasad Red- and assured Ramesh Kumar Reddy dy. Centre Plans PMSHRI Expansion in AP

The Pradhan Mantri Schools for Rising India (PMSHRI) scheme, launched by the Government of India, is playing a vital role in transforming the school education sector across the country. These schools are designed to implement every component of the National Education Policy (NEP) 2020.

Union Minister of State for Education Jayant Chaudhary, in a written reply to Vijayawada MP Kesineni Sivanath (Chinni) in the Lok Sabha, stated that more schools in Andhra Pradesh may be added to the scheme after the successful development of the currently selected institutions.

Ministry of Education on dis- structure. trict-wise allocation of schools under the PMSHRI scheme in Andhra Pradesh, including the number of schools selected, facilities to be developed, funds allocated, and whether new schools can be added in the future.

In his reply on Monday, the Union Minister provided detailed district-wise data. Under the scheme, 953 schools in Andhra Pradesh have been selected. Among these, Kurnool district leads with 54 schools, while Visakhapatnam has only 6. In



NTR district, 29 schools were selected, with a total allocation of ₹3,404.1 lakh. Of this, ₹1,628.2 lakh has been released and ₹1,620.6 lakh utilized so far.

Ex-Minister Narayanaswamy Skips SIT Probe

The Andhra Pradesh liquor scam case continues to create ripples in the state's political circles. In a fresh development, former Excise Minister K. Narayanaswamy has informed officials that he will not be able to attend the Special Investigation Team (SIT) hearing scheduled for today.

The SIT had earlier issued a notice summoning Narayanaswamy to appear at 10 AM today at their office in connection with the ongoing probe. However, citing health issues and personal reasons, the former minister informed SIT officials of his inability to attend the hearing. Narayanaswamy's name has surfaced as part of the broader investigation into the alleged ₹32,000 crore liquor scam, which has already led to several arrests of business associates and political aides. The SIT is investigating irregularities in liquor procurement, pricing, and illegal commissions allegedly routed through various channels during



the previous YSRCP government's tenure.

Sources within the SIT indicate that fresh notices may be issued soon, asking the former minister to appear on a later date. Investigators are keen to question him on specific financial transactions and departmental decisions taken during his tenure.

The refusal to attend today's questioning is being closely watched by political observers, who say it could further intensify scrutiny on former YSRCP ministers involved in the scandal. As the probe progresses, more top names are expected to be summoned, making this one of the most high-profile corruption investigations in recent times.

Women's Free Bus Rides from Aug 15: CM

Chief Minister N. Chandrababu Naidu has directed officials to implement the much-awaited RTC free bus travel scheme for women across Andhra Pradesh starting August 15. In a high-level review meeting held at the Secretariat on Monday, the CM emphasized that women passengers must receive a "Zero Fare Ticket" clearly displaying journey details, the amount saved through the subsidy, and the government's 100% fare contribution.

He instructed the development of a new software system to generate these zero-fare tickets, enabling women commuters to easily understand the benefits they receive. Naidu asserted that making this information transparent on tickets would increase awareness and appreciation of the scheme among women. The CM also held detailed discussions with officials about the financial implications of such schemes in other states and evaluated the estimated expenditure for Andhra Pradesh. He reiterated that the scheme must be launched efficiently on the scheduled date without fail.

To ensure that the APSRTC (Andhra Pradesh



State Road Transport Corporation) remains financially viable despite the free travel scheme, the Chief Minister advised the corporation to explore alternative revenue sources and reduce operational costs. He stressed the need for a concrete action plan to improve the corporation's profitability.

Jana Sena MP **Questions Fall** in PM-SYM

Machilipatnam MP Vallabhaneni Balashouri raised serious concerns in the Lok Sabha about the significant drop in budget allocation and enrollment under the Pradhan Mantri Shram Yogi Maan-dhan (PM-SYM) scheme, which was launched in 2019 to provide pension support for unorganised sector workers.

During the ongoing monsoon session of Parliament, the MP questioned Union Minister for Labour and Employment Shobha Karandlaje on multiple aspects of the scheme. He asked whether the scheme's budget had dropped from ₹324 crore in 2021–22 to ₹137 crore in 2024–25 and if this decline was connected to falling enrollment numbers. He also sought state-wise enrollment data for Andhra Pradesh and asked about steps taken to promote the scheme in rural and unorganised worker communities. In addition, he inquired whether the government had received any demands to revise the income eligibility limit from ₹15,000 to ₹30,000 per month to include more workers under the scheme. In a written reply, the Minister confirmed that PM-SYM is a voluntary and contributo-

ry pension scheme that provides a monthly pension of ₹3,000 to unorganised sector workers after they turn 60. Workers aged between 18 and 40 with a monthly income of ₹15,000 or less and not covered under EPFO, ESIC, NPS, or income tax, are eligible. Monthly contributions range from ₹55 to ₹200 based on age, with an equal contribution from the central government. Enrollment is facilitated through over 4 lakh Common Service Centres (CSCs) across the country. The enrollment data for Andhra Pradesh reflected a worrying trend. In 2021–22, only 1,567 workers enrolled out of a national total of 1,28,369. The numbers rose to 17,800 in 2022–23, but fell drastically to 627 in 2023–24 and further to just 281 in 2024-25, despite national enrollment figures showing higher participation.

However, the Minister clarified that there is currently no proposal to revise the minimum income eligibility limit under the PM-SYM scheme.

The response has sparked debate over the government's commitment to the welfare of unorganised workers, especially in states like Andhra Pradesh, where awareness and accessibility remain major challenges.

YSRCP Questions Govt's Selective Justice



Gottipati accused the previous YSRCP government of looting public money by bypassing digital payments and circulating poor-quality liquor. He said those responsible would be punished, and that no one involved in the scam would escape accountability.

On the issue of smart meters, the minister clarified that they are being installed only for commercial and industrial consumers and not for agricultural motors. He dismissed opposition claims that smart meters lead to inflated bills as baseless misinformation. Minor issues with meter implementation will be resolved by the government, he assured.

Highlighting the failures of the previous government, he said the YSRCP raised electricity charges nine times, burdening the public. The new coalition government, he said, is working to reform the power sector, allocating ₹6,000 crore to fix low-voltage issues. On education, Gottipati alleged that the YSRCP had politicized the system and distributed substandard materials with the CM's image. In contrast, Minister Lokesh has launched reforms aimed at improving government schools. Under the "Talli Ki Vandanam" scheme, ₹10,000 crore was deposited into mothers' accounts in a single day. The minister emphasized the government's commitment to quality education, free from political influence.

YSRCP MP Slams APMDC Debt Model

Tirupati MP Maddila Gurumoorthy has raised grave constitutional and financial concerns regarding the Andhra Pradesh Mineral Development Corporation's (APMDC) decision to float ₹9,000 crore worth of non-convertible debentures (NCDs). Speaking under Rule 377 in the Lok Sabha, the MP urged the Central Government to scrutinize what he described as a "dangerous precedent" set by the state-run corporation.

Gurumoorthy alleged that a private debenture trustee has been empowered—through a direct debit authorization by the Reserve Bank of India (RBI)—to withdraw

funds directly from the Andhra Pradesh state treasury. He stressed that this bypasses Articles 203 and 204 of the Constitution, which stipulate that any withdrawal from the Consolidated Fund of the state must be authorized by the Legislature.

The MP further claimed that the funds raised through these deben-




tures are being routed back to the state government in return for granting mining leases. According to him, this structure essentially mirrors a direct government loan, and thus should fall under the purview of Article 293(3) of the Constitution. This Article mandates that a state must obtain prior approval from the Central Government before incurring any loan liabilities, particularly if it is already in debt to the Centre.

Gurumoorthy demanded to know whether the Andhra Pradesh Government had received the necessary approval under Article 293(3) before proceeding with this financial arrangement. He also called on the Union Finance Ministry to intervene and investigate the transaction's legality and implications.

Warning that such financial practices could set a precedent for unchecked borrowing and undermine constitutional safeguards, the MP urged the Centre to act decisively. He stated that upholding Articles 203, 204, and 293(3) is essential to maintain fiscal discipline and constitutional order in the states.

Interstate Bike Thieves Caught

Gudivada: In a major operation, Gudivada One Town Police arrested two inter-state criminals involved in multiple two-wheeler thefts and recovered 14 stolen bikes worth approximately ₹6.5 lakh. The arrests were announced by DSP Dheeraj Vinil during a press conference held at the One Town Police Station. The incident began on June 28 when a resident of Pamarru, Chatla Srinivasa Rao, filed a complaint after his bike (AP 16 DA 4266) was stolen from the Gudivada Government Hospital premises. Acting on reliable information, DSP Vinil directed a special team led by CI Kondapalli Srinivas

and SI Gowtham Kumar to investigate the case. Based on both technical and non-technical analysis, the team conducted vehicle checks near VKR & BNB College on the outskirts of Gudivada. Around 8:30 AM, the suspects, traveling from Hanuman Junction towards Gudivada, attempted to flee on spotting the police but were swiftly apprehended. Upon interrogation, the accused confessed to stealing two-wheelers across five districts—Krishna, Eluru, NTR, Guntur, and Prakasamcovering 11 police jurisdictions. The thefts included three bikes from Gudivada One Town, one each from Gudivada Two Town, Hanuman Junction, R.Peta, Eluru Two Town,

Kothapeta in Guntur, and Markapuram in Prakasam. Four bikes were stolen from Vijayawada's One Town, Two Town, Bhavanipuram, and Krishnalanka areas. The arrested individuals were identified as Koradala Yesu from Vijayawada Kothapeta and Chilakanti Rangarao from Epuru village in Eluru district They used duplicate keys to steal vehicles parked near hospitals, bus stands, and homes, later pledging them to known traders and farmers. A case has been registered under Crime No. 96/2025, Section 303(2) of the BNS Act. The operation involved the active participation of the CI, SI, and other police personnel from Gudivada One Town.

India's Strategic Trap: Why It Must Diminish, Deter, and De-Hyphenate From Pakistan

India's foreign policy has been to de-hyphenate itself from Pakistan—diplomatically, economically, and strategically. This approach was rooted in the belief that India had moved beyond Pakistan in terms of global stature, and should no longer be viewed through a shared South Asian lens by major powers. However, recent political narratives suggest that India is now self-hyphenating again—dragging Pakistan back to the center of its discourse, especially domestically.

The original rationale behind de-hyphenation was pragmatic: while India must always contend with its two nuclear-armed neighbors—Pakistan and China—the larger challenge lies with China. Militarily and economically, Pakistan can be managed, "en passant," as General Sundarji once put it in 1986. China, on the other hand, requires a long-term strategy in-

For over three decades, a core principle of volving military preparedness, economic stan to manipulate Indian responses, as growth, and mutual interest-building to ensure peace. The India-China equation is vastly more consequential in geopolitical terms, but ironically, China barely features in the domestic political rhetoric. A basic word-cloud analysis of political speeches would show Pakistan mentioned far more frequently than China, despite the latter being the real strategic threat. Why this disparity? It's political. In the post-2019 era—especially after the Pulwama attack—Pakistan has become the centerpiece of the BJP's domestic narrative. Framing Pakistan as synonymous with terrorism feeds into a broader framework of Hindu-Muslim polarization, making it a convenient political tool.

But this strategy has a cost. It re-centers Pakistan in national and international perception, undermining years of effort to break that linkage. It also allows Pakiseen in how military provocations can now trigger predictable political reactions in India. The irony is that this rhetorical dependence benefits not just domestic actors in India, but also the Pakistan Army, which thrives on perpetual hostility with India.

India's strategic thinkers have long pursued a balanced, forward-looking doctrine—stabilize relations with China, expand economic power, and limit Pakistan's influence to manageable levels. But domestic politics is now working at cross purposes with this strategy.



By doing so, India can influence the future of AI in a way that uplifts not just its citizens, but the global majority seeking a fairer and safer digital

India-US Quantum Partnership: A Strategic Leap to Challenge China's Dominance



Quantum technologies—once confined to labs and universities—have now become crucial to national security, economic strength, and geopolitical power. Leading in quantum computing, communication, and sensing means setting the future standards for encryption, surveillance, and next-generation warfare. In this high-stakes arena, India and the US have forged one of their most significant technology partnerships yet.

The collaboration is anchored by the US-India Initiative on Critical and Emerging Technology (iCET), launched in 2022 by Presidents Biden and Modi. It includes two main pillars: the Indo-US Quantum Coordination Mechanism, which connects academia, industry, and government to foster research, and the US-India Science and Technology Endowment Fund, which has already invested over \$2 million in cutting-edge quantum and AI projects.

In January 2025, both countries reaffirmed their commitment to deepening cooperation in quantum communication, post-quantum security, and digital twin technologies. This alliance aims to combine their complementary strengths: the US offers capital, world-class labs, and a robust private sector, while India provides a growing talent pool, cost-effective research, and a vibrant startup ecosystem.

Despite its promise, the partnership faces hurdles. Export controls by the US restrict some technology transfers to India, due to concerns about cybersecurity and defence ties. Intellectual property protections and data privacy in joint ventures also require clear frameworks to prevent future conflicts. Another challenge is the limited quantum talent pipeline—India's National Quantum Mission supports 152 researchers, but overall expertise remains scarce.

Strategically, both countries share democratic values and face common challenges posed by China's rapidly growing quantum investments, estimated at \$15 billion—far outpacing the combined US-India quantum investment of roughly \$5.75 billion. This cooperation is designed to reduce dependency on China-controlled supply chains and to build resilient, secure ecosystems that can withstand global political shifts.

India's National Quantum Mission seeks to develop quantum computers with up to 1,000 qubits by 2031, alongside satellite-based secure quantum communications and multi-node quantum networks. US collaboration will accelerate these ambitions and may evolve into larger joint projects involving quantum hardware and communication systems.

Ultimately, the India-US quantum partnership is more than technology—it is a shared vision of strategic independence, innovation, and geopolitical positioning. Together, they aim to lead in a global quantum market expected to reach \$106 billion by 2040, while securing their place in the future of technological dominance.

Modi's Political Dominance and the Missing Disruptor

As Prime Minister Narendra Modi nears the first anniversary of his third term, he appears reinvigorated—confident, assured, and politically unchallenged. The initial unease following the BJP's dip to 240 seats has faded, buoyed by electoral successes in Haryana and Maharashtra and a floundering INDIA bloc. But beyond the immediate victories, what truly empowers Modi now is the vacuum of compelling ideas from the Opposition. India's political discourse is caught in a state of stasis. The Opposition continues to recycle outdated themes secularism vs. communalism, rich vs. poor—but none resonate deeply with voters anymore. Modi, once an outsider, has successfully co-opted, improved, or rendered irrelevant many of these old paradigms. His welfare politics has scaled up to an unprecedented level: free food grains for 80 crore people, housing and toilet subsidies, farm handouts, Mudra loans all executed with reduced bureaucratic friction. The result? Even the "Adani-Ambani" tag doesn't stick. Mo-



di's politics feels more pro-poor than his rivals'.

The idea that Modi will step down at 75 is little more than a social media fantasy. He's poised to lead the BJP into 2029, and none of his challengers have the momentum—or ideas—to disrupt his run. Congress banking on

caste census as a game-changer only highlights its lack of political imagination. The party's attempt to reinvent itself as a caste-justice crusader

seems forced and inconsistent with its traditional umbrella role.


So, what could shake this status quo? History shows that Indian politics has seen only three truly disruptive ideas: Garibi Hatao, Mandal, and Mandir. All have run their course, and two have been absorbed by every major party. The missing fourth wave could be libertarianism—a revival of what the Swatantra Party once stood for: minimum government, maximum governance. Its original 21-point charter championed wealth creation, private enterprise, and freedom from bureaucratic control.

A libertarian disruptor, speaking uncomfortable truths about state overreach, corruption, and inefficiency-much like Minoo Masani once did-could offer real political differentiation. India, tired of ideological recycling and transactional politics, might just be ready for that bold, new narrative.

Until then, Modi remains the only game in town—and the Opposition, its own biggest problem.







Impeachment Process Launched Against Judge Yashwant Varma

For the first time in independent India's history, Parliament has initiated impeachment proceedings against a sitting High Court judge. Justice Yashwant Varma, formerly of the Delhi High Court, faces removal after piles of burnt ₹500 currency notes were found at his official residence earlier

The process began Monday afternoon after 145 Members of Parliament—cutting across party lines—submitted a memorandum to Lok Sabha Speaker Om Birla. Signatories include prominent leaders such as BJP's Anurag Thakur, Congress leader Rahul Gandhi, and NCP MP Supriya Sule. MPs from parties like the TDP, JD(U), CPI(M), and JD(S) also endorsed the move, underscoring the bipartisan nature of the action.

The impeachment process will now be carried out under Articles 124, 217, and 218 of the Constitution, in line with the Judges (Inquiry) Act of 1968. Although the Constitution does not use the word "impeachment" for judges, it outlines a rigorous process for their removal, requiring an order from the President based on Parliament's recommendation. The threshold for initiating such a process is high at least 100 MPs in the Lok Sabha or 50 in the Rajya Sabha must sign a motion. Once admitted by the Speaker or Chair, an inquiry follows.

Justice Varma's troubles began on March 15, when a fire at his Delhi bungalow led to the discovery of burnt cash in an outhouse maintained by him and his family. Though he denied any wrongdoing, an in-house Supreme Court panel recommended his removal, citing troubling evidence.

Justice Varma has challenged the panel's findings in the Supreme Court, questioning its authority and claiming he was denied due process. The outcome of his challenge could shape the future of judicial accountability in India.

Monsoon session like 'Vijay Utsav': PM Modi hails Operation Sindoor

Meta, Google Executives Skip ED **Summons in Online Gambling Probe**

Senior executives from tech giants Meta and Google did not appear before the Enforcement Directorate (ED) on Monday, as previously summoned, in connection with a money laundering case linked to the promotion of illegal online betting and gambling platforms. The agency has now issued fresh summons, asking them to appear on July 28, official sources confirmed.

The executives reportedly requested additional time to gather necessary documents and prepare

According to sources, the tech firms will be questioned on how advertisements for illegal betting platforms were placed across their platforms, including social media networks, search engines, and app distribution services.

India ready to extend all possible support: PM on Bangladesh plane crash

Prime Minister Narendra Modi on Monday expressed profound grief over the tragic crash of a Bangladesh Air Force training aircraft that struck a school in Dhaka, killing at least 19 people, many of them children.

In a message shared on social media platform X (formerly Twitter), PM Modi conveyed India's solidarity with Bangladesh in the wake of the disaster and assured all possible as-

"Deeply shocked and saddened at the loss of lives, many of them young students, in a tragic air crash in

Dhaka. Our hearts go out to the bereaved families," the Prime Minister said. "We pray for the swift recovery of those injured. India stands in solidarity with Bangladesh and is ready to extend all possible support and assistance."

The crash occurred in the Uttara area of Dhaka when a Chinese-made F-7 BGI training jet of the Bangladesh Air Force plunged into the Milestone School and College campus shortly after takeoff. The impact caused a massive fire, with visuals showing plumes of smoke and rescuers pulling victims from the wreckage.

Bangladeshi officials said the aircraft

had departed at 1:06 PM and crashed minutes later. Emergency responders, including the fire service, police, army, and air force helicopters, were quickly dispatched to the site.

According to eyewitnesses, the jet fell near the school's main gate during active class hours, causing maximum casualties among students and staff. Over 50 people were transported to hospitals, many of them with severe burn injuries.

The tragedy has sparked an outpouring of condolences from leaders across the region, and India's offer of assistance reflects its close historical and diplomatic ties with Banglades

"No Closure For 180 Families": **Asaduddin Owaisi**



All India Majlis-e-Ittehad-ul-Mus-Owaisi on Monday raised serious questions over the justice system after the Bombay High Court acquitted 12 men convicted in the 2006 Mumbai train blasts case. The court ruled that the prosecution had "utterly failed" to prove the charges, leading to the release of men who had spent 18 years in prison.

Reacting to the verdict, Owaisi said the outcome provides "no closure" for the 180 families who lost their loved ones in the coordinated serial bombings that killed 189 people and injured over 800. He also demanded accountability from the Maharashtra Anti-Terrorism Squad (ATS), which led the investigation.

"No Pass for Butchers": Trump Backs **Terror Tag for TRF Over Pahalgam Attack**

US President Donald Trump has voiced strong support for the Former President Biden administration's decision to designate The Resistance Front (TRF) as a Foreign Terrorist Organisation (FTO), following the group's responsibility claim for the deadly April 22 attack in India's Jammu and Kashmir region.

Trump, known for his blunt rhetoric, endorsed the move on social media, stating, "When you butcher civilians, you don't get a pass—you get justice."

The TRF, widely acknowledged as a proxy for the Pakistan-based Lashkar-e-Taiba (LeT), claimed responsibility for the Pahalgam attack that killed 26 civilians and led to a tense four-day military standoff between India and Pakistan. The designation comes amid heightened international focus on cross-border terrorism and growing calls for accountabili-



ty. The US House Foreign Affairs Committee Majority, aligned with the Republican Party, post-

firming bipartisan backing for the decision. "President Trump calls it like it is. The Resistance ed Trump's reaction online, af- Front is a foreign terrorist organization and deserves the designation," the Committee stated.

India's External Affairs Minister S. Jaishankar welcomed the designation, calling it a strong affirmation of India-US counterterrorism ties. "Appreciate @SecRubio and @StateDept for designating TRF as an FTO and Specially Designated Global Terrorist (SDGT). It claimed responsibility for the April 22 Pahalgam attack. Zero tolerance for terrorism," he posted on X. The TRF has been linked to several recent attacks in Kashmir and is considered part of LeT's broader strategy to operate under different names while avoiding direct scrutiny. The new designation is expected to limit the group's access to financial systems and international support networks.

Analysts say the move reflects deepening strategic cooperation between New Delhi and Washington on terrorism and regional security.

Russia Strikes Kyiv Hours Before NATO Talks on Ukraine Support

Russia launched one of its most intense aerial assaults on Kyiv in recent months, just hours before a high-level NATO meeting was set to discuss renewed military aid for Ukraine. The strikes killed at least two people and injured 15, including a 12-year-old child, Ukrainian President Volodymyr Zelenskyy confirmed.

The overnight barrage, which lasted from midnight to dawn, included drones and Kinzhal hypersonic missiles. Key infrastructure was hit across Kyiv, including a kindergarten, supermarket, and warehouse in the Darnytskyi district. In Shevchenkivskyi, a drone struck the entrance of a subway station filled with civilians sheltering from the blasts.

The timing of the attack underscores the growing urgency for Ukraine to strengthen its air defense capabilities. The UK and Germany are co-chairing a virtual Ukraine Defense Contact Group meeting on Monday, where U.S. President Donald Trump's new arms transfer initiative will be a primary focus. The plan involves European allies sending American weapons, including Patriot air defense systems, to Ukraine either from stockpiles or via direct purchase.

Trump has also issued a 50-day deadline to Moscow to agree to a ceasefire, warning of harsher sanctions if it fails to comply. UK Defense Secretary John Healey and German Defense Minister Boris Pistorius are expected to urge allies to accelerate support during the "50-day drive" to bolster Ukraine's military readiness.

Despite the urgency, logistical delays remain. Germany has pledged to finance and potentially donate Patriot systems but warns deliveries may take days or weeks. Meanwhile, the U.S. and NATO continue to coordinate the delivery of other military supplies.

Zelenskyy has proposed fresh peace talks, while Russia has signaled openness but remains firm on its objectives. As attacks escalate, hopes for diplomacy remain fragile amid growing military tensions.



Trump posts AI-generated video of Obama arrested by FBI

U.S. President Donald Trump ignited a fresh wave of controversy on Monday after sharing an AI-generated video depicting former President Barack Obama being arrested by the FBI in the White House. The video, posted on Trump's Truth Social platform, shows Obama being handcuffed in the Oval Office while Trump looks on with a smile.

The clip begins with a digitally altered Obama declaring, "especially the President is above the law," followed by a montage of U.S. leaders saying, "no one is above the law." The video ends with scenes of Obama in an orange prison jumpsuit, pacing inside a jail cell.

Critics have slammed the video as irresponsible and misleading, warning of the potential dangers of AI-generated misinformation, particularly when shared by a sitting president. Legal experts have raised questions about potential defamation, ethical concerns, and national stability in the wake of such digitally fabricated content.

The post comes amid renewed scrutiny of the Obama administration, following explosive statements by U.S. Director of National Intelligence Tulsi Gabbard. Gabbard, a former Democrat now allied with Trump, has called for the prosecution of Obama-era officials. She claims declassified documents show a "conspiracy" involving fabricated intelligence to implicate Russia in aiding Trump's 2016 campaign.

"The goal was to usurp President Trump and subvert the will of the American people," Gabbard posted on X (formerly Twitter). "Every person involved must be prosecuted to the fullest extent of the law."

Meanwhile, the White House amplified the rhetoric, boasting online that Trump has "crushed the left's mess" and "unleashed" the economy. In another viral post, Trump was portrayed as Superman, labeled "a symbol of hope" for the nation.

The Biden campaign has not yet responded, but political analysts warn that AI-driven political content may become a serious threat to democratic discourse.

Microsoft Urgently Patches SharePoint **Vulnerability Amid Active Exploits**

Microsoft has issued an urgent security patch for its on-premises SharePoint Server after detecting active cyberattacks targeting critical vulnerabilities. These attacks reportedly affect government agencies and businesses using SharePoint to manage and share documents within their organizations.

The vulnerabilities are confined to on-premise SharePoint servers. Microsoft 365's Share-Point Online, which operates in the cloud, remains unaffected. In its official security advisory, Microsoft revealed that the attacks exploit weaknesses that were only partially addressed in the July security update.

Bangladesh Air Force Training Jet Crashes Into School in Dhaka, 16 Dead, Dozens Injured

In a devastating incident on Monday afternoon, a Bangladesh Air Force training aircraft crashed into the Milestone School and College campus in Uttara, Dhaka, resulting in the deaths of at least 16 people and injuring dozens more, many of whom are believed to be students.

The F-7 BGI training aircraft took off at 1:06 p.m. and crashed moments later into the school premises with a loud explosion, according to a statement from the Defence Ministry. The plane reportedly burst into flames immediately upon impact.

Lima Khanam, duty officer at the Fire Service Central Control Room, confirmed the recovery of one body at the scene and stated that four injured individuals were rescued by the Air Force. However, the total death toll was later confirmed to be 16. Details regarding the pilot's condition remain unknown.

Eyewitnesses described scenes of chaos as emergency services, including firefighting units, ambulances, and Air Force helicopters, rushed to the



site. "The plane fell on the gate and crashed nearby. Classes were in session at the time. We're pulling out the injured one by one," said Shah Bulbul, spokesperson for the school. According to the Dhaka Tri-

bune, more than 50 individ-

uals were transported to the

National Institute of Burn and Plastic Surgery. While identities have not been officially confirmed, most of the victims are reportedly students.

The crash caused widespread panic and grief in the area, with concerned parents rushing to the school. A full investigation into the cause of the crash is underway, and authorities are expected to release more details in the coming hours.

This tragic event marks one of the deadliest air training accidents in recent memory in Bangladesh.

India's Economic Activity Hits in June: PMI Survey



Tndia's economic momen-**⊥**tum surged in June 2025, with business activity expanding at its fastest pace in over a year, according to the HSBC Flash Purchasing Managers' Index (PMI) survey. The Composite Output Index, which combines manufacturing and services data, rose to 61, up from 59.3 in May—its highest level in 14 months. Any reading above 50 signifies expansion, while below 50 indicates contraction.

The robust performance was primarily driven by strong export demand, increased employment, and subdued inflation, signaling a broadbased economic recovery. The PMI report highlighted that the uptick in export orders was the strongest since comparable data began in September 2014, underscoring India's growing role in global trade.

Manufacturing led the upswing, with firms reporting a sharp rise in new orders and backlogs. This backlog pressure prompted many manufacturers to accelerate hiring. The services sector

also saw improved momentum, although employment growth in services slightly eased compared to May.


HSBC's Chief Economist, Pranjul Bhandari, noted, "The combination of robust global demand and rising backlogs prompted manufacturers to increase hiring. Employment growth is also healthy in the services sec-

Encouragingly, the survey also reported a cooling in cost and inflationary pressures. Input costs for private sector companies—ranging from labor to metals like copper and steel—rose only modestly. The overall inflation rate softened to a tenmonth low and remained below the long-term average, offering relief to businesses and consumers alike.

This PMI data comes as a strong signal of economic resilience amid global uncertainties, with India maintaining growth on the back of export strength, stable inflation, and job creation across key sectors.

Rethinking Food Safety: Are We Really Aware of What We Eat?



During a recent visit to a friend who had just given birth, I was startled when she mentioned feeding donkey's milk to her one-monthold baby—a supposed traditional remedy followed by some in Bengaluru. The baby had just recovered from diarrhoea, and I was baffled that an educated woman, with a postgraduate degree no less, would trust such an unscientific practice. My reaction was disbelief. What nourishment could milk from a care-deprived animal, scavenging on garbage and drain water, possibly offer to an infant?

While this might seem like an isolated incident driven by age-old beliefs, the truth is that questionable food choices and practices are far more common than we care to admit. Think of the deep-fried bondas, bajjis, and French fries we enjoy even when we're fully aware of the health risks posed by saturated fats and poor oil quality.

The ancient Sanskrit sayare what we eat — remains profoundly relevant today.

Globally, foodborne illnesses affect 600 million people annually, claiming 420,000 lives. In India alone, nearly 100 million people fall ill due to unsafe food every year, and over 120,000 die. The reasons are widespread: adulteration, excessive pesticide use, poor hygiene in food handling, lax enforcement, and lack of proper storage infrastructure. Food safety in India often feels like a gamble, more dependent on chance than regulation.

Even young researchers are uncovering alarming data. A group of teens aged 15 to 18 recently shared findings from their study revealing the presence of acrylamide—a harmful compound—in popular snacks like French fries and paneer tikka. Acrylamide forms when starchy foods are cooked at high temperatures, thanks to the Maillard reaction—also responsible for the enticing aroma of spices in hot oil.



India to Host FIDE **Chess World Cup 2025**

Tndia will host the prestigious FIDE Chess ■ World Cup 2025 from October 30 to November 27, the international chess federation announced on July 21. The specific host city will be revealed soon. The tournament will feature 206 players competing for the coveted title and qualification spots in the 2026 FIDE Candidates Tournament.

India previously hosted the World Cup in 2002 in Hyderabad, where chess legend Viswanathan Anand claimed the title. This year's tournament will follow a knockout format, with players eliminated after each round. Since 2021, the event has been conducted as a single-elimination contest, with each round spanning three days: two classical games on the first two days and tie-breaks on the third if needed.

In the first round, the top 50 players will receive byes, while players seeded from 51 to 206 will compete. Pairings are based on matching the top half against the reversed lower half of the seed list.

The top three finishers in the 2025 World Cup will directly qualify for the 2026 Can-

didates Tournament, which determines the challenger for the World Chess Championship. Among the notable Indian players expected to compete are reigning world champion D Gukesh, 2023 World Cup runner-up R Praggnanandhaa, and Arjun Erigaisi, currently ranked world number five. The world number one Magnus Carlsen, who won the 2023 World Cup, will also




