Vizag, Vijayawada Metro Tenders Today



TPN Correspondent | Amaravati: The Andhra Pradesh government is set to invite tenders for the long-awaited metro rail projects in Visakhapatnam and Vijayawada on Friday. The combined estimated cost of the two projects stands at ₹21,616 crore. The Vizag Metro Rail Project is projected to cost ₹11,498 crore, while the Vijayawada Metro Rail Project will be taken up at an estimated cost of ₹10,118 crore. Both metro projects are being developed under a 50:50 partnership model between the central and state governments. This funding model aims to ensure timely execution with shared responsibility and financial support from both sides. To meet its share of the funding commitment, the state government has already arranged internal budgetary support through its urban development authorities. For the Vizag Metro, the state has redirected ₹4,101 crore from the Visakhapatnam Metropolitan Region Development Authority (VMRDA). Similarly, for the Vijayawada Metro, ₹3,497 crore has been allocated through the Capital Region Development Authority (CRDA). Officials stated that this marks a significant milestone in advancing urban transport infrastructure in the state's two largest cities. The proposed metro systems are expected to decongest traffic, improve urban mobility, and promote environmentally sustainable transport. With tenders being floated on friday, the groundwork for both projects is expected to gain momentum, bringing the long-pending metro aspirations of Vizag and Vijayawada residents closer to reality.

Low Pressure Triggers Rain Alert

TPN Correspondent | Andhra Pradesh: A low-pressure area has developed over the North Bay of Bengal and is likely to intensify in the next 24 hours, according to Andhra Pradesh State Disaster Management Authority (APSDMA) Managing Director Prakhar Jain. The system is expected to move northwest towards the West Bengal and Bangladesh coasts, and later towards northern Odisha and the West Bengal coastlines over the next 48 hours. Due to this development, coastal Andhra Pradesh is expected to receive scattered heavy rainfall until Sunday. Fishermen have been advised not to venture into the sea, and the public is urged to remain alert due to possible thunderstorms and lightning. On Friday, heavy rain is likely in parts of Srikakulam, Vizianagaram, Parvathipuram Manyam, and Alluri Sitarama Raju districts. Moderate to heavy showers are expected in Visakhapatnam, Anakapalli, Kakinada, Konaseema, East and West Godavari, Eluru, Krishna, and NTR districts. Light to moderate rainfall is expected in the remaining parts of the state. North Andhra may see isolated heavy rainfall on Saturday, with light to moderate showers in other regions. As of 5 PM Thursday, Seethampeta recorded 58 mm rainfall, Mandasa 49.7 mm, Munchingiputtu 44.5 mm, Chintapalli 41.5 mm, and Vajrapukotturu 40.7 mm.

SIT Acting on Yellow Media's Script: Kethireddy

Tadepalli: Former MLA Kethireddy Venkatarami Reddy launched a scathing attack on the Special Investigation Team (SIT) constituted by the TDP-led coalition government, accusing it of acting under the influence of "yellow media" rather than functioning as a legal investigative body. Addressing a press conference at the YSR Congress Party's state office in Tadepalli, Reddy alleged that the SIT's probe into the liquor scam is entirely driven by media narratives fabricated to malign YS-RCP leaders. He claimed the SIT lacks any factual or documentary evidence and is instead depending on coerced statements and manipulated witness testimonies. "Remand reports are being leaked to newspapers even before they reach the court. This clearly shows a deep nexus between

the SIT and certain sections of the media," Reddy stated.

CABINET APPROVES Rs. 70,000 Cr Investments

The Andhra Pradesh Cabinet, led by Chief Minister N. Chandrababu Naidu, met on Thursday at the State Secretariat and approved fresh investments worth ₹70,000 crore. The Chief Minister held detailed discussions with his ministers on key development issues and said the proposed industries, once grounded, would generate one lakh jobs across the state. He emphasized the need to actively pursue the implementation of these projects without delay. Industries in sectors like IT, renewable energy, electronics, drones, and automobiles will be established under this initiative. CM Naidu urged his ministers to closely monitor the grounding of these industries to ensure rapid employment generation. Housing for the poor and Green Hydrogen push

The Chief Minister stated that the Singapore consortium had played a key role in the startup area development of Amaravati, but was later forced to exit by then CM Jagan Mohan Reddy. "False corruption allegations and attempts to file cases on the consortium officials led to complete dissatisfaction from Singapore's side," Naidu noted, calling for renewed ties with the country. He revealed that the consortium is still willing to participate in proj-

hiring workers in India, and stashing profits in Ireland," Trump said. "Under President Trump, those days are over."

Calling for a renewed focus on "patriotism and national loyalty," he pressed Silicon Valley to "put America first" and prioritize domestic innovation in the AI sector. He urged US technology firms to be fully committed to American interests in the global AI race.

During the summit, Trump unveiled three major executive orders aimed at reshaping the country's AI landscape. The central initiative, titled Winning the Race, is designed to fast-track AI infrastructure development, including the expansion of data centers and the removal of regulatory hurdles to promote growth within the US.

Another directive focuses on eliminating ideological bias from AI systems built with federal funding. Trump emphasized that accuracy must come before diversity agendas, declaring, "We are getting rid of woke."

He also questioned the term "artificial intelligence," stating, "It's not artificial, it's genius," and hinted at rebranding efforts to reflect AI's real impact.

Refuting the allegations of irregularities during the YSRCP regime, Reddy said all the questioned distilleries were approved during the previous TDP government. "Not a single new distillery was sanctioned under YSRCP's rule," he asserted.

He also condemned what he described as blatant violations of court orders by the police, particularly regarding restrictions placed on the movement of his uncle, Kethireddy Pedda Reddy. He warned that officials supporting the current government's political vendetta would face consequences when YSRCP regains power.

Targeting Jana Sena chief Pawan Kalyan, Reddy accused him of losing public trust and acting as a tool for Chandrababu Naidu's political strategies. He recalled that Pawan had earlier made sensational claims about 30,000 missing girls under the YSRCP regime, but the case was later withdrawn by the coalition government. India's First Quantum Tech Hub in Amaravati: CM

The state government of Andhra Pradesh is set to achieve a major milestone in the field of quantum technology by partnering with QPI-AI (Quantum Predictive and Artificial Intelligence) in the development of Amaravati Quantum Valley. This initiative, a key component under the National Quantum Mission, marks India's first such establishment and aims to transform Amaravati into a global hub for quantum computing, innovation, and research. QPI-AI founder Nagendra Nagarajan met with Chief Minister N. Chandrababu Naidu on Wednesday to discuss the institution's involvement in the project, particularly their plan to set up an advanced 8-qubit quantum computer.



Excise Director Orders Staff Overhaul

IMS 2.0 enables agricultural officers

In a decisive move to tighten enforcement and improve accountability under the Navodayam 2.0 initiative, the Director of Excise and Prohibition, Nishant Kumar, has ordered a complete staff overhaul in two key Excise Stations in East Godavari district. The action was prompted by continued underperformance and enforcement lapses in Rajamahendravaram North and South Excise Stations.

Following a detailed review of operations and enforcement progress in the region, the department concluded that the two stations had failed to meet expectations despite repeated instructions and follow-up assessments. Issues such as poor enforcement intensity, lack of field alertness, and ineffective control over illegal liquor activities were reportedly persistent.

To address these concerns, the Director directed that all staff members posted in Rajamahendravaram North and South be transferred with immediate effect. Fresh teams drawn from other excise units have now been deployed at these stations. This reallocation is part of the department's broader strategy to inject efficiency, transparency, and responsiveness into field operations under Navodayam 2.0. The Excise Department has empha-

sized that this is not an isolated decision but part of a wider push to improve field-level enforcement across the state. Officials said that similar reviews will continue in other districts, and wherever underperformance is identified, necessary disciplinary or corrective action will follow.

Navodayam 2.0 aims to curtail illegal liquor trade, boost legal revenue, and ensure that excise policies are strictly implemented at the ground level. The initiative includes a mix of field inspections, real-time monitoring, inter-departmental coordination, and personnel accountability.

Sources in the department revealed that more station-level audits and performance reviews are scheduled in the coming weeks. The department reiterated that only personnel demonstrating commitment, vigilance, and results will continue in enforcement

This swift and comprehensive reshuffling in East Godavari is expected to send a strong message across the department about the seriousness of the Navodayam 2.0 mission.

The Andhra Pradesh Chief Electoral Officer (CEO) convened a key meeting on July 24 with representatives of national and state political parties to discuss voter list revision and election procedures. The meeting was part of a preparatory effort for the Election Commission of India's proposed Special Intensive Revision (SIR) of electoral rolls across the country. During the discussions, the TDP delegation voiced strong opposition to using the 2002 voter rolls from undivided Andhra Pradesh as the base for the SIR. They pointed out that many people from Andhra region who migrated to Hyderabad before the state's bifurcation would face challenges in restoring their voting rights if 2002 is used as the baseline. Instead, the TDP urged that the 2014 voter list, prepared during the state bifurcation, be treated as the standard reference. Andhra Pradesh Minister for Water Resources Dr. Nimmala Ramanaidu paid rich tributes to Sir Arthur Cotton at the Secretariat in Amaravati on the occasion of his death anniversary. He described Cotton as a visionary British engineer who played a crucial role in constructing the Dhavaleswaram Anicut and developing extensive canal systems in the Godavari and Krishna regions, thereby revolutionizing agriculture in the state.

The minister took the opportunity to criticize the previous YS-RCP government, claiming that Sir Cotton's soul would be anguished by the damage inflicted on the irrigation sector over the past five years. He accused the former regime of stalling the Polavaram project and causing overall destruction to the state's irrigation systems. Dr. Ramanaidu stated that under Chief Minister N. Chandraba-



bu Naidu's leadership, the government is putting irrigation projects back on track. Inspired by Cotton's legacy, the Chief Minister has proposed the Polavaram-Banakacharla Link Project to prevent Godavari floodwaters from being wasted in the

This project aims to divert the surplus waters to droughtprone areas, particularly benefiting the Rayalaseema region. The minister highlighted the Chief Minister's commitment to linking rivers across the state to eliminate drought and ensure water security. He assured that the completion of the Polavaram project will provide irrigation and drinking water to both Uttarandhra and Rayalaseema regions, helping to fulfill the government's vision of inclusive water distribution.

After the coalition government assumed power, ₹700 crore has been allocated for maintenance works on irrigation canals and drainage systems.

These funds are being used to ensure the smooth supply of irrigation water across the state, marking a significant step toward agricultural revival and rural development.

Srikanth Reddy Slams Coalition

YSRCP state general secretary Gadikota Srikanth Reddy strongly criticized the NDA coalition government in Andhra Pradesh, accusing it of ignoring public welfare over the past 14 months. Addressing media in Rayachoti, he said that not a single community has benefited under the coalition regime.

He alleged that the government is misleading the people with tall claims of capital development, massive investments, and job creation, which have no visible impact at the grassroots level. "Rather than focusing on people's welfare, the government is trying to divert public attention with liquor scams and politically motivated cases," he stated.

Srikanth Reddy slammed the government for deteriorating law and order, saying that police are being directed to act on political interests, reflecting a situation akin to emer-



gency rule. He questioned actor-turned-politician Pawan Kalyan's silence on increasing crimes against women despite his past promises of protecting 30,000 women.

Referring to incidents in Gandikota and Mucchumarri in Nandyal district, he criticized the government's inaction on rising crimes against women and children, accusing it of completely ignoring public safety.He contrasted this with

the welfare programs implemented during the YSRCP regime, including Amma Vodi, Rythu Bharosa, EBC Nestham, Kapu Nestham, zero-interest loans to DWCRA women, insurance premiums paid by the government, two lakh permanent jobs, and establishment of secretariats, village clinics, ports, and medical colleges—even during the pandemic years.

He accused the current government of betraying mothers in the name of "Talli ki Vandanam" by delaying payments and excluding many students from benefits. He demanded pending payments be cleared immediately.

Criticizing a minister's recent remarks that implementing a ₹1,500 monthly assistance for girls would bankrupt the state, he said the coalition lacks genuine commitment to welfare. He added that despite the Kharif season nearing its end, there is no clarity on Rythu Bharosa payments this year.

No Arrest Till Month-End

Perni gets interim relief from the HC

Former Andhra Pradesh minister Perni Venkataramaiah, popularly known as Perni Nani, has once again secured interim relief from the High Court in a case registered against him for alleged provocative remarks. The court has ordered that no coercive action be taken against the former minister until July 31, providing him with temporary protection from arrest or any immediate legal proceed-

The case was filed based on allegations that Perni Nani made inciting statements that could provoke unrest. In response, the former minister moved the High Court seeking anticipatory bail and protection from any immediate action by law enforcement agencies. After considering the arguments presented by both sides, the court extended the interim stay on action that was previously granted, effectively barring authorities from initiating any hasty steps in the case.

This extension of relief means that police or investigative agencies are restrained from proceeding against him until the next date of hearing. The High Court is expected to take up the matter again after July 31.



Fisherman's Family Get Immediate Aid

APTS to Hold Cyber Awareness **Drives**

He said that with the rise in online frauds, educating people on how cybercriminals operate and how victims can report such incidents has become essential. APTS is playing a critical role in continuously monitoring IT infrastructure across the state and providing timely alerts to prevent cyber threats.

Highlighting the recent global surge in cybercrimes, he stressed the need to use technology to counter such threats. APTS recently conducted a state-level cybersecurity hackathon, 'Hackathon 2025', offering six-month training programs to selected graduates and IT professionals. Certificates were distributed to 30 interns who completed the program, opening up job opportunities in leading IT firms across India and abroad.

Mohana Krishna pointed out that cybercriminals are misusing betting apps, stealing data, and launching attacks on businesses to cause financial losses. To counter this, the state is intensifying awareness campaigns featuring film celebrities across various media platforms.

He noted that APTS serves as the nodal agency for the state's cybersecurity initiatives, in alignment with the 2017 state cybersecurity policy and the 2013 central law. The Andhra Pradesh Cyber Security Operational Centre (APCSOC), established in 2018, continuously monitors cyber threats targeting government departments.

APTS now plans to expand its cybersecurity auditing services beyond government departments into the private sector and other states. The chairman emphasized that the agency's mission is to build a secure digital future for Andhra Pradesh by empowering its youth.

8 Arrested in Inter-**State Drug Racket**

In a major breakthrough against drug trafficking, Vizianagaram district police have arrested eight individuals and seized 120 kilograms of ganja being transported in three cars. Based on credible intelligence, Bhogapuram and Eagle police teams carried out checks near Rajapulova Junction and intercepted the vehicles coming from Vizianagaram. During the operation, police recovered 47 packets of ganja, nine mobile phones, and three cars an Alto (OD 05 H 8352), a Santro (OR 15 M 7782), and a Swift (UP 24 BL 0902).

District SP Vakkul Zindal, briefing the media, stated that the accused were part of an inter-state smuggling network planning to transport the narcotic to Delhi and Uttar Pradesh. The arrested include Korra Kiran (21) and Manoj Bisai (20) from Lantavur village in Koraput district, Odisha; Bijendra (46) from Hapur district, UP; Fazil (30) from Old Seemapur, Delhi; Mukhtar Ahmad (43) and Rammohan (21) from Budaun district, UP; and Sonu (34) and Shilpi (30) from Kasganj district, UP.

Initial investigations revealed that the accused procured the ganja from suppliers in Odisha and planned to move it via cars and trains to North India. The gang had deep connections with ganja traders operating from Odisha. One more accused, Ajith Dadak alias Oji alias Mahesh Dadak, believed to be the main conspirator, is currently absconding. Efforts are underway to apprehend him at the earliest.

SP Zindal stated that strict action will be taken under the Narcotic Drugs and Psychotropic Substances (NDPS) Act, and financial investigation is also underway to trace the source of funds and networks involved. Authorities are considering invoking the Preventive Detention (PD) Act against the accused to curb repeat offenses.

Appreciating the swift and coordinated action, SP Vakkul Zindal congratulated Bhogapuram CI K. Durga Prasad, Eagle CI Dr. Tenka Kalyani, SI P. Paparao, and their police teams. Certificates of appreciation were handed over to the officers for their crucial role in foiling the smuggling attempt and strengthening the district's anti-narcotics operations.

Collector Directs DRDA to Fast-Track Loans

Vetriselvi has directed DRDA officials to expedite the sanctioning of loans to Self-Help Groups (SHGs) and ensure timely achievement of assigned credit targets. Speaking via video conference from the Eluru Collectorate on Thursday, she reviewed the progress of SHG loan disbursements, grounding of employment units, and other key issues with DRDA APMs and community coordinators.

Collector Vetriselvi emphasized the state government's commitment to the economic empowerment and welfare of women. She noted that microcredit plans have already been submitted to banks for disbursing ₹1,145.20 crore to 15,353 SHGs across the district. Of this, banks have so far approved ₹237 crore for 2,888 SHGs. Officials Blamed for Vaikunta **Ekadashi Stampede**

The Andhra Pradesh government has received the final report from the judicial commission investigating the tragic stampede during Vaikunta Ekadashi celebrations at Tirumala, which resulted in six deaths. The report was discussed at length in the state cabinet meeting held in Amaravati.

According to the commission, SP Subbarayudu and then TTD Chief Vigilance and Security Officer (CVSO) Sridhar were given a clean chit.

The commission observed that both officials worked in coordination and took all necessary safety precautions prior to the event.

However, the blame was placed squarely on the negligence of TTD Director Harinath Reddy and DSP E.V. Ramana Kumar.

these two officials failed to

implement proper crowd control measures, especially near the Padmavati Park area where the stampede occurred. Despite having police and TTD rope parties deployed at the location, the report stated that the duo disobeyed orders from higher authorities and irresponsibly ordered the gate to be opened, leading to the uncontrolled rush.

Further, the report highlights the inability to promptly shift the injured to medical facilities. Although two ambulances were stationed nearby, the mismanagement led to fatal delays in treatment. As a result, six pilgrims lost their lives.

When the Artificial Overwhelms...

A Reflection on the Digital Age's Silent Sway Over Nature

"The more we surround ourselves with artificial comforts, the more our inner nature cries for the nature's touch." Once upon a time, humanity lived in tune with the rhythms of the sun, the breeze, and the birdsong. Today, we wake up not to the chirping of sparrows but the ping of smartphones. The contrast is stark: artificiality has not just entered our lives—it dominates them.

But the haunting question remains: how much naturality still survives in this engineered existence?

The Artificial Age: **A Statistical Snapshot**

- 6.9 billion people, or 86% of the global population, use smartphones (GSMA, 2024).
- An average adult spends 7.5 hours a day on screens — more than their sleeping time(Statista, 2023).
- Only 27% of the global workforce is directly or indirectly connected with agriculture or nature-based work today, compared to over 60% just five

- decades ago (World Bank, 2022). More than 80% of the food
- consumed in urban households globally is either processed or packaged (UN FAO report, 2023).
- **Urban areas now host over 56%** of humanity, projected to rise to 70% by 2050 (UN Habitat, 2022).

Artificial Isn't All Bad — But It's Not All Good Either

To be clear, artificiality has brought unimaginable progress:

- Medical miracles through biotechnology,
- Connectivity across continents in seconds,
- Comfort and convenience in everyday life.

Yet it comes at a cost disconnection from self, soil, and soul.

Mental health issues have skyrocketed: the WHO notes a 25% increase in anxiety and depression globally since the pandemic — much of it attributed to isolation, screen fatigue, and lack

of natural engagement. Children today are more likely to know the iPhone model than the names of common birds. A study by the UK's Natural Trust (2023) showed that only 1 in 5 children could identify a robin or

an oak tree, while 4 in 5 could name at least five Pokémon characters.

Where Naturality Still Holds Ground

Despite the dominance of the artificial, naturality hasn't surrendered. It survives in:

- The rising popularity of organic farming and slow food movements.
- The explosion of nature therapy and eco-tourism.
- **Urban community initiatives** like green roofs, balcony gardens, and bird-feeding corners.



A Half-Century of **Unforgotten Sacrifice**









Girayipalli, July 25, 2025: Fifty years ago today, four student activists—Surapaneni Janardhan Rao, Lanka Muralimohan Reddy, Sudhakar, and Anand Rao—were killed in what was later acknowledged as a "fake encounter" by Andhra Pradesh Police at Girayipalli in Medak district. Their deaths remain one of the most controversial and harrowing episodes of the Emergency era .

Janardhan Rao, born August 24, 1950, in Krishna district, had earned a gold medal in engineering at REC and emerged as a charismatic leader in the revolutionary student movement. Alongside him were Lanka Muralimohan Reddy of LB College, and Hanmakonda Junior College students Sudhakar and Anand Rao. In mid-1975, barely a month after Indira Gandhi's Emergency was imposed, the quartet traveled to Medak district to help expand the People's War Party—then an underground left-wing organization. Their growing influence and covert activities attracted swift attention from local authorities.

Commemorations at Girayipalli today include an exhibition of original manuscripts, a public reading of the Commission's report, and candlelight vigils. "Their sacrifice isn't just a relic of the past," said S.P. Mohan Rao, editor of the memorial publication. "It's a clarion call to defend civil liberties whenever they are under threat."

Local NGOs have petitioned the High Court to reopen compensatory claims for the families and to review current police-encounter policies to prevent recurrence. As contemporary debates over campus freedom law-and-order excesses gain momentum across India, the Girayipalli killings serve as a stark reminder: unchecked state power can trample rights under the guise of security.

A Decade Later, Telangana's **Battle for Krishna River Water Continues**

More than ten years after Telangana split rivalry between Telangana's first Chief from Andhra Pradesh, the state's struggle to secure its rightful share of Krishna river water remains unresolved, exposing deep political and administrative challenges.

The Krishna river, flowing through Telangana, Andhra Pradesh, Maharashtra, and Karnataka, is central to this dispute. Telangana and Andhra Pradesh share two major dams on the river: the Srisailam and Nagarjunasagar projects. The Srisailam dam regulates about 811 thousand million cubic feet (TMC) of water, with Telangana allocated 299 TMC and Andhra Pradesh receiving the remainder. At Nagarjunasagar, which holds 285 TMC, Telangana's share is 90 TMC.

Despite clear allocations, Andhra Pradesh has frequently been accused of exceeding its water share, hurting Telangana's agricultural and developmental prospects. In November 2023, tensions escalated when Andhra Pradesh authorities released over 2,000 cusecs of water from the Nagarjunasagar dam—beyond its entitlement—while Telangana was focused on elections. The incident sparked a police standoff, highlighting the fragile nature of water sharing between the two states.

The Centre established the Krishna River Management Board (KRMB) to oversee the equitable distribution of water between Telangana and Andhra Pradesh. The KRMB, comprising officials from both states and the central government, was expected to settle disputes and ensure compliance with the agreed 66:34 water-sharing ratio. Yet, a decade on, its effectiveness remains limited as disputes persist.

Water issues are deeply intertwined with politics. At Telangana's formation, the Minister K Chandrashekar Rao (KCR) and Andhra Pradesh's then-leader N Chandrababu Naidu added fuel to the dispute. Naidu's party had to share Hyderabad, the joint capital, with Telangana for ten years after bifurcation, complicating relations.

The political landscape shifted in 2019 with the rise of YSR Congress Party's Jagan Mohan Reddy in Andhra Pradesh, briefly raising hopes for improved cooperation. However, the honeymoon ended quickly when Andhra Pradesh unilaterally used 3 TMC of water from the Srisailam dam without informing Telangana or the KRMB, reigniting mistrust.

Telangana has also sought a revision of the water-sharing formula. The Bharat Rashtra Samithi (BRS) government, under KCR, pushed for a 50:50 split instead of the current 66:34, citing the state's growing water needs, especially for major projects like the Kaleshwaram lift irrigation scheme. This demand is currently under consideration by the Brijesh Kumar tribunal.

Meanwhile, Andhra Pradesh continues to advance its own projects, such as the Polavaram irrigation project on the Godavari river, aimed at irrigating millions of acres and supplying drinking water to Visakhapatnam.

With the Congress now in power in Telangana—a party historically opposed to Andhra Pradesh's TDP—the political divide remains a significant barrier to resolving the water dispute. For a fair and lasting solution, the KRMB must be empowered and allowed to function effectively, ensuring both states receive their rightful share and protecting the interests of millions dependent on the Krishna river.





Historic day for India-UK relations: PM

In a major milestone for bilateral ties, India and the United Kingdom on Thursday signed a historic Free Trade Agreement (FTA) aimed at significantly enhancing market access, reducing tariffs, and doubling trade between the two nations by 2030.

Prime Minister Narendra Modi and British Prime Minister Keir Starmer witnessed the signing of the comprehensive deal at Chequers, the official country residence of the UK Prime Minister. "Today is a historic day in India-UK relations," Modi declared, calling the agreement the result of "many years of hard work."


The pact will remove or lower tariffs Beyond trade, both leaders discussed

Nearly 99% of Indian exports are expected to benefit from tariff reductions, especially in sectors such as textiles, footwear, gems and jewellery, seafood, and engineering goods. Additionally, the deal will open up new opportunities in the British market for Indian agricultural and processed food products—providing a boost to farmers, fishermen, and MSMEs.

British exports will also see gains, with cuts in tariffs on whisky and automobiles, two key products for the UK market. PM Starmer called the agreement "the biggest and most economically significant trade deal the UK has signed since Brexit."

Speaker Birla Likely to **Announce Inquiry Panel**

Lok Sabha Speaker Om Birla is expected to soon announce the formation of a three-member inquiry committee to investigate allegations against Allahabad High Court Judge Yashwant Varma, official sources confirmed.

The move comes after a notice signed by 152 Members of Parliament was submitted to Speaker Birla on July 21, which now stands as a "property of the House." Consultations have begun for forming the committee as per the Judges (Inquiry) Act. It will consist of either the Chief Justice of India or a Supreme Court judge, a Chief Justice from a high court, and a distinguished jurist.

A similar notice, backed by 63 opposition MPs, was also submitted on the same day to former Rajya Sabha Chairman Jagdeep Dhankhar. This has drawn both Houses of Parliament into the consultation process. As per procedure, the Speaker is expected to write to the Chief Justice of India to nominate the two judges, while the Speaker will independently select the eminent jurist.

The issue has triggered intense political discussions involving key figures including Home Minister Amit Shah, Rajya Sabha Leader JP Nadda, Speaker Om Birla, and Rajya Sabha Deputy Chairman Harivansh, who took charge after Dhankhar's sudden resignation. Dhankhar stepped down citing health reasons but is believed to have faced government displeasure for accepting the opposition-sponsored notice in the Rajya Sabha.

According to the Judges (Inquiry) Act, when such notices are filed in both Houses on the same day, a joint committee is formed. The panel is tasked with probing the grounds on which the judge's removal is being sought. An opposition MP involved in the process said they are still awaiting further updates from the Chair.

DGCA Issues Four Show Cause Notices to Air India Over 29 Safety Violations

The Directorate General of Civil Aviation (DGCA) has served four show cause notices to Air India citing 29 violations related to flight crew rest norms, under-deployment of cabin crew on ultra long-haul flights, and lapses in training. The aviation watchdog has raised serious concerns about unresolved systemic failures in safety oversight, despite previous warnings and interventions.

The notices highlight 19 violations connected to pilot training, including failure to complete mandated refresher programs on time. These also include lapses in specialized training required for flights to Kathmandu, which has a challenging table-top runway. These breaches were record-



ed over a 12-month period from July 2024 to June 2025.

Three incidents of non-compliance with weekly rest requirements for flight crew—one first officer and two captains—were also flagged. Additionally, the DGCA noted that Air India operated four ultra-long haul respectively. Further violations in-

flights between April 27 and May 2, 2025, with fewer cabin crew than the mandatory requirement. On an April 27 flight from Chicago to Delhi, only 12 cabin crew were deployed instead of the required 15. Similar shortfalls were found on flights from Toronto and Mumbai to Delhi and Newark,

cluded three instances of cabin crew operating flights with expired competency cards, and one crew member assigned duty despite a prior safety infraction involving the accidental deployment of an evacuation slide.

The DGCA criticized Air India's continued failure to address systemic issues in compliance monitoring and crew training governance. The regulator noted a lack of effective control mechanisms and raised concerns about the airline's overall safety management.

Air India has 14 days to respond. In a statement, the airline acknowledged receipt of the notices and affirmed its commitment to crew and passenger safety, stating it will respond within the given timeframe.

CBI Investigates Evidence Tampering in RG Kar Medical College Rape-Murder Case

The Central Bureau of Investigation (CBI) has expanded its probe into the rape and murder of a trainee doctor at Kolkata's RG Kar Medical College, examining a possible larger conspiracy to tamper with evidence and suppress the case. The 31-year-old doctor was found raped and murdered in a hospital seminar room on August 9, 2024, sparking nationwide protests and demands for justice.

In its fifth status report filed on July 16 in a sessions court, the CBI revealed it has questioned seven witnesses and is now exploring whether other individuals were involved in efforts to cover up the crime. The report, reviewed by NDTV, indicates ongoing investigation "on the aspect of larger conspiracy in attempt to hush up the matter and tampering of evidence."

As part of its exhaustive probe, the agency has scanned a massive 32 terabytes of CCTV footage and reviewed over 200 pieces of post-incident media coverage—including videos, images, and news articles—for actionable information.

Sanjay Roy, a civic volunteer with the Kolkata Police, was convicted and sentenced to life imprisonment for the rape and murder. However, the victim's parents and protesting junior doctors continue to allege deeper institutional failures and demand full transparency in the investigation.

In April, the victim's father accused the CBI of submitting contradictory reports to different courts and claimed the agency is withholding key findings. "We had faith in the CBI, but now we are losing all hope," he said, expressing frustration over the pace and consistency of the probe. Junior doctors, who had staged a 17-day hunger strike last October, plan to hold a torchlight rally on the night of August 8-9 to mark one year since the incident and renew calls for justice and accountability.

India-US NISAR Satellite Set for Launch

Promises Global Impact on Earth Monitoring

In a landmark collaboration between India and the United States, the \$1.3 billion NA-SA-ISRO Synthetic Aperture Radar (NISAR) satellite is set to launch on July 30 from Sriharikota, Andhra Pradesh. This groundbreaking Earth observation mission is the largest-ever partnership between NASA and ISRO and aims to transform how we study and respond to changes on our planet.

NISAR, weighing 2,392 kg, is designed to scan the entire globe with unmatched precision every 12 days, regardless of weather or time of day. Using its dual-frequency radar system—NASA's L-band and ISRO's S-band—the satellite will track both surface and subsurface changes such as earthquakes, landslides, glacier movements, urban development, and vegetation dynamics.

What sets NISAR apart is its high-resolution imaging through synthetic aperture radar (SAR) and interferometry techniques. These allow it to simulate a massive antenna for detailed imagery and

detect ground displacement over timeessential for understanding tectonic shifts and environmental degradation.

The mission will be crucial for disaster response, infrastructure monitoring, water and food security, and climate science. From detecting groundwater depletion to tracking coastal flooding and forest density, NISAR's open-access data will serve governments, researchers, and private sectors worldwide.

Built and tested over five years, NISAR is a 50-50 venture reflecting strong India-US space ties. NASA's Paul Rosen calls it a "high-definition movie of the Earth," while ISRO's involvement includes providing the GSLV-F16 launch vehicle and spacecraft components.

As the world faces growing environmental and climate-related challenges, NISAR stands out as a symbol of scientific innovation and international cooperation. Its launch marks a strategic milestone for India's expanding space ambitions and a new era in global Earth observation.

Trump Tells Tech Giants to Stop Hiring from India

Washington, D.C. — U.S. President Donald Trump has urged American tech giants to stop building factories abroad and hiring workers from countries like India, calling for a shift away from what he termed "radical globalism." Addressing the All-In Podcast and the Hill & Valley Forum AI Summit on Wednesday, Trump emphasized that companies like Google, Meta, and Microsoft must prioritize American jobs and infrastructure.

"For too long, much of our tech industry pursued a radical globalism that left millions of Americans feeling distrustful and betrayed," Trump said. He criticized major corporations for "reaping the blessings of American freedom" while outsourcing labor to India and manufacturing to China, and shifting profits to tax havens like Ireland.

The remarks came as Trump unveiled his administration's new "AI Action Plan," which includes three key executive orders: streamlining permitting for AI infrastructure, boosting U.S. AI exports, and banning federal use of politically biased AI systems.

Trump announced that American tech firms are projected to invest over \$320 bil-



this year, with Nvidia committing an additional \$500 billion over four years. He described this as a pivotal moment for domestic industry and job creation.

"We're going to build up our own nation," Trump declared. "This investment will create thousands of high-paying, blue-collar jobs."

lion in AI and data center infrastructure He also took a swipe at former President Joe Biden, claiming the previous administration's AI export restrictions pushed allies toward China. Trump said he has reversed those measures, calling it essential to maintain U.S. technological leadership.

> "With your help, the golden age of America will be built by American workers, powered by American energy, and driven by American AI," Trump concluded.

India Urges Gaza Ceasefire, Says Pauses 'Not Enough'

India has called for a full ceasefire in Gaza, emphasizing that "intermittent pauses in hostilities" fall short of addressing the deepening humanitarian crisis in the region. Speaking at a United Nations Security Council open debate on the "Situation in the Middle East, including the Palestinian question," India's Permanent Representative to the UN, Ambassador Parvathaneni Harish, expressed deep concern over the ongoing suffering of civilians in Gaza.

"Today's meeting takes place against the backdrop of a persisting humanitarian crisis in Gaza," Harish said. "Intermittent pauses are not enough to address the scale of challenges confronting the people, who are facing daily shortages of food, fuel, medical care, and education."



support for the Palestinian people and stressed that humanitarian assistance must be allowed to flow in "safely, timely, and sustainably." He urged the release of all hostages and called for peace through dialogue and diplomacy, asserting that "there are no other fixes or solutions."

India, one of the first non-Arab countries

to recognize the State of Palestine, maintains a historically strong relationship with the Palestinian people. Harish described the health and education situation in Gaza as "particularly troubling," citing World Health Organization data that 95% of hospitals in the region are damaged or destroyed. He also noted that over 650,000 children have been out of school for more than 20 months, as reported by the UN human rights office.

Harish reaffirmed India's long-standing Looking ahead, India welcomed the upcoming High-Level International Conference on implementing the two-State solution, scheduled for July 28–30, expressing hope that it will lead to concrete progress toward peace.

Israel and Ukraine to Launch Talks on **Countering Iran's Threats**

Israel and Ukraine have announced a new initiative to begin formal talks focused on addressing the "threat" posed by Iran, signaling closer cooperation between the two nations. Both countries view Iran—a key ally of Russia—as a destabilizing force on the global stage.

Ukrainian Foreign Minister Andriy Sybiga and Israeli Foreign Minister Gideon Saar made the announcement during a press conference in Kyiv on Wednesday. Saar is the highest-ranking Israeli official to visit Ukraine since 2023.

Sybiga referred to Iran as an "existential threat to global security," citing Tehran's ongoing military support to Russia, including Iranian-designed drones used in attacks on Ukraine. "Our countries face common security challenges. Today, we have decided to launch a separate dialogue on the Iranian threat," Sybiga said.

Saar emphasized that limiting Iran's access to advanced weapons and technology is vital not only for Israeli security but also for European stability. "Any effort to curb Tehran's reach contributes to the security of Europe and Ukraine," he noted.

Ukraine has previously criticized Israel's neutral stance on the Russia-Ukraine war, but this new step points to growing strategic alignment. Kyiv has been vocal about Iran's role in supplying arms to Moscow, especially drones that have been used to target Ukrainian infrastructure.

Last month, Israel carried out a surprise bombing campaign targeting Iran's military and nuclear facilities. Ukraine supported the operation, viewing it as aligned with their mutual concerns about Tehran's influence.

The upcoming dialogue is expected to focus on intelligence sharing, defense cooperation, and joint diplomatic efforts to counter Iran's regional and global activities.

PM Modi's visit also aims to reset ties after recent tensions and will include high-level talks with President Mohamed Muizzu to review the India-Maldives Comprehensive Economic and Maritime Security Partnership, marking 60 years of diplomatic relations.

Passenger Plane Crashes in Russia's Far East, 50 Feared Dead

An Antonov An-24 passenger plane carrying around 50 people crashed in Russia's Far East on Thursday, with initial reports suggesting that everyone on board may have perished. The plane, operated by Siberia-based Angara Airlines, was en route from Blagoveshchensk to the remote town of Tynda in the Amur region near the Chinese border when it disappeared

Russian emergency services confirmed that the burning fuselage of the nearly 50-year-old Soviet-era aircraft was spotted on the ground by a helicopter. Rescue teams are currently making their way to the crash site, which lies in a

densely forested and hilly area about 15 kilometers from Tynda. Unverified helicopter footage shared on social media showed the wreckage amidst thick forest cover.

Preliminary information from regional governor Vasily Orlov indicated there were 43 passengers, including five children, and six crew members aboard the flight. However, the Russian emergencies ministry put the total number of people on

board at around 40.

The Antonov An-24, built in 1976, lost contact as it approached its destination. The crash has prompted an official investigation to determine the cause of the accident.

Yuliya Petina, a Russian emergency official, shared updates on Telegram, confirming that rescuers had located the burning aircraft fuselage and were heading to the site to carry out recovery and rescue operations.

This tragic incident highlights the risks associated with operating older aircraft in remote and challenging environments. Further details are awaited as rescue efforts continue and investigators begin their work to uncover the circumstances leading to the crash.

Rupee Strengthens by 14 Paise to Close at 86.59 Against US Dollar

Amid Equity Rally and Lower Oil Prices



The Indian Rupee appreci-■ ated by 14 paise to close at 86.59 (provisional) against the US dollar on Friday, June 20, 2025, supported by a decline in global crude oil prices and a weakening greenback, forex from expectations that the uptraders said. The local currency's gain was further bolstered by robust performance in domestic equity markets and inflows from foreign institutional investors (FIIs).

The Rupee opened at 86.65 at the interbank foreign exchange and traded within a narrow band of 86.55 to 86.67 before settling at 86.59, marking a modest recovery after hitting a two-month low the previous day. On Thursday, the Rupee had dropped 30 paise, closing at 86.73, marking a combined loss of 69 paise over the past three sessions.

Maneesh Sharma, AVP-Commodities & Currencies at Anand Rathi Shares and Stock Brokers, noted that the Rupee's weakness this month largely stemmed from geopolitical tensions, particularly following Israeli strikes on Iranipushed Brent crude oil futures to a five-month high near \$79 per barrel. "The local currency was comforted by a dip in oil prices after the White House indicated that President Don-

ald Trump will decide within two weeks whether the US will intervene in the Israel-Iran conflict," Sharma added.

Market optimism also stems coming HDB Financial IPO will attract significant investment inflows, which could provide further support to the Rupee. Analysts predict the Rupee may continue to trade in a range between 86.20 and 86.70 in the early part of next week.

Steel Sector Hit Hard by Abrupt Quality **Compliance Deadline**

The steel industry is bracing for significant challenges following a sudden notification by the Ministry of Steel that extends quality certification requirements to the inputs used in steel production, including imported raw materials. Released on June 13, 2025, the notification mandates compliance with the Bureau of Indian Standards (BIS) for all steel inputs, effective immediately for imports with a bill of lading dated June 16 or later—leaving industry players less than one business day to adjust.

This extension of the Quality only finished steel products but also the raw materials and semi-finished goods entering India must meet stringent quality standards. For example, steel slabs supplied by a Malaysian firm to a Vietnamese company, which processes

them into sheets and exports to India, must now ensure BIS certification at every stage.

Control Order (QCO) means not Industry leaders warn this will severely disrupt the supply chain and escalate costs, particularly impacting Micro, Small, and Medium Enterprises (MSMEs). Pankaj N. Umrania, Executive Director at KND Steel, highlighted the difficulties importers will face, not-

ing the increased compliance burden and potential production delays. "Manufacturers will struggle to import now, production will be hampered, customers affected, and delays inevitable," he said. He added that the absence of government support and the need to navigate complex paperwork will further strain businesses.

Pankaj Chaddha, Chairman of

the Engineering Exports Promotion Council of India, emphasized that MSME importers dealing in semi-finished goods would bear the brunt of this sudden change.

The key concern is the extremely short notice. With the order dated June 13 and effective for shipments from June 16, importers were given no working days to ensure compliance. Ajay Srivastava, former Director General of Foreign Trade, called the timeline "unrealistic," stating that even a month's notice would have been insufficient due to the long lead times typical in the steel industry.

Industry experts urge the government to reconsider the timeline to avoid severe disruption across the steel manufacturing ecosystem.

No-Shows and Surprise Guests

Afrench restaurant's strict new policy is stirring debate online after the owner announced fines for customers who don't show up as expected. L'îlot, a cozy 20-seat restaurant in Amboise, is run by chef and owner Olivier Vincent, who recently introduced a ₹1,500 (15 euros) fine for any guest who arrives with a different number of people than stated in their reservation.



Vincent explained that this policy came about due to repeated frustrations caused by no-shows and unexpected extra guests turning up without prior notice. Such changes disrupt the restaurant's smooth operation, seating arrangements, and food preparation, which are all carefully planned for each reservation.

In a Facebook post, Olivier Vincent made it clear that any change in party size without warning would result in a fine of €15 per missing or extra person. His caption read simply: "Without warning obviously....."

Despite this strict stance, L'îlot enjoys an impressive 4.7-star rating on Google, reflecting the high quality of its dining experience and the respect many customers have for the restaurant.

The fine aims to encourage responsibility and better communication from diners, helping the small restaurant avoid last-minute disruptions and losses. It also reflects a growing trend among popular eateries worldwide that face similar challenges with no-shows and unpredictable guest numbers.

While some patrons have supported the decision as fair and necessary, others have criticized it as too harsh. Still, Vincent remains firm, emphasizing that the policy ensures the restaurant can continue to provide excellent service to all guests without the stress of unexpected changes.

Have you ever sat on a plane, gazing out the tiny window and wished it were larger for a better view? While it may seem like an aesthetic choice, there are critical safety and engineering reasons why airplane windows are small and round.


1. Structural Integri-

Airplane windows are built into the fuselage — the main body of the aircraft. Making them larger would weaken the fuselage's structure. Large windows would be more vulnerable to damage

and harder to seal against extreme pressure differences experienced during flight. Smaller windows help maintain the overall strength and airtight integrity of the aircraft.

2. Aerodynamic Efficiency:

Larger or oddly shaped windows would disrupt the smooth airflow over the plane's surface, increasing drag and reducing fuel efficiency. Small windows keep the plane streamlined, helping it fly faster and more efficiently.



In the 1950s, early jet airliners like the De Havilland Comet had square windows. But as airlines started flying at higher altitudes to save fuel, aircraft cabins had to be pressurized. The square windows became weak points due to their sharp corners. Tragically, this led to two catastrophic middisintegrations in 1953 and 1954. Investigations revealed that stress cracks developed around the square edges, causing fatal metal fatigue.

4. Why Round Is Safer:

Engineers learned that round or oval windows distribute pressure more evenly and eliminate weak spots. The smooth curves of circular windows reduce stress concentration, significantly lowering the risk of structural failure. This design has become a standard in aviation safety ever since.

In short, airplane windows may be small and round, but they're crucial for ensuring the structural safety and aerodynamic performance of modern airliners — keeping passengers safe high above the clouds.

Why Desert Nation Saudi **Arabia Imports Sand for** Construction


Tt may sound ironic, but **L**Saudi Arabia, a country known for its vast deserts, imports sand from other nations like Australia, China, and Belgium. The reason? The sand found in Saudi deserts is not suitable for construction purposes.

Desert sand, shaped over millennia by wind, has smooth, rounded grains. These grains do not bind well with cement and water, making them unfit for construction. In contrast, construction-grade sand—

used to build everything from skyscrapers to highways—must have rough, angular grains, typically found in riverbeds, lakes, and seabeds. These qualities allow the sand to form a strong bond with cement, essential for stable structures.

As part of its Vision 2030, Saudi Arabia has embarked on massive infrastructure projects like NEOM, The Red Sea Project, and Qiddiya, driving up the demand for high-quality sand. In 2023 alone, Saudi Arabia imported \$140,000 worth of sand from Australia, which was the second-largest global exporter of construction-grade sand that year, supplying over \$273 million worth worldwide.

Saudi Arabia isn't alone. Other Gulf nations like the UAE and Qatar also import sand to support their fast-paced urban growth. According to a 2024 UNEP



report, this trend highlights a global sand crisis. Around 50 billion tonnes of sand are consumed annually, but only a small fraction is suitable for construction. Excessive extraction is now linked to environmental degradation, including river erosion, habitat loss, and biodiversity decline.

In response, countries are turning to sustainable alternatives such as manufactured sand (M-sand) produced by crushing rocks—and recycled construction waste. While these solutions offer hope, widespread implementation remains a work in progress.




Hari Hara Veera Mallu **Review: A Visually Grand, Yet Uneven Period Saga**
