Illegal Surrogacy and Child Sale Racket Busted

Hyderabad North Zone DCP Rashmi Perumal announced the successful bust of a large-scale illegal surrogacy and child trafficking racket operating through Universal Srushti Fertility Centers. Police arrested eight individuals, while two suspects remain absconding. The prime accused, Dr. Atluri Namrata alias Pachipala Namrata (64), is the owner of multiple fertility centers across Vijayawada, Secunderabad, Visakhapatnam, and Kondapur. Others arrested include her son Jayant Krishna (25), center manager Kalyani Achhayamma (40), lab technician and embryologist Gollamandala Chenna Rao (37), anesthetist Dr. Nargula Sadanandam (41) from Gandhi Hospital, and three residents from Assam: Dhanashree Santosh (38), Mohammed Ali (38), and Nasreen Begum (25).

How the Fraud Operated

In August 2024, a couple approached the clinic seeking fertility solutions. Namrata allegedly persuaded them to opt for surrogacy, promising to arrange a surrogate mother through the clinic. Over nine months, the couple paid more than ₹35 lakh. In June 2025, they were informed that a baby boy had been delivered in Visakhapatnam. After charging additional delivery expenses, the clinic handed over the child, created a fake birth certificate, and

even falsified DNA documents to convince the couple the baby was genetically theirs.

Later, when the couple independently conducted a DNA test, results revealed the baby was not biologically related to them. Upon confronting the clinic, they were denied documents and allegedly threatened by Namrata's son. They then filed a police complaint, leading to the exposure of a systematic operation involving selling newborns, fabricating medical records, and deceiving clients.

Evidence of Widespread Illegal **Practices**

Investigations revealed Namrata charged ₹20–30 lakh from each client, claiming to perform IVF and surrogacy while sourcing babies from vulnerable parents primarily migrants from Assam. After delivery, these parents were given minimal payments and sent away. Police seized the clinic, which lacked valid licenses and legal registration. Large quantities of medical equipment, including lab apparatus and nitrous oxide cylinders, were confiscated. Authorities confirmed that Namrata's medical license had expired in 2021, and despite its cancellation by health authorities, she continued operations under another doctor's name.



DCM Orders Action After Elephant Attack

Following the death of a farmer due to an elephant attack in Chittoor district, Deputy Chief Minister and Forest Minister Pawan Kalyan issued immediate directives to forest officials. He instructed them to intensify surveillance on elephant corridors and ensure early alerts to villagers residing in vulnerable areas.



The incident occurred in Kothuru village, where farmer Ramakrishna Raju was trampled to death by a herd of elephants while working in his field. Officials reported that a group of nearly 15 elephants has been roaming in the region for the past three months, destroying crops and threatening human lives. According to forest department records, around 25 people have died in elephant-related incidents in the undivided Chittoor district since 2011.

Pawan Kalyan expressed serious concern over the recurring attacks and directed that the bereaved family receive compensation and official assistance. He emphasized the need for continuous patrolling in elephant-prone zones and better communication with local farmers. Earlier, the Deputy CM had advised the implementation of AI-based elephant tracking and advanced warning systems,



CM Seeks Stronger AP-Singapore Investment Ties

He said that his present visit seeks to address past misunderstandings, rebuild trust, and revive opportunities for international participation in AP's infrastructure projects.

Green Energy, Technology, and Emerging Industries

The Chief Minister detailed new policies aimed at drawing investments into advanced sectors. He announced that Andhra Pradesh is targeting the generation of 160 gigawatts of green energy in the coming years. Projects such as NTPC's renewable initiatives in Visakhapatnam and green hydrogen facilities in Kakinada are already in progress. He added that Amaravati will soon become home to India's first "Quantum Valley," focusing on cutting-edge research, while Visakhapatnam is set to host

Naidu also highlighted that Rayalaseema offers highly favorable conditions for de-

fense manufacturing, aerospace technology, and automobile industries. He urged Ambule to facilitate Singaporean companies' entry into Andhra Pradesh and assured full state support for their operations. Ambule highlighted Singapore's government-driven public housing model, covering 83% of projects. Minister P. Narayana said Andhra Pradesh is pursuing similar initiatives, while IT and Education Minister Nara Lokesh outlined plans to attract top educational institutions, boost research collaborations, and strengthen the technology ecosystem. They also discussed opportunities in electronics, shipbuilding. ports, pharmaceuticals, AI, startups, and academic partnerships with Singapore universities.

AP to Launch State-Level Farm Machinery Inventory Survey

Andhra Pradesh will soon initiate a comprehensive State-Level Farm Machinery Inventory Survey (FMIS) as per the directives of the Hon'ble Chief Minister. The survey, to be completed by August 31, aims to create a detailed digital database of agricultural machinery

across all villages in the state. The initiative will be conducted by Agricultural Assistants at Rythu Seva Kendras (RSKs) and will cover equipment owned by individual farmers, Farmer Producer Organizations (FPOs), Primary Agricultural Cooperative Societies (PACS), and private service providers regardless of whether the machinery was purchased with subsidies or private funds. Director of Agriculture, Dilli Rao, stated that the survey would analyze machinery availability according to crop area and seasonal requirements while identifying gaps at the village level. Data will include details such as ownership, usage, make, model, manufacturing date, and condition.

Previous cases, including over ten complaints registered in Visakhapatnam, Hyderabad, and Guntur, involve sex determination tests and unauthorized fertility procedures.

Government and Health Department Response

DMHO officials stated the seized facility lacked any structural or regulatory standards to be called a legitimate hospital. Patients were reportedly kept only for four hours, with no inpatient care. The Telangana government confirmed Namrata had no authorization to practice or conduct IVF treatments. Investigations continue, and police are pursuing the absconding suspects while scrutinizing connections to earlier

This information will be integrated into APAIMS 2.0's Farm Management Information System, developed by VASSAR LABS, enabling precise planning, monitoring, and budget allocation for farm mechanization programs.

Key objectives include creating a digital inventory, assessing availability versus requirements by agro-climatic zone, supporting Custom Hiring Centres (CHCs), identifying underutilized equipment for redistribution, and providing data-driven insights for policy-making on subsidies and machinery deployment. The collected data will also be aligned with central schemes like SMAM and PM-KISAN.

Rao highlighted that the program is part of the Chief Minister's vision to introduce an Uber-style e-CHC platform that will allow farmers to book machinery on-demand using real-time data. Upcoming enhancements include AI-linked crop advisory systems, a live booking and payment tracking interface for CHC services, and drone-based spraying equipment expansion. Dilli Rao described the survey as a "strategic digital milestone" aimed at ensuring equitable access to modern tools, improving resource efficiency, and supporting small and marginal farmers. District Agricultural Officers have been directed to oversee the process and ensure its completion by August 31.


ADEETIE Scheme Launched to Boost MSME Energy Efficiency

The Union Government has rolled out the Assistance in Deploying Energy Efficient Technologies in Industries and Establishments (ADEETIE) scheme, a major initiative aimed at transforming India's micro, small, and medium enterprises (MSMEs) into more energy-efficient and globally competitive entities. Backed by a central budget allocation of ₹1,000 crore, the program is being spearheaded by the Bureau of Energy Efficiency (BEE) and will cover 60 industrial clusters and 14 energy-intensive sectors across the country.

By adopting these measures, enterprises are expected to reduce operational costs, improve productivity, and make their operations more sustainable.

AP to Get ₹20,000-Crore Steel Plant

The Andhra Pradesh government has given formal approval for the establishment of a large-scale integrated steel plant at Sunnapurallle in Kadapa district. The project will be developed by JSW AP Steel Limited in two phases, with a total proposed investment exceeding ₹20,000 crore.

According to official orders, the To facilitate the project, the govfirst phase will involve an investment of ₹4,500 crore and is scheduled to begin construction by January 2026. The state government has set a target for completion and commencement of production by April 2029. The second phase, estimated at ₹16,350 crore, is expected to begin in January 2031 and reach full operational status by April



2034.

ernment has approved the allocation of 1,100 acres of land within Sunnapurallle village limits, at a cost of ₹5 lakh per acre. Additionally, the state will provide electricity, water resources, and other essential infrastructure support as part of an expanded incentive package under the Industrial Development

The AP government has directed concerned departments, including Power, Water Resources, Industries, Revenue, and Finance, to coordinate and implement the necessary measures promptly. The Andhra Pradesh Industrial Infrastructure Corporation (APIIC) Vice Chairman and Chairman, along with the Director of the Industries Department, have also been instructed to ensure

smooth execution of the project. Officials emphasized that the establishment of this steel plant would boost industrial growth, create significant employment opportunities, and enhance the economic profile of the Rayalaseema region. Minister Orders Probe into 22 Medical Staff

Andhra Pradesh Health Minister Satya Kumar Yadav has directed an immediate and detailed inquiry into serious irregularities that reportedly took place in 2020 at the NTR Government Hospital in Anakapalli. Acting on an Anti-Corruption Bureau (ACB) report, he ordered disciplinary action against 22 individuals, including the then District Coordinator of Health Services (DCHS), nine doctors, and twelve nurses, for alleged administrative failures, negligence, and corruption-related is-

The ACB's surprise inspection in February 2020 revealed multiple violations. These included manipulation of inpatient records, discrepancies in food distribution details, failure to display diet charts, and incomplete documentation of medicine supply and usage. Nurses were found to have presented incorrect figures and neglected proper patient service procedures. The report also cited unauthorized canteen operations, low food quality, civil works awarded in violation of rules, and lack of staff attendance monitoring.

Based on these findings, the minister instructed officials to launch disciplinary action not only against doctors and nurses but also against a driver who allegedly misreported vehicle fuel consumption amounting to ₹74,000, and a contracted sanitation worker involved in procedural violations. Yaday emphasized that accountability measures must be enforced promptly to prevent a repeat of such lapses.

Highlighting the contrast with current efforts, the minister stated that since taking charge, he has focused on improving governance within government hospitals. Regular reviews have been conducted to ensure staff attendance, proper inpatient and outpatient services, diagnostic testing accuracy, and better utilization of hospital facilities. Officials failing to meet standards have been reassigned or replaced, while efficient personnel have been retained or promoted.

Yadav stressed that district-level officers, including DM&HOs and DCHSs, will now be held directly responsible for the implementation of health schemes, staff supervision, and quality assurance. Those who neglect their duties will face strict consequences.





Minister's Swift Action Ends Water Crisis

In a swift intervention, Andhra Pradesh Health Minister Satya Kumar Yadav addressed the ongoing strike by Satya Sai Water Project contract workers in Mudigubba, Satya Sai district, leading to the immediate restoration of drinking water supply in the region.

For the past 15 days, workers had halted operations to protest against the non-payment of salaries for the last nine months. This strike severely affected water distribution to Mudigubba mandal, causing significant inconvenience to local residents.

Upon receiving information about the crisis, Minister Satya Kumar Yadav promptly contacted the Anantapur District Collector over the phone, urging immediate action. He explained the workers' financial hardships and instructed officials to ensure salary disbursement without fur-

Following the minister's directives, the district administration began processing pending payments, with arrangements made to release the overdue wages within two days. As a direct result of this intervention, water supply services that had been disrupted for over two weeks resumed on Saturday, providing much-needed relief to thousands of households.

Local residents expressed their gratitude, stating that the minister's quick response prevented the situation from worsening. They noted that his approach demonstrated an action-oriented style of governance, focusing on prompt problem-solving rather than prolonged promises. Officials assured that continuous monitoring will be maintained to avoid similar service disruptions in the future.



Jagan Shielding Liquor Scam Culprits: Butchaiah

Jagan Misused YSR's **Name: Somishetty**

Telugu Desam Party State General Secretary and KUDA Chairman Somishetty Venkateswarlu launched a sharp attack on former Chief Minister Y.S. Jagan Mohan Reddy, alleging widespread corruption and scams during his tenure. Speaking to reporters at his residence on Sunday, Venkateswarlu accused Jagan of misleading the public by seeking votes in the name of his father, late Y.S. Rajasekhara Reddy, promising good governance, and then engaging in financial crimes.

He questioned why Jagan visited MP Mithun Reddy currently jailed in connection with the ₹3,500-crore liquor scam. "If Jagan has no involvement, why meet an accused behind bars? Is he worried Mithun Reddy might reveal his name to investigators?" Venkateswarlu asked. He reminded that Jagan himself had spent 16 months in jail earlier due to financial irregularities and claimed that every institution under his rule was pushed into disarray.

According to him, multiple scams under the previous government are surfacing, leaving people shocked. "Citizens no longer trust Jagan. They are now openly stating they feel happier under the coalition government's administration," he said.

Venkateswarlu further alleged that Jagan is trying to intimidate investigating agencies by sending signals that those who troubled him politically should not be spared once he regains power. "People can clearly see through these tactics. The coalition government is focusing on good governance, addressing grievances directly through programs like 'Toli Adugu - Supaaripaalana' (First Step in Good Governance), where officials are meeting citizens, listening to their problems, and working toward solutions," he added.

YSRCP alleges

Speaking at a press meet here on Sunday, he said the government was behaving like a real estate agency by distributing public lands at throwaway prices to its followers, favored companies, and real estate groups, sidelining the public interest and ignoring

election promises. He pointed out that while the late YSR and the YSRCP regime had planned to develop Visakhapatnam into a major IT destination to rival Hyderabad, the present government had instead diverted valuable land to unknown or newly incorporated companies with no track record. He cited examples where prime land worth thousands of crores had been handed over to companies like Ursa, Sattva, and Kapil at rates as low as Rs 50 lakh to Rs 1 crore per acre, calling it a "quid pro quo" scam. Amarnath said this allocation had failed to generate even a single IT job for the youth of the state. He stated that Chief Minister Chandrababu Naidu and Minister Lokesh were directly overseeing these shady land deals, and that public land was being looted to benefit their associates. He questioned why similar land allocations were not being made in Amaravati and why the TDP was not bringing investments there.

AP Politicians' Kin Linked to Hyderabad Rave Party

Hyderabad police disrupted a rave party in Kondapur's SV Nilayam apartments on Saturday night, acting on credible intelligence. Excise officials raided the venue and detained 11 individuals, all reportedly from Andhra Pradesh. Among them were organizers identified as Praveen Kumar alias Manne, Appikotla Ashok Kumar, and Sammela Sai Krishna, along with attendees King Ken Sher Rahul, Hit Joseph, Thota Kumaraswamy, Adapa Yashwanth, Sridat, Nanda, Samata, and Teja.

Authorities revealed that Vijayawada-based individuals, Naidu alias Vasu and Shivam Rayudu allegedly connected to influential families—were arranging such parties, inviting wealthy youth from Andhra Pradesh for weekend gatherings in Hyderabad.

During the raid, police seized 2.080 kilograms of marijuana, 50 ounces of Kush marijuana, 11.57



grams of "magic mushrooms," and 1.91 grams of synthetic drugs. Three more suspects managed to escape, and cases have been registered against them.

Officials stated that investigations are ongoing to determine the network's size, suppliers, and

possible links to larger drug rackets. Law enforcement has intensified surveillance in Hyderabad following recent increases in similar incidents, vowing strict action against organizers and participants involved in drug-related parties.

BTech Ravi Counters Satish Reddy

Former MLC BTech Ravi has issued a sharp rebuttal to TDP state secretary Satish Kumar Reddy, questioning his recent remarks and comparing them to "film dialogues." Speaking at a press meet in Kadapa, Ravi mocked, "Why these Rajamouli-style lines like 'When death comes close, I'll twirl my mustache'? If Satish Reddy is truly so brave, why did he hide during the Vempalle firing incident?"

Ravi demanded that Satish clarify whether it was his gunman who opened fire during the Vempalle episode or whether Satish himself grabbed the weapon and shot. He recalled that it was TDP leadership, including Chandrababu Naidu, who ensured Satish's name was removed from the YS Raja Reddy murder case.

He criticized Satish for switching parties for personal gains, stating, "We worked in the same party for over 20 years, and yet he betrayed that bond. Many cadres he claimed were dissatisfied with TDP never left the party. Even when he organized a farewell dinner, very few turned up." Ravi accused Satish of targeting TDP while ignoring his own history, adding, "Satish Reddy did not even have influence in his own polling booth in Vempalle. Why should Lokesh or the party bother about him?"

Ravi emphasized that their criticism was not a threat of physical violence but a political counterattack: "If Satish feels unsafe, let him lie down at Vempalle's main junction. We will provide him security. His real danger is from YSRCP leaders, not from us." He further asserted that past cases—including faction disputes and local killings—prove Satish's political opportunism. "If he answers clearly about the Vempalle incident and the gunfire, we will respond further," Ravi concluded.

From Pride to Neglect Nidadavole Iconic Park

Nidadavole: Once considered a prestigious landmark, the Nidadavole Iconic Park in East Godavari district now stands as an example of poor maintenance and unfulfilled promises. Built with an expenditure of nearly ₹67 lakh under the Rajahmundry Urban Devel-

opment Authority (RUDA), the park, famously featuring the "I Love You Nidadavole" installation, was inaugurated with much fanfare by then MLA G. Srinivas Naidu.

Within a year, the park was temporarily closed. The letter "D" from the iconic signage was stolen, LED lights stopped func-

tioning, and the water fountain lies defunct. Plants planted at significant cost have withered due to lack of care, leaving only bare soil. Municipal authorities, responsible for upkeep, face criticism for their neglect. Ironically, an additional ₹5 lakh from municipal funds was recently sanctioned to raise the height of the steel "I Love You Nidadavole" letters, with tenders reportedly finalized and work yet to begin.

Earlier, the same location, known as Ganapathi Center, supported around a hundred families running small businesses. They were displaced during park construction after assurances—by then MLA Sri-

nivas Naidu—of housing plots and support for livelihood restoration. To date, no such assistance has been provided.

Local leaders, including Town Welfare Association President Juvvala Rambabu and former Jana Sena Town President Ranga Ramesh, once fought for their rights. Now, despite Jana Sena leader Kandula Durgesh becoming MLA and minister, no visible action has been tak-

Displaced families urge current leaders to fulfill earlier promises, demanding housing sites and financial support, warning that without collective pressure, their demands may never be met.

Deputy CM's Nod Leads to Road Completion

Parvathipuram Manyam District Collector A. Shyam Prasad announced that road construction from Bagujola to Chilakamendangi has been completed at a cost of Rs. 250 lakh. The works include rough stone packing on both sides, while blacktopping will be undertaken after the monsoon season. He recalled that on December 20 last year, Deputy Chief Minister laid the foundation stone for multiple roads aimed at improving connectivity to tribal areas.

The newly formed 2.5 km road includes one kilometer of CC work and 1.5 km of WMM work. At present, the road can accommodate two-wheelers, ambulances, jeeps, and small cars. Payments totaling Rs. 56 lakh have been released, while the remaining amount is pending clearance.

Additional works include a 3.6 km BT road from Pamulageesada to Mantrajola in Gummalakshmipuram Mandal at a cost of Rs. 360 lakh, targeted for completion by April next year. In Salur Mandal, a 6.6 km tar road from Bagujola to Sirivara is under construction with Rs. 900 lakh sanctioned. However, as it passes through ghat terrain, some stretches require leveling, and recent heavy rains have eroded portions of the soil road, causing delays. Completion is expected by October next year. Further, a 4 km tar road from Alluru to Rittapadu in Pachipenta Mandal has been approved at a cost of Rs. 400 lakh. Forest clearance is underway, and work will commence once permissions are secured.

No Fertilizer Shortage in **Parvathipuram**



Masani started by challenging the belief that socialism must litical patronage, corruption, and inevitably replace liberalism. He reminded readers of Mahatma Gandhi's wisdom that political consistency is not always virtuous; adapting to changing realities is crucial. Gandhi also taught fined it as a belief in the "self-dithat the means matter as much as the ends—using oppressive or violent methods to build a better society only corrupts the goal itself. The Soviet Union's brutality under Stalin is a stark example, where repression failed to create a more fraternal society.

One of Gandhi's key warnings was about the State's potential to threaten human freedom. According to Masani, socialism, with its heavy state control, leads The results? Prosperity, social justo the loss of liberty, as seen in the communist world where the state monopolizes power indefinitely instead of "withering away" as promised by Lenin. Italian philosopher Benedetto Croce foresaw this outcome, noting that than those under socialism. without "autonomous social forces"—independent property owners, professionals, and businessmen—freedom cannot survive, because no one remains free to oppose government dominance.

Between Justice and Mercy: An Islamic Perspective on Nimisha Priya's Fate

Hyderabad: The story of Nimisha Priya, an Indian nurse on death row in Yemen, is stirring global calls for mercy and offers a profound reflection on justice within Islamic law. Nimisha's execution was recently postponed, rekindling efforts by diplomats and religious leaders—including India's Grand Mufti Sheikh Kanthapuram A.P. Aboobacker Musliyar—to seek clemency. His statement, "I didn't look at her religion. I looked at her humanity," echoes the core Islamic value of compassion.

Nimisha, from Kerala's Palakkad district, has been imprisoned since 2017, accused of causing the death of a Yemeni man, Talal Abdo Mahdi, by administering ketamine. While the authorities allege murder, her lawyers maintain that her intent was only to sedate him to recover withheld docu-

Islamic jurisprudence balances justice with mercy through three categories of punishment: Hudood, Qisas, and Ta'azir. Hudood crimes—such as theft, adultery, and apostasy—have fixed penalties ordained by divine law, which judges must enforce strictly. Nimisha's case, however, falls under Qisas, the principle of retributive justice often summarized as "an eye for an eye."

Under Qisas, the victim's family has the right to demand punishment or opt for forgiveness. Crucially, forgiveness can be granted in exchange for diya, or blood money—a form of compensation recognized by Islamic courts in countries like Yemen, Saudi Arabia, and Iran. This system allows for justice to be served while fostering reconciliation, aligning with Quranic teachings on mercy.

The Quran emphasizes forgiveness over vengeance. Surah Ash-Shura (42:40-43) states, "But whoever pardons and makes reconciliation, his reward is with Allah." Similarly, Surah An-Nahl (16:126) urges patience and forgiveness as superior virtues. Such verses highlight forgiveness not only as permitted but as a sign of true strength and resolve.

Ta'azir, the third category, allows judges discretion to impose punishments when fixed penalties are not specified, further reflecting Islam's nuanced approach to justice.

Public opinion and many Islamic scholars support clemency for Nimisha, viewing the case as a moral test for society. Retired Hyderabad police officer Chakrapani, experienced in Islamic mediation, underscores forgiveness's primacy in Quranic teachings.



Palestinians in Gaza are dying of starvation

Gaza Strip, where the humanitarian crisis worsens daily as Palestinians suffer from extreme food shortages amid a relentless blockade and ongoing conflict. Atef Abu Khater, 17, once healthy, now lies in intensive care in northern Gaza, critically malnourished. His father, A'eed Abu Khater, shares the helplessness of many families trapped in the war zone. "We lost our income in the war. Food is unaffordable. There is nothing," he says, sheltering with his family in a tent in Gaza City.

Hospitals across Gaza are overwhelmed, not only by casualties from airstrikes and violence but increasingly by malnutrition. Dr. Ahmed al-Farra, head of pediatrics at Nasser Hospital in southern Gaza, paints a grim picture: "There is no one in Gaza now outside the scope of famine, not even myself." He describes heartbreaking cases of children too weak to walk, including 11-month-old Siwar Barbaq, who weighs less than half the healthy weight for her age.

The World Food Programme reports that a third of Gaza's two million residents are going multiple days without food, a staggering indicator of the crisis's scale. The Gaza Ministry of Health has reported over 40 hunger-related deaths in July alone, including 16 children, and 111 deaths since the war began in October 2023.

The crisis deepened after Israel resumed military operations in

Severe hunger is devastating the March 2025 and imposed an 80day blockade, restricting food and essential supplies. Aid reaches Gaza through two channels: a controversial private system run by Israeli-backed contractors and convoys from independent international organizations. Both face challenges due to violence, mismanagement, and restrictions, with many Palestinians risking life to reach aid distribution

Conversely, aid organizations and Palestinians accuse Israel of enforcing a blockade that worsens starvation. This year's 79th Independence Day "At Home" reception hosted by President Droupadi Murmu will celebrate the rich craft traditions of Eastern India, with the official invitations themselves serving as works of art. Crafted by artisans from Bihar, Jharkhand, Odisha, and West Bengal, the invitation sets showcase regional artistry, continuing the precedent set during Republic Day, which featured South Indian crafts.

Curated by the National Institute of Design (NID), the invitation package includes contributions from dozens of skilled craftspersons—many of them women. Notably, nine Madhubani artists from Bihar and 15 bamboo artisans from Jharkhand worked collaboratively at NID's Bengaluru campus.

Padma Shri awardee Ashok Kumar Biswas, a Tikuli painting master from Bihar, led the production of 750 Tikuli artworks to accompany the invitation. Asked to design lightweight versions of the typically enamel-on-MDA-based artwork, Biswas created a fourth prototype—Tikuli on paper resembling the traditional base—which was approved. "It is a matter of great pride to be involved in this initiative from the President's office," he said, calling the project a celebration of India's folk art legacy.

The invitation will come enclosed in a handwoven Sikki grass box, crafted by 30 artisans from Raiyam village in Madhubani, Bihar. Inside, a bamboo frame from Dumka, Jharkhand, painted with traditional designs, holds the invitation. This foldable frame can be reused as a photo frame.

Additional handcrafted elements include a Madhubani bookmark, a tussar stole with traditional motifs, and miniature artworks: Tala Patachitra from Raghurajpur (Odisha), Paitkar from East Singhbhum (Jharkhand), and postcard-sized Patachitra from Pingla (West Bengal). This artistic invitation not only celebrates India's independence but also elevates regional craftsmanship on a national platform.

Haridwar Temple Stampede a Systemic Failure, Says AAP Chief Arvind Kejriwal

Dhankhar has to tell what happened, the matter is between him and PM Modi: Kharge

Congress president Mallikarjun Kharge said on Sunday that he has no knowledge of the reasons behind Vice President Jagdeep Dhankhar's sudden resignation, and stated that only Dhankhar and Prime Minister Narendra Modi know what truly happened.

Speaking to reporters in Vijayapura, Karnataka, Kharge said, "He was always on the government's side. He should say what happened. The matter is between him and Modi. We don't have any information."

Dhankhar resigned from the post of Vice President and Chairman of the Rajya Sabha on July 21, citing health reasons. In his letter to President Droupadi Murmu, he said he was stepping down "to prioritise health care", a move that has sparked intense political speculation.

Kharge, who is also the Leader of the Opposition in the Rajya Sabha, was critical of Dhankhar's conduct as Chair. "When we raised issues concerning farmers, the poor, international policy, or atrocities against women and Dalits, we were never given an opportunity. He always sided with the government and didn't let the Opposition speak," he said.

When asked whether Dhankhar's exit had anything to do with his re-



cent remarks in support of farmers, Kharge said, "I don't know all those details. He has to tell what really happened."

Responding to another question about a possible change in leadership of the Karnataka Congress unit, Kharge declined to comment, saying, "All those things cannot be said now. Will speak later."

Currently, Deputy Chief Minister D.K. Shivakumar holds the post of Karnataka Pradesh Congress Committee (KPCC) president, but there have been growing demands within the party for a replacement, citing a conflict of interest in holding both

India Grants Tariff Relief to UK Goods Under FTA, Keeps Sensitive Sectors Protected

India has extended significant tariff concessions to a broad range of British products under the recently signed Comprehensive Economic and Trade Agreement (CETA) with the United Kingdom, while carefully excluding sensitive sectors like tea, coffee, and gold to safeguard domestic producers.

Signed on July 24, the deal will come into force after ratification by the British Parliament, likely within a year. Under the agreement, India will phase out or reduce import tariffs on nearly 90% of goods originating from the UK, according to think tank GTRI.

Among the goods that will benefit from phased duty elimination are:

Pastries and cakes (currently taxed at 33%) and protein concentrates (44%) — duty-free over 10 years

Chocolates (33% duty) — zero

- duty in 7 years
- Dog and cat food (22%) full exemption in 7 years
- Cosmetics (22%) and soaps (11%) — duty removed in 10 vears
- Shaving creams, gels, and detergents (11%) — duty removed immediately



- Air conditioners and washing machines (22%) — duty-free in 10 years
- Microwave ovens duty scrapped immediately For industrial and recyclable
- Waste paper (11%) and silver
- bars (10.75%) duty-free in 10
- Ferrous scrap (2.75%) duty scrapped immediately Brass scrap — phased relief
- over 10 years Aluminium scrap — excluded
- from concessions In aerospace, turbo-jets with thrust over 25kN (8.25%) will see duties cut over seven years.

On alcoholic beverages, India will lower duties only on premium UK spirits priced above \$6 per 750ml. Tariffs will fall from 110% to 75% in year one, reaching 40% by year 10.

The structured timeline gives Indian industries time to adapt while enhancing consumer choice and trade ties with the UK.



They Should Be Prosecuted: Trump

U.S. President Donald Trump has called for the prosecution of Vice President Kamala Harris and several prominent celebrities, accusing them of illegally receiving payments for endorsements during the 2024 presidential election. Trump made the explosive claims on Saturday via his Truth Social account, alleging violations of campaign finance laws.

In his post, Trump claimed that Democrats spent millions of dollars securing endorsements from major public figures, which he described as "totally illegal." Among those named were singer Beyoncé, TV host Oprah Winfrey, and civil rights activist Rev. Al Sharpton. Trump alleged that Beyoncé received \$11 million, Oprah \$3 million for "expenses," and Sharpton \$600,000, calling them "ridiculous fees" for what he claimed was "absolutely NOTHING."

"These endorsements were paid for and falsely reported in the campaign's books. You are NOT allowed to pay for an endorsement—it is ILLEGAL," Trump stated. "Kamala and all of those who received endorsement money BROKE THE LAW. They should all be prosecuted."

The accusations come as Trump himself



faces renewed scrutiny over his handling of the Jeffrey Epstein case files. In a separate Truth Social post, Trump labeled the ongoing investigation a "politically motivated con job" orchestrated by Democrats to undermine his presidency.

"They're playing another Russia, Russia, Russia hoax, this time under the guise of the Jeffrey Epstein SCAM," Trump wrote. He added that he had instructed

Attorney General Pam Bondi to work on releasing the grand jury testimonies of Epstein and Ghislaine Maxwell, citing public pressure and a need for transpar-

The situation adds another layer of political tension as both parties brace for the 2026 midterms, with campaign finance practices and past scandals taking center stage once again.

Pro-Kurdish Leader Calls on India to Support Historic PKK-Turkey Peace Process

Despite the ceasefire, Bakirhan warned that sporadic clashes persist and urged an immediate halt to all military operations to fully realize peace. He emphasized that peace has strong intellectual and popular support within Turkey and stressed that the prolonged conflict has inflicted enormous economic and social damage, costing around \$2 trillion. Bakirhan believes this strategic peace move by Öcalan could reshape Turkey's future and the region's stability.

Israel announces military pause in three Gaza areas

Israeli military announced a daily "tactical pause" in fighting across three key areas of Gaza—Muwasi, Deir al-Balah, and Gaza City. The pause will last from 10:00 am to 8:00 pm local time each day until further notice, aiming to alleviate the worsening humanitarian crisis in the region.

Though the military stated it was not currently active in these specific zones, recent weeks have seen ongoing clashes and airstrikes there. The tactical pause is intended to create safer conditions for aid agencies to deliver critical food, medical supplies, and other essentials to the civilian population suffering under harsh conditions.

Alongside the pause, the Israeli military will establish secure routes to assist humanitarian organizations in reaching people across Gaza. This measure addresses growing international concern over severe food shortages and famine risks exacerbated by strict Israeli restrictions on aid.

The announcement follows mounting



criticism from global actors, including Israel's close allies, amid reports of hundreds of Palestinians killed recently while attempting to access food distribution points. The humanitarian situation in Gaza has deteriorated rapidly, prompting urgent calls for relief efforts.

In addition to the daily pause, Israel said it would resume airdropping supplies into Gaza, marking another step toward easing the acute hunger crisis. Despite

these humanitarian gestures, the military emphasized that its broader offensive against Hamas and other militant groups in Gaza would continue unabat-

The tactical pause represents a rare moment of operational restraint in an otherwise intense conflict, signaling some responsiveness to international pressure while maintaining Israel's strategic objectives in Gaza.



Thailand and Cambodia Agree to Ceasefire Talks Following **Trump's Mediation**

Thailand and Cambodia have signaled readiness to negotiate an end to their deadly border conflict after intervention by former US President Donald Trump. The clashes, now in their fourth day, have resulted in at least 34 deaths and displaced more than 168,000 people.

Trump posted on Truth Social that he had spoken with both countries' leaders, warning that continued hostilities could jeopardize future trade agreements. He announced that both sides agreed to meet for ceasefire negotiations. Cambodian Prime Minister Hun Manet confirmed Cambodia's commitment to an "immediate and unconditional ceasefire," noting that Trump informed him Thailand had also agreed to halt attacks. Hun Manet assigned his deputy foreign minister to coordinate efforts with US Secretary of State Marco Rubio and engage directly with Thailand's foreign ministry.

Thailand expressed cautious optimism. Acting Prime Minister Phumtham Wechayachai thanked Trump and said Thailand agreed in principle to a ceasefire but emphasized the need for "sincere intention" from Cambodia. The Thai Foreign Ministry called for swift bilateral talks to reach a peaceful resolution.

The fighting began after a land mine explosion wounded five Thai soldiers. Both nations blamed each other for initiating the violence. Despite diplomatic efforts, clashes continued, with artillery fire targeting border provinces and disputed sites like the ancient Ta Muen Thom temple. Both sides accused each other of escalating violence and violating humanitarian laws. The conflict has caused mass evacuations, with over 131,000 displaced in Thailand and 37,000 in Cambodia. Many border villages are deserted, and schools and hospitals have closed.

The UN Security Council urged ASEAN to mediate the conflict, while Human Rights Watch condemned the use of banned cluster munitions in civilian areas. The 500-mile Thailand-Cambodia border has long been disputed, but recent clashes have been the most severe in years.



North Korea's Kim Jong Un Vows Victory in Anti-U.S. Struggle on **Korean War Anniversary**

On the anniversary of the Korean War armistice, North Korean leader Kim Jong Un vowed that his country would emerge victorious in its ongoing "anti-imperialist, anti-U.S." battles, state media reported. The statement came as North Korea commemorated the signing of the armistice agreement with the United States and China on July 27, 1953, which ended three years of intense fighting on the Korean Peninsula.

Kim reaffirmed his commitment to building a prosperous nation with a powerful military, declaring that North Korea and its people would become "honorable victors" in their ongoing struggle against U.S. influence. His remarks were made during a visit to a war museum and memorials dedicated to Korean War veterans, including the Tower of Friendship, which honors Chinese soldiers who fought alongside North Korean forces.

The armistice agreement, signed by U.S. generals representing United Nations forces supporting South Korea, halted active combat but did not officially end the war, leaving the peninsula divided roughly along the 38th parallel. While North Korea marks July 27 as "Victory Day," South Korea does not observe the date with major events, reflecting the continued tensions on the peninsula.

In a significant development, North Korea is currently supporting Russia in the war in Ukraine. Thousands of North Korean troops have reportedly been deployed to Russia's Kursk region, with Pyongyang supplying munitions as well. South Korean officials have indicated that additional troop deployments from North Korea may occur in the coming weeks.





Textile Industry Urges Uniform 5% GST Across Value Chain to Boost Growth

The Indian textile industry has reiterated its demand for a fibre-neu-Goods and Services Tax (GST) rate of 5% across the entire textile apparel value chain. Industry leaders argue that rationalising the current tax structure will eliminate the inverted duty structure, boost investments, and promote growth in all segments of the



Currently, the cotton-based textile sector largely attracts a 5% GST, except for garments priced above ₹1,000, which are taxed at 12%. However, the Man Made Fibre (MMF) sector faces a complex and higher tax structure — raw materials like Purified Terephthalic Acid (PTA) and Monoethylene Glycol (MEG) are taxed at 18%, MMF filament and spun yarn at 12%, fabrics and garments at 5%, and items priced above ₹1,000 at 12%.

R.K. Vij, Secretary General of the Polyester Textiles Apparel Industry Association, highlighted the impact of this disparity. "A uniform 5% GST is crucial to remove the inverted duty structure and make MMF sector globally competitive," he said. He added that to achieve the textile sector's ambitious target of \$100 billion in exports and \$250 billion in domestic sales by 2030, all segments — cotton, viscose, and synthetic fibres must grow simultaneously. Currently, there are no major expansions in the viscose or cotton sectors, making MMF sector growth vital.

K. Selvaraju, Secretary General of the Southern India Mills Association, suggested that garments and fabrics priced above ₹2,000 be taxed at 12%, while all other products, irrespective of the fibre, should attract a uniform 5% GST. "Micro, small, and medium enterprises are struggling with input tax credit accumulation. MMF-based fabrics and garments are affordable to the masses and must be supported through lower taxation," he emphasized.

He also pointed out that the textile and apparel industry is one of the largest employment generators in the country. Rationalising the GST structure, he argued, would encourage new investments and job creation.

Industry bodies believe that implementing a fibre-neutral GST regime will bring parity, reduce compliance complexity, and position India more competitively in the global textile market.

India's agri-exports surge in Q1 FY26, rice exports lead



Tndia's agricultural and processed food ex-**⊥**ports have shown strong momentum in the first quarter of FY26, recording a 7% year-onyear increase to reach \$5.96 billion between April and June. This growth reflects the sector's robust performance, driven by supportive policies and strong global demand.

Rice remains the cornerstone of India's agri-export success. Combined shipments of basmati and non-basmati rice rose by 3.5%, reaching \$2.9 billion in Q1 FY26. This comes on the heels of a record-breaking FY25, where rice exports hit \$12.47 billion — a 20% jump over the previous year. For over a decade, India has consistently maintained its status as the world's largest rice exporter, contributing 40% of the global trade.

The recent surge in rice exports was supported by the government's decision in late 2024 to remove various export controls, including minimum export price restrictions, following a record harvest and strong domestic stock levels. Other key drivers of export growth include buffalo meat, dairy, and poultry products, which collectively grew by 17% to \$1.18 billion in Q1.

India is now the world's second-largest exporter of buffalo meat, with major markets in the UAE, Saudi Arabia, Malaysia, Vietnam, Iraq, and Egypt. These exports are managed under the APEDA framework, with integrated, certified meat plants regularly inspected by importing countries to ensure compliance with international standards.

Fruits and vegetables also posted impressive growth, with exports climbing 13% to \$0.95 billion in the quarter, reflecting rising global demand for Indian produce.

APEDA (Agricultural and Processed Food Products Export Development Authority) continues to play a vital role, coordinating exports worth \$25.14 billion in FY25 — a 12% rise from FY24. APEDA products now account for over half of India's total agricultural exports.

Union Commerce Minister Piyush Goyal credited the sector's progress to favorable policies, fiscal incentives, low tariffs, and enhanced market access through free trade agreements (FTAs) with countries like Australia, the UAE, the UK, and EFTA nations.

Crypto Market Surges Past \$4 Trillion Amid New U.S. **Regulatory Framework**

The cryptocurrency sector reached a f I historic milestone on Friday, with its total market value surpassing \$4 trillion, signaling the maturation of digital assets from a speculative fringe to a mainstream component of global finance. According to CoinGecko, this surge comes amid renewed optimism, clearer regulatory policies, and increasing institutional investment.

A key catalyst behind this growth was the U.S. House of Representatives passing a bill on Thursday to establish a regulatory framework for U.S.-dollar-pegged stablecoins—cryptocurrencies designed to maintain a 1:1 value with the dollar. The bill has been sent to President Donald Trump, who is expected to sign it into law. This legislative move marks a significant cautious oversight with support for shift in the U.S. government's stance toward the crypto industry, balancing



innovation.

In addition to the stablecoin bill, the

House approved two more crypto-related laws, including one outlining broader crypto regulations and anoth-

er aiming to prohibit the issuance of kerage Bernstein predicts Bitcoin a U.S. central bank digital currency. These measures now await Senate re-

The rise of stablecoins, which facilitate instant payments and seamless fund transfers between tokens, has been a major driver of market expansion. Meanwhile, corporate adoption of cryptocurrencies like Bitcoin is accelerating, with more public companies adding digital assets to their treasuries as a long-term store of value. Despite Bitcoin's slight dip of 1.8% to around \$120,000 after hitting an alltime high near \$112,000 earlier this week, forecasts remain bullish. Brocould reach \$200,000 by the end of 2025. Ethereum, the second-largest cryptocurrency, climbed 4.5%, having more than doubled in value over the past three months.

The crypto rally also boosted related equities, with Coinbase and Robinhood stocks hitting record highs on Friday. Coinbase shares rose 1%, while Robinhood, which supports crypto trading, gained 3%, reflecting broad investor enthusiasm across the sector.

As the world's third-largest emitter of greenhouse gases, India's transition holds immense global significance. The report underlines that timely action and capital inflow will be critical in determining the country's role in the global climate response.

Nifty Enters Key Demand Zone Between 25,000-24,770, Say

Tndian stock markets ended the week on a **⊥**weak note, with the Nifty slipping below the 25,000 mark, entering what analysts describe as a crucial demand zone between 25,000 and 24,770. This level is now expected to act as immediate support.

On Friday, the Sensex dropped 501.51 points to close at 81,757.73, while the Nifty declined 143.05 points to end the session at 24,968.40. The broader market also witnessed profit booking, with mid- and small-cap indices correcting nearly 1%.

Mandar Bhojane, Senior Technical Analyst at Choice Equity Broking, noted that the Nifty has formed three consecutive bearish candles on the weekly chart, signaling a loss of upward momentum. However, the fall in trading volume during the correction indicates a lack of aggressive selling, suggesting the overall trend structure remains bullish.

"If the index holds the demand zone and reverses, we could see a fresh rally towards 26,000–26,400 in the coming weeks," Bhojane added. Key support for the Nifty lies between 24,900 and 24,800, while resistance is expected

around 25,200–25,500. Global factors like rising crude oil prices due to supply disruptions in Iraq and uncertain



signals from the U.S. Federal Reserve continue to weigh on market sentiment, especially for oil-importing economies like India.

Meanwhile, Bank Nifty ended the week at 56,283, down 0.83%, amid pressure from ongoing earnings announcements. Analysts expect consolidation or a sideways-to-bearish phase ahead unless the index breaks above the 57,000 resistance level. Key support for Bank Nifty is seen at 56,000 and 55,500.

Traders are advised to stay cautious and wait for confirmation signals before taking directional trades. Upcoming earnings from banking heavyweights like HDFC Bank and ICICI Bank are expected to guide market direction in the coming week.

RBI Monetary Panel Member Confident India Will Grow Over 6.5% in FY26

 ${f N}$ agesh Kumar, a member of the Reserve Bank of India's Monetary Policy Committee (MPC), expressed strong confidence on July 27, 2025, that the Indian economy will easily achieve a growth rate above 6.5% in the current financial year (FY26). Speaking in an interview with PTI Videos, Kumar highlighted that India remains a "bright spot" amid global economic uncertainties.

Kumar pointed out that over a third of the world's economies are currently grappling with debt crises, high inflation, and slowing growth—especially in industrialized nations. In contrast, he said India's economy is more resilient due to its heavy reliance on domestic consumption and investment rather than exports or trade, which cushions it from global shocks.

"I do not see any challenges in the Indian economy achieving upwards of 6.5% growth this year and the next," Kumar stated. He further added that this momentum could strengthen over time, potentially reaching growth rates of 7-7.5% in the coming years.

The Reserve Bank of India's projections also support this outlook, estimating the country's economy to expand by 6.5% in FY26, matching the growth recorded in the previous fiscal year.

On inflation, Kumar noted that the current Con-



sumer Price Index (CPI) inflation stands around 2%, a result of prudent policy measures adopted by the RBI and the MPC to maintain price stability.

Despite ongoing global tensions and trade uncertainties, especially with the U.S., Kumar's optimistic assessment points to strong domestic drivers such as consumption, foreign direct investment (FDI), and economic reforms—that will sustain India's growth trajectory in FY26 and beyond.

Red Statue of Donald Trump Emerging from Manhole Stuns New Yorkers

New Yorkers were met with an unusual and provocative installation this week when a bright red sculpture of former U.S. President Donald Trump was spotted emerging from a manhole at a bustling Midtown Manhattan intersection.

The life-sized artwork, simply titled "Donald," was installed by French street artist James Colomina, known for his politically charged, guerrilla-style sculptures. The statue appeared suddenly on East 42nd Street and 2nd Avenue, not far

from Trump Tower, catching pedestrians and commuters off guard.

Painted entirely in a bold red hue, the sculpture features a pursed-lipped Trump figure appearing to crawl out of a sewer, sparking a mix of amusement, confusion, and commentary among passersby. The placement — rising from beneath the city streets — has been interpreted by many as a metaphorical statement, though Colomina himself has yet to release an official explanation.

This isn't Colomina's first foray into public political installations. His past works, often installed without permission, have depicted controversial world leaders in symbolic and sometimes absurd contexts. His installations

are usually unannounced and aim to challenge social norms, provoke thought, and engage the public in conversation.

Social media quickly lit up with photos and videos of the sculpture, with some praising it as "genius street art" and others criticizing it as disrespectful. Many see the artwork as a satirical jab at Trump's political legacy, especially in the lead-up to the 2026 elections.

While the New York City authorities have not yet commented on the legality or future of the sculpture, it remains unclear how long the statue will stay in place. As with many of Colomina's works, the installation may disappear as suddenly as it appeared — but its impact is already generating buzz across both political and artistic circles.



In a startling revelation, archaeologists in Spain have uncovered chilling evidence that ancient human ancestors engaged in cannibalism, including the consumption of young children, nearly 850,000 years ago. The discovery was made at the Gran Dolina cave site in Atapuerca, northern Spain, by a team from the Catalan Institute of Human Paleoecology and Social Evolution (IPHES).

Researchers found a fossilized neck vertebra belonging to a child estimated to be between two and four years old. What sets this discovery apart is the presence of clear butchery marks, suggesting the child was not only killed



but also processed for consumption—treated like any other hunted animal. The marks were found at key anatomical points necessary for decapitation and disarticulation.

Dr. Palmira Saladie, co-director of the excavation, called the case particularly disturbing due to the child's young age and the precision of the cut marks. "This vertebra shows deliberate and skillful incisions, which offer direct evidence that the child was butchered," she said.

The remains have been identified as belonging to Homo antecessor, a species considered to be the last common ancestor of both modern humans (Homo sapiens) and Neanderthals. These early humans lived between 1.2 million and 800,000 years ago, were shorter and stockier than people today, and had smaller brains — about 1,000 to 1,150 cubic centimeters compared to the modern average of 1,350 cc.

While evidence of prehistoric cannibalism is not new, this may be the earliest known instance involving a child, suggesting that such practices may have been more common and systematic than previously believed. The findings challenge modern assumptions about how early humans treated their dead and indicate a more complex and, at times, brutal survival strategy.

At the World Artificial Intelligence Conference (WAIC) in Shanghai, humanoid robots dazzled visitors with their diverse abilities—serving craft beer, playing mahjong, shadowboxing, and even stacking shelves—representing the forefront of China's rapid AI evolution. The event, held over the weekend, highlighted the country's ambition to become a global AI powerhouse, rivaling the United States in both innovation and regulation.

Premier Li Qiang opened the conference by announcing plans to establish an international organization focused on AI governance, cautioning that technological progress must be balanced with risk management.

However, the atmosphere at the expo was filled with excitement, not concern.

"This year, the demand for AI applications—ranging from data and scenarios to model training—is booming," said Yang Yifan, R&D Director at Shanghai-based AI platform Transwarp.

This year's WAIC follows a landmark moment in January when Chinese startup DeepSeek launched an AI model that matched the performance of leading U.S. systems at a fraction of the cost. More than 800 companies presented over 3,000 AI products at the event, with humanoid robots stealing the spotlight.

Among the standout exhibits was Unitree's G1 android, which punched, kicked, and danced




with fluid balance. The company also announced a full-sized humanoid robot, the R1, priced under \$6,000. Meanwhile, robots in work uniforms operated assembly lines and played games with humans, illustrating China's growing dominance in robotics.

AI-powered "digital humans" also drew attention. Baidu unveiled its latest generation of realistic avatars capable of hosting livestreams and making decisions—technologies already used by over 10,000 businesses.

While concerns about AI's impact on jobs persist, many attendees were more fascinated than fearful. As Yang noted, "China has a solid data foundation and countless application scenarios—ideal for advancing AI development."




