Moorthy Naidu's Arrest Triggers Outrage Among Kapu Leaders

The arrest of Point News Director Moorthy Naidu in Vijayawada has sparked strong political and community reactions across Andhra Pradesh, especially among Kapu leaders, financial industry well-wishers, and sections of the Jana Sena Party. The move, which came amidst growing concerns over media freedom and targeted actions against voices aligned with the Kapu community, has drawn sharp criticism.

Moorthy Naidu, a prominent figure in the media and an outspoken representative of the Kapu community, was reportedly taken into custody over alleged news article on Point News regarding Polavaram MLA Balaraju. However, several leaders have questioned the intent and timing of the arrest. Kapu Nadu organizations have described the incident as politically motivated and aimed at silencing influential voices. They expressed solidarity with Naidu and demanded immediate legal support to fight what they termed an "unjustified and targeted action."

Leaders from the financial sector, especially those with ties to community development projects and startups, also conveyed their displeasure over the incident. Several investors and entrepreneurs stated that such actions against individuals working to elevate backward communities could dent the trust of stakeholders in the system. "It is unfortunate and dangerous to see proactive voices from our community being targeted. This raises serious concerns about freedom of expression and equal justice," said one prominent entrepreneur from Vijayawada.

Adding fuel to the fire, a section of Janasena leaders reacted strongly to the arrest, terming it an act of vengeance. "Moorthy Naidu's voice was fearless. His arrest is not a legal action, it's a political message," said a senior Janasena leader off the record.

Meanwhile, Kapu Nadu representatives also referred to the recent attack on Mahaa News channel in Hyderabad, where alleged party workers vandalized the media office. Linking both incidents, they warned of a dangerous trend targeting media voices who refuse to fall in line. They emphasized that these attacks were part of a broader attempt to stifle independent journalism and restrict caste-based empowerment.

A case has been registered against Siga-**Minister visit site** chi Industries following the devastating chemical explosion at Pashamilaram Industrial Estate in Sangareddy district. The BDL Bhanur Police confirmed the case was filed under Sections 105, 110, and 117 based on a complaint by Yashwanth, a relative of a victim. The tragedy, which occurred in Sigachi's chemical unit, has left 45 people dead so far, with dozens more injured or missing.

The clearing of the rubble from the factory's administrative block is still in progress, and officials fear the death toll may rise further. Out of 143 workers present during the blast, at least 27 are still unaccounted for. So far, only six bodies have been formally identified, with many more found in unrecognizable condition, prompting authorities to order DNA tests for confirmation.

Currently, 35 injured victims are being treated in hospitals,







- **Court slams inaction** over illegal structures in Rajendranagar

In a sharp rebuke to government officials for their alleged inaction on illegal constructions, the Telangana High Court made strong observations during the hearing of a petition filed by Syed Rahimunnisa and seven others. The petitioners alleged that illegal structures were being raised on their private land in Rajendranagar, and despite multiple complaints, authorities have failed to

During the hearing, Justice Vijayasai Reddy, expressing deep dissatisfaction, remarked that photos of officials who failed to act on illegal structures should be displayed on Tank Bund. The comment underscored the court's growing frustration over the blame game among various departments.

The Standing Counsel for the government informed the court that orders had already been issued to remove the illegal structures, and the GHMC officials stated they had passed on these instructions to the task force officials. However, the task force officials claimed they could not act due to lack of police security, while the police department cited law and order concerns as a reason for inaction.

Taken aback by the apparent coordination failure, the High Court bench expressed serious impatience and said, "How can all departments wash their hands of responsibility like this?"

The court has now directed all concerned officials to submit clear details of the action taken on the petition filed by the complainants by the time of the next adjournment. The case has become a significant example of bureaucratic apathy toward illegal constructions, and the High Court's strong remarks have drawn public attention to the issue.

Maoist Letter Slams Govt Over Education Neglect

Special Desk: In a strongly worded letter, the Communist Party of India (Maoist) Telangana Committee has accused the government of deliberately weakening the government education system and turning education into a commercial business. The letter, signed by official spokesperson Jagan, demands an immediate allocation of ₹20,000 crore towards strengthening public education in the state. The Maoist party lashed out at successive governments for making empty promises during elections but failing to take basic steps for the improvement of public education. The letter asserts that due to insufficient government institutions matching population growth, education has become a commodity accessible only through private institutions, which the poor can no longer afford.

It accused political parties and their leaders of turning education into a business by setting up private schools, colleges, and universities. The Maoist party went so far as to demand that those who profit from education businesses should be barred from contesting elections.

Personality Development Expert B.V. Pattabhiram Passes Away

Renowned personality development expert, psychiatrist, and magician Dr. B.V. Pattabhiram passed away on Tuesday following a heart attack. He was widely respected for his decades-long contribution to psychology, hypnosis, and personal transformation. He is survived by his wife Jaya, also a personality development expert, and son Prashanth. His mortal remains have been kept at his residence in Khairatabad for fans and well-wishers to pay their last respects from 9 am today. The final rites will be conducted at Mahaprasthanam in Jubilee Hills at 3 pm. Born in East Godavari district, Pattabhiram was one of the 15 children of Rao Saheb Bhavaraju Satyanarayana. While pursuing higher education in Kakinada, he was introduced to magic by a magician named Ember Rao. This passion stayed with him even while working for a food company in Hyderabad.



By the 1970s, he had emerged as an independent magician, capable of captivating audiences for hours with his unique blend of performance and psychology.

Dr. Pattabhiram's academic background was

as rich as his creative pursuits. He completed post-graduation in psychology and philosophy from Osmania University and later earned a PhD in yoga and hypnosis from the same institution. He also worked with the Food Corporation of India before dedicating himself fully to guiding people through psychological counseling, motivational speaking, and personality development training. His lectures and workshops helped thousands across India in areas such as mental health, confidence building, and goal setting. Over his career spanning nearly 50 years, he received several awards and accolades for his service to society in both the scientific and spiritual realms.

The police have concluded in their report that Poorna's deception and emotional manipulation pushed Swetcha to suicide. Sabitha Reddy **Slams Congress Over Welfare Schemes**

Distributes Kalyana Lakshmi cheques to 33 beneficiaries **Credits KCR for introducing** unique women-centric schemes

Former Minister and Maheswaram MLA Sabitha Indra Reddy strongly criticized the Congress government for allegedly neglecting key welfare schemes introduced during the BRS regime. Speaking at a Kalyana Lakshmi-Shaadi Mubarak cheque distribution program held in Kandukur, she distributed cheques to 33 beneficiaries and lauded the visionary efforts of former Chief Minister K. Chandrashekar Rao (KCR).

"There is no scheme like Kalyana Lakshmi anywhere in the country or the world. KCR introduced these revolutionary welfare schemes keeping women at the center," she said, highlighting how the Kalyana Lakshmi and Shaadi Mubarak schemes brought dignity and financial assistance to poor families during weddings.

Sabitha Indra Reddy said that the BRS government had implemented several schemes like the KCR Kit, which provided ₹13,000 for a girl child and ₹12,000 for a boy born in a government hospital, ensuring both maternal and infant care. "KCR even arranged transportation from hospital to home at the government's expense,' she said, expressing disappointment that such schemes have been ignored by the current Congress government. She further stated that Mission Bhagiratha, which ensured safe drinking water to every household, was also aimed at reducing the burden on girl children who had to carry water bottles to school. "To support farmers, Rythu Bandhu was launched. I challenge anyone to show a single farmer who didn't receive Rythu Bandhu during our tenure," she added, accusing the Congress of discontinuing the scheme.

Sabitha Reddy demanded that the KCR Kit be reinstated immediately and questioned the Congress government on the delay in implementing its six guarantees. "They promised big, but they haven't delivered. The people deserve answers," she said.

During the event, several leaders from various political parties joined the BRS under Sabitha Indra Reddy's leadership. Tehsildar, Market Committee Chairman Krishna Nayak, local leaders, beneficiaries, and activists also participated in the program.

No compromise on water issue, says CM Criticism on 2015 pact with AP Will fight politically and legally for water rights

Telangana Chief Minister Revanth Reddy launched a scathing attack on the previous BRS government, accusing former Chief Minister KCR and former Minister Harish Rao of compromising the state's water rights through a 2015 agreement. Speaking at a PowerPoint presentation on the Godavari-Banakacharla issue held at Praja Bhavan on Tuesday, Revanth Reddy described the 2015 signatures by KCR and Harish Rao as a "death warrant" for Telangana's irrigation future.

"There will be no going back on the water issue. We will fight for Telangana's rightful share politically, technically, and legally," Revanth asserted. He made it clear that his government is committed to protecting the interests of the people and that it will not compromise when it comes to the state's lifeline.

Revanth Reddy pointed out that under the 2015 MoU, Telangana was limited to just 299 TMC of Krishna river water out of a total 811 TMC, while the rest nearly 68% — was allocated to Andhra Pradesh. He slammed this agreement, saying it was done without proper justification or resistance.

"Despite Telangana having a larger catchment area, the previous rulers accepted an unfair share. Not only did they agree to it, they also failed to complete key irrigation projects that could

help utilize even the 299 TMC allocated," he said.

The CM expressed concern that while Andhra Pradesh has been rapidly completing its irrigation projects, Telangana's projects were ignored during the BRS rule. He assured the people that the Congress-led government will now focus on protecting Telangana's water interests and make up for the lost time. Revanth Reddy vowed to revive pending irrigation projects and take all necessary steps to ensure Telangana gets its rightful share of Krishna and Godavari waters. He said his government would not shy away from challenging the injustice done in the past, both in courts and on political platforms.

Highlighting the government's success, Uttam said the Expert vironment Ministry returned AP's proposal without even granting Terms of Reference. "This is a big win for Telangana," he said.

He criticized the 2015 agreement signed by KCR and Harish Rao, allocating only 299 TMC to Telangana out of 811 TMC of Krishna water. The Congress government has demanded a higher share and reopened the matter before the tribunal.

The Amrabad Tiger Reserve in Achampet, Telangana, has officially announced its annual monsoon season closure from July 1 to September 30, 2025, in line with the National Tiger Conservation Authority (NTCA) guidelines and recommendations under the Tiger Conservation Plan (TCP).

This seasonal closure is intended to facilitate ecological balance, allow undisturbed wildlife breeding. and ensure visitor and staff safety during the monsoon period. With vation efforts and plan their visits heavy rains likely to make trails accordingly. Worker Injured in Boiler Blast at Medchal Pharma Unit

A major boiler explosion at Alkaloid Bio Actives Private Limited, located in the Medchal industrial estate, left a senior worker Gannaram Srinivas Reddy critically injured on Tuesday. The incident occurred within the limits of the Medchal Police Station and has raised serious concerns about industrial safety protocols.

Srinivas Reddy, a native of Shahpur and an employee at the company for over 12 years, suffered severe injuries due to the blast. Fellow workers rushed him to a nearby private hospital for immediate assistance. However, due to the critical nature of his condition, he was later shifted to AIG Hospital in Nagaram for advanced treatment.

Following the incident, the Medchal police registered a case based on a complaint lodged by the injured worker's family members. Authorities have begun a detailed investigation into the circumstances leading to the

Medchal ACP Shankar Reddy, who visited the scene, stated that preliminary findings indicate a sudden boiler malfunction. "We are looking into potential negligence or technical faults. The safety measures at the company will also be reviewed as part of the investigation," he said.

Industrial accidents continue to pose a serious threat to workers' lives, and this incident highlights the urgent need for stringent safety standards in pharma and manufacturing units.



Workplace Harassment Still Rampant Despite Laws, Undermines Women's Rights and Workforce Participation

A decade after India enacted a landmark law to combat sexual harassment in workplaces, enforcement remains a major concern, as cases continue to go unreported and unresolved. Despite the passage of the Sexual Harassment of Women at Workplace (Prevention, Prohibition and Redressal) Act, 2013, commonly known as the POSH Act, thousands of women across corporate offices, educational institutions, hospitals, and informal sectors still face harassment that threatens their dignity, safety, and professional growth.

Workplace sexual harassment is not The POSH Act, passed in February just a labour law violation, it is a human rights issue. It has a direct impact on productivity, absenteeism, and mental health, and more crit-





ically, on women's equal participation in the workforce. The nature of harassment has also evolved, particularly after the COVID-19 pandemic and the subsequent shift to remote working. The so-called "home office" has blurred the lines between professional and private space, leaving women vulnerable to new forms of abuse such as Zoom bombing, inappropriate WhatsApp messages, coercive video call requests, and digital stalking.

2013 and enacted in December the same year, was considered a milestone in protecting women at work. It defined "aggrieved woman" broadly to include not just employees but also visitors, clients, customers, and even patients, any woman present at a workplace in any capacity. For instance, if a woman visiting a hospital as a patient or attendant is harassed, she is protected under this Act.

Despite its progressive approach, implementation of the law has been inconsistent. In a 2023 judgment, the Supreme Court of India expressed serious concern over "lapses in enforcement" and pointed out that even after 10 years of the Act, many organizations failed to implement mandatory provisions like forming Internal Committees (ICs). The International Labour Organisation (ILO)



echoes this, stating that the lack of reported cases does not indicate the absence of incidents. In most cases, women fear retaliation, social stigma, or being disbelieved, especially when the harasser holds a position of power.

Sexual harassment can take many forms: verbal jokes with sexual overtones, unwanted touching, explicit messages or images, pressuring someone into sexual activity, or even offering professional benefits in exchange for sexual favors. Increasingly, digital harassment has added another layer to this already complex

A 2023 McKinsey and LeanIn.org Women in the Workplace report revealed that only about 50% of women feel confident that their employer would handle a harassment complaint effectively, a statistic unchanged since 2018. This lack of faith in redressal systems enables a toxic culture to persist, pushing many women to suffer in silence or leave the workforce altogether.

While laws and regulations exist, experts stress the need for strong internal workplace policies, regular training, and gender sensitization programs. A robust grievance redressal mechanism, with a trusted and impartial Internal Committee, is key to building confidence. Moreover, organizations must ensure that survivors are not re-traumatized by the complaint process and that retaliation is strictly punished.

Women are increasingly learning to protect themselves by documenting incidents, speaking up, and approaching HR or legal channels. However, the responsibility must not fall on survivors alone. Creating a safe, respectful work environment is a collective responsibility, from top leadership to peers.

The conversation around workplace harassment must go beyond compliance. It must focus on changing attitudes, dismantling power imbalances, and building a culture of trust, safety, and equality. Only then can India truly ensure that women can work with dignity, online or offline.

The Cost of 'Boasting': **Trump And India's Post-Op Sindoor Dilemmas**



Diplomacy thrives on measured words and deliberate pauses. Decisions are usually made behind closed doors, with public statements carefully crafted for impact and interpretation. Yet, former U.S. President Donald Trump broke with this tradition when he publicly claimed that his threats of trade penalties had prevented war between India and Pakistan in May. The declarative tone may have worked for a domestic audience, but it significantly disrupted the delicate regional and strategic dynamics between New Delhi, Islamabad, and Washington.

The situation he referred to was deeply serious. On April 22, a terror attack near Pahalgam in Jammu and Kashmir heightened tensions between India and Pakistan. From May 7 to 10, both nations exchanged air France, and cautiously re-engaging with strikes, escalating fears of a broader conflict. A ceasefire was announced on May 10. By treating India and Pakistan as equal stakeholders in a conflict and positioning himself as a mediator, Trump blurred critical distinctions—between a democracy targeted by cross-border terrorism and a state accused of supporting it.


New Delhi has firmly rejected the claim. Indian officials maintain the ceasefire resulted from direct military dialogue with Pakistan, not external influence. Yet, the perception created by Trump's remarks has been politically costly. Opposition leaders have accused the Modi government of diplomatic weakness, and media voices warn that silence may imply acceptance.

The controversy complicates ambitious trade goals. India and the U.S. have set targets to boost bilateral trade to \$500 billion by 2030, with an initial agreement expected by autumn 2025. But lingering doubts about the reliability of trade as a policy tool, especially if wielded as a geopolitical weapon, cast a shadow over negotiations.

In response, India is diversifying its strategic and economic ties—deepening relations with the EU, strengthening defence ties with China and Russia. This approach reflects a pragmatic effort to hedge against over-dependence on any one partner.

NHAI Capex Claims Under Scrutiny Amid Financial Tightening and Monetisation Setbacks



In 2024-2025, the Government of India lauded the National Highways Authority of India (NHAI) for achieving a record capital expenditure (capex) of over ₹2.5 lakh crore for national highway development, surpassing its ₹2.4 lakh crore target. However, this claim is now being questioned due to discrepancies in NHAI's unaudited financial statements, which report a significantly lower capex of ₹1.45 lakh crore. This gap of over ₹1 lakh crore has raised concerns about possible financial window-dressing and a deepening funding squeeze on the NHAI.

According to NHAI's unaudited 2024-2025 accounts, while the government claimed a record ₹2.5 lakh crore in infrastructure spending, a closer look reveals that a large portion of these funds was used not for highway construction but for loan repayments. Specifically, the repayment of ₹50,000 crore from the National Small Savings Fund (NSSF) and the reduction of public sector bank loans were included in the government's capex figures, thereby inflating the real developmental spending. Effectively, the net capex spent on actual infrastructure works was only ₹1.45 lakh crore—the amount reflected in NHAI's accounts.

This discrepancy suggests the government's ₹2.5 lakh crore claim includes significant debt repayments, thus overstating its investment in new highway infrastructure. The reported repayment of ₹50,000 crore to NSSF, which simply circles money back to the government, further underscores the lack of transparency. Hence, the real support extended to NHAI stands at around ₹2 lakh crore, far below the claimed figure.

Additionally, NHAI's asset monetisation efforts appear to be faltering. The government has celebrated the National Highways Infra Trust (NHIT) as a success in raising ₹18,380 crore in its fourth fundraising round. However, closer scrutiny of NHIT reveals that it remains largely government-controlled, with project management and investment oversight still under NHAI through wholly owned entities. While monetisation transactions have nominally raised ₹43,648 crore by transferring 2,345 kilometres of roads, genuine private sector participation remains limited, with much of the funding sourced through loans rather than equity investment.

Other monetisation models like the Toll, Operate, and Transfer (ToT) approach have been sidelined. Union Minister Nitin Gadkari himself expressed dissatisfaction with the government's decision to discontinue the ToT model, previously an effective monetisation tool. Similarly, the government's special purpose vehicle (SPV) model for financing new expressways has seen little traction, with only one such project—the Delhi-Vadodara expressway—currently underway, despite notable delays.

Adding to the NHAI's challenges is the indefinite freeze on the Bharatmala Pariyojana, a flagship road development project launched in 2017-2018 with a target of 34,800 kilometres and an estimated cost of ₹6.92 lakh crore. Ongoing issues with cost overruns, land acquisition, and contract execution prompted a government review, which remains incomplete well after the 2024 general elections.

Together, these developments point to a tightening financial situation at NHAI and raise serious concerns about the government's infrastructure spending narrative. The inflated capex claims, faltering monetisation, and stalled projects paint a more complex picture than the government's optimistic public messaging suggests.



Rahul Gandhi Slams GST on 8th Anniversary, Calls It Tool of **Corporate Cronyism**

Demands People-Centric Reforms and End to Bureaucratic Burden

On the eighth anniversary of the Goods and Services Tax (GST), Leader of Opposition Rahul Gandhi strongly criticized the current tax regime, calling it a "brutal tool of economic injustice and corporate cronyism." Taking to social media on Tuesday, July 1, 2025, Gandhi accused the Modi government of betraying the original vision of GST and turning it into a mechanism that disproportionately hurts small businesses, farmers, and common citizens.

"Eight years on, the Modi government's GST is not a tax reform—it is a compliance nightmare," he said, pointing to the over 900 amendments made since its rollout. Promised as a 'Good and Simple Tax', Gandhi said the reality is a five-slab system entangled in bureaucracy where even items like caramel popcorn and cream buns are burdened with complex tax rates.

He alleged the GST structure favours big corporates with access to legal teams and accountants, while MS-MEs—the largest job creators—have been pushed to the brink, with over 18 lakh small enterprises shutting down since 2017.



The Congress leader also highlighted how ordinary Indians are now paying GST on essentials like tea and health insurance, even as corporate entities benefit from over ₹1 lakh crore in annual tax breaks. He criticised the continued exclusion of petrol and diesel from the GST framework, arguing that it unfairly affects farmers and transporters.

Indian Navy Rescues 14 Crew Members, Contains Fire on Palau-Flagged Tanker in Arabian Sea

Demonstrating swift action and maritime readiness, the Indian Navy successfully contained a major fire onboard a Palau-flagged oil tanker, MT Yi Cheng 6, in the North Arabian Sea on June 29, 2025. The vessel, operating approximately 80 nautical miles east of Fujairah in the United Arab Emirates, had reported a severe fire in its engine room and a total power fail-

Following a distress call from the ship, the Indian Navy immediately launched a high-risk firefighting and rescue operation. Warship INS Tabar was swiftly deployed and proceeded at maximum speed to the location. Upon arrival, seven of the 14 Indian crew members were promptly evacuated to the Navy ship using small

"All evacuated crew were safe and medically examined onboard INS Tabar. No injuries were reported," the Navy said in an official statement. The remaining crew, including the ship's master, stayed onboard to assist with firefighting efforts.

A six-member team from INS Tabar initially joined the ship's crew to battle the blaze, successfully reducing the fire's intensity and confining the smoke to the engine room. The operation was later reinforced with an additional 13 Indian Navy personnel — five officers and eight sailors — to

strengthen the containment effort. After sustained firefighting over several hours, the joint team successfully brought the fire under control. INS Tabar has remained in the vicinity of MT Yi Cheng 6 to provide continued assistance and ensure safety.

The Indian Navy praised the courage and professionalism of its personnel, stating, "The valiant effort of Indian Naval personnel ensured the safety of the vessel and all Indian crew members. This operation underscores the Navy's rapid response capability, operational preparedness, and commitment to maritime safety."

Telangana Pharma Plant Blast: Death Toll Rises to 36, Rescue Efforts Continue

The death toll in the tragic explosion at Sigachi Industries' pharmaceutical plant in Pashamylaram, Sangareddy district, has climbed to 36, Chief Minister Revanth Reddy confirmed on Tuesday. The blast, which occurred on Monday, is suspected to have been triggered by a chemical reaction inside the facility.

CM Reddy, who visited the site with cabinet colleagues, announced that the state government would ensure compensation of ₹1 crore is paid to the families of each deceased worker. He also promised strict action against those responsible for the incident and visited hospitals to meet the injured.

Authorities revealed that most of the victims were migrant workers termediates.

Pahalgam attack was economic warfare

India won't yield to Pak's nuclear blackmail: Jaishankar

External Affairs Minister S. Jaishankar has called the April 22 Pahalgam terror attack in Jammu and Kashmir an "act of economic warfare," intended to destroy tourism in the region and incite religious violence. Speaking at a fireside chat with Newsweek CEO Dev Pragad at One World Trade Centre in Manhattan, Jaishankar emphasized that India will not allow nuclear threats to deter its response to terrorism emanating from Pakistan. "This was meant to cripple Kashmir's economy and provoke communal tensions," he said, referencing reports that attackers forced victims to identify their religion before killing them. The attack, claimed by The Resistance Front (TRF), a Lashkar-e-Taiba (LeT) affiliate, left 26 civilians dead and prompted India's launch of Operation Sindoor, targeting terror infrastructure across the border.

Jaishankar stressed that Pakistan-based terror groups operate openly and are headquartered in populated cities. "Everyone knows where the headquarters of these organisations are. Those were the targets destroyed in Operation Sindoor," he said. Responding to U.S. President Donald



Trump's claim that trade pressure helped end the recent India-Pakistan conflict, Jaishankar dismissed the assertion, saying there was no link between trade talks and military decisions. "I was in the room when Vice President JD Vance spoke to Prime Minister Modi on May 9. The PM was unmoved by Pakistan's threats and made clear there would be a response," he stated.

He noted that Pakistan launched an attack that night, to which India responded swiftly. The next morning, U.S. Secretary of State Marco Rubio informed him that Pakistan was ready for talks.

SpaceX's Starlink Nears Launch in India After Clearing Regulatory Hurdles

SpaceX's satellite internet service, Starlink, is on the verge of launching in India after clearing most regulatory and licensing requirements, bringing it closer to offering high-speed internet across the country. Dr. Pawan Goenka, Chairman of the Indian National Space Promotion and Authorization Centre (IN-SPACe), India's space regulator, told NDTV that while the groundwork is almost complete, some technical and procedural steps remain before Starlink can become fully operational.

According to DoT sources, Starlink plans to offer bandwidth ranging from 600 to 700 Gbps once operational in India.

While pricing for Starlink's satellite internet in India has not yet been announced,

Trump-Backed Bill Proposes 500% Tariff on Nations Trading with Russia, Including India and China

A controversial new U.S. Senate bill backed by President Donald Trump could impose a 500% tariff on countries that continue to trade with Russia, including major economies like India and China. The legislation, spearheaded by Republican Senator Lindsey Graham and co-sponsored by Democrat Richard Blumenthal, aims to pressure these nations to cut economic ties with Moscow in an effort to weaken Russia's war economy.

Graham revealed in an interview on Sunday that the bill has gained significant bipartisan support, with 84 co-sponsors in the Senate. The proposal would authorize the U.S. President to levy steep tariffs on imports from nations still doing business with Russia, especially those buying oil and other critical goods. "I Was In The Room": S Jaishankar Refutes Trump's India-Pak Ceasefire Claims

External Affairs Minister S. Jaishankar strongly refuted U.S. President Donald Trump's claims that trade negotiations influenced India's ceasefire with Pakistan, labeling such assertions as inaccurate. Speaking in an exclusive conversation with Newsweek, Jaishankar described the recent terror attack in Pahalgam, Jammu and Kashmir, as an "act of economic warfare" aimed at crippling the region's tourism industry and inciting communal unrest.

Referring to the deadly April 22 attack carried out by The Resistance Front, a group linked to Pakistan-based Lashkar-e-Taiba, Jaishankar said, "This was meant to destroy tourism, the mainstay of Kashmir's economy, and provoke



religious violence."

In response, India launched Operation Sindoor, a military offensive targeting terror bases in Pakistan. Jaishankar emphasized that India would not tolerate cross-border terrorism and would not be de-

terred by threats, including nuclear intimidation.

Going to Washington next week to meet with Trump: Netanyahu

Israeli Prime Minister Benjamin Netanyahu announced on Tuesday that he will travel to Washington next week for high-level meetings with U.S. President Donald Trump and other American officials. The announcement came during a Cabinet meeting, where Netanyahu briefly outlined the agenda, highlighting a trade agreement as a central topic of discussion.

While Netanyahu did not provide further details about the proposed trade deal, the visit is widely seen as an opportunity to address a range of critical issues, especially the ongoing conflict in Gaza and the broader regional tensions involving Iran. The timing of the visit is particularly significant, as it comes amid increasing pressure from the international community, including the United States, for a de-escalation in the fighting between Israel and Hamas.

Thailand PM Paetongtarn Shinawatra Suspended Over Leaked Call with Cambodian Leader

Thailand's Prime Minister Paetongtarn Shinawatra was suspended from office on Tuesday by the Constitutional Court following a leaked phone call that sparked protests and political fallout. The call, made during sensitive diplomatic talks with Cambodian Senate President Hun Sen, triggered an ethics investigation and widespread public backlash.

The Constitutional Court unanimously agreed to take up the petition accusing Paetongtarn of breaching ethical standards, and voted 7-2 to suspend her from official duties while the case proceeds. She has been given 15 days to present her defense.

The controversy intensified after a deadly border clash on May 28 left one Cambodian soldier dead. In the leaked call, Paetongtarn was heard making conciliatory remarks that critics say undermined Thailand's national interest. The fallout has fueled growing dissatisfaction over her handling of the border dispute and led to large-scale protests in Bangkok by conserva-

tive, nationalist groups.

Following the court's decision, Paetongtarn said she respects the judicial process and is determined to defend her actions. "My only intention was to prevent escalation and protect our troops from harm," she stated. "If my words caused misunderstanding, I truly apologize." Deputy Prime Minister Suriya Jungrungruangkit is expected to assume the role of acting prime minister, although an official announcement is still pending.

Earlier the same day, King Maha Vajiralongkorn approved a Cabinet reshuffle after a key coalition partner, the Bhumjaithai Party, exited the government over the controversy. The reshuffle removed party leader Anutin Charnvirakul from the deputy prime minister post. Paetongtarn had recently added the role of culture minister to her portfolio, though her future in that post is uncertain.

She also faces a separate ethics investigation by the National Anti-Corruption Commission, which could further jeopardize her political career.





Manufacturing PMI Hits 14-Month High in June on Strong Export Demand




Tndia's manufacturing sector saw its strongest performance **▲**in over a year, with the HSBC India Manufacturing Purchasing Managers' Index (PMI) rising to 58.4 in June 2025, up from 57.6 in May. This marks the highest PMI reading since April 2024 and remains well above the long-term average of 54.1, indicating robust expansion in factory activity.

According to the survey, the surge in manufacturing was driven primarily by a sharp increase in export orders, leading to improved production output, job creation, and order volumes. The report highlighted a record upturn in employment, as manufacturers responded to buoyant demand both domestically and internationally.

"June marked a strong end to the first fiscal quarter, with noticeable gains in output and new orders," the report stated. "External demand rose at one of the fastest rates recorded in over two decades of the survey's history."

The growth in production was largely attributed to intermediate goods manufacturers, while both consumer and capital



goods segments experienced a slowdown. Respondents cited increased operational efficiency and favourable demand conditions as key contributors to higher output levels. Pranjul Bhandari, Chief India Economist at HSBC, noted, "To meet strong international demand, manufacturing firms drew down on inventories, leading to a continued decline in

Interestingly, even as manufacturing accelerated, input price inflation eased to a four-month low, despite persistent cost pressures from materials like iron and steel. However, average selling prices rose sharply as companies passed on increased freight, labour, and material costs to customers. Some firms also raised prices in response to strong demand. The report signals a positive outlook for the manufacturing sector, though it also highlights the uneven nature of growth across segments. With global demand playing a critical role in driving output, Indian manufacturers appear poised to benefit further from favourable export conditions, even as input cost pressures and inventory concerns remain on the

India's Industrial Growth Slows to 9-Month Low of 1.2% in May 2025

India's industrial output growth slipped to a nine-**⊥** month low of 1.2% in May 2025, reflecting a significant slowdown in key sectors such as electricity and mining. This marks the weakest growth since August 2024 and is a decline from 2.6% in April, according to official data released by the National Statistical Office (NSO) on Monday. The April figure was also revised downward from the earlier estimate of 2.7%.

The latest data from the Index of Industrial Production (IIP) — which tracks changes in the volume of production in factories, mines, and utilities — points to broadbased weakness, with particular stress in energy and resource-linked industries. Electricity output contracted sharply by 5.8%, while mining output saw a marginal decline of 0.1% year-on-year.

In contrast, manufacturing, which constitutes the bulk of the IIP, provided some support with 2.6% growth, driven by increased production in machinery, non-metallic minerals, and basic metals. However, this was still notably below the 5.1% growth recorded in the same month last year, indicating persistent softness in industrial momentum.

Sector-wise, consumer goods remained weak, reflecting subdued demand, while capital goods and infrastructure-related output offered modest positive contributions to overall industrial performance.



The IIP reading for May stood at 156.6, up slightly from 154.7 in May 2024, but the slow pace of expansion raises concerns about the resilience of India's industrial recovery amid global uncertainties and domestic demand challenges.

This deceleration in industrial activity may influence monetary policy discussions, especially as the Reserve Bank of India weighs the implications of softening growth against ongoing inflation risks.

India's Trade Deficit Could Rise to \$300 Billion in FY26 Despite Moderate **Oil Prices: ICICI Bank**



TCICI Bank has forecast that In-**L**dia's trade deficit will widen to USD 300 billion in the financial year 2025-26, even though oil prices are expected to remain moderate. This would mark an increase from the USD 287 billion deficit recorded in FY25 and USD 245 billion in FY24, representing 7.0% of the country's GDP.

According to the bank's report, the main driver of the growing trade deficit is the weak performance of India's non-oil exports, which have struggled to keep pace with rising imports. On the other hand, strong domestic economic growth is expected to sustain high import levels, further widening the gap between imports and exports.

Despite the widening trade deficit, ICICI Bank projects that steady inflows from services exports and remittances will help maintain the current account deficit (CAD) at a manageable USD 30

billion, or approximately 0.7% of GDP. The current account deficit includes not only the trade balance but also other international financial flows such as investment income and remittances. A trade deficit occurs when a

country imports more goods than it exports, and India's persistent deficit highlights ongoing challenges in boosting export competitiveness outside of the oil sector. Meanwhile, imports remain robust, driven by strong domestic demand and economic expansion.

The report underscores the importance of strengthening nonoil exports to reduce India's reliance on imports and improve the overall balance of payments. As the economy continues to grow, addressing these structural trade imbalances will be crucial for sustaining external stability and economic resilience in the coming years.

Commercial LPG Cylinder Price Slashed by ₹58.50, Jet **Fuel Sees 7.5% Hike**



2025, delivering mixed news for consumers. While the cost of a 19kg commercial LPG cylinder was reduced by ₹58.50, aviation turbine fuel (ATF) prices saw a sharp increase of 7.5%, driven by global oil market trends.

Following the price cut, commercial LPG cylinders now cost ₹1,665 in Delhi, ₹1,616.50 in Mumbai, ₹1,769 in Kolkata, and ₹1,823.50 in Chennai. This marks the fourth consecutive reduction in commercial LPG rates, totaling a ₹138 cut per cylinder since April. The earlier cuts were ₹41 in April, ₹14.50 in May, and ₹24 in June. The decline in prices has come as a relief for commercial establishments such as hotels, restaurants, and catering services, especially as LPG demand typically dips during the summer months.

In contrast, the ATF price was raised by ₹6,271.50 per kilolitre in Delhi to ₹89,344.05 per kl, reflecting a surge in international crude oil prices following geopolitical tensions, particularly Israel's at-

Oil marketing companies retack on Iran last month. The hike vised fuel prices on July 1, reverses some of the price relief offered in previous months: ATF prices had been reduced by 6.15% in April (₹5,870.54/kl), 4.4% in May (₹3,954.38/kl), and 2.82% in June (₹2,414.25/kl).

> This latest increase in ATF prices is likely to impact airlines significantly, as fuel accounts for nearly 40% of their operational costs. In other metro cities, ATF prices now stand at ₹83,549.23 per kl in Mumbai, ₹92,526.09 per kl in Chennai, and ₹92,705.74 per kl in Kolkata. These rates vary across cities due to differences in local taxes, including VAT.

> While no immediate response came from airlines regarding the price hike, the increase could translate into higher airfares if sustained. Meanwhile, the continued easing of LPG prices provides some cushion to small businesses grappling with inflation and fluctuating energy costs. The diverging trends in ATF and LPG pricing highlight the volatile nature of global energy markets and their domestic implications.

Bengaluru Traffic Jam at 3:30 AM? Resident Warns of 'Ticking Time Bomb'

Tn a city infamous for its traffic woes, Lone Bengaluru resident's recent experience is raising fresh concerns. Sharing his ordeal on Reddit, the longtime resident revealed he was stuck in gridlock not once, but twice—at 3:30 AM and again at 5:40 AM—warning that the city's infrastructure is now a "ticking time bomb."

"I've lived in Bengaluru for over a decade, and this is the worst I've seen," he wrote. "A negative compound effect of small failures in various areas is now exploding." He described how a trip from Indiranagar to Manyata Tech Park via Outer Ring Road (ORR) took him nearly two hours—at 3:30 in the morning.

Later that same day, a beam collapse near Elements Mall at 5:40 AM created chaos again. "There were glass pieces on the road. I think it might've hit a car, though I can't confirm. But it's going to be pandemonium there today," he added, urging people to hold BBMP and local leaders accountable.

The post resonated widely, with others echoing frustration. One user said they've witnessed the city's decline firsthand: "Even the metro is overcrowded. Roads are full of garbage, rents are crazy high, and basic infrastructure like footpaths is missing." Another noted that the ORR stretch is constantly under metro construction



Confessions of a Superstar: Unveiling the Aamir Khan We Never Knew


Tf the story of Hindi cinema had a **⊥**protagonist, Aamir Khan would be a compelling choice. Known for his calculated risks, deep emotional range, and dedication to craft, Khan has carved a unique space among Bollywood's trinity of superstars. Unlike his contemporaries Shah Rukh Khan and Salman Khanwho leaned into charisma and familiarity—Aamir has thrived on unpredictability, choosing roles and stories that often challenge mainstream expectations.

From producing a nearly four-hour sports drama (Lagaan), to playing a supporting role to a child in Taare Zameen Par, to transforming his body to play the father of two wrestlers in Dangal, Khan has repeatedly defied the norms of commercial cinema. Yet, despite his largerthan-life presence and critical acclaim, he has remained a deeply private figure—until now.

A Shift in Persona

In 2025, something changed. Aamir Khan, long known for his guardedness, has become strikingly visible and emotionally open. As part of the promotions for his latest film, Sitaare Zameen Par, he has appeared across podcasts, TV shows, and social media platforms. Dressed simply in round-neck t-shirts and thickrimmed glasses, he has played games, shared personal anecdotes, and even shed tears—offering a raw, unfiltered version of himself rarely seen before.

Interestingly, while the promotional campaign is officially for Sitaare Za-



meen Par—a remake of the Spanish film Champions, featuring a neurodivergent cast—the real subject of these appearances seems to be Khan himself. In one interview, he revealed regrets about being an absent parent. In another, he shared lesser-known personal details, like learning Marathi at 44, or naming one of his dogs 'Sundari.' He's confessed to eloping with his first wife and even considered quitting acting after the failure of Laal Singh Chaddha.

This new phase feels like a rebranding, perhaps in response to past controversies and online backlash, or simply a man at 60 becoming more comfortable in his own skin. His past remarks about growing intolerance in India led to widespread trolling and boycotts, and this new visibility could be seen as an attempt to reclaim his public image. Still, the authenticity in his voice and the vulnerability in his demeanor suggest something more heartfelt.

Marketing or Meaning?

Cynics might view this transformation

as a calculated marketing move, aligning Aamir's personal narrative with Sitaare Zameen Par's core message—"Sabka apna apna normal" (Everyone has their own normal). His public appearances, steeped in emotional honesty, reflect the same individuality and acceptance the film champions. Whether he's eating vada pav at Dadar station, acknowledging his complex relationships, or crying on camera, Aamir is redefining what stardom looks like—one that allows space for flaws, feelings, and fallibility.

This strategy isn't new for Khan. Over the years, he's employed innovative promotional tactics—disguises during 3 Idiots, thematic haircuts for Ghajini, and even appearances on TV serials for Talaash. But this time, the promotional lens has turned inward.

A Second Debut?

There's a strange beauty in watching a veteran actor open up like a debutant eager, uncertain, yet unafraid. Aamir Khan's new public persona is not just about promoting a film; it feels like a reintroduction. He's no longer just the perfectionist superstar; he's a man willing to be seen, heard, and felt.

Whether this vulnerability is a lasting shift or a temporary phase, it has offered a rare and moving glimpse into the man behind the myth. This is not just a marketing campaign—it's a quiet revolution in how we see our stars. Aamir Khan, it seems, is finally playing his most complex role yet: himself.
