Petrol Smuggling from Yanam to Andhra...

MLA Making Crores From ₹15-₹18 Price Gap

Andhra Pradesh: Petrol and diesel smuggling from Yanam, a Union Territory enclave of Puducherry, into Andhra Pradesh is turning into a fullscale racket. With fuel prices in Yanam lower by ₹15 to ₹18 per litre compared to Andhra, this price gap has become fertile ground for an illegal trade network allegedly involving mafia gangs, business dealers, and even public representatives.

Low Tax, High Profit — Mafia Finds A Loophole

Yanam enjoys lower fuel taxes as part of the Union Territory of Puducherry. While petrol in Yanam costs about ₹92 per litre, in Andhra it crosses ₹110. Smugglers are exploiting this gap, transporting fuel in everything from modified tankers to bikes carrying 2-litre bottles. With one full tanker capable of ferrying 10,000 to 12,000 litres, a single trip could yield profits up to ₹1.5 lakh — forming the economic backbone of this illicit network.

Politicians And Officials

Under Scanner

Local sources allege that some public representatives and officials are being bribed to allow the passage of fuel tankers and vehicles across borders unchecked. There are even serious claims that one MLA is receiving over ₹1 crore every month from this network. "Petrol is being moved across daily — how can no one notice? The silence seems strategic," remarked a resident.

Organised Racket, **Coordinated Routes**

Fuel is being smuggled systematically through various well-planned methods. Small vehicles like bikes and autos are being used to transport petrol in 2-litre bottles through narrow gully routes that bypass main roads and

checkpoints. In addition to this, vans equipped with false tanks are being deployed to move larger quantities of fuel discreetly. Most of this illegal transportation is taking place at night, often near police check-posts, where smugglers are reportedly moving undetected due to alleged local collusion Central-State Probe or strategic silence from authorities. Locals are reportedly helping by providing storage spaces and turning a blind eye, all for cash. The illegally transported fuel is then sold freely in Andhra, hurting legitimate fuel dealers and cheating the state government of hundreds of crores in tax revenue.

Fake Fuel and

Safety Hazards

Another worrying trend is the mixing of smuggled fuel with fake diesel, leading to frequent vehicle damage and increasing road safety hazards. Consumers, lured by cheaper rates, are unknowingly endangering their own lives and vehicles.

Administrative

Inaction Fuels Mafia

There is growing frustration over the lack of response from both Andhra Pradesh authorities and the Yanam administration. The police, excise officials, and local enforcement teams have allegedly failed to act despite clear signs of an expanding mafia network. This has led to suspicions that multiple layers of the system are com-

Public Demand For

Locals and civil society groups are now demanding a joint task force to curb this inter-state smuggling operation. With clear implications of corruption, tax evasion, and public endangerment, they are calling for increased surveillance and a thorough investigation into the role of officials and public representatives. Unless swift and coordinated action is taken, what is now a petrol smuggling network may soon become a "petrol gold" mafia, threatening governance, public safety, and economic stability.

No Plan to Merge Vizag Steel With SAIL: Union Minister

Union Minister of State for Steel, Bhupathi Raju Srinivasa Varma, clarified that there is no proposal under consideration to merge the Visakhapatnam Steel Plant with the Steel Authority of India Limited (SAIL). His statement comes amid continued demands from the Visakhapatnam Steel Protection Struggle Committee, which has been urging the central government to withdraw the privatisation decision and instead merge the plant with SAIL.

Responding to a question raised by Samajwadi Party MP Aditya Yadav in the Lok Sabha on Monday, the minister said, "There is no proposal to merge Visakhapatnam Steel with SAIL." He reiterated that the Central government has provided financial assistance of ₹11,440 crore to ensure the plant continues to operate as is. The statement is expected to have a significant impact on the ongoing protests and agitation surrounding the future of the steel plant. The plant, which holds strategic and economic importance to the region, has been at the centre of public and political concern ever since discussions on its privatisation began.



ISRO Launches NISAR Satellite Successfully

In a significant milestone for India's space research, the Indian Space Research Organisation (ISRO) has successfully launched the NISAR (NASA ISRO Synthetic Aperture Radar) satellite into its designated orbit using the GSLV-F16 rocket. The launch was carried out from the Satish Dhawan Space Centre (SHAR), Sriharikota. The mission marks a remarkable achievement in ISRO's journey, as the GSLV-F16 placed the satellite into orbit just 18 minutes and 40 seconds after lift-off. NISAR, jointly developed by NASA and ISRO, is a powerful earth observation satellite equipped to monitor climate change and natural disasters with high precision.

NISAR is designed to provide early warnings and detailed data on natural calamities such as droughts, earthquakes, cyclones, and changes in underground water levels. With its cutting-edge radar technology, the satellite will offer continuous, high-resolution monitoring of Earth's surface dynamics. ISRO announced that before making NISAR's services available to the public, a rigorous testing phase of 35 to 40 days will be conducted to validate all systems and data integrity. Upon success-

ful completion of these tests, the satellite will begin its operational phase,



Centre Establishes 94 Biotech Incubators; AP Hosts Three



Liquor Scam Blowout: 11Cr Seized in Hyderabad

In a major breakthrough in the high-profile liquor scam, the Special Investigation Team (SIT) has seized ₹11 crore in unaccounted cash following early morning raids in Hyderabad. The operation was based on critical information provided by Varun, who has been identified as Accused No. 40 (A-40) in the case.

According to SIT officials, the cash was discovered at a farmhouse in Kacharam village, Shamshabad mandal. The farmhouse, named Sulochana Farms, is registered under the name of Professor Tagala Bal Reddy. The raids were carried out in the early hours of the Wednesday, and the seized cash has since been transported to Vijayawada for further investigation.

Varun reportedly admitted that he, along with another accused named Chanakya, had concealed the money in 12 boxes as per instructions from Kesireddy Ra-



jasekhar Reddy, the prime accused (A-1) in the liquor scam. He claimed the money was hidden in June 2024. This confession provided a crucial lead that enabled the SIT to locate and recover the massive stash. Following the seizure, Varun was brought to the SIT office for intensive questioning. Officials believe that the ₹11 crore is part of a larger money laundering and corruption network linked to liquor licensing and distribution irregularities that are under probe. The SIT is now investigating the origin of the money, its intended usage, and the involvement of other key players. Officials are also examining the ownership documents of the farmhouse and suspect that the location may have been used as a regular hideout for illegal cash storage.

This development marks a significant advance in the liquor scam investigation, which has already implicated several political and business figures. The SIT is expected to continue its search and interrogation in the coming days to uncover the full extent of the financial misappropriation.

Achchenna Slams Jagan on **Crop Insurance**

Andhra Pradesh Agriculture Minister Achchennaidu lashed out at former Chief Minister Y.S. Jagan Mohan Reddy for allegedly misleading farmers with false promises about crop insurance during his tenure. Speaking to the media in Amaravati on Wednesday, the minister accused the previous YSRCP government of deceiving farmers by promoting the idea of crop insurance for just one rupee, while in reality, not even a nominal insurance benefit was imple-

He revealed that because the Ja- ment—reportedly linked to Jastate's share of insurance premiums, claims worth ₹3,138 crore remained pending, severely impacting farmers. Achchenna claimed that former CM Jagan misled the Assembly by stating that insurance amounts had been paid, and only after current TDP chief Chandrababu Naidu staged protests did



the previous government hurriedly release ₹590 crore.

The minister further alleged that water from Pulivendula Reservoir was diverted to Bharathi Ceine farmers. He criticized the former administration for neglecting agriculture and protecting ganja (cannabis) cultivation instead.

Achchenna also highlighted that under Jagan's rule, the expansion of ganja cultivation went unchecked while real issues of farm-

ers were ignored. In contrast, the current coalition government has revived the neglected crop insurance scheme as part of its commitment to farmers' welfare. He said that 46.5 lakh eligible farmers are now benefitting under revived schemes.

As a relief to farmers, Achchenna announced that on August 2, the state government will deposit ₹5,000 under the Annadata Sukhibhava scheme, in addition to the ₹2,000 provided by the Centre under PM Kisan Yojana.

Meanwhile, in Lok Sabha on Tuesday, Union Agriculture Minister Shivraj Singh Chouhan also critgan government failed to pay the gan's relatives—and to sugarcane icised the previous Jagan govfields, ignoring the needs of genu- ernment. He pointed out that Andhra Pradesh did not release funds under the Pradhan Mantri Fasal Bima Yojana for three years, though the Centre had paid its share. He added that if states fail to pay their share, the Centre must transfer funds to farmers with 12% interest.

Dr. Jitendra Singh in the Lok Sabha, in response to questions raised by MPs Kesineni Sivanath (Chinni) and Lavu Krishnadevarayalu.

Dr. Singh stated that three biotech incubators are currently operational in Andhra Pradesh. These include the Andhra Pradesh MedTech Zone in Visakhapatnam, YSR Cancer Research Park, and the bio-incubator at Sri Padmavati Mahila Visvavidyalayam in Tirupati.

Between 2012 and 2025, the central government sanctioned ₹489.42 crore for the development, operation, and expansion of these biotech incubators across the country. Of this, Andhra Pradesh received ₹16.23 crore — ₹4.95 crore for the Med-Tech Zone, ₹7 crore for the YSR Cancer Research Park, and ₹4.28 crore for the Tirupati universi-

These incubators have collectively supported over 2,500 start-ups, facilitated the market launch of more than 800 products, and contributed to employment for over 10,500 individuals. They have also resulted in the registration of 1,300 intellectual property rights and delivered over 5,000 training programs, benefiting nearly 2.5 lakh individuals. Dr. Singh added that the government plans to set up 10 to 15 new incubators annually, allocating ₹20–30 crore for this initiative each year. He also emphasized that significant progress has been made in health and agricultural biotech sectors. The functioning of these centres is regularly reviewed through expert committees, industry representatives, and academic institu-

ID Card Enough to Avail Free Ride: RTC Chairman

Andhra Pradesh RTC Chairman Konakalla Narayana announced that women can avail free bus travel across the state from August 15 using any government-issued ID card. He emphasized that the scheme, initiated by Chief Minister N. Chandrababu Naidu, aims to bring transformative change in the lives of women.

Narayana, along with APSRTC Managing Director Dwarka Tirumala Rao, reviewed the preparations at the NTR Bus Station

in Guntur. They held a meeting with depot managers to discuss the readiness, challenges, and operational guidelines for the successful implementation of the scheme.

RTC MD Dwarka Tirumala Rao stated that women can travel for free in various services including Palle Velugu, Express,

Metro Express, and City Ordinary buses within urban areas. He mentioned that final government orders are expected to be issued after the upcoming cabinet meeting.

Officials confirmed that women can travel to any destination within the state without paying a fare, as long as they present a valid ID card issued by either the state or central government. The RTC is actively working to ensure smooth implementation and address any hurdles in advance.

Govt Approves Smart Street Vending Markets

The Andhra Pradesh government has given its approval to set up smart street vending markets in seven major urban areas across the state. These markets aim to benefit women from self-help groups (SHGs) and street vendors by providing them with improved income opportunities and economic stability.

Following the successful pilot project of a smart vending market at Mypadu Road in Nellore district, which received an encouraging response from the public, the government decided to expand the initiative. It has now officially granted permission to proceed with similar projects in other cit-

Under the guidance of MEPMA (Mission for Elimination of Poverty in Municipal Areas), the smart vending markets will be established in Anantapur, Kurnool, Tadepalli-Mangalagiri, Ongole, Srikakulam, Vijayawada, and YSR Kadapa municipal corporations. Each market may include up to 200 shops.

Municipalities, in coordination with banks, will facilitate loans to eligible beneficiaries for setting up shops. A majority of the shops are expected to be allotted to SHG women to strengthen their livelihoods.

These markets are part of the state's broader strategy to empower urban poor, formalize street vending, and promote inclusive urban development.

Minister Promises Housing for All Eligible Beneficiaries

Minister for Housing and I&PR, Kollu Parthasarathy, assured that the government will sanction houses along with house sites to every eligible individual in Andhra Pradesh. He made these remarks while participating as the chief guest in the "First Step in Good Governance" programme, held as part of the state's flagship initia-

Accompanied by MLA Amilineni Surendra Babu, district party president Venkata Shivudu Yadav, party observer Nageshwar Yadav, and senior TDP leaders, Minister Parthasarathy criticized the previous YS-RCP government. He stated that the state was pushed into a debt trap due to reckless decisions and "button-pushing" welfare schemes without a proper economic plan. He lauded Chief Minister Chandrababu Naidu and Minister Nara Lokesh for actively attracting global investments and simultaneously implementing election promises. "Despite having a Chief Minister from Rayalaseema for five years, the region was neglected. Basic repairs to irrigation project gates were not undertaken," the Minister alleged.

Parthasarathy said the new coalition government has now allocated funds for Rayalaseema irrigation projects. He affirmed that all eligible people would soon receive houses and house sites. He also revealed that due to negligence by the previous government, works on the BTP canal project had stalled, leading MLA Amilineni to fund the remaining works from his personal resources.

MLA Amilineni further explained that despite water reaching Chapiri village, the final 1.5 km canal section was left incomplete, cutting off water to Chapiri lake. He assured that with farmers' cooperation, the government will soon complete the project and restore water supply.

He also highlighted that ₹50 lakh worth of CC roads have been sanctioned for Chapiri Panchayat and that work has already be-

YSRCP MP Urges Urea Supply

Rajya Sabha MP Pilli Subhash Chandra Bose has raised serious concerns over the acute urea shortage in Andhra Pradesh during the peak Kharif season, urging Union Chemicals and Fertilizers Minister JP Nadda to intervene immediately. In a letter on Wednesday, Bose emphasized that although the Centre had allocated 1.30 lakh metric tonnes of urea for July, many districts continued to face severe scarcity. He cited key factors behind the crisis, including limited fortnightly allotments, the shutdown of the NFCL unit in Kakinada, and the Ramagundam plant's inability to meet AP's demand. Farmers in districts like Srikakulam, Kurnool, and Rayalaseema were reportedly suffering from long queues, limited purchasing options, and growing anxiety—especially among small and marginal farmers. The MP also referred to reports from local media and civil society groups, which highlighted irregularities in distribution such as delayed dispatches, understaffed retail centers, and last-mile delivery failures. Recent raids uncovered hoarding worth over ₹10 crore, further exacerbating the crisis. Bose urged the Union Minister to expedite July-August fertilizer supplies, reconsider the Kakinada plant's closure, deploy mobile vans in affected mandals, and enforce real-time stock tracking to ensure equitable distribution. In a separate but significant intervention in Parliament, Bose, the YSR Congress Party's Rajya Sabha floor leader, applauded the Indian government's swift and resolute response to the Pahalgam terror attack through Operation Sindoor.

Good Governance Drive a Big Success

Collector Warns Black Burley Farmers



TPN Correspondent | Bapatla District Collector Venkata Murali has issued a stern warning that any illegal cultivation or sale of Black Burley tobacco beyond government regulations will face strict action, including the destruction of crops. He made these remarks during an interaction with farmers at the Dis-

trict Collectorate-Markfed premises on Wednesday.

The Collector clarified that the government will not initiate action against the companies that sold Black Burley seeds, but focus remains on preventing misuse at procurement centres. He said the tobacco procurement process is progressing well, with around 300 farmers selling produce daily. The government has set a target of procuring 600 tonnes per day, and approximately 1800 tonnes per week.

To facilitate timely purchase, the administration has decided to open markets even on Sundays for those farmers who missed their scheduled slots during the week. Only scheduled farmers will be allowed to sell at the centres, and any deviation from the schedule will not be tolerated.

Strict action will be taken against intermediaries and traders trying to bring tobacco under farmers' names. If such malpractice is detected, criminal cases, including PD (Preventive Detention) Act provisions, will be filed. The Collector assured that all eligible farmers listed in the schedule will be allowed to sell their produce without any hurdles. He also advised farmers to ensure that tobacco moisture levels remain below 20% to avoid rejection or penalties.





Rain To Return in Telugu States **After 2-Day Break**

The Indian Meteorological Department (IMD) has issued a fresh alert for both Telugu states, warning of renewed heavy rainfall due to the formation of another weather system over the Arabian Sea. After two days of dry weather following a week-long spell of heavy rain, residents of Andhra Pradesh and Telangana are now bracing for another round of showers.

According to the IMD, a new air mass is developing in the Arabian Sea, which is likely to trigger heavy rainfall across both states in the coming days. The department forecasts largely dry weather on Wednesday and Thursday, but warns of intense rainfall starting later this week. Officials have urged the public to stay alert, especially in low-lying and coastal areas.

The previous week saw persistent heavy rains due to a low-pressure system in the Bay of Bengal, leading to flooding and disruption in several districts. The recent sunny skies gave people temporary relief, but the new alert suggests they may

have to prepare for more adverse conditions. In Telangana, the IMD said that light showers may occur in districts like Hyderabad, Warangal, Karimnagar, Yadadri Bhuvanagiri, Mahabubnagar, Nizamabad, Rangareddy, Adilabad, and Komuram Bheem Asifabad. However, the weather is expected to remain dry during the day for the next 48 hours. Heavy rainfall accompanied by thunder and lightning is likely to resume thereafter.

In Andhra Pradesh, the impact of a low-pressure zone continues, especially in northern coastal regions. Moderate to heavy rains are expected in districts such as Vizianagaram, Srikakulam, Parvathipuram, Alluri Seetharamaraju, Manyam, Anakapalle, Visakhapatnam, and Kakinada. Authorities have issued an orange alert in these areas.

Fishermen have been strictly warned against venturing into the sea, and residents in vulnerable coastal areas have been advised to shift to safer locations as a precaution.

PM Mudra Yojana Scam: ₹140 Cr Fraud, 2 Held

In a major financial fraud case, Telangana Crime Investigation Department (CID) has arrested Tippaneni Ramadasappa Naidu, 61, chairman of Mudra Agriculture Skill Development Multi-State Cooperative Society Limited, and his son Sai Kiran, 43, for duping nearly 2,000 people of ₹140 crore. The accused allegedly misused the branding of the Centre's Pradhan Mantri Mudra Yojana (PMMY) to portray their society as a government-backed entity. Established in 2017, the co-

operative society lured thousands of farmers, unemployed youth, and daily wage earners through extensive advertisements in regional newspapers. The victims

on investments and permanent government jobs once the society was converted into a full-fledged bank.

The CID probe revealed that the society released recruitment advertisements for "government" mar-2,000 keting supervisor jobs, collected original educational certificates, and demanded money under the pretext of share capital and investment bonds. The victims were led to believe they were investing in a legitimate government initiative.

The society rapidly expanded, opening around 330 branches across Telangana and Andhra Pradesh. It hired over 1,600 employees to collect public deposits. Employees faced pressure to meet daily collec-

were promised high returns tion targets, with penalties and salary cuts imposed on those who failed. Those who resigned were reportedly denied refunds and coerced into signing blank documents.

According to CID officials, the scam allowed the father-son duo to collect about ₹140 crore. A large portion of the funds was used to purchase industrial plots in Andhra Pradesh's Anantapur district and properties in Telangana's Keesara region.

The scam was uncovered following multiple complaints filed across Telangana. The CID took over the investigation, tracing financial records and seizing documents. The two accused were produced in court and remanded to judicial custody.

Minors Assault Kids in Ganja High.. **Video Goes Viral**

In a disturbing incident from Kalisamudram village in Kadiri mandal, Sri Sathya Sai district, a group of minors under the influence of ganja violently assaulted two other children—an act that was captured on video and is now going viral on social media. According to local sources, the incident involved three boys, reportedly under 15 years of age, who brutally attacked two other children while another minor recorded the scene on a mobile phone. The video shows the attackers using abusive language and thrashing the victims with footwear, sparking outrage among residents.

The incident has brought to light the growing and unchecked availability of ganja even in rural areas. Concerned villagers say that drug abuse among minors is becoming a serious issue in Kalisamudram, with many children reportedly addicted to ganja. Parents are now deeply worried about their children's future, as the addictive substance is ruining young lives at



an alarming rate.

"This is heartbreaking. We never imagined our children would fall into such habits. We feel helpless," said one parent, expressing anguish over the unfolding crisis. Locals have reportedly informed the police about the rampant ganja usage in the area, urging for immediate action.

The incident has triggered a broader conversation about drug abuse among minors and the urgent need for stricter monitoring and rehabilitation initiatives in rural Andhra Pradesh.

Fake Posts to Face Legal Action: SP

Sri Sathya Sai District Superintendent of Police (SP) V. Ratna, IPS, has issued a strong warning against the spread of false information through media and social media platforms. In an official statement, SP Ratna clarified that anyone posting misleading or baseless content on WhatsApp, Facebook, Instagram, or news portals will face legal consequences under relevant laws.

The SP referred to a recent case from Kalisamudram village in Kadiri mandal, where false reports circulated about a group of youth allegedly fighting under the influence of ganja. "Our investigation revealed that the altercation was due to alcohol consumption, not ganja use," she said. She condemned the spread of misinformation without verification and urged citizens to act responsibly before posting on social media.

Another incident involved reports of a major clash near the Kia Motors factory in Penukonda. The SP dismissed the rumors, confirming that it was a minor argument due to personal reasons, which was promptly resolved by police intervention.

SP Ratna warned that false posts, especially those intended to defame or provoke unrest, will invite stringent legal action. She also urged the public to avoid defamatory content or personal attacks online.

She encouraged citizens to report any criminal or anti-social activity directly to the police and assured that informants' identities would be kept confidential. The district police remain committed to maintaining peace and curbing illegal activities such as drug use and misinformation campaigns.

Their work demands high cognitive effort, moral courage, and continuous learning — all while facing job insecurity, physical risk, and limited recognition.


Intellectual Labor Without Respect

Journalism is not just about reporting facts; it involves investigation, contextual analysis, critical thinking, and articulation — all hallmarks of intellectual labor. Yet, unlike academics, scientists, or even popular influencers, journalists are seldom accorded the same intellectual stature. Their mental rigor often gets dismissed as "just writing stories."

Example: A senior reporter working tirelessly to uncover political corruption may be paid less than a PR executive writing promotional material for a the 'Fourth Pillar' brand.

Young GM Divya Deshmukh **Makes Chess History**

On July 28, 2025, in Batumi, Georgia, 19-year-old Divya Deshmukh made history by becoming the first Indian woman to win the FIDE Women's World Cup. In a thrilling final against legendary compatriot Grandmaster Humpy Koneru, Divya's victory marked not just a personal milestone, but a defining moment in Indian chess.

The 2025 Women's World Cup featured 107 top players from 46 nations. Divya's path to the crown was anything but easy. She overcame World No. 6 Zhu Jiner, former World Champion Tan Zhongyi, and veteran Harika Dronavalli. The final clash with Humpy, one of India's most decorated players, was a dramatic showdown of nerves and skill. After the classical and first rapid game ended in draws, Divya sealed her win in the second rapid tiebreak with composure and precision.

This win catapulted Divya into the global spotlight and granted her the Grandmaster title—the highest in chess—automatically. Uniquely, she achieved it without previously earning a single GM norm, a testament to the magnitude of her triumph. She also secured a coveted place in the 2026 Candidates Tournament, moving one step closer to challenging for the Women's World Championship title. Divya is now only the third woman to win this title, following Alexandra Kosteniuk and Aleksandra Graciano. Her win is historic not just for its rarity but because it symbolizes India's rising dominance in women's chess. For the first time, four Indian women reached the quarterfinals of the event—Divya, Humpy, Harika, and Vaishali—signaling a generational shift in the sport.

India-China Thaw Amid U.S. Strain: Tactical Pivot or Strategic Gamble?



Recent developments suggest a surprising softening in India-China relations, despite ongoing tensions. This thaw appears paradoxical, given China's continued support for Pakistan during Operation Sindoor, the initiation of the Yarlung Zangbo dam project (seen as a threat by India), and rising economic coercion through export curbs on critical inputs like rare earths, semiconductors, and agri-tech. Yet, diplomatic signals indicate a willingness to engage: External Affairs Minister S. Jaishankar's visit to China, India's openness to revive the Russia-India-China (RIC) mechanism, resumed tourism visas and flights, and discussions over a possible 24% Chinese stake in Indian firms.

This convergence comes amid growing unease in India-U.S. relations, marked by trade friction, defense procurement issues, and disagreements over Russian sanctions. Delhi, once optimistic about a trade pact, now finds Washington's demands such as wider market access and the removal of non-tariff barriers—increasingly intrusive. President Trump's blunt references to leverage-based diplomacy, particularly around the May 10 ceasefire, and U.S. reluctance on timely defense supplies like GE jet engines, have contributed to Indian skepticism.

India's multi-alignment strategy has long used

tactical shifts in its China posture to extract better terms from the U.S., but this time, the context is more precarious. China is applying multifaceted pressure: militarily, via Pakistan and the LAC; ecologically, through the Zangbo dam; and economically, with coercive trade tactics. India is struggling to respond to these new levers effectively.

China's economic arm-twisting—restricting exports vital to sectors like automotive and defense—is particularly alarming. Companies like Bajaj Auto have already warned of production halts. If China demands dual-use certification, the ripple effects could reach defense manufacturing. Yet, India may feel compelled to engage economically with China due to declining FDI, global supply chain ambitions, and hopes of ending coercive trade practices.

The danger lies in India's tactical overtures becoming strategic vulnerabilities. Increased Chinese participation in sensitive sectors could enable Beijing to exert long-term economic leverage. Past experience shows that temporary goodwill may not result in durable cooperation. As geopolitical volatility grows, India must carefully balance short-term flexibility with long-term resilience lest tactical engagement today turns into strategic dependence tomorrow.

Iran's Strategic Path: A Clarification on Sovereignty, Sanctions, and Misconceptions



In response to the recent article "Snapback to Reality: On Iran's 45-Year Slog to Nowhere," Iran's Ambassador to India, Dr. Iraj Elahi, offers a pointed rebuttal, emphasizing that such narratives distort Iran's historical and strategic reality. While the original piece frames Iran as a nation isolated due to its policies, Ambassador Elahi argues that the country's path is rooted not in defiance, but in dignity and sovereignty.

He begins by reminding readers that the 1979 Islamic Revolution was not born out of blind hostility toward the West. Rather, it was a reaction to decades of foreign interference, coups, and exploitation. Iran's resistance, he asserts, is not about hatred but about refusing subjugation. Its slogans reflect historical memory and the pursuit of justice—not a desire for endless enmity with nations like the U.S. or Israel.

On the nuclear issue, the ambassador defends Iran's record under the Joint Comprehensive Plan of Action (JCPOA), saying that Iran upheld its commitments, as verified by the International Atomic Energy Agency. It was the U.S., under the Trump administration, that unilaterally withdrew from the agreement and re-imposed sanctions. Iran's subsequent actions were lawful and within the deal's framework, contrary to the claim that Iran escalated tensions unprovoked.

Addressing the idea that Iran faces a binary choice between "capitulation or collapse," Ambassador Elahi calls for a more nuanced understanding. He stresses that Iran is open to fair and respectful negotiations—but will not yield to threats disguised as diplomacy. He urges Western powers to recognize their role in fostering mistrust and to end collective punishment through sanctions.

On regional matters, the ambassador defends Iran's alliances in Lebanon, Palestine, Iraq, and Yemen, framing them as support for resistance movements rather than imperial ambition. He points out that Iran has consistently called for regional dialogue and a nuclear-free Middle East—calls that have been ignored while Israel's undeclared arsenal remains untouched.

Concluding his remarks, Ambassador Elahi calls for mutual respect, stating that Iran does not seek conflict but refuses to trade its sovereignty for survival. "Iran will remain what it has always been," he writes—"independent, proud, and unafraid to choose its own path."





"Don't Control Me": Jaya Bachchan Sparks **Controversy Over 'Operation Sindoor' Remarks**

Samajwadi Party MP and veteran actor Jaya Bachchan stirred a heated debate in the Rajya Sabha today during a discussion on Operation Sindoor, questioning both the intelligence failure behind the Pahalgam terror attack and the naming of the operation itself.

Indus Water Treaty Suspended: Jaishankar Slams Congress Over Historic "Mistakes"

External Affairs Minister S. Jaishankar announced in the Rajva Sabha on Wednes- He particularly targeted former Prime Minday that the Indus Water Treaty (IWT) with ister Jawaharlal Nehru, quoting his state-cooperation cannot coexist with terrorism.

Pakistan will be held in abeyance until Is- ment in Parliament from November 30, lamabad irreversibly ends its support for terrorism. The decision follows the deadly terror attack in Pahalgam in April, which claimed the lives of 26 people.

During his address, Jaishankar took a sharp dig at the Congress party, accusing it of being "uncomfortable with history" and unwilling to confront past errors. He cited how the treaty, signed in 1960, granted Pakistan access to major rivers originating in India, calling it a "unique agreement" in global diplomatic history.

"I cannot think of any other agreement where a country allows its major rivers to flow into another without securing its own rights," Jaishankar said, referring to the provisions of the IWT.

1960, where Nehru allegedly prioritized the interests of Pakistani Punjab over Indian states. "There was no mention of the farmers of Kashmir, Punjab, Rajasthan, or Gujarat," Jaishankar said, questioning the intent and foresight of the treaty's original architects.

The minister credited Prime Minister Narendra Modi with reversing historical oversights, citing the abrogation of Article 370 and now the suspension of the Indus Water Treaty as evidence of decisive action. "We were told for 60 years that these mistakes could not be corrected. PM Modi has proven that they can," he stated.

Jaishankar concluded with a firm warning: "Blood and water will not flow together." The suspension of the IWT, he said, is a strong diplomatic signal that peace and

Priyanka Gandhi Leads Protest Over Nuns' Arrest; **Shashi Tharoor's Absence Raises Eyebrows**

Congress leader Priyanka Gandhi Vadra led a high-profile protest in Parliament on Tuesday, condemning the arrest of two Kerala-based Catholic nuns in Chhattisgarh, who were accused of human trafficking and forced religious conversion. However, the absence of senior Congress MP Shashi Tharoor, who participated in a similar protest just a day earlier, raised fresh questions about his growing distance from the party leadership.

Ms Gandhi Vadra, joined by other Kerala Congress MPs, denounced the arrests as a targeted attack on minorities. "These nuns were accused of things they were not in-

volved in. They were manhandled and taken away. We are protesting against such assaults on minority communities," she told reporters.

Tharoor, who had vocally supported the cause on Monday with a placard reading "India for all, proud to be one," was notably missing on Tuesday. His absence is being viewed in the context of recent tensions between him and the Congress high command, especially following his remarks after the Pahalgam terror attack and the government's Operation Sindoor. His refusal to speak in Parliament during the Operation Sindoor debate — allegedly because he would not "contradict himself for party messaging" — only deepened the rift.

The controversy stems from the arrest of two nuns at Durg railway station. Allegations were made by Bajrang Dal members that the nuns were trafficking three minor tribal girls. The police booked them under the Bharatiya Nyay Sanhita and the Chhattisgarh Freedom of Religion Act.

The incident has triggered nationwide backlash. Rahul Gandhi demanded their immediate release, saying religious freedom is a constitutional right. Interestingly, BJP Kerala leaders also defended the nuns, with party president Rajeev Chandrasekhar promising to assist in their release. However, Chhattisgarh CM Vishnu Deo Sai stood by the arrests, accusing the opposition of politicising the issue.



"CJI's Office Not a Post Office": **Supreme Court Questions Judge** in Cash Recovery Case

In a high-profile courtroom exchange, the Supreme Court strongly rebuked Justice Yashwant Varma, who is under scrutiny after large sums of cash were found at his Delhi residence during a fire incident. Justice Varma is challenging the findings of a three-member in-house committee that recommended his removal.

The bench, led by Justices Dipankar Datta and Augustine George Masih, emphasized that the Chief Justice of India's office "is not a post office" but carries a national duty as the judiciary's leader. The remarks came in response to Senior Advocate Kapil Sibal, who argued that the committee overstepped its constitutional role.

Sibal insisted that under Article 124 of the Constitution and the Judges (Inquiry) Act, the committee cannot recommend a judge's removal—only advise the Chief Justice. He added that allowing this process would create an "extra-constitutional mechanism."

Justice Datta countered this, asserting that the CJI has a responsibility to forward misconduct reports to the President and Prime Minister when warranted. He added that the Chief Justice's office must act when credible information is received, not merely pass along complaints.

Sibal further alleged that the findings were politically influenced and that Justice Varma was not given a fair opportunity to respond during the inquiry. The bench, however, maintained that the panel's report is preliminary and does not bind future parliamentary action.

Critically, the bench also questioned Justice Varma's timing in approaching the court, stating, "You were waiting for a favourable outcome, and when it turned against you, you came here. That does not inspire confidence."

The court reserved its judgment but made clear that the issue touches on the integrity of the judiciary and constitutional responsibility at the highest levels.



Some States Failed: Minister Shivraj **Singh Announces Changes To Crop Insurance Scheme**

Union Agriculture Minister Shivraj Singh Chouhan today announced major reforms to the Pradhan Mantri Fasal Bima Yojana (PMFBY), aimed at protecting farmers from losing crop insurance benefits due to state government defaults.

Highlighting issues faced under the previous Jagan Reddy government in Andhra Pradesh, Chouhan revealed that the state failed to pay its share of the insurance premium for three consecutive years, leaving many farmers without compensation. "Some states, like Andhra Pradesh, committed to covering the entire farmer premium but later defaulted, causing massive distress," he said in Parliament, responding to Rajasthan MP Hanuman Beniwal.

In response, the Centre has revised the PMFBY to ensure farmers receive their insurance benefits even if state governments delay or skip their contributions. Going forward, the Union Government will pay its share regardless of the state's participation, ensuring uninterrupted support for farmers.

To enforce accountability, Chouhan also announced a new penalty clause: if a state fails to pay its premium share, it will incur 12% interest, which will be directly deposited into the accounts of affected farmers.

"This change is rooted in our commitment to farmers. Insurance claims will no longer be hostage to politics or state-level inefficiency," the Minister said. Under PM Modi's leadership, he added, the scheme continues to evolve in favour of farmers, settling claims within 21 days and preventing bureaucratic hurdles. The policy shift is seen as a bold move to shield farmers from administrative lapses while pressuring states to honour their financial responsibilities.





Massive Earthquake in Russia

Tsunami Alert in America, Japan...


A massive earthquake with a magnitude of 8.7 struck near Russia's Kamchatka Peninsula early this morning, triggering tsunami warnings for the United States, Japan, and several Pacific island nations. Waves rising as high as 13 feet led to evacuations in coastal areas and reports of building damage in the region.

8.7 Magnitude Quake Shakes Kamchatka

According to the US Geological Survey (USGS), the earthquake occurred at a depth of 19.3 kilometers (12 miles), with the epicenter located approximately 125 kilometers (80 miles) east-southeast of Petropavlovsk-Kamchatsky in Avacha Bay. The magnitude was initially reported as 8.0 before being upgraded to 8.7. Russian officials confirmed that villages were being evacuated, and at least one kindergarten suffered damage.

Tsunami Warnings **Across Pacific**

Following the earthquake, Russia's Emergency Minister Sergei Lebedev reported tsunami waves of 3 to 4 meters (10 to 13 feet) in parts of Kamchatka. He warned the public to stay away from the coast. The US Tsunami Warning System also issued alerts for "dangerous tsunami waves" potentially affecting the









northwestern Hawaiian Islands and the Russian Far East. Waves of more than 3 meters could reach those areas within hours.

Waves between 0.3 to 1 meter (1 to 3.3 feet) are expected to hit Chuuk, Kosrae, the Marshall Islands, Palau, and the Philippines, while less than 0.3-meter waves are predicted along the coasts of South Korea, North Korea, and Taiwan.

Japan Braces for Impact

The Japan Meteorological Agency issued a tsunami warning forecasting waves up to 1 meter (3.28 feet) for coastal regions. The alert came shortly after a second quake measuring 6.9 struck southeast of Petropavlovsk-Kamchatsky at 5:39 a.m. IST, at a depth of 10 kilometers (6.2 miles).

Region With Seismic History

The Kamchatka Peninsula is historically known for frequent seismic activity. In July this year, the region experienced five significant quakes, including a 7.4-magnitude event offshore. The most powerful quake on record in Kamchatka occurred on November 4, 1952—a 9.0 magnitude earthquake that generated 30-foot waves in Hawaii, though no fatalities were reported.

Monitoring agencies continue to assess the threat across the Pacific region, urging caution and preparation as waves continue to build.



UK PM Keir Starmer Threatens to Recognize Palestine if Gaza **Crisis Continues**

United Kingdom Prime Minister Keir Starmer has announced that the UK will recognize a Palestinian state at the upcoming United Nations General Assembly in September if Israel does not take "substantive steps" to end the humanitarian crisis in Gaza and commit to a genuine peace process. This statement, made during a special Cabinet meeting and later addressed at Downing Street, marks a major shift in Britain's long-standing position on the Israel-Palestine conflict.

Starmer cited the worsening conditions in Gaza, describing scenes of starving children and a catastrophic failure to deliver aid as the driving force behind the decision. "We see starving babies, children too weak to stand, images that will stay with us for a lifetime," he said. The Prime Minister emphasized that the peace process is "under threat," and that immediate action is needed to prevent further devastation.

However, Israel's government quickly dismissed the move, labeling it as a "reward for Hamas," with Prime Minister Benjamin Netanyahu criticizing it as "appeasement." Starmer maintained that for progress to be made, Hamas must release all remaining hostages, disarm, and accept that it will not govern Gaza.

UK Foreign Secretary David Lammy, speaking at a UN conference in New York, highlighted Britain's "special burden of responsibility" due to its historic role in the region. The announcement was met with applause and hailed as the biggest shift in the UK's approach to the Israel-Palestine issue in a generation. While some British MPs and international allies support the move, there is uncertainty over whether it will satisfy activists demanding stronger action or provoke criticism from figures like US President Donald Trump, who remains skeptical about recognizing Palestine. The coming weeks will be critical as the UK prepares to make its formal stance clear at the UN.

Trump Imposes 25% Tariff on Indian Imports

United States President Donald Trump on Tuesday issued a strong warning to India regarding potential tariffs on its imports, stating that if a trade agreement is not reached soon, Indian goods could face tariffs as high as 25 percent. Speaking to reporters, Trump emphasized the need for a fair trade deal that provides greater access for American products to the Indian mar-

When asked if India would be charged tariffs between 20 and 25 percent, Trump responded, "Yeah, I think so. India has been; they're my friends." Despite the friendly tone, his statement made it clear that the US is prepared to impose significant tariffs to protect its economic interests if negotiations stall.

Bangladesh-US Third Round of Tariff Talks Underway in Washington, DC

The third round of tariff discussions between Bangladesh and the United States officially commenced on Tuesday in Washington, DC. The talks, led by Bangladesh's Commerce Adviser Sheikh Bashiruddin and National Security Adviser Khalilur Rahman, aim to resolve ongoing trade tensions and explore opportunities for deeper cooperation.

The informal session began at 12:30 pm local time and continued until 5:30 pm, with plans to resume the discussions Wednesday morning. The Bangladesh delegation, accompanied by officials from various ministries participating virtually from Dhaka, met with the US team led by Assistant Trade Representative Brendan Lynch and officials from trade and customs departments.

This round comes amid significant developments in bilateral relations. Bangladesh recently signed a Memorandum of Understanding (MoU) to



annually purchase 700,000 tonnes of wheat from the US, a deal signed by Md Abul Hasanat Humayun Kabir, Director General of Bangladesh's Food Department, and Joseph K. Sower, Vice President of the US Wheat Association. Food Adviser Ali Imam Majumder emphasized that the MoU aims to enhance food security, nutritional quality, and supply, while also fostering trust and broader trade cooperation between the two nations.

In addition to trade talks, the US announced continued joint military exercises with Bangladesh. The US Embassy in Dhaka highlighted ongoing partnerships through three joint military exercises this summer, along with delivery of new capabilities to strengthen regional security.

The tariff discussions follow a July 9 letter from US President Donald Trump imposing a 35 percent tariff on Bangladesh, effective August 1.

Domestic stock markets gained moderately on Wednesday. Benchmark indices were volatile throughout. Mixed signals from global markets, US inflation and unemployment data, Fed results and crude oil prices are the reasons for this. dollar also contributed to this. Overall, the Nifty rose 33 points and the Sensex rose 143 points.

The BSE Sensex, which closed at 81,337 in the previous session, opened at 81,594 on Wednesday. It touched an intraday low of 81,187. It reached an intraday high of 81,618. It finally closed at 81,486 with a gain of 143 points. The NSE Nifty, which opened at 24,890, touched a low of 24,771 and a high of 24,902. It closed at 24,855, up 33 points. The Nifty Bank fell 71 points to settle at 56,150.

In the Nifty50, 23 companies gained and 27 lost. Larsen & Turbo, Sun Pharma, NTPC, Maruti, Tata Consumer Products were the top gainers. Hero Moto, Power Grid, Bajaj Auto, Eternal, Coal India were the biggest losers. Today, the Infra, IT, Defense, FMCG, Consumer Durables, and Commodities indices rose marginally. Realty, media, PSU bank, mobility, auto, tourism, healthcare indices rose.

Market breadth on NSE today was equal for buyers and sellers. Out of a total of 3057 stocks traded, 1508 gained and 1465 lost. 85 shares touched their 52-week high and 35 touched their 52-week low. The upper circuit was 94 and the lower circuit was 26.

The rupee weakened by 60 paise to settle at 87.42 against the dollar. HSBC raised its target on Nippon AMC to Rs. 690 and gave it a hold rating. India's economic liberalization began in the early 1990s under Prime Minister Narasimha Rao and Finance Minister Manmohan Singh. At that time, reforms allowed foreign investments through automatic and approved routes, laying the foundation for India's FDI journey. However, three decades later, the trajectory has lost momentum. According to the IMF's 2024 Article IV report, India's share in global FDI fell sharply from 6.5% in 2020 to 2% in 2023. UNC-TAD's 2024 report and past World Bank rankings emphasize the need for policy stability and deeper trade integration to regain investor trust.

A key area of concern is India's withdrawal from the Investor-State Dispute

India finds itself at a crossroads in its Settlement (ISDS) mechanisms. While the move is intended to preserve national sovereignty and regulatory space, it has raised alarm among investors who seek legal predictability and enforcement. The 2015 Model BIT reflects India's cautious approach, emphasizing domestic legal remedies and echoing principles akin to Latin America's Calvo Doctrine.

> India terminated over 60 BITs between 2016 and 2019, coinciding with a 32% drop in greenfield FDI projects. Scholars suggest this may have contributed to a 30% fall in overall investment inflows. Despite reforms in patent laws and business regulations, high-profile arbitration cases like Vodafone and White Industries continue to haunt investor sentiment.

Moving forward, India must strike a delicate balance—preserving its sovereign right to regulate while fostering a policy environment that reassures foreign investors. Rebuilding FDI momentum will require not just legal clarity and policy coherence, but also a transparent, geopolitically neutral approach that aligns domestic priorities with global economic aspirations.



India-China Econ Thaw Begins, Caution Persists: FM

Finance Minister Nirmala sitharaman has acknowledged early signs of improving economic engagement between India and China, but stressed the need for a "sense of caution" as the two Asian powers navigate a complex relationship. Speaking at the launch of A World in Flux: India's Economic Priorities, Sitharaman remarked that both nations are showing interest in increased interaction, including recent relaxations in visa norms.

"This could be a beginning, but we have to wait and see how far it goes," she said, noting that while access and economic collaboration might benefit both countries, the past still warrants a cautious approach.

India had imposed strict investment restrictions on China through Press Note 3 in April 2020. This move was aimed at preventing potential opportunistic takeovers of Indian firms during the economic vulnerabilities of the COVID-19 pandemic. While these curbs remain partially in place, recent developments point to a subtle but notable shift in tone.

Sitharaman emphasized that India's priority remains sustaining strong economic growth while playing a proactive role in reshaping global institutions and asserting leadership in the Global South. She also highlighted the importance of having a business-friendly and appealing FDI policy to attract long-term investments.

Commenting on the broader trend in global



trade, she observed that bilateral and regional trade agreements are increasingly taking precedence over multilateral frameworks. However, she refrained from judging whether this trend was beneficial, saying it's "too early to

Her remarks come at a time when India is working to position itself as a resilient and stable investment destination amidst shifting global supply chains and geopolitical uncertainty. As New Delhi cautiously re-engages with Beijing, the government appears to be balancing strategic interests with pragmatic economic considerations.

The evolving Indo-China dynamic, while still fragile, may offer opportunities for both economies—provided it is managed with foresight, caution, and mutual respect.

India, gold prices for 24 karat have touched new highs. The price per gram of 24K gold stands at ₹10,048, while 22K gold is retailing at ₹9,210 per gram. Meanwhile, 18K gold, commonly used in lightweight and everyday jewellery, is being sold at ₹7,536 per gram. This marks a marginal but consistent rise from the previous day's prices, with cities like Delhi, Mumbai, Chennai, Bangalore, Hyderabad, and Kolkata reflecting similar patterns.

Experts believe that the rise in gold prices is tied to several global economic concerns, including geopolitical instability, currency fluctuations, and inflationary pressures in the US and Europe. Locally, demand for gold remains strong, especially with the upcoming festive and wedding seasons likely to further push the demand curve



upward. Additionally, gold's traditional appeal as a secure asset in uncertain times is again drawing investors to add it to their portfolios.

In Delhi, the rate for 18K gold increased from ₹7,499 to ₹7,548 per gram overnight, showing the market's responsive nature to broader trends. In Chennai, 24K gold crossed ₹10,098 per gram, among the highest in the country. Such increases are causing many to reassess their buying decisions, with some rushing to purchase ahead of further hikes, while others prefer to wait for potential price corrections.

Baba Vanga's Prediction Comes True After 25 Days?

Anxiety Hits Amid Japan, Russia Tsunami

Amassive 8.8 magnitude earthquake struck off Russia's Kamchatka Peninsula on Wednesday, triggering tsunami alerts across Pacific coast and reviving an eerie prophecy from a decades-old manga. The incident, marked as the region's strongest since 1952,



caused tsunami waves measuring 3–4 metres to hit parts of Russia, while smaller waves were Earthquake—Tatsuki did it again!" reported in Japan.

What has shocked many is the resurfacing of predictions made in Watashi ga Mita Mirai (The Future I Saw), a manga by Japanese artist Ryo Tatsuki. The quake hit about 125 km southeast of Petropavlovsk-Kamchatsky at a shallow depth of 19.3 km, causing panic across Russia's Far East. In Japan, tsunami sirens rang out, coastal evacuations were ordered, and fishing boats were sent out to sea. The Fukushima nuclear plant took precautionary measures, though no damage or radiation leaks were reported.

While Japan only recorded small tsunami waves with no major destruction, authorities remain on high alert. The unsettling coincidence between fiction and reality has triggered a wave of speculation, with many drawing comparisons between Tatsuki's manga and the legendary predictions of Baba Vanga—raising questions about fate, foresight, and fear.

Engineers Create Innovative Robotic Arm to Assist People With Mobility Impairments

Tn a major step forward Ifor assistive technology, engineers at Virginia Tech have developed a robotic system designed to support individuals with impairments in completing everyday tasks. The system features a robotic arm equipped with an adaptive gripper capable of handling objects of various sizes, shapes, and textures with remarkable precision and care. This innovation is particularly effective for handling delicate

items like fruits, vegetables, and baked goods.

Traditional robotic grippers typically fall into two categories: soft grippers and rigid end-effectors. Each type has its own limitations—soft grippers struggle to lift irregular, heavy objects, while rigid grippers often fail to grasp small or fragile items effectively. To overcome these challenges, the team introduced a new hybrid approach called RISOs, which merges *Rigid end-effectors with **SO*ft adhesives.

"Our philosophy is that if you are going to provide someone with a robot to help them, it needs to mimic how a person would naturally perform the same task," explained Dylan Losey, associate professor of mechanical engineering. "This way, the robot acts more like an extension of the user's own movement, making it

more intuitive and user-friendly."

The RISOs system can switch between gripping modes—using either rigid fingers to pinch or soft, adhesive materials that attach and release objects gently. This hybrid functionality enhances the robot's ability to manipulate a broader range of objects, combining strength with sensitivity.

The team also enabled the robot to receive inputs via joystick and developed a soft, bubble-like fingertip that deflates upon contact, creating a temporary adhesive bond for secure gripping.

This breakthrough could significantly improve the quality of life for people with physical limitations, giving them greater independence in performing routine activities.

Bitchat vs WhatsApp

Offline Messaging App Sparks Buzz



Tn an era where WhatsApp is stored temporarily in device **L**deeply woven into our daily routines, a surprising new challenger has emerged—Bitchat, a messaging app that doesn't require Wi-Fi or mobile data. Launched by Twitter co-founder Jack Dorsey, Bitchat is gaining attention for its unique ability to function completely offline using only Bluetooth technology.

What sets Bitchat apart is its Bluetooth Low Energy (BLE) mesh networking system, which allows users to send messages to nearby devices within a 30-meter range. Instead of routing messages through central servers like WhatsApp or Telegram, Bitchat sends messages by splitting them into small encrypted data packets, which are then broadcast via BLE. These packets are reassembled into the original message on the recipient's phone if they're within range. If not, the data can "hop" through other Bitchat-connected devices until it reaches the destination.

India has been placed in a challenging Group **L**C for the AFC Women's Asian Cup 2026, set to take place in Australia from March 1 to 21. The draw, held at Sydney Town Hall on July 29, featured Indian midfielder Sangita Basfore as one of the draw assistants.

The Blue Tigresses will face Vietnam in their tournament opener on March 4 at the Perth Rectangular Stadium. They will then take on Asian giants Japan on March 7, followed by a match against former champions Chinese Taipei on March 10 at the Western Sydney Stadium.

Group C is one of the toughest in the tournament. Japan, ranked 7th globally, are former World Cup winners (2011) and two-time Asian Cup champions (2014, 2018). Vietnam, ranked 37th, are coming off their 2023 Women's World Cup debut and are hungry for a return to the global stage. Chinese Taipei, ranked 42nd, boast three Asian Cup titles, though their last came in 1980.

India, currently ranked 70th, are the lowest-ranked team in the group. However, head coach Crispin Chettri expressed cautious optimism, stating, "It's a tricky group, but we can compete with Vietnam and Chinese Taipei. Our preparation now has to be smart and focused."

Sangita Basfore added, "We've played all three teams before. Our dream is to reach the World Cup in Brazil, and now we're just one step away."

The top two teams from each group, along with the two best third-placed teams, will qualify for the quarterfinals. The four semifinalists will book direct tickets to the 2027 FIFA Women's World Cup, while quarterfinal losers will get another shot through playoffs.

India will be looking to overcome the heartbreak of 2022, where a COVID outbreak forced their withdrawal from the tournament.
