

Komatireddy-Uttam Tensions Return...

Fresh tension erupted in Telangana Congress today as ministers Komatireddy Venkat Reddy and Uttam Kumar Reddy clashed once again—this time over a delayed helicopter trip. The incident took place at Begumpet Airport where both ministers were scheduled to fly together to Nagarjuna Sagar to attend an official event along with joint Nalgonda in-charge minister Adluri Laxman.

As per the official plan, all three were ers never accepted quietly. supposed to leave by helicopter at 9 the airport on time. However, Uttam Kumar Reddy failed to arrive even by 10 AM. Unable to tolerate the delay, Komatireddy expressed his anger and left the airport in protest. Uttam arrived only after Komatireddy had already departed and later proceeded to Nagarjuna Sagar with Minister Adluri Laxman.

Old Rivalry Resurfaces

This public fallout has once again highlighted the long-standing rivalry between Komatireddy Venkat Reddy and Uttam Kumar Reddy. Their differences date back to the Congress regime in 2009, when Komatireddy was inducted as a minister while Uttam was left out. Later, after Komatireddy resigned during the Telangana movement, Uttam filled the vacancy something that Komatireddy's follow-

The friction intensified when Ut-Komatireddy brothers despite their es. lobbying for the position. Eventually, both leaders entered Revanth Reddy's cabinet after the Congress formed the government in Telangana. ISRO Launches NISAR Satellite Successfully

Drugs Worth ₹40 Crore Seized at Shamshabad Airport

TPN Correspondent | Hyderabad In a significant crackdown on drug trafficking, the Narcotic Control Bureau (NCB) seized 400 kg of hydroponic cannabis worth an estimated ₹40 crore at Shamshabad airport in Hyderabad. The seizure took place during an intensified round of checks being conducted across Telangana as part of the government's campaign against drug abuse and trafficking.

The consignment was discovered with a woman passenger who had arrived from Bangkok. Officials

suspect the hydroponic cannabis, known for its high potency and sophisticated cultivation methods, was intended for distribution within India. The woman has been detained for questioning, and investigations are underway to uncover the network behind the operation. Authorities have ramped up surveillance and inspections at key transit hubs including bus stations, railway stations, and highways, following a directive from the state government.

₹140 Cr Mudra Scam , Father-Son Held

The Telangana Crime Investigation Department (CID) has arrested Tippaneni Ramadasappa Naidu, chairman of Mudra Agriculture Skill Development Multi-State Cooperative Society Limited, and his son Sai Kiran, for allegedly masterminding a ₹140 crore fraud by falsely projecting their cooperative as linked to the Pradhan Mantri Mudra Yojana (PMMY). Established in 2017, the society misused the PMMY brand to pose as a government-supported institution. Investigations revealed that through widespread regional newspaper advertisements, the duo lured thousands of people—mainly farmers, unemployed youth, and daily wage workers—with false promises of high returns and permanent government

As part of the scam, the society issued advertisements for 2,000 "marketing supervisor" posts, collected original educational certificates, and charged substantial sums from as-

pirants under the pretense of share capital and investment bonds. Victims were misled into believing that the cooperative would become a bank within two years.

The fraudulent society expanded aggressively, opening around 330 branches across Telangana and Andhra Pradesh. It employed nearly 1,600 individuals tasked with collecting deposits. CID officials stated that employees were pressured to meet high targets, faced salary deductions for shortfalls, and were denied dues or coerced if they attempted to resign. The accused reportedly used the funds collected to acquire industrial lands in Anantapur district of Andhra Pradesh and real estate in the Keesara region of Telangana. The fraud came to light following multiple complaints at various police stations, prompting a CID investigation.

The father-son duo have been remanded to judicial custody. Further investigation is underway to trace remaining assets and identify all victims involved in the scam.

NIMS in crisis

From a medical beacon to a broken system

Hyderabad: Once a beacon of hope for the poor and an institution that upheld the highest standards in public healthcare, Nizam's Institute of Medical Sciences (NIMS) is now reeling under a growing cloud of mismanagement, corruption, and internal strife. Established during the NTR regime and built up with vision and discipline under the guidance of stalwarts like Dr. Kakarla Subbarao, NIMS earned its name as the 'medical temple' for the poor. But today, that very temple is slowly crumbling.

What was once an institution synonymous with selfless service is now being driven into the ground by greed and administrative apathy. Sources allege that the current NIMS leadership is neck-deep in corruption, driven by personal gain and political shielding.

Rules are being bent and policies rewritten — not to improve patient care, but to favor a chosen few. The very systems built to protect the hospital's integrity are being compromised, and officials who should safeguard it are instead acting as enablers to this rot. Doctors whisper of backdoor dealings, where beds in the emergency ward are being 'sold' for ₹10,000 to ₹20,000, a shocking scenario where brokers thrive while patients suffer. Internal appointments have turned into a regional bias game, sidelining experienced, long-serving professionals to make room for handpicked loyalists. Key administrative and promotion rules are being rewritten to suit the needs of the top brass, rather than the institution.

These developments have triggered an exodus. Some of the brightest doc-

tors, who once turned down offers from corporate hospitals to serve the poor at NIMS, have walked away in dismay. Departments like cardiology, neurology, nephrology — once the pride of NIMS — are now witnessing a vacuum of leadership and expertise. Morale is at an all-time low, and the sense of mission that once defined the NIMS workforce has all but vanished. Staff and insiders allege that the socalled "chief" of NIMS, under whose leadership the institution has begun to disintegrate, continues to protect wrongdoers and antagonize genuine voices. Instead of mediating and resolving internal conflicts among senior officers, he is allegedly encouraging divisions to consolidate power. The fallout is now visible to all - a hospital plagued by mistrust, misallocation, and loss of public confidence.

All this while NIMS allegedly ignores major defaulters who owe rent or financial dues to the hospital, including medical stores on campus generating lakhs in profit. even legal cases registered against the NIMS head, there appears to be no political or administrative will to step in. Those who once held the institute's values close to heart now question why a corrupt official is being sheltered — and why the dignity of a sacred public health institution is being allowed to erode without resistance. As public trust diminishes and medical services collapse under the weight of systemic decay, one question looms large: Will NIMS ever return to its glo-

ry — or has the rot gone too deep?

SC Verdict Today on Disqualification of 10 MLAs

BRS seeks disqualification of MLAs who joined Congress post-polls

MLAs who were elected on the Bharat Rashtra Samithi (BRS) ticket but defected to the ruling Congress party after the recent Telangana Assembly elections will be determined today. The Supreme Court is set to pronounce its final verdict on the disqualification petition filed by the BRS leadership.

Following the electoral setback of BRS in the last elections, ten of its MLAs shifted their allegiance to the Congress party.

The BRS, led by Working President K. T. Rama Rao (KTR), The political future of ten took legal action seeking their disqualification under anti-defection laws. Despite filing disqualification petitions before the Assembly Speaker and then in the High Court, the issue remained unresolved, prompting the BRS to escalate the matter to the Supreme

> KTR, along with MLAs Padi Kaushik Reddy and KP Vivekanand, approached the Supreme Court accusing the Speaker of deliberately delaying a decision on



the disqualification. The case has undergone multiple hearings, and on April 3, the bench comprising Justice B. R. Gavai

and Justice Vinod Chandran reserved its verdict, which will be announced today. During the hearings, senior hvi represented the Telangana Speaker's Secretary. He argued that there is no legal precedent mandating a specific time frame for the Speaker to decide on such matters. However, Justice Gavai questioned what could be considered a "reasonable time" and criticized the approach of some lawyers in handling the case after reaching the Supreme Court.

Meanwhile, advocate Aryama Sundaram, appearing for petitioner MLA Kaushik Reddy, pointed out a controversial statement made by Chief Minister Revanth Reddy in the As-

sembly. According to him, the CM had declared there would be "no by-elections" and implied that he was speaking on behalf of the Speaker. He also alleged that Revanth Reddy claimed protection from courts in this matter. These remarks irked the bench, with Justice Gavai questioning the Chief Minister's restraint and warning that such statements could amount to contempt of court. He emphasized that all branches of governance must maintain mutual respect and decorum. As political tensions simmer, all eyes are on the Supreme Court, which is expected to deliver a decisive ruling that could have significant implications for the Telangana Assembly and party dynamics.

CM Reviews Energy Sector

Chief Minister A. Revanth Reddy held a key review meeting on Telangana's energy sector at his residence in Jubilee Hills. The session focused on strengthening the state's power generation and distribution systems, improving coordination among departments, and ensuring uninterrupted supply amid growing seasonal demand.

Deputy Chief Minister Bhatti Vikramarka, Energy Principal Secretary Naveen Mittal, CM's Special Secretary Ajith Reddy, TG GENCO CMD Harish, TG SPDCL CMD Musharraf, TG NPDCL CMD Varun Reddy, Singareni CMD Balaram, and TGREDCO VC & MD Anila attended the meeting. Officials discussed issues like electricity demand, power plant performance, coal supply from Singareni, and renewable energy proj-

CM Revanth reportedly stressed the need for reliable power for agriculture and rural areas and called for better coordination between departments. He also reviewed the financial health of power utilities and ongoing energy initiatives.



Ponnam Slams BJP Over Fertilizer Issue

Minister Ponnam Prabhakar strongly criticized BJP State President Ramachandra Rao for making "ignorant and misleading" remarks about the ongoing fertilizer shortage in Telangana. He questioned how Rao could head the state unit without understanding how fertilizer distribution is handled.

Ponnam clarified that fertilizer supply is regulated by the Central Government, not the states, despite production happening locally. "The Centre is responsible for allocating stocks as per state requirements," he said.

He noted that Chief Minister Revanth Reddy and Agriculture Min-Tummala Nageswara Rao have repeatedly appealed to the Centre for sufficient fertilizer, but the supply has fallen short, causing hardship to farmers.



Between April and July 2025, Telangana planned for 6.60 lakh metric tons (LMT) of urea but received only 4.35 LMT—a deficit of 2.25 LMT. Monthly breakdowns show consistent shortfalls ranging from 20% to 45%. Ponnam accused Ramachandra Rao of spreading false information by claiming that 12.02 LMT of urea had been supplied. "These are fabricated numbers aimed at misleading the public," he said.

He added that CM Revanth Reddy met the Union Chemicals and Fertilizers Minister on July 8 to raise the issue. Minister Tummala has also made multiple representations.

With daily urea sales between 10,000 and 13,000 metric tons, the shortage is severely affecting farming. Ponnam urged BJP leaders to stop political blame games and instead push the Centre to resolve the crisis. He assured that the state government is taking all steps to ensure sufficient supply for farmers.

He said that shortly after assuming the role of state president, he had written to Chief Minister Revanth Reddy, urging immediate action. Rao also highlighted the poor condition of court infrastructure across the state and reminded the gathering that he had earlier raised the issue during his tenure as an MLC. He questioned the status of the ₹100 crore welfare fund for advocates announced by the previous BRS government and called for transparency regarding its current use.

He noted that states like Rajasthan and Madhya Pradesh have already enacted the Advocate Protection Act and urged Telangana to follow suit. Rao also spoke about the role of advocates in India's freedom struggle and the Telangana movement, encouraging more lawyers to take up public service and enter politics. He said that while real estate businessmen are entering politics in large numbers, there is a greater need for individuals with public spirit and dedication. Concluding his remarks, Rao encouraged young lawyers to take their profession seriously and urged senior advocates to mentor junior lawyers through monthly lectures. He called advocates "social engineers" and emphasized that they must lead by example in society.

Harish Slams Govt Over Gurukul Crisis

Former Minister Harish Rao has strongly criticized the Congress government over its handling of the Gurukul education system, following a protest by students in Alampur, Jogulamba Gadwal district. The students marched to highlight poor conditions in their hostels, including lack of proper food and drinking water.

dents, who should be studying in classrooms, were forced to take to the streets

just to get basic facilities. He accused the Revanth Reddy-led government of ignoring the real issues faced by students while focusing on political padayatras ahead of local body

He also questioned the silence of the government on serious incidents such as food poisoning in Gurukuls and the lack of action even after appeals to the National Human Rights Commission. Rao also appealed to the Congress party to shift its focus from political gains to student welfare, saying the future of children should not be compromised due to poor governance.

Rs. 22 Lakh Ganja Seized in Twin Raids

In a series of successful anti-drug operations, Telangana Excise Enforcement teams seized over 35 kilograms of cannabis across Hyderabad and surrounding areas, valued at more than ₹22 lakh. The major haul was discovered at Secunderabad railway station, while two additional raids in Nampally and Ghatkesar led to further arrests and drug

Acting on specific intelligence, Excise Enforcement CI Chandrashekhar Goud, along

with Railway Protection Force (RPF) officials, conducted a surprise inspection at the Secunderabad railway station. Based on reports of cannabis being smuggled into Hyderabad via a Bhubaneswar train from Odisha, the team inspected multiple platforms. While checking platform 10, they discovered three suspicious, unattended bags tucked away in a corner.

Upon opening the bags, 19 brown packets of cannabis were found, weighing a total of 32.8 kg. The market value of the seized narcotics is estimated at ₹20 lakh. RPF Inspector B. Saraswathi, along with Sub-Inspectors S. Karunmurthy, V. Reddy, and V. Bhupal, participated in the operation. Director of Enforcement Shahnawaz Qasim and Deputy Commissioner Anil Kumar Reddy commended the team's swift action.

In a separate operation in Nampally, the Special Task Force (STF) raided Heal Fort Adarsha Colony and seized 1.6 kg of cannabis. Abhishek Singh (28) was arrested on the spot, and cases were registered against two others — Adhar Singh and Sahel. The seized narcotics and the accused were handed over to the Nampally Excise Station for further investigation.

Meanwhile, STF personnel under CI Venkateswarlu seized 1.1 kg of cannabis in Ghatkesar. Three accused — Kothuri Revanth (21) from Jagtial, Prashanth (21) from Namboina (Warangal), and Mote Santosh (21) were arrested and handed over to the Ghatkesar Excise Station.

Excise officials have reiterated their commitment to cracking down on drug smuggling and urged the public to report any suspicious activity. Further investigations are underway in all three cases.

Actor Prakash Raj **Faces ED Questions**

Popular actor Prakash Raj was questioned by the Enforcement Directorate (ED) in connection with the ongoing investigation into illegal betting apps. The actor appeared at the ED office in Basheerbagh, Hyderabad, and was interrogated for nearly five hours.

Sources said the interrogation focused primarily on Raj's association with the promotion of the betting platform 'Jungle Rummy'. ED officials questioned him about the



nature of his involvement, the financial transactions involved, and whether any payments were received in exchange for promotional activities.

In his statement, Prakash Raj reportedly clarified that he had endorsed Jungle Rummy in 2016, but had no financial dealings with the app or its operators. He claimed that no money was received through the platform, and no transactions took place during or after the endorsement. ED officials also exam-

ined his financial records from the past five years to trace any possible links with betting app transactions, particularly those connected to firms operating out of Dubai. The agency suspects that funds from celebrity promotions may have been routed abroad.

Raj, speaking briefly to the media after the questioning, advised the public not to fall victim to online betting and reiterated his stand against promoting such platforms in the future. He added that his contract with Jungle Rummy ended years ago and was never renewed.

Prakash Raj is among several celebrities being investigated in the case, as authorities aim to uncover the financial trail behind the growing betting app network.



GHMC Plans New App & Website for Seamless Services

The Greater Hyderabad Municipal Corporation (GHMC) is developing a comprehensive new mobile app and website to offer all civic services in one place, making it easier for citizens to access services from the comfort of their homes. GHMC Commissioner Ronald Rose has directed the Centre for Good Governance (CGG) to develop the new software, aiming to correct the existing flaws and expand digital accessibility.

The upgraded platform is expected to bring all GHMC-related services into a centralized, user-friendly interface that will significantly improve convenience for Hyderabad residents.

No Compromise on Water Quality, Says **District Collector**

26 Gates Opened at Nagarjunasagar

In response to the rising inflows from upstream reservoirs and catchment areas, the irrigation authorities at Nagarjunasagar Reservoir have intensified water discharge by lifting 26 crest gates on Wednesday. The decision was taken as part of ongoing flood regulation efforts amid consistent monsoon inflows. As per official data, the reservoir received an inflow of 1,68,988 cusecs, while the outflow has surged to 3,13,016 cusecs, released downstream into the Krishna River. This measure is aimed at preventing the reservoir from reaching its maximum storage limit and ensuring the structural safety of the dam.



of Nagarjunasagar is 590 feet, while the current level stands at 586.5 feet, indicating a swift rise due to heavy upstream contributions. Out of the total storage capacity of 312.04 TMC, the reservoir currently holds 302.91 TMC, nearing its full potential.

Engineers at the site mentioned that the discharge would continue over the next few days, depending on the inflows. With upstream reservoirs like Srisailam and Jurala also witnessing high inflows, water management is being executed in real-time to avoid overflow risks and ensure regulated releases.

The monsoon season, particularly over the past week, has significantly boosted the river systems across Telangana and Andhra Pradesh. The authorities continue to keep a close watch on weather updates and river basin conditions to make timely deci-

Immoral Activities Surface in Temple Town Lodges

Known as the "Ayodhya of the South," Bhadrachalam is now facing serious concerns over immoral activities taking place in private lodges near the temple area. Allegations have surfaced that couples posing as devotees are engaging in

inappropriate behavior, while some lodge staff are reportedly exploiting the situation for financial gain.

In a recent case, a young man from the town visited a private lodge near the temple along with his girlfriend. During their stay, unknown individuals secretly recorded intimate moments of the couple. The counts used for extortion. same group later contacted the man via Instagram, threatening to leak the video unless he paid them money.

According to the victim, the blackmailers collected around ₹60,000 in three installments. They used an Instagram account and internet calls to avoid being traced. Eventually, when the demands became unbearable, the man approached the Bhadrachalam town police and lodged a formal complaint.

Police have registered a case and launched an investigation. However, they mentioned that identifying the culprits may take time due to the anonymous nature of the online acLocal residents and devotees are alarmed by the developments and have urged the authorities to take swift action. They are demanding strict surveillance, regular police checks on lodges, and

restoration of the sanctity and spiritual significance of the temple town.

Concerns are growing over the apparent negligence in monitoring private lodges and the lack of adequate police presence in the area. Citizens have called for immediate attention to the issue to prevent further misuse of the holy place and ensure that Bhadrachalam remains a peaceful and sacred pilgrimage destination.

1 Cr Women to Become **Millionaires: Ponguleti**

Telangana Revenue, Housing and Information Public Relations Minister Ponguleti Srinivasa Reddy stated that the state government is moving forward with the goal of making one crore women millionaires. Speaking at a Vana Mahotsavam event held at Nelakondapalli Government Degree College, the minister emphasized that several welfare schemes are being implemented in the name of women to improve their economic conditions. Along with planting saplings, the minister also distributed newly sanctioned ration cards to eligible beneficiaries at the local market yard.

Minister Ponguleti said that the Praja government is focused on supporting women and poor families through various initiatives such as free RTC bus travel, the Indiramma Housing scheme, and zero-interest loans to women's self-help groups. He recalled that during the YSR government, there was a promise to make one lakh women millionaires, and now the goal has expanded to one crore. Last financial year, Rs. 25,000 crore was disbursed to 65 lakh women's groups, and in the last four months alone, Rs. 855 crore has been released. He added that the government is involving women in running solar power plants, petrol stations, rice mills, and even in managing government schools through Amma Adarsh Committees.

The minister criticized the previous governments for failing to provide ration cards to many deserving families. He assured that the current government is continuing the process of issuing cards and ensuring that rice and other benefits are regularly delivered to eligible families. He also mentioned that from Ugadi, ration for three months is being provided at once. Additionally, the state government has waived Rs. 21,000 crore in crop loans within one year and is giving a Rs. 500 bonus per quintal to fine rice farmers. Funds for Indiramma houses will be released every Monday, and houses will be allotted in phases to eligible beneficiaries.

District Collector Anudeep Durisetty shared that 19,690 new ration cards are being distributed in Khammam district, including 4,225 in Paleru constituency. Yet, paradoxically, these torchbearers of truth are often among the most underpaid and unrewarded intellectual workers. Their work demands high cognitive effort, moral courage, and continuous learning — all while facing job insecurity, physical risk, and limited recognition.


Intellectual Labor Without Respect

Journalism is not just about reporting facts; it involves investigation, contextual analysis, critical thinking, and articulation — all hallmarks of intellectual labor. Yet, unlike academics, scientists, or even popular influencers, journalists are seldom accorded the same intellectual stature. Their mental rigor often gets dismissed as "just writing stories."

Example: A senior reporter working tirelessly to uncover political corruption may be paid less than a PR executive writing promotional material for a the 'Fourth Pillar' brand.

Young GM Divya Deshmukh **Makes Chess History**

On July 28, 2025, in Batumi, Georgia, 19-year-old Divya Deshmukh made history by becoming the first Indian woman to win the FIDE Women's World Cup. In a thrilling final against legendary compatriot Grandmaster Humpy Koneru, Divya's victory marked not just a personal milestone, but a defining moment in Indian chess.

The 2025 Women's World Cup featured 107 top players from 46 nations. Divya's path to the crown was anything but easy. She overcame World No. 6 Zhu Jiner, former World Champion Tan Zhongyi, and veteran Harika Dronavalli. The final clash with Humpy, one of India's most decorated players, was a dramatic showdown of nerves and skill. After the classical and first rapid game ended in draws, Divya sealed her win in the second rapid tiebreak with composure and precision.

This win catapulted Divya into the global spotlight and granted her the Grandmaster title—the highest in chess—automatically. Uniquely, she achieved it without previously earning a single GM norm, a testament to the magnitude of her triumph. She also secured a coveted place in the 2026 Candidates Tournament, moving one step closer to challenging for the Women's World Championship title. Divya is now only the third woman to win this title, following Alexandra Kosteniuk and Aleksandra Graciano. Her win is historic not just for its rarity but because it symbolizes India's rising dominance in women's chess. For the first time, four Indian women reached the quarterfinals of the event—Divya, Humpy, Harika, and Vaishali—signaling a generational shift in the sport.

India-China Thaw Amid U.S. Strain: Tactical Pivot or Strategic Gamble?



Recent developments suggest a surprising softening in India-China relations, despite ongoing tensions. This thaw appears paradoxical, given China's continued support for Pakistan during Operation Sindoor, the initiation of the Yarlung Zangbo dam project (seen as a threat by India), and rising economic coercion through export curbs on critical inputs like rare earths, semiconductors, and agri-tech. Yet, diplomatic signals indicate a willingness to engage: External Affairs Minister S. Jaishankar's visit to China, India's openness to revive the Russia-India-China (RIC) mechanism, resumed tourism visas and flights, and discussions over a possible 24% Chinese stake in Indian firms.

This convergence comes amid growing unease in India-U.S. relations, marked by trade friction, defense procurement issues, and disagreements over Russian sanctions. Delhi, once optimistic about a trade pact, now finds Washington's demands such as wider market access and the removal of non-tariff barriers—increasingly intrusive. President Trump's blunt references to leverage-based diplomacy, particularly around the May 10 ceasefire, and U.S. reluctance on timely defense supplies like GE jet engines, have contributed to Indian skepticism.

India's multi-alignment strategy has long used

tactical shifts in its China posture to extract better terms from the U.S., but this time, the context is more precarious. China is applying multifaceted pressure: militarily, via Pakistan and the LAC; ecologically, through the Zangbo dam; and economically, with coercive trade tactics. India is struggling to respond to these new levers effectively.

China's economic arm-twisting—restricting exports vital to sectors like automotive and defense—is particularly alarming. Companies like Bajaj Auto have already warned of production halts. If China demands dual-use certification, the ripple effects could reach defense manufacturing. Yet, India may feel compelled to engage economically with China due to declining FDI, global supply chain ambitions, and hopes of ending coercive trade practices.

The danger lies in India's tactical overtures becoming strategic vulnerabilities. Increased Chinese participation in sensitive sectors could enable Beijing to exert long-term economic leverage. Past experience shows that temporary goodwill may not result in durable cooperation. As geopolitical volatility grows, India must carefully balance short-term flexibility with long-term resilience lest tactical engagement today turns into strategic dependence tomorrow.

Iran's Strategic Path: A Clarification on Sovereignty, Sanctions, and Misconceptions



In response to the recent article "Snapback to Reality: On Iran's 45-Year Slog to Nowhere," Iran's Ambassador to India, Dr. Iraj Elahi, offers a pointed rebuttal, emphasizing that such narratives distort Iran's historical and strategic reality. While the original piece frames Iran as a nation isolated due to its policies, Ambassador Elahi argues that the country's path is rooted not in defiance, but in dignity and sovereignty.

He begins by reminding readers that the 1979 Islamic Revolution was not born out of blind hostility toward the West. Rather, it was a reaction to decades of foreign interference, coups, and exploitation. Iran's resistance, he asserts, is not about hatred but about refusing subjugation. Its slogans reflect historical memory and the pursuit of justice—not a desire for endless enmity with nations like the U.S. or Israel.

On the nuclear issue, the ambassador defends Iran's record under the Joint Comprehensive Plan of Action (JCPOA), saying that Iran upheld its commitments, as verified by the International Atomic Energy Agency. It was the U.S., under the Trump administration, that unilaterally withdrew from the agreement and re-imposed sanctions. Iran's subsequent actions were lawful and within the deal's framework, contrary to the claim that Iran escalated tensions unprovoked.

Addressing the idea that Iran faces a binary choice between "capitulation or collapse," Ambassador Elahi calls for a more nuanced understanding. He stresses that Iran is open to fair and respectful negotiations—but will not yield to threats disguised as diplomacy. He urges Western powers to recognize their role in fostering mistrust and to end collective punishment through sanctions.

On regional matters, the ambassador defends Iran's alliances in Lebanon, Palestine, Iraq, and Yemen, framing them as support for resistance movements rather than imperial ambition. He points out that Iran has consistently called for regional dialogue and a nuclear-free Middle East—calls that have been ignored while Israel's undeclared arsenal remains untouched.

Concluding his remarks, Ambassador Elahi calls for mutual respect, stating that Iran does not seek conflict but refuses to trade its sovereignty for survival. "Iran will remain what it has always been," he writes—"independent, proud, and unafraid to choose its own path."





"Don't Control Me": Jaya Bachchan Sparks **Controversy Over 'Operation Sindoor' Remarks**

Samajwadi Party MP and veteran actor Jaya Bachchan stirred a heated debate in the Rajya Sabha today during a discussion on Operation Sindoor, questioning both the intelligence failure behind the Pahalgam terror attack and the naming of the operation itself.

"Priyanka, don't control me," Ms Bachchan snapped, visibly irked. Chaturvedi, seated beside her, laughed off the reaction, but the moment quickly went viral.

Indus Water Treaty Suspended: Jaishankar Slams Congress Over Historic "Mistakes"

External Affairs Minister S. Jaishankar announced in the Rajva Sabha on Wednes- He particularly targeted former Prime Minday that the Indus Water Treaty (IWT) with ister Jawaharlal Nehru, quoting his state-cooperation cannot coexist with terrorism.

Pakistan will be held in abeyance until Is- ment in Parliament from November 30, lamabad irreversibly ends its support for terrorism. The decision follows the deadly terror attack in Pahalgam in April, which claimed the lives of 26 people.

During his address, Jaishankar took a sharp dig at the Congress party, accusing it of being "uncomfortable with history" and unwilling to confront past errors. He cited how the treaty, signed in 1960, granted Pakistan access to major rivers originating in India, calling it a "unique agreement" in global diplomatic history.

"I cannot think of any other agreement where a country allows its major rivers to flow into another without securing its own rights," Jaishankar said, referring to the provisions of the IWT.

1960, where Nehru allegedly prioritized the interests of Pakistani Punjab over Indian states. "There was no mention of the farmers of Kashmir, Punjab, Rajasthan, or Gujarat," Jaishankar said, questioning the intent and foresight of the treaty's original architects.

The minister credited Prime Minister Narendra Modi with reversing historical oversights, citing the abrogation of Article 370 and now the suspension of the Indus Water Treaty as evidence of decisive action. "We were told for 60 years that these mistakes could not be corrected. PM Modi has proven that they can," he stated.

Jaishankar concluded with a firm warning: "Blood and water will not flow together." The suspension of the IWT, he said, is a strong diplomatic signal that peace and

Priyanka Gandhi Leads Protest Over Nuns' Arrest; **Shashi Tharoor's Absence Raises Eyebrows**

Congress leader Priyanka Gandhi Vadra led a high-profile protest in Parliament on Tuesday, condemning the arrest of two Kerala-based Catholic nuns in Chhattisgarh, who were accused of human trafficking and forced religious conversion. However, the absence of senior Congress MP Shashi Tharoor, who participated in a similar protest just a day earlier, raised fresh questions about his growing distance from the party leadership.

Ms Gandhi Vadra, joined by other Kerala Congress MPs, denounced the arrests as a targeted attack on minorities. "These nuns were accused of things they were not in-

volved in. They were manhandled and taken away. We are protesting against such assaults on minority communities," she told reporters.

Tharoor, who had vocally supported the cause on Monday with a placard reading "India for all, proud to be one," was notably missing on Tuesday. His absence is being viewed in the context of recent tensions between him and the Congress high command, especially following his remarks after the Pahalgam terror attack and the government's Operation Sindoor. His refusal to speak in Parliament during the Operation Sindoor debate — allegedly because he would not "contradict himself for party messaging" — only deepened the rift.

The controversy stems from the arrest of two nuns at Durg railway station. Allegations were made by Bajrang Dal members that the nuns were trafficking three minor tribal girls. The police booked them under the Bharatiya Nyay Sanhita and the Chhattisgarh Freedom of Religion Act.

The incident has triggered nationwide backlash. Rahul Gandhi demanded their immediate release, saying religious freedom is a constitutional right. Interestingly, BJP Kerala leaders also defended the nuns, with party president Rajeev Chandrasekhar promising to assist in their release. However, Chhattisgarh CM Vishnu Deo Sai stood by the arrests, accusing the opposition of politicising the issue.



"CJI's Office Not a Post Office": **Supreme Court Questions Judge** in Cash Recovery Case

In a high-profile courtroom exchange, the Supreme Court strongly rebuked Justice Yashwant Varma, who is under scrutiny after large sums of cash were found at his Delhi residence during a fire incident. Justice Varma is challenging the findings of a three-member in-house committee that recommended his removal.

The bench, led by Justices Dipankar Datta and Augustine George Masih, emphasized that the Chief Justice of India's office "is not a post office" but carries a national duty as the judiciary's leader. The remarks came in response to Senior Advocate Kapil Sibal, who argued that the committee overstepped its constitutional role.

Sibal insisted that under Article 124 of the Constitution and the Judges (Inquiry) Act, the committee cannot recommend a judge's removal—only advise the Chief Justice. He added that allowing this process would create an "extra-constitutional mechanism."

Justice Datta countered this, asserting that the CJI has a responsibility to forward misconduct reports to the President and Prime Minister when warranted. He added that the Chief Justice's office must act when credible information is received, not merely pass along complaints.

Sibal further alleged that the findings were politically influenced and that Justice Varma was not given a fair opportunity to respond during the inquiry. The bench, however, maintained that the panel's report is preliminary and does not bind future parliamentary action.

Critically, the bench also questioned Justice Varma's timing in approaching the court, stating, "You were waiting for a favourable outcome, and when it turned against you, you came here. That does not inspire confidence."

The court reserved its judgment but made clear that the issue touches on the integrity of the judiciary and constitutional responsibility at the highest levels.



Some States Failed: Minister Shivraj **Singh Announces Changes To Crop Insurance Scheme**

Union Agriculture Minister Shivraj Singh Chouhan today announced major reforms to the Pradhan Mantri Fasal Bima Yojana (PMFBY), aimed at protecting farmers from losing crop insurance benefits due to state government defaults.

Highlighting issues faced under the previous Jagan Reddy government in Andhra Pradesh, Chouhan revealed that the state failed to pay its share of the insurance premium for three consecutive years, leaving many farmers without compensation. "Some states, like Andhra Pradesh, committed to covering the entire farmer premium but later defaulted, causing massive distress," he said in Parliament, responding to Rajasthan MP Hanuman Beniwal.

In response, the Centre has revised the PMFBY to ensure farmers receive their insurance benefits even if state governments delay or skip their contributions. Going forward, the Union Government will pay its share regardless of the state's participation, ensuring uninterrupted support for farmers.

To enforce accountability, Chouhan also announced a new penalty clause: if a state fails to pay its premium share, it will incur 12% interest, which will be directly deposited into the accounts of affected farmers.

"This change is rooted in our commitment to farmers. Insurance claims will no longer be hostage to politics or state-level inefficiency," the Minister said. Under PM Modi's leadership, he added, the scheme continues to evolve in favour of farmers, settling claims within 21 days and preventing bureaucratic hurdles. The policy shift is seen as a bold move to shield farmers from administrative lapses while pressuring states to honour their financial responsibilities.





Massive Earthquake in Russia

Tsunami Alert in America, Japan...


A massive earthquake with a magnitude of 8.7 struck near Russia's Kamchatka Peninsula early this morning, triggering tsunami warnings for the United States, Japan, and several Pacific island nations. Waves rising as high as 13 feet led to evacuations in coastal areas and reports of building damage in the region.

8.7 Magnitude Quake Shakes Kamchatka

According to the US Geological Survey (USGS), the earthquake occurred at a depth of 19.3 kilometers (12 miles), with the epicenter located approximately 125 kilometers (80 miles) east-southeast of Petropavlovsk-Kamchatsky in Avacha Bay. The magnitude was initially reported as 8.0 before being upgraded to 8.7. Russian officials confirmed that villages were being evacuated, and at least one kindergarten suffered damage.

Tsunami Warnings **Across Pacific**

Following the earthquake, Russia's Emergency Minister Sergei Lebedev reported tsunami waves of 3 to 4 meters (10 to 13 feet) in parts of Kamchatka. He warned the public to stay away from the coast. The US Tsunami Warning System also issued alerts for "dangerous tsunami waves" potentially affecting the









northwestern Hawaiian Islands and the Russian Far East. Waves of more than 3 meters could reach those areas within hours.

Waves between 0.3 to 1 meter (1 to 3.3 feet) are expected to hit Chuuk, Kosrae, the Marshall Islands, Palau, and the Philippines, while less than 0.3-meter waves are predicted along the coasts of South Korea, North Korea, and Taiwan.

Japan Braces for Impact

The Japan Meteorological Agency issued a tsunami warning forecasting waves up to 1 meter (3.28 feet) for coastal regions. The alert came shortly after a second quake measuring 6.9 struck southeast of Petropavlovsk-Kamchatsky at 5:39 a.m. IST, at a depth of 10 kilometers (6.2 miles).

Region With Seismic History

The Kamchatka Peninsula is historically known for frequent seismic activity. In July this year, the region experienced five significant quakes, including a 7.4-magnitude event offshore. The most powerful quake on record in Kamchatka occurred on November 4, 1952—a 9.0 magnitude earthquake that generated 30-foot waves in Hawaii, though no fatalities were reported.

Monitoring agencies continue to assess the threat across the Pacific region, urging caution and preparation as waves continue to build.



UK PM Keir Starmer Threatens to Recognize Palestine if Gaza **Crisis Continues**

United Kingdom Prime Minister Keir Starmer has announced that the UK will recognize a Palestinian state at the upcoming United Nations General Assembly in September if Israel does not take "substantive steps" to end the humanitarian crisis in Gaza and commit to a genuine peace process. This statement, made during a special Cabinet meeting and later addressed at Downing Street, marks a major shift in Britain's long-standing position on the Israel-Palestine conflict.

Starmer cited the worsening conditions in Gaza, describing scenes of starving children and a catastrophic failure to deliver aid as the driving force behind the decision. "We see starving babies, children too weak to stand, images that will stay with us for a lifetime," he said. The Prime Minister emphasized that the peace process is "under threat," and that immediate action is needed to prevent further devastation.

However, Israel's government quickly dismissed the move, labeling it as a "reward for Hamas," with Prime Minister Benjamin Netanyahu criticizing it as "appeasement." Starmer maintained that for progress to be made, Hamas must release all remaining hostages, disarm, and accept that it will not govern Gaza.

UK Foreign Secretary David Lammy, speaking at a UN conference in New York, highlighted Britain's "special burden of responsibility" due to its historic role in the region. The announcement was met with applause and hailed as the biggest shift in the UK's approach to the Israel-Palestine issue in a generation. While some British MPs and international allies support the move, there is uncertainty over whether it will satisfy activists demanding stronger action or provoke criticism from figures like US President Donald Trump, who remains skeptical about recognizing Palestine. The coming weeks will be critical as the UK prepares to make its formal stance clear at the UN.

Trump Imposes 25% Tariff on Indian Imports

United States President Donald Trump on Tuesday issued a strong warning to India regarding potential tariffs on its imports, stating that if a trade agreement is not reached soon, Indian goods could face tariffs as high as 25 percent. Speaking to reporters, Trump emphasized the need for a fair trade deal that provides greater access for American products to the Indian mar-

When asked if India would be charged tariffs between 20 and 25 percent, Trump responded, "Yeah, I think so. India has been; they're my friends." Despite the friendly tone, his statement made it clear that the US is prepared to impose significant tariffs to protect its economic interests if negotiations stall.

Bangladesh-US Third Round of Tariff Talks Underway in Washington, DC

The third round of tariff discussions between Bangladesh and the United States officially commenced on Tuesday in Washington, DC. The talks, led by Bangladesh's Commerce Adviser Sheikh Bashiruddin and National Security Adviser Khalilur Rahman, aim to resolve ongoing trade tensions and explore opportunities for deeper cooperation.

The informal session began at 12:30 pm local time and continued until 5:30 pm, with plans to resume the discussions Wednesday morning. The Bangladesh delegation, accompanied by officials from various ministries participating virtually from Dhaka, met with the US team led by Assistant Trade Representative Brendan Lynch and officials from trade and customs departments.

This round comes amid significant developments in bilateral relations. Bangladesh recently signed a Memorandum of Understanding (MoU) to



annually purchase 700,000 tonnes of wheat from the US, a deal signed by Md Abul Hasanat Humayun Kabir, Director General of Bangladesh's Food Department, and Joseph K. Sower, Vice President of the US Wheat Association. Food Adviser Ali Imam Majumder emphasized that the MoU aims to enhance food security, nutritional quality, and supply, while also fostering trust and broader trade cooperation between the two nations.

In addition to trade talks, the US announced continued joint military exercises with Bangladesh. The US Embassy in Dhaka highlighted ongoing partnerships through three joint military exercises this summer, along with delivery of new capabilities to strengthen regional security.

The tariff discussions follow a July 9 letter from US President Donald Trump imposing a 35 percent tariff on Bangladesh, effective August 1.

Indian Markets See India's FDI Dilemma **Moderate Gains**



Domestic stock markets gained moderately on Wednesday. Benchmark indices were volatile throughout. Mixed signals from global markets, US inflation and unemployment data, Fed results and crude oil prices are the reasons for this. Although there is some MURTHY NAIDU PAADAM enthusiasm as companies report better results, investors are acting cautiously. The weakening of the rupee against the

dollar also contributed to this. Overall, the Nifty rose 33 points and the Sensex rose 143 points.

The BSE Sensex, which closed at 81,337 in the previous session, opened at 81,594 on Wednesday. It touched an intraday low of 81,187. It reached an intraday high of 81,618. It finally closed at 81,486 with a gain of 143 points. The NSE Nifty, which opened at 24,890, touched a low of 24,771 and a high of 24,902. It closed at 24,855, up 33 points. The Nifty Bank fell 71 points to settle at 56,150.

In the Nifty50, 23 companies gained and 27 lost. Larsen & Turbo, Sun Pharma, NTPC, Maruti, Tata Consumer Products were the top gainers. Hero Moto, Power Grid, Bajaj Auto, Eternal, Coal India were the biggest losers. Today, the Infra, IT, Defense, FMCG, Consumer Durables, and Commodities indices rose marginally. Realty, media, PSU bank, mobility, auto, tourism, healthcare indices rose.

Market breadth on NSE today was equal for buyers and sellers. Out of a total of 3057 stocks traded, 1508 gained and 1465 lost. 85 shares touched their 52-week high and 35 touched their 52-week low. The upper circuit was 94 and the lower circuit was 26.

The rupee weakened by 60 paise to settle at 87.42 against the dollar. HSBC raised its target on Nippon AMC to Rs. 690 and gave it a hold rating. Nuama has given a buy rating to Varun Beverages with a target price of Rs. 606. JBM Auto Q1 profit rose 11% to Rs 37 crore from Rs 33.4 crore. Welspun Living Q1 profit fell 52% to Rs 89.3 crore from Rs 186 crore. M&B Engineering IPO received a response of 0.50 times on the first day afternoon. While the country aspires to become a global economic powerhouse and attract international investors, its retreat from key international frameworks such as Bilateral Investment Treaties (BITs) paints a conflicting picture. This duality has led to a paradox: a government advocating for FDI while enacting policies that may deter it.

India's economic liberalization began in the early 1990s under Prime Minister Narasimha Rao and Finance Minister Manmohan Singh. At that time, reforms allowed foreign investments through automatic and approved routes, laying the foundation for India's FDI journey. However, three decades later, the trajectory has lost momentum. According to the IMF's 2024 Article IV report, India's share in global FDI fell sharply from 6.5% in 2020 to 2% in 2023. UNC-TAD's 2024 report and past World Bank rankings emphasize the need for policy stability and deeper trade integration to regain investor trust.

India finds itself at a crossroads in its Settlement (ISDS) mechanisms. While the move is intended to preserve national sovereignty and regulatory space, it has raised alarm among investors who seek legal predictability and enforcement. The 2015 Model BIT reflects India's cautious approach, emphasizing domestic legal remedies and echoing principles akin to Latin America's Calvo Doctrine.

> India terminated over 60 BITs between 2016 and 2019, coinciding with a 32% drop in greenfield FDI projects. Scholars suggest this may have contributed to a 30% fall in overall investment inflows. Despite reforms in patent laws and business regulations, high-profile arbitration cases like Vodafone and White Industries continue to haunt investor sentiment.

Moving forward, India must strike a delicate balance—preserving its sovereign right to regulate while fostering a policy environment that reassures foreign investors. Rebuilding FDI momentum will require not just legal clarity and policy coherence, but also a transparent, geopolitically neutral approach that aligns domestic priorities with global economic aspirations.



India-China Econ Thaw Begins, Caution Persists: FM

Finance Minister Nirmala sitharaman has acknowledged early signs of improving economic engagement between India and China, but stressed the need for a "sense of caution" as the two Asian powers navigate a complex relationship. Speaking at the launch of A World in Flux: India's Economic Priorities, Sitharaman remarked that both nations are showing interest in increased interaction, including recent relaxations in visa norms.

"This could be a beginning, but we have to wait and see how far it goes," she said, noting that while access and economic collaboration might benefit both countries, the past still warrants a cautious approach.

India had imposed strict investment restrictions on China through Press Note 3 in April 2020. This move was aimed at preventing potential opportunistic takeovers of Indian firms during the economic vulnerabilities of the COVID-19 pandemic. While these curbs remain partially in place, recent developments point to a subtle but notable shift in tone.

Sitharaman emphasized that India's priority remains sustaining strong economic growth while playing a proactive role in reshaping global institutions and asserting leadership in the Global South. She also highlighted the importance of having a business-friendly and appealing FDI policy to attract long-term investments.

Commenting on the broader trend in global



trade, she observed that bilateral and regional trade agreements are increasingly taking precedence over multilateral frameworks. However, she refrained from judging whether this trend was beneficial, saying it's "too early to

Her remarks come at a time when India is working to position itself as a resilient and stable investment destination amidst shifting global supply chains and geopolitical uncertainty. As New Delhi cautiously re-engages with Beijing, the government appears to be balancing strategic interests with pragmatic economic considerations.

The evolving Indo-China dynamic, while still fragile, may offer opportunities for both economies—provided it is managed with foresight, caution, and mutual respect.

This marks a marginal but consistent rise from the previous day's prices, with cities like Delhi, Mumbai, Chennai, Bangalore, Hyderabad, and Kolkata reflecting similar patterns.

Experts believe that the rise in gold prices is tied to several global economic concerns, including geopolitical instability, currency fluctuations, and inflationary pressures in the US and Europe. Locally, demand for gold remains strong, especially with the upcoming festive and wedding seasons likely to further push the demand curve



upward. Additionally, gold's traditional appeal as a secure asset in uncertain times is again drawing investors to add it to their portfolios.

In Delhi, the rate for 18K gold increased from ₹7,499 to ₹7,548 per gram overnight, showing the market's responsive nature to broader trends. In Chennai, 24K gold crossed ₹10,098 per gram, among the highest in the country. Such increases are causing many to reassess their buying decisions, with some rushing to purchase ahead of further hikes, while others prefer to wait for potential price corrections.

Baba Vanga's Prediction Comes True After 25 Days?

Anxiety Hits Amid Japan, Russia Tsunami

Amassive 8.8 magnitude earthquake struck off Russia's Kamchatka Peninsula on Wednesday, triggering tsunami alerts across Pacific coast and reviving an eerie prophecy from a decades-old manga. The incident, marked as the region's strongest since 1952,



caused tsunami waves measuring 3–4 metres to hit parts of Russia, while smaller waves were Earthquake—Tatsuki did it again!" reported in Japan.

What has shocked many is the resurfacing of predictions made in Watashi ga Mita Mirai (The Future I Saw), a manga by Japanese artist Ryo Tatsuki. The quake hit about 125 km southeast of Petropavlovsk-Kamchatsky at a shallow depth of 19.3 km, causing panic across Russia's Far East. In Japan, tsunami sirens rang out, coastal evacuations were ordered, and fishing boats were sent out to sea. The Fukushima nuclear plant took precautionary measures, though no damage or radiation leaks were reported.

While Japan only recorded small tsunami waves with no major destruction, authorities remain on high alert. The unsettling coincidence between fiction and reality has triggered a wave of speculation, with many drawing comparisons between Tatsuki's manga and the legendary predictions of Baba Vanga—raising questions about fate, foresight, and fear.

Engineers Create Innovative Robotic Arm to Assist People With Mobility Impairments

Tn a major step forward Ifor assistive technology, engineers at Virginia Tech have developed a robotic system designed to support individuals with impairments in completing everyday tasks. The system features a robotic arm equipped with an adaptive gripper capable of handling objects of various sizes, shapes, and textures with remarkable precision and care. This innovation is particularly effective for handling delicate

items like fruits, vegetables, and baked goods.

Traditional robotic grippers typically fall into two categories: soft grippers and rigid end-effectors. Each type has its own limitations—soft grippers struggle to lift irregular, heavy objects, while rigid grippers often fail to grasp small or fragile items effectively. To overcome these challenges, the team introduced a new hybrid approach called RISOs, which merges *Rigid end-effectors with **SO*ft adhesives.

"Our philosophy is that if you are going to provide someone with a robot to help them, it needs to mimic how a person would naturally perform the same task," explained Dylan Losey, associate professor of mechanical engineering. "This way, the robot acts more like an extension of the user's own movement, making it

more intuitive and user-friendly."

The RISOs system can switch between gripping modes—using either rigid fingers to pinch or soft, adhesive materials that attach and release objects gently. This hybrid functionality enhances the robot's ability to manipulate a broader range of objects, combining strength with sensitivity.

The team also enabled the robot to receive inputs via joystick and developed a soft, bubble-like fingertip that deflates upon contact, creating a temporary adhesive bond for secure gripping.

This breakthrough could significantly improve the quality of life for people with physical limitations, giving them greater independence in performing routine activities.

Bitchat vs WhatsApp

Offline Messaging App Sparks Buzz



Tn an era where WhatsApp is stored temporarily in device **L**deeply woven into our daily routines, a surprising new challenger has emerged—Bitchat, a messaging app that doesn't require Wi-Fi or mobile data. Launched by Twitter co-founder Jack Dorsey, Bitchat is gaining attention for its unique ability to function completely offline using only Bluetooth technology.

What sets Bitchat apart is its Bluetooth Low Energy (BLE) mesh networking system, which allows users to send messages to nearby devices within a 30-meter range. Instead of routing messages through central servers like WhatsApp or Telegram, Bitchat sends messages by splitting them into small encrypted data packets, which are then broadcast via BLE. These packets are reassembled into the original message on the recipient's phone if they're within range. If not, the data can "hop" through other Bitchat-connected devices until it reaches the destination.

India has been placed in a challenging Group **L**C for the AFC Women's Asian Cup 2026, set to take place in Australia from March 1 to 21. The draw, held at Sydney Town Hall on July 29, featured Indian midfielder Sangita Basfore as one of the draw assistants.

The Blue Tigresses will face Vietnam in their tournament opener on March 4 at the Perth Rectangular Stadium. They will then take on Asian giants Japan on March 7, followed by a match against former champions Chinese Taipei on March 10 at the Western Sydney Stadium.

Group C is one of the toughest in the tournament. Japan, ranked 7th globally, are former World Cup winners (2011) and two-time Asian Cup champions (2014, 2018). Vietnam, ranked 37th, are coming off their 2023 Women's World Cup debut and are hungry for a return to the global stage. Chinese Taipei, ranked 42nd, boast three Asian Cup titles, though their last came in 1980.

India, currently ranked 70th, are the lowest-ranked team in the group. However, head coach Crispin Chettri expressed cautious optimism, stating, "It's a tricky group, but we can compete with Vietnam and Chinese Taipei. Our preparation now has to be smart and focused."

Sangita Basfore added, "We've played all three teams before. Our dream is to reach the World Cup in Brazil, and now we're just one step away."

The top two teams from each group, along with the two best third-placed teams, will qualify for the quarterfinals. The four semifinalists will book direct tickets to the 2027 FIFA Women's World Cup, while quarterfinal losers will get another shot through playoffs.

India will be looking to overcome the heartbreak of 2022, where a COVID outbreak forced their withdrawal from the tournament.
