Govt Orders Probe Into Pashamilaram Blast

The Telangana government has taken a serious note of the deadly explosion at the Sigachi Industries chemical plant in Pashamilaram, Sangareddy district, and issued orders on Wednesday to form a high-level inquiry committee. The move comes in response to rising public concern and pressure from victims' families over the cause of the explosion and the slow pace of rescue and identification efforts.

Expert Committee to Investigate Accident

A four-member expert committee has been con-

stituted to investigate the causes of the blast and assess safety lapses at the chemical unit. The panel will be headed by eminent scientist Dr. B. Venkateswara Rao of CSIR, with Chief Scientist T. Pratap Kumar, retired scientist Suryanarayana, and Pune-based safety officer Santosh Ghuge as members. The committee has been given one month to submit its report.

The Directorate of Factories has been directed to provide full assistance to the panel. The team is expected to identify lapses in safety protocols, check if Sigachi Industries followed necessary guidelines, and make recommendations to prevent such incidents in the future.

Telangana Minister Damodar Rajanarsimha

visited the blast site, met with company representatives, and reviewed the rescue and cleanup operations. Debris clearance at the site has officially begun, with officials supervising the process closely.

Victims' Families Protest at **Factory Gate**

Amid official efforts, grief-stricken families of the deceased and missing gathered in protest at the gates of Sigachi Industries. They demanded clarity on the fate of the 11 individuals still unaccounted for, accusing authorities of delays and inefficiency in rescue and identification.

Relatives expressed frustration that even days

after the blast, the whereabouts of their loved ones remain unknown. They urged the government to speed up DNA testing and increase transparency in the ongoing investigation.

Due to the severe burns on the bodies, identification has proven difficult. Officials confirmed that DNA testing is underway, with samples taken from relatives of the missing. Only after genetic matches are confirmed are bodies being handed over to families.

So far, 11 bodies have been identified and returned, while 18 remain in the Patancheru hospital morgue. Officials stated that the identification process is complex and time-consuming, which is causing the delay.

Search for Missing Continues

Search operations are ongoing to locate the 11 individuals still missing after the blast. Rescue teams sifting through the debris, while efforts are being coordinated with forensic and disaster response teams.

Sigachi Confirms 40 Deaths...

Announces ₹1 crore compensation to families of deceased Sigachi Industries has officially confirmed that 40 employees lost their lives in the recent chemical plant explosion at awaiting the official report from the government-appoint-

Pashamilaram in Sangareddy district. The company, in its first formal communication since the accident, also stated that 33 workers were injured and are currently undergoing treatment in various hospitals.

Sigachi Company Secretary Vivek Kumar issued a statement this morning and sent a formal communication to the National Stock Exchange (NSE). In the statement, the company expressed deep regret over the tragic incident and assured that all possible support

will be extended to the affected families. As part of its compensation package, the company announced that the families of the deceased will receive ₹1 crore each. The statement mentioned that Sigachi is also making arrangements to ensure better medical care for the

injured workers.

In a notable clarification, the company denied initial reports that a reactor explosion was the cause of the blast. "We are

Further, the company has decided to suspend operations at the Pashamilaram plant for the next 90 days as a precautionary and safety measure. The shutdown comes as the government's four-member expert panel begins its probe into the explosion and potential lapses in safety norms.

The official announcement comes amid mounting pressure from the

victims' families, protests at the factory gate, and a broader inquiry into the industrial safety practices followed at chemical units across the state. The government's response and the upcoming report from the expert committee are now eagerly awaited.

Ara Mastan's Calls with **Revanth Tapped...?**

Key strategist's phone under surveillance since 2020, confirms probe team

Sensational revelations have come to light in the ongoing phone tapping investigation involving political strategist Ara Mastan, as top officials confirm that his mobile phone had been under surveillance since 2020. Shocking details show that Mastan's conversations with several high-profile political figures, including then TPCC president and cur-

rent CM Revanth Reddy, were tapped and recorded by the alleged illegal surveillance team led by former SIB chief Prabhakar Rao.

According to investigation sources, Ara Mastan's phone was actively tapped starting from September 2023, but earlier data indicates that he had been



monitored for over three years. Investigators found that Mastan held phone conversations in November 2023 with Revanth Reddy, Kondal Reddy, and Chamala Kiran Kumar Reddy, which were secretly recorded by the team operating

under Prabhakar Rao.

Irrigation and Civil Supplies Minister Capt. N. Uttam Kumar Reddy announced that

Chief Minister A. Revanth Reddy will launch the statewide distribution of new ration cards on July 14 at Tirumalagiri in the Tungaturthi constituency. Deputy Chief Minister Bhatti Vikramarka will also attend the inaugural event.

During a review meeting held at the Nalgonda District Collectorate, Uttam Kumar Reddy directed officials to finish the verification process of all eligible ration card applications by July 13. He stressed that the selection process must be transparent

and free from corruption.

Highlighting the significance of the initiative, the Minister said Telangana's free fine rice scheme is one of the largest in the country, serving 6 kg of rice per person to over 3.10 crore people monthly. The program costs the state over ₹13,000 crore annually. He noted that to ensure uninterrupted supply, three months' worth of rations were distributed in June, July, and August.

Taking a dig at the previous BRS govern-

ment, Uttam pointed out that while Telangana had 89.73 lakh white ration cards at the time of its formation, only 49,000 were added in ten years. "The Congress government is correcting this by processing lakhs of pending applications," he stated.

On irrigation, the Minister said pending projects in erstwhile Nalgonda district will be fast-tracked. He revealed that the stalled Srisailam Left Bank Canal (SLBC) works will be resumed with the help of Army engineers conducting LIDAR surveys for technical clearanc-

R&B Minister Komatireddy Venkatareddy and Welfare Minister A. Laxman Kumar joined the meeting and assured support for infrastructure and social welfare initiatives. Legislators raised concerns regarding canal repairs, land acquisition, and pending resettlement funds.

Telangana Revamps Disaster Management Authority to Set National Example

Telangana Revenue, Housing, and Information & Civil Relations Minister Ponguleti Srinivasa Reddy announced that the Telangana State Disaster Management Authority (TGSDMA) has been reorganized and strengthened to serve as a model for disaster preparedness and response in the country. He emphasized the government's proactive approach to minimizing damage to life and property during natural disasters.

In a high-level meeting chaired by Chief Secretary K. Ramakrishna Rao and Special Principal Secretary for Disaster Management Arvind Kumar, district collectors and senior officials from Godavari and Krishna river basin districts gathered to review flood preparedness. The meeting focused on strategies for flood forecasting, inter-departmental coordination, and relocation of vulnerable populations. "We may not be able to prevent natural disasters, but with a robust and well-coordinated system, we can certainly reduce their impact," said Minister Ponguleti. As part of this reform, the Chief Minister

will head the newly constituted TGSD-MA, with key ministers from Revenue, Home, Finance, Health, Irrigation, Roads & Buildings, Panchayati Raj, and Rural Development as members. The Chief Secretary will act as Member Convener, and the Special Chief Secretary of Revenue will serve as a special invitee.

The Minister proposed that instead of moving flood victims to temporary shelters during every calamity, they should be provided with permanent housing. "We

will construct Indiramma Houses under an additional quota for identified families in flood-prone catchment areas," he

Highlighting last year's tragic incident in Paleru, where victims could not be rescued due to the absence of a proper airlift system, he stressed the urgency of developing aerial rescue capabilities and studying effective airlift mechanisms. He directed officials to develop a scientific alert system in coordination with the IMD, to share timely information from top to bottom.

Special nodal officers will also be appointed at the state level for departments directly involved in flood and rain response—such as irrigation, electricity, police, transport, health, and agriculture. Other senior attendees at the meeting included Fire Department DG Nagi Reddy, Panchayati Raj Commissioner Srujan, Civil Supplies Director Muzammul Khan, Hyd Commissioner Ranganath, CP DCL Director Mushraf Ali, and IMD Officer Nagaratnam, among others.

Revanth acting as Chandrababu's 'bag man', alleges Harish

BRS MLA and former minister Harish Rao has launched a scathing attack on Telangana Chief Minister Revanth Reddy, accusing him of acting as a 'bag man' for Andhra Pradesh Chief Minister Chandrababu Naidu and betraying the interests of Telangana. He alleged that Revanth has become a tool in the hands of the Andhra Pradesh government, prioritizing political deals over the welfare of Telangana.

Reacting to the recent PowerPoint presentation made by the Congress government on irrigation at Pragathi Bhavan, Harish Rao said it looked like a document prepared in Amaravati, not Hyderabad. "It doesn't highlight how Chandrababu is pushing the Banakacharla project or the statements he made. For Revanth, Chandrababu looks like a god, while BRS, which is fighting to stop Banakacharla, looks like a dead snake," he said.

Harish countered the Congress's criticism by questioning, "If BRS is a dead snake, why are Congress leaders still losing sleep over us?" He also drew parallels with the Congress party at the national level, asking whether a party out of power for over a decade should be called a 'dead snake' too. Harish Rao strongly alleged that a covert agreement exists between Revanth Reddy and Chandrababu regarding the Banakacharla project. He claimed that Revanth and Uttam Kumar Reddy had given the green signal to the Godavari-Banakacharla linkage—Revanth from Telangana and Uttam from Andhra—in 2024. He pointed out that AP CM Chandrababu later wrote to Union Finance Minister Nirmala Sitharaman in November and December requesting funds for the same project, but Revanth remained silent, raising suspicions of a secret pact.

Further, he revealed that it was only after BRS exposed this backdoor agreement in a January 24 press meet that Telangana Irrigation Minister Uttam Kumar Reddy rushed to write a backdated letter to the Centre. Harish said the temporary halt of the Terms of Reference (TOR) process for the Banakacharla project was a direct outcome of BRS's relentless efforts.

He clarified that the Banakacharla issue was not even raised in the Apex Committee meeting, where the only resolution was to initiate talks between the two states about the 3,000 TMC of water that is flowing unused into the sea. Harish concluded by warning that Revanth lacks even a basic understanding of river basin dynamics and said, "If he continues to speak arrogantly, the state will end up in

Revanth's Job Is to Protect Chandrababu and Blame KCR: Gangula

Senior BRS leader and MLA Gangula Kamalakar has lashed out at Telangana Chief Minister Revanth Reddy, accusing him of prioritizing the defense of Andhra Pradesh CM Chandrababu Naidu while targeting former CM K. Chandrashekar Rao. Speaking at a press conference held at Telangana Bhavan on Tuesday, Gangu-

la ridiculed the PowerPoint Presentation (PPP) given by CM Revanth Reddy and Minister Uttam Kumar Reddy to legislators, calling it a waste of public money and lacking any new in-

Gangula alleged that Revanth Reddy's political agenda is simple: "Protect Chandrababu and scold KCR." He criticized the Congress government for not taking the Banakacharla project seriously and for failing to confront the Centre effectively. He pointed out that it was only after

BRS leader Harish Rao exposed the facts that the government was forced to react. Ganja Seized in Four Separate Cases Across Telangana

Seven-member gang arrested in Borampet with 3.7 kg ganja Multiple arrests in Ghatkesar, Balanagar, and Dhoolpet areas Illegal trade traced to Khammam and Orissa links

In a major crackdown on ganja smuggling, Telangana enforcement authorities have registered four separate cases across the state, seizing substantial quantities of narcotics and arresting several individuals involved in illegal drug trade.

In the most significant case, a gang operating out of a rented house in Borampet was busted by Rangareddy Enforcement AES Jeevan Kiran and the NPA Enforcement Team. A total of 3.7 kilograms of ganja was seized. Seven accused were arrested, including Srigiri Suresh, Sheikh Soyal, Podila Jaswanth, Podila Yashwanth, Mallamparthi Sai Praveen, Ande Srinath, and Andesan Sen. Authorities revealed

that five of the accused are from Khammam, while two are from Hyderabad. The gang had been bringing ganja from Orissa and selling it locally, sharing profits among themselves.

In another incident, 1.4 kg of ganja was seized in Ghatkesar. A 20-year-old photographer named B. Nikhil from Janagam district was caught selling ganja in Yennampet. He was arrested by CI Balaraju and SI Ravi of the NPT enforcement team, under the supervision of AES Jeevan Kiran. Meanwhile, in the Balanagar area, 1.250 kg of ganja was seized based on intelligence inputs. Enforcement CI Subash and SI Venkat apprehended Mammamad Jamil while selling ganja. A case has also been registered against a woman



named Kavitha, who is believed to be involved. In a fourth operation, the STFA team led by Anji Reddy arrested Manoj Singh at a house in Dhoolpet Devinagar, where 1.568 kg of ganja was recovered. Two suspects, Arunabai

and Sumabai, are currently absconding. Authorities have intensified surveillance and vowed continued action against narcotics trade in the region. Further investigations are underway in all four cases.

Floating Trash Collectors Launched at Banjara Lake

Mayor Gadwal Vijayalakshmi flags off hyacinth and garbage removal drive

Hyderabad: In a significant step toward environmental protection and public health, Mayor Gadwal Vijayalakshmi on Wednesday launched Floating Trash Collector (FTC) machines and carting operations at Banjara Lake, located in the Khairatabad zone of Banjara Hills. The initiative aims to clear water hyacinth and garbage from the lake to curb mosquito breeding and improve lake health.

The event was attended by GHMC Zonal Commissioner Anurag, Deputy Commissioner Samaiah, Executive Engineers, and other municipal officials.

As part of the drive, FTC machines will be deployed across the lake to systematically remove the widespread water hyacinth and floating debris. Heavy machinery like Hitachi and JCBs will assist in areas where lake embankments are not properly formed, ensuring smooth extraction and carting processes. "From tomorrow, the collected hyacinth and garbage will be transported to the Jawahar Nagar dump yard and disposed of systematically," GHMC officials stated.

The program is a focused effort to control the spread of vector-borne diseases like malaria, dengue, and chikungunya by eliminating mosquito breeding grounds. Drone-based spraying is also being conducted as part of an integrated mosquito control strategy.

GHMC emphasized that such actions reflect its proactive commitment to public health, cleanliness, and environmental sustainability.

Asia's largest tribal fair to be held from Jan 28 to 31 Sammakka arrives on Jan 29, Vanapravesh on Jan 31 Priests finalize muhurat, devotees gear up for festival

The muhurat for the revered Sammakka-Saralamma Medaram Mahajatara has been officially declared by the priests' association, confirming that Asia's largest tribal fair will take place from January 28 to 31, 2026 in Medaram village, Tadwai mandal of Mulugu district.

As per the traditional schedule, Saralamma, Pagiddidda Raju, and Govinda Raju will ascend the holy platform (gadde) on January 28, marking the ceremonial commencement of the festival. On January 29, Sammakka Thalli, the central deity of the Jatara, will arrive from Chilakalagutta, a significant ritual that draws lakhs of devotees from across Telangana and beyond.

January 30 will be devoted entirely to fulfilling vows, where devotees offer jaggery, turmeric, saffron, and sarees as symbols of gratitude and devotion. The four-day event will conclude on January 31 with the Vanapravesham, the symbolic return of Sammakka and Saralamma to the forest.

Seetakka Visits Jailed Tribal Leader Kawasi Lakhma in Raipur

Telangana Minister Seetakka visited former Chhattisgarh Excise Minister and senior tribal leader Kawasi Lakhma at the Central Jail in Raipur on Tuesday, expressing strong solidarity with him and his supporters. She was accompanied by Tribal Cooperative Chairman and Adivasi Congress National Vice President Bellaiah Naik, along with other Congress leaders.

Speaking to the media outside the prison, Minister Seetakka lashed out at the BJP-led Chhattisgarh government, accusing it of illegally detaining Kawasi Lakhma and filing baseless cases as part of political vendetta.

"Lakhma garu is a six-time MLA, a former minister, and the strongest tribal voice in Bastar. He has been iailed for six months without any

Sandalwood Smuggling Racket Busted in Chevella

1000 kg white sandalwood worth ₹35 lakh seized

In a cinematic-style sandalwood smuggling operation, police teams from Madhapur SOT and Chevella police busted an illegal sandalwood transportation racket near Bastepur village on the outskirts of Chevella mandal. Acting on credible intelligence, authorities intercepted a DCM vehicle (MH25AJ3689) carrying 1000 kg of white sandalwood worth approximately ₹30 to ₹35 lakhs.

According to Chevella ACP Kishan, the sandalwood, sourced from Hantwadi village, Sangli district, Maharashtra, was en route to an Andhra Perfume Factory located in Nagarguda village of Shabad mandal in Rangareddy district. The smuggled consignment was being illegally processed for use in perfumery.

Police arrested three persons involved in the transportation — driver Abdul Aziz, supervisor Soheb, and farmer Vijay Hanumant Mane. However, the factory owner Abdul Kurvi and manager Siddique are absconding. Efforts are underway to trace and apprehend them.

The operation was carried out by Madhapur SOT CI Sanjay, SIs Satish and Ajay, forest officer Ravi Kumar, and Chevella police personnel.

All three accused have been remanded to judicial custody, and further investigation is ongoing to trace the entire network involved in the high-value sandalwood smuggling operation.



BJP Seeks ₹100 Cr Grant for Karimnagar Development

Sunil Rao leads delegation, slams Congress for neglecting civic issues



TPN Correspondent | Karimnagar A delegation of BJP leaders, led by former Karimnagar Mayor Yadagiri Sunil Rao, submitted a representation to District Collector and Special Officer Pamela Satpati, urging immediate intervention to resolve pending civic issues and stalled development works in Karimnagar city. The leaders demanded that the state government release ₹100 crore as a grant to the municipal corporation to address the pressing needs of the citizens.

Speaking to the media after the meeting, Sunil Rao criticized the Congress government, alleging that no development work has been initiated in the city since it came to power. He pointed out that not a single rupee had been released to the municipal corporation under the current regime and that the entire development over the past six years was made possible only due to funds sanctioned by the central government. He credited Union Minister Bandi Sanjay Kumar with bringing ₹800 crore to the city under central schemes, including ₹279 crore under AMRUT 1 and 2 for drinking water projects and another ₹100 crore under the 15th Finance Commission. He said the merged divisions of the corporation are still being covered under these central schemes.

Rao said the city's civic body is now struggling due to the lack of financial assistance from the state and is unable to fund development works with its own resources. The taxes collected are barely sufficient to manage routine affairs, and 70 roads dug up by contractors since 2023 remain abandoned, creating major inconvenience during the rainy season.

"The Congress government is ignoring Karimnagar. No representative from the ruling party seems to care about the city. While leaders are busy with their constituencies and politics, Karimnagar's issues are being neglected," Rao remarked.

The BJP leaders appealed to the Special Officer to escalate their concerns to the state government. They demanded the completion of all abandoned road works, filling of potholes, and repairs to ensure public safety during the monsoon. Rao warned that if the government fails to act, the BJP will launch a massive agitation to pressurize the state into action.

This "Quantum Valley" in Andhra Pradesh is designed to bring together brilliant minds, cutting-edge labs, and big companies to create new quantum computers, develop super-secure communication methods, and even invent materials with incredible properties. It's like building the future of technology in one place, which will create lots of high-paying jobs, attract businesses, and make India a leader in this revolutionary field. He and his government is now writing a new slogan 'Bye Bye Silicon Valley, Hello Quantum Valley".

Andhra Pradesh's proposed Quantum Valley is poised to become a powerful force in transforming the state and propelling India onto the global stage in quantum technology. This ambitious initiative, planned for launch in January 2026 in Amaravati, is designed as India's first full-stack integrated quantum technology ecosystem, spanning 50 acres and integrating quantum computing, artificial intelligence, semiconductor research, and defense innovation. A key immediate impact will be substantial job creation, with estimates ranging from 90,000 to 100,000 highend positions once fully operational. This growth will be bolstered by a vibrant startup ecosystem, supported by initiatives like the Ratan Tata Innovation Hub and a proposed ₹1,000 crore Quantum Fund.

To ensure a steady supply of skilled talent for these roles, the Andhra Pradesh State Council of Higher Education has directed universities to introduce quantum computing curricula, with Andhra University already offering degree programs from the 2025-26 academic year, and the Amaravati Quantum Academy launching India's first Integrated Quantum Skilling Ecosystem. A critical national benefit is its contribution to national security and defense, supporting advancements in post-quantum cryptography, high-performance computing, photonics, and quantum-aligned aerospace and defense technologies, thus building India's strategic deep-tech capacity. Collaborations with industry giants like IBM, TCS, and L&T will drive the development of quantum-integrated applications in sectors such as life sciences, materials science, supply chain resilience, energy optimization, and cryptography.

The Quantum Valley directly supports

national initiatives like "Atmanirbhar Bharat" and "Digital India" by addressing critical gaps in indigenous hardware and talent development, enhancing India's self-reliance in cutting-edge technologies. Job specialties like Quantum Algorithm Developers, Quantum Software Developers, who create higher-level software using quantum frameworks (like Qiskit or Cirq) to run on quantum processors. Another high-paid job will be for Quantum Error Correction Specialists who are trained and focused on improving the stability and reliability of fragile qubits.

Besides the above key positions in various companies blossoming in the Valley will be 1000s of jobs in Post-Quantum Cryptography Expertise, Application Scientists or Domain Specialists who can apply quantum techniques to specific fields such as chemistry, finance, logistics, life sciences, materials science, and ener-

gy optimization, requiring combined knowledge in a specific field and quantum concepts.

Artificial Intelligence and Semiconductor Research Engineers are also in need of thousands. Given the integrated nature of the Valley, there will also be strong demand for experts in artificial intelligence and semiconductor research. Data and AI is going to be buzzwords in the Valley.

These roles reflect the broader trend towards hybrid classical-quantum systems and the increased demand for post-quantum security measures. Students aspiring to enter these fields will need a strong foundation in mathematics (linear algebra, probability, complex numbers), quantum mechanics basics, programming (especially Python and quantum frameworks), and classical computer science fundamentals. The Quantum Valley's emphasis on education and skill development directly aims to prepare the workforce for these specialized and high-demand future jobs, making it a critical hub for India's technological and economic advancement. Our present school curriculum badly needs to be modified, and the capacity of the teachers in the area of computer science and AI needs to be built to provide a robust foundation for the present-day school students in Andhra Pradesh to ensure the Valley is filled first with natives.

NHAI Capex Claims Under Scrutiny Amid Financial Tightening and Monetisation Setbacks

In 2024-2025, the Government of India lauded the National Highways Authority of India (NHAI) for achieving a record capital expenditure (capex) of over ₹2.5 lakh crore for national highway development, surpassing its ₹2.4 lakh crore target. However, this claim is now being questioned due to discrepancies in NHAI's unaudited financial statements, which report a significantly lower capex of ₹1.45 lakh crore. This gap of over ₹1 lakh crore has raised concerns about possible financial window-dressing and a deepening funding squeeze on the NHAI. According to NHAI's unaudited 2024-2025 accounts, while the government claimed a record ₹2.5 lakh crore in infrastructure spending, a closer look reveals that a large portion of these funds was used not for highway construction but for loan repayments. Specifically, the repayment of ₹50,000 crore from the National Small Savings Fund (NSSF) and the reduction of public sector bank loans were included in the government's capex figures, thereby inflating the real developmental spending. Effectively, the net capex spent on actual infrastructure works was only ₹1.45 lakh crore—the amount reflected in NHAI's accounts. This discrepancy suggests the government's ₹2.5 lakh crore claim includes significant debt repayments, thus overstating its investment in new highway infrastructure. The reported repayment of ₹50,000 crore to NSSF, which simply circles money back to the government, further underscores the lack of transparency. Hence, the



real support extended to NHAI stands at around ₹2 lakh crore, far below the claimed figure.

Additionally, NHAI's asset monetisation efforts appear to be faltering. The

government has celebrated the National Highways Infra Trust (NHIT) as a success in raising ₹18,380 crore in its fourth fundraising round. However, closer scrutiny of NHIT reveals that

it remains largely government-controlled, with project management and investment oversight still under NHAI through wholly owned entities. While monetisation transactions have nominally raised ₹43,648 crore by transferring 2,345 kilometres of roads, genuine private sector participation remains limited, with much of the funding sourced through loans rather than equity investment.

Other monetisation models like the Toll, Operate, and Transfer (ToT) approach have been sidelined. Union Minister Nitin Gadkari himself expressed dissatisfaction with the government's decision to discontinue the ToT model, previously an effective monetisation tool. Similarly, the government's special purpose vehicle (SPV) model for financing new expressways has seen little traction, with only one such project—the Delhi-Vadodara expressway—currently underway, despite notable delays.

Adding to the NHAI's challenges is the indefinite freeze on the Bharatmala Pariyojana, a flagship road development project launched in 2017-2018 with a target of 34,800 kilometres and an estimated cost of ₹6.92 lakh crore. Ongoing issues with cost overruns, land acquisition, and contract execution prompted a government review, which remains incomplete well after the 2024 general elections.

Together, these developments point to a tightening financial situation at NHAI and raise serious concerns about the government's infrastructure spending narrative. The inflated capex claims, faltering monetisation, and stalled projects paint a more complex picture than the government's optimistic public messaging suggests.



Hearing in Rahul Gandhi Defamation Case Adjourned to July 14 in Sultanpur Court

The MP-MLA Court in Sultanpur on Wednesday, July 2, 2025, adjourned the hearing of a defamation case against Congress leader Rahul Gandhi until July 14. The case pertains to alleged objectionable remarks made by Mr. Gandhi against Union Home Minister Amit Shah.

The defamation complaint was originally filed in 2018 by BJP leader Vijay Mishra. Advocate Santosh Kumar Pandey, representing Mr. Mishra, informed the court that a witness was scheduled to be examined on Wednesday. However, the hearing was deferred as the witness failed to ap-

This case has been ongoing for several years. In December 2023, the MP-MLA Court had issued a warrant against Rahul Gandhi. Subsequently, in February 2024, Mr. Gandhi surrendered before the court and was granted bail after furnishing two sureties of ₹25,000 each.

On July 26, 2024, Rahul Gandhi recorded his statement in the court, denying the allegations and asserting that the case was part of a political conspiracy aimed at tarnishing his reputation.

The defamation suit stems from comments Mr. Gandhi allegedly made against Amit Shah during the Karnataka Assem-



bly poll campaign. Vijay Mishra had accused him of making objectionable remarks that amounted to defamation.

The case has attracted significant political attention, given the stature of the individuals involved and its potential impact on public discourse. The upcoming hearing on July 14 is expected to move forward

with the examination of witnesses and further arguments from both parties.

As the legal proceedings continue, supporters and critics alike are closely following the developments in this high-profile defamation case, which reflects the intense political rivalry between the Congress and BJP parties in India.

PM Modi Embarks on Longest Diplomatic Visit in a Decade

Strengthens Ties with Global South

Prime Minister Narendra Modi on Wednesday, July 2, 2025, began a landmark five-nation diplomatic tour — his longest in the past 10 years — with a focus on deepening India's engagement with the Global South. His itinerary includes visits to Ghana, Trinidad and Tobago, Argentina, Brazil, and Namibia from July 2 to 9.

Modi's visit to Brazil is especially significant, marking the first by an Indian Prime Minister in nearly six decades. He will attend the BRICS Summit in Rio de Janeiro on July 6-7, followed by a bilateral visit to Brasília. "India is committed to BRICS as a vital platform for cooperation among emerging economies. Together, we strive for a more peaceful, equitable, democratic, and balanced multipolar world order," Modi stated before depar-

Kicking off his tour in Accra, Ghana, PM



Modi will engage with President John Dramani Mahama to explore cooperation in investment, health, energy, and development. He is also scheduled to address Ghana's Parliament, calling it a special honour shared between two democracies.

From West Africa, the Prime Minister will travel to Trinidad and Tobago on July 3-4. This year marks 180 years since the first Indians arrived in the Caribbean nation. He will meet President Christine Carla Kangaloo and Prime Minister Kamla Persad-Bissessar, emphasizing historical and cultural ties.

In Buenos Aires, Modi will hold talks with Argentine President Javier Milei. This is the first bilateral visit by an Indian PM to Argentina in 57 years. The discussions are expected to focus on trade, technology, agriculture, and critical minerals.

Concluding his tour in Namibia, Modi will meet President Netumbo Nandi-Ndaitwah and address the Namibian Parliament, highlighting shared anti-colonial histories and development goals. The visit reflects India's growing commitment to Global South solidarity and multilateral cooperation through platforms like BRICS, the African Union, ECOWAS, and CARICOM.



China objects to Dalai Lama's plan, says 'seal of approval' must

A new diplomatic and ideological confrontation has erupted between Tibetans and China after the 14th Dalai Lama, Tenzin Gyatso, affirmed the continuation of the Dalai Lama institution and asserted that only the Gaden Phodrang Trust holds the legitimate authority to recognize his rein-

Reacting sharply, China dismissed the announcement on Wednesday, with Foreign Ministry spokesperson Mao Ning declaring that any future successor to the Dalai Lama must be approved by Beijing. She insisted that the process must adhere to Chinese domestic laws, the "Golden Urn" system, and official state approval — a requirement Beijing claims aligns with religious tradition and legal procedure.

The "Golden Urn," introduced by Qing dynasty officials in the 18th century, involves drawing lots to select religious leaders. Mao noted that its use was formally codified into Chinese regulations in 2007, banning foreign involvement in Tibetan reincarnation processes.

The response drew swift and pointed criticism from the Tibetan side. Dhundup Gyalpo, Secretary of the Bureau of the Dalai Lama in New Delhi, dismissed Mao's statement on X (formerly Twitter), calling it "Lies, damned lies and Chinese propaganda."

Gyalpo clarified that the traditional Tibetan method of identifying reincarnated lamas relies on signs, visions, or divinations such as the dough-ball method — not the Golden Urn, which he said was only used once symbolically in the selection of the 11th Dalai Lama. He asserted that the 14th Dalai Lama was identified without any Chinese involvement, and China's delegates attended his 1940 enthronement on British-issued visas as guests — not participants. Gyalpo further pointed out that China's state-sponsored "Han Buddhism" lacks any reincarnation system, underscoring that the lineage-based system of Tibetan Buddhism remains culturally and spiritually distinct.

Notably, Mao Ning's remarks about the Dalai Lama's succession were omitted from the official Chinese Foreign Ministry transcript, according to Press Trust of India.

The latest exchange reflects the deep-rooted tensions between Tibetan religious independence and China's attempt to assert political control over spiritual matters in Tibet, especially as the issue of the next Dalai Lama grows more urgent with the current leader now 89.

Indian Navy Rescues 14 Crew Members, Contains Fire on Palau-Flagged Tanker in Arabian Sea

Demonstrating swift action and maritime readiness, the Indian Navy successfully contained a major fire onboard a Palau-flagged oil tanker, MT Yi Cheng 6, in the North Arabian Sea on June

29, 2025. The vessel, operating approximately 80 nautical miles east of Fujairah in the United Arab Emirates, had reported a severe fire in its engine room and a total power failure.

Following a distress call from the ship, the Indian Navy immediately launched a high-risk firefighting and rescue operation. Warship INS Tabar was swiftly deployed and proceeded at maximum speed to the location. Upon

were promptly evacuated to the Navy ship using small boats.

"All evacuated crew were safe and medically examined onboard INS Tabar. No injuries were reported," the Navy said in an official statement. The remaining crew, including the ship's master, stayed onboard to assist with firefighting efforts.

A six-member team from INS Tabar initially joined the ship's crew to battle the blaze, suc-

cessfully reducing the fire's intensity and confining the smoke to the engine room. The operation was later reinforced with an additional 13 Indian Navy personnel — five officers and eight sailors — to strengthen the containment effort. After sustained firefighting over several hours,



arrival, seven of the 14 Indian crew members the joint team successfully brought the fire under control. INS Tabar has remained in the vicinity of MT Yi Cheng 6 to provide continued assistance and ensure safety.

The Indian Navy praised the courage and professionalism of its personnel, stating, "The valiant effort of Indian Naval personnel ensured the safety of the vessel and all Indian crew members. This operation underscores the Navy's rapid response capability, operational preparedness, and commitment to maritime safety."

Gunfight Breaks Out Between Security Forces and Terrorists in J&K's Kishtwar Forests

An intense encounter erupted on Wednesday evening between security forces and terrorists in a dense forested region of Kishtwar district, Jammu and Kashmir, officials confirmed.

The gun battle began during a joint cordon and search operation launched by the Jammu and Kashmir Police, the Indian Army, and the Central Reserve Police Force (CRPF) in the Kuchal area of Chatroo, a remote and heavily forested region known for difficult terrain and limited visibility.

Security forces initiated the op-

eration based on credible intelligence inputs about the presence of terrorists hiding in the area. As the search teams advanced into the forest, terrorists opened fire, triggering a fierce exchange of gunfire.

The operation was ongoing at the time of the latest reports, with heavy firing being reported from both sides. Security forces have moved in reinforcements to the area to tighten the cordon and prevent any escape of the terrorists. "The terrorists opened fire upon noticing the search parties. The forces immediately retaliated, leading to an ongoing encounter," an of-

Kishtwar, once relatively peaceful compared to other districts in the Kashmir Valley, has witnessed an uptick in terrorist activity in recent months. Security forces have increased patrolling and intelligence-gathering efforts in response to renewed threats.

Officials said the objective is to neutralize the terrorists and prevent any potential threat to civilian life in the surrounding areas. The operation is being closely monitored by senior police and army officials, and further updates are awaited as the situation develops.



Trump-Backed Bill Proposes 500% Tariff on Nations Trading with Russia, Including India and China

A controversial new U.S. Senate bill backed by President Donald Trump could impose a 500% tariff on countries that continue to trade with Russia, including major economies like India and China. The legislation, spearheaded by Republican Senator Lindsey Graham and co-sponsored by Democrat Richard Blumenthal, aims to pressure these nations to cut economic ties with Moscow in an effort to weaken Russia's war economy.

Graham revealed in an interview on Sunday that the bill has gained significant bipartisan support, with 84 co-sponsors in

the Senate. The proposal would authorize the U.S. President to levy steep tariffs on imports from nations still doing business with Russia, especially those buying oil and other critical goods. "India and China buy 70% of Putin's oil. They keep his war machine going," Graham told ABC News.

The bill is expected to be introduced in August and represents a major shift in U.S. foreign policy tactics as the war in Ukraine drags on. President Trump, who previously hesitated on expanding sanctions against Russia, reportedly endorsed the legislation during a golf outing with Graham. "It's time to move your bill," Trump allegedly told the senator. Though initially delayed nomic and diplomatic backlash.

Pakistan Confirms Another Polio Case, Raising 2025 Tally to 14

Pakistan has reported another case of poliovirus, bringing the total number of infections in the country to 14 so far in 2025. The latest case involves a 19-month-old boy from North Waziristan in Khyber Pakhtunkhwa province, according to officials at the Regional Reference Laboratory for Polio Eradication at the National Institute of Health (NIH) in Islamabad.

With this new case, the number of reported polio cases in Khyber Pakhtunkhwa has increased to eight. Sindh has reported four cases, while Punjab and Gilgit-Baltistan have recorded one each.

Pakistan remains one of only two countries

in the world—alongside Afghanistan where polio remains endemic. Despite consistent nationwide immunization campaigns, eradication efforts continue to face major obstacles, including security threats, vaccine hesitancy, and widespread misinformation.

This is the second polio case reported from Khyber Pakhtunkhwa within a week. On June 27, health officials confirmed that an 18-month-old child from the Union Council Amakhel in the Tank district had also contracted the virus.

In an effort to eliminate polio, Pakistan has conducted three nationwide vaccination drives in 2025—in February, April, and May. The most recent campaign aimed to immu-

nize around 45 million children under the age of five.

Polio is a highly infectious and incurable disease caused by the poliovirus, which primarily affects children under five. It can lead to permanent paralysis or even death. The only reliable protection is through multiple doses of the oral polio vaccine administered during routine and mass immunization drives.

Despite setbacks, the Pakistani government has reaffirmed its commitment to eradicating the disease by the end of this year. However, recurring attacks on health workers and law enforcement personnel guarding vaccination teams remain a serious challenge to the goal of a polio-free Pakistan.

Going to Washington next week to meet with **Trump: Netanyahu**

Israeli Prime Minister Benjamin Netanyahu announced on Tuesday that he will travel to Washington next week for high-level meetings with U.S. President Donald Trump and other American officials. The announcement came during a Cabinet meeting, where Netanyahu briefly outlined the agenda, highlighting a trade agreement as a central topic of

While Netanyahu did not provide further details about the proposed trade deal, the visit is widely seen as an opportunity to address a range of critical issues, especially the ongoing conflict in Gaza and the broader regional tensions involving Iran. The timing of the visit is particularly significant, as it comes amid increasing pressure from the international community, including the United States, for a de-escalation in the fighting between Israel and Hamas.

President Trump has recently indicated that the U.S. is ready to support efforts aimed at bringing the war in Gaza to an end. His administration has called for both sides to begin moving toward a ceasefire, signaling a shift in tone that could shape the diplomatic conversations between the two leaders.

Another key item on the agenda is Iran. Following the recent 12-day war between Israel and Iranian-backed forces, concerns over Tehran's growing influence in the region are likely to dominate much of the dialogue. Netanyahu has long viewed Iran as a strategic threat, and his visit to Washington is expected to reinforce the shared concerns of both nations over Iran's nuclear ambitions and regional activities.

As Netanyahu prepares for his U.S. visit, the stakes are high. The outcome of these discussions could play a significant role in shaping the trajectory of Middle East policy in the coming months, particularly regarding peace in Gaza and security challenges posed by Iran.

Thailand PM Paetongtarn Shinawatra **Suspended Over Leaked Call with Cambodian Leader**

Thailand's Prime Minister Paetongtarn Shinawatra was suspended from office on Tuesday by the Constitutional Court following a leaked phone call that sparked protests and political fallout. The call, made during sensitive diplomatic talks with Cambodian Senate President Hun Sen, triggered an ethics investigation and widespread public backlash.

The Constitutional Court unanimously agreed to take up the petition accusing Paetongtarn of breaching ethical standards, and voted 7-2 to suspend her from official duties while the case proceeds. She has been given 15 days to present her defense.

The controversy intensified after a deadly border clash on May 28 left one Cambodian soldier dead. In the leaked call, Paetongtarn was heard making conciliatory remarks that critics say undermined Thailand's national interest. The fallout has fueled growing dissatisfaction over her handling of the border dispute and led to large-scale protests in Bangkok by conservative, nationalist groups.

Following the court's decision, Paetongtarn said she respects the judicial process and is determined to defend her actions. "My only intention was to prevent escalation and protect our troops from harm," she stated. "If my words caused misunderstanding, I truly apologize."

Deputy Prime Minister Suriya Jungrungruangkit is expected to assume the role of acting prime minister, although an official announcement is still pending.

Earlier the same day, King Maha Vajiralongkorn approved a Cabinet reshuffle after a key coalition partner, the Bhumjaithai Party, exited the government over the controversy. The reshuffle removed party leader Anutin Charnvirakul from the deputy prime minister post. Paetongtarn had recently added the role of culture minister to her portfolio, though her future in that post is uncertain.

She also faces a separate ethics investigation by the National Anti-Corruption Commission, which could further jeopardize her political career.





Rupee Falls 9 Paise to Close at 85.68 Against U.S. Dollar **Amid Market Caution and Rising Oil Prices**

The Indian rupee weakened by 9 paise to settle at 85.68 (provisional) against the U.S. dollar on Wednesday, July 2, 2025. 'I Can't Stay Silent Anymore': Former Zepto Employee Exposes **Food Safety Violations**

Quick-commerce start-up Zepto is under fire after a former employee exposed alarming food safety violations and poor working conditions, prompting public outrage and regulatory action. The revelations come as the Maharashtra Food and Drug Administration (FDA) has already suspended Zepto's food business license in Mumbai's Dharavi for breaching hygiene and safety standards.

The whistleblower, who claims to have worked at Zepto for three years, detailed disturbing practices in a now-viral Reddit post. "I can't stay silent anymore," the post begins. One specific instance de-

scribes expired Greek yogurt being knowingly delivered to a customer after management allegedly said, "Give it anyway."

The employee paints a grim picture of daily operations, including packing groceries in monsoon-flooded warehouses in Pune, often filled with gutter water. "We worked more than 9 hours in that dirty water without shoes. Many of us fell sick, but no medical compensation was given," the post reads. Damaged fruits, rotting vegetables, and expired products, the employee claims, were routinely packed and sent to customers.

Public reaction has been swift. Several social media users shared their own experiences with delayed deliveries, spoiled groceries, and



lack of customer support. "These apps were supposed to make life easier—now they're just unreliable," one user commented. Others pointed to competitors like Blinkit and Big-Basket as better alternatives.

Earlier this month, a raid by the Maharashtra FDA on a Zepto facility found fungal contamination on food, poor cold storage, and generally unsanitary conditions—leading to the license suspension.

The incident raises serious concerns about food safety in India's booming quick-commerce sector. While Zepto has yet to issue a detailed public response, calls for greater regulation and consumer transparency are growing louder in light of the controversy.

Woman Wears Makeup Daily for 22 Years, Suffers Severe Skin Damage



Chinese woman's shocking skincare journey Ahas gone viral after she revealed the devastating effects of wearing makeup every single day for 22 years—without ever properly removing it. Known online as Niuyoumian, the 37-year-old from China's Jilin province shared her painful story, drawing attention to the long-term risks of poor skincare and heavy cosmetic use.

In a video widely circulated on social media, Niuyoumian appears with visibly inflamed, red, and swollen skin—symptoms of what she refers to as "hormone face," a chronic skin condition caused by prolonged exposure to cosmetic chemicals and inadequate cleansing routines.

According to South China Morning Post, her skin problems began as early as age 14 after using an unsuitable acne cream. By 15, she was wearing makeup daily and continued the habit for over two decades. Working in the beauty and hair industry, she was also regularly exposed to strong salon chemicals. Using inexpensive, low-quality foundations only worsened her condition.

Despite suffering early signs like redness and itching, she ignored them. "I thought it could be fixed with some ointment," she admitted. "But after 25, everything changed."

Niuyoumian eventually turned to facial injections in 2011, hoping to improve her skin. However, these treatments backfired, further damaging her complexion. She has since been diagnosed with rosacea and Demodex mite infestations. "At its worst, it felt like ants crawling on my face,"

Reflecting on her journey, she acknowledged that her impatience and constant switching of skincare products only made things worse. Now, with nearly 30,000 followers, she urges others: "Don't blindly trust beauty products just because someone else says they work."

Her experience has sparked widespread discussion online about responsible makeup use, the importance of proper skincare, and the hidden costs of beauty standards.

Ramen Lovers Stunned as **Cancer Warning** Found on Instant **Noodle Packet**



Aviral video has sparked widespread concern among ramen lovers after revealing a shocking warning label printed on an instant noodle packet. The label read: "Warning: Cancer and Reproductive Harm," leaving many stunned and questioning the safety of their favorite go-to snack.

The video, posted on Instagram by a concerned user, shows him flipping over the back of the ramen packet and pointing to the printed warning. "I eat this all the time," he said, clearly in disbelief. The clip quickly gained traction online, with viewers flooding the comments section with reactions ranging from confusion to alarm.

Ramen noodles have long been a staple for students, busy professionals, and anyone looking for a quick, affordable meal. But this video is making people take a hard look at the ingredients and manufacturing standards behind these convenient packets.

Nutrition expert Cara Harbstreet weighed in on the matter, explaining that most packaged instant noodles rely heavily

on sodium, preservatives, and artificial flavor enhancers for taste. "Many instant noodle products contain chemicals that, in large quantities or over time, may pose health risks. Labels like these are mandated under specific regional laws to inform consumers," she said. In the United States, such

warnings often appear due to California's Proposition 65, which requires products containing certain chemicals to carry notices about potential cancer or reproductive risks. This doesn't necessarily mean the product is unsafe in standard consumption levels, but it does highlight the presence of certain flagged substances.

While the warning may be routine in some regions due to regulatory policies, the video has ignited debates over food transparency, health risks, and the need for clearer consumer education on packaged foods. As the discussion continues, health experts urge consumers to enjoy instant noodles occasionally and balance them with a nutritious, whole-foodbased diet.

Brain's Built-In Signal Threshold Helps Distinguish Imagination from Reality

New research reveals that the brain uses a built-in "signal threshold" to differentiate between real visual experiences and imagined ones. This discovery sheds light on how our minds distinguish reality from imagination and has important implications for understanding mental health conditions like schizophrenia, where this distinction often blurs. Scientists at University College London conducted a study using functional

MRI scans on 26 volunteers. Participants were shown diagonal lines on a noisy screen—sometimes real, sometimes imagined. When participants imagined lines that matched the expected visual input, they were more likely to report seeing something even if nothing was actually shown. This suggested that strong internal signals from imagination can trick the brain into perceiving something as real.



Both real and imagined visuals activated the fusiform gyrus, a key brain region involved in visual processing. However, the brain only recognized the input as "real" when the activity in this region passed a certain intensity threshold. Alongside the fusiform gyrus, the anterior insula—a region linked to decision-making—also became active, possibly acting as a "reader" that evaluates the strength of the visual

Lead researcher Nadine Dijkstra explained that although imagination stimulates the same brain area as real visuals, the signal generated by imagination is usually too weak to convince the brain that it is perceiving actual external input. Understanding this threshold system offers new insights into hallucinations and other mental health disorders that affect perception.

Experts say these findings represent a significant step forward in understanding how the brain monitors reality ver-

sus imagination. Future research will explore more complex visual stimuli and real-world perceptions, including faces and animals. There is also interest in whether brain stimulation techniques could enhance imagined perception or help address perception-related disorders.

This study provides a crucial foundation for unraveling the neural mechanisms behind how we experience and interpret





Jyothi Yarraji Suffers Knee Injury, Puts Season on Hold **Ahead of World Championships**



Tndia's top sprint hurdler Jyothi Yarra-**↓**ji has suffered a significant setback in her athletic career. The 25-year-old national record holder in the women's 100m hurdles announced on July 2, 2025, that she has sustained a knee injury during training, forcing her to pause her current season. The injury comes just months before the World Athletics Championships, scheduled to be held in Tokyo from September 13 to 21.

Yarraji took to social media to share the news with her fans and supporters. "Due to an unfortunate injury to my knee during training a few days back, I've had to put a pause on my season," she wrote. "I'm working with my medical team to assess my options and take a decision on the way forward. Injuries are part of an athlete's journey and I'm viewing this as just another hurdle I'm going to overcome soon. With all your support and blessings, I'll be back stronger."

Her coach, James Hillier, confirmed the severity of the injury to PTI, calling it a "freak" incident. "Unfortunately, she picked up a freak injury to her knee in training. It's pretty bad, so we are assessing our options at the moment," Hillier said, indicating that her participation in the World Championships may now be in doubt.

Yarraji, who recently clocked sub-13 seconds—a first for an Indian woman—has been a standout performer in Indian athletics. Her performances over the past two years have elevated her to one of the country's top track stars, with consistent results in international meets.

A recent Instagram reel posted by her titled "Athlete's life"—foreshadowed the incident, showing clips of her stumbles both in training and during competition. Fans and fellow athletes have poured in support as she begins her road to recov-

ferred position on the left flank. "We saw that giving him width allowed him to attack better from outside in," Alonso explained.

Defensively, Real Madrid displayed strong discipline, effectively shutting down Juventus's attacking threats. The team has now conceded just two goals across four matches in the tournament, highlighting a marked improvement in their defensive structure. With momentum on their side and Mbappe nearing full fitness, Real Madrid look poised for a strong run in the Club World Cup.



Interestingly, while the promotional campaign is officially for Sitaare Zameen Par—a remake of the Spanish film Champions, featuring a neurodivergent cast—the real subject of these appearances seems to be Khan himself. In one interview, he revealed regrets about being an absent parent. In another, he shared lesser-known personal details, like learning Marathi at 44, or naming one of his dogs 'Sundari.' He's confessed to eloping with his first wife and even considered quitting acting after the failure of Laal Singh Chaddha. This new phase feels like a rebranding, perhaps in response to past controversies and online backlash, or simply a man at 60 becoming more comfortable in his own skin. His past remarks about growing intolerance in India led to widespread trolling and boycotts, and this new visibility could be seen as an attempt to reclaim his public image. Still, the authenticity in his voice and the vulnerability in his demeanor suggest something more heartfelt. Marketing or Meaning?

Cynics might view this transformation as a calculated marketing move, aligning Aamir's personal narrative with Sitaare Zameen Par's core message—"Sabka apna apna normal" (Everyone has their own normal). His public appearances, steeped in emotional honesty, reflect the same individuality and acceptance the film champions. Whether he's eating vada pav at Dadar station, acknowledging his complex relationships, or crying on camera, Aamir is redefining what stardom looks like one that allows space for flaws, feelings, and fallibility.

This strategy isn't new for Khan. Over the years, he's employed innovative promotional tactics—disguises during 3 Idiots, thematic haircuts for Ghajini, and even appearances on TV serials for Talaash. But this time, the promotional lens has turned inward.
