### 50th Amaravati CRDA Meet Clears Land, **Roads, Convention Centers**

- 20,494 acres cleared for acquisition in **Amaravati**

The 50th meeting of the Capital Region Development Authority (CRDA) was held under the chairmanship of Andhra Pradesh Chief Minister N. Chandrababu Naidu at his residence, where seven key proposals aimed at fast-tracking Amaravati's development were approved.

the meeting was the approval for acquisition of an additional 20,494 acres of land spread across four villages in Amaravati mandal and three villages in Thullur mandal. The CRDA also received approval to call for RFPs (Request for Proposals) for the development of high-density residential and mixed development zones on about 58 acres in Finance and Sports Cities at One of the major decisions taken in Mandam, Rayapudi, and Pichukalapa-

#### Amaravati Capital Work to Be Completed in 3 Years



Speaking after the meeting, Municipal Administration Minister P. Narayana stated, "Amaravati's construction will be completed in three years. Unlike the previous delays in 2018 due to master plan confusion, there will be no more doubts now." He also criticized the opposition, saying, "YCP leaders are creating objections in some villages, but their leader Jagan won't even win the 11 seats he currently holds." The minister assured that Amaravati will soon take shape as a world-class capital with planned progress.

The meeting gave a green signal for the construction of four new convention centers, each on 2.5 acres, to be located in Mandam, Thulluru, and Lingayapalem. These centers will be built on a QBS (Quality-Based Selection) basis near upcoming five-star hotels in the capital.



# Is This the Real Reason **Behind Pawan's Praise** for Babu?

- Repeated praise for CBN raises political curiosity
- Janasena grip loosening in coalition?
- · Internal buzz over Lokesh's growing influence

Andhra Pradesh: Deputy Chief Minister Pawan Kalyan's repeated praise of Chief Minister Chandrababu Naidu in every public meeting has sparked debate within political circles and even among his own party cadre. While his words highlight alliance unity, questions are now being raised over the intent and timing of his remarks — especially as internal speculation grows about his role and influence in the coalition government.

YCP leader and former minister Ambati Rambabu openly questioned Pawan's relevance in the administration. "What exactly is his role in governance? Does he even know what is going on in Andhra Pradesh?" he asked, accusing Pawan of surfacing only during public meetings to target YCP with no substantial intervention in governance matters.

This comes amidst growing speculation that Pawan's influence is shrinking, particularly when compared to the early months of the coalition government. Insiders point out that the Jana Sena chief has been restricting himself to his own department and appears detached from broader government affairs, fueling doubts over his confidence within the alliance.

Despite this, Pawan continues to praise Chandrababu's experience and vision, often reiterating that Naidu should become CM at least two more times. His statements have become more frequent, including during recent meetings like the Ongole Sabha, where his emphasis on unity and seniority took center stage.

Interestingly, even though Chandrababu Naidu had promised a ministerial post to Nagababu, the assurance has yet to materialize. Cabinet expansion plans remain on hold, and TDP sources suggest that no such move is imminent — adding to Jana Sena's unease. At the same time, there's an internal buzz within the TDP that Minister Nara Lokesh has quietly consolidated significant control over government operations, becoming a de facto "shadow CM", barring Pawan's portfolio. Party leaders reportedly acknowledge this in internal discussions, and TDP supporters are already promoting Lokesh's rising stature on social media.

This shifting dynamic has not gone unnoticed within the Jana Sena. Why is only Pawan constantly praising Chandrababu, while TDP leaders remain silent about alliance camaraderie in their speeches? That's a question being quietly discussed among Jana Sena leaders, who are watching the evolving coalition balance with cautious concern.

As of now, Pawan's repeated emphasis on unity may reflect not just alliance loyalty, but a subtle assertion of presence and relevance within a rapidly centralizing government structure.

### Three Women in the BJP President Race — Who Will Make History?

- BJP likely to choose a woman national president for the first time
- Sitharaman, Purandeswari, and Vanathi Srinivasan in the top race
- Southern states strategy may drive final decision

With the BJP National President elections expected soon, buzz has intensified within political circles that the saffron party may choose its first-ever woman president — a historic move if it materializes. What's more interesting is that all the top contenders are from southern India, signaling a strategic shift towards strengthening the BJP's south-

According to sources, the announcement may come by the end of July, and the names doing the rounds include Union Finance Minister Nirmala Sitharaman, Rajahmundry MP and former Union Minister Daggubati Purandeswari, and Tamil Nadu MLA Vanathi Srinivasan.

#### Nirmala Sitharaman

A frontrunner in the race, Sitharaman has served as both Defence Minister and Finance Minister in Modi's cabinet. Her administrative experience and clean image, coupled with her Tamil Nadu roots, make her a strong choice — especially as the party looks to gear up for future battles in the South. Her name was reportedly discussed in a recent



high-level meeting chaired by BJP President J.P. Nadda and General Secretary B.L. Santosh, with RSS reportedly backing her candidacy.

#### Daggubati Purandeswari

The Rajahmundry MP, daughter of NTR and former Union Minister, brings her deep political lineage and a grasp of Andhra, Telangana, and Tamil Nadu politics to the table. Her strong oratory, experience, and appeal across key social communities are seen as her strengths. Her name has gained prominence in the internal party buzz, especially after the recent Lok Sabha victory.



# Kadapa Steel: Will The Promise Be Broken Again?

- CM and Minister Lokesh's deadline crosses with no action
- Foundation stones laid multiple times but no actual progress
- ₹500 Cr worth of earlier works still pending clearance

Andhra Pradesh: What happened to the much-publicized 'Kadapa Steel' promise? Is it turning into yet another unfulfilled assurance, just like the one made at the TDP Mahanadu? During the party's last Mahanadu, TDP National President and current Chief Minister Chandrababu Naidu clearly announced that the steel plant works in Kadapa would begin soon. On May 29, in the Assembly, he reiterated this commitment and assured that the steel plant work would officially begin within 10 days — setting June 12 as the firm date for commencement near Peddadandluru-Sunnapurallapally in Jammalamadugu constituency of YSR Kadapa district.

Even IT Minister and his son, Nara Lokesh, echoed the same date during a media interaction. However, it's been over a month since that deadline passed, and there has been no sign of any activity or ground-level progress in the region. The promised steel plant — a long-standing demand of the Rayalaseema people and a mandate in the AP State Reorganization Act — seems to remain once again

The Kadapa Steel Plant issue has seen foundation



stones laid twice already — first by Chandrababu Naidu himself in February 2018 at Kambaladinne, Mylavaram mandal, and later by the YSRCP government under the banner of YSR Steel Corporation. The latter even allocated 3,200 acres near Sunnapurallapalli and tied up with JSW Group to set up the steel plant at an estimated cost of ₹15,000 crore. However, even after the new TDP-led coalition came to power in 2024, no headway has been made.

With increasing construction sand rates becoming a concern, the CRDA has been granted permission to undertake sand dredging through the desiltation process above the Prakasam Barrage. Officials estimate around 159.54 cubic meters of sand will be needed in the next two years for Amaravati construction works.

Further, the CRDA approved land allocation of 65 acres to 16 key institutions including the CBI, Zoological Survey of India, Pullela Gopichand Badminton Academy, MSK Prasad Cricket Academy, and KIMS Hospital. A six-lane Railway Over Bridge (ROB) on the E-15 highway also received a nod, along with the proposed construction of memorials for freedom fighters Potti Sriramulu and Alluri Seetharama Raju.

The approvals granted in the 50th CRDA Authority meeting mark a major step forward in reviving Amaravati's development, with the government aiming to create a globally recognized capital city.

Several bills related to the earlier YSRCP-initiated infrastructure works remain pending. These include payments for a 7.5 km road, compound wall construction, SS tanks, water reservoirs, and the supply pipeline project from Brahmasagar, all amounting to around ₹500 crore. Another ₹150 crore was meant for additional support infrastructure including a dedicated railway line and water facilities — none of which have seen political will for continuation or revival.

Despite tall promises and repeated foundation stone ceremonies, the Kadapa Steel Plant remains a distant dream. The locals are beginning to question whether this project will ever see completion or if it will continue to serve as a political bait every election season. With the June 12 deadline long missed and no official response from the government, the people of Kadapa are left wondering: Will this promise made at Mahanadu be honored or abandoned like the ones before?

A lawyer and seasoned BJP leader, Vanathi represents Coimbatore South as an MLA and has served in various key roles in the party, including as the national president of BJP Mahila Morcha and as a member of the Central Election Committee. Having joined BJP in 1993, her consistent service and grassroots connect in Tamil Nadu are seen as valuable assets, and she too remains a serious contender for the top post.

If any of these leaders are chosen, the BJP will witness its first-ever woman national president, a significant moment in its history. More importantly, it reflects a larger political strategy — to strengthen the party's image among women voters and southern states, where it continues to seek deeper inroads.

As the date of the announcement nears, all eyes are on the BJP's top brass and the RSS, who will likely have the final say in this crucial decision.

# Telugu Woman Nominated for Top UN Telecom Post

In a moment of immense pride for Andhra Pradesh and India, Revathi Mannepally, a native of Sullurpet in Tirupati district, has been nominated as India's official candidate for the prestigious post of Director of the Radiocommunication Bureau in the International Telecommunication Union (ITU) — a United Nations agency. If elected, she will become the first woman ever to hold this coveted global position. The announcement was made by Union Communications Minister Jyotiraditya Scindia, who said, "Heartiest congratulations to Revathi, who has been nominated as the Indian candidate for the post of Director of the ITU Radio Communication Bureau for the period 2027–30. I sincerely wish her success and take India's vision to the world stage." The election for the post will take place in 2026. Revathi's journey is a remarkable one — from becoming the first engineer from her hometown to now being in contention for one of the most influential roles in global telecommunications. A B.Tech graduate from JNTU Hyderabad, she began her career at SHAR (Sriharikota) as an engineer. She played vital roles in the ASLV and PSLV missions before moving to BARC (Bhabha Atomic Research Centre) as a scientist. Over the last few years, Revathi has been an influential voice in the global telecom arena. Currently, she is a member of the International Radio Regulation Board (IRRB) in Geneva and serves as Joint Wireless Advisor in India's Department of Telecommunications.

# How Did the Terrorists Find a Place in Rayachoti?

Sleeper cell suspects arrested after years of undetected presence in the peaceful Andhra town

Annamayya: Shock and disbelief continue to grip Rayachoti in Annamayya district after the arrest of two long-hidden Al Ummah terrorists who had quietly lived in the town for decades. Their sudden capture has triggered serious questions: How did they go undetected for nearly 30 years? How did they win the trust of locals while allegedly plotting major terror acts, including attempts to bomb BJP veteran L.K. Advani? The arrest of Abubakar Siddique and Mohammed Ali, who were living under the aliases Amanullah and Manjud, has exposed an unsettling truth — that this quiet Rayalaseema town may have inadvertently turned into a shelter zone for a terror sleeper cell.

#### **Terrorists Among Us?**

Like in Puttur, Chittoor district—where two suspects linked to the same Al Ummah network were arrested in 2013—Siddique and Ali operated under the guise of everyday businessmen. Siddique ran a small clothing business while Ali managed a retail shop, blending seamlessly into the town's social fabric. Locals, many of whom are Tamil-speaking Muslims or small traders with Gulf connections, never suspected their true identities.

What's more chilling is their methodical approach: building families by marrying local women, running businesses, and participating in community life. These men weren't just hiding — they were embedding themselves.

### Puttur Case Was the First Clue

This latest breakthrough is reportedly linked to the arrest of Fakhruddin, a known Al Ummah operative, in Tamil Nadu in 2013. His interrogation led to a massive 11-hour operation in Puttur, which resulted in the arrest of Bilal Malik and Ismail alias Munna. During that time, intelligence agencies also flagged the names of Siddique and Ali — but they had already vanished.

Now, investigators believe they relocated to Rayachoti shortly after the Puttur raid, identifying it as a low-profile, safe environment for continuing their







covert activities.

#### Why Rayachoti?

Rayachoti's demographic profile may have made it an appealing hideout. With one of the highest Muslim populations in Andhra Pradesh, a sizeable Tamil-speaking community, and a local economy driven by small business and overseas jobs, the town offered the perfect cover. The general peace in the region and absence of communal tension in recent years may have further emboldened the fugitives.

Yet, that very harmony also became the blind spot—allowing wanted terrorists to live freely under false names for decades.

## How Were They Finally Caught?

The arrests didn't happen by chance. According to police sources, it was a coordinated surveillance operation by the Intelligence Bureau (IB) and the Tamil Nadu Anti-Terrorism Squad (ATS) that led to their downfall. Officers monitored the duo in disguise for several weeks, comparing their movements with old photos and records.

The critical moment came when a suspicious courier parcel arrived for one of the suspects. The surveillance team

acted swiftly, verified the identity through the courier office, and alerted anti-terror units. In a joint operation with local police, both men were taken into custody without resistance.

# How Deep Is The Network?

The Rayachoti arrests raise a grim question: how many more sleeper cells are operating in the shadows of Andhra towns, particularly in Rayalaseema and regions bordering Tamil Nadu? Investigators fear this may be just the tip of the iceberg, especially given confirmed links to earlier bombing plots in Tamil Nadu and Karnataka.

While police sources confirm that questioning is underway and further arrests may follow, it is clear that sleeper cells may be operating under long-term, well-integrated strategies—biding their time, awaiting orders, and maintaining absolute secrecy.

The challenge now is to uncover the full extent of this network—before another attack is planned.

"This isn't just about Rayachoti," a senior police official said. "This is a reminder that terrorism doesn't always come with a warning. Sometimes, it hides in plain sight."

# GST Data Sharing Between States

**Payyavula Urges**

Andhra Pradesh Finance Minister Payyavula Keshav has made a significant proposal at the national level, advocating for inter-state sharing of GST-related information to combat tax evasion more effectively. He made this suggestion during a meeting of the Committee of State Finance Ministers on GST, held in New Delhi on Friday. Keshav participated in the meeting virtually from the Anantapur Collectorate. Addressing the gathering, the minister emphasized that mutual cooperation between states in sharing data is essential to detect and stop fraudulent practices in the GST system. He stressed that if one state has access to GST data from another, identifying tax evasion patterns becomes easier and enforcement can be streamlined. Keshav said Andhra Pradesh is actively advocating for this approach at the national lev-

In his presentation to the committee, the minister showcased a PowerPoint briefing on the state's latest efforts to curb tax evasion. He highlighted the success of an AI-powered application developed exclusively for GST officers in Andhra Pradesh, which is already delivering positive results. He explained how the app helps detect irregularities and supports enforcement teams in taking swift and accurate action. Keshav's pitch received attention from other members of the committee as a potential model for technological integration and transparency in GST administration. His recommendations are expected to be discussed further in upcoming rounds of consultation between states and the central government.

# Flood Flow Rises in Krishna River

Due to continuous rains in the upper catchment areas, the flood flow in the Krishna River has significantly increased, raising alert levels at major reservoirs. Authorities report that 1.2 lakh cusecs of inflow from the Jurala project is currently reaching the Srisailam reservoir, leading to increased outflows downstream. To manage the rising water levels, officials are releasing a total of 67,000 cusecs from Srisailam towards Nagarjunasagar. Of this, 35,000 cusecs are being discharged through the left bank power station, while 31,000 cusecs are flowing from the right bank power station — all through power generation units.

The water level at Srisailam has now reached 873.90 feet, compared to its maximum capacity of 885 feet. As of now, the reservoir holds 172.66 TMC of water, nearing its full storage capacity of 215 TMC.

Officials continue to monitor inflows and storage closely as further rainfall in upstream regions could push the levels higher. Authorities are urging downstream regions to stay alert and are coordinating flood management measures as a precaution.

# CM Finalizes Swarnandhra P-4 Logo

Chief Minister N. Chandrababu Naidu has officially finalized the logo of the Swarnandhra P-4 initiative, marking a significant step in the implementation of his flagship vision. The decision came during the first general body meeting of the Swarnandhra P-4 Foundation, held via Zoom on Friday.

During the meeting, CM Naidu directed the formation of two dedicated committees to supervise the implementation of the P-4 scheme. These committees will operate at both district and constituency levels, and include in-charge ministers, MPs, public representatives, and key officials as members. Their responsibility will be to oversee execution and ensure accountability at all levels.

Naidu highlighted Bapatla district as the frontrunner in implementing the P-4 scheme effectively. He urged officials and



leaders to expedite efforts to identify 15 lakh golden families and appoint one lakh mentors by August 15.

When some MLAs expressed concerns about public confusion regarding the scheme, CM Naidu offered a firm clarification. "P-4 will not reduce or replace welfare schemes. It will be an addition to our existing welfare programs," he assured. He instructed leaders and offi-

cials to actively counter misinformation and to explain the scheme's goals clearly to the public.

He further emphasized the need for guides and mentors to provide timely and continuous support to golden families, aligning with the government's broader vision of empowerment and prosperity.

The Swarnandhra P-4 scheme, which stands for Public-Private-People-Partnership, is a core component of the TDP government's development agenda for a future-ready Andhra Pradesh.



#### **Govt Targets Mango** TDP Cracks Widen in Srisailam **Farmers Ahead of**

Bhumana accuses govt of suppressing farmers to sabotage YSRCP meet

Jagan's Visit

Tirupati: YSR Congress Party senior leader and former TTD Chairman Bhumana Karunakar Reddy has strongly criticized the Andhra Pradesh coalition government for harassing mango farmers in Chittoor district, alleging that the motive is to sabotage former Chief Minister Y.S. Jagan Mohan Reddy's upcoming visit to Bangarupalyam

Speaking at the YSRCP camp office in Tirupati, Bhumana claimed that the government is trying to intimidate farmers, spread false rumors about the cancellation of Jagan's visit, and discourage public participation. He condemned the administration for turning a blind eye to the severe losses faced by mango farmers, many of whom, he said, are on the brink of destroying their own orchards in despair.

He cited the case of T. Kumar, a farmer from Tumindagu village, who was fined ₹12,750 by forest officials for cutting down 16 mango trees after suffering heavy financial losses. "This is the kind of cruelty this coalition regime is showing—punishing farmers instead of helping them," said Bhumana.

Drawing a contrast with Karnataka, where the NDA government ensured farmers received ₹16 per kg, Bhumana alleged that in Andhra Pradesh, only fake meetings with pulp factories were being conducted, with no actual support on the ground.

He confirmed Jagan's visit will proceed as planned and said no attempt to block or intimidate the farmers would work. "No threat, no police denial, and no case can stop Jagan from standing by farmers," he said, adding that the YSRCP has already requested the district collector to provide necessary security arrangements.

Bhumana also took aim at Deputy CM Pawan Kalyan, calling his recent statements baseless and politically motivated, and said the government should focus on supporting farmers instead of suppressing dissent.

"The farmers will speak to Jagan directly. The coalition's tactics to silence them only expose its failures," Bhumana warned, reiterating the YSRCP's unwavering stand on defending farmers' rights.



# **Pedda Reddy Seeks Fresh Permission to Enter Tadipatri**

Former MLA writes to SP Jagadish amid HC orders backing his visit

Tadipatri politics have flared up once again with former MLA and YSRCP leader Kethireddy Pedda Reddy making a renewed attempt to enter the town. As part of his party's campaign 'Recalling Chandrababu Manifesto', Pedda Reddy has written a fresh letter to Anantapur SP Jagadish requesting permission to visit Tadipatri, sparking political speculation.

The renewed request has once again pushed the spotlight on the ongoing restrictions against Kethireddy, even though the Andhra Pradesh High Court had earlier ruled in his favor. On April 30, the High Court had clearly stated that there were no legal hurdles to his entry and that adequate police protection should be provided during his

Despite the court's directive, previous efforts by Kethireddy to enter Tadipatri had failed, leading to intense criticism from his supporters. Now, with his latest appeal to the police administration, pressure is mounting on the authorities to respond in line with the High Court's rul-

YSRCP sources claim that party chief Jagan Mohan Reddy is determined to proceed with the public campaign, especially in strongholds like Tadipatri, where TDP influence remains significant through leaders like JC Prabhakar Reddy. Interestingly, political observers point out that Kethireddy now faces a situation very similar to what JC Prabhakar Reddy experienced during YSRCP rule, when he too was restricted from entering Tadipatri.

The police department has yet to respond officially to the letter, but local political circles are abuzz with speculation over whether Pedda Reddy will finally be allowed entry or face resistance once again. With the YCP's 'Recalling Chandrababu Manifesto' campaign gaining traction, the outcome of this issue could have wider implications in the district's political landscape.

Naidu summons both leaders to Amaravati

The internal tussle between senior Telugu Desam Party (TDP) leaders in Srisailam constituency has escalated to the party high command. Tensions between Srisailam MLA Budda Rajasekhar Reddy and Nandyal MP Byreddy Sabari have reached a flashpoint following a controversial event conducted without coordination.

MP Byreddy Sabari recently held a program in the constituency in association with former minister Erasu Pratap Reddy. Notably, the local MLA, Budda Rajasekhar Reddy, was not invited or informed about the event, sparking a rift between the two



factions. The incident has led to speculation about group politics intensifying within the constituency unit.

Following the event, both the MP

and MLA have reportedly submitted complaints against each other to the TDP leadership. The issue quickly caught the attention of the party's top brass,

with TDP state president Palla Srinivasa Rao stepping in and directing both leaders to present themselves before the party

Party sources confirmed that both leaders have been summoned to Amaravati to meet Chief Minister and TDP national president N. Chandrababu Naidu. The high command is keen to address the infighting before it further affects the party's image and unity in the region. The incident has sparked concerns among local party cadres, who fear that the open discord between senior leaders may hinder developmental coordination and electoral strategy ahead of upcoming polls.

### **Dalit MPTC Insulted by YSRCP** Sarpanch in East Godavari

Sarpanch objects to MPTC sitting beside him in meeting

East Godavari: Tensions flared in Dammennu Gram Panchayat of Undrajavaram Mandal in East Godavari district after a YSR Congress Party sarpanch allegedly insulted a Dalit MPTC member during an official panchayat meeting. The incident, which sparked public outrage, led to a dramatic protest and ended with the sarpanch issuing a public apology.

According to sources, Sarpanch Gurajala Satyanarayana objected to MPTC Geddam Ramakrishna sitting next to him during a gram panchayat meeting on Friday. He reportedly ordered the secretary to remove the chair placed next to him, stating that the MPTC should not sit beside the sarpanch and the meeting would not prohim. When questioned by TDP and Jana Sena ward members present, they pointed out that Ramakrishna was also elected by the people and was from the same YSRCP party. Deeply hurt by the incident, Ramakrishna walked out of the meeting, holding a portrait of Dr. B.R. Ambedkar, and launched a protest on the Tanuku–Rajahmun– dry main road. He alleged that the sarpanch's actions were rooted in caste discrimination,



stating, "How can a Dalit MPTC be insulted like this in today's society?" The protest disrupted traffic, and a large number of people from the Dalit community gathered in support.

As tensions rose, members of the community dragged the sarpanch out of the panchayat office and demanded a public apology. The police arrived to control the situation, and the ceed unless he stood next to sarpanch offered to apologize privately inside the office. However, the protesters insisted on a public apology.

> Later, officials including Tahsildar P.N.D. Prasad and MPDO V.V.V.S. Ramarao intervened. The Tahsildar told the sarpanch that his actions were inappropriate and urged all parties to resolve the matter peacefully. The sarpanch then publicly apologized to Ramakrishna in the presence of the villagers, officials, and police.

# Man Attempts Suicide After Alleged Harassment by SI

Consumed deworming medicine after police humiliation Family rushes him to Mangalagiri AIIMS in critical condition Victim's family demands action against SI and ASI

NTR District: A disturbing incident occurred under the jurisdiction of Ibrahimpatnam Police Station, where a young man attempted suicide by consuming deworming medicine, reportedly after being humiliated and scolded by police officials, including the Sub-Inspector and Assistant Sub-Inspector.

According to sources, Vemula Gopi Chand, a resident of Ibrahimpatnam, had ongoing marital issues with his wife Tammisetti Harika. On Friday night, relatives from Harika's side visited Gopi's residence and allegedly verbally abused and physically attacked him. In restation to lodge a verbal complaint.

However, Sub-Inspector Phanindra and an ASI, instead of registering his grievance, allegedly humiliated Gopi and hurled abuses at him in front of others.

Feeling distressed and insulted, Gopi is said to have consumed deworming tablets in an attempt to take his own life. As his condition deteriorated, family members immediately shifted him to AIIMS Mangalagiri, where he is currently undergoing treatment and said to be in a critical state.

Following the incident, Gopi's family members rushed to the Ibrahimpatnam police station, demanding accountability and action against the SI and ASI, whom they hold responsible for pushing Gopi to the brink.

The incident has sparked outrage among locals, with many questioning the insponse, Gopi approached the local police sensitive handling of domestic issues by law enforcement officers. # **CPI Protest in Nandigama Against Power Tariff Hike**

The Communist Party of India (CPI) staged a strong protest at the Nandigama Electricity Office today as part of a statewide agitation demanding immediate relief from what it termed an "unjust burden" on the people due to increased power tariffs and smart meter installations. Protesters, raising slogans against the state government, condemned

the imposition of Rs. 15,485 crore in electricity adjustment charges in just one year of the coalition regime. CPI leaders claimed that these charges have severely affected the common man and accused the government of siding with corporate interests.

CPI leaders vowed to continue their agitation until the smart meter project is scrapped, the tariff hike is reversed, and all anti-people electricity agreements are cancelled.

## **Cease the Cess: Time for Structural Reforms in India's GST System**



As India marks the eighth anniversary of the Goods and Services Tax (GST) on July 1, 2025, the latest data highlights a pressing concern: GST collections have hit their lowest point in months. June's collections stood at ₹1.85 lakh crore, showing a mere 6.2% increase over June 2024 — the slowest growth in four years. When adjusted for refunds, actual government revenue grew by only 3.3%. Domestic transaction revenues, excluding imports, increased by just 4.6%, barely outpacing inflation. Since GST is a consumption-based tax, such sluggish growth signals not only a slowdown in economic activity but also points to inefficiencies within the tax system itself.

Eight years after its launch, GST needs significant structural reforms to regain momentum and fulfill its promise of simplifying India's complex tax landscape. One long-standing demand is the inclusion of fuel under GST. However, States resist this move as fuel and alcohol remain among the few independent revenue sources they control. While this concern is valid, it cannot indefinitely justify excluding these major items from GST, especially when the principle of 'one nation, one tax' remains unfulfilled. To offset any revenue loss, the Centre should consider increasing States' share in central taxes, fostering trust and cooperation. At the same time, the Centre must reduce its reliance on non-shareable cesses, and States should avoid using additional funds for populist freebies.

Another overdue reform is the rationalization of GST rates. The GST Council's committees are already exploring options to reduce the number of tax slabs, which would simplify compliance and administration. Connected to this is the future of the GST Compensation Cess, levied above the highest 28% slab. Originally meant to compensate States for revenue losses during GST rollout, and extended until March 2026 to cover pandemic-related shortfalls, this cess has served its purpose. The Centre should resist subsuming this cess into regular GST rates and instead abolish it altogether. Removing the cess would not only be a goodwill gesture to taxpayers but could also stimulate much-needed urban consumption. GST is a pact not only between the Centre and the

States but also with the people. It is time to honor that covenant with meaningful reforms that enhance transparency, fairness, and efficiency.

### The Hidden Mental Health Risks of AI Chatbots: Psychotic Episodes and Declining Critical Thinking

As AI platforms like ChatGPT become increasingly integrated into professional and personal lives, troubling mental health concerns are emerging. Recent reports suggest that heavy reliance on AI for tasks may be eroding critical thinking skills and motivation among users. More alarmingly, some individuals are experiencing severe psychological effects, including psychotic episodes, after extended interactions with chatbots.

Meetali Jain, a lawyer and founder of the Tech Justice Law project, has recently been contacted by over a dozen individuals who reported delusional episodes or psychotic breaks linked to their use of ChatGPT and similar AI platforms. Jain is currently leading a lawsuit against Character.AI, alleging that its chatbot manipulated a 14-year-old boy through deceptive, addictive, and sexually explicit conversations, contributing to his tragic suicide. The lawsuit seeks damages and changes to the company's practices to prevent similar harms.

Google, which provides foundational technology and infrastructure to Character.AI, has denied a significant role in the development of the chatbot's technology. However, Google has not commented on the increasing reports of psychotic episodes connected to chatbot usage. OpenAI, the creator of ChatGPT, has stated that it is working on automated tools to identify and mitigate harmful interactions but acknowledges that the company has yet to find effective ways to alert users who might be experiencing severe mental health crises during their use of AI.

OpenAI CEO Sam Altman recently admitted



that while ChatGPT has issued warnings to users in distress in the past, these alerts often go unheeded or misunderstood. The company is still grappling with how to recognize and respond to signs of users being "on the edge of a psychotic break."

The growing anecdotal evidence highlights a critical gap in understanding and managing the psychological impact of generative AI. As these technologies become more private and pervasive, addressing the mental health risks they pose is becoming an urgent challenge for developers, regulators, and users alike.

The state-run Public Service Media (PSM) reported that both leaders had a constructive conversation, aligned with the ongoing momentum to strengthen bilateral engagement.

Minister Saeed later posted on X (formerly Twitter), saying, "Had a productive meeting with India's Commerce Secretary Sunil Barthwal. We discussed strengthening trade and investment partnerships and exploring new avenues for economic cooperation."

In a reciprocal statement, India's Department of Commerce said the talks aimed at "enhancing trade and investment ties and discovering fresh economic opportunities."

The Maldives has been actively seeking Indian investments, and recent business forums were held in three Indian cities to showcase economic potential in the island nation. India, meanwhile, continues to be a key development partner, contributing to several infrastructure, capacity-building, and financial assistance projects — including a \$25.94 million currency swap facility to support the Maldivian economy.

The meeting follows earlier discussions held in May 2025 during the Maldivian Foreign Minister Abdulla Khaleel's visit to New Delhi, which focused on implementing the Comprehensive Economic and Maritime Security Partnership agreed upon during President Mohamed Muizzu's visit to India in October 2024.

Despite early tensions after Muizzu's election in late 2023, both nations are showing signs of resetting bilateral ties, with the Maldives reaffirming its strategic importance in India's 'Neighbourhood First' policy and Vision MAHASAGAR (Mutual and Holistic Advancement for Security and Growth Across Regions).

# **EPS Launches New AIADMK Logo, Begins** 2026 Campaign with Fierce Attack on DMK

AIADMK General Secretary Edappadi K. Palaniswami (EPS) kicked off the party's campaign for the 2026 Tamil Nadu Assembly elections by unveiling a new party logo and the slogan: "Protecting People, Redeeming Tamil Nadu." The launch marks the beginning of a state-wide tour where EPS plans to visit all 234 Assembly constituencies, focusing on local issues and reaching out directly to voters. At the event held Friday, EPS

EPS also made a strong appeal to "like-minded parties" to join forces against the DMK, signaling efforts to build a broader opposition alliance. This comes



amid speculation following actor Vijay's announcement that his party, Tamilaga Vettri Kazhagam (TVK), will not ally with the BJP. When asked about Vijay distancing himself from the NDA, EPS responded, "That is his decision. In politics, parties will criticize each other — it's natu-

On Union Minister Amit Shah's

comment that the next Chief Minister will be from AIAD-MK, EPS confidently asserted his leadership, saying, "Amit Shah has made it clear from day one — AIADMK will lead the alliance, and I will be the Chief Minister."

Despite AIADMK's setbacks in the 2019 and 2021 elections and a poor showing in 2024, EPS remains confident of a revival, especially after rekindling the alliance with the BJP.

Meanwhile, the DMK has launched its own mass enrolment drive under the "Tamil Nadu Under One Team" campaign, targeting 30% voter registration ahead of what promises to be a high-stakes political contest in 2026.

# **India Ranked Fourth Most Equal Country** in the World: World Bank Report

India has emerged as the fourth most equal country globally, according to the latest World Bank report, marking a significant milestone in the nation's economic and social journey. The report highlights a sharp

decline in inequality and a dramatic reduction in extreme poverty over the past decade.

Between 2011-12 and 2022-23, India's Gini Index — a key measure of income and consumption inequality — improved from 28.8 to 25.5, placing it just behind the Slovak Republic, Slovenia, and Belarus. This places India well ahead of countries like China (35.7), the USA (41.8), and the UK, in terms of equality. The Gini Index measures inequality on a scale from 0 (perfect equality) to 100 (complete inequality). India now falls under the "moderately low inequality" category, which includes Gini scores between 25 and 30, and is just a fraction away from entering the "low inequality" group.

Alongside this progress, extreme poverty in India has also seen a steep fall—from 16.2% in 2011-12 to just 2.3% in 2022-23. According to the report, 171 million Indians have been lifted out of extreme poverty in this period.

The government attributed these gains to a range of targeted welfare schemes such as PM Jan Dhan Yojana, Direct Benefit Transfer (DBT), Ayushman Bharat, and Stand-Up India, which have improved financial inclusion, healthcare access, and self-employment.

"This Gini Index score isn't just a number; it reflects real improvements in people's livesaccess to food, healthcare, jobs, and banking," the official release stated. India's ability to blend economic reforms with inclusive growth has become a model for equitable development worldwide.

### **Bengaluru Court Bars Kamal Haasan From Remarks Against Kannada Language**

A Bengaluru court has issued an ex-parte interim injunction restraining veteran actor and politician Kamal Haasan from making any statements deemed derogatory or disrespectful toward the Kannada language, its literature, land, or culture. The court also prohibited him from making any claims of linguistic superiority over Kannada.

The Additional City Civil and Sessions Judge passed the order on Friday after hearing a suit filed by the Kannada Sahitya



Parishat (KSP), represented by its president Mahesh Joshi. The Parishat had sought legal intervention following Haasan's recent controversial comments that Kannada "was born out of Tamil," which were made during a promotional event for his upcoming film Thug Life. The remarks triggered widespread outrage among Kannada cultural organizations and pro-Kannada activists, who considered the

statement offensive and historically inaccurate.

In its plea, the KSP argued that Kamal Haasan's comments were defamatory and hurt the sentiments of Kannada-speaking people by undermining the significance and independent origins of the Kannada language. The court found merit in the plaintiff's plea and issued a temporary injunction to prevent further remarks of this nature.

Alongside the injunction, the court also directed the issuance of a summons to Kamal Haasan and scheduled the next hearing for August 30, 2025. The controversy has stirred emotions across Karnataka, where language and cultural identity hold deep significance. Several Kannada organizations have demanded a formal apology from Haasan, while others have called for a boycott of his film.



# **Trump Signs Tariff Letters to 12** Nations, Set for Release on July 7

U.S. President Donald Trump has confirmed that he has signed letters to 12 countries outlining new proposed tariff levels on goods exported to the United States. Speaking to reporters aboard Air Force One on July 4 while en route to New Jersey, Trump described the communications as "take it or leave it" offers, signaling a tougher trade stance as part of his administration's push to reset global trade terms in favor of U.S. interests.

# **BRICS Nations Set to Condemn Trump Tariffs at Rio Summit**

#### **Pakistan Open to Extraditing Key Individuals to India, Says Bilawal Bhutto**

In a significant statement hinting at a possible thaw in Indo-Pak relations, former Pakistan Foreign Minister Bilawal Bhutto Zardari has said that Pakistan has no objection to extraditing "individuals of concern" to India—provided there is a genuine willingness from New Delhi to engage in a broader dialogue.

Speaking to Al Jazeera during an interview on July 4, 2025, Bhutto said such actions could serve as confidence-building measures if approached through comprehensive diplomatic engagement. "As part of a comprehensive dialogue with Pakistan, where terrorism is one of the issues that we discuss, I am sure Pakistan would not be opposed to any of these things," said Bhutto, who currently serves as chairman of the Pakistan People's Party (PPP).

His comments came in response to questions about the possible extradition of notorious terror group leaders Hafiz Saeed (Lashkar-e-Taiba) and Masood Azhar (Jaish-e-Mohammad), both of whom are wanted in India for their alleged roles in major terror attacks. The Dawn newspaper also reported Bhutto's remarks, suggesting that such gestures could be interpreted as acts of goodwill if accompanied by reciprocal efforts from the Indian side.

The statement is noteworthy given the traditionally rigid stance of Pakistani leadership on matters related to cross-border terrorism and extradition. While Bhutto is no longer in office, his comments could reflect shifting political sentiment or a broader openness within sections of Pakistan's leadership toward constructive engagement with India.

Despite long-standing hostility, sporadic diplomatic efforts have continued over the years. However, trust between the two nuclear-armed neighbors remains fragile, largely due to unresolved issues like terrorism, Kashmir, and border disputes. Observers note that any progress on extradition or anti-terror cooperation would require firm commitments from both governments and the willingness to move past entrenched posi-

Fluent in English, Gujarati, and Hindi, Nehal Modi has already been named in charge sheets filed by the ED for destruction of evidence and for knowingly aiding Nirav in his financial crimes.

# Cement Demand to Grow 7-8% in FY26 Driven by Real Estate and **PMAY Push: Report**

nement demand in India is project-Led to grow between 7-8% in the financial year 2025-26, supported by strong real estate activity and government housing initiatives such as the Pradhan Mantri Awas Yojana (PMAY), according to a report by Axis Securi-

The report highlights that the ongoing momentum in the real estate sector, coupled with large-scale construction projects under various government schemes including PMAY, will continue to drive steady demand for cement—an essential material for housing infrastructure. Additionally, the government's focus on infrastructure development, reinforced by increased budget allocation for construction in FY26, is expected to further boost cement consumption.

After a modest start to FY25, with only 2-3% year-on-year growth in Q1, the cement sector saw a strong recovery in the second half of the year, expanding at a high single-digit pace in Q3 and Q4. For the full FY25, the sector recorded an overall growth of 4-5%. Core sector data also show an 8% year-on-year rise in cement output



during April-May 2025, driven by robust infrastructure and construction activities.

Historically, the last quarter of a financial year and the first quarter of the next tend to be peak periods for cement consumption. This seasonal trend is aided by favourable weather conditions, accelerated government infrastructure spending, and

increased real estate activity, all of which are expected to keep the growth trajectory intact in Q1 FY26.

In summary, the combination of government housing programs like PMAY, a resilient real estate market, and enhanced infrastructure spending underpins a strong outlook for cement demand in the coming year.

# Inflation Likely to Align with RBI Projections in Q1 FY26: Bank of **Baroda Analysis**

**T**nflation is expected to **⊥**remain consistent with the Reserve Bank of India's (RBI) forecasts in the first quarter (Q1) of the financial year 2025-26, according to a recent report from Bank of Baroda (BoB). This outlook is supported by a favorable statistical base and ongoing deflation in essential commodities, which together suggest subdued inflationary pressures in the near term.

The RBI's policy projections estimate Consumer Price Index (CPI) infla-

tion at 3.7% for FY26, with a quarterly breakdown of 2.9% in Q1, 3.4% in Q2, 3.9% in Q3, and 4.4% in Q4. The slower inflation rate expected in Q1 is largely attributed to easing prices in essential goods and improved supply conditions across key commodities.

Reinforcing this trend, the Bank of Baroda's Essential Commodities In-



dex (BoB ECI) showed deflation for the third consecutive month in June 2025, declining by 1.8% year-on-year—a sharper fall than the 0.6% dip recorded in May. This persistent deflation is mainly due to significant price corrections in vegetables and pulses, driven by increased production and better supply dynamics.

The report highlights that this ongoing deflation in essential commodities will continue to moderate overall inflation, providing relief to consumers and helping stabilize the cost of living. Since essentials form a large part of household expenses, their price moderation has a meaningful impact on inflation expectations.

Given these conditions, the RBI is expected to maintain a cautious stance in upcoming monetary policy deci-

sions, carefully monitoring inflation trends across both essential and discretionary items.

In conclusion, with a favorable supply environment and a supportive base effect, inflation in Q1 FY26 is likely to stay within the RBI's target range, indicating relative price stability during the quarter.

# **Unified Pension Scheme to Get NPS-Like Tax Benefits**

### **India Plans \$724 Million** Retaliatory Tariffs on U.S. **Imports Amid Trade Tensions**



**T**ndia has formally informed the **■**World Trade Organization (WTO) of its intention to impose retaliatory response to the United States' recent decision to raise tariffs on specific automobiles and automotive parts imported from India.

The Indian government justified the proposed suspension of concessions and obligations under WTO rules by citing the U.S.'s failure to hold prior consultations before increasing the tariffs. According to India, this breach of protocol gives it the right to withdraw equivalent trade benefits previously extended to the U.S.


# **Stranded UK Fighter Jet in Kerala Sparks Meme Fest - 'F-35B Nair Got Its PAN Card'**

In the women's draw, the tournament saw a major shake-up as several top seeds, including Australian Open champion Madison Keys, were eliminated early. Sabalenka remains the only player among the top six women's seeds still competing.

# Neeraj Chopra Wins Inaugural NC Classic with 86.18m Throw

Olympic champion Neeraj Chopra added another feather to his cap by winning the first-ever Neeraj Chopra (NC) Classic 2025 held at Bengaluru's Sree Kanteerava Stadium on July 5. Competing in front of a home crowd and his family, the 27-year-old threw 86.18 meters in his third attempt to clinch the title at the event he himself hosted.

Kenya's Julius Yego, the reigning 2025 World Champion, secured second place with a best effort of 84.51m, while Rumesh Pathirage of Sri Lanka came in third, just form. behind, with 84.34m.

This win marks Chopra's third straight victory in just over two weeks, following triumphs at the Paris Diamond League on June 20 and the Golden Spike in Ostrava, Poland, on June 24. In Ostrava, he threw 85.29m, showcasing consistent top-level


