AP-UAE Strengthen Economic Ties at Investopia Summit

At the Investopia Global Andhra Pradesh Summit held in Vijayawada, Chief Minister N. Chandrababu Naidu reiterated his commitment to transforming Andhra Pradesh into a global investment hub. He welcomed UAE Economic and Tourism Minister Abdulla bin Touq Al Marri, Lulu Group Chairman Yusuf Ali, and several global and Indian business leaders.

Naidu highlighted the strong Indo-UAE relationship and praised the UAE's development, especially Dubai's transformation into a global destination. Drawing parallels with the launch of Hyderabad's Hitec City, Naidu revealed ambitious plans to build Amaravati as a world-class green and knowledge city. He promised rapid project clearances and emphasized AP's use of digital governance, with over 550 services now accessible via WhatsApp. Naidu stated that Andhra Pradesh is targeting a \$2.4 trillion economy, and his administration is focused on Ease and Speed of Doing Business.

He also spoke about upcoming green hydrogen and ammonia export projects in Visakhapatnam and Kakinada, with vast potential in renewable energy, food processing, aquaculture, tourism, and aerospace. Naidu confirmed that Visakhapatnam would soon host



India's largest Google data center and that Amaravati will be home to a quantum computing valley by January 2026.

UAE Minister, Lulu Chairman Praise AP's **Potential**

UAE Minister Abdulla bin Touq Al Marri praised Andhra Pradesh as a progressive state that welcomes entrepreneurs and investors. He emphasized the UAE's longstanding friendship

with India, with \$250 billion in trade between the two nations. Marri noted that the UAE sees Andhra Pradesh as a key partner in sectors like AI, tourism, green energy, digital transformation, and food processing.

Lulu Group Chairman Yusuf Ali announced plans to build an ultra-modern shopping mall in Visakhapatnam and expand operations in food processing in Vijayawada.



Govt Launches ₹30,635 Cr Credit Plan for SHGs

Andhra Pradesh has chalked out an ambitious ₹30,635 crore annual credit plan to boost the economic development of 7.69 lakh Self-Help Groups (SHGs) across the state. Minister for MSMEs, Rural Poverty Alleviation, and NRI Empowerment KondaPalli Srinivas made this announcement during the conclusion of a two-day review and planning meeting with Project Directors and field officials of the Rural Development Department in Amaravati on July 23.

The minister said the state was advancing with the prestigious "Velugu 2.0" program under the National Rural Livelihoods Mission, targeting sustainable livelihoods and women-led entrepreneurship. As part of this initiative, 2.5 lakh women will receive individual bank loans during FY 2025–26 to establish manufacturing and service sector enterprises.

He emphasized that field-level officials, including PDs, DPMs, and APMs, must analyze agriculture-related activities in their districts and develop strategic plans to enhance farmers'

incomes. As part of this year's initiatives, ₹98.1 crore has been sanctioned to 350 Farmer Producer Groups (FPGs), with clear directives to utilize these funds transparently and effectively.

In addition, the minister instructed the SERP CEO to explore all options for social audits of fund utilization and take corrective actions accordingly. Under the NRETP scheme, egg carts worth ₹50,000 each have been distributed to beneficiaries in Guntur district, with a target of distributing 1,000 such units this year.

Minister Srinivas also stressed the need to strengthen women-led markets at the grassroots. Outstanding PDs from Chittoor, Tirupati, and Sri Sathya Sai districts were felicitated for efficient execution and promotion of these markets. Similarly, PDs from Anakapalli and Parvathipuram Manyam districts received mementoes for arranging exceptional photo exhibitions.

SERP CEO Vakati Karuna, Additional CEO Sriramulu Naidu, Agri Advisor T. Vijay Kumar, and directors and staff from various districts participated in the session.




PM Kisan funds on Aug 2

Big news for the farming community in India — the 20th installment of the Prime Minister Kisan Samman Nidhi (PM Kisan Yojana) is set to be credited on August 2. According to national media reports, Prime Minister Narendra Modi is expected to release the funds during a public meeting in Varanasi, scheduled for the same day. This release is part of the Central Government's ongoing support to farmers, where ₹2,000 is directly deposited into the accounts of eligible beneficiaries every four months. Previously, PM Modi had launched the 17th installment from Varanasi, making it a precedent for such announcements. Adding to the Centre's assistance, the Andhra Pradesh coalition government has also planned to release ₹5,000 in additional aid to its farmers. Thus, farmers in Andhra Pradesh are likely to receive a combined benefit of ₹7,000 in a single transfer on August 2 — ₹2,000 from the Central Government and ₹5,000 from the state government. The PM Kisan Yojana continues to serve as a crucial financial lifeline for small and marginal farmers across the country. With over 11 crore beneficiaries nationwide, the scheme aims to ensure a minimum level of income support for farming households.

Lokesh Invited to UAE for Strategic Talks

Andhra Pradesh is set to leverage the data revolution to attract global opportunities, according to Minister for Education, IT, and Electronics, Nara Lokesh. Speaking at the "Investopia Global – Andhra Pradesh" summit organized by the Economic Development Board at Novotel Hotel in Vijayawada, Lokesh emphasized that the state is preparing to be at the forefront of the digital economy. Lokesh highlighted the UAE's pioneering efforts in artificial intelligence (AI), being the first country to establish a dedicated Ministry of AI. He said Andhra Pradesh is keen to emulate the UAE's model to strengthen its own digital economy. With ambitious goals, the state economy in the coming years.

aims to evolve into a \$2.4 trillion During the summit, Lokesh held discussions with UAE Minister of Economy, Abdulla bin Toug Al Marri, focusing on collaborations in renewable energy, infrastructure, digital governance, AI-first university development, genome sequencing, quantum valley, and logistics. The UAE Minister responded positively and invited Lokesh for an official visit to the UAE.

Lokesh announced that India's first 152-bit quantum computer will be launched in Amaravati in January 2026, a move that he said would transform the state's economy. He also revealed plans to develop Visakhapatnam as a "Data City", with several international companies already expressing interest in setting up data centers there.

In education, Lokesh stressed the importance of integrating AI and quantum computing into curricula across polytechnic, degree, and engineering courses. He said the government is introducing skill development programs tailored to emerging technologies.

Highlighting governance reforms, Lokesh noted the implementation of "Mana Mitra" WhatsApp governance, which provides over 600 citizen services. This initiative is powered by a massive data lake connecting multiple departments to deliver faster, AI-driven public services.

Other key attendees at the summit included G42 India CEO Manu Jain and Primus Partners Vice President Raksha Shraddha. Lokesh reiterated the state's commitment to harnessing AI, data centers, and smart governance to drive economic growth.

Vizag to Add 50,600 Jobs: Nara Lokesh

Visakhapatnam is all set to transform into a leading IT and electronics hub, thanks to the proactive efforts of Andhra Pradesh IT, Electronics, and Education Minister Nara Lokesh. The State Investment Promotion Board (SIPB), chaired by Chief Minister N. Chandrababu Naidu, on Wednesday approved ₹20,216 crore worth of investments in four major projects in the IT sector, projected to create over 50,600 johs

These approvals mark a key milestone in the government's push to make Vizag a digital capital. Lokesh's initiatives over the past year, including investment roadshows in Bengaluru and Davos, have already started yielding results. During his Bengaluru visit, MoUs were signed in a single day



with two companies—Satva Developers and ANSR—which alone promise 35,000 jobs. These two projects received SIPB approval in

the latest round.

Satva Developers will invest ₹1,500 crore in Madhurawada to create 25,000 jobs, while ANSR plans to set

up a ₹1,000 crore Global Capability Centre (GCC) to generate 10,000 jobs. Another key project is by Sify Infinite Spaces Ltd., which will invest ₹1,466 crore in the first phase to build a Data Centre in Vizag, providing 200 jobs. A second phase will see an additional ₹15,000 crore investment and 400 more jobs. In addition, BVM Energy & Residency Pvt. Ltd. received approval to establish a World Trade Center in Endada with a ₹1,250 crore investment, expected to create 15,000 jobs.

Top firms like TCS (12,000 jobs) and Cognizant (₹1,583 crore investment for 8,000 jobs) are also preparing to launch operations in Vizag. Lokesh's persistent efforts have attracted ₹1 lakh crore in IT and electronics investments from 95 leading firms in the past year, setting the stage for 20 lakh job opportunities over five

Anil Kumar Yadav Probed in Quartz Smuggling

In a major development in the ongoing illegal quartz transport investigation, YSR Congress Party leader Anil Kumar Yadav faces escalating legal pressure following the arrest of his close associate, Biradavolu Srikant Reddy. Srikant was apprehended in Hyderabad by Andhra Pradesh's rural crime unit and produced before the Gudur court, which granted a 14 day police remand for further questioning.

During custodial interrogation, officials report that Srikant disclosed several critical details implicating senior party members in orchestrating the unauthorized movement of high value quartz consignments across state lines. He is said to have revealed logistics routes, key financiers, and the complicity of certain local officials who allegedly facilitated transport permits and evaded law enforcement scrutiny.

This arrest marks the third high profile detention in the case. Former Andhra Pradesh minister Kakani Govardhan Reddy was previously arrested and remains in judicial

arrested and remains in judicial custody under similar remand orders. Together, these arrests suggest a far reaching network that extends into political circles, prompting investigators to probe deeper into potential conspirators.

Anil Kumar Yadav, who has thus far evaded direct detention, is reportedly under intense surveillance, with police tightening the net around his known associates and properties. Law enforcement sources indicate that a formal summons may be issued shortly, based on leads obtained from Srikant's testimony.

Minister Nadendla Launches P4 Anti-Poverty Program

Andhra Pradesh's Consumer Affairs, Food and Civil Supplies Minister Nadendla Manohar launched the state's comprehensive anti-poverty initiative titled "P4 – Program to Promote Prosperity and Eliminate Poverty" during a Vision Action Plan meeting held in Amaravati Secretariat.

The minister released a dedicated P4 poster at the event and announced that a full-featured website, www. zeropovertyp4.ap.gov.in, will soon be launched to provide complete information about the program. The initiative is part of the coalition government's broader 2047 Vision to steer 50 lakh families out of poverty by 2029. Speaking at the launch, Minister Manohar emphasized that the government aims to transform poor families into "Golden Families" by supporting them through targeted welfare schemes. He highlighted that Tenali constituency alone has already identified 14,280 such families, with 376 volunteers adopting around 3,289 households.

SPREE-2025 Launched to Boost Worker Welfare

The Employees' State Insurance Corporation (ESIC) launched the SPREE-2025 (Scheme for Promotion of Registration of Employers and Employees) campaign at its Vijayawada regional office to boost social security for workers in Andhra Pradesh. Regional Director M. Rama Rao urged factories and establishments to voluntarily register under the scheme, which simplifies the process and enhances health and financial protection.

SPREE-2025, approved during ESIC's 196th meeting, waives past contribution demands and inspections for the pre-registration period, easing compliance and eliminating penalties. Registrations take effect from the date specified by employers, encouraging prompt enrollment. As of now, over 69,000 units and 14 lakh employees are covered under ESI in the state. The scheme offers benefits including medical care, maternity and sickness support, and post-retirement security for employees earning up to ₹21,000 per month. In case of factory closures, ESIC ensures 50% wage compensation.

'Adikarmayogi' to **Empower Tribal Villages: Minister**

YCP Brokers Now Circle TDP Office: AB Rao

Former IPS officer and TDP senior leader A.B. Venkateswara Rao launched a scathing attack on certain individuals who recently joined the Telugu Desam Party (TDP) from the YSR Congress Party (YSRCP), accusing them of continuing their "broker-style politics" under a new banner.

Speaking at a press conference, Rao referred to these individuals as "YCP bulls" who have now switched sides only to protect the illegal wealth amassed during the YSRCP's regime. He alleged that they have no real purpose except for lobbying and manipulating the system for personal gain.

"These people have no genuine political or public service intentions," Rao said. "They spend their entire day roaming around party offices, not to serve the public, but to find out whom to pressure, whom to threaten, or whom to emotionally exploit — all for money."

He accused them of turning politics into a brokerage business, stating that their entire focus is on earning money through influence rather than participating in any meaningful political or developmental activity. Rao further emphasized that such individuals are already trying to dominate party affairs within TDP and called upon party leadership to take strong disciplinary action. "These people are degrading the values and reputation of our party. They must be reined in before they cause further damage," he warned.Rao's comments reflect growing concerns within TDP about opportunistic defections and internal sabotage. He urged the party to act decisively against such elements and restore clean political practices. Rao concluded by reiterating that the Telugu Desam Party must not allow its platform to be hijacked by those who previously contributed to the corruption and decay of the YSRCP government.

Sunitha emphasized that all deserving families in rural areas must be allotted 3 cents of house sites as per the newly issued government orders. The MLA reviewed the status of NTR Housing from 2016 to 2019, particularly focusing on pend-


support underprivileged fam- expected to guide families by understanding their challenges and helping them overcome barriers to economic and social upliftment.

ACME Solar secures 275 MW/550 **MWh** storage deal

TPN Correspondent | Vijayawada ACME Solar Holdings has signed Battery Energy Storage Purchase Agreements with NHPC for a combined capacity of 275 MW/550 MWh across two standalone BESS projects. The agreements were executed on July 22, 2025 through wholly owned subsidiaries and follow the Letter of Award issued on July 8.

The first project comprises 50 MW/100 MWh secured at a tariff of INR 210,000 per MW per month, and the second covers 225 MW/450 MWh at INR 222,000 per MW per month. Both were awarded through an e reverse auction on June 24, 2025.

The projects fall under the Government of India's Viability Gap Funding scheme, entitling developers to Rs 27 lakh per MWh or 30 percent of total project cost, whichever is lower.

Strategic customer identification in Andhra Pradesh, which provides the land and evacuation infrastructure, enabled rapid transition from LOA to agreement signing. The standalone installations are expected to be commissioned within 18 months.

By absorbing surplus power during off peak hours and dispatching it during peak demand, the BESS solutions will enhance grid stability and facilitate higher penetration of variable renewable sources such as solar and wind. ACME Solar will adopt a "BESS as a service" model, making capacity charges payable under this pioneering framework. This milestone marks a significant advancement in India's energy storage sector and strengthens ACME Solar's portfolio through large scale battery procurement and deployment.

DMHO Warns Unregistered Hospitals

Private hospitals, clinics, diagnostic centers, and laboratories in Sri Potti Sriramulu Nellore district have been warned to ensure valid registration under the Andhra Pradesh Allopathic Private Medical Care Establishments Act, 2002 and Rules, 2007. District Medical and Health Officer (DMHO) Dr. V. Sujatha instructed that all such establishments must be mandatorily registered with the district health department. She emphasized that any private medical establishment whose registration has exceeded the five-year validity must apply for renewal online at least one month before expiry. Failure to register or renew within the stipulated time will result in strict action under the existing Act, she warned.

Dr. Sujatha has directed the concerned field-level medical and health staff to collect data on whether private establish-

urban health centers have valid registrations or renewals. The collected data must be submitted to the district health office within a week.

To strengthen enforcement, seven district, divisional, and program officers have been appointed to conduct surprise inspections. They have been clearly instructed to conduct extensive checks in their allotted areas to verify compliance with the Act. These officials will also oversee the ongoing survey being conducted by field-level staff regarding registration status.

Dr. Sujatha stated that once the survey results are in, the department will take action against those running private hospitals, clinics, diagnostic centers, or labs in violation of the law.

She reiterated that all private health establishments must prioritize compliance to avoid legal consequences. The department ments functioning under primary and aims to ensure that all health services op-



erate with transparency, accountability, and proper authorization, to safeguard public health standards.

Father-Son Duo Brutally Murdered Over Real Estate Dispute

Tension gripped Palnadu and Bapatla districts after a father and son duo were brutally murdered, allegedly over real estate and financial disputes. The victims, Veeraswamy Reddy and Prashanth Reddy, long settled in Bengaluru, were engaged in real estate dealings. A dispute with business associate Gaddam Anil Kumar Reddy over financial transactions reportedly led to their kidnapping and murder.

According to police, the victims were facing multiple cheque bounce cases in Ongole, Addanki, and Narasaraopet courts. On Tuesday evening, the duo arrived by flight to attend a court hearing scheduled for Wednesday in Narasaraopet, staying overnight at a local lodge. The next morning, they were kidnapped by six unidentified men outside a hotel near the court after breakfast. Their bodies were later found at a private real estate venture near Santamaguluru. Following the incident, Palnadu SP Kanchi Srinivasarao visited the crime scene and gathered details from their advocate Nagabhushanam.

Investigations revealed that Anil Reddy was present at the court premises during the abduction. Police have taken him into custody for questioning. They also suspect Badam Madhava Reddy, a former YSRCP leader from Darsi, Prakasam district, as the main conspirator. The attackers are believed to be members of a local gang from Santamaguluru mandal. Efforts are on to trace and apprehend them.

Residents are reportedly wading through knee-deep saltwater, unable to leave their houses. The recurring threat of seawater intrusion has sparked concern among locals, especially fishermen and farmers, who fear for their homes and livelihoods. They have demanded permanent solutions to prevent future erosion and flooding.

In response, Deputy Chief Minister Pawan Kalyan conducted a high-level review with the Kakinada district administration. Officials informed him that several houses had been affected due to the powerful tidal activity along the Uppada coast. Taking serious note, Pawan Kalyan directed authorities to immediately provide essential supplies such as food,

milk, and drinking water to the villagers. He also instructed them to deploy medical teams and ensure the availability of emergency medicines.

Emergency teams have been mobilized to pump out floodwater into the Bay of Bengal and reinforce vulnerable areas with temporary sandbag walls. Plans are also being prepared for long-term and more durable coastal defense projects. The Deputy CM asked for a full assessment of the existing infrastructure, including the damaged geo-tubes and sea walls, and emphasized the need for enhanced preparedness in light of the ongoing heavy rain forecasts.

Pawan Kalyan reiterated that protecting the lives and livelihoods of the people in vulnerable coastal regions is a top priority and ordered the official machinery to stay on high alert for further emergencies.



Neglect of Plant Scientist J.C. Bose by **Agricultural University Raises Concern**


Prof. Jagadish Chandra Bose, a world-renowned Indian plant scientist, biologist, physicist, and botanist, has left an indelible mark on the global scientific community. Born on November 30, 1858, he was a pioneer in the study of radio and microwave optics and made groundbreaking contributions to plant physiology. India has honored his legacy by naming esteemed institutions such as the J.C. Bose University of Science and Technology in Faridabad, Haryana after

In Andhra Pradesh, one of the most prominent institutions in the field of agricultural sciences is the Agricultural College, Bapatla, which celebrated its Platinum Jubilee just a year ago. Established in 1945 under the Composite Madras State and initially affiliated with Andhra University, the college has played a pivotal role in producing generations of agricultural scientists and professionals.

The college's historic association with Prof. J.C. Bose is symbolized through the "J.C. Bose Life Science Building," a landmark structure inaugurated in the late 1960s. The building was named to honor the scientific legacy of Prof. Bose and housed key departments and classrooms where generations of students attended lectures and wrote their examinations.

In 2015, the university undertook a redevelopment project, demolishing the aging structure to make way for a more modern facility. Funded by NABARD under its RIDF-XX scheme, the new building was inaugurated by the then NABARD Chairman Sri C. Govinda Rajulu, himself an alumnus of the college. However, to the surprise and disappointment of alumni and well-wishers, the newly constructed building was christened "College Annex Building," omitting the name of J.C. Bose entirely. This move has sparked widespread dismay among alumni and academic circles. Over 14,000 students have graduated from this historic campus, many of whom hold prestigious positions in government, academia, industry, and civil society. For them, the J.C. Bose Building was more than just a physical structure—it was a place filled with formative memories and deep academic engagement.

In response, concerned alumni have come together to demand the rightful restoration of the building's original dedication. Leading this initiative are





Why India Needs a New Forum of Free Enterprise Moment



This week's National Interest is sparked by three sharply relevant and interconnected developments that point toward an unsettling trend in India's economic and intellectual discourse: the creeping return of old, failed economic instincts.

The first trigger is the viral circulation of a misleading social media post that conflated India's GDP with the wealth of its billionaires, claiming it exposes the country's worsening inequality. While India does have serious inequality issues, the post reflects a broader confusion—GDP is annual national income, whereas wealth is accumulated assets. Many smart and well-meaning people fell for this argument, showing how deeply emotional narratives rooted in old "povertarian" thinking still resonate—even 33 years after the 1991 reforms.

India's stock market capitalization—around \$6 trillion—has little to do with annual GDP figures. The wealth of industrialists like Ambani, Adani, Tata, and others is largely market-based. The majority of India's 1.42 billion people contribute to GDP, but not everyone accumulates comparable wealth. This misunderstanding, though romantic, reveals how anti-capitalist sentiment still finds an audience, even among the educated.

The second trigger concerns India's steel industry. Steelmakers are lobbying for more import duties, pushing domestic steel prices to among the highest in the world. The burden falls on everyday Indians—whether building homes or buying scooties, tractors, or even kitchen utensils. Worse, 20% of the steel required by India's automotive sector isn't manufactured locally. Yet, a protectionist government remains unmoved, stalling industry and choking MSMEs.

FDI inflows have halved in recent vears—from \$56 billion in 2019-20 to \$26.8 billion in 2023-24—and India's trade is stagnant. Growth is slipping; the RBI just revised GDP forecasts downward to 6.6%. The third trigger is personal and symbolic. The writer recalls attending an event hosted by the Forum of Free Enterprise (FFE) in the Emergency era, a pivotal moment in shaping his economic worldview. Founded in 1956 by A.D. Shroff as a counter to Nehruvian socialism, the FFE stood firm against government overreach, nationalisation, and the licence-quota raj. Supported by intellectual heavyweights like Nani Palkhivala, Minoo Masani, and H.T. Parekh, the FFE was once a vibrant platform defending free markets and economic liberty.

But since the 1991 reforms, the FFE's momentum has faded. It no longer has the visibility or influence to counter the resurgence of protectionism, government overreach, and economic nationalism. At a time when India needs bold voices for reform and resistance against creeping statism, institutions like the FFE are missing in action.

As Shroff once argued, it is not capitalism but socialist overreach that endangers democracy and freedom. That truth matters more now than ever.

Finding Meaning in the Age of AI: Reclaiming Humanity in a Digital World

As artificial intelligence (AI) continues to redefine how we live, work, and interact, an urgent question arises: How do we preserve meaning and purpose in a world increasingly run by machines? The AI era, while marked by unprecedented innovation, is also triggering deep existential anxieties.

Take, for instance, a doctor deeply committed to healing her patients through human insight and empathy. Suddenly, AI outperforms her in diagnostics and treatment protocols. Her role feels diminished, and so does her sense of purpose. Similarly, a farm labourer proud of his honest toil watches helplessly as AI-powered machinery renders him irrelevant—leaving him disoriented in a life he once found meaningful.

In the gig economy, a food delivery worker navigates pothole-filled roads under harsh weather, only to be evaluated by cold, impersonal AI metrics. He becomes a cog in an algorithmic wheel, his human struggles unacknowledged, his autonomy steadily eroded. A schoolteacher relying entirely on AI-generated content soon loses her pedagogical identity, feeling alienated from the profession she once pursued with passion.

These are not isolated cases. They signal a growing crisis of authenticity, freedom, and identity. While humanity has always

AI is not inherently dangerous. But when we blindly accept its dominance or fail to critically engage with its presence, we risk losing the very essence of what makes us human. In an AIshaped world, preserving meaning demands more than technological adaptation—it calls for self-awareness, critical thinking, and authentic engagement. Only then can we reclaim freedom, agency, and purpose in our lives.



India to Resume Tourist Visas for Chinese Citizens

In a significant diplomatic development, India will resume issuing tourist visas to Chinese citizens starting July 24, 2025 marking the first such move in five years. The decision, announced by the Indian Embassy in Beijing on Wednesday, comes after a prolonged suspension that began with the COVID-19 pandemic and was further compounded by the military standoff between the two nations in Eastern Ladakh in 2020.

The embassy stated that Chinese nationals can now apply for a tourist visa to India by completing an online application, booking an appointment, and submitting their passport and necessary documents in person at Indian Visa Application Centres in Beijing, Shanghai, and Guangzhou. The statement also noted that any passport withdrawal requests must include an official withdrawal letter. India had halted all tourist visa services in early 2020 as part of pandemic containment efforts. Following that, bilateral relations sharply deteriorated due to the deadly Galwan Valley clashes in June 2020, which led to the worst border tensions between India and China in over six decades.

While China had gradually reopened visa issuance for Indian students and business travellers, tourist visas had remained re-



stricted until now. The latest move signals a cautious thaw in ties, with India extending travel permissions to Chinese tourists for the first time since hostilities began.

In recent months, there have been signs of de-escalation. In October 2024, India and China announced a disengagement agreement at the remaining friction points of bilateral relations.

Muslim population in Assam will be almost equal to Hindus by 2041: CM

Assam Chief Minister Himanta Biswa Sarma on Wednesday made a striking demographic projection, claiming that if current trends persist, the Muslim population in Assam will nearly equal the Hindu population by 2041.

Speaking at a press conference following a state cabinet meeting, Sarma said that according to the 2011 Census, Muslims constituted approximately 34% of Assam's population. Of that figure, he said, around 31% were Muslims who had migrated to Assam in earlier decades, while only 3% were indigenous Assamese Muslims.

"This is not my opinion, it is based on Census data," the Chief Minister stated. "If you project the same trend into the future — for 2021, 2031, and 2041 — the demographic balance will be close to 50:50. That's what the statistics suggest," he claimed.

Sarma's remarks come amid ongoing political discourse over illegal migration and its impact on Assam's demographic structure, a long-standing issue in the state's politics.

When asked whether indigenous Assamese communities risk becoming a minority, Sarma did not directly answer but emphasized that he was only quoting official data and making a statistical projection. He added that the state's future policies would continue to focus on preserving the cultural and demographic integrity of the indigenous population.

The Chief Minister has previously made headlines for his strong stance on issues of illegal migration, border security, and identity preservation in Assam. His government has also launched several initiatives aimed at population control and community development, particularly in Muslim-majority areas.

While critics may view Sarma's comments as politically charged, he framed them as a factual reading of demographic trends. The statement is likely to reignite debate over Assam's population policy and migration issues ahead of the next census and elections.

Bihar Assembly Uproar Over Voter List Revision

The ongoing Special Intensive Revision (SIR) of electoral rolls sparked heated debates for the third consecutive day in the Bihar Legislative Assembly, with the Opposition cornering the government over the controversial drive's timing and execution.

Speaker Nand Kishor Yadav, after sustained protest by the Opposition, allowed a discussion on the issue despite Chief Minister Nitish Kumar's objection. The move opened the floor for Leader of Opposition Tejashwi Yadav to launch a scathing critique of the Election Commission's pro-

Yadav reiterated that the Opposition was not against updating the rolls but questioned the "urgency, transparency, and fairness" of the exercise. "The right to vote is guaranteed by the Constitution to every citizen above 18, regardless of social or Highlighting logistical issues, he queseconomic status. This equality is non-negotiable," he stated.

He raised concerns about the documentation required for inclusion in the revised rolls, noting that many poor and marginalized citizens lacked the 11 documents reportedly being demanded. "Why are Aadhaar cards, ration cards, or MNREGA cards being rejected, even though the Supreme Court has supported their use?" he asked. Yadav also accused the Election Commission of operating in opacity. "A major

India Rejects UK Media Report on Air India Crash Victim Misidentification

The Indian government has strongly dismissed claims made in a British media report that the bodies of victims in the June 12 Air India plane crash were misidentified and sent to the wrong families in the UK.

Responding to the allegations published by the

Daily Mail, which quoted two unnamed British families alleging serious errors in the repatriation of their loved ones' remains, the Ministry of External Affairs (MEA) issued a firm rebuttal on Wednesday.

"All mortal remains were handled with utmost professionalism and with due regard for the dignity of the deceased," said MEA spokesperson Randhir Jaiswal. He added that Indian authorities followed all established protocols and technical procedures for identification before repatriating the bodies.

The tragic crash of Air India Flight AI-231 in Ahmedabad claimed the lives of all 241 people on board, including 53 British nationals. In the aftermath, the MEA confirmed that it had been in close coordination with UK authorities to ensure that the victims' remains were identified and returned appropriately.

"We have seen the report and have been working

closely with the UK side from the moment these concerns and issues were brought to our attention," Jaiswal said. He also noted that India continues to engage with British officials to address any specific concerns raised by the families.

The Daily Mail report alleged that grieving relatives were subjected to renewed trauma after receiving the wrong remains, calling the process a "horrif-



ic bungle." Indian officials, however, emphasized that identification was carried out using internationally accepted standards, and maintained that no mishandling took place.

The incident has drawn significant media attention in both countries, but India's response reaffirms its commitment to transparency and dignity in handling such sensitive matters.





Dam on upper reaches Brahmaputra will not impact India, **Bangladesh: China**

Beijing on Wednesday defended the construction of a massive hydropower dam on the Brahmaputra River in Tibet, dismissing concerns raised by India and Bangladesh about its potential downstream impact. The project, located in Nyingchi City near the Line of Actual Control (LAC) in Arunachal Pradesh, was formally announced by Chinese Premier Li Qiang over the weekend.

The dam, situated on the lower reaches of the Yarlung Zangbo River (as the Brahmaputra is known in Tibet), is expected to generate over 300 billion kWh of electricity annually — enough to power 300 million people. However, the scale and location of the project have sparked alarm in India, with concerns over both environmental risks and strategic vulnerabilities.

Chinese Foreign Ministry spokesperson Guo Jiakun insisted that the project would not negatively affect lower riparian countries, emphasizing that China has communicated with India and Bangladesh, and continues to share hydrological data to aid in flood control and disaster management.

"China strictly adheres to the highest ecological and industrial standards," Guo said. "This is part of our clean energy efforts and supports local livelihoods while addressing climate change."

India, however, remains wary. Arunachal Pradesh Chief Minister Pema Khandu recently described the dam as a ticking "water bomb" and a more serious threat than military tensions. He noted that China's refusal to sign any international water treaty makes the project especially concerning, warning that China's control over water flow could be used as a strategic tool.

Meanwhile, Bangladesh received assurances from Chinese Ambassador Yao Wen that the dam's purpose is solely energy generation and will not reduce water flow.

Five jets shot down in Ind-Pakistan conflict which could have turned nuclear

Washington has once again asserted that the United States, under President Donald Trump's leadership, played a key role in recent de-escalations between India and Pakistan. However, India has strongly refuted the claim, maintaining that the ceasefire agreement following Operation Sindoor was initiated at Pakistan's request, without any third-party mediation.

At a UN Security Council debate on 'Multilateralism and Peaceful Settlement of Disputes,' chaired by Pakistan's Deputy Prime Minister Ishaq Dar, U.S. Ambassador Dorothy Shea claimed that American diplomacy was instrumental in facilitating peaceful outcomes in several global flashpoints — including between India and Pakistan, Israel and Iran, and the Democratic Republic of Congo and Rwanda.

"The United States continues to work with parties to disputes to find peaceful solutions," Shea said. She praised recent resolutions and



urged all UN member states to follow the example of nations choosing diplomacy over conflict.

India, however, pushed back strongly. Ambassador Parvathaneni Harish, India's Permanent Representative to the UN, clarified that Operation Sindoor — a focused strike on terrorist camps in Pakistan and Pakistan-occupied Jammu and Kashmir (PoJK) — was a precise, non-escalatory action. Once India achieved its operational objectives, a ceasefire was concluded directly at Pakistan's request.

"There is no one-size-fits-all approach to conflict resolution," Harish stated, emphasizing India's position that external mediation is neither needed nor accepted in India-Pakistan matters.

India also reaffirmed its commitment to global peace, stating that it remains engaged with the UN and international partners to promote stability and justice worldwide.

Meanwhile, the U.S. also took aim at China's maritime claims in the South China Sea, condemning its ongoing defiance of the 2016 international tribunal ruling. Washington urged Beijing to respect international law and cease destabilizing actions in the region.

PM Modi's Visit Will Boost Indian Tourism and Strengthen Ties: Nasheed

Obama Calls Trump's 2016 'Treason' Claim Outrageous and Bizarre

Former U.S. President Barack Obama has responded to Donald Trump's recent "treason" accusations, dismissing them as a "weak attempt at distraction" from growing scrutiny over the Trump administration's handling of the Jeffrey Epstein case.

Trump, speaking during a press event with Philippine President Ferdinand Marcos, called for Obama's prosecution, citing a report by U.S. Director of National Intelligence Tulsi Gabbard. The report alleged that officials from the Obama administration manipulated intelligence regarding Russia's interference in the 2016 election claims widely discredited by experts and lawmakers from both parties.

Obama spokesman Patrick Rodenbush issued a rare public response: "Out of respect for the office of the presidency, our office usually does not respond to the constant stream of misinformation. But these claims are outrageous and deserve a response. These bizarre allegations are a ridiculous and weak attempt at distraction."

The report Gabbard released claimed Obama's administration manufactured intelligence to support what she called a "years-long coup" against Trump. However, multiple investigations from 2019 to 2023 — including criminal, counterintelligence, and oversight probes — consistently confirmed Russian interference in the 2016 election in support of Trump.

A 2020 bipartisan Senate Intelligence Committee report, led by then-Chairman Marco Rubio (now Secretary of State), concluded that the Trump campaign sought to "maximize the impact" of stolen Democratic documents leaked by Russian operatives. The report called Russia's interference and the Trump team's cooperation "one of the most grave counterintelligence threats to American national security in the modern era."

Despite this, Trump accused Obama of being the "leader of the gang" in a conspiracy, also naming Joe Biden, James Comey, James Clapper, and John Brennan. Critics have dismissed his statements as a continued effort to deflect from legal and political pressure.

According to the India Bullion and Jewellers Association (IBJA), the price of 24-carat gold surged by ₹1.025 to ₹1,00,533 per 10 grams, breaching the ₹1 lakh mark once again. The previous day, gold had closed at ₹99,508. Similarly, 22-carat gold rose to ₹92,088 per 10 grams from ₹91,149, while 18-carat gold increased to ₹75,400 per 10 grams from ₹74,631.

New Delhi: Indian cities are poised to become the engines of economic growth by 2030, creating nearly 70% of the country's jobs. However, they also face significant risks, including a potential annual loss of \$5 billion due to urban flooding, according to a new World Bank report.

Released in collaboration with the Union

Ministry of Housing and Urban Affairs, the report highlights the urgent need for Indian cities to enhance their climate resilience. It estimates that building climate-resilient infrastructure and services will require a massive investment of \$2.4 trillion by 2050.

At the report's launch, World Bank Country Director for India, Auguste Tano Kouame, emphasized the importance of empowering urban local bodies (ULBs). "Cities that have greater autonomy and decision-making power have consis-

Navi Mumbai Earns 'Clean City' Tag

 ${f J}$ ust days after being named India's third cleanest city in the Central Government's annual cleanliness survey, Navi Mumbai is at the center of an online debate over its real onground conditions. A viral social media post has cast doubt on the city's clean image, showing Starbucks-branded plastic cups discarded on a wet roadside pavement.

The images, shared by a user on X (formerly Twitter), featured multiple plastic cups with green straws, left carelessly on the street. Expressing disappointment, the user wrote, "#Disgraceful. How to explain basic civic sense to the children of a spoilt parent?" He further questioned whether parental responsibility ends with providing money and cars. His frustration highlighted the disconnect between official rankings and public behavior.

The post quickly gained traction, prompting reactions from citizens across the country. One user commented, "Till the time fines are not put... Common man won't learn." Another sar-



castically noted, "Fancy beverages worth Rs 500, but basic civic sense is worth less than a paise." Some users called for stricter enforcement, suggesting the use of AI surveillance to issue automatic complaints and hefty fines. Others blamed broader societal patterns, arguing that adults and public figures set poor examples. One remark summed up the sentiment: "If these kids went abroad, they wouldn't dare do this. They're only following what they see

Despite Navi Mumbai's official recognition, the incident sparked reflection on the gap between policy and practice. It underscores the need for not only cleaner infrastructure but also a deeper cultural shift in civic behavior.



Myntra Under ED Probe for ₹1,600 Cr FDI Violation

Myntra Designs, the leading fashion e-commerce platform, has come under the radar of the Enforcement Directorate (ED) over suspected violations of Foreign Exchange Management Act (FEMA) norms. A notice has reportedly been issued to the company concerning ₹1,654 crore in foreign direct investment (FDI) that allegedly breached existing retail policy regulations.

According to official sources, the complaint accuses Myntra of violating FDI guidelines by engaging in retail sales through group entities, a practice restricted under India's FDI rules in the multi-brand retail sector. FEMA regulations

allow FDI in marketplace models but prohibit inventory-based models for foreign-funded e-commerce firms. The ED is investigating whether Myntra routed sales through related party entities, potentially circumventing these rules.

The alleged contravention involves transactions that occurred over several financial years, during which Myntra reportedly received significant foreign capital infusion while continuing to conduct sales via relatry-led model—a grey area under current law.

The investigation follows similar scrutiny faced by other major e-commerce players in India, including Amazon and Flipkart, who were earlier probed for comparable FEMA-related concerns. Regulatory agencies are tightening their oversight to ensure foreign

investment does not violate India's retail trade frameworks.

Myntra, a subsidiary of Walmart-owned Flipkart Group, is expected to respond to the notice with detailed records and clarifications regarding its business practices and FDI inflows.

The case is likely to reignite debates around FDI norms in e-commerce, especially concerning the distinction between marketplace and inventory-led models. On the women's singles front, PV Sindhu was tested by Japan's Tomoka Miyazaki but showed great resilience








