AP Sets New GST Record in July: Lokesh

Andhra Pradesh's economy is showing strong signs of revival, as evident from the record-breaking GST collections reported in July 2025. Minister for IT, Education, and Human Resources Nara Lokesh shared the details on social media, highlighting the state's economic resurgence. According to Lokesh, Andhra Pradesh collected ₹3,803 crore in GST revenues in July the highest ever since the implementation of GST in 2017.

This figure represents a 14% increase compared to July last year. Lokesh pointed out that Andhra Pradesh topped all southern states in GST growth and stood third among all major Indian states. "Andhra Pradesh is bouncing back. This is just the beginning," he remarked on his X account. Focus on Youth Employment through Green Skilling

The event will be attended by Minister Nara Lokesh, State Energy Minister Gottipati Ravi Kumar, and over 250 industrialists, educationists, and experts from various sectors.

The summit intends to serve as a key platform to offer high-quality technical training to the youth, preparing them for emerging green job markets. Green Energy Sector to Drive Future Job Opportunities

Chandrababu Announces GST Relief for Weavers

In a major boost to the handloom sector, Chief Minister N. Chandrababu Naidu announced a slew of decisions aimed at supporting weavers across the state. During a review meeting of the handloom department held at the state secretariat on Tuesday, the CM declared that the state government will fully bear the GST on handloom garments to reduce the burden on weavers and enhance market competitiveness.

Chandrababu emphasized that handlooms are the second-most important livelihood sector in the state after agriculture. Recalling his recent interaction with a weaver's family, he said their struggles highlight the need for immediate intervention. "The sector is not just about tradition, but also about livelihoods. It deserves both recognition and support," he added. As part of the newly introduced measures, the government will provide 200 units of free electricity for traditional looms and 500 units for power looms. The CM instructed officials to implement this decision immediately and ensure uninterrupted power supply to weavers.

Another significant initiative announced is the creation of a thrift fund for weavers. The government will contribute Rs. 5 for every Rs. 1 saved by the weaver. This scheme is expected to offer financial security and promote a culture of savings among handloom workers.

Chandrababu also directed that all these decisions be implemented from National Handloom Day, which falls on Thursday. "Let this be a turning point for the handloom sector in Andhra Pradesh," he remarked.

Officials from the handloom department, who were present at the meeting, informed the CM that Andhra Pradesh's handloom products had recently won 10 national awards, including the first prize in the One District One Product division. These accolades were presented to the CM before the review began.

The CM expressed confidence that with these reforms, the handloom sector would witness a revival, leading to better income, increased sales, and improved lives for thousands of weavers across the state.

Cabinet Panel Reviews Ramayapatnam Port **Proposals**

A key meeting of the Cabinet Sub-Committee was held on Tuesday at the Second Block Conference Hall of the Velagapudi Secretariat to discuss the proposed extension of Phase-1 construction deadline and increase in port draft from 16 to 18.5 meters for the Ramayapatnam Greenfield Port.

The meeting was attended by Finance Minister Payyavula Keshav, Infrastructure and Investment Minister BC Janardhan Reddy, and Tourism, Culture and Cinematography Minister Kandula Durgesh. The committee evaluated technical and financial proposals for the port's development and deliberated on critical issues such as dredging works, internal and external road networks, and rail connectivity enhancements.

The ministers reviewed the feasibility of completing Phase-1 works, including port basin deepening and breakwater construction, within the extended timeframe. They also examined suggestions to strengthen the port's cargo handling capabilities and ensure seamless multi-modal transport integration. Officials presented reports emphasizing the strategic importance of upgrading the port draft to 18.5 meters, which would enable handling of larger cargo vessels and boost industrial development in southern coastal Andhra Pradesh. The committee is expected to submit its recommendations to the state cabinet soon for final approval. The Ramayapatnam Greenfield Port, once operational, is anticipated to significantly contribute to regional economic growth, attract private investments, and create employment opportunities. The government aims to make it a major maritime hub along the eastern coast.

Misuse of In-Service Reservation Sparks Fresh Debate Over PG Medical Seats

Amaravati: The issue of in-service reservation in postgraduate (PG) medical seats has once again triggered a heated debate in the state, with allegations of misuse overshadowing the government's original intent to strengthen public healthcare. Recent policy changes have further intensified tensions between general medical aspirants and in-service doctors.

The state government had introduced in-service reservation years ago to address a shortage of specialist doctors in government hospitals. The idea was simple- encourage MBBS graduates to join Primary Health Centers (PHCs) and other public health institutions by offering them a fixed quota of PG seats and fulfilling the need of specialty doctors in the government sector. In return, these doctors would specialize and later serve in government hospitals,

thereby improving healthcare delivery. However, over time, the scheme has reportedly been exploited. Many MBBS graduates, unable to secure PG seats through the competitive NEET exam, joined PHCs primarily to benefit from the reservation quota rather than out of a commitment to public service. Several instances surfaced where doctors, after securing PG admissions under the in-service quota, took long leaves or allegedly bribed officials to avoid returning to government service. Some even moved to private practice soon after completing their specialization, defeating the purpose of the reservation policy.

To counter this malpractice, the government



introduced strict rules, including a hefty fine view. Officials concluded that by 2029, the of up to ₹50 lakh for doctors who failed to serve in government hospitals after availing of in-service reservations. Yet, the deterrent has not proven fully effective. "Doctors are willing to pay the fine because obtaining a PG seat under management quota in private colleges often costs between ₹2 to ₹5 crore unofficially. Compared to that, even paying a crore to the government is cheaper," a senior health department official admitted. Meanwhile, genuine aspirants who prepare extensively for NEET have expressed frustration over losing a significant chunk of seats to in-service doctors. Until the 2023-24 academic year, 30% of clinical PG seats and 50% of non-clinical seats were reserved for in-service candidates. The current government, after reviewing the scenario, revised the quota for 2024-25 to 20% for clinical and

30% for non-clinical seats.

state is unlikely to face a shortage of PG doctors, given the rapid expansion of medical colleges and rising seat availability. Consequently, the quota has been further reduced to 15% in seven clinical specialties and 20% in nine non-clinical specialties.

While many medical students have welcomed the move, the Andhra Pradesh PHC Doctors Association has raised concerns. "The decision was taken without consulting us. We are not officially aware of the changes and will seek discussions with the government," said Dr. ABN Kishore, Secretary of the Association.

As the controversy unfolds, experts stress that while reservation policies can help build a strong public healthcare system, loopholes that allow misuse must be firmly addressed. The government's latest decision may ease pressure on general aspirants, but the tug-of-war over PG seats is far from

The circulation of this single selfie is raising several questions. Is there a deeper link between the two high-profile liquor cases? Is the presence of Kavitha in a photo with one of the AP liquor accused purely incidental, or is it a thread that ties together parallel scams across two states?

While political observers and critics are quick to draw inferences, investigative agencies have not officially confirmed any connection stemming from the photo. However, the image is now being shared widely across social media and is fuelling debates about the wider network and political backing behind the liquor scams in both Andhra Pradesh and Telangana.

The answer to whether this selfie is a mere coincidence or a key connecting dot in a broader liquor nexus now lies in the hands of the investigating authorities. As the probe deepens, more details are expected to emerge, potentially altering the trajectory of both scandals.

The YSRCP leaders claim threats like withholding bills, cancelling dealership licenses, and stopping welfare benefits are being used, but voters remain undeterred.

Probe ordered against 11 medical staff

Health Minister Satya Kumar Yaday has directed an inquiry into allegations of negligence, poor management, and irregularities involving 11 medical staff members of Gudivada Government Area Hospital. The order followed his review of a report submitted by the Anti-Corruption Bureau (ACB), which carried out a detailed inspection of the hospital in February 2020.

The ACB's two-day inspection, prompted by reliable complaints about hospital mismanagement, found multiple violations. The report implicated the then superintendent, six doctors, an administrative officer, two nursing superintendents, and pharmacists, citing failure to maintain proper oversight and accountability in patient care and hospital operations.

Investigators uncovered glaring lapses, including errors in the drug stock register, irregularities in the supply and quality of food served to patients, and poor hygiene standards on the premises. Used test kits and gloves were found discarded in unsuitable areas such as the kitchen, pump room, and storage sheds, raising serious health concerns.

The report further revealed that despite several internal audits between 2014 and 2018 flagging issues in hospital administration, no corrective action was taken. Funds amounting to lakhs were reportedly spent on unrelated tasks for a hospital driver while a non-functional vehicle lay unused for years. Nursing superintendents and pharmacists were also faulted for irregular medicine distribution and neglecting basic patient needs, including daily changes of bed linens.

Minister Yadav, who has made hospital supervision a key focus since assuming charge, said such disregard for audit findings and patient welfare would not be tolerated. Only last month, he had ordered action against 22 doctors and other staff at Anakapalle Government Hospital based on another ACB report from 2020. He remarked that repeated instances of such mismanagement highlighted the lack of responsibility and oversight in government hospitals under the previous administration.

The minister reaffirmed that strict measures would be taken against those proven guilty and asserted his commitment to enhancing supervision, accountability, and service quality in state-run medical institutions.

Govt Prioritizes Worker Welfare. Announces New Initiatives

The Andhra Pradesh coalition government is committed to the welfare of workers, particularly in construction and other unorganized sectors, said Labour Minister Vasamsetti Subhash during a Labour Welfare Board meeting held here on Tuesday. Addressing the gathering, the minister emphasized that the government is taking significant steps to protect unorganized workers, contrasting it with the alleged neglect during the previous regime.

As part of these efforts, the government plans to construct integrated labor buildings in Vijayawada, Visakhapatnam, and Tirupati as a pilot project, with a vision to extend one such facility to every constituency. These buildings aim to provide workers with a dignified workspace, eliminating the need to wait on roadsides for daily wage opportunities. Additionally, skill development training for workers and their families, the appoint-



ment of safety officers in factories, and MOUs with universities to enhance safety measures were announced.

Minister Subhash noted that under Chief Minister N. Chandrababu Naidu's leadership, investor confidence has surged, attracting industries and creating job opportunities. The government is also increasing cess collections to fund welfare schemes, targeting recognition of 15 lakh workers. Welfare Board Chairman Valavala Babji assured the revival of stalled welfare programs to ensure comprehensive benefits for workers.

Leopard Spotted Again in Tirumala

Panic gripped the residents of East Balaji Nagar in Tirumala after a leopard was sighted near Gangamma Temple at midnight. The wild animal's presence has once again raised concerns over the safety of locals and pilgrims in the sacred hill town.

According to eyewitnesses, the leopard was seen roaming in the la, especially in areas adjacent to vicinity of the temple late at night. Locals, alarmed by the sighting, promptly alerted the TTD Forest Department officials, who have since intensified monitoring in the area.

This is not the first time such an incident has occurred. Leopard sightings have become more frequent in recent months, prompting calls for more robust measures to ensure public safety in Tiruma-



forest zones.

Forest officials are now reviewing CCTV footage and tracking possible movement routes. Patrols have been stepped up, and night surveillance has been enhanced to prevent any untoward incidents. The TTD has urged residents and devotees to remain cautious, avoid isolated paths at night, and report any further sightings immediately.



TDP Misleading on GST Rise: Buggana

Former Finance Minister and senior YSR Congress Party leader Buggana Rajendranath has accused the TDP-led coalition government of misleading the public with exaggerated claims of GST revenue growth for July 2025. He stated that the apparent increase is not due to genuine economic improvement but a statistical illusion created by the TDP's own poor performance

In a statement, Buggana said the 14% yearon-year growth in GST revenue is deceptive. "The spike is not from better governance or policy reforms, but simply because GST collections in July 2024 were unusually low," he asserted, blaming the TDP alliance for weak economic management during that

He presented comparative data to support his argument. In July 2023, net GST revenue was ₹2,755 crore, while in July 2025, it rose to ₹2,930 crore—a mere 6.3% increase over two years. He said this means the real yearon-year growth for 2025 is just 3.13%, with gross GST revenue growing only 2.88%.

Buggana criticised TDP General Secretary Nara Lokesh for celebrating this marginal rise and calling it the fastest growth rate among South Indian states. "He's hiding the fact that growth in 2024 was negative. This year's increase looks big only due to the base effect," he said.

Dudekula JAC Slams Coalition Government

The Muslim Dudekula Political Joint Action Committee (JAC) has slammed the Andhra Pradesh coalition government, accusing it of neglecting the promises made to the Noor Basha/Dudekula Muslim community. JAC State President Sheikh Dasthagiri alleged that both Chief Minister N. Chandrababu Naidu and Deputy CM Pawan Kalyan betrayed the trust of the community by failing to deliver on commitments made during the 2014 and 2024 elections.

He pointed out that despite assurances of MLAs, MLCs, MPs, and a Rs. 100 crore corporation for the community's upliftment, no promises were fulfilled even after 18 months in power. "Chandrababu used our community as a vote bank," Dasthagiri said, recalling the 2014 "Dudekula Simha Garjana" in Guntur, where grand assurances were made but never implemented.

Dasthagiri also accused Pawan Kalyan of misleading the Dudekula community. "He cried on stage in Siddhavatam, promising support. But he secured a Deputy CM post for himself and gave his brother an MLC seat, while ignoring Dudekula Muslims completely," he said.

Highlighting deep discrimination, Dasthagiri said that while other Muslim groups received MLA and ministerial posts, advisory roles, and chairmanships in boards like the Wakf Board and Minority Finance Corporation, the Dudekula community got nothing. "The government serves feasts to some and leaves us with empty plates," he added. He also targeted TDP general secretary Nara Lokesh for promising a Rs. 100 crore corporation in Tadipatri, only to forget it post-elections. In contrast, Dasthagiri praised the previous YSRCP government for granting self-respect to the community and ensuring welfare benefits reached them.

Minister Kandula Distributes CMRF Cheques

Tail-end farmers lack irrigation water, minister says

Water Resources Minister Nimmala Ramanaidu, along with MLAs Kagita Krishna Prasad, Venigandla Ramu, and former MLA Ravi Venkateswara Rao, inspected the locks at Gudlavalleru and assessed irrigation issues in the Pedana and Gudivada con-

Despite releasing 10,400 cusecs into the Eastern Canal, the minister observed that tail-end farmers are not receiving irrigation water. He directed the Chief Engineer and all field-level staff to monitor water supply along the canals. Ramanaidu instructed the district collector to coordinate with revenue and irrigation officials to ensure water reaches every acre.

He highlighted the need for effective water management to store surplus floodwaters. Referring to Chandrababu Naidu's leadership, he said Pattiseema was completed with ₹1,350 crore despite Jagan mocking it as "Votti Seema." The project helped divert Godavari water to Krishna Delta, generating over ₹50,000 crore in revenue.

He criticized the previous YSRCP government for neglecting canal desilting and allocating no funds, while the current coalition allocated ₹700 crore in the first year. ₹350 crore has been sanctioned for repairs at Srisailam Plunge Pool and Dhavaleswaram gates.

MLC Slams Govt Over Farmers' Distress

The previous YSRCP government had provided ₹13,500 annually to farmers, while the current regime has slashed it to ₹5,000 over two years. He said seven lakh farmers were denied benefits under Annadata Sukhibhava.

Farmers are facing severe fertilizer shortages, forced to queue under the sun for urea and complex fertilizers. With RBKs weakened, they are buying from private shops at high prices. Crops are not getting MSP, and mango, chilli, paddy, cocoa, and tomato farmers are incurring heavy losses.

Citing government apathy, he revealed that over 250 farmers have committed suicide since June 12, with no compensation provided.

Protest Erupts Over Garbage Tax Irregularities

Political tension has escalated in Kadapa as both ruling YSRCP corporators and opposition TDP leaders raised serious concerns over the misappropriation of waste tax collections by the municipal corporation. The controversy surrounds an estimated ₹36 crore collected over recent years under the guise of waste tax, with allegations of funds being diverted into private hands instead of reaching government coffers.

YSRCP corporators and division incharges, during a press meet at the mayor's chamber, urged the district collector to conduct a thorough probe into the matter. They demanded clarity on who collected the tax, how much was collected, and where the money ultimately went. They highlighted that multiple news reports had accused the ruling party and the corporation of misusing the tax collections. The corporators argued that instructions had earlier been given not to burden the public with waste taxes during the YSRCP's term, especially not more than ₹40 to ₹60 per



household.

They also opposed the appointment of the additional commissioner, involved in the CLAP programme, as the inquiry officer, citing conflict of interest. Meanwhile, TDP leaders held a protest in front of the Kadapa Municipal Corporation office demanding a full-fledged inquiry. They claimed that ₹8 crore collected as garbage tax was not deposited into official accounts and questioned the lack of transparency. TDP further alleged that since the CLAP programme's implementation in 2021, over ₹36 crore had been unaccounted for. They submitted a memorandum demanding action and transparency in tax col-

Orphans can get a Family with Foster Care and Adoptions

he United Nations Convention on the Rights of the Child (UNCRC) emphasizes that for the full and harmonious development of a child's personality, it is essential that the child grows up in a family environment, filled with happiness, love, and understanding. A child's destiny is best shaped within the nurturing environment of a family. It is within this setting that values, culture, and a sense of responsibility are naturally instilled, enabling the child to grow into a morally grounded and contributing citizen.

Recognizing this, the Government of India—being a signatory to the UNCRC—has taken commendable steps to promote Adoption and Foster Care systems. These initiatives aim to provide orphaned and vulnerable children, legally termed as Children in Need of Care and Protection (CNCP), the opportunity to grow up in a loving family environment rather than in institutional care.

Adoption: A Permanent

Family for a Child

Adoption is the legal process by which an individual assumes the parenting of a child, permanently transferring all rights and responsibilities from the biological or legal parents to the adoptive ones. In India, adoption is governed by the Juvenile Justice (Care and Protection of Children) Amendment Act, 2021, came into effect from 1st September 2022 and regulated by the Central Adoption Resource Authority (CARA), functioning under the Ministry of Women and Child Development, Government of India since 1990.

However, adoption rates in India re-



main dishearteningly low. In 2010, there were 5,693 in-country adoptions through CARA, which dropped to just 3,351 in 2019–20. This decline is surprising considering that there are an estimated 27.5 million childless couples in the country. Despite this, only about 20,000 couples have infants are housed. Once the Child formally approached CARA.

This gap can be attributed to the prevalent cultural preference for biological children who share parental genes and lineage. Often, couples consider adoption only after However, the demand far exceeds exhausting other options like IVF. Under this system, children are placed in the temporary custody of government-approved foster families who are responsible for their shelter, education, health, and overall well-being. Regular monitoring by the authorities ensures that the child is being properly cared for. Foster care placements are made

under Section 44 of the Juvenile Justice Act Rules, 2016 and Rule 23 of the Juvenile Justice Rules, 2016 (as amended in 2022). If a child remains with the foster family for two continuous years and the arrangement proves mutually satisfactory, the family can apply to adopt the child permanently. This

provision enables the foster child

to eventually gain the same legal rights as a biological child.

According to data from the National Commission for Protection of Child Rights (NCPCR) as of July 2018, there are nearly 5,850 registered CCIs in India, housing around 2.32 lakh children in need of care and protection. Many of these children are eligible for Foster Care and could benefit immensely from growing up in a family setup, even if initially temporary.

Both Adoption and Foster Care are vital systems to ensure every child enjoys their fundamental right to a family. However, awareness among the public remains limited. The Government must intensify its efforts to promote these systems through widespread campaigns, streamlined procedures, and incentives for foster and adoptive families.

Encouraging more families to consider Foster Care—especially as a step towards eventual adoption can bridge the gap between institutional care and a permanent home. Children raised in such nurturing environments are more likely to grow into emotionally secure, socially responsible, and culturally rooted individuals. It is our collective responsibility—as a society and a nation—to ensure that every child not only survives but thrives in a loving family atmosphere. Through greater acceptance and implementation of Adoption and Foster Care systems, we can build a stronger, more compassionate India.

Air Force, Navy To Place Mega Orders For BrahMos

Following the significant success of BrahMos missiles during Operation Sindoor, the Indian Air Force and Navy are set to place large orders for the supersonic cruise missiles, according to defence sources.

The Indo-Russian BrahMos missile, known as the world's fastest supersonic cruise missile, played a crucial role in striking Pakistani air bases and army cantonments throughout the four-day conflict. Its precision and impact were widely acknowledged by military officials and political leaders alike.

A high-level meeting at the Defence Ministry is expected to approve the procurement of a substantial num-

ber of BrahMos missiles for deployment across multiple platforms. The Indian Navy plans to equip its Veerclass warships with these advanced missiles, enhancing their strike capabilities at sea. Meanwhile, the Indian Air Force intends to arm its fleet of Russian-origin Su-30 MKI fighter jets with air-launched BrahMos missiles, significantly boosting aerial combat and precision strike potential. Prime Minister Narendra Modi recently lauded the performance of indigenous defence systems during the conflict, stating, "During Operation Sindoor, the world saw the capabilities of our indigenous weapons. Our Air Defence Systems, missiles, and drones have proved the strength of 'Atmanirbhar Bharat', especially

the BrahMos missiles."

In the initial phase of Operation Sindoor, the BrahMos missile was the primary weapon used by the Indian Air Force to target terrorist infrastructure in Pakistan's Punjab province, including terror hubs of Jaish-e-Mohammed and Lashkar-e-Toiba. The missile's effectiveness continued as it damaged Pakistani air bases, forcing Pakistan Army to respond and protect terrorist elements.

This move to expand the BrahMos arsenal underscores India's commitment to strengthening its defence capabilities with advanced, homegrown and joint-developed weaponry in the face of ongoing regional security challenges.





India Fuelling War Machine: Trump's 24-Hour 'Substantial' Tariff Threat

In a dramatic escalation of trade tensions, U.S. President Donald Trump on Tuesday announced that tariffs on Indian imports would be raised "very substantially" within the next 24 hours, citing India's continued purchase of oil from Russia.

"India has not been a good trading partner," Trump said during a televised interview with CNBC. "They do a lot of business with us, but we don't do business with them. We settled on 25%, but I think I'm going to raise that very substantially... because they're buying Russian oil."

Trump's latest remarks follow a similar statement a day earlier, in which he accused India of purchasing discounted Russian oil and allegedly re-exporting it for profit. He described India's actions as indirectly fuelling the Russian war effort, calling it "unacceptable." India swiftly pushed back against the accusations, with the Ministry of External Affairs issuing a sharp Highlighting European hypoc-

Obama-Era Officials Probed Over 2016 Russia Intel Claims

Federal prosecutors have launched a grand jury investigation into allegations that top officials from former President Barack Obama's administration fabricated intelligence about Russian interference in the 2016 U.S. election. The move follows recent claims by Director of National Intelligence Tulsi Gabbard and mounting political pressure from Republican leaders, including former President Donald Trump.

U.S. Attorney General Pam Bondi reportedly ordered the probe, tasking a federal prosecutor with presenting evidence to a grand jury. The Justice Department has not officially confirmed details but did announce the formation of a strike force to assess the alleged "weaponisation of the intelligence community."

Gabbard, who previously declassified related documents, has accused senior Obama-era officials of orchestrating a conspiracy to undermine Trump's presidential campaign by linking it to Russia. These allegations have been dismissed by Democrats as baseless and politically driven. Trump welcomed the development on his Truth Social platform, calling it "great news" and claiming "the truth always wins out." He has previously accused Obama of treason—without evidence—saying the former president spearheaded a plot to damage his campaign.

A spokesperson for Obama strongly denied the accusations, describing them as "ridiculous and a weak attempt at distraction." Fox News was the first to report Bondi's directive to initiate legal proceedings. If the grand jury finds sufficient grounds, the Justice Department could pursue criminal indictments against former officials.

The controversy stems from a 2017 U.S. intelligence assessment, which concluded that Russia interfered in the 2016 election through disinformation, hacking, and social media manipulation to harm Hillary Clinton and boost Trump. The report found no direct impact on voting results. As the investigation proceeds, it is likely to deepen partisan tensions and rekindle debates over the politicisation of intelligence and accountability within the U.S. government.

Zelenskyy Claims Pakistani, **Chinese Mercenaries Fighting for Russia**



Ukrainian President Volodymyr Zelenskyy has alleged that foreign mercenaries from several countries, including China and Pakistan, are fighting alongside Russian troops in the ongoing war. During a visit to the Kharkiv frontlines on Monday, Zelenskyy met with soldiers from the 17th Separate Motorised Infantry Battalion of the 57th Brigade. While assessing battlefield conditions, he was informed of foreign mercenaries participating in combat against Ukrainian forces.

"Our warriors in this sector are reporting the participation of mercenaries from China, Tajikistan, Uzbekistan, Pakistan, and African countries in the war. We will respond," Zelenskyy said in a post on X (formerly Twitter).

He also discussed key military concerns with frontline commanders, including the defence of Vovchansk, drone supplies, recruitment issues, and funding ers, announced by Zelenskyy on Sunfor battalions. Zelenskyy praised the day. soldiers' courage and presented state awards during his visit. "It is an honor for me to be here. Thank you for fighting, serving your state and the Ukrainian people, and for supporting one another," he said.

Sovereign Nations Have Right: Russia Backs India Amid US Tariff Threat

Russia has spoken out in support of India after U.S. President Donald Trump threatened to impose tariffs on countries purchasing Russian oil, calling such pressure "illegal." The Kremlin defended India's continued energy trade with Moscow, asserting that sovereign nations have the right to decide their economic partnerships.

"We hear many statements that are in fact threats, attempts to force countries to cut trade relations with Russia. We do not consider such statements to be legal," said Kremlin spokesperson Dmitry Peskov. He stressed that each country has the right to pursue trade and economic cooperation based on its own inter-

On Friday, Trump announced fresh sanctions targeting Russia and countries that continue importing its energy exports, demanding an end to the Ukraine conflict. Despite the pressure, Russian President Vladimir Putin remained firm on his position.

India has strongly rejected the U.S. tariff threats, calling them "unjustified." A statement from the Indian government emphasized that the country would take all steps necessary to protect its economic inter-

ests and sovereignty. "Like any major economy, India will take all necessary measures to safeguard its national interests and economic security," said a spokesperson from the Ministry of Exter-

India also highlighted U.S. double standards, pointing out that Washington initially encouraged energy imports from Russia following the Ukraine war. 



Govt finalises bankers to advance LIC stake sale



The Department of Investment Chawla also provided an update and Public Asset Management (DIPAM) has finalized the appointment of merchant bankers and legal advisors to facilitate the upcoming stake sale in the Life Insurance Corporation of India (LIC), DIPAM Secretary Arunish Chawla announced on Friday.

This development is a key step in the government's broader plan to divest a 6.5 percent stake in LIC over the next two years through multiple tranches of offer-forsale transactions. The objective is to comply with the Securities and Exchange Board of India's (SEBI) minimum public shareholding norms, which require LIC to have at least 25 percent public ownership by May 16, 2027.

Currently, the government holds a dominant 96.5 percent stake in LIC. It had previously sold 3.5 percent of its holdings during the company's initial public offering (IPO) in 2022. The upcoming stake sale is expected to generate around Rs 35,000 crore in revenue.

on the government's stake sale in IDBI Bank. Expressions of interest were invited in 2022 for the sale of a 30.48 percent government stake in the bank, which LIC itself holds 30.24 percent of. The government plans to shortlist the final bidder for the IDBI Bank sale by March 2026. Financial bids will be invited after October, with the goal of receiving them by December 2025.

The appointment of merchant bankers and legal advisors has been completed through a request for proposals process. These merchant bankers have been appointed for an initial tenure of three years, extendable up to five years, and will serve all government financial institutions involved in stake sales.

This move marks an important phase in the government's efforts to divest from public sector entities, aiming to raise capital and meet regulatory requirements while encouraging broader public participation in these institu-

India's Services **Sector Hits 11-Month High in July**

India's services **■** sector expanded at its fastest pace in 11 months in July, driven by robust international demand and sustained domestic sales, according to the latest HSBC Services Purchasing Managers' Index (PMI) released on Tuesday.

The HSBC India PMI, Services compiled by S&P Global, rose slightly to 60.5 in July from 60.4 in June, surpassing earlier estimates

that had forecasted a decline to 59.8. This marks the fourth consecutive year of expansion in the services sector, signaling strong underlying momentum in the economy.

The growth was fueled largely by a significant rise in new export orders, reflecting growing global appetite for Indian services. Finance and insurance were among the leading sectors contributing to this surge, showing strong performance amid improving demand condi-

The PMI measures the health of the services sector on a scale where readings above 50 indicate expansion. At 60.5, the index points to solid growth momentum, with businesses reporting increased activity levels, higher sales, and rising new work inflows.



healthy, supporting sustained sales growth alongside exports. Service providers noted an improvement in client activity, reflecting steady consumer confidence and corporate spending.

Analysts view the latest data as a positive sign for India's economic recovery, especially as the services sector accounts for a major portion of the country's GDP. The combination of strong export growth and resilient domestic demand suggests India's services industry continues to be a key driver of economic expansion.

This upbeat performance comes amid broader global uncertainties, highlighting India's competitive edge in the international services market and its potential to sustain growth in the coming months.

Adani Ports Q1 Revenue Rises 21% Led by Logistics

Adani Ports and Special Economic Zone Ltd (APSEZ) reported a strong 21% year-on-year (YoY) increase in consolidated revenue for the first quarter of FY26, driven primarily by significant growth in its logistics and marine businesses.

The company posted revenue of Rs 9,126 crore for April-June 2025, up from Rs 7,560 crore a year ago. Net profit rose 7% to Rs 3,311 crore, while EBITDA grew 13% to Rs 5,495 crore. Ashwani Gupta, Whole-time Director and CEO of APSEZ, highlighted that the logistics and marine sectors showed exceptional momen-

tum, with logistics revenue doubling to Rs 1,169 crore and marine services nearly tripling to Rs 541 crore, aided by deployment of 118 vessels.

Cargo handling volume rose 11% YoY to 121 million metric tonnes (MMT), increasing the company's all-India market share to 27.8%. Container volumes jumped 19%, and Krishnapatnam port recorded its highest-ever monthly cargo handling of 5.85 MMT in June.

Internationally, Haifa port in Israel delivered a 29% YoY volume increase, with container traffic up 25% and other cargo rising 38%, generating the best quarterly revenue and EBITDA since acquisition by APSEZ. Key expansions included launching the fully automated Colombo West International Terminal under a 35-year BOT agreement, opening a new export terminal at Dhamra Port, and starting construction of two



additional berths to boost capacity to 92 MMT. The board approved the acquisition of NQXT Port in Australia, a deep-water export terminal with 50 MTPA capacity, pending regulatory approvals.

On the sustainability front, APSEZ was named a "Leader" in the CDP Supplier Engagement Assessment 2024 and secured Zero Waste to Landfill certification for 12 ports, ranking in the top 15% of ESG-rated companies. The company raised Rs 5,000 crore through long-term debentures and launched a USD 450 million bond buyback tender, improving debt maturity and lowering

APSEZ reaffirmed its FY26 guidance, supported by growing marine operations in the MEASA region and expanding logistics services from port to customer



4,000-Year-Old 'Doorway to Afterlife' Found in **Egyptian Tomb**

Ateam of archaeologists has uncovered a remarkable find in Cairo — a massive pink granite "false door" believed to be a symbolic portal to the afterlife. The discovery was made inside the 4,000-year-old tomb of Prince Userefre, son of King Userkaf, the first ruler of Egypt's Fifth Dynasty.



archaeological site, the tomb includes inscriptions such as "hereditary prince," "governor," "minister," and "chanting priest," revealing the prince's high status in ancient Egyptian society. The centerpiece of the discovery is a 15-foot tall, 1.15-meter wide pink granite door — the first of its kind in both scale and craftsman-

According to Egyptologist Ronald Lephoron said in an interview with The New Archaeolo-

The door, which does not open, was carved as a symbolic threshold allowing the spirit — or ka — of the deceased to move between the tomb and the afterlife. Dr. Melanie Pitkin of Cambridge University explained, "Family members

The pink granite used for the door was sourced from Aswan, indicating the prince's elite status, as the material was both rare and expen-

Paan Stains Spark Outrage in **London's Harrow**

Residents of Harrow, London, are voicing frustration over the growing problem of red paan stains littering sidewalks, bins, and shop fronts. Once considered mainly an issue in India, the public spitting of paan — often mixed with tobacco leaves — has now become a serious concern in parts of Harrow, including Rayners Lane and North Harrow.

The local council has condemned the habit as "disgusting," "unhygienic," and a costly nuisance. A video circulating on Instagram

captures locals expressing their anger about the unsightly red stains that have appeared across the neighborhood, prompting a strong response from authorities.

In July alone, Harrow Council issued 33 fines to individuals caught spitting paan in public. Officers have also confiscated over 4,000 packs of illegal tobacco as part of an ongoing crackdown on shops selling banned products.

The problem intensified with the opening of a new paan shop in North Harrow, which sparked a petition from concerned residents demanding stricter enforcement and better cleanliness around such establishments.

Kerala Student Unveils "Talk-to-Write" **Device to Aid Disabled**


AKerala student has developed an innovative "Talk-to-Write" device that converts spoken words into handwritten notes, aiming to assist people with disabilities. The AI-powered system was showcased at the Ente Keralam Expo 2025 held in May and has received widespread appreciation for its potential social impact.

Ajay H, an electronics and communication engineering gradu-

ate, shared details of the device on LinkedIn. The technology uses a CNC pen plotter controlled by Raspberry Pi, Arduino (GRBL), and Python to transcribe speech into handwritten text on A4 paper, line by line.

"This platform allowed us to present how accessible, inclusive tech can be built by combining AI, embedded systems, and a clear vision for social impact," Ajay said. He also thanked his team members Aparna Hari, Roobak Hari Nair, and Akash G Nair for their dedication and creativity in bringing the project to life.

The device is designed as a digital scribe, helping those who find it difficult to write manually due to disabilities. Its ability to transform voice into neat handwritten notes offers a valuable solution for people seeking greater in-



dependence and communication ease.

Social media users have praised the innovation. Comments like "Excellent!" and "That's a great idea! If developed further, it could help many people," reflect the excitement around the project.

In related developments, engineers at Virginia Tech have created a robotic arm with an adaptive gripper to assist individuals with mobility impairments in handling objects of varying sizes and textures. This technology is particularly useful for managing delicate items like baked goods and fresh produce.

Together, these innovations mark important steps toward making technology more inclusive and supportive for people with disabilities.





Brazil Wins Ninth Women's Copa America Title

Brazil claimed their ninth Women's Copa America title after a thrilling 5-4 penalty shootout victory over Colombia at the Estadio Rodrigo Paz Delgado in Quito, Ecuador, on August 2, 2025. The roller-coaster final ended 4-4 after extra time, with both teams showing incredible resilience.

six minutes into stoppage time to send the match into extra time. Marta then scored again early in extra time, giving Brazil the lead. Colombia responded with a brilliant free-kick from Leicy Santos in the 115th minute, pushing the match to penalties.

The shootout was just as tense, with Colombia taking an early lead after Angelina missed. However, Brazil gained the upper hand when Colombia's Manuela Pavi missed and goalkeeper Lore-

na saved Leicy Santos' attempt. Marta's chance to clinch the title was saved by Colombia's Katherine Tapia, pushing the shootout to sudden death. Finally, Carabali's miss sealed Brazil's victory.

Brazil's Amanda Gutierres said, "It's Brazil's job. That mentality of never giving up is a source of pride for us." The win marks another milestone in Brazil's dominant history in women's football.

Novak Djokovic Withdraws from **Cincinnati Masters**



Tovak Djokovic announced his Withdrawal from this week's ATP Cincinnati Masters, marking exactly one year since his triumphant Olympic gold medal victory in Paris. Tournament officials confirmed the news to The Athletic on Monday, signaling that the 38-yearold Serbian star will not play any matches between his recent Wimbledon semifinal loss and the upcoming US Open, which begins in three weeks.

Djokovic's decision comes as part of his ongoing strategy to manage his schedule and fitness, following a demanding season. The world number one, alongside top players like Carlos Alcaraz and Jannik Sinner, has opted to skip the current ATP Toronto Masters to rest and recover after Wimbledon. While Djokovic sits out Cincinnati, Sinner has already been present at the venue since the weekend, preparing for the event. On Monday, Sinner and his team shared a casual selfie from a golf course on social media,

highlighting their downtime after the opening practice session at the pre-US Open tournament.

Djokovic's history at Cincinnati is notable. He first competed in the tournament in 2005 and has won it three times, including his most recent title in 2023 after overcoming the disappointment of five previous final losses. The Serbian superstar holds 24 Grand Slam singles titles, underscoring his status as one of the all-time greats in tennis.

As the US Open approaches, Djokovic's withdrawal from Cincinnati raises questions about his readiness for the last Grand Slam of the season.
