YS Jagan Demands Rollback of Medical College Privatization



VIJAYAWADA/9th OCT Former Chief Minister and YSR Congress Party (YSRCP) President Y.S. Jagan Mohan Reddy has demanded that the Andhra Pradesh government immediately roll back its plan to privatize government medical colleges. Speaking at Narsipatnam in front of the semi-completed medical college, he warned that if corrective action is not taken, the party would launch statewide pro-

Y.S. Jagan criticized the current government, alleging that while his administration had laid the foundation for 17 new government medical colleges to make medical education and healthcare affordable, Chief Minister N. Chandrababu Naidu is pushing privatization, depriving poorer sections of these facilities. He described hospitals as "modern tests and a one-crore signature campaign to exert temples," warning that private players would exploit the poor and that public health would be compromised under

Naidu's plans. Of the 17 colle

ges, five were completed during his term, including those at Pulivendula and Paderu, where classes have already begun. According to Y.S. Jagan, the total seats in these colleges would have risen to 4,910, with 2.360 seats available free of cost to poor students, while the rest would have been offered at significantly lower fees

Seven of the 17 medical colleges were completed during his term, providing 800 medical seats, but the Naidu government allegedly blocked additional seats at Pulivendula Medical College and stalled remaining projects, which could have added 2,500 seats to the state's medical education capacity.

Detailing the agitation program, Y.S. Jagan announced Rachabanda outreach programs from October 10 to November 22, constituency- and district-level dharnas on October 28 and November 12, and the collection of one crore signatures. The signature sheets would be sent to Vijayawada by November 23 and submitted to the Governor on November

During his journey to Narsipatnam, Y.S. Jagan also met VSP employees, who raised concerns about privatization, and Chodavaram Sugar Factory farmers, who claimed the government withheld 35 crore owed to 24,000 families. He further criticized land acquisition delays for a bulk drug factory and the demolition of 4,500 small shops in Visakhapatnam, which left nearly 32,500 people without livelihoods.

Y.S. Jagan concluded with a stern warning to Chandrababu Naidu, asserting that unless the privatization plan is reversed, history will judge him as a leader who disregarded the welfare of the poor and pub-


CM Directs Introduction of Mobile Rythu Bazaars

TPN / Vijayawada Chief Minister N. Chandrababu Naidu has directed officials to introduce mobile Rythu Bazaars and prepare a comprehensive master plan for upgrading existing Rythu Bazaars across the state. The initiative aims to ensure remunerative prices for farmers while providing quality produce at affordable rates for consumers.

During a review meeting on agriculture and allied sectors at the Secretariat, the Chief Minister stressed that the 218 market committee sites in the state must be effectively utilized to strengthen the agricultural marketing system. He also reviewed preparations for the PM DhanaDhanyaKrishiYojana, which is scheduled to be launched by Prime Minister Narendra Modi on October 11.

The CM emphasized the need for close coordination between the Agriculture and Marketing Departments to deliver measurable benefits to both producers and consumers. Citing the recent drop in tomato prices in Pattikonda, he instructed market committee officials to act promptly by moving the produce to Rythu Bazaars or utilizing cold storage facilities to prevent distress sales. He also called for upgrading infrastructure at all market yards and Rythu Bazaars to provide better facilities for both farmers and buyers.

Naidu directed officials to educate farmers on reducing fertilizer



and pesticide use, highlighting the harmful effects of excessive urea application. Officials informed him that 23 lakh metric tonnes of urea are available for the Rabi season. In response, the CM ordered expedited soil testing and preparation of plans to distribute micro-nutrients based on soil health results. He insisted that Aadhaar authentication be made mandatory for fertilizer distribution to

ensure transparency. The Chief Minister noted that the state anticipates a crop yield of 90.91 lakh metric tonnes this year, a 44% increase over last vear. He stressed the importance of maintaining accurate records of fertilizer distribution to both farmers and tenant cultivators.

Referring to the PM DhanaDhanyaKrishiYojana, he said farmers should be encouraged to grow high-value and profitable crops. He noted that the Central Government has committed to procure 100% of pulsing Karnataka's success ful model in sericulture, where output is eight times higher than Andhra Pradesh's. He also proposed exploring partnerships with the Bill & Melinda Gates Foundation to enhance the state's capabilities in agritech and sericulture. The Chief Minister further called for regular monitoring of vegetable prices, encouraged farmers to cultivate crops with strong market demand, and recommended linking produce to food processing units to prevent price crashes and ensure income stability. Stressing the promotion of natural farming, he urged departments to ensure fair prices for forest produce, particularly to uplift tribal communities through value addition.

Govt Will Not Tolerate Spurious Liquor Supply: Minister Kollu

TPN / Vijayawada Andhra Pradesh Minister for Mines, Geology and Excise, KolluRavindra, has reiterated that the state government will not tolerate anyone involved in the manufacture or supply of spurious liquor. Speaking at the AP Secretariat on Thursday, he affirmed that the government is taking all false reports and allegations seriously and will conduct thorough investigations to uncover the truth and ensure accountability.

The minister highlighted that the Excise Department's Enforcement Wing has been working effectively to curb illegal liquor production across the state. He emphasized that stringent measures have been put in place to regulate liquor manufacturing, enforce quality standards, and prevent the sale of adulterated products. Under the Navodayam initiative, 21 districts have already been declared illicit liquor-free, a milestone achieved through coordinated efforts between local authorities and the Excise Department.

Chief Minister N. Chandrababu Naidu has issued clear directives to completely eliminate illicit liquor from Andhra Pradesh.

Since assuming office, the coalition government has strengthened enforcement mechanisms, enhanced the functioning of border check-posts, and established laboratories in five key regions to conduct rigorous quality testing. These measures aim to curb the menace of adulterated liquor, protect public health, and uphold law and order.

Referring to a recent incident in Kadiri, Annamayya district, the minister said that during inspections on October 3, officials seized 30 cans of spirit, cartons, and bottle caps from a shed in Kodirinaidukota village. Cases have been registered against AdepalliJanardhan Rao, Kodali Srinivas Rao, and several others. Investiga-

tions are also ongoing into bars and wine shops connected to these individuals in Tenali, highlighting the comprehensive approach taken by the government to trace and penalize those involved in illegal liquor operations.

Ravindra pointed out that the government is giving special attention to the Mulakalacheruvu and Ibrahimpatnam spurious liquor cases, which had allegedly been neglected by the previous YSRCP administration. He accused YSRCP leaders of politicizing the issue and spreading false propaganda, calling it shameful misleading.

Condemning certain media reports, he said some YSRCP-affiliated outlets falsely linked natural deaths to consumption of spurious liquor. He warned that individuals spreading such misinformation via social, print, or electronic media would face action under Sections 353 and 356 of the BNS Act.

The minister also demanded that former Chief Minister Y.S. Jagan Mohan Reddy explain why no action was taken against Tenali YSRCP booth convener Kodali Srinivas Rao, who is allegedly connected to spurious liquor cases. Enforcement officials had also detained Ad $dempalli \\ Jagan mohan$ Rao, brother of Ibrahimpatnam resident Janardhan, after discovering evidence of adulterated liquor be-

AP Govt Constitutes High-Level Panel to Probe Rayavaram Firecracker Explosion



TPN / Vijayawada The Andhra Pradesh government has ordered a comprehensive probe into the tragic firecracker explosion that took place in Rayavaram, Dr. B.R. AmbedkarKonaseema district, earlier this week, which claimed multiple lives and left several others injured. Taking serious note of the incident, the state government has constituted a high-level committee to investigate the causes of the explosion and recommend strong preventive and regulato-

ry measures to avoid similar accidents in the future.

Chief Secretary K. Vijayanand issued Government Order (GO) RT No. 1841 on Thursday, formally announcing the formation of the inquiry committee. The order stated that the government views the loss of lives and injuries in the mishap with utmost seriousness. It directed the committee to conduct a thorough investigation to identify safety lapses, violations, and the persons responsible for the

The committee will be chaired by S. Suresh Kumar, Principal Secretary to the Government (Municipal Administration and Urban Development Department), while Ake Ravi Krishna, Inspector General of Police, Elite Anti-Narcotics Group for Law Enforcement (EA-GLE), will serve as a member. The panel has been tasked with examining the immediate causes that triggered the explosion at the firecracker manufacturing unit in Rayavaram and

ings that allowed unsafe operations to continue.

According to the GO, the committee will review the licensing and regulatory framework under which the firecracker unit was functioning, assess the compliance of safety norms prescribed under the Explosives Act, and identify failures in enforcement at various levels. It will also recommend a set of Standard Operating Procedures (SOPs) to ensure stricter monitoring of such hazardous industries across the state. The panel has been directed to submit its report within one week, outlining short-term and long-term measures to strengthen safety mechanisms.

The District Collector and Superintendent of Police of Dr. B.R. AmbedkarKonaseema district have been instructed to extend complete cooperation to the inquiry team. They have been directed to appoint a nodal officer to coordinate with the committee and provide all necessary data, logistical arrangements, and administrative support to facilitate the investigation. The government has emphasized that the inquiry should be transparent, evidence-based, and

ture tragedies rather than merely identifying procedural lapses.

Preliminary reports suggest that the explosion occurred due to improper storage and handling of explosive materials in violation of safety guidelines. The intensity of the blast was such that it caused extensive damage to the surrounding structures and resulted in multiple casualties. Rescue and relief operations were immediately launched under the supervision of the district administration, and injured victims were shifted to nearby hospitals for treatment.

Officials said the findings of the high-level committee would form the basis for policy-level reforms in the licensing, inspection, and monitoring of firecracker manufacturing units. The state government is expected to consider stricter regulations, mandatory periodic safety audits, and enhanced coordination between local authorities and disaster management agencies.

The inquiry panel's report, once submitted, is likely to play a pivotal role in shaping the state's future approach to industrial safety and accident prevention.



Govt to Develop Roads Worth 2,500 Crore This Year

TPN / Vijayawada Andhra Pradesh Roads and Buildings Minister B.C. Janardhan Reddy has announced that the State gov ernment will undertake road development works worth nearly 2,500 crore this year. Chairing a review meeting with senior officials of the R&B Department at the ENC office in Vijayawada on Thursday, the Minister directed them to expedite ongoing and pending projects to ensure smooth road connectivity across the

Janardhan Reddy instructed chief engineers to personally monitor field conditions and ensure timely completion of repairs and reconstruction. He asked officials to classify completely damaged roads into three priority groups and undertake restoration works accordingly.

Highlighting the need to revive stalled infrastructure projects, the Minister said around 650 km of road works under the NDB and CRIF schemes, which had been pending for some time, must be accorded top priority. The government will soon hold a meeting with NDB contractors to accelerate these projects. He assured that clearing contractors' pending bills promptly would help resume and complete the remaining works without delay.

Janardhan Reddy suggested ex-

ploring the use of drone surveys to assess the condition of roads and bridges across the State. He added that priority-based works on damaged bridges will begin shortly, while construction of nearly 10 incomplete bridges will be undertaken immediately.

In a push for innovation, the Minister announced the experimental construction of Eco Pave roads using steel slag in select areas to promote sustainable infrastructure. He also directed officials to identify four road projects that require no land acquisition or viability gap funding and implement them under the Public-Private Partnership (PPP) model.

With Detailed Project Reports (DPRs) already prepared, he called for their swift execution. Janardhan Reddy further instructed officials to utilize vacant R&B lands for PPPbased development and to fill vacant engineering posts by appointing Engineering Assistants from the Village Secretariat system to strengthen field-level supervision.

from the PPP model? Claiming it's privatization—have they proven this? The total expenditure required for medical colleges was 8,500 crore, but only 1,550 crore has been spent so far. Even then, full funds were allocated to just the Pulivendula college. Did Jagan make Pulivendula the state's capital? Is development only meant for one college? Jagan's distorted mindset does not allow him to support Andhra Pradesh's growth. He traveled 5 km by helicopter but seeks permission to travel 60 km by road. People have seen how he caused havoc in Visakhapatnam earlier. He blocked the establishment of the Tribal University in North Andhra, and now if he inspects these areas, he will witness the reality for himself," Yadav asserted.

The minister concluded by emphasizing that Jagan's actions are motivated by political theatrics rather than genuine concern for the state's development or the welfare of the people.

The letter, containing specifics of recent raids, implicated individuals, and the scale of spurious liquor circulation, is expected to influence the central authorities' decision on whether to initiate a CBI investigation into Andhra Pradesh's liquor scam.





YSRCP launches statewide movement against privatization of medical colleges

The YSR Congress Party (YSRCP) on Thursday launched a statewide movement opposing the privatization of government medical colleges in Andhra Pradesh. At the party's central office, the One Crore Signature Campaign posters were unveiled by State Coordinator Sajjala Ramakrishna Reddy in the presence of party leaders, including MLCs Lella Appi Reddy, Monditoka Arun Kumar, former MLA Malladi Vishnu, Vijayawada Mayor Rayana Bhagyalakshmi, and NTR District YSRCP President Devineni Avinash.

Addressing the gathering, Sajjala announced that a massive people's movement would begin across the state from Friday. The 45-day campaign will commence with the Rachabanda program in

all 175 constituencies, where campaign posters will be released simultaneously. Constituencylevel rallies are scheduled for October 28. followed by district-level rallies and memorandum submissions on November 12. Signature sheets collected from across the districts will be consolidated at the party headquarters on November 24, and under the leadership of Y.S. Jagan Mohan Reddy, one crore signatures will be submitted to the Governor on November 25.

Sajjala highlighted that while only 12 medical colleges were established in Andhra Pradesh over the past century, Y.S. Jagan Mohan Reddy's government had laid the foundation for 17 new government medical colleges with teaching hospitals during its five-year tenure,

of which seven were already completed. However, he alleged that Chief Minister N. Chandrababu Naidu, despite having all facilities in place, has shown no intention to complete these projects and is pursuing privatization through the Public-Private Partnership (PPP) model benefiting his associates while making healthcare costly for the poor.

He warned that the YS-RCP would firmly resist any attempts to privatize government medical colleges, emphasizing the need to address the shortage of super-specialty doctors and protect affordable healthf o r underprivileged. Sajjala also noted that Y.S. Jagan Mohan Reddy visited Narsipatnam earlier in the day as part of the ongoing campaign efforts.

The Andhra Pradesh High Court has issued directions to Neha Reddy, daughter of former MP Vijayasai Reddy, and her company Avyan Realtors LLP regarding illegal construction near the seashore in Bheemunipatnam, Visakhapatnam district. The court ordered that 48.21 lakh—the estimated cost of demolishing the concrete structure built in violation of CRZ (Coastal Regulation Zone) rules—be deposited with the Greater Visakhapatnam **Municipal Corporation** (GVMC).

The High Court further emphasized that, during the subsequent hearings, the deposited funds should be kept with GVMC. Additionally, the court sought a response from Avyan Realtors LLP regarding compensation of 17.46 crore for environmental damage caused by the illegal construction, based on a report submitted by a committee under the Ministry of Environment and Forests.

The next hearing in the case has been postponed to October 16, as ordered by the bench headed by Chief Justice Dheeraj Singh Thakur. The proceedings on Thursday were



based on a petition filed by Janasena Corporator Murthy Yadav.

Meanwhile, a committee comprising the AP Coastal Zone Management Authority (APCZMA) Member Secretary, the GVMC Commissioner, and the Visakhapatnam District Collector submitted a report noting that several restro-bars near Bheemunipatnam had been constructed in violation of CRZ regulations. The High Court directed the restro-bar owners to respond to the findings.

In a related public interest litigation (PIL), Ganta Nukaraju, President of the Gramabhivruddi Seva Sangham, requested the court to demolish four illegally constructed restro-bars and restore

the natural habitats affected by the constructions. The court has also directed the APC-ZMA Member Secretary to consider criminal action against Neha Reddy's company for

violations. The GVMC Commissioner has been instructed to recover demolition costs from the company. Furthermore, the High Court directed that a committee of experts be constituted to assess environmental damage caused by these illegal concrete structures, and to submit recommendations to the Ministry of Environment and Forests.

YSRCP will stand by Visakha Steel Plant workers: YS Jagan

Medical Services Bandh: Hospitals to Halt Treatment

Andhra Pradesh faces a major healthcare disruption as the Andhra Pradesh Speciality Hospitals Association (ASHA) announces a bandh of all services under the NTR Medical Services Trust from tomorrow, citing unresolved dues from the state government. Health Minister Satyakumar Yadav has responded, expressing concern over the impending situation and assuring action to resolve the crisis. The announcement by ASHA has sent shockwaves across the state's healthcare system. ASHA revealed that despite repeated appeals to government authorities, dues remain unpaid, forcing hospitals to operate at a loss. The association emphasized that escalating operational costs combined with an absence of payment have made the situation untenable, compelling the drastic step of suspending all medical services in hospitals affiliated with the NTR Medical Services Trust. According to the association's statement, the decision to halt services was not taken lightly. The leadership cited multiple attempts at dialogue with officials but observed that promises made in the legislative assembly by Health Minister Satyakumar Yadav for dues clearance have not materialized. The financial strain, coupled with growing frustration among hospital managements, has culminated in a total medical services bandh, effective from tomorrow. "All types of medical services will have to be stopped from tomorrow unless there is an urgent intervention from the government," the statement warned. Minister Satyakumar Yadav's ResponseRe-

acting to the crisis, Health Minister

Satyakumar Yadav acknowledged the gravity of the situation and urged hospitals not to halt services, stressing the hardship this would impose on the public. The minister pointed out that the problem stemmed largely from arrears, amounting to Rs. 2,500 crore left unpaid by the previous administration. Minister Yadav stated that since taking office, the current government has been addressing payment delays through phased, installment-based payouts. Minister Yadav reiterated the government's commitment to resolving the crisis and showed empathy for the challenges faced by the hospitals. He assured that immediate discussions would be held with Chief Minister Chandrababu Naidu. "We understand the difficulties hospitals are facing and are committed to finding a solution. I will meet with the CM to discuss how best to address the pending dues and ensure uninterrupted medical services for the people of Andhra Pradesh," Yadav said. Public Impact and Next StepsThe suspension of services poses a significant threat to healthcare access for thousands of patients relying on NTR Trust-affiliated hospitals. The move underscores broader issues in public-private healthcare partnerships and fiscal management. With government and hospital representatives expected to meet urgently, citizens hope for a swift resolution to avoid a prolonged healthcare crisis. As the state waits for clarity, all eyes remain on the outcome of discussions between Minister Satyakumar Yadav, CM Chandrababu Naidu, and the hospital association, with the wellbeing of patients hanging

Fake Liquor Racket Busted in Vijayawada: **Multiple Accused in AP Excise Case**

A major fake liquor racket operating across different parts of Andhra Pradesh has come to light following an intensive excise department investigation in Vijayawada. According to officials, counterfeit liquor bottles filled in Ibrahimpatnam were being sold at several outlets, including the ANR Bar in the name of Addepalli Janardhan Rao, and at a liquor shop in Bhawanipuram.Key accused Addepalli Jaganmohan Rao (A-2) reportedly confessed during interrogation that he had supplied fake liquor to Srinivasa Wines, a shop partly owned by Janardhan Rao. Angaluru Kalyan, the manager of this outlet, allegedly procured up to 15 cases of counterfeit liquor every week, selling them to customers and splitting the proceeds equally with suppliers. The network of operations was extensive. Authorities revealed that Jaganmohan Rao became cautious after a fake liquor consignment was recently discovered in Mulakalacheruvu. In response, he shifted his illegal production setup from the premises of the old ANR Bar to a godown close to the current bar. The counterfeit bottles were then distributed through various channels. Excise officials, acting on credible information, conducted raids and collected samples from the seized goods in the presence of mediators. These samples have been sent to the state forensic science laboratory for chemical analysis to determine the composition and potential health hazards posed by the fake liquor. Investigators say the syndicate extended beyond Vijayawada, involving individuals from other states. The accused list includes: A-1: Addepalli Janardhan RaoA-2: Addepalli Jaganmohan RaoA-3: Balaji (Bangalore)A-4: Ravi (Hyderabad) A-5: Syed Haji (Ibrahimpatnam) A-6: Katta Raju Das (Odisha)A-7: Badal Das (Odisha)A-8: Pradeep (Vijayawada)A-9: Mithun Das (Od-



isha)A-10: Anta Das (Odisha)A-11: Srinivasaddi (Owner of Srinivasa Pet Bottles)A-12: Angaluru Kalyan (Kothapeta, Ibrahimpatnam) Authorities believe the racket's interstate links may have facilitated large-scale distribution, with suppliers from Odisha and Karnataka transporting illicit material into Andhra Pradesh. The use of Srinivasa Pet Bottles reportedly aided in packaging the fake liquor to resemble genuine branded products, making detection difficult for unsuspecting customers. The offenders are facing serious charges. A case has been registered at Bhawanipuram Excise Station under several provisions of the AP Excise Act, including Sections 13 (6), 13 (25), 34 (2) 3 25, 34 (2) (1), 34 (8), 34 (5), and Sections 36 (1)(b)(c), 37, 42, 50, 50B of the AP Excise (Amendment) Act, 2020.Officials warn that consumption of such counterfeit liquor poses grave health risks, ranging from intoxication-related accidents to life-threatening poisoning. This incident underscores the need for strict monitoring of liquor manufacturing and distribution channels across the state. The AP Excise Department has intensified its crackdown on illicit liquor rackets and vowed to bring all those involved to justice. Further arrests are expected as the investigation advances, with chemical analysis results likely to serve as critical evidence in court.

Fake Liquor Racket in Mulakalacheruvu: Minister's Name Surfaces, More Officials Under Scanner

The fake liquor manufacturing case that recently came to light in Mulakalacheruvu, in Annamayya district, is taking new twists by the day, with sensational details emerging about those allegedly involved. Police and excise officials, who have already arrested several accused in connection with the racket, are now tracking the network further based on statements given during interrogation. According to official sources, the most recent development has put a local political figure under the spotlight. The name of Minister Giridhar Reddy from the Mulakalacheruvu area has allegedly surfaced in the case. Investigators claim that based on testimony given by A13 in the case, Katta Surendra Naidu, Giridhar Reddy not only had knowledge of the fake liquor business but also played a key role in its sale. Excise officials allege that Giridhar Reddy acquired the Andhra Wines shop in PTM mandal specifically to facilitate the distribution of counterfeit liquor. It was reportedly stored at his residence in Kammavaripalle before being supplied to belt shops in the region. Officials state that such organized supply channels made it possible for the fake liquor to reach multiple pockets without attracting immediate suspicion. Growing List of Suspects and Official ComplicityThe investigation has taken a serious turn after call data analysis reportedly suggested that certain excise officials had cooperated with those running the racket. This has triggered deeper scrutiny into recent police transfers and postings.In particular, CI Himabindu, who was posted to Mulakalacheruvu police station just two months ago after being transferred from another location, is now under the scanner. Authorities are probing the recommendations that led to her appointment. Officials are

also revisiting the role of her pre-

Investigators are tracking communications, financial transactions, and property details of the accused and suspected beneficiaries. Sources say that certain transactions may have been deliberately conducted under false or alternative names to obscure the trail. Government's Tough Stance. The seriousness of the issue has prompted the state government to fast-track the probe. Top-level officials have been instructed to leave no stone unturned, given the broader implications for public safety and law enforcement credibility. The government is reportedly considering stringent action against all individuals — whether political figures, police officials, or excise staff — found to be involved. The fake liquor trade has long been a menace in parts of rural Andhra Pradesh, often leading to severe health hazards and fatalities. The Mulakalacheruvu case, however, stands out for the alleged nexus among political leaders, suppliers, and law enforcement personnel. Political and Social ReactionsThe latest revelations have become a hot topic in both political and administrative circles. Opposition leaders are demanding immediate suspension of all officials named in the investigation and calling for the arrest of any politician found directly involved. Meanwhile, local residents have expressed shock, especially at claims that fake liquor was stored in the house of a public representative. As the probe continues, more names could emerge in what is now shaping up to be one of the most high-profile illicit liquor cases in the district's recent history. Police and excise teams are expected to file additional chargesheets in the coming weeks, potentially making this a long legal battle involving both political and bureaucratic accountability.

Dalit Groups Stage Protest in Narsipatnam Against Former CM Jagan's Visit

TPN BUREAU, NARSI-PATNAM, 9TH OCTO-BER: In a powerful show of dissent, several Dalit groups in Narsipatnam town of Anakapalle district staged a large-scale protest on Thursday against the visit of former Chief Minister Y.S. Jagan Mohan Reddy. The protest, organized at the town square, drew significant attention as Dalit leaders, social activists, and community representatives joined hands to form a human chain and raise slogans denouncing the former CM and his previous administration.

Carrying placards and banners, the protesters expressed their anger and grief over what they described as continuous injustice and humiliation faced by Dalit individuals during the YS-RCP regime. The participants invoked the



memory of anesthesiologist Dr. K. Sudhakar, who had faced disciplinary action and social humiliation during the pandemic period. Protesters recalled that Dr. Sudhakar, then serving in Visakhapatnam, had merely questioned the lack of adequate PPE kits for medical staff during the height of the COVID-19 crisis but was allegedly humiliated and mentally harassed by officials acting under political

Dalit groups alleged that such mistreatment and relentless pressure eventually led to his tragic death, which they termed as a "state-ininjustice."Placards displayed during the demonstration carried poignant messages such as "This is Jagan Reddy's tribute to a Dalit intellectual" and "A Dalit heart that stopped tired of



fighting the Jagan Reddy government." Resonating through the gathering were chants of "Jagan Go Back," as the protesters demanded acknowledgment of the alleged atrocities faced by Dalits under his rule.

Leaders said that inviting Jagan to Dalit-dominated areas was tantamount to reopening wounds that had not yet healed.Before the main demonstration, Dalit leaders performed a symbolic ritual in mem-

ory of Dr. B.R. Ambedkar, garlanding his statue and performing a milk anointment ceremony (paalabhishekam) as a mark of reverence and solidarity. They asserted that Dr. Ambedkar's ideals of equality

Speaking to the media, several Dalit activists emphasized that their protest was not politicallv motivated but a collective call for justice and respect. They demanded an official apology from Jagan Mohan Reddy for the alleged harassment of Dr. Sudhakar and accountability for the injustices against marginalized communities during his tenure.As Jagan's convoy entered the town later in the day, heavy police deployment was observed along the main road, ensuring that the protest remained peaceful. The incident has, however, reignited the debate over Dalit rights and the political sensitivity surrounding Dr. Sudhakar's case in Andhra Pradesh's social and political discours.

TDP, in Chittoor, Andhra Pradesh, on October 9, 2025, took out a protest, demanding the arrest of former Deputy Chief Minister Narayana Swamy for his alleged involvement in the recent Ambedkar statue burning incident in Devalampeta of Gangadhara Nellore constituency. The demonstration, marked by passionate sloganeering and pointed allegations, served as both a condemnation of the event and a critique of political maneuvering in the district.

TDP Protest DetailsThe TDP's protest began with a rally from the Gandhi statue and culminated in a spirited demonstration at the Ambedkar statue in Chittoor district. Led by prominent local leaders. including Gangadhara Nellore MLA Dr. V.M. Thomas, District President CR Rajan, "Chuda" chairman Katari Hemalatha, and former MLC Dorababu, the event drew significant attention from party workers and local citizens.

The display of unity among party ranks underscored the gravity with which the TDP views the alleged desecration of Ambedkar's legacy and the perceived attack on Dalit sentiments. Allegations Against Narayana SwamyRaising slogans throughout the protest, TDP members accused former Deputy Chief Minister Narayana Swamy of orchestrating the statue burning incident. "We will not rest until justice is served and those responsible for this heinous act are brought before the law," declared one of the party's senior leaders at the protest. Shocked and terrified, the young woman immediately started screaming for help. Her cries alerted fellow passengers nearby, who rushed to her aid.

Flexis of Dr. Sudhakar apoeared in Jagan's visit

TPN BUREAU, NAR-SIPATNAM, 9th October: Dalit Groups Protest with Flexi Sheets Ahead of Jagan's Visit to NarsipatnamNarsipatnam, Anakapalle District: Tension gripped Narsipatnam on Wednesday as several flexi sheets bearing the image of late Dr. Sudhakar were displayed across key locations in the town, ahead of former Chief Minister Y.S. Jagan Mohan Reddy's visit to the region. The flexis carried a sharp message that sparked public attention: "Are those who committed murders because they could not provide masks talking about medical colleges? People... be careful.'

The display of these provocative posters coincided with Jagan's scheduled inspection of the under-construction government medical college at Makavarapalem in Narsipatnam constituency. The messages, set up by certain Dalit group leaders, directly referred to the controversial case of Dr. K. Sudhakar, an anesthesiologist who served at Narsipatnam Government Hospital during the COVID-19 pandemic.Dalit organizations have long accused Jagan's previous government of indirectly causing Dr. Sudhakar's death.

They allege that Dr. Sudhakar, a Dalit doctor, was publicly humiliated, mentally harassed, and suspended after raising concerns over the shortage of protective gear and masks for medical staff at the height of the pan-

demic. The doctor's tragic death under mysterious circumstances later intensified criticism against the then YSRCP administration. As news of Jagan's visit spread, several Dalit activists in Narsipatnam and nearby villages expressed outrage, calling for justice for Dr. Sudhakar.

The activists alleged that those responsible for his humiliation had faced no consequences despite widespread protests at the time. "It's an insult to his memory that the same people who made his life unbearable are now visiting medical colleges and speaking about healthcare development," said a local Dalit leader, demanding accountability from the former ruling party.Au-



thorities swiftly moved to remove the provocative flexis from prominent public places, including junctions, bus stops, and near govern-

ment offices. Police maintained a close vigil in the area to prevent the situation from escalating during the former Chief Minister's visit.The incident has once again brought the issue of justice for Dr. Sudhakar back into public discussion, reviving old wounds among many in the Dalit community. Political observers note that the resurfacing of this controversy just ahead of Jagan's public engagements could have wider political implications, especially in the Anakapalle region where Dalit sentiment runs strong.

While Jagan's visit aimed to highlight progress in medical education and infrastructure, the unexpected protest through flexi displays turned the spotlight back on one of the most painful chapters of his previous tenure.







Modi's Political Dominance Faces No Real Disruption-Yet

Narendra Modi approaches the first anniversary of his third term, his political footing appears more assured than ever. The initial wobble following the BJP's reduced tally of 240 seats in the Lok Sabha has faded, replaced by a renewed confidence bolstered by recent victories in Maharashtra and Haryana—and, critically, the disarray within the Opposition.

POINT

But beneath this confidence lies a deeper truth: there is currently no disruptive idea, leader, or movement capable of challenging Modi's dominance. The political climate is stagnant. The BJP,

under Modi, has absorbed, repackaged, or outperformed the key planks of its rivals. The Opposition's playbook—from secularism and social justice to rich-versuspoor populism—feels dated and dull in contrast.

Modi, meanwhile,

continues to deliver efficient, targeted welfare to 80 crore citizens with schemes like free food grains, direct benefit transfers, and Mudra loans—making him more "pro-poor" in the public perception than his opponents. As a result, attacks branding him pro-corporate or elitist fail to stick, not because of PR spin,

but because voters see real benefits.

The caste census, the latest Congress experiment, has failed to ignite public imagination. Within Congress-led states like Karnataka, the complexities and internal frictions it creates are already surfacing. The party, once a broadbased national umbrella, appears awkward and unconvincing in its new avatar as a

caste-centric platform.
Attempts to challenge Modi on nationalism, religion, or "temple politics" are non-starters. The Opposition has no compelling ideological alternative and no charismatic disruptor.

Voters, particularly the floating 15%, are fatigued by predictable rhetoric and recycled promises.

Historically, Indian politics has been shaken by three big ideas: Garibi Hatao, Mandal, and Mandir. Today, none of these offer disruption. Hindutva remains the BJP's strength; the rest are now shared or neutralised.

Globally, figures like Trump, Georgia Meloni, and Javier Milei have succeeded by breaking the mould. India once had its own libertarian spark in C. Rajagopalachari's Swatantra Party, advocating small government, wealth



creation, and freedom from state control—an idea that may be due

Straight Talk: Just How Big Is The Effect Of Trump Tariffs On India?

tensions and trade realignments reshape global commerce, India finds itself grappling with an increasingly hostile export environment particularly from its largest trading partner, the United States. The recent wave of steep tariffs imposed by the current US administration is now threatening the very backbone of India's export economy — its informal, labour-intensive sectors.

India's bilateral trade with the US stood at \$131.84 billion, with the US accounting for nearly 18% of India's total goods exports. Yet, tariffs as high as 50%–64% on Indian goods have left key industries in distress. Leather. textiles, electronics, pharmaceuticals, and especially gems and jewellery — sectors that form the core of India's export basket - are bearing the brunt.

The informal economy, which absorbs more than 80% of India's workforce, is the



hardest hit. In Q1 FY26, informal manufacturing employment dropped by 9.3%, and the total informal workforce shrank by 2.1% to 12.86 crore. The number of enterprises declined by 4.7%, despite India's overall GDP

growing at 7.8%.

On the ground, in regions like Ambur, a leather hub, over 50 out of 300 factories have shut down since the US tariffs took effect. Workers like P. Gopi, once earning Rs 450 a day, have lost livelihoods, forcing families into crisis. Similarly, Tiruppur's knitwear industry, responsible for over

60% of India's knitwear exports, is struggling under a combined 64% tariff, pushing businesses toward Vietnam and Bangladesh, where duties are lower.

The gems and jewellery sector, employing nearly 10 lakh workers in Gujarat, is also under severe stress. The US, which imports \$10 billion worth of polished diamonds annually from India, has revised tariffs sharply, putting slim-margin polishing units at risk of

collapse.
High-value sectors
like electronics and
pharmaceuticals, key

to India's "Make in India" push, also face long-term threats. The Chief Economic Adviser warned that tariffs could shave off 0.5%–0.6% of GDP growth, a figure likely to rise with recent pharma tariffs.

Unless India diversifies export destinations, strengthens access to finance, and resolves the structural fragili in its informal economy, these external shocks risk cascading into long-term economic and social disruption — with vulnerable workers and industries paying the highest price.

Hyderabad: We need an urban climate emergency fund

his year's monsoon has once again exposed the growing vulnerability of Hyderabad to climateinduced urban flooding. Torrential rain events through the 2025 season left key areas of the city waterlogged for days, damaging roads, disrupting power supply, and halting business operations. From upscale neighbourhoods to riveredge settlements, the deluge disrupted daily life and left thousands struggling to recover.

According to longterm data, Hyderabad's average monsoon rainfall through the 20th century stood at 76.88 cm. Over the last 25 years, that average has surged to 91.84 cm. While scientists continue to study the precise links to climate change, for the city's residents, the shifting rainfall patterns are already a lived reality Each monsoon now carries the risk of

devastation.

This year, basements of high-rises were flooded, vehicles were swept away, and roads collapsed under the weight of water. But the brunt was borne by the urban poor, especially those living in vulnerable areas like Moosa Nagar, Chaderghat, and



Kishanbagh along the Musi River. For these communities, flooding meant more than just inconvenience—it meant the loss of rations, appliances, documents, and months of fragile financial stability.

Children have dropped out of school. The spread of waterborne illnesses has increased. With no insurance coverage or state relief readily available, families are left to rebuild their lives from scratch, often multiple times in a decade.

Yet, even as urban

flooding becomes a regular monsoon occurrence in Indian cities, disaster relief continues to rely on ad hoc grants and delayed government responses. This reactive approach is proving inadequate in the face of intensitying climate events.

fying climate events.
Experts now argue that cities like Hyderabad need a dedicated Urban Climate Emergency Fund—a proactive, fast-disbursing financial mechanism designed to support pre-disaster preparation and post-disaster recovery. Such a fund

shelters, health kits, temporary schooling, and direct cash transfers to affected families.

The 2025 monsoon should be a wake-up call. As rainfall becomes more intense and less predictable, Indian cities must evolve from disaster response to climate resilience. A dedicated climate emergency fund is not just an environmental imperative—it is a social and economic necessity for urban India's most vulnerable.

How Pakistan thinks: Army for hire, ideology of convenience

sudden turn in Pakistan's foreign policy has triggered global debate, as Islamabad appears to be moving closer to recognising Israel—an unimaginable move just weeks ago. This comes in the wake of former US President Donald Trump's 20-point Gaza resolution, announced alongside Israeli Prime Minister Benjamin Netanvahu. In a surprising twist, Pakistan became the first Islamic nation to openly support the plan, even before regional powerhouses responded.

Prime Minister Shehbaz Sharif's effusive praise of Trump's plan sparked confusion and quiet backtracking in Pakistan's domestic discourse. But the episode is symptomatic of a deeper pattern in Pakistan's geopolitical behaviour—one where ideological rhetoric rarely matches action.

Despite its self-declared identity as an Islamic republic, Pakistan's strategic decisions have long been shaped not by Islamic solidarity, but pragmatic self-interest-and, more often than not, anti-India sentiment. Historically, Pakistan has never taken military action to defend any Muslim cause, even while invoking the Ummah in international forums like the OIC, especially

Its military involvements in Islamic countries—from Jordan (1970) during the Palestinian revolt to Saudi Arabia (1979) during the Mecca siege—were not in defence of Islamic ideals but to protect ruling regimes. Even during the Gulf War,

PM Modi Inaugurates Rs 19,650-Crore Navi Mumbai International Airport

Prime Minister Narendra Modi today inaugurated the Navi Mumbai International Airport, marking a major milestone in India's aviation sector. Built at a cost of 19,650 crore, the Greenfield airport is expe₹ted to significantly boost trade, tourism, and connectivity across the Mumbai Metropolitan Region, Pune, and the Konkan belt. PM Modi, joined by Civil Aviation Minister Kinjarapu Rammohan Naidu, Maharashtra Chief Minister Devendra Fadnavis, and Adani Group Chairman Gautam Adani, was given a walkthrough of the state-of-the-art facility before unveiling it to the public. Addressing the

gathering, PM Modi said the airport's inauguration ends Mumbai's long wait for a second major international gateway. "This is a big step toward the vision of Viksit Bharat, which aims for gati aur pragati (speed and progress)," he said. Highlighting the government's achievements, Modi noted that India had only 74 airports in 2014, which has now grown to 160, thanks in part to the UDAN scheme. "Lakhs of people have taken to the skies for the first time, fulfilling their dreams," he added. Chief Minister Fadnavis called the airport a "game-changer" that will "redefine air travel" and drive Maharashtra's growth. The airport, built under a

Public-Private Partnership between Mumbai International Airport Ltd (a subsidiary of Adani Airports Holdings Ltd) and CIDCO, is designed to handle 2 crore passengers annually in its initial phase, and eventually scale up to 90 million. Equipped with a 3,700-metre runway, the airport will operate in tandem with the Chhatrapati Shivaji Maharaj International Airport to ease congestion and place Mumbai among global cities with multiairport systems like London and Tokyo. Airlines such as IndiGo, Akasa Air, and Air India Express have already announced plans to operate from the new facility, with domestic

Kerala Assembly Uproar: CM Vijayan's **Height Remark Sparks Body Shaming Row**

Kerala Chief Minister Pinarayi Vijayan's comment mocking the short stature of an opposition MLA has ignited a political storm and accusations of body shaming in the state assembly. The controversial remark came on Wednesday during a heated Assembly session marked by scuffles and shouting between ruling and opposition members over the alleged disappearance of gold from the dwarapalaka idols at the Sabarimala Lord Ayyappa temple. As the Opposition boycotted proceedings, tensions escalated when some of its MLAs clashed with the House's watch and ward staff, including female personnel. In response, CM Vijayan, while addressing the unrest, made a veiled reference to an unnamed opposition legislator involved in the scuffle. Using colloquial language, the Chief Minister mocked the MLA's short height and suggested that his actions were not due to physical strength but because of the legislative immunity he enjoys as an elected representative. The comment quickly drew sharp criticism. Leader of the Opposition V D Satheesan condemned the Chief Minister's remark, calling it "politically incorrect" and "body shaming." He added, "Calling themselves progressives is meaningless. They ought to be living in 19th-century Spain." The episode has added fuel to the ongoing protests by the Opposition in the Assembly over the Sabarimala gold-plating controversy. The



Opposition has been demanding accountability over missing gold and accusing the ruling LDF government of trying to deflect from the issue. The height remark has now shifted the spotlight from the gold-plating issue

to concerns about the decorum of debate in the House, sparking fresh outrage on social media and in political circles. No apology or clarification has been issued by CM Vijayan

Centre Rebuts Mamata's 'No Flood Funds' Claim. Says ₹1,290 Crore Released to Bengal

Amid criticism from West Bengal Chief Minister Mamata Banerjee over the Centre's alleged inaction during the Darjeeling flash floods, the Union Jal Shakti Ministry on Tuesday clarified that the Central government has already released ₹1,290 crore to the state under the Flood Management and Border Areas Programme (FMBAP). The Ministry rejected Banerjee's accusation that the Centre had not extended any financial help to manage the floods or responded to her repeated calls for setting up an Indo-Bhutan River Commission. In a statement, it said the Centre remains actively engaged with Bhutan on issues of river erosion, siltation, and flash floods affecting trans-border rivers in north Bengal. "The Government of India is in regular contact with Bhutanese authorities to address the shared concerns on river management," the Ministry said, adding that both countries are coordinating on mitigation efforts related to river debris and sudden water surges. Mamata Banerjee had earlier claimed that her government had received "zero support" from the Centre for tackling recurring flash floods in the region and demanded the formation of a joint river commission with Bhutan. She also criticised the Centre for not recognising the "urgent ecological threat" posed by trans-border rivers flowing from Bhutan into Bengal.



The Centre, however, maintained that it has provided substantial assistance through existing mechanisms, including FMBAP, and urged the state government to strengthen coordination with central agencies to implement flood control and disaster mitiga-

tion projects more effectively. The recent flash floods in north Bengal, triggered by intense rainfall and glacial water surges, have left several dead and displaced thousands, prompting a political row over relief and ac-

Vijay Video Calls Families of Karur Stampede Victims, Promises Visit



Nearly 10 days after the tragic stampede at Karur during his campaign rally that claimed 41 lives, actorturned-politician Vijay reached out to bereaved families via video calls on Monday evening. The move comes amidst mounting criticism over his absence from the tragedy site and delay in offering condolences in person. The outreach, conducted by Vijay's party Tamilaga Vettri Kazhagam (TVK), was coordinated by K G Arun Raj, TVK's general secretary for propaganda and policy. Raj, a former Income Tax official, led a team from Chennai to initiate the process. According to party insiders, at least eight families were contacted on the first day, with all 27 affected families expected to receive video calls in the coming days. Families were instructed not to record the private conversations, which lasted only a few minutes 2026 Assembly elections.

each. Vijay reportedly expressed sorrow, offered support, and promised to meet them in person soon. Dulquer Salmaan, Film Stars' Houses Raided Again In Luxury Car Smuggling Case

Kerala HC Allows to Seek Release of Car

The Kerala High Court permitted actor Dulquer Salmaan to approach customs authorities for the provisional release of his seized luxury vehicle — a 2004 Land Rover Defender — taken during the recent crackdown under 'Operation Numkhor'. Justice V.G. Arun directed the actor to file an application under Section 110A of the Customs Act, 1962 with the Additional Commissioner of Customs in Kochi, who must decide on the matter within one week of submission. The court also emphasised that provisional release is a legal right under normal conditions and rejection, if any, must be backed by a "speaking order" detailing reasons. The Land Rover was among over 35 luxury vehicles seized during raids on multiple properties, including the residences of actors Dulquer Salmaan and Prithviraj Sukumaran. Dulquer had earlier submitted documents to prove the vehicle's legality, but his initial request for release was denied by Customs. President Joe Biden's alleged involvement in suppressing corruption concerns in Ukraine during his tenure as Vice President in the Obama administration. According to a report by the New York Post, the files reveal that Ukrainian officials were "bewildered and disappointed" by Biden's anti-corruption speech during his December 2015 visit to Kyiv, citing his family's business ties to the controversial energy firm Burisma. The documents, recently uncovered during an internal CIA review ordered by Director John Ratcliffe, suggest that Biden's then-national security adviser, Colin Kahl, intervened to prevent a damaging intelligence report from being in-cluded in the President's Daily Brief (PDB). An internal CIA email dated February 10, 2016, from a person identified as "PDF Briefer" stated that Kahl "would strongly prefer the report not/ not be disseminated," a rare and highly unusual move for intelligence handling. At the time

of Biden's speech, his

reportedly earning USD 1 million annually as a board member at Burisma, a company long accused of corruption. Ukrainian officials, the documents say, privately viewed Biden's public remarks as hypocritical, given the ongoing US media scrutiny of Hunter Biden's role. The PDB is the most sensitive intelligence report delivered to the US President, compiling insights from across the 18-agency intelligence community. Intelligence officials claim this omission shielded the Obama administration from internal criticism and public scrutiny at a crucial time. The revelations add a new dimension to past accusations of political interference in foreign policy and intelligence reporting. The documents also implicate senior intelligence officials from the Obama era, including James Clapper, who is reportedly under federal investigation for his role in the Trump-Russia probe. Indian Captured Fighting for Russia in Ukraine. **MEA Verifying Claim**

Ukraine has claimed to have captured a 22-year-old Indian national allegedly fighting for the Russian army. The man, identified as Majoti Sahil Mohamed Hussein from Morbi, Gujarat, appeared in a video released by Ukraine's 63rd Mechanised Brigade. However, the Indian Ministry of Exter-nal Affairs (MEA) has not yet confirmed his identity or the circumstances. "We are ascertaining the veracity of the report. No formal communication has been received from the Ukrainian side so far," MEA sources told NDTV. According to The Kyiv Independent, Hussein had initially gone to Russia for studies but ended up joining the Russian army under duress. In the video, Hussein claimed he was sentenced to seven years in a Russian prison on drug charges and was later offered a deal: military service in exchange for release. "I didn't want to stay in prison, so I signed a contract for the 'special military operation'," he said, referring to Russia's war in Ukraine. After only 16 days of training, Hussein was sent on a combat mission on October 1. He claims to have fought for three days before surrendering to Ukrainian forces following a dispute with his commander. "I walked up to a Ukrainian trench, put down my rifle, and said I didn't want to fight. I needed help," he told the Ukrainian military. Hussein also alleged that promises of financial compensation were not fulfilled and expressed his unwillingness to return to Russia. This incident follows earlier reports that Russia has been recruiting foreign nationals, including Indians, with false job offers. In January, India reported 12 deaths and 16 missing cases among Indians misled into fighting for Russia. The Indian government has since raised the issue with Moscow, seeking early release of its citizens caught in the conflict.

"Transformative President": Canadian PM Praises **Trump Over India-Pak Peace**

Canadian Prime Minister Mark Carney lauded former U.S. President Donald Trump as a "transformative president" during bilateral talks at the White House, notably crediting him for fostering peace between India and Pakistan. The remarks came during Carney's second visit to the Oval Office since assuming office in March 2025. "You hosted me and some of my colleagues a few months ago, and I said at the time, 'You are a transformative president," Carney told Trump. "Since then, the transformation in the economy, unprecedented commitments of NATO partners, peace from India-Pakistan through to Azerbaijan-Armenia, disabling Iran as a force of terror—these were important." Trump, visibly pleased, nodded during the exchange. He has repeatedly claimed credit for mediating a ceasefire between India and Pakistan during a 2025 border confrontation claims that New Delhi has strongly denied. Indian officials have maintained that the ceasefire followed a request from Pakistan's military leadership and not due to third-party intervention. Carney's visit also comes ahead of a scheduled review of the United States-Mexico-Canada Agreement (USMCA). While trade tensions persist—particularly over U.S. tariffs on Canadian lumber, aluminium, steel, and automobiles—Carney offered no concrete breakthroughs following the meeting. "We're focused on building new opportunities," he said in a later statement. During the meeting, Trump humorously referred to earlier controversial remarks about annexing Canada, joking about a "merger," to which Carney replied, "That wasn't where I was going." Despite the upbeat tone and mutual praise, the talks did not yield any announcements on tariff relief. Trump praised Carney as a "world-class leader" and hinted at future progress, stating, "I think they're going to walk away very happy." Carney concluded by reaffirming support for U.S. efforts in the Middle East and expressed optimism over future trade negotiations.



LeT-ISKP Alliance Exposed: ISI Weaponising Terror in Balochistan, Kashmir



A new Indian intelligence dossier has revealed a dangerous nexus between Lashkar-e-Taiba (LeT) and Islamic State Khorasan Province (ISKP), orchestrated and funded by Pakistan's intelligence agency, the Inter-Services Intelligence (ISI). The report highlights Pakistan's continued use of terror groups as tools of statecraft, now focusing on destabilising Balochistan, Afghanistan, and Kashmir. The dossier reveals that ISKP, once labelled un-Islamic by the Afghan Taliban, is being restructured by ISI to wage a hybrid war against Baloch nationalists and anti-Pakistan factions within the Taliban regime. Recent editions of ISKP's propaganda magazine Yalgaar also indicate a shift towards Kashmir, marking a dangerous expansion of the terror threat in South Asia. A crucial piece of evidence is a photograph showing ISKP's Balochistan coordinator, Mir Shafiq Mengal, handing a pistol to LeT's Nazim-e-Ala, Rana Mohammad Ashfaq. The image reportedly captures the formalisation of a terror alliance, crafted under direct ISI supervision. Mengal, son of ex-Balochistan Chief Minister Nasir Mengal, has long operated as an ISI asset, Known for running death squads targeting Baloch nationalists, he now facilitates ISKP operations, managing arms, funding, and logistics. Under ISI's guidance, ISKP bases were set up in Mastung and Khuzdar to suppress local resistance and stage attacks in Afghanistan. After Baloch fighters killed 30 ISKP militants in March 2025, the ISI turned to LeT to rebuild its proxy strength. By June 2025, LeT leaders Rana Ashfaq and Saifullah Kasuri hosted a Jigra in Balochistan, pledging jihad against "anti-Pakistan" forces. Experts warn the LeT-ISKP collaboration signals a new phase in Pakistan's proxy war doctrine merging extremist factions under state control. The move could reignite terrorism in Kashmir and intensify unrest in Balochistan and Afghanistan. As Pakistan's denials grow weaker, the evidence of its deep state's terror complicity becomes harder to ignore.

UK PM Keir Starmer in India to Boost Trade Ties Post-FTA

UK Prime Minister Keir Starmer arrived in Mumbai on Wednesday for a two-day visit aimed at strengthening economic and strategic ties with India following the signing of a landmark Free Trade Agreement (FTA) earlier this year. Accompanied by a 125-member delegation of top business leaders-including British Airways CEO Sean Doyle—Starmer's visit signals a renewed focus on expanding the India-UK Comprehensive Strategic Partnership under the "Vision 2035" roadmap. Upon arrival at Chhatrapati Shivaji Maharaj International Airport, Starmer was welcomed by Maharashtra and Gujarat Governor Acharya Devvrat, Maharashtra Chief Minister Devendra Fadnavis, and Deputy Chief Ministers Eknath Shinde and Ajit Pawar. Later on Wednesday, Starmer is expected to hold discussions with External Affairs Minister S. Jaishankar. On Thursday, Starmer will meet Prime Minister Narendra Modi at Raj Bhavan in Mumbai. The leaders will review progress on the bilateral partnership and explore new areas of cooperation, particularly in fintech, defence, climate, and trade. The leaders will then address the CEO Forum and the 6th edition of the Global Fintech Fest, where they will engage with Indian and UK business leaders on opportunities arising from the India- $U\bar{K}$ Comprehensive Economic and Trade Agreement (CETA). With bilateral trade currently valued at \$54.8 billion, both countries



view the new FTA as a central pillar for future economic growth. The agreement includes tariff reductions on British

goods like whisky and medical devices and Indian exports like garments and frozen prawns. However, despite busi-

Gold Hits Record High of ₹1.24 Lakh per 10 Grams

Gold prices soared by ₹700 reaching an all-time high of ₹1,24,000 per 10 grams in the national capital. This sharp jump comes amid rising global uncertainty, driven by fears of a prolonged US government shutdown and increasing expectations of further interest rate cuts by the US Federal Reserve. According to the All India Sarafa Association, the yellow metal of 99.9% purity had settled at ₹1,23,300 per 10 grams on Monday. The fresh surge marks a significant milestone for gold, which continues to gain favour as a safe-haven asset in times of economic and geopolitical turbulence. Traders and analysts attributed the price rally to strong safe-haven demand, as investors around the world are growing cautious. The risk of a fiscal deadlock in the United States, combined with the Fed's dovish signals, has weakened the dollar and boosted demand for gold. "Concerns over the US government shutdown and talk of more rate cuts have pushed investors toward safer assets like gold. The weakening of the dollar has further supported this uptrend," said a senior analyst from a Delhi-based bullion trading firm. In addition to global factors, strong domes tic buying ahead of the festive season is also supporting prices in India. With festivals like Dussehra and Diwali approaching, demand for gold jewelry and investment products is expected to rise further, which could drive prices even higher. Silver also saw a modest gain, trading at ₹1,48,500 per kg, up by ₹500 from the previous close. Bullion traders expect volatility to persist in the coming weeks, with gold likely to remain firm if economic uncertainties continue to mount.



World Bank Ups India's Growth Forecast to 6.5%

Remains Fastest-Growing Major Economy



The World Bank on Tuesday raised India's GDP growth forecast for 2025-26 to 6.5%, up from its earlier estimate of 6.3%, reaffirming India's position as the world's fastest-growing major economy. The upward revision comes on the back of robust consumption growth, improved rural demand, and favourable domestic conditions. According to the World Bank's South Asia Development Update (October 2025), India's economic momentum has been supported by better-than-expected agricultural output and rising rural wages. Recent reforms in the Goods and Services Tax (GST) — including simplification of compliance and reduction in tax brackets — have also contributed to boosting business activity. "India is expected to remain the world's fastestgrowing major economy," the report stated, highlighting strong internal drivers of growth. However, the World Bank also issued a cautionary note, citing external risks. The imposition of 50% tariffs by the United States on nearly 75% of Indian exports is expected to impact trade and may slow down economic growth in the coming year. As a result, the GDP forecast for 2026-27 has been revised downward to 6.3%, from the earlier projection of 6.5%. The report noted that growth across South Asia is projected to slow sharply from 6.6% in 2025 to 5.8% in 2026, mainly due to weaker export demand and tightening global financial conditions. Despite the slowdown, South Asia will still outperform other emerging markets and developing economies (EMDEs). Inflation in India is expected to remain within the Reserve Bank of India's target range, aided by stable commodity prices and monetary policy continuity. Overall, while India's economic outlook remains strong, the report emphasizes the need to stay vigilant amid rising global trade tensions and policy uncertainties.

Tata Trusts Infighting Deepens, Govt Steps In Amid 'Coup Attempt' Allegations

A power struggle within Tata Trusts, the principal shareholder of Tata Sons, has escalated sharply, with reports of a "coup attempt" by four trustees against Chairman Noel Tata. The infighting has drawn the attention of the government, which is now actively engaging to prevent instability at the \$180-billion Tata Group. Sources close to the Tata Group told CNBC-TV18 that the Centre is "fully seized of the matter" and cannot remain a silent spectator. The tension centres around governance issues, board appointments at Tata Sons, and a growing divide between factions of trustees. On Tuesday evening, Noel Tata and Tata Sons Chairman N Chandrasekaran, accompanied by Vice-Chairman Venu Srinivasan and trustee Darius Khambata, held a closed-door meeting with Union Home Minister Amit Shah. Finance Minister Nirmala Sitharaman also attended the high-level discussions. The current rift is reportedly driven by four trustees — Darius Khambata, Jehangir HC Jehangir, Pramit Jhaveri, and Mehli Mistry — who are alleged to be functioning as a "super board," undermining Noel Tata's authority. Key disagreements include the proposed ₹1,000-crore equity infusion into Tata International, chaired by Noel Tata, and suggestions around new executive roles at Tata Sons. In contrast, the faction opposed by Noel Tata reportedly pushed for the appointment of Mehli Mistry to the Tata Sons board—an idea Noel resisted. Discontent over unilateral decisions has been reflected in internal communications, including a May 26 email from Mistry objecting to board appointments without full trustee approval. The Tata Trusts board is set to meet on October 10, with key philanthropic decisions on the agenda. While sources claim the meeting is unrelated to the internal tensions, many expect the power struggle to overshadow proceedings. The government's intervention under-



September CPI Seen at 1.2% **Amid Sharp Fall in Food Prices**



India's retail inflation is expected to ease significantly, with the Consumer Price Index (CPI) projected at just 1.2% for September 2025, according to Bank of Baroda's latest Price Picture report. The report attributes this sharp moderation to continued deflation in essential food items, especially tomatoes, onions, and potatoes (TOP), alongside a favourable base effect. The BoB Essential Commodities Index (BoB ECI) remained in deflation for the fifth straight month, showing a 1% year-on-year decline in September and a sharper 3.8% fall in the first six days of October. Month-onmonth, the index dropped 0.3%, indicating sustained easing in food price pressures. Retail prices of tomatoes fell by 8.3% in September, while onions and potatoes witnessed even steeper declines -46.2% and 30.9%, respectively. These corrections were driven by strong market arrivals and efficient supply

chain management "Headline CPI is experiencing a food-driven downward spiral, supported by robust arrival statistics of TOP vegetables," the report stated. Notably, cumulative arrivals of these key vegetables rose by 10.3% in FYTD26, a sharp turnaround from a 15.4% contraction during the same period last year. Additionally, global food prices have remained favourable, and recent GST rate cuts by automakers, FMCG companies, and e-commerce platforms are also contributing to the disinflationary trend. Bank of Baroda now expects the headline CPI to fall well below the Reserve Bank of India's inflation forecast for FY26, easing pressure on monetary policy and potentially creating room for rate cuts if needed. The continued deflationary trend could also support consumer sentiment and boost discretionary spending in the upcoming festive season, further aiding economic recovery.

Rupee Rises 2 Paise to 88.75 **Against U.S. Dollar Amid Range-Bound Trade**



The Indian rupee appreciated marginally by 2 paise to 88.75 against the U.S. dollar in early trade on Wednesday, tracking a positive trend in domestic equities and limited inflows linked to ongoing IPO activity. The local currency had closed at 88.77, after falling 3 paise. At the interbank foreign exchange market, the rupee opened at 88.76 and moved slightly to 88.75, showing modest strength despite ongoing global headwinds. Traders described the movement as rangebound, with broader cues keeping the currency under pressure. "Rupee is expected to remain in the range of 88.50 to 89.00 for the day as inflows on account of IPOs remain tepid with subscriptions being completed only on the last day," said Anil Kumar Bhansali, Head of Treasury and Executive Director, Finrex Treasury Advisors LLP. He also warned that negative global cues, including a stronger dollar index

and weaker Asian currencies, could challenge the rupee's position unless the RBI steps in to defend the crucial 88.80 level. The dollar index, which measures the greenback's strength against a basket of six major currencies, was trading higher at 98.85, up 0.28%. Meanwhile, Brent crude oil rose 0.75% to \$65.94 per barrel, putting some pressure on import-heavy economies like India. On the equity front, domestic markets opened strong with the Sensex gaining 254.02 points to reach 82,180.77, while the Nifty rose by 70.25 points to 25,178.55. Foreign institutional investors (FIIs) were net buyers on Tuesday, investing ₹1,440.66 crore in Indian equities, according to exchange data. Commerce Minister Piyush Goyal also noted that India and the U.S. remain in active talks over a bilateral trade agreement, though the ongoing U.S. government shutdown may delay further negotiations.

His remarks, however, quickly sparked backlash. Many social media users criticised the glorification of extreme



Baahubali: The Epic' Re-Release on Oct 31; No **Baahubali 3 Announcement Yet**


