

AP CABINET APPROVES 1.27 LAKH CRORE INVESTMENTS

TPN/VIJAYAWADA In a landmark decision underscoring Andhra Pradesh's renewed growth trajectory, the state Cabinet, chaired by Chief Minister Nara Chandrababu Naidu, on Friday approved a record 1,27,181 crore worth of investments poised to generate 78,771 new jobs across multiple sectors, including industry, en-

ergy, tourism, and urban

infrastructure. Announcing the decisions taken at the 32nd e-Cabinet meeting, Information & Public Relations and Housing Minister KolusuParthasarathy said the approvals reflect the government's aggressive industrial and digital expansion agenda. Since assuming office in June 2024, the government has cleared 149 proposals worth 7.37 lakh crore, creating nearly 7 lakh jobs.

A significant portion of the newly approved investments will anchor

Andhra Pradesh's manufacturing and defense production base.

Among the major ap-

provals is a 260 crore in-

vestment by M/s Sunveera Industries Ltd to establish an advanced carbon complex in Anakapalle district, generating 800 jobs. In the cement, aerospace, and automotive sectors, Raymond Group subsidiaries M/s JK Mini Precision Technology Ltd and M/s JK Mini Global Aerospace Ltd will set up units in Anantapur district, alongside a new cement plant in Palnadu. These three projects together represent 5,800 crore in investments and 6.646 jobs.

The Cabinet also approved land allotments and plans for new industrial hubs. M/s Bharat Dynamics Limited (BDL), a Defence PSU, will establish a propellant plant at Donakonda in Prakasam district with a 1,200 crore investment, creating 1,400 jobs. In addition, new industrial estates will be devel-

oped in Kurnool and a

logistics hub in

Visakhapatnam. A major highlight is the approval for a Private Mega Industrial Park by M/s JSW Industrial Park Ltd over 1,166 acres in Vizianagaram district. The 531 crore project aims to create 45,000 MSME-linked jobs across textiles, agri-processing, EV manufacturing, and green hydrogen production.

Andhra Pradesh's digital and infrastructure vision received a huge push with two key approvals.

In one of the state's biggest tech investments, M/s Raiden Infotech India Pvt. Ltd, a Google subsidiary, will set up AIpowered hyperscale data centers in Visakhapatnam and Anakapalle districts. The 87,520 crore project will generate 200 direct and thousands of indirect jobs, marking a milestone in the state's data and AI ecosystem.

Additionally, M/s Imaginnovate Tech Solutions will build an IT campus on 4.05 acres in Bheemili, Visakhapatnam, with a 140 crore investment and 2,600 job opportunities.

The Cabinet continued its focus on renewable energy and food security. M/s Tata Power Renewable Energy Ltd received approval for a 400 MW solar project in Anantapur, while M/s Amipin Energy Transition Pvt. Ltd was permitted to expand hybrid energy projects in Kurnool and Nandyal.

In a significant renewable initiative, M/s Chinta Green Energy Pvt. Ltd will establish a 2,000 MW Duggeru Pumped Storage Project (PSP) in Vizianagaram district. The project is expected to generate 1,230 crore in revenue for the state's Green Energy Development Fund over 40 years and create 3,000 jobs.

Food processing also received a strong boost. M/s Reliance Consumer Products Ltd will set up a 758 crore food park in Orvakal, Kurnool, generating 500 jobs. M/s Fair Exports (Índia) Pvt. Ltd (Lulu Group) will lease 7.48 acres at the Mallavalli Mega Food Park for a core processing center.

Tourism and hospitality projects worth 1,628.8 crore were approved, set to create 4,398 direct chayat Raj system, the jobs. These include Courtyard by Marriott and Daspalla hotels in Amaravati, a Hilton Garden Inn in Srisailam, and a luxury eco-resort in Araku Valley by VSK Hotels.

Land was also allocated for an Oberoi (Vilas) Resort in Tirupati and for redeveloping the Taj Gateway 5-Star Deluxe Hotel on Visakhapatnam's Beach Road.

In Amaravati, the Cabinet sanctioned 212.22 crore for constructing the Governor's Residential Complex, including the Mansion, Assembly Darbar Hall, and Governor's Office-reaffirming Amaravati as the state's permanent capital. The APCRDA has also been authorized to allocate land for four new convention centers to strengthen Amaravati's business ecosystem.

In a sweeping reform, the Cabinet approved the restructuring of the Panmost comprehensive in 48 years. The existing 7,244 clusters will be dissolved, and 13,351 Gram Panchayats will function as independent units. Panchayat Secretaries will now be designated as Panchayat Development Officers (PDOs), organized into three grades.

This administrative overhaul is expected to save the state 37.77 crore annually without additional financial burden.

The Cabinet also approved amendments to the Industrial Disputes Act, 1947, and introduced "The Labour Laws (Andhra Pradesh Amendment for Compounding of Offences) Bill, 2025," aimed at enhancing ease of doing business. Additionally, a 5,000 crore HUDCO loan guarantee was sanctioned for developing industrial clusters in Orvakal, Kopparthi, and

A1 JANARDHAN RAO ARRESTED **IN SPURIOUS LIQUOR CASE**

A major breakthrough has been achieved in the MulakalaCheruvu fake liquor case in Annamayya district, with the arrest of the main accused, Janardhan Rao, a resident of Vijayawada. The Excise Department officials detained him at Gannavaram Airport upon his arrival from South Africa, acting on prior intelligence about his travel plans.

According to police reports, Janardhan Rao, along with his associate Raju, allegedly rented a house in the Kanugonda Arch area of MulakalaCheruvu and set up an illegal liquor manufacturing unit. Acting on credible information, Excise officials conducted raids on the premises recently and seized fake liquor worth approximately 1.75 crore.

Investigations revealed that Janardhan Rao and his associates had been producing counterfeit liquor using the labels of wellknown brands such as Gold Admiral, Classic Blue, Kerala Malt, and Manieera. These counterfeit products were so meticulously packaged that they were nearly indistinguishable from genuine brands. Police also discovered bottle sealing machines, hologram stickers, and packaging cartons at the site.

Authorities said that the fake liquor manufactured in MulakalaCheruvu was being processed further at a bottling unit located in Ibrahimpatnam, near Vijayawada, before being distributed to various outlets. The team identified another illegal manufacturing hub near the ANR Bar in Ibrahimpatnam, where fake liquor was being produced and sold directly to the market.

During searches, police found thousands of



with the counterfeit liquor, complete with genuine-looking caps and holograms. The finished products were reportedly supplied to liquor shops and belt shops across parts of Krishna and Annamayya districts. Officials confirmed

that Janardhan Rao's brother, Jaganmohan Rao, had already been arrested earlier in connection with the same case. Investigations have now established that the two brothers were the key figures operating the large-scale racket. Together, they are suspected of running an organized fake liquor network across multiple districts, with potential links to other states.

Excise officials said the racket posed a serious threat to public health and safety, as the counterfeit alcohol was being produced using unregulated and potentially toxic substances. Samples of the seized liquor have been sent for laboratory testing to composition and possible health hazards.

Authorities have intensified their probe to trace the supply chain, raw material sources, and financial transactions linked to the racket. More arrests are likely as the investigation expands to identify others involved in production, transport, and

Excise officials lauded their team for swiftly acting on intelligence inputs and preventing large-scale distribution of the fake liquor. They added that this operation marks a significant step in curbing illicit liquor trade in Andhra Pradesh, which has seen a rise in such activities in recent months.

Meanwhile, Janardhan Rao has been taken into custody for interrogation, and officials said further details will emerge once he is questioned about the broader network and his international connections.

SPURIOUS LIQUOR IS THE BIGGEST SCAM: YSRCP

She criticised that TDP leaders, constituency in-charges, and their relatives of

GREEMENT ON GOOGLE DATA **CENTER ON 14thAT DELHI**

Andhra Pradesh Chief Minister N. Chandrababu Naidu and Information Technology Minister Nara Lokesh are scheduled to visit New Delhi on October 13 and 14 for a series of highlevel meetings and investment discussions. The highlight of the visit will be the signing of a major Memorandum of Understanding (MoU) with Raiden, a subsidiary of Google, to establish a massive data centproject Visakhapatnam.

Valued at around 84,000 crore, the project represents one of the largest technology investments in Andhra Pradesh's history and is expected to significantly boost the state's digital infrastructure, employment generation, and industrial growth.

According to government sources, the MoU will be formalized in the presence of Union Minister for Electronics and Information Technology AshwiniVaishnaw, Chief Minister Chandrababu Naidu, and Minister Nara Lokesh. The agreement will pave the way for the development of an ultra-modern data

center campus in Visakhapatnam, positioning Andhra Pradesh as a major hub for cloud computing, AI infrastructure, and digital services

Officials said the data center will not only support Google's growing cloud network but will also attract other global technology players to invest in the region, creating a robust digital ecosystem. The project is likely to generate thousands of direct and indirect jobs, provide a major boost to ancillary industries, and stimulate

infrastructure development around Visakhapatnam.

Before departing for Delhi, Chief Minister Naidu will inaugurate the CRDA Project Office in Amaravati on the morning of October 13. The office is expected to play a pivotal role in accelerating development activities in the state capital region. Following the event, both Naidu and Lokesh will proceed to New Delhi to participate in the MoU signing and related discussions.

During the two-day visit, the Chief Minister is also expected to hold meetings with senior Union ministers to discuss key infrastructure, industrial, and digital initiatives being undertaken in Andhra Pradesh. There is also a possibility of a meeting with Prime Minister Narendra Modi, where Naidu is likely to seek central support for ongoing and proposed projects, including those related to green energy, port development, and technologydriven governance reforms.The visit underscores the state government's renewed focus on attracting glob-

al investments and trans-

forming Andhra Pradesh into a leading destination for technology and innovation. Since assuming office, Naidu and Lokesh have prioritized rebuilding investor confidence, re-establishing international partnerships, and fast-tracking projects in the IT and electronics sectors. If finalized, the Raiden-Google data center project is expected to serve as a landmark achievement for the state, symbolizing Andhra Pradesh's resurgence as a preferred investment hub for multinational technology firms.

NMC ENDORSES PPP MODEL FOR MEDICAL COLLEGES: PATTABHI

Telugu Desam Party (TDP) leader and Andhra Pradesh Swachhandhra Corporation Chairman KommareddyPattabhiram has strongly defended the state government's decision to establish medical colleges under the Public-Private Partnership (PPP) model, saying the initiative aligns with recommendations made by the National Medical Commission (NMC).

Pattabhiram referred to recent remarks by NMC Chair-Dr. m a n AbhijatChandrakant Seth, who stated that the PPP model is among the most effective ways to advance medical education and healthcare infrastructure in India. Citing these comments, Pattabhiram questioned the opposition voiced by former Chief Minister Y.S. Jagan Mohan Reddy, who has criticized the state's move to adopt the model.

"The NMC itself has endorsed the PPP model for expanding medical education. How can Jagan Reddy oppose a policy supported by the country's top medical regulatory body? Pattabhiram asked. He added that the NDA government, led by Chief Minister N. Chandrababu Naidu, had taken up this ap-



proach to accelerate the construction of new medical colleges across Andhra Pradesh.

Explaining the benefits of the PPP system. Pattabhiram said the model ensures timely completion of projects, operational efficiency, and greater access to medical education, especially for students from economically weaker sections. The initiative, he noted, will help bridge the gap between public and private investment in healthcare infrastructure while maintaining transparency and accountability.

He further said that under the PPP model, the state will partner with reputed private institutions that have proven expertise in managing medical education and hospital facilities. "This collaboration will not only improve the quality of medical education but also enhance healthcare delivery in underserved areas." Pattabhiram said.

According to him, the new institutions will collectively add around 110 medical seats reserved for students from underprivileged backgrounds, ensuring that the benefits of expanded capacity reach those most in need. He said the state government has a clear roadmap to ensure fair admissions, reasonable fee structures, and consistent monitoring of academic standards in these colleges.

Pattabhiram asserted that while the NDA government is committed to development and modernization in health and education, the YSR Congress Party (YSRCP) is resorting to what he called "politics of obstruc-tion." "Instead of supporting a forwardlooking initiative that improves healthcare and creates opportunities for youth, Jagan Reddy and his party are behaving like a gang of disruptors trying to block every positive step," he said.

Reiterating the state government's focus on reform-driven governance, Pattabhiram emphasized that the PPP model would enable Andhra Pradesh to expand medical infrastructure faster than conventional public projects. "The objective is clear — better facilities, better education, and better healthcare for all," he

AAROGYASRI IS WEAKENING BY CHANDRABABU: VIDADALA RAJINI



TPN/Vijayawada Former Minister VidadalaRajini launched a sharp attack on the coalition government led by Chief Minister N. Chandrababu Naidu, alleging that the flagship Aarogvasri health scheme has collapsed under his administration and "turned into

Anarogyasri." Rajini said that with over 3,000 crore in pending arrears, several network hospitals have stopped providing services and displayed notices refusing treatment to Aarogyasri patients. Despite repeated representations and letters to the government, no action has been taken, she said. "Not a single state in the country has witnessed such a total breakdown of healthcare services," she added.

The former minister highlighted that under the previous YSRCP government, Aarogvasri services were expanded from 1,059 to 3,257 medical procedures, the AarogyasriAasara initiative was launched, and the number of network hospitals increased from 900 to 2,300. She also recalled the introduction of the Family Doctor scheme, which brought medi-

cal services closer to rural communities, particularly during the COVID-19 pandemic.

Rajini accused the present government of neglecting public health as network and PHC doctors remain on strike, leaving patients to fend for themselves. "Families are being forced to sell assets for education and healthcare," she said.

Criticizing the government's proposed insurance-based healthcare model, Rajini remarked "They have no clarity-sometimes it's an insurance model, other times a hybrid model-but even that is capped at just 2.5 lakh."

She alleged that while other states are adopting YSR's Aarogyasri model, the coalition government is attempting to dismantle it by moving towards the privatization of medical colleges

The YSR Congress Party demanded the immediate clearance of arrears to hospitals and a rollback of the PPP model in healthcare. "The government's duty is to ensure health and financial security for every citizen. This coalition is doing neither," Rajini said.

ly," she asserted. Highlighting the importance of continuous awareness programmes, Shailaja stressed that such efforts must go beyond symbolic observances. "Awareness campaigns should not be Day (October 11). They should be carried out throughout the year to create a lasting impact," she said.

The Chairperson also revealed plans to integrate women's rights and legal awareness education into the school and college curricula to help students understand the laws that protect them. "Educating young people about gender equality, legal rights, and digital safety is essential to preventing many issues before they occur," she added.

Shailaja noted that a

majority of complaints received by the Commission arise from mistakes or misjudgments made at a young age due to a lack of awareness. She emphasized the need for limited to occasions like statewide legal literacy International Girl Child campaigns to empower women and girls with knowledge of their rights and remedies available under the law.

Earlier, Marpu Trust Chairperson R. Behera said the programme aims to create a sustainable market platform for SHG women and rural craftsmen, thereby improving their livelihood opportunities and ensuring greater financial independence.

The initiative, organised with the support of Nestham Voluntary Organisation under NAB-ARD's assistance, seeks to bridge the gap between urban consumers and rural creativity. "Through this platform, we are not only supporting livelihoods but also celebrating the cultural and artistic diversity of rural India," Behera

He explained that the 'Stall in Mall' exhibition will continue till January 9, featuring products from artisans across Andhra Pradesh, Odisha, Chhattisgarh, and Telangana. He urged people in Vijayawada to visit the stalls and encourage rural artisans by purchasing their handmade products. Sanitation Workers Stage Protest at Tullur CRDA Office Demanding Salary Arrears, Wage Hike



TPN BUREAU, AMAR-AVATHI, OCTOBER 10: Tullur, Amaravati: Sanitation workers employed in the capital Amaravati under the auspices of the Centre for Indian Trade Unions (CITU) besieged and staged a sit-in protest at the Capital Region **Development Authority** (CRDA) office in Tullur on Friday. The workers demanded immediate payment of two months' salary arrears for August and September and a wage hike to Rs. 21,000, seeking parity with sanitation workers in other municipalities of Andhra Pradesh.

The workers steadfastly remained seated in the office, raising slogans and vocalizing their frustration for over an hour, amid a tense atmosphere. They pressed the officials to address the salary backlog and presented a petition to the Nodal Officer, Jaya Sri, through the Deputy Collector. The protest saw active participation from sanitation workers, CITU leaders Ravi, Lakshmana, Bhagyaraju, and CPM state secretary CH Baburao, who led the agitation and voiced the

workers' grievances. After prolonged discussions between officials and representatives of the sanitation workers, and following assurances from the authorities that salary arrears would begin to be paid from Friday evening, the workers called off their protest. The union also submitted petitions demanding that along with arrear payments, wages be increased to Rs. 21,000 to bring them on par with other municipal workers across the state. They raised additional concerns regarding unpaid Provident Fund and Employees' State Insurance (ESI) dues affecting housekeeping workers and sanitation staff working in government offices and villages of Amaravati. Speaking on the occa-

attitude toward the workers and farmers of the capital. He lamented the irony that while Amaravati is being developed with investments amounting to several lakhs of crores, sanitation workers cleaning the roads and offices had to protest for their basic wages. Baburao criticized advances being given to major construction companies like L&T, Shapoorji, and NCC, while the workers who labored for them were left unpaid. He highlighted the wage disparity where apparently Rs. 21,000 is paid to sanitation workers in surrounding municipalities such as Mangalagiri, Tadepalli, Vijayawada, and Guntur, whereas workers in Amaravati receive only Rs. 12,000, calling it an outright discrimination against the poor of the capital. Baburao accused the CRDA and government of violating labor laws and failing to provide promised social security to the workers, despite presenting a favorable

banks like the World Bank. The leaders pointed out that the number of sanitation workers in Amaravati has been reduced by half, negatively impacting public health in the region. They also decried delays in rent payments to farmers and stagnation in the devel opment of plots, expressing disappointment over the government's lack of employment provisions for local people and failure to fulfill commitments made to workers and farmers.Baburao urged the Municipal Minister Narayana to cease foreign travels and instead visit the villages of Amaravati to listen to the voices of the poor, workers, and farmers and to fulfill the promises of wage hikes and regular salary payments.

The agitation leaders warned that the protest would intensify if issues remained unresolved.Be sides Baburao and Ravi, CITU leaders Lakshmana Rao, Bhagyaraju, Babu, Mabu, Sushila, Gopi, Bujji, and several others participated in the protest. The sanitation workers affirmed that they would resume agitations if the government fails to pay the full arrears and meet their demands for wage increase and improved working conditions.

The CRDA Deputy Collector Jaya Sri briefed that efforts were ongoing to resolve the payment issue, with initial payments scheduled to be deposited by Friday evening and the balance by Monday, as promised to the workers. Supremd court issues interim protection to Chevireddy Mohith Reddy

Chevireddy Mohit Reddy, son of YSRCP leader and former MLA Chevireddy Bhaskar Reddy, has received interim protection from the Supreme Court in the ongoing Andhra Pradesh liquor scam case. The apex court granted him relief and directed that no coercive action, including arrest, be taken against him for the next four weeks. bench headed by Justice Vikram Nath heard the matter today. The court also issued notices to the Andhra Pradesh government and directed the Special Investigation Team (SIT) probing the case to file its counter within four weeks. The matter is scheduled for the next hearing after this period. The liquor scam in Andhra Pradesh involves alleged irregularities and massive money laundering tied to liquor kick-

backs and election funding. Mohit Reddy is accused of misusing his position as the chairman of the Tirupati Urban Development Authority (TUDA) and using official vehicles to transport illicit money.

Investigations suggest that he played a significant role in channeling unaccounted cash through benami companies and deploying it for the 2024 election expenditures. Mohit Reddy's defense team argued that the case against him was politically mo-



tivated and that there was no direct evidence apart from the statements of co-accused individuals. The Andhra Pradesh High Court, however, dismissed his anticipatory bail plea last week, citing the

gravity of the allegations and the ongoing investigation. Earlier this year, Chevireddy Bhaskar Reddy, Mohit's father, was arrested while allegedly trying to flee the country amid the investigation.

The family's companies and properties have been raided by SIT teams multiple times, uncovering several shell companies with suspicious financial transactions linked to the liquor scam. The Supreme

Court's interim protection allows Mohit Reddy temporary respite from arrest while ensuring that the probe continues robustly. The SIT has been directed to finalize their investigation and respond in court within the stipulated four weeks. This latest development is significant in the politically sensitive case that has rocked Andhra Pradesh, with prominent political figures from YSR Congress Party being implicated.

The liquor scam case itself revolves around a

staggering Rs 3,200 crore financial irregularity involving illicit funds derived from liquor sales and kickbacks. While Mohit Reddy enjoys temporary relief, the shadow of the liquor scam looms large, with the investigation ongoing and more legal hurdles expected in the coming weeks. The Supreme Court's intervention underscores the case's gravity and the judiciary's role in overseeing the legal process in high-profile political and financial scandals.

Minister Satyakumar Yadav Emphasizes Urgent Need for More Mental Health Professionals in Andhra Pradesh

All set for entertainment. Mini Theater at Vijayawada's PNBS Ready to Reopen After 5 Years

TPN BUREAU, VIJAYAWADA, OCTOBER 10:

After a gap of almost five years, the much-talked-about mini theaters at Pandit Nehru Bus Station (PNBS) in Vijavawada are finally set to reopen, bringing renewed entertainment options for passengers and visitors. Andhra Pradesh State Road Transport Corporation (APSRTC) officials have announced that tenders have been successfully called, and arrangements are now being made to lease the premises to the current contractor on a monthly rental basis of ₹2.50 lakh. The mini theaters, popularly known as Y Screens, were first introduced at PNBS in 2015, marking a pioneering concept in India. Designed to provide shortduration movie screenings and entertainment for bus passengers during waiting periods, the facility quickly gained attention as an innovative blend of transport utility and leisure. Equipped with modern seating, sound systems, and air-conditioning, the theaters catered to travelers looking to enjoy a cinema experience without having to leave the bus station premises. However, the venture faced difficulties in 2020 when APSRTC officials seized the premises due to the operators failing to pay rents on time. The decision effectively shut down the facility, leaving the once vibrant entertainment zone inoperational. Despite multiple attempts by APSRTC to revive the concept by inviting new bidders through tenders over the past five years, there was no significant response, resulting in the space remaining unused. In a fresh push to reopen the theaters, APSRTC has now finalized plans to lease them to the current contractor at a fixed monthly rent of ₹2.50 lakh. Officials believe this arrangement



will not only revive passenger entertainment but also generate steady income for the corporation. The reopening is expected to happen in the coming weeks after all contractual and logistical processes are completed. Interestingly, in the earlier operational phase, APSRTC had permitted the setting up of small shops around the theater to serve snacks, beverages, and other passenger needs. These stalls added to the vibrancy of the area and acted as an additional source of revenue for the bus station. However, APSRTC officials have clarified that, this time, no permission has been granted to set up any commercial shops around the theater premises. This decision is expected to maintain better crowd control, reduce clutter, and keep the focus solely on the theater's core entertainment function. Passengers and local residents have welcomed the move, seeing it as a step toward reviving a unique facility that had once set Vijayawada apart from

other bus stations in the country. Industry watchers say the combination of bus travel and cinema could prove to be an attractive model if managed efficiently, as it caters to both long-distance travelers with waiting time and local visitors seeking short entertainment. Given PNBS's position as one of the busiest transport hubs in Andhra Pradesh, officials are optimistic that the reopening will draw significant footfall, especially during evenings and weekends. This initiative is also aligned with AP-SRTC's broader goal of diversifying revenue streams beyond traditional ticketing, ensuring that bus stations evolve into lively, multi-functional spaces. If successful, this revival could inspire similar projects in other major bus stations across the state and potentially across India. The countdown has begun for the Y Screens at PNBS to switch on the projector lights once again, bringing back a long-missed dose of cinema for travelers.

Dwakra Loan Scam of 2.80 crore Unearthed in Gollapudi



CC and APM Suspended Amid Major Irregularities A major Dwakra loan scam has come to light in Gollapudi village under Vijayawada Rural Mandal, exposing serious violations in the sanctioning process of government loans meant for women self-help groups (SHGs). District Rural Development Agency (DRDA) Project Director A.N.V. Nanchara Rao on Thursday issued suspension orders against Gollapudi Cluster Coordinator (CC) Chimata Srilakshmi and Assistant Project Manager (APM) Gandhamu Chandrasekhar, who allegedly diverted huge sums meant for women's empowerment. According to official sources, the two suspended officers recently sanctioned loans in the names of 14 women's savings societies at a National Bank near the NTR statue in Gollapudi. Each society was granted a loan of ₹20 lakh, bringing the total to a massive ₹2.8 crore. The fraudulent operations were reportedly carried out from a building located on Saipuran Colony Road in Gollapudi. Officials say that the accused flouted all established procedures of the Micro Credit Plan (MCP) system, which is mandatory for sanctioning loans to women's groups. Preparing an MCP ensures transparency by verifying whether the members have already received loans elsewhere or are part of other groups. However, in this case, CC Srilakshmi allegedly collected Aadhaar cards of women from different areas including Vi-

jayawada city, Kondapalli, and nearby villages and grouped them under fake savings societies. Instead of entering the details online through the MCP system, they applied for loans manually, convincing bank officials to release funds directly into a single account, thus concealing irregularities. The DRDA PD initiated a preliminary investigation after receiving complaints about irregularities in loan disbursal. Upon verification of data from four societies, glaring violations were observed, prompting immediate action. Both Srilakshmi and Chandrasekhar have been placed under suspension pending further disciplinary proceedings. Authorities are now probing how the sanctioned funds were utilized. Key questions remain unanswered: Was the money distributed to women beneficiaries? Were loans obtained in the names of unsuspecting women? Or did the accused misappropriate the funds for personal gain? Bank officials have been instructed to verify digital records, account statements, and beneficiary acknowledgments. Speaking about the case, DRDA PD A.N.V. Nanchara Rao stated that a comprehensive investigation is underway to uncover the extent of the fraud and identify other individuals who might be involved. He assured strict action against all those found guilty, reaffirming that the government will not tolerate misuse of funds meant for women's development through self-help initiatives.





We wii never let the Steel Plant be Privatized The Coalition Government Defends PPP Policy, **Dismisses Privatization Rumours**

The Norwegian Nobel Committee made the announcement on their official X (formerly Twitter) handle, stating:

"The Norwegian Nobel Committee has decided to award the 2025 Nobel Peace Prize to Maria Corina Machado for her tireless work promoting democratic rights for the people of Venezuela and for her struggle to achieve a just and peaceful transition from dictatorship to democracy."

Machado has long been a key figure in Venezuela's prodemocracy movement, often facing repression, legal threats, and political disqualification by the Maduro-led regime. Despite these obstacles, she has consistently advocated for free elections, civil liberties, and institutional reforms in a nation plagued by authoritarian rule, economic collapse, and widespread human rights abuses.

Her win is being seen as a major recognition not just for her, but for the broader Venezuelan opposition movement that has battled to restore democratic governance for over a decade. Supporters across Latin America and beyond have

hailed the award as a timely spotlight on Venezuela's ongoing crisis and the resilience of its democratic fighters.

Interestingly, former U.S. President Donald Trump was also among the high-profile names nominated for the 2025 Nobel Peace Prize. In August, White House Press Secretary Karoline Leavitt had publicly endorsed Trump for the award, claiming he had "ended several conflicts around the world." This fueled significant public speculation and debate leading up to announcement.

However, the Nobel Committee's decision clearly leaned toward recognizing grassroots efforts in volatile political landscapes, with Machado's on-ground activism and unwavering resolve taking precedence over political leaders' diplomatic legacies.

Machado's Nobel win adds to a growing list of global figures celebrated for non-violent resistance and democratic advocacy. As Venezuela prepares for its next round of political developments, this international honor is expected to significantly boost her influence both at home and abroad.

The award not only acknowledges Maria Corina Machado's courage, but also serves as a powerful message to authoritarian regimes — that the world is watching, and that voices for democracy cannot be silenced.

Mental Health Fundamental To Our Overall Well-Being: PM Modi



Stay Within Limits": Mamata Banerjee Targets State's Poll Body Chief

West Bengal Chief Minister Mamata Banerjee issued a stern warning to the state's Chief Electoral Officer (CEO), Manoj Agarwal, on Thursday, cautioning him to "stay within his limits." Speaking to reporters at the state secretariat, Banerjee alleged that the CEO was threatening government officers, despite facing corruption allegations

himself.

"That CEO from this state, who has allegations against him – which I will talk about when the time comes – I hope he stays within his limits. Don't overreact," Banerjee said, without naming Agarwal directly. Her remarks came as an Election Commis-

sion (EC) delegation, led by senior official Ganesh Bharti, concluded a two-day visit to review the state's preparedness for the Special Intensive Revision (SIR) of electoral rolls. The EC has reportedly set an October 15 deadline for completing preparations, though no official timeline has been announced.

Banerjee's comments triggered a sharp response from the Bharatiya Janata Party (BJP), which accused the Chief Minister of threatening a constitutional functionary. Leader of the Opposition Suvendu Adhikari raised the issue with the Chief Election Commissioner of India in a post on X (formerly Twitter), calling for immediate

"It is with grave concern that I draw attention to the audacious threats made by Mamata Banerjee against the Chief Electoral Officer," Adhikari said. He also referenced a past incident from July 28, when Banerjee allegedly threatened Booth Level Officers during an administrative meeting in Bolpur. The BJP has welcomed the SIR process, claiming that over 1 crore "fake" voter names may be removed from Bengal's electoral rolls. The EC delegation, meanwhile, met with district officials across the state, barring flood-affected North Bengal. With elections approaching, tensions between the ruling TMC and the EC appear to be

Amit Shah Reviews J&K Security, Praises Response After Pahalgam Attack

Sources said the meeting focused on the current threat assessment, counter-terror operations, and steps taken to prevent cross-horder infiltration Special attention was also given to the protection of civilians, infrastructure, and personnel involved in ongoing development projects in the region. The Home Minister reviewed the preparedness of forces ahead of the upcoming winter season, when infiltration attempts along the



Line of Control (LoC) are typically expected to rise. Officials briefed him on recent intelligence inputs and counter-insurgency strategies.

Shah reiterated the government's commitment to ensuring lasting peace and stability in Jammu and Kashmir. He directed the security agencies to maintain a high level of alertness and continue proactive operations to eliminate remaining terrorist threats.

The recent attack in Pahalgam, which claimed the lives of security personnel, has triggered increased se-

curity across the region. Officials said enhanced surveillance and intelligence coordination are already in place. The meeting also reviewed the progress of infrastructure development and public outreach initiatives being carried out under the Union Government's J&K development

plan.

Jairam Ramesh Slams PM Modi Over'Selective Diplomacy' Amid Gaza Crisis

Senior Congress leader Jairam Ramesh on Friday criticised Prime Minister Narendra Modi for what he called "selective diplomacy" and misplaced international pri-

dra Modi for what he called "selective diplomacy" and misplaced international priorities. He accused the Prime Minister of ignoring critical humanitarian issues like the ongoing crisis in Gaza while engaging in high-profile conversations with global leaders.

In a sharply worded post on social media platform X, Ramesh said, "Prime Minister Modi spent all day yesterday talking to UK Prime Minister Keir Starmer and sending message after message of praise and admiration to President Trump. He did not, of course, forget to speak to the man who had unleashed the genocide on Gaza, the Israeli PM Benjamin Netanyahu, also during this time."

Ramesh's remarks come amid growing international criticism of Israel's military actions in Gaza and concerns about India's diplomatic stance. The Congress leader questioned Modi's silence on the suffering in Gaza, calling it a moral failure in India's foreign policy.

He also mocked former US
President Donald Trump for
his repeated and controversial claim that he halted "Operation Sindoor" — a military
campaign in South Asia —
using trade tariffs as a diplomatic tool. "Yesterday was
also the day when President

Trump, during his meeting with Finland's President Alexander Stubb, reached the half-century mark on his claim that he stopped Operation Sindoor using trade and tariffs as his brahmastra," Ramesh said.

The comment referred to Trump's repeated boasts about using economic pressure to stop regional conflicts, a claim that has not been substantiated by international observers.

With tensions escalating in the Middle East and Indian opposition parties growing more vocal, Ramesh's remarks highlight the sharp divide in how India's foreign policy is being perceived across the political spectrum.



India to Upgrade Kabul Technical Mission to Full Embassy: Jaishankar

India will upgrade its Technical Mission in Kabul to the status of a full Embassy, announced External Affairs Minister S. Jaishankar on Friday. This move signals India's intent to strengthen diplomatic ties with Afghanistan despite the ongoing challenges posed by the Taliban government. Jaishankar made the announcement during a meeting with Amir Khan Mut-

taqi, Foreign Minister of the Taliban administration, at Hyderabad House in New Delhi. The talks highlighted India's commitment to Afghanistan's sovereignty, territorial integrity, and independence. India had shut its Embassy in Kabul in 2021 following the Taliban's takeover after the withdrawal of U.S.-led NATO forces. However, India reopened a Technical Mission in Kabul a year later to maintain diplomatic engagement and assist in de-

velopmental projects. During the meeting, Jaishankar also raised concerns about Afghan refugees being pushed back into Afghanistan from Pakistan, urging collaborative efforts to address the humanitarian crisis. Both ministers identified cross-border terrorism as a shared threat and discussed the importance of closer cooperation to combat it

"India is fully committed to the sovereignty, territorial integrity and independence of Afghanistan. Closer cooperation between us contributes to your national development, as well as regional stability and resilience. To enhance that, I am pleased to announce today the upgrading of India's Technical Mission in Kabul to the status of Embassy of India," Jaishankar said. This upgrade is expected to boost India's diplomatic presence and deepen bilateral relations amid a complex

geopolitical environment marked by security challenges and humanitarian concerns. India's move also underscores its strategic interest in maintaining stability in Afghanistan and countering regional threats, particularly from cross-border terrorism emanating from Pakistan. The elevation of the mission to an Embassy marks a significant step in India-Afghanistan ties under the evolving regional landscape.

Maria Corina Machado Awarded **Nobel Peace Prize 2025**

TPN Bureau | Washington Venezuelan opposition leader Maria Corina Machado has been awarded the 2025 Nobel Peace Prize for her unwavering fight for democracy and her role as a unifying force in Venezuela's fractured opposition. The Norwegian Nobel Committee praised her for promoting democratic values and standing firm against authoritarianism, despite grave personal risks

Machado, a longtime critic of President Nicolás Maduro, was disqualified from running in the last election despite being the opposition's frontrunner. The government crackdown that followed saw mass disqualifications, arrests, and violent suppression of dissent. More than 20 people died during post-election protests, and diplomatic ties with several countries, including Argentina, were severed.

In his announcement, Nobel Committee Chair Jorgen Watne Frydnes described Machado as a "key, unifying figure in a political opposition that was once deeply divided." He lauded her deci sion to remain in Venezuela despite threats and persecution, calling her an inspiration for millions across Latin America.

Forced into hiding since January, Machado has not been seen in public. Her chosen replacement, Edmundo

This year's Nobel Peace Prize comes amid global attention on democratic backsliding and political repression. There had been speculation that the prize might go to Donald Trump

ance in Latin America. Machado now joins a distinguished list of Nobel laureates recognised for peaceful resistance and advocacy authoritarian regimes.

Trump Team Plans New H-1B Visa Curbs After \$100,000 Fee Hike

The Donald Trump administration is preparing to tighten restrictions on the H-1B visa programme, following a steep hike in mandatory fees to \$100,000. The latest proposed changes aim to overhaul how employers use the permit and who qualifies, with the goal of increasing oversight and protecting U.S. workers. The Department of Homeland Security (DHS) has introduced a rule under the title "Reforming the H-1B Non-

immigrant Visa Classifica-

tion Program" in the Federal Register. Key proposals include stricter scrutiny of employers, redefining eligibility for cap exemptions, and tighter regulations on third-party job placements. The changes could particularly affect nonprofit research organisations, universities, and healthcare institutions, which are currently exempt from the annual visa cap. It remains unclear whether these exemptions will remain un-

der the new rule. "These changes are intended to improve the in-

tegrity of the H-1B programme and better protect U.S. workers' wages and working conditions," the DHS stated. A final rule could be published as early

as December 2025. The Trump administration is also considering replacing the current H-1B lottery system with a wagebased selection model prioritising higher-paying jobs over random selection. This move could have a major impact on thousands of Indian professionals, who account for nearly 75% of approved H-1B applica-

tions, according to the Pew Research Centre. The H-1B visa is a key pathway for high-skilled foreign workers to gain employment in the U.S., especially in tech, healthcare, education, and research sectors. Despite criticism, research shows H-1B workers often earn equal or higher wages compared to American peers, due to legal wage protections. With the new rule, the Trump administration is signaling a broader immigration crackdown, especially on skilled worker visas central to U.S. industries.

Pakistan's federal government has suspended mobile and internet services in Islamabad and Rawalpindi ahead of a major anti-Israel protest called by the Islamist political party Tehreek-e-Labbaik Pakistan (TLP). The move comes amid heightened security concerns surrounding TLP's planned "Agsa Million March" from Faizabad to the U.S. Embassy in Islamabad. The protest is aimed at opposing the recently brokered Gaza

rael and Hamas, which TLP claims was an "embarrassing surrender" by the Shehbaz Sharif government and Pakistan's military leadership to U.S. President Donald Trump and Israeli Prime Minister Benjamin Netanyahu.

To counter potential unrest, authorities have placed containers and trailers at key intersections across Islamabad and Rawalpindi. Roads near Faizabad Junction have already been blocked, and police in Rawalpindi have begun seizing transport vehicles to prevent crowd mobilization. According to tion and prevent misinforreports, security forces have arrested at least 280 TLP activists in a preemptive crackdown. The Islamabad Police have also detained local TLP leaders and increased their presence across sensitive areas of the capital. Pakistan's Ministry of Interior has directed the Pakistan Telecommunication Authority (PTA) to cut off mobile and internet services in both cities from midnight on Friday, with no official timeline for restoration. The shutdown is intended to disrupt protest coordina-

mation during the rally.

Several educational institutions in Islamabad and Rawalpindi have announced temporary closures due to safety concerns, while businesses in the affected areas are bracing for disruptions. The protest and the government's response come at a time of growing political and public unrest in Pakistan over its foreign policy stance on the Gaza conflict. With the internet blackout and mass arrests, tensions are expected to remain

"If Not India, Who?" Palestine Envoy Asks New Delhi To Lead Gaza Reconstruction

Palestine's Ambassador to India, Abdullah Abu Shawesh, has called on New Delhi to take a leading role in alleviating the humanitarian crisis in Gaza and shaping its post-war future. In an exclusive interview with NDTV, the envoy said India's historic ties with Palestine and its strong relationship with Israel give it a unique position to press for peace and accountability.

Abu Shawesh urged India act as a bridge stating "If it is not India, then who?" He described India as a "champion of the Global South" and appealed for it to be a major partner in Gaza's reconstruction. The ambassador painted a grim picture of the humanitarian collapse in Gaza. "The 67,000 Palestinians who were killed... are purely civilians," he said, rejecting claims that most victims were Hamas fighters. He also de-



scribed dire conditions, including surgeries on children without anesthesia and hundreds of deaths due to malnutrition.

Calling the violence a "genocide," Abu Shawesh said international bodies and even Israeli watchdogs had used similar language. He challenged the global narrative around Hamas, ques-



tioning the absence of equal condemnation for the Israeli occupation. vThe envoy reiterated the Palestinian Authority's stance against armed militias in a future state and claimed that Israeli policies had historically enabled Hamas's rise. Shawesh also reminded India of its historical support for Palestine, from Mahatma Gandhi's era

to India's recognition of the Palestinian state in 1988. He cited strong public support across Indian states and political parties. In conclusion, he urged India to use its diplomatic influence to help end the suffering in Gaza and assist in building a peaceful, two-state solution that ensures long-term security and justice for Palestinians.

Pakistan Warns Afghanistan Over Cross-Border Terrorism

In a stern message to the Taliban-led government in Kabul, Pakistan's Defence Minister Khawaja Asif warned that Islamabad would no longer tolerate terrorist attacks launched from Afghan soil. Speaking in the National Assembly, Asif said Pakistan's patience has "run out" after a recent spike in cross-border terrorism that has killed several Pakistani soldiers in tribal regions.

"Enough is enough. Our patience has limits. Those who shelter or facilitate terrorists — whether in Pakistan or Afghanistan — will face the consequences," Asif declared, according to a report by Dawn. He emphasized the need for a "unified response" against those aiding militants and hinted at possible retaliation if the Taliban fails to act. Asif revealed that during a visit to Kabul three years ago, the Taliban demanded PKR 10 billion to re-

locate Tehreek-e-Taliban Pa-



kistan (TTP) fighters from border areas. However, no assurance was given that terror attacks on Pakistan would

The comments come amid rising tensions between Islamabad and Kabul, as TTP attacks continue to destabilize Pakistan's northwest. Islamabad now plans to send an official delegation to Kabul to press its concerns directly. Pakistan, however, is also confronting criticism over its own history of sponsoring extremist groups. Asif himself admitted in a 2025 interview that Pakistan did the "dirty work" for the U.S. during the Cold War and post-9/11 era. Former Foreign Minister Bilawal Bhutto echoed these sentiments, acknowledging that Pakistan's

past links to terror have had

long-term consequences. Both leaders insist that Pakistan has moved away from this legacy and undergone internal reforms to combat extremism.



Sensex Jumps 329 Points on Pharma, Banking Boost; Nifty Closes Above 25,280



Indian equity markets closed on a strong note Friday, with the BSE Sensex rallying nearly 329 points, led by gains in pharmaceutical and banking stocks alongside sustained foreign institutional inflows.

The 30-share BSE Sensex surged 328.72 points, or 0.40%, to end the session at 82,500.82, after hitting an intraday high of 82,654.11, up 482 points. Meanwhile, the broader NSE Nifty gained 103.55 points, or 0.41%, to settle at 25,285.35.

Investor sentiment remained buoyant, buoyed by positive global cues, expectations of robust earnings in the banking sector, and a continued rally in pharma stocks. The pharmaceutical

index led sectoral gains, driven by strong Q2 forecasts and improving export outlooks.

Banking stocks also attracted strong buying interest, with heavyweight private lenders leading the charge amid easing inflationary concerns and improved credit growth projections. Analysts noted that foreign institutional investors (FIIs) were net buyers in recent sessions, supporting the uptrend.

"Strong inflows from foreign funds and optimism around earnings season have supported market sentiment. Pharma and banks provided the major thrust today, supported by a stable global environment," said a market analyst at a leading brokerage.

Among key gainers on the Sensex were Sun Pharma, ICICI Bank, HDFC Bank, and Axis Bank. On the flip side, select IT and FMCG counters faced mild selling pressure.

With today's rally, both benchmark indices closed the week on a positive note. Analysts remain cautiously optimistic, though they advise investors to monitor global cues, geopolitical developments, and domestic macro data for near-term direction.

Market participants now await the upcoming inflation and industrial production data due next week, which could further influence investor sentiment.



US tariffs to hit 8% of India's auto component output

The Indian auto component industry is facing significant headwinds as high US tariffs are expected to impact nearly 8% of the sector's total production, according to ratings agency Icra. Auto component exports contribute almost 30% to the industry's revenues, with the United States alone accounting for 27% of this share. However, the recent imposition of a 50% tariff on Indian goods has placed Indian exporters at a relative disadvantage compared to several Asian

While China, Japan, Vietnam, and Indonesia face tariffs in the 15–30% range, India's much higher tariff burden makes its products less competitive.

Adding to the challenge, manufacturers in Mexico and Canada enjoy exemptions under the United States-Mexico-Canada Agreement (USMCA), further intensifying competition in the American market. This disparity underscores the growing need for India to accelerate trade talks with Washington to protect its export interests

Despite the hurdles, Indian auto component exports to the US have witnessed steady growth in recent years. Shipments rose from USD 4.1 billion in FY2021 to USD 6 billion in FY2022, followed by USD 6.5 billion in FY2023, and USD 6.8 billion in FY2024. For FY2025, exports are projected to touch USD 7.3

billion, reflecting the strong demand for Indianmade components. However, experts caution that the escalating tariff regime could slow this momentum in the near future

Geographically, Europe remains India's largest export market with a 30% share, followed closely by the US at 27%, Asia at 26%, Latin America at 3%, and other regions contributing 13%. Domestic sales account for 56% of the industry's revenues, while replacement demand makes up the remaining 15%. With exports under pressure, industry stakeholders are calling for urgent policy interventions to safeguard market access and sustain the sector's growth trajectory

GST Cut on Renewables to 5% Aims to Power India's Green Future

The government's decision to rationalize GST rates across the renewable energy value chain from 12% to 5% is set to bring down the cost of clean energy projects, making electricity more affordable for households, farmers, industries, and developers. According to the Ministry of New and Renewable Energy, the move will significantly reduce capital costs for utility-scale projects, rooftop solar systems, and solar pumps, while strengthening India's clean energy ecosystem For large-scale solar pro-

iects, where the cost typically stands at ₹3.5-4 crore per MW, the revised GST is expected to generate savings of ₹20-25 lakh per MW. A 500 MW solar park, for instance, could see project costs cut by over ₹100 crore, improving tariff competitiveness and lowering the financial burden on distribution companies (DISCOMs). Nationwide, annual savings of ₹2,000-3,000 crore in power procurement costs are anticipated. Households will also benefit as rooftop solar systems become cheaper. A 3 kW system will



now cost ₹9,000–10,500 less, accelerating adoption under the PM Surya Ghar: Muft Bijli Yojana. Farmers under the PM-KUSUM scheme are expected to save nearly ₹17,500 on a 5 HP solar pump, translating into a collective saving of ₹1,750 crore

Analysts expect the bullish momentum in bullion to continue in the near term as investors turn to precious metals for security during volatile times According to the Indian Bullion and Jewellers Association (IBJA), 24-carat gold closed at ₹1,09,707 per 10 grams on Friday, registering a sharp gain of ₹1,670 compared to Monday's ₹1,08,037. Gold has remained above the ₹1 lakh mark throughout September, hav-

ing started the month at



₹1,04,075. Prices of 22-carat gold followed suit, ending the week at ₹1,00,492 per 10 grams, up from ₹98,962 earlier in the week

Silver prices also maintained a strong rally. The met-

al ended the week at ₹1,28,008 per kilogram, higher by ₹3,595 from Monday's ₹1,24,413. With silver holding firm above ₹1.20 lakh levels, investor appetite remains robust. On the futures market,

According to lead archaeologist Pablo Solis, the intricately carved club heads are believed to have held ceremonial or symbolic importance, shedding light on the ritual practices of a civilization that remains largely understudied. "These artifacts offer a rare glimpse into the ceremonial life of the Chachapoyas people," Solis said.

The site also features a zigzag frieze, a decorative pattern never before found in the region. Archaeologists believe this discovery could represent a unique architectural style or symbolic motif



tures discovered at Ollape suggests that it may have served as a major ceremonial and residential

The Chachapoyas civilization, known for its distinct cliffside tombs and cloud-forest architecture, has long fascinated histomysterious compared to other ancient Andean cultures like the Incas. Peru continues to be a global hotspot for archaeological discoveries. With landmarks like Machu Picchu and the Nazca Lines, the country's vast and varied geography remains rich in historical secrets. The lat-

est discoveries in Ollape add to a growing body of evidence highlighting the complexity and cultural richness of pre-Columbian societies in the Amazon region. Further excavations and studies are expected to reveal more about the Chachapoyas' social structure, religious beliefs, and daily life.

Indian Engineer Sparks Debate Over 100-Hour Work Weeks

An Indian software engineer at AI startup Mercor has ignited online debate after revealing he works 72 to 100 hours a week. Pranav Mehta, a former Microsoft employee, described the intense schedule as a "worthwhile trade-off" for rapid personal and professional growth.

Mehta's comments followed a post by Mercor CEO Brendan Foody, who announced the company had grown from a \$1 million to a \$500 million revenue run rate in just 17 months, calling it the "fastest growing company of all time." Mercor is now aiming for a \$10 billion valuation. Acknowledging that such long hours may appear "daunting," Mehta highlighted the unmatched learning opportunities at the firm. "A comfy 40-hour week won't offer the same upside," he wrote on X (formerly Twitter), defending the demanding work schedule as part of the startup's high-growth culture. His remarks, however, quickly sparked backlash. Many social media users criticised the glorification of extreme work hours, raising concerns about burnout, mental health, and toxic workplace




One user questioned the mindset behind such schedules, asking, "Why do you guys try to flaunt toxic work culture as hustle culture?" Another sarcastically noted, "Dada, you don't have mental issues," pointing to the potential mental toll of such intense routines. Some offered a more optimistic perspective. A user suggested that the "working environment must be lit and hyped up all the time," implying that the energetic atmosphere might justify the high level of commitment. The discussion reflects ongoing tensions in India's tech sector, where startups often push employees to extreme limits for rapid growth,

sparking debates over the balance between ambition and employee well-being.

Pranav Mehta's post has reignited conversations about whether the drive for professional advancement is worth the personal cost, highlighting the growing scrutiny of "hustle culture" in the country's booming tech industry.







Dhruv Kapila-Tanisha Crasto Enter Arctic Open 2025 Quarterfinals

Indian mixed doubles duo Dhruv Kapila and Tanisha Crasto have stormed into the quarterfinals of the Arctic Open 2025, following a hard-fought comeback win over Ukraine's Oleksii Titov and Yevheniia Kantemyr in Vantaa, Finland, on Thursday. The eighth-seeded Indian pair bounced back after losing the first game to clinch a 23-25, 21-14, 21-17 victory in a tightly contested 54-minute encounter at the Energia Areena, as per

Olympics.com. After narrowly losing the opening game in extra points, Kapila and Crasto regrouped strongly. They led 11-9 at the mid-game break in the second set and maintained the momentum to level the match. The decider followed a similar pattern, with the Indians again taking an 11-9 lead at the break before comfortably sealing the contest to advance into the final eight.

In other Indian action. Anmol Kharb, ranked 62nd in the world, also produced a gritty performance in the women's singles category. She upset world No. 32 Hsu Wen-chi of Chinese Taipei with a 18-21, 21-18, 21-17 victory after coming from behind. However, it was the end of the road for Tanya Hemanth, who lost in straight games 21-9, 21-8 to Thailand's second seed and former world champion Ratchanok Intanon.

In the men's singles. Tharun Mannepalli, who had stunned world No. 14

Toma Junior Popov in the opening round, was knocked out by Japan's Koki Watanabe. Despite leading 11-6 in the first game and holding five game points, Mannepalli faltered, eventually going down 22-20, 21-12.

With mixed results overall, Indian hopes now rest on the remaining contenders heading into the quarterfinals.

ndia Hold Singapore 1-1 to Keep Asian Cup 2027 Qualification Hopes Alive

A 10-man Indian football team salvaged a crucial 1-1 draw against Singapore in their Group C Asian Cup 2027 Qualifier on Thursday, thanks to a last-minute equaliser by substitute Rahim Ali. The result keeps India's slim qualification hopes alive with two points from three games.

India found themselves trailing after Ikhsan Fandi scored in the first-half stoppage time, capitalising on poor defensive coordination between Anwar Ali and Muhammed Uvais. The goal gave Singapore a deserved lead after dominating possession (over 60%) and constantly pressing the Indian defence with swift passing and attacking moves.The situation worsened for India early in the second half when senior defender Sandesh Jhingan received his second yellow card in the 47th minute, reducing the visitors to 10 men. Jhingan, returning from facial surgery and playing in a protective mask, was shown red by Chinese referee Shen Yinhao, putting India on the back foot for the remainder

of the match.

Despite being a man down, Khalid Jamil's side remained resilient. Their persistence paid off in the 90th minute when Singapore defender Jordan Emaviwe inexplicably sent a long back pass from near the halfway line, catching his goalkeeper Izwan Mahbud off guard. Rahim Ali seized the opportunity, calmly rounding the goalkeeper and slotting the ball into an empty net.

Singapore, who now have five points from three matches, had multiple

chances to seal the game earlier but failed to capitalise on India's defensive vulnerability. Their inability to convert and a costly late error handed India a lifeline. India previously drew 0-0 with Bangladesh and lost 0-1 to Hong Kong, making their path to qualification difficult. Only the top team from each group secures a direct spot in the AFC Asian Cup 2027, with six matches to be played in a homeand-away format.India next need wins, not draws, to keep their Asian dream

India ended Day 1 of the second Test against West Indies in commanding fashion at 318/2, thanks to a magnificent unbeaten 173 from opener Yashasvi Jaiswal at the Arun Jaitley Stadium in New Delhi. Jaiswal, batting from start to finish, continued his rich vein of form and etched his name in history by becoming only the second Indian after Sachin Tendulkar to score seven or more Test centuries before the age of 24. His innings was a blend of patience, timing, and calculated aggression, anchoring India through all three sessions. The 23-year-old lefthander shared a crucial 185run partnership with B Sai Sudharsan, who registered his highest Test score of 87 before falling just 13 runs short of a maiden century. 


Trisha to Tie the Knot? Parents Reportedly Approve Chandigarh Businessman
