October 11, 2025: Andhra Pradesh Excise Minister Kollu Ravindra on Saturday announced a comprehensive special action plan to eliminate spurious liquor from the state, while strongly criticizing YSR Congress Party (YSRCP) leaders for allegedly spreading "false and baseless" claims to mislead the public. Addressing reporters at the R&B Guest House in Vijayawada, the Minister accused the previous YSRCP government led by Jagan Mohan Reddy of allowing fake and low-quality liquor to proliferate for

Ravindra alleged that during YSRCP's rule, genuine international liquor brands were replaced with substandard imitations, endangering public health. He asserted that the present coalition government had taken stringent enforcement measures, resulting in large-scale seizures of adulterated liquor and arrests of those involved, regardless of political influence or social status.Providing detailed updates on

CM Chandrababu Naidu Reviews Health Condition of BC Hostel Students in Guntur District

TPN BUREAU / Vijayawada, October 11: Chief Minister N.

Chandrababu Naidu on Saturday conducted a thorough review of the health condition of students from the BC Boys Hostel at Annaparru village in Peddanandipadu mandal of Guntur district, after several students reportedly fell ill due to suspected food poisoning. The Chief Minister held a teleconference with BC Welfare Minister S. Savita and senior officials from the Health, Education, and BC Welfare Departments to gather detailed information on the incident and to ensure that immediate medical measures were being taken.During the review, officials informed the Chief Minister that 24 students were currently undergoing treatment at the Guntur General Hospital.

Among them, one student, who had preexisting health complications, was shifted to the Intensive Care Unit (ICU) for special medical care and close monitoring. Except for two students, all others who received initial treatment at the medical camp in Peddanandipadu were discharged after improvement in their condition. Minister S. Savita briefed the Chief Minister that the condition of the remaining students was stable and that the child in the ICU was shifted to AIIMS, Mangalagiri, for advanced medical treatment on the recommendation of a team of medical experts.

The Chief Minister

expressed concern over the health and safety of all the students and directed officials not to discharge any student until they have completely recovered. He reiterated that the government would bear all medical expenses and ensure the best healthcare facilities are provided. The Chief Minister also enquired extensively about the hostel amenities, food supply and preparation methods, quality of drinking water, and overall sanitation standards in

the premises. He advised officials to conduct a detailed inspection of the hostel kitchen and dining area and ensure that proper hygiene and cleanliness are maintained at all times. Minister Savita stated that immediate sanitation and disinfection measures have already been initiated in the hostel and surrounding areas of Annaparru village. Health teams have been deployed to monitor the situation and offer preventive care to other hostel students. Preliminary medical reports have indicated that food poisoning could be the probable cause of the incident.

Accordingly, samples of the food and drinking water served to the students have been collected and sent to the laboratory for detailed testing and analysis.The Chief Minister instructed officials to initiate strict action against those responsible if negligence or contamination is confirmed in the lab reports. He directed the district administration to submit continuous updates regarding the students' health status and the progress of the investigation.

Naidu emphasized that such incidents should never recur in government hostels and advised the concerned departments to review and strengthen food safety protocols across all hostels in the state.Reassuring anxious parents, the Chief Minister said that every affected student would be provided with complete medical care until full recovery. He asserted that student welfare and safety remain top priorities for his government, and that continuous monitoring will be carried out until the hostel is declared completely safe for regular operation again.

Minister Kollu Promises to Address Issues of Chimakurthy **Granite Unit Owners**

TPN / Vijayawada Oct 11-Mines, Geology and Excise, Kollu Ravindra, has assured that the State government will take proactive measures to resolve the concerns raised by granite cutting and polishing unit owners from Chimakurthy. Speaking at the R&B Guest House in Vijayawada after meeting a delegation representing the industry, the Minister emphasized that mutual dialogue and cooperation are the best ways to resolve industrial disputes while safeguarding the interests of all stakeholders. A team of granite entrepreneurs from Chimakurthy approached the Minister with a detailed representation outlining the financial strain the sector is currently facing. The delegation explained that each unit pays around ₹35,000 per blade per month as seigniorage charges — a fee levied for the right to extract and process granite. According to them, these charges apply uniformly across all grades of raw material, which they argue is impractical and unsustainable for long-term operations.

The owners requested that the government review

its premium black galaxy granite, which is in high demand internationally. However, the owners said that escalating operational costs, particularly the steep seigniorage fee, are eroding profitability and threatening the viability of their businesses.

Many units have already shut down in protest, leading to the loss of livelihood for thousands of workers, a situation they described as alarming.Minister Kollu Ravindra took note of the delegation's grievances and assured them that he would raise the matter with senior officials in the Mining Department as well as Chief Minister N. Chandrababu Naidu. He stressed that the government's approach

revenue interests while ensuring the operational sustainability of the granite units. "We will ensure that neither the industry nor the State's finances suffer. Proper consultation will pave the way for a win-win situation," Ravindra stated. TPN BUREAU, Vijayawada, Oct 11: Union Minister Rammohan Naidu Realises Long-Pending Demand Vijayawada is set to achieve a major leap in international connectivity with IndiGo Airlines announcing the launch of its direct flight service to Singapore, beginning November 15. The threedays-a-week service is the result of consistent efforts by Union Minister of Civil Aviation Kinjarapu Rammohan Naidu, who played a key role in fulfilling a long-standing demand from residents of Andhra Pradesh's capital region. The new route will operate on Tuesdays, Thursdays, and Saturdays, linking Vijayawada International Airport to Singapore's Changi Airport, one of Asia's busiest and most advanced aviation hubs. Announcing the service to the media, Minister Rammohan Naidu explained that the proposal had its origins during Chief Minister N. Chandrababu Naidu's visit to Singapore on July 28 this year. At a meeting with the Telugu diaspora, the Chief Minister had assured them of direct air connectivity between Vijayawada and Singapore. Remarkably, the project has been realised within 100 days of that commitment. Calling the service a strategic milestone, the Minister emphasised the critical role of Non-Resident Telugus in achieving the state's ambitious 'Swarna Andhra 2047' vision. He said strong international connections like this would accelerate trade, education, tourism, and create new avenues for global collaborations. Vijayawada Oct 11: Andhra Pradesh Director General of State Disaster Response and Fire Services, P.V. Ramana, has issued strict directives mandating absolute compliance with safety protocols in the manufacture, handling, and storage of firecrackers across the state. The move aims to avert potential fire mishaps and explosions, particularly ahead of the festive season when fireworks manufacturing and sales reach their peak. In a detailed statement released on Saturday, Ramana emphasized that all licensed fireworks manufacturers and traders must strictly adhere to the Standard Operating Procedures (SOPs) laid down under the Explosives Rules, 2008. He noted that the slightest negligence in handling explosives or failure to meet safety norms could lead to catastrophic accidents, endangering both lives and property. Highlighting the structural requirements for firecracker manufacturing units, the DG instructed that such factories must function only in single-storey buildings with no basement facilities. Each shed should maintain a minimum safety distance of 45 meters from other sheds and from surrounding residential areas. These measures, he said, are es-

sential to contain the im-

pact of any accidental ex-

plosion.Ramana further

directed that manufactur-

ronment at all times. Strict prohibition has been placed on smoking, open flames, lighters, matches, and even mobile phones within the premises. "Safety begins with discipline. Any act of negligence, however small, can trigger disaster when dealing with explosives," he cautioned.Operations inside these factories should be restricted to working hours between 7:30 a.m. and 5:30 p.m., ensuring that no hazardous activities are carried out during night hours. He also insisted that dangerous processes such as chemical mixing must be carried out using automated systems wherever possible to reduce human exposure and errors. The use of nonsparking tools is mandatory to prevent accidental ignition, while all workers must wear personal protective equipment (PPE), including fire-retardant clothing, gloves, and face

shields. Further clarifying the regulations, Ramana stated that persons below 18 years of age and those under the influence of alcohol must not be allowed to enter or work in any firecracker manufacturing facility. Every worker should undergo comprehensive training in fire safety, handling of explosive materials, and emergency response procedures. Factories are also required to ensure that all employees are covered under life and medical insurance policies. To bolster safety



preparedness, firecracker factories must install automatic fire detection and alarm systems and maintain adequate firefighting equipment such as extinguishers, sand buckets, and water sources. Regular inspection and maintenance of these systems are compulsory. The DG warned that severe action would be taken against violators of these safety regulations, including suspension of licenses and legal prosecution. He urged all manufacturers to view safety compliance not as a formality but as a moral and civic responsibility. "Ensuring worker safety and protecting nearby communities is paramount. Prevention through strict adherence to standards is the only way to avoid tragedy," Ramana asserted. With the festive season nearing, the Fire Services Department has also intensified inspections of manufacturing units, warehouses, and retail outlets. Officials have been instructed to ensure full compliance with the Explosives Rules and to immediately halt operations in any facility found breaching safety

The YSR Congress Party (YSRCP) has intensified its attack on the ruling Telugu Desam Party–Jana Sena Party-Bharatiya Janata Party (TDP-JSP-BJP) alliance, alleging that a dangerous network of spurious liquor production and distribution is thriving under government protection. Senior YSRCP leaders have demanded a Central Bureau of Investigation (CBI) probe into the "state-sponsored liquor mafia," holding Chief Minister Nara Chandrababu Naidu directly responsible for safeguarding those involved in

the illegal trade that has

claimed several lives across Andhra Pradesh.Former Minister Kakani Govardhan Reddy, speaking in Nellore, accused the ruling government of indulging in a massive cover-up of the fake liquor racket while targeting opposition leaders to suppress the truth. He said the government is attempting to shift blame by branding arrested TDP leaders as "YS-RCP coverts." Questioning Chandrababu's integrity, Kakani demanded an explanation for why Jayachandra Reddy—linked to the syndicate—was given a TDP ticket in the 2024 elections and was in charge of the Tamballapalle constituency for 16

months. "Factories producing counterfeit liquor have been exposed in Tamballapalle, Ibrahimpatnam, Eluru, Nellore, Anakapalli, Palakollu, and Repalle," Kakani stated, revealing that spirit and duplicate bottles were being used to manufacture fake liquor supplied across the state through TDP-controlled belt shops. He further condemned the state government for allegedly filing false cases against journalists and media houses, particularly Sakshi, who have been reporting on the illicit trade. "The government's intimidation of the media shows its desperation to hide the truth," Kakani re-



marked, claiming that the health and lives of citizens were being endangered for political and financial gain. At a press briefing in the YS-RCP Central Office in Tadepalli, Vijayawada Mayor Rayana Bhagyalakshmi

ter Chandrababu Naidu and Deputy Chief Minister spond to the allegations instead of maintaining silence. "The fake liquor mafia has become a state-sponsored operation, looting crores from the public and endangering lives every day," she said. She asserted that every person arrested in connection with the racket has ties to the TDP, vet the government has failed to

conduct statewide raids or dismantle illegal networks. "If the government continues to protect criminals, YS-RCP will not remain silent. We will expose their lies before the people," she warned. Meanwhile, from Proddatur, former MLA Rachamallu Siva Prasad Reddy condemned the alarming rise of spurious liquor sales, describing it as a public health emergency. He pointed out that it is nearly impossible for consumers to distinguish between genuine and fake liquor, as counterfeit bottles have flooded the market. While the state officially has 3,396 licensed shops, he claimed over one

lakh illegal belt shops are operating unchecked under TDP's watch. "The poor are being poisoned for profit. The mafia is being run by individuals close to Chandrababu Naidu, and the government owes the people a full disclosure," Rachamallu said. All three YSRCP leaders demanded an impartial investigation by the CBI to uncover the full extent of the liquor mafia's network. They warned that if the government continues shielding those responsible, YSRCP would launch a statewide agitation to hold the ruling coalition accountable for risking public health and plundering state resources.

Running natural farming training centers to promote chemical-free cultivation methods. Public Outrage Erupts in Vijayawada Over Sale of Spurious Liquor

TPN/VIJAYAWADA, Oct 11:

 $Tension\ gripped\ Vijayawada's\ Vidyadharapuram$ locality on Saturday as residents, led by Communist Party of India (Marxist) leaders and local women's groups, staged a vehement protest against the alleged continued sale of spurious liquor at Srinivasa Wines. The demonstration came despite recent police seizures from the outlet and registered cases against the sale of adulterated liquor. Protesters, holding placards and shouting slogans, demanded the immediate cancellation of the shop's license, accusing officials of turning a blind eye to a racket that endangers public health.

The protest, spearheaded by CPI(M) State Secretary Ch Babu Rao, West Secretary Boyi Satyababu, and women leaders Saroj and Adilakshmi, saw a large contingent of women closing the liquor shop and smashing bottles of fake liquor in public. Many of the demonstrators expressed frustration over what they called "official indifference" despite repeated crackdowns. "Governments change, leaders change, but the liquor mafia remains the same," one CPI(M) leader told the crowd.

According to evewitnesses, the gathering lasted for more than an hour, causing palpable tension in the area. The protest was only called off after excise department and police officials visited the site and assured agitators that sales from the shop would be immediately stopped. They also promised that the shop's license would be formally cancelled within a week. Addressing the protesters, CPI(M) leaders squarely blamed the coalition government for failing to curb the menace of spurious liquor, alleging it had adopted the same negligence that marred the previous YSRCP administration. They highlighted that the illicit liquor racket, first exposed in Molakalachervu of Annamayya district, had now spread far beyond its origin to cities and towns including Vijayawada, Ibrahimpatnam, and across the NTR district. The leaders demanded an independent judicial probe into the entire liquor



scam, insisting the inquiry must determine where adulterated liquor has been sold, identify all victims who consumed it, and assess their present

They also raised pointed questions on why certain political leaders named in the scam were allegedly being shielded from legal action and even rewarded with party tickets.In their speeches, CPI(M) representatives criticized what they termed the government's "revenue-first" approach, accusing officials of prioritizing excise income over safeguarding citizens from severe health risks posed by illegal liquor. They further demanded that licenses be cancelled across the state for any outlet found to be selling spurious liquor and called for stringent penalties against

those enabling or profiting from the trade. Locals participating in the protest expressed deep anger over news reports suggesting the persistence of such illicit sales even after police action. Commu nity members said the fight against adulterated liquor was not just a political protest but a public health emergency that had already claimed lives in other districts.By late afternoon, the Vidyadharapuram protest site returned to calm, but CPI(M) leaders warned they would resume agitation if authorities did not keep their word within the promised timeframe. "This is not just about one shop, this is about the safety of our people," said Ch Babu Rao, reiterating demands for immediate and statewide action against the



YSRCP's Dr. Mehaboob Shaik Slams TDP's Manikya Vara Prasad Over "Anti-Poor" Remarks on Medical Colleges

TPN | Vijayawada | October 11, 2025 YSR Congress Party State Executive Committee Member and State Vice President of the Medical Wing, Dr. Mehaboob Shaik, launched a scathing attack on Telugu Desam Party (TDP) leader Manikya Vara Prasad over his recent comments on government medical colleges in Andhra Pradesh. Calling the remarks "shocking and anti-poor," Dr. Mehaboob accused Vara Prasad of siding with policies that would undermine access to medical education for marginalized communities across the state. During a fiery response to Vara Prasad's statements made in a television debate, Dr. Mehaboob questioned the TDP leader's intentions, asking whether his comments were an effort to please Chief Minister N. Chandrababu Naidu at the cost of the poor. "Is Mr. Vara Prasad opposing institutions that offer Dalits, tribals, minorities, and economically weaker sections a chance to study medicine and gain dignity in society?" Dr. Mehaboob asked. He argued that such remarks reflected a disregard for inclusive education and the constitutional responsibility to empower disadvantaged groups. Drawing comparisons with neighboring states, Dr. Mehaboob highlighted that Karnataka and Tamil Nadu each host more than 70 medical colleges, while Andhra Pradesh lags far behind with only 17 government medical colleges. He pointed out that of these, three were started by former Chief Minister Dr. Y.S. Rajasekhara Reddy, and six were established under the leadership of Y.S. Jagan Mohan Reddy. "Despite ruling for nearly 15 years, Mr. Chandrababu Naidu did not create even a single government medical college in Andhra Pradesh," Dr. Mehaboob stated, emphasizing the TDP's alleged neglect of public healthcare and education infrastructure. Further intensifying his criticism, Dr. Mehaboob accused the current TDP government of betraying the poor by initiating moves to lease 17 government medical colleges to private entities under a Public-Private Partnership (PPP) model for a 66year period. He said such a long-term privatization plan would effectively strip away affordable education opportunities for nearly one lakh aspiring medical students from underprivileged backgrounds."Leasing government medical colleges to private institutions is a direct attack on the dreams of poor and rural students," Dr. Mehaboob said. "These colleges were meant to serve the common man, not to become profitmaking ventures for private players."

He warned that the privatization policy would burden families with high fees and restrict admissions to those from wealthy and urban backgrounds, thereby widening social inequalities in higher education. Dr. Mehaboob appealed to Manikya Vara Prasad to retract his "misguided" remarks and stop endorsing policies that aid in the commercialization of education. He urged the TDP leadership to uphold public interest and prioritize the welfare of marginalized communities instead of supporting the privatization of essential public institutions. Concluding his statement, Dr. Mehaboob reiterated the YSR Congress Party's commitment to ensuring equal opportunities in medical education. He said the government's duty was to strengthen public institutions, not hand them over to private hands for decades. "Education is not a business, it is a right of every child, irrespective of caste, region, or economic status," he said, calling on the people of Andhra Pradesh to stand united against any move that threatens the accessibility and affordability of medical education in the state.

Speaking to the assembled crowd and union members, Subhash acknowledged that the dues owed to these cooperative societies had become a significant stumbling block for the current NDA coalition government, primarily due to unresolved issues inherited from the previous YSRCP administration. He criticized the previous government's

neglect, but reaffirmed the new coalition's dedication to worker welfare. Notably, the minister promised to take the matter of outstanding funds and arrears directly to Chief Minister Chandrababu Naidu and ensure a solution within the next month. Follower's Shadow Role Raises Eyebrows in Rajahmundry Rural

TPN BUREAU, RAJAH-MUNDRY, OCT 11: Politics In Rajahmundry Rural, controversy is brewing around a man named Kishore a close follower of MLA Gorantla Buchi Chowdhury whose increasing presence in official meetings and interactions with top district officials has raised serious questions about propriety, power, and protocol. What started as quiet murmurs within political circles has now turned into a full-fledged public debate, with citizens and administrators questioning the authority and role of an "unofficial person" appearing in official government consultations. According to administrative norms, elected representatives such as MLAs, MPs, and MLCs must adhere strictly to government protocol when attending official programs or meeting senior officials like the District Collector or Joint Collector. Typically, an MLA's presence in such meetings is accompanied only by their accredited personal staff their PA (Personal Assistant) or PS (Private Secretary). No family members or followers

are permitted to participate, particularly when confidential or administrative matters are being discussed. However, the recent meeting convened by Rajahmundry Rural MLA Gorantla Buchi Chowdhury to review developmental activities in the constituency deviated from these norms. The MLA met with East Godavari District Collector Kirti Chekuri, Joint Collector Megha Swarup, and National Highways Project Director Rohit. In what should have been a strictly official setting, officials and attendees were surprised to see Kishore — a known follower of the MLA — present beside him throughout the meeting. Photos of Kishore sitting close to the MLA have since gone viral, sparking debate across Rajahmundry Rural and Urban regions.Questions Over Authority and Legitimacy. The central guestion being raised by observers is simple: in what capacity was Kishore present at the meeting? He does not hold any government position, nor is he officially designated as the MLA's PA or PS. Yet his conspicuous presence in discussions concerning developmental projects and administrative strategies has prompted confusion among district officials. "He has no official identity, but is seen in key discussions," said a senior source within the administration, adding that such instances undermine the standard operating procedures and the authority of institutional offices.Officials are reportedly uneasy about Kishore's role but remain cautious about voicing open criticism, fearing implicit political pressure. Even so, the discontent is palpable. "An MLA's follower has no place in a confidential meeting with the Collector," remarked one local political observer. The Hidden Racism Against Northeastern Indians **An Urgent Call for Introspection**



Racism against people from India's North East remains a persistent, troubling issue that often goes unnoticed or is dismissed with casual indifference. Despite sharing the same nationality, Northeastern Indians frequently face derogatory slurs, discrimination, and harassment—sometimes brutal in nature within the very country they call home. This racism is no different, nor any less offensive, than the prejudice Indians encounter abroad.

A recent incident underscores this harsh reality: a 27-year-old flight attendant from the Garo Hills region revealed on social media that she was subjected to racial abuse twice within the span of an hour in New Delhi. The slurs, predominantly hurled by unruly men, included demeaning and offensive language. Sadly, such

compounded discrimination due to their gender and are often targets of sexual harassment. They are stereotyped as "fast" or morally loose, fueling further abuse.

Union Minister Kiren Rijiju condemned this harassment, emphasizing that it is unacceptable. While his words are welcome, history and current realities suggest that such abuses will continue unless society as a whole confronts its deep-seated biases.

This intolerance is especially disheartening considering the complex history of the North East's integration with India. Violent secessionist movements in states like Nagaland and Mizoram were met with harsh suppression by the government. Though peace has largely returned, and many young Northeasterners proudly identify as Indian while moving to cities

At the root of this prejudice lies ignorance—most harassers likely have no understanding of the North East's geography, culture, or history. This ignorance breeds contempt, much like the prejudices against Muslims or Christians within India, or even racial bias faced by Indians abroad.

It is time for a collective introspection. We easily condemn racism outside India but often fail to ac-



Pharma Tariffs: Trump Keeps Indian Drug-Makers on Edge



In the midst of ongoing negotiations between India and the United States over a long-pending trade agreement, President Donald Trump has announced a sweeping new tariff policy targeting the pharmaceutical sector. The US administration has imposed a 100% tariff on branded and patented pharmaceutical products imported into the country unless the manufacturing companies establish production facilities on American soil. This policy shift has sent ripples through India's pharmaceutical industry, which is a major player in the global market.

India, often hailed as the "pharmacy of the world," exports over \$30 billion worth of pharmaceutical products globally, with the US accounting for roughly \$10 billion of that figure. The country predominantly supplies low-cost generic drugs to the American market, which, importantly, remain exempt from the new tariff regime. This exemption provides some relief to Indian drugmakers, safeguarding a significant portion of their exports.

However, concerns persist over the status of active pharmaceutical ingredients (APIs), the core components used in drug production. The tariff policy has not clearly addressed whether APIs will fall under the new tariffs, leaving Indian manufacturers uncertain about potential impacts Additionally, the indus-

try is witnessing a strategic shift as major Indian pharmaceutical firms increasingly focus on complex generics — advanced formulations that are more difficult to develop than traditional generic drugs. These include inhalers, injectables, and ophthalmic solutions, which often fall within the branded or patented categories and thus might be subject to the new tariffs. Complex generics are commercially valuable as they enable companies to enter higher-value markets and diversify beyond conventional generics.

This evolving landscape creates a delicate balance for Indian drug manufacturers. While the exemption of standard generics offers some protection, the new tariff rules pose challenges for growth in specialized drug segments. Setting up manufacturing bases in the US, as demanded by the policy, would require substantial investments and strategic decisions by Indian companies.

As trade talks between the two nations continue, clarity on tariff implications, especially concerning APIs and complex generics, remains crucial. The outcome will determine how India's pharmaceutical exporters navigate this new regime while sustaining their vital role in global

Bond Yields Defy RBI Rate Cuts Amid Fiscal, Global Concerns

Despite India's inflation hitting an eight-year low and the Reserve Bank of India (RBI) cutting interest rates since February, government bond yields are moving in the opposite direction—rising sharply when they would typically fall.

India's 10-year benchmark bond yield has climbed over 20 basis points since the RBI's last rate cut in June, closing at 6.47% on Wednesday. This unusual rise is driven by concerns over weak tax collections, a potential fiscal deficit overshoot, and geopolitical risks—especially the impact of U.S. tariffs on Indian exports.

Traditionally, lower interest rates and inflation lead to higher bond prices and lower yields. But recent market behavior has defied this logic. Experts point to the RBI's shift in policy stance—from 'accommodative' to 'neutral'—as a key trigger. While the repo rate was cut by a cumulative 100 basis points this year, markets interpreted the policy shift as a signal that further rate cuts may not follow.

Finance Minister Nirmala Sitharaman has acknowledged the rise in yields is "not affordable," though she maintained it doesn't currently affect the government's fiscal calculations.

Independent analyst Ajay Bodke noted that fiscal slippage fears—especially with underperforming direct and indirect tax collections—are keeping bond investors wary. A recent report by Axis Bank estimates a possible 1.4 trillion shortfall in direct taxes for FY26, adding pressure to government borrowing.

The new GST rate rationalisation announced in early September—cutting slabs to 5% and 18%aims to boost demand but may reduce revenue by 48,000 crore. Bond yields briefly softened following the GST announcement, but broader worries

Adding to market jitters is the potential fallout from U.S. trade policy. Trump's new 100% tariffs on branded pharmaceuticals and the proposed HIRE outsourcing bill have raised red flags for Indian exporters. Experts warn that substitution to other markets won't match U.S. profit margins and could lead to reduced earnings across labour-intensive

Until there is clarity on fiscal trends and external pressures, experts suggest bond yields may remain elevated—even as inflation and interest rates stay low. For now, market sentiment is clearly being driven more by future risks than present data.

Rajya Sabha Polls in J&K Put **NC-Congress Alliance to the Test**

The upcoming Rajya Sabha elections in Jammu and Kashmir, set to fill four seats vacant since 2021, have become

a critical test for the fragile alliance between the National Conference (NC) and the Congress. Reports of a deadlock over seat-sharing arrangements are threat-

ening to strain the partnership ahead of the polls scheduled in 10 days. Sources reveal that the NC has offered Congress a "risky" seat, while the Congress is pushing for one of the three relatively safer seats. "Talks are still underway, but if the NC does not concede a safer seat, Congress may decide to stay out of the familiar with the

The stakes are high, with the ruling alliance expected to comfortably win three seats. The BJP, with its 28 votes, holds a strong position to capture the fourth seat, making the decision over the risky seat crucial.

On Friday, the NC announced its candidates— Choudhary Muhammad Ramzan, Šajad Kichloo, and Shammi Oberoi—for three seats, while the fourth seat intended for Congress remains contentious. Political analysts view the standoff as a reflection of the alliance's fragile nature. Last year, Congress had walked out of the NC-led government after disagreements over ministerial portfolios, despite the alliance winning a majority in the assembly. Experts warn that if the NC insists on the risky seat, Congress might either reluctantly contest or opt out altogether, which could expose cracks in the coalition and potentially benefit the BJP.

With election day approaching fast, all eyes remain on whether the NC and Congress can reconcile their differenc-

The Enforcement Directorate (ED) has arrested Ashok Kumar Pal, Chief Financial Officer (CFO) of Reliance Power Limited (RPL), in connection with a massive Rs 3,000 crore bank loan fraud case involving companies from the Reliance Anil Dhirubhai Ambani Group. intensifying its efforts to probe financial crimes linked to prominent corporate houses, and this arrest marks a significant development in the ongoing investigation against the Anil Am-

bani Group. Reliance Power Limited is one of the key entities under the group, and the alleged fraud case has raised concerns over governance and financial transparency within the conglomerate.

Further details are awaited as the ED continues its inquiry and custodial interrogation of Ashok Kumar Pal. The agency aims to unravel the full extent of the alleged fraud and trace the flow of funds to bring those responsible to iustice.

Trump Imposes 100% Tariff on China After Rare-Earth Export Controls

US President Donald Trump announced a sharp escalation in the ongoing trade conflict with China by imposing a 100% tariff on all Chinese goods starting November 1. The move comes in direct response to China's recent export restrictions on rareearth minerals, essential components in semiconductors, fighter jets, and other advanced technologies critical to America's industrial and defense

In a post on his social media platform Truth Social, Trump called China's actions "extraordinarily aggressive" and labeled them "a moral disgrace in international trade." He warned that tariffs could be imposed earlier if Beijing takes further aggressive steps.

US officials view China's export controls as a strategic effort to gain leverage ahead of the upcoming APEC summit in South Korea, where Trump and Chinese President Xi Jinping were expected to meet. However, with tensions rising, the meeting now appears uncertain. Trump has stated he sees no need to meet Xi but has not officially canceled

The tariff surge serves multiple purposes: retaliation against China's direct hit on US supply chains, political signaling to Trump's base by showcasing toughness on trade, and a tactical attempt to pressure China back into negotiations on America's terms. Despite a \$400 million investment to boost domestic rareearth production, the US remains heavily reliant on Chinese supplies.

The announcement coincided with Trump promoting a Middle East peace breakthrough, aiming to balance diplomacy with economic assertiveness on the global

Taliban Minister Sends Message to Pakistan on **Terrorism From Indian Soil**

In a significant diplomatic development, Afghanistan's Taliban-appointed Foreign Minister Amir Khan Muttaqi, during his first official visit to India, made a strong statement urging Pakistan to follow Afghanistan's example in eliminating terror groups operating on its soil.

Addressing a press conference in New Delhi, Muttaqi declared that no terrorist groups like Lashkar-e-Taiba or Jaish-e-Mohammad are currently active in Afghanistan. "Not an inch of land is controlled by them. The Afghanistan you knew in 2021 has changed," he said, responding to concerns over past terror activities linked

to Afghan territory. He delivered a pointed message to Pakistan from Indian soil — a country that has long suffered from cross-border terrorism. "Just as Afghanistan has taken action for peace, other countries should do the same," he said.

Muttaqi also accused Pakistan of orchestrating a recent blast in Kabul, stating, "We consider this act of Pakistan wrong... Afghanistan is now peaceful and independent. Why should that trouble anyone?"

India marked the visit by announcing the restoration of full diplomatic ties with Afghanistan. External Affairs Minister S. Jaishankar confirmed the upgradation of India's Technical Mission in Kabul to an embassy, indicating New Delhi's deeper engagement with the Taliban regime.

Muttaqi, praising India as a "close friend," acknowledged New Delhi's swift humanitarian response during the recent earthquake in Afghanistan. He also called for mutual respect, trade, and stronger people-topeople ties.

Maruti Suzuki Cuts Car Prices by Up to Rs 1.3 Lakh After GST Reduction

Maruti Suzuki India on Thursday announced a price reduction across its entire model range by up to Rs 1,29,600, effective from September 22, to pass on the benefit of the recent GST rate cut to customers. The country's largest carmaker said the move is aimed at making vehicles more affordable and encouraging two-wheeler users to upgrade to cars.

Entry-level models will see significant price drops, with S-Presso reduced by up to Rs 1,29,600, Alto K10 by Rs 1,07,600, Celerio by Rs 94,100, Wagon-R by Rs 79,600, and Ignis by Rs 71,300. Premium hatchbacks and sedans are also included, with Swift down by Rs 84,600, Baleno by Rs 86,100, Dzire by Rs 87,700, Fronx and Brezza by over Rs 1.1 lakh, Grand Vitara by Rs 1.07 lakh, Jimny by Rs 51,900, Ertiga by Rs 46,400, and XL6 by Rs 52,000. Commercial vehicles like Invicto, Eeco, and Super Carry LCV will see reductions of up to Rs 68,000.

Partho Banerjee, Senior Executive Officer (Marketing & Sales) at Maruti Suzuki India, said the company is reducing prices of small cars over and above the 8.5% GST cut to boost motorisation in India, noting the low car penetration of 34 vehicles per 1,000 people. He added that the move would stabilise the entry-level segment after years of volume decline and that GST rate cuts on car parts will also reduce overall maintenance costs.



SEBI Mulls Allowing FPIs in Non-Cash, **Non-Agri Commodity Derivatives**

The Securities and Exchange Board of India (SEBI) is reviewing a proposal to allow foreign portfolio investors (FPIs) to trade in non-cash settled, nonagricultural commodity derivative contracts, SEBI Chairman Tuhin Kanta Pandey said on Wednesday. The move is aimed at strengthening India's domestic commodity markets and attracting

greater foreign participation.

Speaking at the MCX Metals and Energy Summit 2025 in Mumbai, Pandey highlighted that SEBI has already set up a committee to suggest measures for deepening the agricultural commodities segment. "We are actively looking at ways to develop the non-agricultural commodity space, including metals, and a dedicated working group will be con-

stituted for this purpose," he added. The proposed change would enable FPIs to participate in derivative contracts beyond cash-settled agricultural commodities, potentially enhancing market liquidity and offering international investors broader avenues in India's commodities market. Currently, FPI participation in commodity derivatives is largely restricted, limiting foreign inflows and investment opportunities.

Pandey emphasized that expanding FPI access to non-agri commodity derivatives aligns with SEBI's broader goal of deepening financial markets while maintaining robust regulatory oversight. The regulator is also exploring other measures to improve transparency, risk management, and market participation across commodity segments.

Market participants expect the potential approval to provide a boost to metals and energy derivatives trading, attracting foreign capital and increasing competitiveness. Analysts say this could also help Indian commodity mar-



kets integrate better with global commodity flows, while giving domestic investors more hedging and investment

GST Inversion Eases, But Input-Output Rate Gaps Worry Industry



The recent GST rate rationalisation in India has eased the inverted duty structure (IDS) across many sectors, but wide gaps between input and output tax rates continue to raise concerns for industry, particularly regarding working capital and refund processes. The removal of the 12 per cent slab and consolidation into two main rates of 5 per cent and 18 per cent has addressed most anomalies, yet items such as bicycles, tractors, fertilisers, and certain textiles still face inversion. For example, steel inputs attract 18 per cent GST, while final products like bicycles and e-bicycles are taxed at 5 per cent, creating potential capital blockage.

In the textile sector, GST cuts on manmade fibres and yarn have largely corrected inversion, with about 80 per cent of the value chain now aligned. However, minor inversions remain in polyester fibre raw materials and textile machinery, where input tax at 18 per cent exceeds the final product's 5 per cent rate. A textile industry executive noted that the wide rate difference, though smaller than before,

continues to pose work ing capital challenges and highlighted the importance of a smooth refund mechanism.

Similarly, in the fertiliser sector, GST on key inputs such as sulphuric acid, nitric acid, and ammonia has been reduced from 18 per cent to 5 per cent. Yet packaging costs and government subsidies can still result in inversion, as final product prices may fall below input costs. Officials involved in GST rationalisation acknowledged these transitional issues but emphasized that majority of IDS cases have been corrected, with expected savings for the fertiliser sector reaching Rs 5,000 crore annually due to lower refund outgo.

Industry experts caution that while progress has been made, residual inversions could incentivize evasion if refunds are delayed or capital remains blocked underscoring the need for efficient implementation and monitoring. The government continues to refine rates and streamline processes to minimise such bottlenecks and support industrial liquidity.

Sensex, Nifty Rise on US **Fed Rate Cut; IT Stocks Lead Gains**



Indian equity markets extended their positive run on Thursday following global cues after the US Federal Reserve cut interest rates by 25 basis points, bringing the benchmark rate to 4-4.25%. The S&P BSE Sensex surged over 350 points to trade above 83,000, while the NSE Nifty50 crossed 25,400 in early trade. Broader market indices also recorded gains, with volatility re-

maining stable. Dr. VK Vijayakumar, Chief Investment Strategist at Geojit Investments, described the Fed's 25 bp rate cut as a "risk management cut," highlighting uncertainties around economic activity, unemployment, and inflation. He added that with the US labor market cooling and GDP growth projected at 1.6% for 2025, further rate cuts are possible, creating a favourable environment for global and domestic markets. Despite this, Indian stocks are largely driven by expectations of corporate earnings revival and positive developments

in India-US trade negotiations.

On the domestic front, Nifty50 closed Wednesday at 25,330, marking gains in 11 of the last 13 sessions and recovering over 900 points from its recent low of 24,404 on August 29. Analysts noted that the Nifty remains in an uptrend, with support near 25,150 and resistance levels at 25,550 and 25,670.

IT stocks led the gains, with Infosys and Wipro seeing notable increases, while investor activity included major insider purchases in Jindal Steel (Rs 997 crore), Indus Towers (Rs 708 crore), Jindal Stainless (Rs 352 crore), Tourism Finance Corporation (Rs 161 crore), and Paisalo Digital (Rs 126 crore).

With both global and domestic factors providing momentum, market analysts expect Indian equities to maintain their bullish trajectory in the near term, driven by earnings optimism, policy support, and sustained foreign investor

Gold Prices Soar in Pakistan: 10 Grams Cost Over Rs 4.3 Lakh



Gold has long held cultural and financial significance across South Asia, but in Pakistan, its price has recently surged to recordbreaking levels. According to the latest reports, the cost of 10 grams of 24-carat gold in Pakistan has sky-rocketed to PKR 430,500, making it significantly more expensive than in neighbouring India.

The sharp rise in gold prices is primarily due to a governmentimposed 60-day ban on gold imports, aimed at stabilizing the country's struggling economy. This ban, however, created a severe supply crunch, sending gold prices soaring.

In comparison, the Indian gold market remains relatively stable, with a notable price difference of nearly INR 13,000 per 10 grams when compared to Pakistan (after currency conversion). This widening gap has sparked interest among traders and entrepreneurs on both sides of the

"Buying gold in India and selling it in Pakistan sounds like a lucrative business

opportunity," some have speculated online. The massive price differential may present arbitrage possibilities. though cross-border trade in gold remains heavily regulated and legally complex.

The Pakistani rupee's weakening against the US dollar has also played a key role in driving up gold prices. As global gold is priced in dollars, local currency depreciation directly impacts affordability for Pakistani consumers.

With gold being central to weddings, religious events, and investment in Pakistan, the current pricing surge makes it difficult for many families to afford the precious metal. Analysts believe that unless the import restrictions are lifted and the rupee stabilizes, gold will remain out of reach for the aver-Pakistani household.

As Diwali and wedding season approach, many in Pakistan are watching the gold market closely, hoping for relief — but for now, the glittering metal remains a luxury few can

Google Doodle Celebrates Idli: A South Indian Classic



Google Doodle paid lis may have roots in tribute to one of India's most iconic and beloved breakfast dishes idli. Soft, steamed, and often paired with spicy sambar and fresh coconut chutney, idlis are a staple in South Indian homes and a comfort food enjoyed across the country.

The special Google Doodle artwork creatively depicts the making and serving of idlis. The first "G" is filled with rice grains, a key ingredient in idli batter. The two "O"s show a bowl of white batter and a traditional steamer. The second "G" is made up of several cooked idlis, while the "L" is shaped with chutneys, and the final "E" resembles a flavorful side dish — possibly sambar. The doodle sits on a banana leaf, a traditional serving plate in South Indian cuisine.

Despite its popularity, the origin of idli remains uncertain. Food historian K.T. Achaya once suggested that idIndonesia, inspired by a similar fermented rice cake known as kedli. Ancient trade between South India and Southeast Asia could have helped the recipe travel across regions.

Another theory points to Arab traders on India's western coast. Seeking halal food, they may have adapted local ingredients into the now-familiar form of idlis paired with coconut chutney.

Food historian Kurush Dalal added that since rice cultivation in South India dates back about 3,000 years, idlis cannot be older than that. He also noted that the process of fermenting rice and urad dal batter likely developed later, meaning the modern idli could be just a few centuries old.

While its exact origins are still debated, one thing is certain: idli continues to be a timeless dish — light, nutritious, and deeply rooted in Indian food

Your computer mouse can listen to your conversations, suggests new study

Researchers have demonstrated that an ordinary computer mouse can be turned into a makeshift microphone capable of eavesdropping on nearby conversations.

A team at the University of California unveiled a technique called Mic E Mouse on October 11, 2025, showing how high precision optical and motion sensors in modern mice pick up tiny acoustic vibrations. By exploiting those vibrations, malware running on an infected computer can emulate a microphone and reconstruct speech recorded through the

The researchers say the attack relies on a compromised host: an attacker must first install code on the victim's machine. Once installed, the code reads sensor outputs that respond to sound induced vibrations, applies denoising methods including a Wiener filter, and feeds the cleaned signal into an AI model to identify speech. According to the team, word recognition averaged about 61 percent accuracy in their tests, while numeric strings — such as credit card digits were recovered with higher reliability. raising clear privacy and financial security concerns.


Mic E Mouse highlights a broader issue: many endpoint security tools focus on network traffic and common audio devices, while small peripherals are often less monitored and can be abused as covert sensors. The researchers stressed that the attack requires physical proximate sound and still presents practical challenges, but it is realistic enough to



warrant attention from manufacturers and security teams.

The paper's demonstration video and technical details accompany the release. Experts recommend treating peripherals as potential attack surfaces, applying strict device control policies, keeping systems patched, and using endpoint detection tools that monitor unusual device readings. For most users, switching to a sturdier surface for the mouse, repositioning it away from sensitive conversations, and maintaining good malware hygiene can reduce risk. Regulators and vendors will likely need to update standards and testing to address this emerging side channel threat

strated the tool in a video, explaining that many Reels are in languages users don't understand, but AI translation can help bridge that gap. In his demo, Mosseri spoke in Hindi, Spanish, and Portuguese to showcase the tool's accuracy and ease of use.

What sets Meta's translation apart from similar tools like YouTube's autodubbing is that both creators and viewers have control. While creators can enable or disable voice translation when uploading Reels, viewers can also choose whether or not to hear translated audio. This can be managed by tapping the three-dot menu on a Reel, going to "Audio and language settings," and selecting "Don't translate."

Creators also benefit from performance insights. Once a Reel is translated, Meta provides a breakdown of views by language, allowing creators to see which audiences are engaging with their content the most. The feature works best with face-to-camera videos where the speaker's mouth is clearly visible and supports up to two voices in a single clip. Meta says the feature is aimed at helping creators grow their audiences globally by removing language barriers, making Reels more inclusive and widely accessible across different regions.

Why Some Sounds Hurt Your Ears

Most of us have winced at the highpitched screech of chalk on a blackboard or cringed at the sound of nails scraping a surface. But why do some everyday sounds feel so irritating—or even painful?

The answer lies in the frequency of sound. Human ears can typically hear frequencies ranging from 20 Hz to 20,000 Hz (20 kHz). Sounds lower than 20 Hz are called infrasonic and are often felt as vibrations rather than heard. Sounds above 20 kHz are ultrasonic, and while humans can't usually hear them, very high-pitched noises within the upper end of our hearing range can feel extremely uncomfortable.

High-frequency sounds, like squeaking, screeching, or sudden metallic noises, are especially hard on our ears. These sounds stimulate a more intense response in the auditory system, triggering discomfort, and in some cases, even physical pain. This is why certain sounds, despite being low in volume, can still be intolerable.

Children and younger people tend to hear higher frequencies better than older adults. As people age, their ability to perceive high-pitched sounds often diminishes—a natural process



called presbycusis.

So how does hearing work? Sound is a form of energy that travels in waves. These waves enter the outer ear (the part you can see, called the pinna) and travel down the ear canal, where they

strike the eardrum (tympanic membrane). The vibrations are then passed through the middle and inner ear, eventually reaching the brain, where they are interpreted as sound.

Understanding sound sensitivity is

not just about discomfort—it can also help in designing better classrooms, devices, and public spaces that are more acoustically friendly, especially for people with sensory sensitivities.

Nitish Kumar Reddy (43 off 54) provided quick runs in the morning session, sharing a fluent 91-run stand with Gill for the fourth wicket. He entertained with aggressive stroke play, including two sixes off left-arm spinner Jomel Warrican, who was the pick of the bowlers with 3 for 98.

West Indies bowlers toiled hard on a flat pitch, with Jayden Seales and Anderson Phillip proving expensive and inconsistent.

India declared after 134.2 overs, giving themselves enough time to press for a series win. With the pitch expected to deteriorate, India's spinners will look to exploit conditions in the coming sessions.

Simran Sharma Faces Medal Loss After Guide Fails Dope Test

India's top para-athlete Simran Sharma is facing the prospect of losing her medals from the World Para Athletics Championships 2025, after her guide runner, Umar Saifi, tested positive for a banned substance.

Saifi, who has been guiding Simran for over seven months, has tested positive for Drostanolone, an anabolic steroid known to enhance muscle mass and strength. The dope test was reportedly conducted during the Delhi State Open meet on September 7, where Saifi won gold in the 200m event.

He now features on the National Anti-Doping Agency (NADA)'s updated list of provisionally suspended athletes released on Friday. Saifi can contest the finding and request a 'B' sample analysis, but his provisional suspension has already raised serious implications for Simran's medals.

Simran clinched gold in the 100m T12 and silver in the 200m at the recently concluded World Championships held in New Delhi from September 27 to October 5. The event marked India's first time hosting the global para athletics showpiece.

However, according to International Paralympic Committee (IPC) rules, if a guide is found guilty of doping, the athlete may also be stripped of their medal, as the guide is considered an essential part of the performance.

"Yes, there is a big chance of Simran and India losing both medals. The guide is also considered an athlete. Though only the athlete's medal counts, both receive medals and certificates," confirmed Indian Para Athletics Chairman Satyanarayana.

Simran had earlier gained recognition after winning a bronze at the Paris Paralympics in 2024, guided then by Abhay Singh.



In the girls' singles, Unnati Hooda kept India marginally ahead at 18-16 against Thalita Wiryawan, but Indonesia's topranked boys' singles player Mohd Ubaidillah swung the momentum with an 11-5 win over Rounak Chouhan.

The mixed doubles pair Lalramsanga and Vishakha Toppo brought India back into contention, leveling at 28-28 and briefly leading 9-3, but Ikhsan Pra-mudya and Rinjani Nastine surged late to take the match

Nastine then partnered Riska Anggraini to defeat Reshika U and Vennala K 9-2, sealing the first set 45-35. Indonesia maintained dominance in the second set with consistent wins across all categories.

With the team event concluded, Indian players will now shift focus to the individual championships starting Monday.




Mahanati, they were not paired romantically.
