

AP Govt Launches Suraksha App to Combat Spurious Liquor: CM Naidu Vows Zero Tolerance

jayawada Oct 12: In a decisive move to curb the menace of spurious liquor and illegal belt shops across Andhra Pradesh, Chief Minister N. Chandrababu Naidu on Saturday launched the "AP Excise Suraksha App", a technology-driven initiative aimed at ensuring transparency, accountability, and safety in the liquor trade. The Chief Minister announced the launch at his camp office, asserting that the new initiative would mark a significant step toward eradicating counterfeit liquor and restoring public confidence in the state's excise system.

Explaining the features of the newly introduced app, Naidu said that every liquor bottle sold in Andhra Pradesh would now be traceable from manufacturing to retail. "Shop owners will be required to scan each bottle before selling it to consumers, while custhe authenticity of the product through the app. This two-way verification will make it nearly impossible for counterfeit or illicit liquor to enter the market," he stated. The application will also ensure that all authorised retail outlets are geo-tagged, effectively preventing the operation of illegal belt shops that have proliferated in recent years.

Referring to the recent Mulakalacheruvu spurious liquor case, which resulted in several casualties and public outrage, the Chief Minister revealed that 16 individuals, including the main accused Janardhan, have been arrested out of the total 23 persons involved.

"We have also suspended a TDP leader allegedly linked to the case. My government will take strict action against anyone involved, regardless of political party or position," he asserted. Naidu maintained that it was,



in fact, leaders from the Telugu Desam Party (TDP) who first exposed the incident, highlighting the administration's commitment to accountability transparency.

The Chief Minister alleged that the network behind the spurious liquor trade has international roots, with operations traced to parts of Africa. "Certain individuals are trying to replicate that model here in Andhra Pradesh under political cover," he said, accusing opposition elements of attempting to tarnish the government's reform efforts. To strengthen enforcement and prevent recurrence, the state government has formed a Special Investigation Team (SIT) comprising top police and excise officials G.V.G. Ashok Kumar, Rahul Dev Sharma, K. Chakravarthi, Mallika Garg, and an expert from the Excise Department.

The SIT has been tasked with conducting an exhaustive probe and recommending a comprehensive revamp of the existing excise system.Naidu dismissed the opposition parties' demand for a CBI probe, calling it a politically motivated tactic designed to divert attention from their own failures. "Those who remained silent when 27 people died in the Jangareddygudem liquor tragedy during the previous regime are now demanding a CBI probe. Their hypocrisy is evident," he remarked. The Chief Minister accused the previous government of promoting its own liquor brands and monopolizing the entire liquor trade by forci-

shops, transport networks, and distilleries.

He claimed that during their tenure, the state saw the transformation of ganja cultivation into a commercial enterprise, which in turn led to an alarming rise in drugrelated crimes. "Those who once encouraged such criminal activities are now trying to mislead the public with false propaganda. This government will not spare anyone spreading misinformation," Naidu

warned. Emphasizing that the welfare and safety of citizens remain top priority, he said the Suraksha App will establish a transparent, citizen-connected monitoring system wherein consumers themselves become part of the enforcement network by verifying product authenticity.In a stern message to Excise Department personnel, Naidu stressed that officials must discharge

accordance with the law. "Any negligence or col-

lusion will invite disciplinary action. There will be no room for corruption or compromise when it comes to public safety," he cautioned. With the launch of the AP Excise Suraksha App, the government signals a significant push toward integrating technology into public governance. By enabling bottle-wise tracking, citizen participation, and digital transparency, the state aims not only to dismantle illegal liquor networks but also to rebuild trust between citizens, retailers, and the government. The initiative reflects Chief Minister Chandrababu Naidu's broader vision for a technology-powered, corruption-free Andhra Pradesh, one where innovation and enforcement go hand in hand to protect lives and uphold public trust in

are expected to cover Visakhapatnam, Anakapalli, Vizianagaram and Srikakulam districts, anticipating population expansion alongside industrial investment. Highlighting the government's "employment-first" agenda, Lokesh revealed that upcoming projects, including a major steel plant and a host of large-scale manufaccompanies, could generate close to five lakh jobs in the region. Liquor Scam, Blames Chandrababu and Lokesh TPN BUREAU, Nagari, oct 12: Andhra Pradesh Former Minister and YSRCP leader RK Roja has launched a scathing attack on the

Chandrababu Naiduled state government, demanding an immediate CBI investigation into what she described as a "massive spurious liquor scam" devastating families across Andhra Pradesh. Addressing a press conference in her constituency Nagari, Roja alleged that all availa-

ble evidence points towards Chief Minister N. Chandrababu Naidu and his son, Minister Nara Lokesh, as key masterminds behind the illegal liquor network. She argued that such large-scale production and distribution of toxic liquor could not occur without the protection or involvement of political

leaders in power. For the last 16 months, after the NDA coalition came to power, spurious liquor manufacturing has spread across the state," Roja said, adding that Excise Department data reportedly indicates a 21% rise in fake liquor. ganja, and drug-related crimes during this pe-

she claimed that instead of taking strong action against culprits, the ruling TDP was trying to brand those arrested as YSRCP sympathizers, misleading the public and shielding political allies.

Roja demanded the resignation of Excise Minister Kollu Ravindra, alleging complete failure in tackling the menace and deliberate attempts to misinform

citizens about the scale of the crisis. The former minister also called for a criminal probe into Principal Secretary Mukesh Kumar Meena, citing administrative lapses and potentially deliberate inaction. According to her, these failures have allowed the fake liquor trade to expand unchecked and cause considerable harm to communities. In a startling allegation, Roja claimed that the TDP had brought in international liquor dealer Jayachandra Reddy reportedly owner of four liquor factories in Africa to replicate an "Africa model" of spurious liquor manufacturing in Andhra

She questioned the party's decision to field him from Tamballapalle and continue with him as constituency incharge despite his alleged conviction in smuggling-related cases.Roja appealed directly to Prime Minister Narendra Modi to intervene and order a Central Bureau of Investigation probe into the scam, asserting that only an independent investigation could deliver justice to the families affected by toxic liquor.

She also urged wom-

en across the state to join the YSRCP's agitation, intensify protests, demand the closure of belt shops, and press for strict punitive action against those responsible. "This is not just a political issue, it is a public health emergency," Roja emphasized, warning that without immediate and decisive measures, the fake liquor crisis could claim even more lives and push countless families into tragedy.

YSRCP Launches State wide Protest Against Spurious Liquor Menace in Andhra Pradesh

jayawada, October 12, 2025: The YSR Congress Party (YSRCP) has announced a state-wide agitation to protest against the alarming surge in spurious liquor trade across Andhra Pradesh. The protest campaign, directed by party president and former Chief Minister YS Jagan Mohan Reddy, aims to spotlight the alleged largescale corruption and failure of the ruling Telugu Desam Party (TDP)led coalition government in controlling this deadly menace that has already claimed numerous

As part of the ongoing agitation, the YSRCP is organizing protest demonstrations on Monday. October 13, in front of all Excise Department of-

Party leaders, cadre, and supporters will gather to submit petitions demanding immediate and decisive action against those involved in the illicit liquor trade. The party alleges deep-rooted political patronage and involvement of key ruling party leaders in this illegal racket, placing the health and safety of the common people at risk.

The YSRCP has called for a comprehensive investigation into all wine shops, bars, and belt shops to expose those running the spurious liquor network regardless of their political affiliations. A central investigative agency probe by the Central Bureau of Investigation (CBI) has been demanded to en-

The party also demands fair compensation for the families of victims who have lost their lives to fake liquor poisoning.Highlighting their concerns, YSRCP leaders have sought the rollback of the government's privatization moves in liquor sales and called for its return to direct state control.

They have urged the reduction of working hours for wine shops and the cancellation of licenses for bars operating close to schools, temples,

and public spaces as measures to curb the spread of spurious liquor.The YSRCP Women's Wing has been particularly vocal, staging protests across major districts like Vijayawada, Tirupati, Kurnool, Guntur, Visakhapatnam, Anantapur, and Nellore. Women leaders dramatically smashed liquor bottles during these protests while chanting slogans condemning the government's alleged role in

enabling the illicit trade. They accused the current coalition govern-

ernment-run liquor shops to benefit TDP leaders involved in illegal activities linked to counterfeit liquor manufacturing and sales.YS-RCP Rajampet MP P V Midhun Reddy has urged the Union Home Minister Amit Shah for urgent central government intervention. He described the spurious liquor racket as a large-scale, organized interstate crime involving the manufacture of toxic methanol-based liquors that have led to multiple poisoning deaths. He stressed the need for coordinated intelligence sharing among states to dismantle the illicit network and called for tight monitoring of industrial alcohol to prevent its diversion for illegal use.

TPN BUREAU, AMAR-AVATI OCT 12: The Andhra Pradesh Class IV Employees Association, a vital partner in the APJAC Amaravati coalition of employee unions, has made a strong demand for the immediate implementation of pre-election promises made by the government to its staff. At a crucial state executive committee meeting held in Guntur on Sunday, association leaders decried the coalition government's continued inaction, emphasizing that employees, especially retirees and bereaved familiesare bearing the brunt of unfulfilled commitments and overdue

Key Demands on Unfulfilled Promises

Addressing the gathering as chief guest, AP-JAC Amaravati State Chairman Bopparaju Venkateswarlu called on the government to honor

the guarantees it gave before coming to power. "The government should implement the guarantees given to the employees before the movement takes off," he asserted, underlining the mounting discontent among employees. He noted that more than 15 months have passed since the coalition government took office, yet crucial pledges such as the announcement of Interim Relief (IR), appointment of the statutory 12th PRS Commissioner, and release of four pending Dearness Allowances (DAs) remain neglected.

Equally alarming, Bopparaju said, is the situation of retired employees who are "dying while waiting for their dues" such as gratuity and leave encashment. He also highlighted the pain of families of deceased employees who are still awaiting financial settlements. The delay in clearing thousands

of crores in arrears, coupled with the government's failure to even announce IR to mitigate hardship, was condemned as a gross Organizational Initia-

tives and Association StrengtheningThe meeting, presided over by Class IV Employees Association State President S. Malleswara Rao and conducted with the support of State General Secretary Thota Sri Chennappa, also resolved to boost organizational strength at the district level. Central to this resolution is the formation of district executive committees for the Class IV Association in all the 13 newly formed districts. "Vacancies of class - IV employees should be filled in all offices," stressed the resolution, further reiterating the demand for filling vacant posts across departments.

Association leaders

pledged to establish or strengthen district units in the next two months, covering both the restructured 13 districts and one additional unit, to better mobilize grassroots support and effectively address long-pending demands.

Employee Plight and Call for Action.

Speakers at the meeting poured out their grievances, stating that employees have held on to hope with the arrival of every festival, expecting resolution or financial disbursement, but so far not a single rupee has reached them from the government. Government Invites Public Ideas for Rushikonda Palace Utilization in Visakhapatnam

TPN BUREAU, Amaravati, October 12:

In a significant move aimed at ensuring transparency and optimal utilization of state assets, the Andhra Pradesh government has initiated steps to bring the palatial buildings constructed during the YSRCP regime on Rushikonda Hills in Visakhapatnam into productive use. The Tourism Department has opened the doors for public participation by inviting ideas and suggestions from citizens, experts, and organizations on how best these buildings can serve the public interest.

Tourism Authority CEO Dr. Amrapali announced that the department is seeking innovative proposals on potential uses for the Rushikonda structures, which have remained largely unused since their construction. Members of the public who wish to share their ideas have been requested to send their suggestions via email to rushikonda@ aptdc.in. Dr. Amrapali stated that the government aims to make practical and people-centric decisions regarding these

prime properties. To achieve this, the Andhra Pradesh Tourism Development Corporation (APTDC) is looking to balance tourism promotion, environmental sustainability, and public welfare while considering future use plans. The focus of the exercise is to ensure that the development at Rushikonda complements Visakhapatnam's image as a fast-emerging tourist and business hub. "As part of this initiative, we are encouraging citizens to share their creative ideas about how these build-



ing ecological balance. To further expand the consultation, a meeting has been scheduled for the 17th of this month with several national and international organizations. These include prominent tourism development consultancies. hospitality experts, and environment planners. The purpose of the meeting is to gather a wide range of professional perspectives on repurposing the Rushikonda buildings in ways that can attract both domestic and international visitors. Dr. Amrapali emphasized that the government wants to ensure that any decision taken reflects inclusiv-

ity and transparency. Therefore, all suggestions received from the general public and expert bodies alike will be compiled and studied by a specially formed Group of Ministers. This group will thoroughly review each proposal's feasibility, sustainability, and potential

impact on tourism and employment generation in the region."After reviewing the inputs from various stakeholders. the Group of Ministers will submit their recommendations to the state cabinet," she explained. "Only after this process will the government make a final decision on how the Rushikonda properties will be utilized.

'The state government's decision to seek public participation is being viewed as a progressive step toward participatory governance. It also marks an effort to put contentious infrastructure, created at considerable expense, to meaningful use that benefits both the local community and the state economy.By involving citizens and global advisors, the government hopes to transform the Rushikonda buildings into iconic spaces that could potentially serve as tourism resorts, convention centers, or eco-friendly recreational facilities, thereby boosting Visakhapatnam's tourism profile. The initiative is expected to set a new benchmark for accountable and citizen-driven policymaking in Andhra Pradesh.

Government Set to Cancel Four Limestone Leases, Including Bharathi **Cement's Allocations**


TPN BUREAU OCT 12: The Andhra Pradesh government is preparing to cancel four controversial limestone mining leases granted last year, including those allotted to Bharathi Cement, Associate Cement Company (ACC), and Ramco Cements. This decision comes in line with the Central Mines Department's 2015 regulations, which mandate that all new mining leases for major minerals must be issued only through public auction. According to official sources, the government has instructed the Mines Department to submit a detailed report on the irregularities in granting these leases.

The department has reportedly completed its investigation and submitted the report, recommending the cancellation of four leases that were issued in violation of central norms and timelines. The controversy primarily surrounds Bharathi Cement, a company owned by the family of YSR Congress Party (YSRCP) chief Y.S. Jagan Mohan Reddy, where his wife Bharathi Reddy serves as a director. The company had obtained two limestone leases just before the 2024 Assembly elections, raising questions about the timing and legality of the approvals.

The leases in question trace back to 2009, when Raghuram Cements later acquired by Bharathi Cement—applied for mining rights over 509.18 acres and 235.56 acres in Kamalapuram and Erraguntla mandals of YSR Kadapa district. Letters of Intent (LOIs) were is-

sued for these leases before 2015. However, as per amended rules brought by the Central government, companies with LOIs issued before January 12, 2015, were required to secure all permissions a n d environmental clearances within two years, i.e., by January 11, 2017.

Failure to do so would render the LOIs invalid. Bharathi Cement, however, failed to obtain the necessary permits within that period. Further complications arose when the company did not inform the Mines Department about the name change from Raghuram Cements to Bharathi Cement. As a result, the state government issued a notice in 2016 withdrawing the LOIs. The company then approached the High Court and obtained a status quo order. In 2023, the court directed the government to hear Bharathi Cement's case and decide accordingly. Subsequently, on February 2, 2024 barely a month before election notification the then Jagan-led ad-

case. The YSRCP government then sought opinions from a former Chief Justice of the Supreme Court and the then Advocate General. Based on their favorable opinions, a lease was officially granted to ACC on November 15, 2023. Ramco Cements too benefited from similar circumstances, receiving 267.30 acres of lease rights in Jayanthip-

dal of NTR district on March 15, 2023.

Officials now confirm that all these leases two of Bharathi Cement, one of ACC, and one of Ramco Cements are under review and scheduled for cancellation. The government's latest move signals a firm enforcement of central rules and aims to prevent irregular allocations of valuable mineral resources without transparent auction procedures.

Sharmila Slams Centre for Weakening RTI Act, Calls for Restoration of Transparency Measures

OCT 12: In a sharp criticism of the Union government, Andhra **Pradesh Congress Committee** (APCC) president Y.S. Sharmila Reddy on Sunday accused the Centre of systematically eroding the Right to Information (RTI) Act—one of the most powerful citizen-centric laws ever enacted in India. Addressing a gathering in Vijayawada on the occasion of the RTI Act's 20th anniversary, Sharmila described the law as a "revolutionary weapon for citizens" and a milestone in ensuring transparency and accountability in public governance.Recalling the historic contribution of the Congress in bringing the law into existence in 2005, she said the RTI Act was a proud achievement of the UPA government under the leadership of then Prime Minister Dr. Manmohan Singh and UPA chairperson Sonia Gandhi.

"It was a visionary step that empowered ordinary citizens to question the government, expose corruption, and demand transparency at every level of administration," Sharmila stated. She noted that lakhs of people across the country had used the provisions of the Act to access government records and bring irregularities to light, strengthening democratic participation over the past two decades. However, the APCC chief alleged that the Narendra Modiled BJP government had deliberately undermined the Act's original spirit through the 2019 amendments.

"The amendments effectively stripped the Information Commissions of their autonomy, gave undue powers to the Centre to determine their service



conditions, and diluted the fixed tenure of commissioners,' Sharmila said. "This not only weakens the institutional integrity of the commissions but also discourages officials from functioning independently," she added. Highlighting the growing administrative negligence, Sharmila pointed out that the Central Information Commission (CIC) has been operating for months without a full-time Chief Information Commissioner and is currently understaffed.

Only a few of the mandated 11 commissioners have been appointed, leading to massive backlogs. "Across 29 information commissions in the country, more than four lakh RTI applications are pending," she revealed, calling the situation unacceptable and indicative of the Centre's disregard for peo-

ple's right to know. Sharmila asserted that the RTI framework represents the foundation of participatory democracy, where transparency serves as a check on power. "When the government hides facts or delays responses, it is not just a bureaucratic lapse, it is an attack on democracy itself," she warned.

Emphasising that truth and openness are essential for public trust, she said the weakening of the RTI system threatens the ability of citizens to hold officials accountable for misuse of authority or funds. The APCC, under her leadership, has demanded a complete reversal of the 2019 amendments and restoration of the RTI Act to its original 2005 format. The party also called for reinstating the fiveyear tenure of commissioners, ensuring the appointment of all eleven members in the Central

Information Commission, and enforcing strong whistleblower protection mechanisms.

Additionally, the APCC urged the inclusion of representatives from various sections of society, especially women, minorities, and marginalized communities in the information commissions to reflect India's diversity in its transparency institutions.Y.S. Sharmila concluded by pledging that the Congress would continue to defend the RTI Act as part of its larger mission to safeguard citizens' democratic rights. "Every Indian has the right to ask questions and the government has the duty to answer. The RTI Act is not just a law, it is the voice of the people. We will not allow that voice to be silenced," she declared amid applause from Congress members and RTI activists gathered at the Vijavawada event.

Farm Sector in Deep Crisis Under Coalition Rule: MVS Nagi Reddy

TPN | Vijayawada | October 12, 2025 YSR Congress Party (YS-RCP) General Secretary MVS Nagi Reddy has launched a scathing attack on the NDA coalition government in Andhra Pradesh, accusing it of completely neglecting the farm sector and pushing lakhs of farmers and agricultural labourers into distress. Addressing reporters at the YSRCP Central Office in Vijayawada on Sunday, Nagi Reddy said that the coalition's policies have crippled the state's agricultural economy and deepened the crisis in rural livelihoods.

According to Nagi Reddy, the total cultivated area in the state has drastically fallen under the current government's tenure. "During the five years of YS Jagan Mohan Reddy's administration, an average of 32.94 lakh hectares was cultivated every kharif season. Under the coalition government, that number has dropped to just 28.19 lakh hectares, marking a steep decline of 11.73 lakh hectares," he said. This sharp drop, he noted, has led to an estimated loss of over 3,000 crore in agricultural employment and production value, a serious blow to the state's rural economy. The YSRCP leader criticised the government's withdrawal of key farmer welfare schemes such as free crop insurance,



which he said has left cultivators vulnerable to natural calamities like droughts and floods. "Major crops such as paddy, chilli, tobacco, mango, onion, and tomato have faced massive damage this year. Yet, the government has offered no compensation, no relief, and no reassurance," he alleged.Nagi Reddy contrasted the current situation with the proactive measures taken by the pre-YSRCP vious

administration. He recalled that despite starting with a nearly empty treasury of just 100 crore, for-mer Chief Minister YS Jagan Mohan Reddy had prioritised the welfare of farmers through initiatives like Rythu Bharosa, which provided 12,500 in annual investment support to every farmer. He also mentioned that the previous government ensured timely disbursal of free crop insurance, input assistance, and created price stabilization funds to protect farmers from market volatility."In contrast," Nagi Reddy continued, "Chief Minister Chandrababu Naidu began his term with 7,000 crore but has failed to deliver even basic support to the agricultural community.

Payments are being delayed, crop procurement is stalled, and promises made to farmers have not been honoured."He pointed out that the denial of minimum support prices (MSP) has further worsened the farmers' plight. Many, he said, have been forced to dump their produce on roads due to lack of proper market prices or timely government intervention. "This administration's inaction has led to desperation among the farming community. Tragically, 29 farmers have committed suicide since the coalition came to

Yet, not a single bereaved family has received compensation," he revealed.Calling the current situation a "collapse of the rural economy," Nagi Reddy demanded the immediate restoration of crop insurance, release of compensation to affected farmers, and revival of procurement through MARKFED. "The government must act before the farming landscape in Andhra Pradesh is irreversibly damaged. This is not development it is destruction," he warned, urging the state to prioritize agriculture once again to prevent further social and economic suffering.

Praja Arogya Vedika Demands Immediate Fulfillment of Promises to PHC Doctors



TPN BUREAU, Vijayawada, Oct 11 – Praja Arogya Vedika (PAV) has extended full support to the ongoing protest of Primary Health Center (PHC) doctors, urging

the state government to immediately fulfil the assurances given to them and restore the supply of medicines to PHCs across Andhra Pradesh. On Saturday, a delegation from PAV's NTR District Committee visited the protest camp of PHC doctors at Dharna Chowk, Alankar Center, Vijayawada, where hundreds of physicians from

government primary health centers have been staging an agitation since October 4th.

The team expressed solidarity with their struggle, stressing that

sues is directly tied to improving the public healthcare system. Speaking at the protest site, PAV NTR District General Secretary G. Vijay Prakash emphasized that addressing PHC doctors' problems is tantamount to addressing patient concerns and strengthening the overall medical infrastructure. He noted that nearly 2,800 doctors serve in rural and tribal areas, often under challenging circumstances, ensuring that underserved communities receive essential healthcare services.

"The government's indifference is unacceptable. These doctors have been boycotting duties and agitating for over a week to secure promises already made to them. Yet, the administration is responding like a lemoncompletely indifferent," Vijay Prakash stated bluntly. He demanded the immediate cancellation of JVO No. 99, provision of 30% reservation in clinical posts for inservice doctors, and 50% in non-clinical posts within the in-service category, along with tribal allowance for doctors serving in tribal PHCs. Other major demands from the protesting doctors include timely promotions, payment of notional increments, settlement of 104 service arrears, and complete government management of all medical and health services.

Vijay Prakash warned that continued inaction would severely undermine the primary health system and jeopardize the public's access to quality care.He rejected any notion that the doc-

sive demands, pointing out that their agitation is rooted solely in promises the government had already agreed to earlier. "By fulfilling these just demands, the government will empower doctors to deliver far more effective healthcare services to the people," he said. The protest also saw participation from various medical sector leaders, including Dr. Ravindra Nayak, Dr. Kishore, Dr. Vinod, Dr. Gyanesh, and Dr. Mounika. Representatives from other associations in the medical field echoed the call for immediate resolution of the PHC doctors' grievances. A round table meeting, held at the protest camp, reiterated the urgency of addressing these issues. PAV leaders argued that it was imperative to get the primary

track, especially in rural and tribal belts where PHCs form the backbone of basic medical care. District leaders PBS Ramavatharam, Leela, and Bhanu Prasad, along with several PAV activists, stood alongside the doctors, affirming their commitment to continue supporting the movement until the government takes concrete action.

Praja Arogya Vedika warned that prolonged government silence could escalate the crisis, disrupt rural healthcare delivery, and erode public trust in the medical system. They appealed to state authorities to demonstrate responsiveness and empathy by fulfilling the assurances without delay, thereby strengthening public health in

Expands Focus from Electric to **Hydrogen Buses**

TPN BUREAU, Vijayawada, October 12, 2025: In a major boost to India's green mobility revolution, Convergence **Energy Services Limited** (CESL), a wholly-owned subsidiary of Energy Efficiency Services Limited (EESL) under the Ministry of Power, Government of India, has unveiled a comprehensive plan to expand its clean transportation initiatives from electric to hydrogen-powered buses. After successfully tendering over 33,000 electric buses across

multiple Indian states and cities under various government flagship programs, CESL is now preparing to aggregate national demand for hydrogen buses. The overarching objective is to ensure that hydrogen bus adoption becomes a practical and scalable solution for India's public transportation needs. Building upon the success of its electric bus programs such as FAME India Phase II, National Electric Bus Program (NEBP), PM-eBus Sewa



Scheme, and PM E-DRIVE Scheme, CESL has been designated by the Ministry of Housing and Urban Affairs (Mo-HUA), Ministry of Heavy Industries (MHI), and Ministry of External Affairs (MEA) as the nodal and project implement-

ing agency for the demand aggregation, tendering, and deployment of both electric and hydrogen mobility solutions. The company is also the implementing agency for the Payment Security Mechanism (PSM) under the PM-

eBus Sewa Scheme. CESL's earlier success in electric bus aggregation has already demonstrated a transformation in India's transport economics. Its Gross Cost Contract (GCC) model brought down the cost of e-bus operations to levels comparable to or lower than CNG and diesel buses, ensuring financial feasibility for states and operators

The model emphasized transparent bidding, standardized technical requirements, and mobility-as-a-service contractsprinciples CESL now intends to replicate for hydrogen bus procurement. Highlighting the importance of the hvdrogen initiative, Akhilesh Kumar Dixit, Chief Executive Officer of EESL, in a letter to key stakeholders including Bhupender Gupta, CMD of NHPC, reinforced the need for accelerated hydrogen bus demand aggregation to further national economic and environmental interests. Five Students Swept Away by Waves at Chirala Vadarevu Beach, Three Dead, Search On for Two Missing.

TPN BUREAU, CHIRA-LA, OCT 12: Tragedy struck the coastal waters of Vadarevu Beach in Chirala mandal of Bapatla district on Sunday, when five students were swept away by powerful waves. The incident has cast a pall over the holiday mood, as rescue teams continue searching for two of the missing youths. According to eye witnesses, the group of ten engineering students from Wits University in Amaravati had come to Vadarevu for a Sunday outing. Vadarevu, along with nearby Suryalanka Beach, is a popular tourist spot during weekends and holidays. The students, excited

The students, excited to enjoy the sea, entered the water in the afternoon. Suddenly, strong waves pulled several of them out to deeper waters before they could react. Among those who were caught by the powerful current were Sri Saket, Sai Manideep, and Jeevan Satwik, all from

Hyderabad, as well as Somesh and Gautam, both hailing from Chirala. Local fishermen and swimmers, seeing the group in distress, rushed to help. Despite their valiant efforts, three of the youths Sri Saket, Sai Manideep, and Jeevan Satwik could not be saved.

The sea carried them away, and their lifeless bodies washed ashore shortly afterward. The bodies have been shifted to Chirala Government Hospital for post-mortem formalities, and their families have been informed. The news has come as a devastating blow to parents and classmates, many of whom have gathered at the hospital in shock and grief. Meanwhile, Somesh and Gautam remain missing. Officials from the Fire Department and the Fisheries Department have deployed rescue boats and special lighting equipment, including dragon lights, to aid in nighttime search operations.



The strong currents and choppy waters have posed significant challenges to the search teams, but authorities remain hopeful they will locate the missing youths.Bapatla District Superintendent of Police Umamaheshwar personally visited the site to oversee the rescue efforts and assured that all possible measures were being taken. He also appealed to the public to exercise caution when entering the sea, especially during periods of rough weather. Incidents such as this have once again highlighted the need for increased safety measures and public awareness at beaches in Andhra Pradoch

Andhra Pradesh.
While Vadarevu and Suryalanka beaches are popular destinations, they have witnessed accidents in the past due to strong tidal conditions. Officials are likely to review safety protocols, in-

of lifeguards and warning systems, to prevent similar tragedies in the future. As rescue operations continue late into the night, hopes remain pinned on finding the missing students and bringing closure to the grieving families. The incident serves as a sobering reminder of the unpredictable nature of the sea and the importance of vigilance near coastal waters.

India Attracts Record Foreign Investment Despite Rupee Weakness

Global central banks monetary complexity, unison, creating a fragmented monetary landscape. The United States Federal Reserve recently cut its policy rate by 25 basis points, bringing it to a range of 4-4.25 per cent. In contrast, the European Central Bank (ECB) remains cautious, holding rates steady as it balances inflation concerns with sluggish growth. Japan continues its ultra-loose monetary policy with nearzero rates and extensive bond purchases, while China is aggressively easing policy rates to support its slowing economy. This divergence marks a clear departure from the postpandemic trend when most central banks tightened policies collectively to combat inflation. Liquidity is now being injected in some regions while withdrawn in others, creating yield differentials that scatter capital flows rather than chan-

neling them uniformly.

the Indian rupee is under pressure, recently slipping past Rs 88 to the dollar, marking a historic low. Conventional wisdom would suggest that a weakening currency deters foreign investors, yet paradoxically, inflows into India continue unabated. Third, indexdriven and structural flows provide stability, as pension funds and sovereign wealth funds allocate resources to India due to benchmark mandates rather than speculative motives.

Free Speech: The Lifeblood of Public Reason and Democracy

One of the most vulnerable domains of public life today is free speech. As US Supreme Court Justice Louis Brandeis famously stated, public discussion is a political duty: the remedy to falsehood and harm is more speech, not enforced silence. Free speech is essential because it makes the Public, enabling citizens to participate in shaping ideas, policies, and societal norms. Yet, both totalitarian and democratic regimes increasingly curtail this freedom, revealing a worrying convergence in practice.

The principle of Public Reason asserts that laws harming communities, driven by prejudice, sectarianism, or ideological motives, are illegitimate. Restrictions are justified only when speech produces actual harm, such as hate



speech inciting violence. What is unacceptable is viewpoint-based suppression—proscribing speech simply because it challenges the state's official stance. Legal scholar Geoffrey Stone emphasized:

"The government may

not restrict expression simply because it disagrees with the speaker's views." Similarly, Justice Thurgood Marshall insisted that governments cannot limit speech based on its content or ideas, for doing so undermines democratic debate. Yet, governments

often justify curbs on speech citing "national interest" or "national good," ironically undermining the very public whose participation defines these concepts. Paternalistic regulation privileges certain majority interests over the broader public, skewing discourse and shaping citizens to conform to ideological lines. Historical examples are stark: Nazi Germany's propaganda machinery and Rwanda's radio-fueled ethnic mobilization show how viewpoint suppression and orchestrated hate speech paved the way for genocide.Countering harmful speech is central to preserving Public Reason. As political scientist Katherine Gelber observes, citizens must respond to disagreeable or harmful speech, engaging in reasoned rebuttal to prevent

the public from being manipulated. In Habermasian terms, the Public emerges not only through debate but through active counters to misinformation, bias, and hate speech. Silence, or non-engagement, enables manipulation and diminishes democratic life. Nobel laureate Toni Morrison reminded us: "There is no time for despair, no place for selfpity, no need for silence, no room for fear. We speak, we write, we do language. That is how civilizations heal." Speaking back—continually, logically, and purposefully—is not just a civic duty; it is what sustains Public Reason and qualifies our life within a democracy. Free speech, therefore, is not merely a right—it is the lifeblood of an informed, resilient, and participatory society.

After weeks of intense negotiations, the National Democratic Alliance (NDA) has officially sealed its seat-sharing arrangement for the upcoming Bihar Assembly elections. The final agreement was announced by Union Minister and BJP's Bihar in-charge Dharmendra Pradhan via a post on X (formerly Twitter) on Saturday.

Under the deal, the BJP and Nitish Ku-

mar's Janata Dal United (JDU) will contest 101 seats each out of the total 243 assembly seats in the state. This reflects a slight reduction from the 2020 elections, where the BJP contested 110 and the JDU 115.

Smaller allies Upendra Kushwaha's Rashtriya Lok Morcha and Jitan Ram Manjhi's Hindustan Awam Morcha (HAM) have been allocated six seats each.

The highlight of the agreement, however, is the final allocation of 29 seats to Chirag Paswan's Lok Janshakti Party (Ram Vilas), whose demands had caused prolonged delays. Initially pushing for 40–45 seats, the LJP had even hinted at exploring an alliance with Prashant Kishor's Jan Suraaj Party if demands were not met. Despite the BJP initially offering just 25 seats, persistent negotiations with Pradhan led to a compromise, with all major partners making room for the LJP. The agreement reportedly involved sacrifices from both the BJP and JDU's share to accommodate Paswan's demands

The LJP's claim was backed by its 100% strike rate in the 2024 Lok Sabha elections, winning all five constituencies it contested, and its performance in the 2020 assembly elections. Chirag Paswan also pushed for at least two assembly seats in each of his party's Lok Sabha strong-holds, along with seats for senior party

The NDA hopes the unified front will strengthen its chances against the Maha-

"Attacks On Independent Thinking": Rahul Gandhi's Remarks In Chile Irk BJP

Congress leader and Leader of the Opposition Rahul Gandhi has once again drawn sharp criticism from the Bharatiya Janata Party (BJP) after his recent comments during an interaction with students at the University of Chile. Speaking about India's education system, caste dynamics, and the state of independent thinking, Gandhi's remarks have been labelled by the BJP as "anti-India propaganda on foreign soil."

Responding to a student's question, Ganthi said he wished to preserve the "curios ity" of young minds in India and ensure that students can "think openly, ask ques-tions, and be scientific." He claimed that such freedom is "under attack" in India, citing a decline in scientific thinking over the past decade under the current government.

"Our education system is dominated by upper castes. Tribal, middle, and lower caste traditions have been left out. I want to change that," he added, arguing for broader inclusion in the academic curriculum.

The BJP quickly hit back. Spokesperson Shehzad Poonawalla, a former Congress leader, accused Gandhi of undermining India's institutions. "He is not the Leader of the Opposition. He is the leader of propaganda and hypocrisy. This is a pattern—he goes abroad to attack India's democratic



system, judiciary, and sovereignty," said Poonawalla.

He also accused Gandhi of spreading misinformation, saying, "He talks of free thinking being suppressed in India. But the real suppression happens in his party — look at what happened to Shashi Tharoor."

The video of Gandhi's remarks was shared on his social media after returning from a tour of South American nations, including Chile. The BJP's criticism of Gandhi has intensified since his elevation as Leader of the Opposition in Parliament, particularly after his foreign visits.

1 Lakh Single-Teacher Schools Serve Over 33 **Lakh Students Across India**

Over 1.04 lakh schools in India are being run by just one teacher, catering to more than 33 lakh students, according to data from the Ministry of Education for the academic year 2024-25. These schools, averaging around 34 students each, raise serious concerns about adherence to the norms of the Right to Education (RTE) Act, 2009.

The RTE Act mandates a pupil-teacher ratio (PTR) of 30:1 at the primary level (Classes I-V) and 35:1 at the upper primary level (Classes VI-VIII). However, in these singleteacher schools, achieving such ratios is structurally impossible, leading to questions about the quality of education being

Among states, Andhra Pradesh leads with the highest number of single-teacher schools, while Uttar Pradesh tops the list in terms of student enrolment in these schools. Other states with significant numbers of such schools include Jharkhand, Maharashtra, Karnataka, and the Union Territory of Lakshadweep.

When it comes to the total number of students in these schools, Uttar Pradesh again tops the chart, followed by Jharkhand, West Bengal, and Madhya Pradesh. Education experts warn that such a setup is unsustainable and detrimental to student learning out-



comes, especially in rural and tribal belts where these schools are often concentrated.

The data comes at a time when the government has been pushing for improved infrastructure, digitisation, and quality in school education under schemes like Samagra Shiksha Abhiyan. However, the prevalence of such a large number of single-teacher schools indicates severe staffing gaps, particularly in remote and underdeveloped

With over 33.7 lakh students dependent on these schools, addressing the shortage of teachers is likely to be a key challenge for both state and central education authorities in the coming years.

Afghan Minister Defends Absence of Women Journalists at Presser as 'Technical Issue'

Afghanistan's Foreign Minister Amir Khan Muttaqi on Sunday responded to widespread outrage over the absence of female journalists at his recent press conference in New Delhi, calling it a "technical issue" and denying any deliberate

The controversy erupted after NDTV reported that no women journalists were seen at the minister's press meet held at the Afghanistan Embassy. The incident prompted backlash from Indian opposition leaders, journalists' associations, and civil society groups, calling it "discriminatory" and an "insult to women."

Clarifying at a second press interaction, Muttaqi said, "It was organised on short notice with a short list of journalists. There was no intention to exclude anyone. It was merely a logistical decision by our colleagues." He also claimed that 2.8 million girls and women continue to study in schools and madrasas in Afghanistan, though certain restric-

The issue gained political traction turn to power in 2021.

after Congress MP Rahul Gandhi criticised Prime Minister Narendra Modi, stating that allowing such exclusion signals weakness and a lack of commitment to gender equality. "He's telling every woman in India that he is too weak to stand up for them," Gandhi said.

Former Union Minister P. Chidambaram also expressed shock and said male journalists should have boycotted the event in solidarity. CPI(M) leader M.A. Baby termed the act "deplorable," while the Editors Guild of India and Indian Women Press Corps (IWPC) condemned the move, calling it a violation of media freedom and gender equality norms.

The Ministry of External Affairs (MEA) clarified it had no role in organising the press conference, stating the Afghan Embassy, a foreign mission, independently handled the guest list. The decision to exclude women, it said, was made by visiting Taliban officials.

The Taliban regime remains under global scrutiny for curbing women's rights in Afghanistan since its re-

Uddhav Thackeray Leads Protest, Demands Loan Waiver and ₹50,000 Aid for **Farmers**

Former Maharashtra Chief Minister Uddhav Thackeray led a protest demanding a complete loan waiver and ₹50,000 per hectare compensation for farmers hit by floods and crop loss. His party, Shiv Sena (UBT), accused the Maharashtra government of misleading farmers with a "₹31,000 crore

Thackeray warned of a statewide agitation after Diwali if the demands are not met. "Farmers are selling their wives' mangalsutras. Where is the government's conscience?" he asked, taking a swipe at Prime Minister Narendra Modi for not mentioning farmers during his recent visit to the

Thackeray said the party would support the state's package if ₹1 lakh per hectare is deposited into farmers' accounts before Diwali. He cited the Shiv Sena-led Maha Vikas Aghadi's previous loan waiver as proof of com-

mitment to farmers' welfare. "This is not a hambarda morcha, it

is an ishara morcha," he said, vowing to visit every district post-Diwali to review implementation of aid. He also appealed to farmers not to lose hope or resort to suicide.

The ₹31,000 crore relief package announced by the Fadnavis government covers crop damage across 65 lakh hectares, including major losses in cotton, soybean, and onion farms. Of this, ₹17,675 crore is for crop compensation, ₹30,000 per damaged well, and ₹10,000 per hectare for the upcoming Rabi season.


CM Devendra Fadnavis dismissed the protest, questioning Thackeray's moral right to lead it. "His ₹20,000 crore waiver during his term was nothing new. We had already implemented similar relief earlier," Fadnavis said. He added that 16 lakh farmers' dues were cleared under the

current government. With farmers' distress growing, the issue is set to become a major flashpoint ahead of the upcoming state











Ukrainian President Volodymyr Zelensky revealed on Saturday that he spoke with former U.S. President Donald Trump, urging him to leverage his diplomatic influence to help end the ongoing war in Ukraine, just as he did in previous Middle

East peace efforts. In a Facebook post following the phone call, Zelensky wrote, "If a war can be stopped in one region, then surely other wars can be stopped as well — including the Russian war." The Ukrainian leader has consistently pushed for stronger international mediation since Russia's full-scale

invasion began in 2022. The appeal to Trump marks a significant turn in their relationship, which has evolved substantially since a contentious meeting at the White House earlier this year in February. At the time, the two leaders clashed over military aid and foreign policy during a widely covered, tense

televised encounter. However, relations have since improved.

Trump has softened his

rhetoric, recently calling Zelensky a "nice guy" and reiterating support for Ukraine's sovereignty. The former U.S. President has also made headlines by claiming he could negotiate an end to the war "within days" if reelected, a stance that has drawn both praise and skepticism.

While Trump currently holds no official government position, Zelensky's outreach suggests Ukraine is open to any avenue that could bring about a ceasefire or broader peace deal, especially with the conflict nearing its fourth year and casualties mounting on both sides.

Zelensky's call comes as global diplomatic momentum builds for renewed negotiations, and follows comments by Melania Trump, who credited Russian talks for aiding the return of Ukrainian children displaced during the war — an issue Ukraine considers a major humanitarian

There has been no official statement from Trump's office regard ing the call.

Preparations begin to ramp up aid in Gaza as ceasefire

Brings hope for end to 2-year war



Preparations are in full swing to deliver urgently needed aid into the Gaza Strip as a new ceasefire agreement between Israel and Hamas offers the first major opening for humanitarian relief after two years of relentless conflict.

On Sunday, Egypt announced it is sending 400 aid trucks into Gaza, loaded with medical supplies, food, fuel, tents, and blankets. The Egyptian Red Crescent confirmed the dispatch, with the aid expected to reach Gaza after passing through Israeli inspection zones at the Kerem Shalom crossing.

The Israeli Coordination of Government Activities in the Territories (COGAT), the agency overseeing humanitarian operations in Gaza, said aid delivery will increase to 600 trucks daily as agreed in the ceasefire terms. This marks a significant rise from the limited aid flows of recent months, which the United Nations said covered only 20 percent of the population's needs due to ongoing fighting, border clo sures, and restrictions on certain items. Sunday's develop-

ments come amid renewed hope that the ceasefire could hold and eventually bring an end to the two-year war that has devastated Gaza's infrastructure, economy, and civilian life. Images from Gaza City on Sunday showed Palestinians returning to street markets, a sign of tentative normalcy following months of displacement and

However, all aid convoys will still undergo Israeli security checks before entering the enclave, a point of ongoing tension among aid groups who argue that restrictions have long delayed essential hu-

manitarian support. Despite the challenges ahead, the increased aid movement is a critical lifeline for Gaza's 2.2 million residents. Humanitarian agencies are now preparing to scale up operations in the coming days, hopeful that this truce will mark a lasting shift toward peace and

Trump to Join Gaza Peace Deal Ceremony in Israel and Egypt

U.S. President Donald Trump is set to travel to Israel and Egypt on Sunday to participate in the signing ceremony of the long-anticipated Gaza Peace Plan, marking a significant diplomatic moment in the Middle East following a two-year-long war between Israel and Hamas.

Trump will depart the White House on Sunday afternoon and arrive in Tel Aviv early Monday morning, local time. His visit will begin with a private meeting with the families of hostages at the Knesset (Israeli Parliament), followed by a formal address to Israeli lawmakers. This is Trump's first visit to Israel since announcing the ceasefire agreement, which has raised hopes for lasting peace in the war-ravaged Gaza Strip.

The visit coincides with the rollout of the first phase of the Gaza Peace Plan—a 21-point framework that includes the gradual disarmament of Hamas, increased humanitarian aid, and a phased reopening of Gaza's

Following his address in Israel, Trump will travel to Sharm el-Sheikh, Egypt, where the official peace signing ceremony will be held on Monday afternoon. Egypt has played a crucial mediating role in the negotiations, hosting several rounds of backchannel talks between Israel and Hamas following Trump's proposal earlier this year.

While the full details of the agreement remain undisclosed, White House officials have described the plan as a "comprehensive roadmap to end hostilities and begin rebuilding Gaza."

The trip highlights Trump's renewed diplomatic push in the region and comes amid broader efforts to stabilize the Middle East. The White House has said the President's itinerary is subject to change depending on security conditions on the ground, but all preparations are in place for what could be a landmark moment in regional peace efforts.



"58 Pak Soldiers Killed": Taliban's Big Claim And **A Warning After Strikes**

Taliban spokesperson Zabeehullah Mujahid on Sunday said retaliatory strikes near the Durand Line in Beh-

rampur district killed at least fifty eight Pakistani soldiers and wounded over thirty. He warned Pakistan that the Taliban would leave "no attack unanswered" and accused Islamabad of allowing ISIS members to shelter on

Mujahid told reporters that Afghan forces struck multiple Pakistani posts along the frontier after three explosions in Afghanistan the previous week — two in Kabul and one in Paktika — incidents the Taliban blamed on Pakistani actors. He alleged that recruits were moved through Karachi and Islamabad to training centres in Pashtunkhwa, where attacks against Afghanistan were planned, and claimed "documented evidence" supported those assertions.

Defending the operations, the spokesperson said Afghan forces seized a significant cache of weapons but also suffered casualties, with more than twenty Islamic Emirate fighters killed or wounded. He framed the strikes as defensive actions to protect Afghanistan's airspace and land borders.

Pakistan, while not confirming responsibility for the earlier blasts, condemned the cross border attacks and accused the Afghan side of harbouring Pakistani Taliban elements. Prime Minister Shehbaz Sharif condemned the airstrikes, saying the Pakistani army a befitting reply," destroyed several Afghan posts and forced those forces to retreat, and insisted that every provocation would be met with a strong response.

Mujahid added that the air operations were halted following diplomatic interventions by Qatar and Saudi Arabia. The exchanges have increased tensions along multiple border provinces cited by the Taliban, including Helmand, Kandahar, Zabul, Paktika, Paktia, Khost, Nangarhar and Kunar.

Independent verification of casualty figures and many claims remains unavailable. NDTV, a trusted news outlet, reported on the developments and attributed statements to both sides. Tens of thousand of Palestinians began returning to northern Gaza on Friday as a U.S.-brokered ceasefire between Israel and Hamas took effect, raising hopes for an end to a devastating twoyear war. The truce comes alongside a deal to release the remaining 48 hostages, expected by Monday.

Though the fighting has largely ceased, uncertainty looms over who will govern Gaza as Israeli forces gradually pull back, still holding nearly 50% of the territory. Israeli Prime Minister Benjamin Netanyahu has warned that Hamas must disarm or face renewed military action.

The war, sparked by Hamas' October 2023 attack on Israel that killed 1,200 and led to 251 hostages, has claimed over 67,000 Palestinian lives and displaced nearly 90% of Gaza's population. Returning families are now greeted by rubble and ruins in once-thriving neighbourhoods like Zeitoun and Khan Younis.

In parallel, international aid is set to ramp up. The United Nations confirmed aid convoys carrying fuel, medicine, and food will begin entering Gaza on Sunday, with 170,000 metric tons pre-positioned in Jordan and Egypt. However, only 20% of required aid has reached Gaza in recent months due to Israeli restrictions. Meanwhile, prisoner-hostage exchang-

es are expected to begin soon. Israel will reportedly release 2,000 Palestinian prisoners, though high-profile detainees like

Marwan Barghouti are excluded. The ceasefire is part of former U.S. President Donald Trump's peace plan, which includes a continued Israeli military presence in Gaza and proposes an international security force led by Arab and Muslim nations. The plan envisions a long-term role for the Palestinian Authority, though it lacks clarity

on Palestinian statehood — something Netanyahu firmly opposes.





Climate Change Forces Fish to New Homes: DNA Tells the Story

Across the planet, species are on the move, with climate change forcing over 12,000 species to shift their homes across land, freshwater, and seas. In the ocean, tropical fish are moving into temperate reefs along Australia's east coast, one of the fastest-warming marine regions. New coral and fish species are arriving in Sydney's waters, and their numbers are expected to rise as the climate changes. Traditionally, researchers and citizen scientists monitor these shifts through visual surveys, but small, rare, nocturnal, or cave-dwelling species are often missed, meaning the true rate of movement is likely underestimated.

Our new research, published in Diversity and Distributions, uses environmental DNA, or eDNA, to detect these hidden migrations. Fish shed mucus, scales, and waste that contain DNA. By collecting seawater and filtering it, we can extract these genetic fingerprints and identify the species present, much like forensic scientists solving a crime from hair or fingerprints. While eDNA has been used since the 1980s for microbes, its application to larger animals and plants has transformed biodiversity monitoring.

We surveyed 2,000 kilometres of Australia's east coast, from tropical reefs to temperate kelp forests. Alongside traditional visual transects, we collected seawater for DNA analysis. Back in the lab, filtering and sequencing the water revealed species often missed by divers. Quantum Entanglement Breakthrough Brings Nuclear Spin Computers Closer



Quantum entanglement — famously called 'spooky action at a distance" by Albert Einstein — is the key feature that makes quantum computers powerful. It allows particles to be connected in ways that enable computations impossible for classical computers, such as simulating molecules, pharmaceuticals, or catalysts. In new research published in Science, scientists have demonstrated entanglement between two atomic nuclei separated by about 20 nanometres, a breakthrough that could accelerate the development of quantum computers using nuclear spins.

Quantum engineers face a fundamental challenge: balancing the need to shield qubits from noise while allowing them to interact for computations. Many quantum hardware platforms either excel in shielding but are hard to control, or perform fast operations but are prone to errors. The team, led by Professor Andrea Morello, works with phosphorus atoms implanted in silicon chips, using the spins of atomic nuclei to store quantum information reliably. Until now, entanglement between nuclei required them to share a single electron, limiting scalability.

The new approach uses electrons as "telephones" to enable communication between nuclei even when they are physically separated. Each electron interacts with a nucleus, and electrons interact with one another, creating entanglement between distant nuclei via a method called the "geometric gate." In the experiment, the phosphorus nuclei were 20 nanometres apart — a distance compatible with existing silicon transistor fabrication.

This breakthrough integrates long-lived nuclear spin qubits into standard silicon chips, opening the path for scal-

able, reliable quantum computing. The team envisions extending entanglement over even greater distances by manipulating electron shapes and positions, allowing more complex quantum circuits. This research bridges electron-based quantum devices and nuclear spin qubits, bringing practical, high-fidelity quantum computers closer to reality.

By combining precision, stability, and scalability, this work marks a significant step toward the next generation of quantum computing built on silicon, the backbone of todav's electronics.

Despite these challenges, Italy will look to secure their place in the play-offs as they continue their World Cup qualification campaign.






