### **JAGAN GAVE WRONG NUMBER - CBI**

Former Chief Minister of Andhra Pradesh and YSR Congress Party chief Y.S. Jagan Mohan Reddy is facing a fresh legal controversy after the Central Bureau of Investigation (CBI) approached the special CBI court alleging that he violated one of the key conditions associated with his foreign travel permission. Jagan, who is currently on a Europe trip after receiving conditional clearance from the CBI court earlier this month, was required to submit his mobile phone number, email ID, and complete travel itinerary as part of the approval process. The court had permitted him to visit his daughters abroad for about 15 days between October 1 and 30, subject to strict compliance with the specified conditions.

However, it has now emerged that the mobile number submitted by Jagan was not his own. According to the CBI, the number actually belongs to someone else. The agency contends that by providing a false contact number, Jagan has breached one of the central conditions of the court's permission. CBI officials have consequently filed a petition before the court seeking revocation of his travel



clearance, asserting that such conduct amounts to contempt of court and misrepresentation of information

The issue has sparked

outrage within legal and political circles, as the CBI described the act as an "irresponsible violation" of judicial restrictions. The agency urged the court to immediately cancel the conditional travel permission and direct Jagan's return to India. Sources indicate that the petition has already been listed for hearing, with Jagan's legal counsel expected to file a counter during the proceedings today. Jagan's legal team, meanwhile, is preparing to argue that there was no deliberate attempt to mislead the court, maintaining that the controversy stems from a misunderstanding. Jagan has long claimed that he does not personally use a mobile phone a statement he has made multiple times in public

Nonetheless, CBI officials have argued that such an excuse does not justify submitting another person's contact de tails in an official judicial document. The incident has emerged as another significant turning point in Jagan's ongoing legal battles. The former Chief Minister continues to face scrutiny over his bail conditions in the long-pending disproportionate assets case investigated by the CBI. Any violation, even technical in nature, can lead to severe repercussions including the potential cancellation of his bail. Observers note that this episode has once again drawn national attention to Jagan's legal issues, which have persisted since his tenure as Chief Minister.

The court, now examining the CBI's petition, will decide whether Jagan's actions constitute a serious breach of his conditional travel privileges. If the court finds merit in the CBI's claims, Jagan may be ordered to return to India immediately, marking yet another major blow to his political and personal agenda.

# **DASPALLA GROUP TO INVEST IN AMARAVATHI**

Amaravati, October 16: Daspalla Group to Build 4-Star Hotel in Amaravati with Gov-

ernment Incentives The Andhra Pradesh government has given a major boost to tourism and hospitality in the state capital region by approving the construction of a four-star hotel by Daspalla Amaravati Hotels Private Limited. The luxury project, estimated to cost around Rs. 200 crore, is set to become a landmark addition to Amaravati's growing urban landscape. According to official orders released on Wed nesday, the government has granted multiple incentives under the Tourism Policy 2024-2029 to facilitate the project's execution. The decision aim s to encourage private investment in the tourism and hospitality sector, which is considered a vital component of Amaravati's economic development and employment gen-

eration strategy. Special Chief Secretary of the Tourism Department, Ajay Jain, issued the government order permitting Daspalla Hotels to

proceed with construction and outlining the series of financial and policy incentives approved for the project. Comprehensive Incentives for GrowthAs part of the government's incentive package, the Daspalla Group will receive a 100% refund on state taxes and stamp duty for a period of ten years. Additionally, electricity will be billed at industrial tariff rates, easing the operational costs for the company. The government has also assured a refund of electricity duty for the initial fivevear period after the hotel begins operat

Officials stated that these concessions are consistent with the provisions of the AP Tourism Policy 2024-2029, which seeks to attract large-scale investment into the hospitality and travel sectors. The policy offers a range of financial incentives, simplified clearances, and infrastructure development support for investors establishing new hotels, resorts, and eco-tourism projects across the state.



Economic Impact: The Rs. 200-crore Daspalla Amaravati project is expected to generate direct and indirect employment for over 400 individuals, including administrative staff, technical personnel, and service workers. The hotel's operations will provide work opportunities for professionals in tourism, catering, maintenance, and event management, contributing to the local economy and skill development. Tourism Department officials highlighted that the project will not only strengthen Amaravati's hospitality infrastructure but

also enhance its appeal as a destination for business, conferences, and leisure travel. Given the capital's proximity to Vijayawada and its growing prominence as an administrative hub, the new hotel is anticipated to attract corporate visitors, government delegations, and national

Boosting Amaravati's Urban Profile: The Daspalla Group, know n for its notable hospitality ventures in Visa khapatnam, Hyderab ad, and Kakinada, is entering Amaravati with premium infrastructure and modern facilities aligned with international stand-

ards. The proposed 4-star hotel will include accommodation suites, multi-cuisine restaurants, convention halls, and wellness amenities designed to cater to both domestic and international guests. State officials said the initiative aligns with the government's broader strategy to make Amaravati a vibrant economic zone with robust support from sectors like hospitality, tourism, education, and commerce.

By attracting reputed hotel chains such as Daspalla, the administration hopes to build tourism-led economic momentum and strengthen investor confidence in the capital region. The project's approval marks another milestone in the AP government's proactive approach to promoting tourism as a key engine of growth. Construction is expected to begin soon, following environmental and infrastructure clearances, signaling a new era of hospitality development in Amaravati's emerging skyline.

During his stay in London, Naidu is expected to hold meetings with top executives, investors, and representatives from global corporations to showcase the state's industrial potential and investmentfriendly policies. The government has planned a major partnership conference in Visakhapatnam on November 14 and 15, which will serve as a networking platform for global investors, ers. and innovators to



Indian entrepreneurs, and state officials. Naidu will personally extend invitations to industrialists during his London visit, urging them to attend the summit and explore strategic collaborations across sectors such as infrastructure, renewable energy, automobiles, healthcare, education, a n d digital technology.

Sources indicated that the Chief Minister will also highlight Andhra Pradesh's proactive approach in creating world-class infrastructure, including industrial corridors, deepwater ports, and logistics hubs, alongside its focus on skill development and ease-of-doing-business reforms. The initiative marks a strong revival in cooperation between local farmers and the Andhra Pradesh Capital Region Development Authority (APCRDA), which has been actively reviving various infrastructure works in the capital region.

According to official sources, 22 farmers from Undavalli village have collectively offered 12 acres, while another 14 farmers from Penumaka have voluntarily contributed about 28.25 acres. This voluntary land contribution is expected to significantly aid in bridging the missing link required to complete the Seed Access Road, which has been un-

Officials also clarified that while a major portion of the required land has been made available through LPS (Land Pooling Scheme) and voluntary contributions, the APCRDA is exploring the possibility of acquiring any remaining land either through further pooling arrangements or land acquisition as per existing regulations. This step, they said, would ensure seamless completion of the Seed Access Road, which is essential for integrating the region's infrastructure network.In addition

APCRDA has intensified works on several critical infrastructure projects, such as the Kondaveeti Vagu flood management structures and other arterial roads that form the backbone of the Amaravati township plan.

These projects are aimed at accelerating the city's progress, improving urban connectivity, and establishing Amaravati as a model for sustainable regional development.With the latest land contributions and the government's reasserted focus on key capital works, the momentum for Amaravati's development appears to be regaining pace. The voluntary participation of farmers has injected new optimism into the project, giving fresh impetus to the long-standing dream of transforming Amaravati into a well-planned and vibrant administrative capital.

### **DELAY IN SCR - VIZAG ZONE**

Today in Visakhapatnam, the much-anticipated South Coast Railway Zone (SCR), with Visakhapatnam as its headquarters, is making vital progress, but official implementation still faces delay. This development has brought considerable happiness among the people of the state, yet challenges remain due to the Railway Board's delay in releasing the crucial official Gazette needed for the zone's full operational status. The South Coast Railway Zone was formed after extensive lobbying and political efforts following the coalition government taking power. The Prime Minister laid the foundation stone for the General Manager (GM) office earlier this year, and temporary office space has been secured in the VMRDA's 'The Deck' building in Visakhapatnam.

The interior work of this office, spanning two floors, is almost complete, enabling the appointed GM and associated officers to start functioning. Despite these facilities being ready and the GM appointed, the release of the Railway Board Gazette, which officially details the zone's operational boundaries and jurisdiction, has been delayed. This Gazette is legally mandatory to start the full functions of the new zone, including staff adjustments and allocation of resources. Currently, administrative activities of the Waltair division, which falls under the South Coast Zone, are still managed from the East Coast Railway Zone headquarters in Bhubaneswar. This has led to an awkward situation where the South Coast Zone's GM is unable to exercise full administrative control. The East Coast Zone's GM often conducts inspections in the Waltair

division, raising questions about the authority of two GMs over the same division. Because the official operationalization has not been gazetted, certain employees and resources needed to run the new zone efficiently remain attached to the older zones of Hyderabad and Bhubaneswar, further complicating governance. The delay in Gazette issuance is reportedly influenced by resistance from higher officials in the existing zones who may be reluctant to release key personnel and assets.

This interference obstructs the smooth transfer of employees and hinders the new zone's independent functioning. The public and rail users alike have voiced their concerns, urging Chief Minister Chandrababu Naidu, who is currently visiting, to raise this issue with the Prime Minister and expedite the Gazette re-



lease.The South Coast Railway Zone is strategically important, combining divisions including Vijayawada, Guntur, Guntakal, and Visakhapatnam, and serves areas rich in minerals and port infrastructure. The establishment of this zone is expected to improve administrative efficiency, local decision-making, freight management from key ports, and accelerate regional development.

Despite the bureaucratic hurdles, positive momentum continues with the appointment of the GM and progress on the zonal headquarters office construction. Once the Gazette is published, administrative control will shift fully to the

South Coast Zone, enabling smooth operations and resource management. The people hope this delay will soon be resolved so the South Coast Railway Zone delivers its promised benefits to Andhra Pradesh and neighboring areas.

In summary, while the South Coast Railway Zone's creation is a significant advancement for Indian Railways and regional development, bureaucratic delays in formalizing its operational status remain a challenge. Public demand and political advocacy continue to push for swift action to release the Railway Board Gazette, allowing the new zone to operate independently and efficiently

### **TOURISM DEVELOPMENT REVIEW - GUNTUR COLLECTOR**

Kondaveedu Fort District Collector Dr. Kritika Shukla visited the historic Kondaveedu Fort in Yadlapadu mandal on Thursday and reviewed ongoing and proposed development works aimed at promoting the fort as a premier tourist destination. Kondaveedu Fort, often referred to as the 'Golkonda of Andhra,' is a symbol of the region's medieval heritage and architectural brilliance. However, the privileges extended to YSRCP leaders appear to have become the center of controversy. According to reports, although YSRCP leaders did not submit any formal petition to Prime

resentatives handed him a petition seeking inclusion of Valmiki community members in the Scheduled Tribes list and immediate establishment of new medical colleges across the state.

These reports sparked criticism after central sources labeled them as "false propaganda," suggesting intentional distortion of facts for political mileage. The CIA's reported inquiry aims to assess whether any deliberate dissemination of fake news was carried out to mislead the public and influence perceptions during the highprofile visit. Senior offi-

cials have indicated that such actions, if proved. could amount to misuse of the Prime Minister's protocol arrangements for partisan publicity. The incident has raised serious questions about the ethical conduct of political communication in the state.Political analysts observe that this development also highlights a sharp contrast in how official protocols were handled under different administrations.

During the previous YSRCP-led government, opposition parties were often excluded from formal invitations and receptions during Prime Minister Modi's state visits. In contrast, the present coalition government has followed inclusive procedures, ensuring that all public representatives regardless of party affiliation receive recognition and due respect at nationallevel events. Coalition leaders have reportedly expressed their fury at what they describe as a "breach of trust and decorum" by YSRCP figures who allegedly exploited the government's

goodwill gesture.

They argue that politicizing a national-level event not only disrespects the protocol but

also undermines the spirit of cooperative governance the coalition has tried to foster in the state. Observers suggest that this fresh controversy could deepen existing political frictions in Andhra Pradesh, especially as preparations for upcoming development reviews and central-aided projects are underway. The alleged misuse of Prime Minister Modi's visit could prompt tighter scrutiny of media narratives and stricter communication protocols by both the central and state governments in future high-lev-

QR Code Move a Cover-Up for Fake Liquor Scam: YSRCP's Pothina MaheshTPN / VijayawadaYSR Congress Party's Guntur Parliament constituency observer Pothina Mahesh has lashed out at the coalition government led by Chief Minister N. Chandrababu Naidu, accusing it of misleading the public with its new initiative to print QR codes on liquor bottles. # LIQUOR SYNDICATE - AUDIO LEAK

TPN, Rajamahendravaram Oct 16: Liquor Syndicate Audio Leak Creates Stir in Rajamahendravaram: Former MP Margani Bharat Ram Demands Action

A political storm erupted in Rajamahendravaram on Thursday night following the alleged leak of an audio clip linked to a liquor syndicate, sparking outrage across the city. YSR Congress Party State Spokesperson and former MP Margani Bharat Ram accused certain Telugu Desam Party (TDP) leaders of orchestrating an organized liquor racket that endangers public health and exploits regulatory loopholes for massive profits. Speaking at a press conference, Bharat Ram alleged that a group of TDP leaders in Rajahmundry has been operating a powerful liquor syndicate by selling spurious liquor across urban and rural areas under a coordinated network. He directly accused TDP city president Majji Rambabu of leading the operation, alleging that he has been "spinning the wheel" in liquor management and collecting huge illegal profits through unfair

Bharat Ram revealed that evidence existed showing the owners of 39 liquor outlets in Rajahmundry had conspired to raise liquor prices in unison, in blatant violation of government regulations. Instead of adhering to standard rates, these shop owners allegedly decided to continue selling liquor at inflated prices and offered bribes to excise officials to ensure no action was taken. According to the former MP, the syndicate leaders had resolved that if any cases were filed by excise officials, only one case per shop should be registered to minimize legal

He said the group also forced shop owners to sign 100 bond papers and hand over cheques worth 1 lakh each, effectively binding them to the syndicate's decisions. "This entire structure is not just unethical it's criminal," he declared. Bharat Ram further claimed that Majji Rambabu's alleged advisory role in uniting the

ed es es en er liquor sellers made him equally responsible for the exploitation. He condemned Rambabu's suggestion that all 39 shop

owners "move forward with unity" in price manipulation and illicit sales, calling it a direct attack on fair business practices and consumer safety.

The YSRCP leader demanded that stringent legal action be taken against all those involved. He urged excise authorities to register cases against Majji Rambabu and other members of the liquor network under multiple

legal provisions, including Section 37(a) and Sections 39(1)(2) of the Andhra Pradesh Excise Act, as well as Sections 274 and 276 of the Bharatiya Nyaya Sanhita (BNS), which deal with adulteration of liquor and endangering human life through harmful substances. conspiracy is not merely about illegal trade, it is about risking the lives of thousands of citizens. The government must treat this with zero tolerance," Bharat Ram insisted.

He called on excise officials to act with "an

iron hand" to dismantle the syndicate, seize all fake liquor stock, and ensure that the accused face imprisonment without delay. As the allegations continue to circulate, the incident has rattled Rajamahendravaram's political circles, with residents and local traders demanding transparency and accountability. The court announced that the order would be pronounced on Friday, following the completion of arguments from both sides on Thursday.Mithun Reddy, an accused in the alleged multi-crore liquor scam, was recently released on bail from the Rajahmundry Central Jail. He filed the petition requesting permission to visit New York on October 20 as part of a parliamentary delegation scheduled to attend the 80th session of the United Nations General Assembly. The delegation, led by BJP MP Daggubati Puran deswari, is expected to leave for the U.S. on October 26.During his arrest, the Special Investigation Team (SIT) seized Mithun Reddy's passport. To facilitate his foreign travel, the MP filed a separate plea

# **ACB CAUGHT AMALAPURAM TAHSILDAR**

According to the ACB, the case was initiated based on a complaint lodged by Gandham Durgakondalarao of Rajavol, near Rajamahendravaram rural. His father, Venkata

chased a 15-cent land plot in Amalapuram way

Due to old age and ill health, the family could not process the necessary survey and documentation for sale of the property. When the land was recently taken up for boundary marking, Tahsildar Ashok Prasad allegedly demanded a bribe of 1 lakh from them to complete the work officially. Unable to tolerate the demand, Durgakondalarao approached the Anti-Corruption Bureau and lodged a complaint. Acting swiftly, the ACB team

first installment through data entry operator Ramu, the ACB officials caught Ashok Prasad in the act.

The team immediately conducted raids in the Tahsildar's office and recovered 5,88,500 in cash hidden inside a table drawer. In total, the officials seized 6,38,500 from the accused, including the bribe money.ACB DSP M. Kishore Kumar confirmed that both Tahsildar Ashok Prasad and data entry operator Ramu were taken into custody under the Prevention of Corruption Act. The officials stated that they would be produced before the ACB Court for judicial remand. ACB Circle InP. Bhaskara Rao, along with other staff members, took part in the operation that led to the arrests and seizure of the unaccounted cash.

The raid has sent shockwaves across the local administration and the revenue circles of Konaseema district. where several complaints concerning landrelated services have been pending for months. ACB officials are now investigating whether the arrested officials were involved in similar cases in the past. Further inquiry is underway to trace the sources of the seized money and identify any other individuals connected to the bribery network.

# Nitish and Tejashwi: 11 Key Forces That Will Decide Bihar's 2025 Election



As Bihar heads into a high-stakes assembly election, the battle is far from straightforward. While the spotlight often falls on Chief Minister Nitish Kumar and opposition leader Tejashwi Yadav, this election is being shaped by a far more complex web of political forces. Shifting alliances, social welfare dynamics, caste arithmetic, and the emergence of a third front have all made this one of the most unpredictable elections in Bihar's recent history.

Here are the 11 major factors that will ultimately decide who forms the next government in the state.

#### 1. Alliance Chemistry and Internal Friction

The NDA and the Mahagathbandhan (MGB) are both grappling with internal tensions. The NDA, led by BJP and JD(U), has brought in smaller players like the Lok Janshakti Party (LJP) and Rashtriya Lok Morcha (RLM), but these additions haven't come without complications. In 2020, a lack of effective vote transfer between BJP and JD(U) damaged their prospects. This time, the Jan Suraaj Party (JSP) may disrupt intra-alliance vote transfers further.

The MGB faces its own coordination hurdles with new allies like the Vikassheel Insaan Party (VIP) and the Jharkhand Mukti Morcha (JMM), alongside a faction of the LJP. Seat-sharing remains unresolved, and friction is growing with the Congress asserting itself post its Voter Adhikar Yatra success.

Maintaining internal unity and ensuring seamless vote transfers across alliance partners will be key for both sides.

#### ${\bf 2.\,Leadership\,Preferences:\,Fragmented\,Loyalties}$

Tejashwi Yadav leads in Chief Ministerial preference polls, but only marginally. His appeal is mostly limited to the MY (Muslim-Yadav) vote and some segments of youth. Nitish Kumar, though still respected, is facing voter fatigue after nearly two decades in power. Prashant Kishor, once a strategist, now poses a fresh political challenge. Leaders like Chirag Paswan and Samrat Choudhary appeal to specific caste groups.

However, only 15% of voters base their decision on CM faces. A larger share is driven by development, caste, religion, and local issues. This diffused focus makes cohesive leadership appeal even more critical.

#### 3. Pro- and Anti-Incumbency: A Split Verdict

VoteVibe surveys indicate that 48% of voters are antiincumbent, while 32% are pro-incumbent and 14% remain neutral. This near-even split creates a volatile environment where coalition cohesion and voter mobilisation matter more than overarching popularity.

Although discontent exists with Nitish Kumar's government, the opposition is fragmented. If MGB consolidates anti-incumbent sentiment effectively, it has a strong shot. But NDA's last-minute welfare schemes have boosted pro-incumbency sentiment from 18% in July to 34% in September, complicating the narrative.

#### 4. The Welfare Push: Last-Minute Lifeline or Election Gimmick?

The NDA has launched a sop spree, targeting women, youth, farmers, senior citizens, and labourers. Key schemes include:

₹10,000 business grant for women

Unemployment allowance for youth

125 units of free electricity

₹5,000 for daily labourers

Increased pensions for elderly and widows

Despite these efforts, Bihar's per capita income remains one-third of India's average, the same as in 2005. Opposition parties argue that short-term welfare measures can't mask long-term underdevelopment. Whether voters buy into the immediate relief or punish the lack of structural change remains to be seen.

#### 5. Modi vs Rahul: National Leaders in a State Battle

Unlike previous elections, national leaders are playing a significant role. The election is increasingly becoming Modi vs Rahul, rather than Nitish vs Tejashwi.

PM Modi holds a 52% approval rating in Bihar compared to Rahul Gandhi's 41%, per C-Voter. However, Gandhi is gaining ground through his Bharat Jodo Yatra and outreach among Dalits, minorities, and youth. His appeal complements Tejashwi's, creating a potentially powerful combination for the MGB.

Meanwhile, NDA banks heavily on Modi's charisma and welfare narrative, hoping it offsets any local dissatisfaction with Nitish.

#### 6. Women Voters: Bihar's Silent Game Changers



Women account for nearly 50% of Bihar's voters, and in 2020, their turnout exceeded men's in 167 seats. The NDA won 99 of those.




Nitish Kumar has historically focused on female welfare — from bicycle schemes to police quotas and selfhelp groups. The new ₹10,000 Mahila Rozgar Yojana aims to expand this base.

The MGB, meanwhile, is attempting to woo women with a monthly ₹2,500 direct benefit promise. The question is: Will women choose trusted continuity or tempting alternatives?

#### 7. Youth: Angry, Unemployed, and Politically Crucial

With 35% of voters under 35, young voters are a decisive force. They're less swayed by past governance vs. "jungle raj" narratives. Their focus is on jobs, education, and migration.



Tejashwi's promise of "a government job in every home" may sound utopian, but it resonates emotionally. Prashant Kishor appeals to educated and urban youth, especially via digital platforms.

The youth are angry, and their vote is split. Who wins this group could tip dozens of tight races.

#### 8. Caste Dynamics: Still the Heart of Bihar Politics

Caste remains the strongest voting determinant in Bihar. The traditional NDA support base (Upper Castes, Non-Yadav OBCs, EBCs, Mahadalits, and Paswans) adds up to 68%. But their actual 2020 vote share was only 37%, showing leakages and cross-voting.

EBCs (26%) and SCs (20%) are the real swing voters. MGB is trying to counter with Mukesh Sahni (EBC) and Rajesh Ram (SC) as potential Deputy CMs.

The NDA's edge lies in its multi-caste leadership—

from Nitish (Kurmi) to Choudhary (Kushwaha) and Paswan (Dalit). How much caste leaders can pull their community votes remains to be tested.



#### 9. The Dalit Vote: Diverse, Divided, and Decisive

Dalits, especially Paswans and Ravidas, make up 20% of the electorate. The NDA traditionally dominated these votes through Chirag Paswan and Jitan Ram Manjhi. But the Ravidas vote is showing signs of shifting to MGB and Congress, who are highlighting representation gaps and promising social justice.

Prashant Kishor is also trying to attract young, educated Dalits through development-focused messaging rather than caste identity. These shifts could influence up to 40 reserved seats, where 2020 saw NDA win 22 and MGR 18

#### 10. Muslim Voters: Reliable Yet Restless

Muslims, at 18% of the population, have long been a pillar of MGB support. But this bloc is no longer monolithic. AIMIM's emergence and JSP's appeal among young Muslims threaten to fragment it.

While traditional loyalty to RJD and Congress remains, underrepresentation (only 8% MLAs) has sparked community discontent. AIMIM offers assertive Muslim representation but risks acting as a vote-splitter in tight seats—especially in Seemanchal.

If Muslims consolidate behind MGB, it could sweep Muslim-heavy constituencies. If not, the NDA could benefit again, as it did in 2020.

#### ${\bf 11.} \, The \, PK \, Wildcard; \, Spoiler \, or \, Kingmaker?$

Prashant Kishor's Jan Suraaj Party is the biggest wild-card in this election. He has created buzz, especially among urban, youth, and upper-caste voters. His  $10\,\%$  vote share in recent bypolls reduced the MGB's tally from 3 to 0 and handed the NDA key wins.

In over 83 seats with thin victory margins, even a small JSP vote could tilt the balance. Kishor's strategy may be to force a hung assembly, where he can play kingmaker.

The biggest test for JSP is turning social media support into actual votes.

#### Conclusion: A Battle of Margins, Not Waves

With no clear wave in sight, Bihar 2025 will be an election of wafer-thin margins. A mere 2-3% shift in women's votes, youth mobilisation, caste realignment, or minor party interference could decide the outcome.

More than Nitish or Tejashwi, it is the interplay of these 11 powerful factors—from alliance mechanics to demographic shifts—that will shape Bihar's political destiny in this high-stakes election.

# India Needs a Trade Exposure Inflation Index to Tackle Global Price Shocks

India's inflation story is no longer confined to domestic monsoons or policy rate hikes. It now has a global dimension—from Indonesia's palm oil exports to freight costs on Red Sea routes. And yet, India lacks a dedicated tool to measure how much of its inflation is imported.

Despite recent moderation in headline inflation—retail inflation dropped to 3.16% in April 2025 and 1.55% in July—external factors like global commodity prices, rupee depreciation, and shipping disruptions continue to impact household costs. For example, over 85% of India's crude oil is imported, and a 1.2% rupee fall in FY24 raised input costs across sectors.

To address this, experts propose a Trade Exposure Inflation Index (TEII)—a new tool to quantify imported inflation. It would break down consumer prices into three trade-exposed components: imported goods (like electronics), imported inputs (like fertilisers), and exchange rate effects. Initial estimates suggest 40% of India's recent inflation may have come from external sources.

The TEII would not replace the Consumer Price Index (CPI) but act as a complementary lens, much like "core inflation." It could guide smarter policymaking—combining monetary tools with trade, tariff, or stockpile strategies. For instance, during 2022–24, when RBI raised rates by 250 basis points, a TEII might have revealed that much of the inflation was beyond

the central bank's control.

India already has the data infrastructure



needed for TEII—CPI weights (MoSPI), import exposure (DGCI&S), and exchange rate studies (RBI). A joint working group could

launch it within a year.

In a globalised economy, ignoring imported inflation risks misdiagnosing the problem—and us-

ing the wrong tools to fight it. With TEII, India could lead the way in building inflation transparency and smarter economic coordination.

# All Gujarat Ministers Resign As CM **Bhupendra Patel Set To Rejig Cabinet**

In a major political development, all ministers in the Gujarat government, except Chief Minister Bhupendra Patel, have submitted their resignations ahead of a major cabinet reshuffle. The resignations have been accepted by the Chief Minister, who is expected to meet Governor Acharya Devvrat later today to formally stake a claim to form a new

The move is being seen as part of a broader administrative and political overhaul in the state, likely in preparation for upcoming political events and elections.

According to senior BJP leaders, the new cabinet is expected to be announced and sworn in on Friday at 11:30 AM. Sources indicate that nearly 10 new ministers may be inducted, while about half of the existing ministers could be replaced. The reshuffle aims to bring in fresh faces and revamp the state

Currently, the Gujarat cabinet comprises 17 ministers, including the Chief Minister, with eight holding cabinet rank and eight others serving as Ministers of State (MoS). As per constitutional provisions, Gujarat is permitted to have up to 27 ministers, which is 15% of the total 182-member Assembly.

Notably, this reshuffle follows the recent appointment of Jagdish Vishwakarma as the new president of the Gujarat BJP unit, replacing Union Minister C.R. Paatil.

Bhupendra Patel first assumed office as Chief Minister in 2021 and began his second



term on December 12, 2022. The upcoming cab inet expansion is expected to reflect strategic adjustments by the BJP as it strengthens its position in the state.

The reshuffle is being closely watched both within Gujarat and at the national level, as it may signal the party's broader game plan ahead of the 2026 Assembly elections.

In a significant relief to Congress leader and Lok Sabha Leader of Opposition Rahul Gandhi, the Gauhati High Court has set aside a lower court's order allowing additional witnesses in a long-pending defamation case against him.

The case, filed by an RSS worker in 2016, alleged defamatory remarks made by Gandhi during a speech. The matter was being heard in a trial court in Kamrup Metropolitan

On Monday, October 13, Justice Arun Dev Choudhury of the Gauhati High Court issued the order in a criminal revision petition, quashing the decision by the additional sessions judge that had permitted more prosecution witnesses to be summoned. The High Court ruled that the lower court's move to expand the scope of the trial by adding further witnesses was not justified at this stage of the

The trial court's order had been challenged by Gandhi's legal team, who argued that the inclusion of new witnesses after such a long duration would delay justice and was procedurally flawed.

With this decision, the High Court has effectively streamlined the trial, which had been ongoing for nine years, offering Gandhi a legal breather amid several other litigations he faces across the country.


The defamation case stemmed from Gandhi's remarks allegedly linking the RSS to the assassination of Mahatma Gandhi — a claim that has repeatedly landed him in legal

The first list, released earlier, featured 57 candidates. With Thursday's announcement, the party has now declared all its 101 candidates for the 243-member Bihar Assembly.

Elections will be held in two phases – on November 6 and November 11 and results will be declared on Novem-

The announcement comes at a crucial time as the NDA looks to maintain its grip on power in Bihar amidst a growing challenge from the opposition INDIA bloc, led by the RJD and

The JD(U)'s candidate list reflects a mix of senior leaders, loyalists, and strategic new entrants, aimed at balancing caste dynamics and regional representation across the state.

All eyes are now on how the final phase of campaigning unfolds, with Bihar once again set to play a key role fielded from the Rupauli in the national political narrative.

### **Execution of Indian** Nurse in Yemen Stayed, **SC Told**



The Supreme Court was informed on Thursday that the execution of Indian nurse Nimisha Priya, who is on death row in Yemen for murder, has been stayed, and there are no adverse developments in her case at present.

A bench comprising Justices Vikram Nath and Sandeep Mehta heard the update during the proceedings on a petition filed by the 'Save Nimisha Priya International Action Council'. The organisation has been providing legal assistance to Priya, a 38-year-old nurse convicted in 2017 for the murder of her Yemeni business partner

Attorney General R Venkataramani, appearing for the Centre, told the court that a new mediator has intervened in the matter. "The only good thing is, nothing adverse is happen-Venkataramani said, confirming that efforts are ongoing to resolve

the issue diplomatically. The bench inquired about the sta-

tus of the execution, to which the petitioner's counsel confirmed it is currently stayed. The lawyer also requested that the matter be adjourned in view of the recent developments.

"List in January 2026. It will be open for the parties to apply for early listing in case the situation so demands," the bench directed.

Earlier in August, the court was told there was "no immediate threat" to Priya, whose execution had initially been scheduled for July 16, 2025, but

# 'Priority To Safeguard National Interest': India On Trump's Russia Oil Claim

New Delhi has firmly rebutted U.S. President Donald Trump's claim that Prime Minister Narendra Modi assured him India would stop purchasing oil from Russia. In a statement issued on Wednesday, the Ministry of External Affairs (MEA) emphasized that India's energy policy is guided solely by its national interest and the welfare of Indian consumers.

"India is a significant importer of oil and gas. It has been our consist-

ent priority to safeguard the interests of the Indian consumer in a volatile energy scenario," said MEA spokesperson Randhir Jaiswal. He added that ensuring stable prices and secure energy supplies remains central

to India's approach. Trump had recently claimed, "He [Modi] has assured me there will be no oil purchases from Russia. He can't do it immediately, but the process is going to be over soon." His remarks have triggered a political row in India, with the opposition accusing the Prime

Minister of compromising national interest.

Congress leader Rahul Gandhi criticized Modi, saying the PM is "frightened of Trump" and accused him of allowing a foreign leader to dictate India's energy choices. Gandhi also listed a series of alleged diplomatic missteps, including cancelling the finance minister's U.S. visit and not challenging Trump's public assertions.

In response, Union Minister Piyush Goyal hit back at the Congress, calling it a "rudderless, leaderless, and direction-

less" party. "They must make up their mind one day they ask why there's no trade deal, and the next day they attack us for diplomacy," Goyal

Dozens of troops and civilians were reportedly killed in the clashes, prompting urgent diplomatic engagement. Both countries claimed the other had requested India may have in- the ceasefire to halt

the escalation.

Pakistan's Ministry of Foreign Affairs stated that during the ceasefire, "both sides will sincerely strive to find a positive solution through constructive dialogue." The Taliban's government in Kabul echoed the sentiment, stating it had instructed Afghan forces to respect the truce "unless it is violated" Pakistan.

# Taiwan Detects 23 chinese Aircraft, 8 naval vessels near its territory

Taiwan's Ministry of National Defense (MND) reported on Thursday (October 16) that it detected 23 Chinese military aircraft, 8 Chinese naval vessels, and 2 official ships operating near its airspace and territorial waters as of 6 a.m. local time.

According to the MND, 21 out of the 23 aircraft crossed the median line of the Taiwan Strait, entering Taiwan's northern, southwestern, and eastern Air Defense Identification Zone (ADIZ) — a significant escalation in Chinese

military activity in the

"We have monitored the situation and responded accordingly," Taiwan's Defense Ministry said in a statement posted on X (formerly Twitter). The incursions were part of a continuing pattern of aggressive maneuvers by China around Taiwan's borders. The latest development comes just a day after a similar display of military pressure, when Taiwan recorded 16 Chinese aircraft and 13 naval vessels, with 14 aircraft violating the median line and entering Taiwan's ADIZ.



Beijing does not recognize the median line, an unofficial boundary in the Taiwan Strait long respected by both sides to avoid conflict. Chinese military activities near Taiwan have sharply increased over the past year, raising regional

tensions Adding to the geopolitical strain, recent reports highlight China's growing nuclear capabilities, with analysts

warning of possible "nuclear blackmail" scenarios in case of conflict over Taiwan. During a recent military parade in Beijing, China showcased nuclear-capable missiles — including the JL-1, JL-3, and DF-61 demonstrating its progress toward a nuclear triad, the ability to launch nuclear weapons from air, land, and sea.

The United States and other democracies have expressed concern over Beijing's escalating military assertiveness and rapid weapons development, particularly in relation to Taiwan's security.

# With Gaza Ceasefire Holding, Trump Shifts Focus to Ending Russia-Ukraine War

With a fragile ceasefire currently holding between Israel and Hamas, U.S. President Donald Trump is now turning his attention to another major global conflict — Russia's war in Ukraine. Trump, who made ending foreign wars a key part of his 2024 re-election campaign, is reportedly exploring new strategies to bring Moscow to the negotiating table.

"Now that Gaza is calming down, it's time to get Russia done,' Trump was quoted as saying in private conversations with senior aides, according to U.S. officials. The President is considering the option

TPN Correspondent of supplying Ukraine with long-range weapons — a move he hopes will pressure Moscow into serious negotiations while strengthening Kyiv's leverage.

The latest diplomatic push comes amid growing pressure on Trump to deliver on his campaign promises of restoring global stability. Throughout the 2024 race, Trump repeatedly criticized former President Joe Biden's handling of both the Ukraine and Gaza conflicts, vowing that he would end both swiftly if elected.

With the Israel-Hamas ceasefire and hostage exchange currently in place, Trump's administration sees a narrow

window to make progress in Eastern Europe. Officials say Trump's team is engaging both NATO allies and neutral parties in a bid to facilitate a framework for

negotiations. Meanwhile, concerns remain high over whether the Gaza truce will hold, as previous ceasefires have often collapsed within days. However, with a degree of stability returning to the region, Trump appears determined to pivot toward resolving the Ukraine conflict — a war that has dragged on since Russia's invasion in Febru-

ary 2022. While critics remain skeptical of Trump's approach, supporters ar-



gue that his unconventional diplomacy could yield breakthroughs where traditional efforts have stalled. Whether Trump's focus shift will

bring real results in Ukraine remains to be seen, but the renewed push signals a highstakes phase in global diplomacy.

# Sensex Surges 575 Points, Nifty Closes Above 25,300 on Global Market Rally

The rally in Asian markets provided a strong impetus for Indian equities, with investors hopeful that central banks will adopt accommodative monetary policies amid concerns about slowing economic growth. European markets also contributed to the positive momentum, further bolstering global risk

Market analysts noted that the combination of do-

### **Rupee Recovers 75** Paise to Close at 88.06 **Against US Dollar**



The Indian rupee bounced back sharply on Wednesday, October 15, 2025, recovering 75 paise from its all-time low to close at 88.06 (provisional) against the U.S. dollar. This marked the currency's biggest intraday gain in nearly four months, driven by a combination of likely intervention by the Reserve Bank of India (RBI) and a strong rally in domestic equity markets.

Forex traders attributed the rupee's recovery to positive sentiment sparked by optimism over ongoing trade talks between India and the United States. The improvement in bilateral trade relations boosted investor confidence, which was reflected in the surge of domestic markets. The benchmark indices rose by nearly 0.70%, supporting the rupee's rebound against the greenback.

Market participants also pointed to the RBI's probable intervention in the foreign exchange market to curb excessive volatility and stabilize the currency, helping the rupee recover

from previous sharp losses. The central bank's efforts are aimed at maintaining orderly market conditions amid global uncertainties.

Despite the recovery, foreign institutional investors (FIIs) continued to show caution, selling equities worth 1.508.53 crore on October 14, according to exchange data. This indicates ongoing concerns among foreign investors, even as domestic market sentiment improved.

The rupee had recently hit record lows against the dollar due to a stronger greenback and global economic pressures. However, Wednesday's sharp bounce suggests that the worst may be over, at least for now, as trade optimism and RBI support provide relief.

Analysts will closely monitor upcoming developments in trade negotiations and global market trends to assess the rupee's direction in the near term. For now, the currency's 75 paise intraday gain offers some respite for importers and market participants concerned about currency volatility.

# Price of gold skyrocketing; why is this, will it continue?

The price of gold surged above USD 4,100 an ounce on Wednesday, marking an extraordinary rally of over 50% this year and nearly 100% since the run began in early 2024. The rapid rise has far outpaced analysts' expectations, driven by several key factors reshaping the global gold

While economic uncertainties such as ballooning government debt and the US government shutdown add to gold's appeal as a safe haven, the main driver of this meteoric price surge is growing demand for gold exchange-traded funds (ETFs). These financial products have made gold more accessible to everyday investors by allowing it to be traded easily on stock exchanges, shifting gold's role from just a physical safe haven to a mainstream financial asset.

In addition to retail demand, emerging market economies like China and Russia are increasingly moving their official reserves from major currencies such as the US dollar into gold. According to the International Monetary Fund, central bank gold holdings in emerging markets have soared 161% since 2006. This shift is largely due to concerns over geopolitical tensions, financial sanctions, and efforts to reduce reliance on Western currencies.

Russia, a major gold buyer since 2006, accelerated purchases after its 2014 Crimea annexation, while China has been actively "de-dollarising" by reducing US government bond holdings in favor of gold. These moves signal a broader trend toward gold as a shield against financial sanctions and currency risks.

With sustained demand from both investors and central banks, analysts at Goldman Sachs have revised gold's price target to USD 4,900 an ounce by the end



of 2026. The World Gold Council also reported record ETF inflows, highlighting strong market appetite.

# Bengaluru Zepto Agent Earns ₹21K in a Week, Internet Applauds His Hustle





The fourtime Grand Slam champion was visibly emotional, wiping away tears after hitting the winning backhand shot and later describing the match as a mentally

"Emotionally I was going through a lot in this match,'

Osaka said. "And then in the third set I tried my best to have

Osaka admitted she had taken painkillers to manage the pain but acknowledged the injury "doesn't feel good." She explained her limited mobility, saying, "I couldn't really move that well." However, she remains optimistic about her recovery, adding, "It's not good, but I think I'm a fast healer so it should be OK for my next

The 27-year-old Osaka is returning to competitive tennis after a strong showing at the US Open, where she reached the semi-finals before losing to Amanda Anisimova. This marks her first major tournament progress beyond the second week since she won her second Australian Open title in 2021.

Osaka will next face Romania's Jaqueline Cristian in the quarter-finals, hoping to continue her comeback despite the injury setback. Fans and analysts alike are keenly watching the Japanese star's performance, inspired by her grit and determination to play through adversity in front of her home crowd.

This loss puts India's hopes in the tournament under pressure as they prepare for their remaining matches in the pool stage. The Blue Colts will need to regroup and focus on




