DEEP DEPRESSION IN SOUTHWEST BAY MAY BRING HEAVY RAINS TO ANDHRA PRADESH.

TPN BUREAU VI-JAYAWADA, OCT 22: A deep depression that has developed over the southwest Bay of Bengal, centered along the Tamil Nadu coast, is likely to intensify further and move in a northwesterly direction over the next 24 hours, according to Andhra Pradesh State Disaster Management Authority (APSDMA) Managing Director Prakhar Jain. He stated that the weather system is expected to advance toward the northern Tamil Nadu, Puducherry, and south coastal Andhra Pradesh coastlines by Thursday, potentially bringing widespread rainfall to several parts of the state.

In his weather briefing on Wednesday, Jain said that due to the influence of this system, heavy rainfall is likely to occur in isolated places across Prakasam, Nellore, Chittoor, and Tirupati districts, while the remaining districts may experience light to moderate rainfall. He further warned that thunderstorms accompanied by lightning are expected to continue across the state for the next five days. Coastal areas are likely to experience strong surface winds with speeds ranging between 35 and The APSDMA advised residents in coastal regions to remain alert and take precautions against possible flooding and damage due to gusty winds. Fishermen have been strictly warned not to venture into the sea until Saturday, as conditions are expected to remain rough along the coast. To ensure swift response to any emergency, Jain announced that one team of the National Disaster Response Force (NDRF) and four teams of the State Disaster Response Force (SDRF) have already been deployed in the affected districts. These teams will assist local authorities in rescue and relief operations if the situation worsens.The APSDMA also shared rainfall data

Elderly Man Held for Raping Minor in Orchard; Video Goes Viral in Tuni.



TPN BUREAU, Tuni Oct 22: (Kakinada District): A shocking incident has come to light in Tuni town where a 62-year-old man was arrested for sexually assaulting a 13-year-old girl inside an orchard. The accused, identified as T. Narayana Rao, allegedly posed as the girl's grandfather to pick her up from her government school hostel on Tuesday morning before committing the crime, according to police officials.Kakinada District Superintendent of Police (SP) Bindu Madhav Garikapati said the incident occurred around 11 a.m. on Tuesday when Rao lured the girl into accompany-

"The girl went with him on her own, but the consent of a minor is not considered valid. It technically falls under kidnapping and constitutes a serious sexual assault under the POCSO Act since the consent of her parents was not obtained," the SP explained. The case came to light after a video, purportedly recorded by the orchard owner where the assault took place, went viral on social media. The footage, which allegedly showed the minor visibly, triggered public outrage and forced the police to take immediate action. Surprisingly, the

orchard owner did not lodge a complaint with authorities but instead circulated the video

recorded until 6 p.m. on

Police have registered a case under relevant sections of the Protection of Children from Sexual Offences (POC-SO) Act and the Bharatiya Nyaya Sanhita (BNS) based on the girl's statement. SP Bindu Madhav stated that both the accused and the victim hail from the same locality in Tuni and belong to the same community. He further revealed that Rao had reportedly taken the girl out once before, raising concerns about earlier missed warning

Authorities are also deliberating on whether to file a case against the orchard owner for violating the child's privacy and spreading sensitive content instead of reporting the crime. Another video showing the accused being beaten by the victim's family has also gone viral. Police have assured that a thorough investigation is underway and affirmed that strict action will be taken against all those responsible for the distressing incident.

Focus on Consumer Awareness. Launching the campaign at a retail liquor outlet in Veterinary Colony, Vijayawada, the Director unveiled and affixed awareness posters designed to educate consumers on identifying genuine liquor bottles. The posters provide detailed instructions on using the AP Excise Suraksha mobile application, an innovative tool developed to combat the circulation of spurious liquor in the state. Through this app, customers can scan the QR code printed on the bottle cap to instantly verify its authenticity.



The app immediately displays a message confirming whether the bottle is an "Authentic Product", along with key details such as the batch number, manufacturing date, and maximum retail price (MRP). Sridhar clarified that,

at present, the verification feature is available for Indian Made Foreign Liquor (IMFL) only, and not for beer products. He emphasized that the campaign's core objective is to empower consumers with the knowledge to make safer and more informed purchases. Inspection at Nidamanur Depot Following the programme in Vijavawada, Director Sridhar, accompanied by the Deputy Commissioner of Prohibition and Excise, Vijayawada, conducted an inspection at the AP State Beverages Corporation Limited (APSB-CL) Depot in Nidamanur. During the visit, the Depot Manager explained the stock indenting and

AISF Hits NRI IT Over Illegal Fees

IMMEDIATE REVOCATION OF NRI INSTITUTE OF TECHNOLOGY'S AUTONOMY OVER ILLEGAL FEE COLLECTION

TPN, Vijayawada, October 22 : The Akhila Bharatiya Vidyarthi Parishad (AISF) has strongly condemned the management of the NRI Institute of Technology (NRI IT), Agiripalli, accusing it of gross violations of government and university norms. The student organization demanded that the state government immediately revoke the institute's autonomous status for running illegal programs and exploiting students through unauthorized fee collection. Addressing the media at Dasara Bhavan, AISF National Secretary Shi-

va Reddy and State Vice-President M. Sai Kumar alleged that the NRI IT management had turned education into a business enterprise under the veil of autonomy.

They charged that the college was violating the rules of the University Grants Commission (UGC) and the All India Council for Technical Education (AICTE), urging regulatory bodies to initiate action.AISF leaders highlighted several major violations. Firstly. they claimed that the college had disregarded the Andhra Pradesh Fee **Regulatory Commission** (APFRC) norms and was collecting a fee of 2.10 lakh annually from each student far exceeding the officially approved amount. This, they said, constituted a direct contravention of the state's fee regulation laws. Secondly, the institute was accused of conducting illegal B.Tech courses in collaboration with the private firm Nxt Wave's

NIAT program without

any approval from the UGC or AICTE.

According to AISF, NIAT lacks the authority to issue B.Tech degrees, yet NRI IT was misusing its autonomous status and JNTU Kakinada affiliation to run two parallel academic systems within the same campus. This "illegal dual system," they stated, severely disadvantages students admitted under the government quota. Unlike those enrolled under the NIAT program who pay high fees, government quota students reportedly receive no additional facilities, resources, or specialized training. Such discriminatory practices, AISF leaders said, undermine the equity and quality of education.

AISF issued four key demands:Immediate revocation of NRI IT's autonomous status.Strict criminal and disciplinary action against the college management.A joint high-level investigation by UGC, AICTE,

and APSCHE into all unauthorized programs.Refund of the illegally collected excess fees to all affected students. Sai Kumar also questioned the inaction of JNTU Kakinada authorities despite repeated complaints. Shiva Reddy warned that if prompt action was not taken, the issue would be escalated to the Union Ministry of Education. 
He instructed municipal commissioners and Public Health officials to coordinate with the RWS department and com-

TPN, Kalyandurg, October 10 — Education has become a daily life-risking ordeal for hundreds of students in and around Kalyandurg constituency of Anantapur district. Every day, students from several surrounding villages travel to Kalyandurg town to pursue higher studies, but their journey resembles a nightmare. With only one overcrowded bus available to serve hundreds of commuters, students are forced to endure suffocating and dangerous rides just to reach their schools and colleges.

Venkatampalli bus stand in Kambaduru mandal, a chaotic scene unfolds every morning. Hundreds of students gather in desperation, pushing and struggling to squeeze into the lone bus

that serves their route. The bus is so overcrowded that passengers can barely breathe, prompting parents and locals to call the situation "a moving death trap.' Many commuters

hang dangerously by the doors or stand precariously in passageways, fearing injury but left with no other option.Parents and residents have expressed severe frustration, accusing the transport authorities of negligence. "If our children want to study, they have to risk their lives every single day," said Raju, the father of one student. "We have complained to the RTC depot manager multiple times, but he doesn't even answer our

Do the lives of our children mean nothing to them?" his anguished complaint echoed the sentiments of many families in the region.Students say they have repeatedly appealed to the Road Transport Corporation (RTC) officials to allocate additional buses during peak hours, but their pleas have gone unanswered. "Despite our repeated requests, officials act as if our suffering doesn't matter," Raju added, warning that parents are prepared to organize protests if the government continues to

Residents argue that while the state government has introduced several welfare schemes such as free bus travel for women, the welfare of students — the very future of the state has been forgotten. Parents stressed that education policy cannot succeed without providing safe and reliable transport to

ignore their calls.

as.The demand is straightforward: allocate at least one or two additional buses for school and college timings to ease the burden on the existing overloaded service.

Locals have appealed directly to the district collector and Kalyandurg MLA Amilineni Surendra Babu to intervene and ensure that RTC takes immediate action. The situation underscores a deeper rural infrastructure problem — while educational opportunities have expanded in towns, accessibility remains a major challenge for students in remote areas. For now, hundreds of young passengers continue to endure a daily "hell ride," their determination to learn overshadowed by the risks they take each morning and evening.

Unless swift action is taken, this issue could spiral into a larger safety crisis. Parents and students have vowed to intensify their agitation if authorities fail to act, emphasizing that safe transport is not a privilege but a basic necessity for every child seeking an education in rural Andhra Pradesh.

AP GOVT CLEARS 250 CRORE PENDING MEDICAL BILLS

Another 250 Crore in **Pipeline**

TPN | Vijayawada | October 22, 2025: In a major step towards addressing the financial concerns of empaneled hospitals, the Andhra Pradesh Government has released 250 crore to Dr NTR Vaidya Seva (Network) Hospitals across the state. This move brings immediate relief to medical institutions struggling with pending dues for months.According to official sources, Health Minister Satya Kumar Yadav held a crucial meeting with Finance Minister Payyavula Keshav on Wednesday to review the settlement of arrears pending under the state's flagship health insurance scheme.

Following detailed discussions, the Finance Department cleared the file, paving the way for the timely release of the first tranche of 250 crore. Health Department Principal Secretary Saurabh Gaur confirmed the development and announced



that another installment of 250 crore would soon be released as part of the government's phased clearance plan. He said the State Government remains committed to ensuring that payments to network hospitals are made systematically and without unnecessary delay."The government is fully committed to ensuring that patients do not face any inconvenience and that all eligible hospitals receive their dues promptly," Gaur emphasized.

He mentioned that the clearance process had been expedited after several rounds of consultation involving the Finance and Health

Departments.Gaur also interacted with representatives from the Andhra Pradesh Super Specialty Hospitals Association and other hospital management bodies, urging them to withdraw their ongoing protests and resume regular operations. The association had recently launched agitation over non-payment of dues, warning that continuing delays could affect medical services to economically weaker patients relying on NTR Vaidya Seva coverage.

He appealed to the hospital representatives to consider the government's proactive steps and cooperate in maintaining uninterrupted services to the public. "With this release, we have set the process in motion to settle all legitimate dues. The next phase of 250 crore will follow soon," he assured. The Health Department clarified that the state government attaches top priority to patient welfare and smooth functioning of the health system. Officials estimate that the pending bills under Dr NTR Vaidya Seva cumulatively amount to several hundred crores, and the staged release of payments is expected to stabilize healthcare delivery across public and private institutions.

As the Union government celebrates the conclusion of its much-publicised 'GST Bachat Utsav', it's time to shift the spotlight where it truly belongs — the State governments. While the Centre has rolled out a campaign around recent GST rate revisions, it is the States, especially those ruled by Opposition parties, that have borne the brunt of revenue losses and deserve recognition for their role in the GST reform

The revision in GST rates, which took effect a month ago, has been widely marketed by the Centre as a Diwali "gift" to citizens. However, behind the scenes, many States were hesitant and sought revenue loss assurances before approving the changes. Their concerns were valid — GST, in its very structure, limits State autonomy over indirect taxation. With delays in



compensation payments and a pattern of selective fund allocation, States have had to navigate not iust financial shortfalls but also a Centre that

many say favours BJPruled States.

Data from the Reserve Bank of India backs these concerns. From

Maharashtra — both BJP strongholds — topped the list in private corporate investment intentions, with Gujarat alone accounting for nearly a

quarter of total projects. Of the top ten States attracting such investments, nine were BJPruled. Several Opposition leaders have accused the

Centre of diverting investment projects — including multi-crore deals originally earmarked for Tamil Nadu, Telangana,

Trump's H-1B Policy Risks U.S. Edge as **Global Competition for Indian Talent Grows**

A recent move by the Trump administration to tighten the H-1B visa program has raised serious concerns about America's longterm competitiveness in science, technology, and innovation. With a new \$100,000 fee per H-1B petition and entry restrictions for certain nonimmigrant workers, the U.S. may be ceding its advantage in attracting top Indian talent — long seen as vital to its tech

In FY-2024, over 71% of H-1B visas were granted to Indian nationals, with 64% going to tech-related roles. These figures highlight how heavily U.S. companies rely on skilled Indian professionals. However, the revised policies — framed as measures to prioritize American workers — are already pushing students and professionals to explore friendlier alternatives like Australia. France. and Germany.

Shifting Global Preferences

Australia, for instance, has introduced the MATES program, allowing Indian STEM graduates to work for two years. France has committed to hosting 20,000 Indian students by 2030 and offers five-year Schengen visas for Indian postgraduates. Germany has tripled skilled Indian worker visas and eased bureaucratic

Bihar 2025: The Missing Music of Democracy



In 1995, Bihar's elections were more than a political event—they were a festival. Streets came alive with drums, folk songs, colourful processions, and theatre-like campaign performances that turned even the most rural village into a carnival of democracy. Thirty years later, the scene has changed drastically. The Bihar of 2025 is witnessing a quiet, almost muted campaign season, leaving many to wonder: has democracy in Bihar lost its soul?

Veteran journalist Ajit Kumar Jha recalls the electric atmosphere of the 1995 elections—where slogans echoed from every corner, local artists composed campaign songs, and participation wasn't just a duty, but a celebration. Campaigns were loud, physical, and full of community spirit, even with restrictions from the Election Commission. People sang, danced, debated, and believed.

Today, the election landscape feels eerily quiet. Gone are the bamboo loudspeakers and folk singers. Instead, social media reels, 30-second shorts, and hashtags dominate the campaign narrative. Walls once covered in political posters are now bare. Village gatherings have been replaced by livestreams and virtual speeches. The largest visible campaigner isn't a candidate but strategist Prashant Kishor, whose Jan Suraaj Yatra travels the state more on YouTube than on foot.

Some blame the silence on timing—Diwali and Chhath have left little room for campaigning before the first phase of polls on November 6. Others

point to the Election Commission's hurried voter roll revisions. The broader truth, however, may be more troubling: a sense of political fatigue. Voters aren't angry, they're indifferent.

This shift isn't just stylistic, it's spiritual. When politics ceases to be participatory, democracy begins to lose its vitality. Voter turnout may drop. A subdued electorate often benefits incumbents. Yet, perhaps the silence offers a chance for thoughtful reflection—a pause before the people speak.

Still, many in Bihar miss the music, the hope, the drama. As the 2025 elections approach, it's not just votes at stake—it's the very spirit of democracy that once made Bihar's elections a vibrant celebration of the peo-

Microsoft CEO Satya Nadella's Pay Jumps to \$96.5 **Million Amid AI Success**

Microsoft CEO Satya Nadella's total compensation for the financial year 2024-2025 has surged to \$96.5 million, marking his highest annual pay since taking over the tech giant in 2014. The sharp increase is attributed to Microsoft's dominant strides in artificial intelligence (AI) under his

leadership.
According to the company's regulatory filing, nearly 90% of Nadella's earnings came in the form of Microsoft shares, with a base salary of \$2.5 million. In comparison, he earned \$79.1 million the previ-

In a note to shareholders, Microsoft's board credited Nadella and his executive team for positioning the company at the forefront of the glob-

al AI revolution during a "generational technology shift."

Other top Microsoft executives also saw significant compensation packages. CFO Amy Hood earned \$29.5 million, while Judson Althoff, who heads the commercial business, received \$28.2 million.

Microsoft shares have climbed 23% this year, largely due to the strong performance of its Azure cloud services, which continue to challenge market leader Amazon Web Services.

Since taking the helm in 2014—succeeding Steve Ballmer and co-founder Bill Gates—Nadella has reshaped Microsoft into a cloud-first, AIdriven company. His strategic bets on cloud computing and key acquisitions such as

LinkedIn, GitHub, and Activision Blizzard have expanded Microsoft's reach across enterprise software, professional networking, and gaming.

One of Nadella's most transformative moves was backing OpenAI. What began as a \$1 billion investment evolved into a \$10 billion partnership, enabling Microsoft to integrate cuttingedge AI tools like ChatGPT across its products, from Office to Azure.

Born in Hyderabad, Nadella earned his engineering degree from Mangalore University before completing a master's in computer science from the University of Wisconsin-Milwaukee. He joined Microsoft in 1992 and rose through the ranks before becom-

Karnataka Congress MLA Flags ₹900 Crore Fund Crunch In Free Bus Travel Scheme

Congress MLA and NWKRTC Chairman Raju Kage has raised concerns over a massive ₹900 crore funding shortfall under the Karnataka government's Shakti scheme, which provides free bus travel for women across the state. Kage revealed that the North Western Karnataka Road Transport Corporation (NWKRTC) is struggling financially and urged the state to release the overdue funds.

"We are not making profits. We're trying to reach a break-even point. We are owed around ₹900 crore under the Shakti scheme, which has not been released since its implementation two years ago," Kage said. He explained that the government currently pays only 70% of the cost, holding back the remaining 30%, making it difficult for transport corporations to stay afloat.

The MLA added that the issue has already been brought to the attention of Chief Minister Siddaramaiah and Transport Minister Ramalinga Reddy.



In response, Minister Reddy defended the government's efforts, stating that the state had sanctioned ₹2,000 crore to support road transport corporations when they were in distress. "Out of this, over ₹500 crore has already been allocated to NWKRTC. Additionally, 700 new buses worth ₹350 crore are being provided. This totals ₹850 crore in

support," he said. Despite these measures, Karnataka's road transport sector remains in financial turmoil. As of November 2024, total

liabilities across KSRTC, BMTC, NWKRTC, and KKRTC stood at ₹6,330 crore, with ₹3,000 crore in immediate dues. KSRTC alone recently requested a ₹623 crore loan to clear fuel and statutory

payments. Key reasons behind the fiscal stress include the COVID-19 impact, delayed fare revisions, and the financial burden of the Shakti scheme. Stakeholders are now urging urgent financial intervention to sustain essential public transport services in the



PM Carney Confirms Arrest of Netanyahu if He Enters Canada

Motorist Crashes Into White House Gate, Arrested by Secret Service

A man was arrested late Tuesday night after crashing his vehicle into a security gate near the White House complex, the U.S. Secret Service confirmed. The incident occurred at approximately 10:37 pm near the corner of 17th and E Streets NW.


According to the Secret Service, the vehicle struck a security barrier located on the southwest perimeter of the White House, close to the American Red Cross headquarters. The driver was immediately taken into custody by responding officers.

The agency stated that

a thorough inspection of the vehicle was carried out by Secret Service officers alongside Washington Metropolitan Police officials, who later confirmed that the car posed no threat. The vehicle was cleared and subsequently towed from the scene.

No injuries were reported, and the White House was not placed on lockdown. However, the area around the impacted gate was temporarily closed off while authorities completed their investigation and secured the site.



The course, named Tufat al-Muminat, aims to recruit and indoctrinate women into the group's newly formed women's unit, Jamat u l-M umin at.According to exclusive documents obtained by NDTV, the course is scheduled to begin on

November 8 and will be conducted entirely online to bypass extremist social norms in Pakistan that discourage women from venturing out alone. Each session will last 40 minutes daily and be led by Masood Azhar's sisters, Sadiya Azhar and Samaira Azhar. Sadiya, who heads the women's unit, will be one of the primary instructors encouraging women to participate actively in

the organization. The course requires a fee of 500 Pakistani Rupees (approximately 156 Indian Rupees) from eve-

ry woman enrolling, with participants required to fill out an online information form. This fee collection appears to be part of an intensified 'donations' drive by Masood Azhar, following his recent public address at the Markaz Usman O Ali in Bahawalpur.

Sadiya's husband, Yusuf Azhar, was among ten members of Masood Azhar's family killed during India's Operation Sindoor airstrike on the Jaish headquarters in Bahawalpur earlier this year, a retaliatory action

against the April terror attack in Jammu and Kashmir's Pahalgam.

Also involved in the course is Afreer Farooq, wife of one of the Pahalgam attackers, Umar Faroog.

This online initiative not only highlights the group's attempt to expand its influence through women but also exposes Pakistan's claim of compliance with Financial Action Task Force (FATF) regulations, revealing a worrying nexus between militancy and financial channels.



Hamas Returns Remains of Two More Hostages to Red Cross Amid Ceasefire

TPN Correspondent | Iran Hamas has handed over the remains of two additional hostages to the Red Cross in Gaza, the Israeli military confirmed on October 22. This development comes amid the ongoing ceasefire between Israel and Hamas, which began on October

Since the ceasefire took effect, the remains of 13 hostages have been returned to Israel as part of efforts to recover those captured or killed during the recent conflict. Following this latest transfer, Israeli officials say that the remains of another 13 hostages are still held in Gaza and await recovery and handover.

The transfer of bodies is being facilitated by the International Committee of the Red Cross (ICRC), which is overseeing the humanitarian aspects of the ceasefire agreement. Red Cross vehicles were seen escorting a truck transporting the remains in the Gaza Strip's Deir Al-Balah area, highlighting the fragile but ongoing cooperation between the conflicting

The return of the remains marks a significant humanitarian step in the tense and complex aftermath of the conflict, which saw numerous kidnappings and casualties on both

sides. Families of the missing hostages in Israel continue to seek closure as the process of recovery and identification

The ceasefire, brokered earlier this month, has provided a temporary halt to active hostilities but challenges remain in resolving the broader conflict and addressing humanitarian concerns in the region.

With the recovery of these two additional remains, efforts continue to locate and retrieve the rest of the hostages' bodies still held in Gaza, underscoring the ongoing humanitarian impact of the conflict between Israel and Hamas.

Core Sector Growth Slows to 3% in September, **Hits 3-Month Low**

Growth in India's eight core infrastructure sectors slowed to a three-month low of 3% in September 2025, according to data released by the Ministry of Commerce and Industry. The deceleration was mainly due to contractions in key fuel-related sectors — coal, crude oil, natural gas, and refinery products — as well as a marked slowdown in fertiliser production.

POINT

The Index of Eight Core Industries, which represents about 40% of the weight of items in the Index of Industrial Production (IIP), showed that although growth in September 2025 was higher than the 1.5% growth recorded in the same month last year, it was the weakest performance since June 2025.

Sector-Wise Performance:

Coal, crude oil, natural gas, and refinery products all registered declines in output compared to September 2024.

Fertiliser output, while not contracting, saw significantly slower growth, further dampen-



ing the overall index.

Sectors like steel, cement, and electricity provided some cushion with moderate gains but were not enough to offset the drag from energy-related sectors. Analysts attributed the slowdown to seasonal factors, lower global demand, and operational bottlenecks in certain sectors. The contraction in coal and refinery products, in particular, may affect downstream industries and overall industrial momentum in the coming months.

Despite the setback, the government maintains that the medium-term outlook remains stable, with core sector growth for the first half of FY2025-26 still showing positive trends.

The data will likely be closely watched by policymakers and the Reserve Bank of India, as it offers early signals for industrial output and broader economic performance. The next few months will be crucial in determining whether the slowdown is temporary or indicative of a more sustained moderation.

Silver Prices Likely to Fall as Global Supply Increases



Silver prices in India are expected to decline further after a sharp correction, following an increase in global supply aimed at cooling down soaring demand during the Diwali festival season, according to industry experts.

Kumar Jain, national spokesperson for the India Bullion and Jewellers Association (IBJA), said the London Bullion Market Association (LBMA) has released additional silver stocks into the international market to counterbalance India's high demand, which led to a recent price surge. This increase in supply has caused silver prices to drop sharply, and further declines are anticipated.

During the festive season, Indian investors heavily bought silver jewelry and silver ETFs, leading to a shortage of physical silver. This demand spike was intensified by financial influencers promoting silver as an attractive investment with a favorable ratio compared to gold. The demand pressure was so intense that MMTC-Pamp, India's largest precious metals refinery, exhausted its silver stock for the first time ever.

Silver premiums in India surged above \$5 per ounce, far exceeding normal levels. Due to the shortage, several mutual fund houses, including Kotak MF, UTI, and SBI MF, had to halt new silver fund subscriptions. Globally, the silver market faces supply challenges due to China's holiday slowdown and increased silver shipments to the US

amid tariff concerns. Following Dhan teras, silver prices fell over 5-6% in the past two days, with international spot prices dropping below \$50 per ounce after a 60% rally year-to-date. In India, silver traded at Rs 1,62,000 per kg on October 22.

Despite recent corrections, structural demand for silver remains strong, driven by industrial uses such as solar panel manufacturing, which continues to outpace mining and recycling

The decline in net FDI during August is likely to raise concerns for policymakers who are keen to maintain India's position as a top destination for foreign investment. The government has recently emphasized initiatives to boost manufacturing, digital infrastructure, and ease of doing business to sustain and grow foreign capital inflows.

As the economic landscape evolves globally, the coming months will be critical for India to stabilize FDI flows and ensure continued confidence among foreign investors. Market watchers will closely monitor upcoming data to assess whether August's net outflow is an isolated incident or a sign of shifting investment trends.

India Emerging as Global Hub for Services Exports: NSE



India is rapidly establishing itself as a global hub for services exports, outpacing the growth of goods exports, according to the National Stock Exchange (NSE). NSE chief economist Tirthankar Patnaik said. "India will be to services what China has been to manufacturing," highlighting the country's transformation in the global economic landscape.

The NSE reported that India's services exports have been growing at a compound annual growth rate (CAGR) of 14.8%, significantly higher than the 9.8% CAGR observed in goods exports. This robust expansion is attributed to several factors, including structural reforms, digital innovation, and demographic advantages that position India favorably in the global services market.

The services sector, which includes IT and software services, finance, telecommunications, and professional services, has become a key driver of India's economic growth. Investments in technology, skill development, and infrastructure have accelerated the sector's ability to compete on a global scale. Additionally, India's young and dynamic workforce provides a demographic edge that fuels the expanding services

industry.

Smart Bed Worth 1.75 Lakh Malfunctions, **Users Face Sleepless Night**

Owners of the high-en d Eight Sleep "Pod" smart beds, priced around 1.75 lakh (\$2,000), were left frustrated after a global Am azon Web Services (AWS) outage caused widespread malfunctions late Monday night.

The Pod beds, known for their automated temperature control and adjustable settings, suddenly overheated and froze in fixed positions, leaving users stuck and

sleep-deprived. The issue was traced to a disruption in AWS's US-EAST-1 region, which began around 3 a.m. ET. The beds rely on AWS servers to function via app-based controls.

By morning, Downdetector had recorded over eight million outage reports globally, affecting not just smart home devices but also apps, gaming platforms, and banking services.

Several users took to Reddit and X (formerly Twitter) to share their ordeal. Some reported intense heating issues, while others were unable to adjust their beds, leading to discomfort and panic during sleep.

Eight Sleep's CEO Matteo Franceschetti issued a public apology on

"The AWS outage has impacted some of our users since last night, disrupting their sleep. That is not the experience we want to provide, and I want to apologize for it."

Franceschetti added that the company would work round-the-clock to ensure such issues don't happen again. He revealed that developers were building an "outage-proof mode" that would allow the bed to operate independently of AWS during similar

incidents.

While some services have been restored, Franceschetti noted that data processing delays may persist, and full functionality would return as AWS stabilizes.

For now, frustrated users are demanding a "real solution" — with many questioning the reliability of smart home devices that rely entirely on cloud services for basic operations.

Bengaluru's crumbling roads have long been a sore spot for its residents, but a recent incident near KR Road has pushed the frustration to new heights — or depths. A pothole nearly half a foot deep was spotted covered by an old couch, reportedly placed there by local shopkeepers as a warning for drivers and tw o-wheelers.


The unusual workaround gained attention after a photo of the scene was shared on Reddit. The uploader explained that despite the pothole being a hazard large enough to trap a scooter wheel, civic authorities had done little beyond placing traffic cones and barricades



How Do Engineers Keep The Water Out While Building **Bridges On Rivers?**

bridge foundations are laid in forming a sealed circle or rectandeep, fast-flowing rivers? Unlike gle that blocks water from enterland construction, building in water poses serious challenges, including strong currents, limited visibility, and high risk for workers. To overcome this, engineers use a remarkable technique called a cofferdam — a temporary watertight structure that makes underwater construction possible in dry

A cofferdam is essentially an enclosed area built within the river using interlocking steel sheet piles, typically 10 to 20 metres long. These sheets are hammered deep into the riverbed using hy-

Ever wondered how massive draulic or vibratory hammers, required. ing. Once sealed, powerful pumps remove the water from the inside, creating a dry workspace.

This method was used in major Indian infrastructure projects like the Thane Creek Bridge, where engineers noted that vibrations from the pile-driving process even scared off nearby fish.

Before construction begins, a thorough survey of the riverbed is conducted to measure depth, soil stability, and current speed. These details determine how deep the foundation needs to be and how many support pillars are

Once water is pumped out and descend into the cofferdam — often via ladders or crane platforms – to begin laying the bridge foundation. Strict safety measures are in place, with helmets and life jackets mandatory on site.

Despite its temporary nature, a cofferdam plays a critical role in ensuring bridge stability and safety. Once the foundation work is complete, the structure is dismantled, and water is gradually reintroduced to the area.

LaLiga Cancels Barcelona-Villarreal Miami **Match Amid Controversy**

LaLiga has officially canceled its plans to hold the December 2025 league match between Barcelona and Villarreal in Miami, citing growing uncertainty in Spain in recent weeks. The announcement came on October 21, 2025, following widespread backlash and disputes surrounding the move.

The controversial plan to stage a LaLiga match outside Spain, specifically in the United States, had initially received reluctant approval from UEFA, European football's governing body. If true, Gates' cameo would follow a series of special appearances on the show, with actors Sakshi Tanwar and Kiran Karmarkar having recently featured in guest roles.


