

**Efforts Underway to Rescue Andhra Fishermen Detained** in Bangladesh Waters: Union Minister Rammohan Naidu.

RIKAKULAM, OCT 23: A major rescue operation is underway to bring home eight fishermen from Andhra Pradesh who were accidentally detained by Bangladeshi naval authorities after they drifted into foreign waters. The incident, which occurred last week, has sparked widespread concern across the state, especially in the coastal districts of Srikakulam and Vizianagaram. According to reports, the group of eight fishermen, all residents of Bhogapuram in Vizianagaram district, had set sail from the Visakhapatnam coast on October 13.

They were aboard a fishing boat owned by Satyanarayana from the Relli Veedhi area of Visakhapatnam. While continuing their fishing operations late into the night, the crew inadvertently crossed into Bangladesh's territorial waters due to rough sea conditions and poor navigation visibility. Before they could realize the situation, a Bangladeshi naval patrol intercepted



their vessel, detaining all eight men for unlawful entry. In the wake of the incident, Union Minister for Civil Aviation Kinjarapu Rammohan Naidu acted swiftly to ensure the safe return of the detained fishermen.

The minister, who

hails from Srikakulam, has been in constant contact with the Ministry of External Affairs and the Indian High Commission in Bangladesh. He confirmed that diplomatic communications are in progress to secure their early release. "I have already spoken to the External Affairs Minister Dr. S. Jaishankar, and the matter is under close observation," Rammohan Naidu stated. "The Indian Mission in Dhaka and our Coast Guard authorities are coordinating on all fronts to bring the fishermen back home safely. Every necessary step is being taken at the

highest level of government."Minister Naidu further emphasized that maintaining the welfare and security of Indian fishermen is a national priority. He revealed that extensive coordination is ongoing between multiple agencies, including the Indian Coast Guard, the Ministry of Defence, and the Ministry of External Affairs, to handle the issue diplomatically but decisively. "This is a sensitive situation involving an international boundary, and we are ensuring that due diplomatic channels are followed,' he said.

Meanwhile, sources close to the Union Minister indicated that regular updates are being sought from the Bangla-

desh Embassy, and efforts are focused on ensuring legal clearance for the fishermen's release without delay. The Indian authorities are also verifying that the detained individuals are safe and have access to basic facilities during their custody. Chief Minister N. Chandrababu Naidu, who was in Dubai on an official visit when the news broke, also responded promptly, directing state authorities to stay in close touch with the central government.

He assured the affected families that both the state and union governments are united in resolving the matter quickly. Family members of the detained fishermen in Bhogapuram have expressed cautious relief after learning about the minister's swift intervention. They continue to hope for an early reunion with their loved ones. Anakapalli (Andhra Pradesh), Oct 23: In a major crackdown on illegal gambling activities, the Andhra Prade sh police arrested 11 individuals and seized over Rs 19 lakh in cash during a raid conducted on the outskirts of Nakkavanipalem village. The operation, carried out late on Tuesday night based on reliable intelligence, aimed to dismantle an organized gambling ring thriving under the guise of casual entertai

According to Deputy Swaroop, the main organiser was identified as Jerripothula Shiva, aged 30, a resident of Donkada Colony in Aganampudi village. Preliminary investigations revealed that Shi-

"We received credible information about a group engaging in card-based betting.

Acting swiftly, we raided the spot at Nakkavanipalem and ap-

prehended 11 persons in the act of playing the card game commonly known as 'Kotha'. A few others managed to we have initiated efforts to trace and arrest them soon," said DSP Swaroop.During the raid, police seized cash amounting to more than 19 lakh, along with 17 mobile phones, two motorcycles, one

car, and an assortment of gambling material including 10 unopened decks and 52 used sets of playing cards.

Authorities also recovered lighting equipment used to facilitate the game during night sessions. The DSP further stated that the accused have been booked under Section 9(1) of the Andhra Pradesh Gaming Act, 1974, and

Bharatiya Nyaya Sanhita (BNS), for organising and participating in unlawful gambling activities. The seized property has been taken into custody as evidence, and investigation is ongoing to determine the extent of the racket's operations and its possible connections with other districts.Police officials have urged the public to remain vigilant and report any suspicious gambling activities in their areas.

"Illegal gambling encourages criminal networks and financial exploitation. Our depar tment is intensifying efforts across the distri ct to curb such offences," DSP Swaroop emphasized. The arrests mark one of the largest cash seizures in a gambling case reported in recent months in the Anakapalli region, reflecting the police department's sustained drive against organised gaming and betting operations in the state.

#### **Financial Inclusion Rises. Yet Gender and Community**

Gaps Persist
TPN BUREAU, AM-ARAVATHI, OCT 23: India's push toward financial inclusion has reached a significant milestone, with 80.2% of citizens now part of the formal financial system. However, new data reveals underlying disparities in access and debt distribution across gender, religion, and community groups, shedding light on the uneven progress in achieving inclusive

According to the findings, only 7.4% of the population is currently burdened with loans, indicating relatively low levels of indebtedness compared to the

clusion rate. This trend suggests that while more people are gaining access to bank accounts and financial services, borrowing remains limited, possibly due to risk aversion or lack of collateral amo ng low-income households. Among religious groups, Hindus have recorded the highest rate of participation in financial services at 88.1%, followed by Muslims at 80.8%.

The gap underscores continued challenges in ensuring equitable access to banking facilities and financial aware ness across communities. Experts note that cultural factors, income disparities, and regional inequalities often influence financial inclusion outcomes. Gender, too, continues to influence financial participation. While 89.8% of men are financially included, only 84.5% of women

have access to formal



financial institutions. This gender divide reflects broader socioeconomic patterns where women, especially in rural or marginalized areas, face barriers such as limited mobility, lower literacy levels, and lack of documentation.

Government initiatives like Jan Dhan Yojana and digital banking schemes have improved access for women, yet the gap highlights the need for continued focus on genpolicies.Caste and community-based differences in debt levels also draw attention. Other Backward Classes (OB Cs) show a higher debt burden, with 16.6% of individuals reporting loans, compared to Scheduled Tribes (STs), where only 11% are inde bted.

**Economists** interpret this as a reflection of differing economic activities-OBC households often engage in small-scale trade, agriculture, or self-employment, leading to higher credit dependency, whereas tribal communities may rely more on subsistence livelihoods with limited credit interactions. An interesting pattern emerges when comparing household size with debt levels. Families with more members tend to have lower debt burdens than smaller households. This counterintuitive finding could be attributed to the shared

tential within larger families, which might enhance financial stability and reduce individual borrowing nee ds. Conversely, smaller or nuclear families mig ht experience higher financial strain due to limited earning members, leading to greater reliance on credit.

Overall, while India's financial inclusion journey continues to make impressive strid es, the finer details of this data tell a more complex story. Bridging gender and community divides, enhancing financial literacy, and promoting equitable access to credit remain critical steps toward ensuring that economic opportunity reaches every household. Policymakers and financial institutions must therefore focus not just on expanding access, but on creating meaningful inclusion that empowers every section of





# AP CS ON 34/7 COST EFFECTIVE POWER SUPPLY

#### **APCS DIRECTS POWER UTILITIES TO ENSURE 24X7 RELIABLE AND COST-EFFECTIVE POWER SUPPLY.**

TPN | Vijayawada | October 23, 2025: Andhra Pradesh Chief Secretary K. Vijayanand has directed the State's Power Utilities to ensure round-theclock reliable and uninterrupted power supply across the state while maintaining financial discipline and costeffectiveness in power procurement. Chairing a high-level review meeting on Thursday in Vijayawada, he emphasized the importance of dynamic planning and continuous market monitoring to manage the upcoming month's power needs efficiently.

The meeting, attended by top officials from AP-GENCO, APTRANSCO, DISCOMs, and NRED-CAP, reviewed the power procurement plan for November 2025 in detail. Vijayanand stressed that

ensuring affordable power and system stability must remain the top priority for all power utilities, especially in view of rising demand and fluctuating renewable energy generation.Presenting the projections for November, the Chief Secretary said the total power availability has been estimated at 213 million units (MU) per day, against an expected grid demand of 218 MU per

He noted that renewable energy would continue to play a crucial role in meeting this demand. The state anticipates solar energy generation between 70 MW and 1,870 MW depending on weather conditions, and wind energy production ranging from 90 MW to 400 MW. To maintain grid stability, hydro generation from the Sileru Power Station (500 MW) will be strategically used for balancing during daytime and operated at full capacity during evening peak load hours.

Referring to October's performance, Vijayanand commended the

efforts of the power utilities for effectively managing a projected daily deficit of 15.33 MU and a peak shortfall of 1,800 MW without resorting to expensive long-term tieups. Through agile and real-time power procurement strategies, the utilities achieved significant financial savings while maintaining uninterrupted supply across all regions. He appreciated the coordinated efforts of APGENCO, AP-TRANSCO, and DIS-COMs in ensuring system reliability and operational efficiency during the challenging

The Chief Secretary instructed APGENCO to sustain an average daily thermal generation of 4,200 MW throughout November to meet expected peak demand. He directed the corporation to ensure adequate coal stocks and prioritize quality fuel procurement to enhance efficiency at higher-capacity units. Vijayanand also reviewed progress on the ongoing construction works at the NTTPS expansion and MVR Rayalaseema Thermal Power Project (RTPP), urging officials to accelerate completion and commission the projects by March 2026.

In addition, Vijayanand reviewed the status of Pumped Storage Projects (PSPs) under development and called for expediting statutory clearances, tendering, and project approvals. He instructed coordination among APSPCL, NREDCAP, and related entities to establish solar parks supporting these PSPs, thus strengthening the state's renewable energy base and ensuring long-term grid stability. The review meeting was attended by APGEN-CO Managing Director S. Nagalakshmi, AP-TRANSCO Joint Managing Director Surya Sai Praveenchand, and senior officials AKV Bhaskar, JV Rao, NV Ramana Murthy, M. 
# **AP GOVT MAKES A DIPLOMATIC PUSH** TO BRING BACK AP FISHERMEN

#### **AP GOVT STEPS UP DIPLOMATIC PUSH TO BRING BACK 8 VIZIANAGARAM FISHERMEN DETAINED**

In response, the





Indian High Commission in Dhaka has deputed a special legal team to provide legal assistance and representation.

> The embassy team is actively pursuing legal remedies and engaging with Bangladesh authorities to expedite the release.Meanwhile, the State Government has extended dinlomatic outreach by requesting the Bangladesh Embassy in New Delhi to cooperate in fast-tracking the legal and administrative process leading to the fishermen's return. Union Minister for Civil Aviation Kinjarapu Ram Mohan Naidu has personally taken up the matter with External Affairs Minister Dr. S. Jaishankar, seeking immediate central intervention to resolve the issue through bilateral channels.

At the state level, Minister for MSME, SERP and NRI Af-

fairs Kondapalli Srinivas is supervising developments closely. He is also attempting to establish contact with the fishermen using satellite communication to ascertain their condition and offer reassurance to their families.On the local front, Vizianagaram District Collector S. Ramsundar Reddy directed RDO D. Keerthi to meet the families of the detained fishermen in Visakhapatnam.

She briefed them on the coordinated action being taken by both state and central authorities and assured them of full support and assistance until the fishermen safely return home. # MINOR GIRL'S MOLESTER DIES **COMMITTING SUIDIDE**

#### **ACCUSED IN MINOR GIRL'S ATTEMPTED RAPE CASE DIES BY SUICIDE IN**

#### KAKINADA.

Kakinada, Oct 23: In a tragic turn of events, the accused in the attempted rape case of a minor girl in Tuni, Kakinada district, allegedly died by suicide late Wednesday night. Police said the accused, identified as 37-year-old Tatika Narayana Rao, ended his life by jumping into Komati Cheruvu, a lake located

on the outskirts of Tuni town. According to police sources, the incident occurred around 10:30 p.m. while Rao was being escorted by a police team to be produced before a magistrate in connection with the attempted rape of a Gurukul student.

Inspector Ramakrishna of Tuni police station stated that the accused requested a halt along the way under the pretext of relieving himself. When the vehicle stopped near the lake, he suddenly leaped into the waters before anyone could react."Despite the police personnel's immediate efforts to rescue

him, it was too late. We suspect it to be a case of suicide," Inspector Ramakrishna said.

The police have registered a case under the relevant sections, and an inquest has been conducted. Rao's body was retrieved early Thursday morning and shifted to Tuni Government Hospital for post-mortem.The accused, who faced charges under sections of the Protection of Children from Sexual Offences (POCSO) Act, had been arrested just hours earlier following allegations that he attempted to sexually assault a minor student of a government-run Gurukul resi-

dential school in Tuni mandal.

The incident had triggered outrage among local residents and parents, leading to demands for strict action.Meanwhile, the Andhra Pradesh State Women's Commission has taken suo motu cognisance of the attempted rape and the subsequent developments. Expressing shock and deep anguish, Commission Chairperson Dr. Rayapati Sailaja directed authorities to ensure swift action and complete justice for the

Dr. Sailaja spoke with the Kakinada District Superintendent of Police soon after learning of the incident. She instructed the police to invoke all relevant sections of the POCSO Act against the accused and conduct a transparent investigation into the case as well as the circumstances surrounding his death. "The safety and dignity of children in residential institutions must be safeguarded at all costs," she stated.

The Women's Commission also issued directives to the District Collector's Office and the Child Welfare Committee to provide immediate protection, medical care, and legal assistance to the victim. Additionally,



the Commission instructed the Andhra Pradesh Social Welfare Residential Educational Institutions Society (AP-SWREIS) to enhance security and surveillance systems in all Gurukul schools across the state.

# **Immigration and the Politics of Fear: From Border Control to Cultural Panic**

General Assembly last month, U.S. President Donald Trump reignited global debate on immigration with a fiery attack on Europe's openborder policies. Declaring that "it's time to end the failed experiment of open borders," Trump warned European leaders that their nations were "going to hell" — a statement that laid bare his intent to export his brand of anti-immigrant populism to the very continent his Scottish-born mother once left behind.

In the United Kingdom, immigration has long been a politically charged issue. Historical flashpoints such as Enoch Powell's infamous 'Rivers of Blood' speech in 1968, the National Front's activism during the 1970s, and the Brexit-era 'Take Back Control' rhetoric of the mid-2010s have all shaped the country's relationship with migration. What makes the current moment distinct, however, is a shift



in focus — from condemning illegal or irregular immigration to denouncing legal migration

The evolution of the

discourse reflects a deeper nativist anxiety about identity, culture, and belonging. Where earlier debates centered on the

age and integrate migrants, today's narratives increasingly hinge on protecting "heritage" and "way of life." These

cloaked in the language of integration and national security, yet they resonate most strongly with populist movements seeking to mobilize fear

of demographic and cultural change.

The growing prominence of far-right demonstrations — such as the recent "Unite the King-

dom" march led by English Defence League founder Tommy Robinson in London — underscores how mainstream

the politics of exclusion

has become. Images from the rally, including that of a demonstrator perched defiantly atop the South Bank lion near Westminster Bridge, have come to symbolize the intersection of nationalism and spectacle in the U.K.'s political landscape.

Analysts warn that the shift from policy-based migration debates to identity-based panic risks normalizing xenophobia in public discourse. What was once a question of economic management has morphed into a cultural battlefield, where even legal immigrants find themselves under suspicion.

As global migration continues amid conflict, inequality, and climate change, the U.K. and much of the West face a defining question: whether to be guided by fear and exclusion, or by inclusion and shared humanity — a choice that will shape not just immigration policy, but the

### **Bengaluru Auto Fare Chaos: Permanent Fix Needed to End Passenger Woes**

As Bengaluru grapples with mounting commuter frustration over autorickshaw fares, the government's ongoing fare verification drive, slated for completion by October 31, appears unrealistic and unfair — both to drivers struggling with delayed verifications and to passengers forced to pay arbitrary fares.

The Transport Department had revised auto fares in August, fixing rates at ₹36 for the first two kilometres and ₹18 for every additional kilometre. However, compliance has been patchy at best. Many drivers continue to charge unregulated amounts, often without displaying fare charts or recalibrated meters. Passengers, left to negotiate or argue mid-ride, are bearing the brunt of administrative

The verification process has been chaotic. Several drivers reported being turned away from verification centres or told to return after October 25, due to a manpower crunch in the Legal Metrology Department, whose staff have been deputed for the Karnataka Social and Educational Survey. With poor coordination and communication, the recalibration exercise—meant to restore order—has instead



deepened confusion and emboldened fare violations.

Experts and commuter groups have urged the government to extend the deadline and, in the meantime, mandate that all autorickshaws display printed fare charts. This would protect commuters from overcharging and enhance transparency while the recalibration

drive continues. Yet, the fare crisis extends beyond street-hailing autos. Ride aggregator platforms, despite adopting the revised fare structure in August, face growing criticism for exorbitant pricing and surge fares. Commuters routinely

report fares 20-30% higher than government-fixed rates, with additional opaque charges. In some cases, cab rides through the same apps are cheaper than autos, prompting questions about fairness and oversight.

Critics say that while authorities crack down on independent drivers, aggregators face little scrutiny. The government, they argue, must enforce uniform fare monitoring and curb profiteering practices under the guise of "digital convenience.'

Additionally, passenger safety remains a major concern. Authorities have been urged to launch a comprehensive verification drive to check driver credentials, permits, and vehicle documents—especially vital for single women and senior citizens who depend on autos for daily commutes.

Ultimately, experts agree that fare tinkering and enforcement drives are only temporary fixes. The sustainable solution lies in strengthening Bengaluru's public transport system, ensuring that autorickshaws serve primarily as last-mile connectors, not as substitutes for the city's inadequate mass transit network.

### The Long wait For A Resolution..!



The prolonged legal tussle over the Munambam land dispute has entered yet another complicated phase, following a recent order by the Kerala High Court that has added layers to an already tangled issue. Instead of providing finality, the judgment has further muddied the waters, leaving the matter open for continued legal scrutiny.

In its latest ruling, a Division Bench of the High Court de-clared that the disputed Munambam holding does not qualify as Waqf property. However, the court simultaneously refrained from annulling the previous actions taken by the Kerala Waqf Board concerning the same property, despite terming those actions as bad in law. This nuanced decision effectively transfers the responsibility for a conclusive resolution back to the Waqf Tribunal, which is already hearing related petitions on the issue.

The judgment, while significant, has not delivered the clarity many stakeholders had hoped for. By directing the matter back to the Tribunal, the court has reignited debates around jurisdiction, ownership rights, and the procedural correctness of the Waqf Board's earlier interventions. Legal experts note that this move could prolong the dispute, as the Tribunal must now re-examine aspects that the High Court has left open-ended.

The Munambam property, located in Ernakulam district, has long been the subject of contention between private claimants and the Waqf Board. Questions regarding its legal status and ownership have persisted for years, with both sides presenting competing claims of historical rights and religious endowments.

The High Court's decision, observers say, highlights the complexities inherent in property cases involving Waqf land, where questions of faith, community interest, and statutory interpretation intersect. The ruling may also have wider implications for similar disputes across the State, where Wagf land holdings have frequently been challenged on grounds of title and management.

For now, the case remains far from resolved. With the Waqf Tribunal tasked once again with reassessing the matter, the Munambam dispute appears destined to continue its long and winding journey through the corridors of justice — offering, at least for the moment, no clear end in sight.

# Pakistan-Afghanistan Conflict Escalates After **Cross-Border Strikes**

The fragile peace between Pakistan and Afghanistan has collapsed into a near-war situation following what is believed to be Pakistan's first-ever aerial bombing of Afghanistan earlier this month. The drone strikes on Kabul and Paktia on October 9, coinciding with Taliban Acting Foreign Minister Amir Khan Muttaqi's visit to Delhi, marked a dramatic escalation in tensions after decades of insurgency and statesponsored militancy in the region.

The cross-border attacks, allegedly targeting Tehrik-e-Taliban Pakistan (TTP) camps, resulted in civilian casualties, including the deaths of members of a local cricket team in Urgon district. In retaliation, Afghanistan Pakhtunkhwa. Observpulled out of a tri-na- ers allege that Paki-

# **Gaganyaan Mission: 90% Development Work Completed, Says ISRO Chief**

The Gaganyaan mission, India's first human spaceflight project, is progressing steadily with about 90 percent of the development work now complete, ISRO Chairman V. Narayanan announced Thursday.

Speaking to reporters during the promotional activities for the upcoming Emerging Science, Technology, and Innovation Conclave (ES-TIC-2025) in New Delhi, Narayanan detailed the extensive technological advancements involved in the mission. "A lot of technology development has to take place - the rocket has to be human-rated, the orbital module developed, along with the environmental control and safe-

ty systems," he said. Narayanan highlightthe crew escape system. parachute deployment system, and human-centric products critical for the mission's success. "Now, three uncrewed missions have to be accomplished before going

ed the importance of

for the crewed mission, and we are working towards that. In the first uncrewed mission, Vyommitra, the humanoid robot, will fly," he added, setting a target for the crewed mission by early 2027.

On August 24, 2025, ISRO successfully conducted its first integrated air drop test for the Gaganyaan program at the Satish Dhawan Space Centre in Sriharikota. The test validated the parachutebased deceleration system for the crew module, a crucial safety

safe splashdown during re-entry.

"For the Gaganyaan programme, the integrated air drop test involved lifting a simulated module by helicopter to about three kilometers above the Earth. and using nine parachutes to ensure a synchronized and safe descent," Narayanan explained.

The successful parachute test marks a major milestone for the Gaganyaan mission, demonstrating the reliability of the critical systems needed for human spaceflight. With development nearing completion, ISRO continues to work towards launching India's first crewed space mission, showcasing the country's growing capabilities in component ensuring a exploration.

### Bihar Battle: Tejashwi Yadav Named CM Candidate, Mukesh Sahni Deputy

The Opposition INDIA bloc on Thursday officiallv announced Rashtriya Janata Dal (RJD) leader and former Deputy Chief Minister Tejashwi Yadav as its Chief Ministerial candidate for the forthcoming Bihar Assembly elections. The announce ment was made at a joint press conference held in Patna, attended by representatives of all alliance partners.

Senior Congress leader Ashok Gehlot, who is also the senior observer for the Bihar polls, declared the decision. vironmental care. Preparations are already underway, with the festival scheduled to begin in the first week


### **Rifts Emerge Between Congress and National Conference Ahead of J&K Rajya Sabha Poll**

Tensions have surfaced between the Congress and National Conference (NC) in Jammu and Kashmir ahead of the upcoming Rajya Sabha elections, with the Congress accusing the NC of "betrayal" and refusing to participate in a joint legislative party meeting called by NC leader Farooq Abdullah. The meeting took place ahead of the Assembly session starting Thursday and the voting for four Rajya Sabha seats scheduled for Friday.

The Congress has kept the NC waiting on its role in the Rajya Sabha elections after opting out of the Upper House race as well as a bye-election for Jammu's Nagrota Assembly seat. In both instances. the Congress declined the

NC's offers to collaborate. The rift deepened when the NC announced three candidates for the Rajya Sabha polls, leaving only one seat for the Congress. However, Congress leaders labeled the fourth seat as "unsafe" — indicating



that seat. Senior Congress leaders accused the NC of reneging on a promise made to Sonia Gandhi to ensure

Congress would secure a "safe seat." This perceived breach of trust has heightened tensions between the allies.

These developments come at the start of a crucial Assembly session and present a political challenge for Chief Minister Omar Abdullah. Abdullah has appealed to both his ally, the NC, and rival party People's Democratic Party (PDP), led by former Chief Minister Mehbooba Mufti, to unite and vote against the Bharatiya Janata Party's (BJP) Rajya

Sabha candidate. Currently, the NC holds 41 MLAs, Congress has six, and six independents support the government. The BJP commands 28 MLAs, while the PDP holds three.

The widening rift within the alliance adds complexity to the political dynamics of Jammu and Kashmir as the Rajya Sabha elections approach.

# 'Spoke to PM Modi'-Trump Claims India to Stop Buying Russian Oil by Year-End

US President Donald Trump has reiterated that India will "stop" buying oil from Russia and reduce imports to "almost nothing" by the end of 2025. Speaking to reporters at the White House on October 22, Trump said the process would take time but expressed confidence following a recent conversation with Indian Prime Minister Narendra

"India, as you know, has told me they are going to stop (buying Russian oil)... It's a process. You can't just stop... By the end of the year, they'll be down to almost nothing, almost 40 percent of the oil," Trump said, praising India for being "absolutely great' on the issue.

China and India re-

main the two largest buyers of Russian crude oil. and Trump also said he would try to persuade China to follow a similar path. He claimed that under previous US administrations, China and Russia were "forced together" but expressed hope their relationship would not remain close.

The announcement comes amid escalating US sanctions targeting Russia's oil industry, aimed at cutting off Moscow's financial resources amid its ongoing war in Ukraine. The US has accused India of helping Russia finance the conflict through its oil purchases.

However, the US-India relationship has been strained recently, especially after the US doubled tariffs on Indian 25% additional duty on Russian crude oil imports. India criticized these measures as "unfair, unjustified and unreasonable.'

Trump also defended his tariff policies, asserting they strengthened the US economy and helped avoid conflicts. He claimed to have helped settle recent military tensions between India and Pakistan by threatening tariffs, a claim India has consistently denied, attributing the ceasefire to direct military talks.

Trump is scheduled to meet Chinese President Xi Jinping later this month at the APEC summit in South Korea, where he plans to discuss ways to end the Rus-



#### **US Vice President Vance Visits** Israel, Says Gaza Ceasefire **Progress Better Than Expected**

JD Vance arrived in cautious optimism about the fragile ceasefire in Gaza that began on October 10, 2025. Speaking during a visit to a civilian and military cooperation center, Vance said the ceasefire is going "better than I expected" after two years of intense conflict between Israel and Hamas.

Vance's visit, his first as vice president, comes amid ongoing questions about the future of Gaza, including Hamas' disarmament, the deployof an ment international security force, and governance after the war. While emphasizing that his trip was not an urgent attempt to shore up the ceasefire, Vance warned that Hamas risks being "obliterated" if it fails to cooperate.

Trump administration Middle East envoy Steve Witkoff also highlighted progress, stating, "we are exceeding where we thought we would be at this time." Jared Kushner, a key architect of the ceasefire, described the complex transition from intense warfare to a peacetime posture for both sides.

# Canada to Reduce U.S. Reliance, **Cut Spending in New Budget**

Canadian Prime Minister Mark Carney announced on October 22, 2025, that his government's first budget will focus on reducing Canada's economic and security dependence on the United States while cutting wasteful spending. Speaking in Ottawa ahead of the 2025 budget release, Carney declared an end to the decadeslong trend of ever-closer economic integration with the U.S.

Carney, who took office in April, emphasized that the uncoming budge et will strike a balance between austerity measures and significant investments aimed at strengthening Canada's economy. The goal is to shield the nation from growing risks linked to U.S. protectionist policies, which Carney de-



scribed as a looming

safeguarding our economic sovereignty," Carney said. "We will invest wisely but also eliminate wasteful expenditures to ensure long-term stability."



#### **Indian-Origin Historian Sunil** Amrith Wins British Academy **Book Prize**

Indian-origin historian Sunil Amrith has won the prestigious British Academy Book Prize for his latest work, The Burning Earth: An Environmental History of the Last 500 Years. The award, worth £25,000, was presented at a ceremony at the British Academy in London on October 22,

Amrith, a Yale University history professor born in Kenya to South Indian parents, grew up in Singapore and studied at the University of Cambridge. His book offers a sweeping global history that links human events with environmental change, shedding light on the roots of today's climate crisis.

Judges praised The Burning Earth as "important reading" amid ongoing climate concerns. The chair of the judging panel, UK historian Professor Rebecca Earle, called the book a "magisterial account" vividly detailing how colonization, industrialization, and shifts in human settlement have shaped the modern world while also driving environmental damage.

Speaking via live

video from the US, Amrith said the book is not meant to be bleak but hopeful, highlighting "paths not taken" and sustainable ideas from history that could inspire a better future. "Perhaps we can find seeds of inspiration for a more hopeful and less violent way of living together on this planet," he

noted. The British Academy lauded Amrith's decades of research that spans continents and centuries, from the Americas' conquest to British gold mining in South Africa, and from the Black Death to World War II, presenting a fresh perspective on humanity's intertwined fate with the environment.

The prize celebrates non-fiction works that deepen understanding of the humanities and social sciences. Other shortlisted authors included William Dalrymple and Sophie Harman.

Professor Susan J Smith, President of the British Academy, emphasized that Amrith's book combines rigorous research with engaging prose, making it a worthy winner of the international prize.

# **US Sanctions Russia's Top Oil Firms, Oil Prices Surge; India Faces Import Dilemma**

The United States imposed sanctions on Russia's two largest oil companies, Rosneft and Lukoil, marking a sharp policy shift by President Donald Trump amid the ongoing war in Ukraine. The move, announced by the US Treasury on October 23, 2025, led to a 3% jump in global oil prices and has raised concerns in India about its continued imports of discounted Russian

The sanctions aim to curtail Moscow's abilitv to fund its military campaign in Ukraine, now entering its fourth year. US Treasury Secretary Scott Bessent stressed that these measures target Russia's main financial sources fueling the conflict and urged allies to join in adhering to the restrictions.



This decision comes just days after Trump cancelled a planned summit with Russian President Vladimir Putin in Budapest, citing skepticism about achieving meaningful progress. The cancellation underscores the unpredictability of US-Russia relations in the current geopolitical

climate. While oil and gas revenues, accounting for about a quarter of Russia's budget, have already fallen 21% yearon-year, the sanctions focus on export companies rather than direct state revenue sources like output taxes. Analysts predict Russia might deepen discounts on oil exports to offset risks from secondary sanctions, though rising global oil prices could partially cushion the financial blow.

Indian refiners, major buyers of discounted Russian oil following Western sanctions, are reportedly preparing to sharply reduce imports to comply with the new US sanctions. The Treasury has allowed a grace period until November 21 for

companies to wind down dealings with the sanctioned firms.

Meanwhile, the geopolitical tensions persist with Trump reversing his stance to demand an immediate ceasefire in Ukrainean outcome supported by Kyiv but rejected by Moscow. Russia continues to oppose a ceasefire, favoring a negotiated peace settlement that Kyiv views as tantamount to surrender. The conflict's resolution remains uncertain as global powers weigh sanctions and diplo-

matic efforts.

The company revealed this in a stock market filing on Wednesday, October 22, 2025. Infosys plans to buy back 10 crore shares at an average price of 1,800 per share, marking its fifth buyback in the last decade. This significant move reflects the company's strong cash position and confidence in its long-term prospects.

ers — including Sudha Gopalakrishnan, wife of co-founder Kris Gopalakrishnan, who holds the largest pro-

moter stake with 9,53,57,000 shares have chosen not to participate in this buyback exercise. The company

In his petition, Chiranjeevi stated that several organizations were using his name, photos, and even popular titles like "Megastar" and "Chiru" to attract customers and earn profits without authorization. He argued that such actions not only harmed his personal image but also resulted in finan-


