

#### **DNA PROFILING OF THE BUS MISHAP VICTIMS TO COMPLETE BY MONDAY**

The DNA profiling of victims from the tragic Andhra Pradesh bus fire accident will be completed by Monday, according to local officials. The catastrophic accident claimed the lives of 20 individuals, including 19 bus passengers and a motorbike rider, in the early hours of Friday at Chinnatekuru village of Kurnool district. The incident, which unfolded when a private bus collided with a two-wheeler, left several passengers with burns so severe that their bodies could not be immediately identified.

Pradesh, Oct 25 -In a tragic sequence of accidents on Friday near Chinna Tekuru village in Kurnool district, police have clarified that the rider of the twowheeler involved in the horrific bus fire had died moments before the bus ran over the vehicle. The clarification came after an official investigation and questioning of the pillion rider who survived the incident. According to Kurnool Superintendent of Police Vikrant Patil. the deceased rider. identified as Siva Shankar, died instantly after his motorcycle skidded on the slippery road and hit the divider. The subsequent collision involving a private sleeper bus occurred moments later, after the twowheeler was left on the roadway."While approaching Chinna Tekuru village, the twowheeler skidded and Siva Shankar

# Cyclone Montha Brewing, AP Coast on Alert

ijayawada, Oct 25: A potentially dangerous cyclonic system is brewing in the Bay of Bengal, prompting the India Meteorological Department (IMD) to issue alerts across Tamil Nadu and Andhra Pradesh's coastal districts as it tracks the progression of Cyclone 'Montha', which is expected to make landfall early next week. The developing story has generated widespread concern, with authorities, fishermen, and residents urged to take precautionary measures as the system continues to

intensify. **IMD Issues Alert Over Bay of Bengal** 

On Saturday, the IMD confirmed that a wellmarked low-pressure area situated over the southeast Bay of Bengal had intensified into a depression, the precursor to cyclonic activity. The depression, located approximately 990 km east-southeast of Chennai, is advancing west-northwestward and is anticipated to become a deep depression by Sunday. By Monday morning, it is expected to escalate further into a cyclonic storm officially named 'Montha'. The meteorological forecast indicates that Cyclone Montha will traverse the southwest and adjoining west-central Bay of Bengal, moving in a northwestward direction.

Preliminary models suggest a landfall somewhere between Machilipatnam and Visakhapatnam along the Andhra Pradesh coast, with potential impacts felt from early next week. Precautionary Measures Along Tamil Nadu and Andhra Pradesh CoastGiven the increasing risk, the IMD has directed the hoisting of storm warning cage No. 1 at nine ports spanning Tamil Nadu and Puducherry. This is an important indication of approaching squally weather conditions that threaten safe navigation and fishing operations in the region's coastal waters. Fishermen have been strongly advised to avoid venturing into sea, while coastal inhabitants are being asked to remain vigilant to further developments. The IMD has stressed the possibility of heavy rain, strong winds, and perilous sea conditions coinciding with Montha's landfall, potentially causing disruptions to daily life and physical

infrastructure along

the coast.

Rainfall and Weather Forecasts Across Tamil

Nadu While Andhra Pradesh is expected to bear the brunt of Montha's impact, districts in Tamil Nadu will not be spared from associated weather changes. The Regional Meteorological Centre (RMC). Chennai, has forecast isolated showers with light rain in Chennai, Tiruvallur, Chengalpattu, and Kanchipuram over the weekend. These districts, collectively known as the KTCC region, will see a gradual increase in rainfall intensity as the cvclone

#### **Smartphones May Have Fanned Kurnool Bus Blaze,** Say Police

Preliminary investigations into the devastating bus fire near Kurnool, which claimed 19 lives, have revealed that explosions from hundreds of smartphones stored in the vehicle's luggage cabin may have worsened the blaze. Andhra Pradesh Police and forensic experts found that a consignment of 234 smartphones, valued at around Rs 46 lakh, played a key role in intensifying the inferno that engulfed the Hyderabad-Bengaluru bus early Friday morning.

urnool, Oct 25: The private sleeper bus, operated by V. Kaveri Travels, had started its journey from Hyderabad on Thursday night, heading towards Bengaluru with nearly 46 passengers onboard. Around 3 a.m. on Friday, tragedy struck near Chinnatekur village on the outskirts of Kurnool when the bus hit a two-wheeler that was reportedly lying on the road after a prior accident. The bike got stuck under the bus, and the resulting friction and possible petrol leakage likely triggered the initial fire, officials said. According to survivors, the flames erupted sud-

denly beneath the vehicle before rapidly spreading to the pas-

senger cabin. Many passengers reported hearing a series of loud explosions as the fire intensified. Investigators believe that these explosions came from the lithium batteries of the smartphones packed in the luggage hold beneath the seats. The heat generated by the fire would have caused the batteries to overheat and explode, adding fuel to the already raging

#### **What's The Mystery Behind Kurnool Bus Mishap**

**Investigation Reveals Key Chain of Events**

ijayawada, Oct 25: The Kurnool bus tragedy that shocked the Telugu states earlier this week has finally yielded critical answers, as police investigators have pieced together the sequence of events leading to the horrifying accident that claimed 19 lives. Kurnool District Superintendent of Police, Vikrant Patil, on Saturday revealed that the fatal collision stemmed from a series of tragic mishaps involving a motorcycle and a private travel bus. According to the official investigation.

the mishap occurred on National Highway-44 between Chinnatekur and Chettlamallapuram villages

in Kallur Mandal. Preliminary reports indicated that a Vemuri Kaveri Travels bus, carrying passengers from Hyderabad to Bengaluru, collided with a motorcycle late in the night. The impact triggered a massive fire that engulfed the bus, reducing it to ashes within minutes and resulting in the deaths of 19 passengers on the spot. The unfortunate motorcyclist, identified as Shiva Shankar of Laksh mipuram

"During the investigation, we identified the deceased motorcyclist as Shiva Shankar and the pillion rider as Erriswamy alias Nani," SP Vikrant Patil told media representatives, "Both had left their native Lakshmipuram village around 2 a.m. on a Pulsar bike heading towards Tuggali. At about 2:24 a.m., they stopped near a petrol bunk beside the Kia showroom and refu-

eled with ₹300 worth of petrol. Shortly afterward, while proceeding towards Chinnatekur, their bike skidded and struck a road divider. "SP Patil further elaborated that the crash proved fatal for Shiva Shankar, who sustained

severe head injuries. Erriswamy, however, managed to survive with minor wounds. "While Erriswamy was attempting to move his injured companion and drag the damaged motorcycle to the roadside, a speeding bus approached from behind and hit the vehicle. The bike got trapped under the front section of the bus and was dragged for several meters, causing sparks and igniting a fire. Within moments, the flames spread rapidly, engulfing the entire bus," he explained.

The survivor, Erriswa my alias Nani, reportedly fled the scene in panic, fearing for his life and shock-stricken by the explosion. He later returned home to Tuggali village, where he was traced by the police during their probe. His statement proved vital in reconstructing the complete sequence of events. Based on his account and CCTV footage retrieved from the nearby highway stretch, officers were able to confirm that the fire was accidental and not caused by any mechanical fault in the

The Ulindakonda Police have registered a case and are continuing further inquiries, including forensic examination of the burnt bus and remnants of the motorcycle. Investigators are also checking whether the bus's safety protocols, such as emergency exits and fire-safety equipment, complied

#### RIDER DIES BEFORE BUS TRAGEDY IN

DNA Profiling Underway for Charred VictimsDistrict Collector A Siri, addressing the media on Saturday, confirmed the scale of the tragedy and outlined ongoing efforts to identify those who lost their lives. "Samples from 19 bodies were collected and promptly sent to the Forensic Sciences Laboratory in Vijayawada. I am informed that DNA profiling will take about 48 hours, so we expect completion by October 27." Siri stated. The gravity of the fire was such that the remains were described as being "completely charred and black, with only the trunk part left in most cases," explained the collector. As such, scientific DNA profiling became the only viable method for establishing the identities of the deceased. Without this pro-

#### **Coordination with Victims' Families**

According to the district administration, relatives of 16 victims have arrived and provided DNA samples, while family members for two additional victims are expected to reach Vijayawada for the same purpose. Notably, one body remains unclaimed, further complicating identification and handover procedures. "We are making all necessary arrangements. including ambulances and vehicles, so that as soon as the results are available, we can ensure swift and dignified transportation of the bodies to their respective hometowns," Collector Siri assured. Currently, all bodies are being preserved at the Kurnool Government General Hospital (GGH) to await identification and the arrival of associated families.

#### **Factors** Aggravating the

Preliminary official findings have shed light on the potential causes behind the ferocity of the fire. A consignment of cell phones stored in the luggage rack reportedly intensified the blaze. "I saw a few boxes of unburnt cell phones,' noted Collector Siri during her visit. Adding to the complexity. Kurnool Superintendent of Potors played a role in ensuring the fire spread rapidly and proved fatal. "The bus batteries, presence of flammable furnishings in the bus, and the cargo consisting of cell phones all aggravated the fire leading to the tragic event," Patel said in a previous

statement. These findings point to the hazardous mix of combustible materials that made rescue and escape difficult for many inside the vehicle.Survivors and Scene ResponseOut of a total of 44 bus passengers, multiple individuals managed to escape the burning vehicle, though the number of injured and the extent of injuries was not detailed in the official statement. Rescue teams, police, and local authorities coordinated to evacuate survivors and manage the aftermath, moving bodies first to the hospital and subsequently to Vijayawada for forensic procedures.

The Kurnool bus accident stands as one of the most devastating recent tragedies in Andhra Pradesh, highlighting the urgent need for stringent safety standards and scrutiny of cargo and passenger vehicles. As families await DNA results to lay their loved ones to rest, officials continue the difficult task of piecing together the full sequence of events, underscored by the combined grief and resolve of an affected community.

He died on the spot, but the pillion rider. Erri Swamy, survived with minor injuries. SP Patil said in an official press release. "The bus did not hit the two-wheeler from behind, as initially believed. It ran over the motorcycle after the first accident had al-

ready taken place. "Nineteen passengers aboard the private sleeper bus lost their lives after the vehicle caught fire following the impact. Dozens of others suffered burn injuries and were rushed to nearby hospitals for treatment. The bus, en route from Hyderabad to Bengaluru, was completely gutted in the incident. Fresh details from police investigations suggest that the catastrophe was set off by two back-to-back accidents, both happening within moments.

The first involved the motorcycle skidding and crashing, and the second occurred when the speeding bus unintentionally ran over the fallen vehicle, leading to an explosion and massive blaze.Police said the survivor, Erri Swamv. provided crucial information that helped piece together the correct sequence. Swamy and Shankar had departed from Lakshmipuram village around 2 am on Friday, with plans for Shankar to drop Swamy at Tuggali village. On their way, they stopped at a

petrol bunk near the

Kia car showroom around 2:24 am to refuel, spending ₹300 on petrol a short halt that was captured in CCTV footage and later went viral on social media. Shortly after they resumed their journey, the heavy rain that had drenched the area left the road surface wet and muddy, causing the two-wheeler to

lose control. "When Swamy pulled Shankar from the middle of the road and checked his breath, he realised Shankar had died on the spot. As he was trying to move the bike aside, the bus rushed in and ran over it, dragging it for some distance," SP Patil said. Following the twin accidents and the bus fire, Swamy, reportedly in shock, fled to his native Tuggali village. Police later traced him and recorded his statement. The Kurnool district police have launched further investigations into the tragedy, including technical assessments and inspection of CCTV footage from the

surrounding area. Authorities are also examining whether poor visibility, excess speed, or negligence contributed to the bus driver's inability to avoid the motorcycle on the road. The devastating double accident has left local residents in shock and raised concerns about road safety and emergency response infrastructure on the busy highway.

Four teams have been tasked specifically with determining the nature of the explosions, while two teams are performing chemical analyses of the debris collected from the accident site. Authorities

are also investigating the identity of the bike rider allegedly involved in the initial collision. According to the bus

driver, the motorcycle appeared to have already been involved in an accident before the bus ran over it. The deceased were identified as residents of Andhra Pradesh, Telangana, Karnataka, Tamil Nadu, Odisha, and Bihar, while one victim remains unidentified. The government has announced financial assistance to the victims' families and assured strict action against any parties found negligent in this shocking tragedy.

### CM & Lokesh Foreign Trips Only To Hide Loot: T Chandrasekhar

As the political atmosphere intensifies in Andhra Pradesh, Yerragondapalem MLA Tatiparthi Chandrasekhar has unleashed a scathing attack on Telugu Desam Party (TDP) Chief N. Chandrababu Naidu and his son Nara Lokesh, qu estioning the very intent of their ongoing foreign tours. Addressing the media at the YSR Congress Party (YSRCP) central office in Tadepalli, Chandrasekhar alleged that the duo's international visits have nothing to do with attracting investment to the state but are instead "pleasure trips" meant for concealing ill-gotten gains.

Chandrasekhar did not mince words, claiming, "Chandrababu and Lokesh are now enjoying abroad under the guise of investment promotion tours after having looted public money for 17 months." He further criticized the TDP for its alleged indifference to the plight of Andhra Prad esh's farmers, who are currently battling hardship brought on by untimely rains. "While our farmers are suffering, the government is ignor-

ing their distress," he

added, targeting both the TDP's past administration and current narra-

tives on development. Taking forward his barrage, Chandrasekhar described Naidu as a "master of credit theft". accusing the TDP chief of habitually taking cred it for projects initiated by Chief Minister YS Jag an Mohan Reddy. "Chandrababu failed to bring even half a rupee of investment during his own tenure, yet he never hesitates to claim ownership over every achievement made under YSRCP's leadership," he said. He went on to recall several high-profile promi ses made during the TDP regime, including claims of investments from glob al giants such as Airbus, Alibaba, Lulu Group, an d Saudi Aramco between 2014 and 2019.

Highlighting the hollowness of these claims, Chandrasekhar pointedly stated, "Not a single project materialized. Even his much-publicized Dubai visits, which were supposed to usher in 4.39 lakh crore in investments, ended up being empty hype."The MLA went further to bring up the Google Data



Center project established in Visakhapatnam, affirming that the vital IT infrastructure was conceived and executed during the YS-RCP's tenure, with key collaboration from Adani Group, Google, and Airtel. "Naidu deliberately hid Adani's involvement in the project, fearing that the credit would inevitably go to Jagan Mohan Reddy," Chandrasekhar alleged.

Under YSRCP, the Vizag Data Center is projected to bring in investments worth 87,000 cror e and generate 25,000 direct jobs, positioning Visakhapatnam as a Tier-1 IT hub and a leading destination for global technology companies. Shifting the focus towards Nara Lokesh, Chandrase khar was sharply critical of the former minister's handling of the education sector. Citing recent incidents of student abuse and deaths in Gurukulam schools, as well as troubling reports of surveillance practices in girls' hostels, he accused Lokesh of both mismanagement and apathy.

"No meaningful action has been taken in response to serious lapses in student safety," he asserted. Chandrasekhar concluded his attack by challenging the TDP's oft-touted "vision." He

questioned why, despite Amaravati being promoted relentlessly by Naidu, no major companv has chosen to invest there, while industries are flocking to Visakh apatnam under Jagan Mohan Reddy's stewar

"Chandrababu is at his peak in propaganda and credit theft, but the weakest in governance and integrity," he said. The remarks from the Yerragondapalem MLA underline the deepening rift between the YSRCP and TDP camps, even as Andhra Pradesh navigates economic challenges and developmental aspirations.







## CHECKS ON PRIVATE BUSES IN AP - 289 CASES BOOKED

#### **Statewide Drive** by Transport department

TPN | Vijayawada, Oct 25: In a swift response to the recent Kurnool bus tragedy, the Andhra Pradesh Transport Department has launched an extensive statewide enforcement drive to improve passengersafety and ensure compliance with transport regulations. The initiative, directed by the Transport Commissioner, aims to scrutinize the safety and operating standards of all private travel buses across the state. As part of the special drive, transport officials carried out surprise inspections across every district, focusing on



ters such as roadworthi-

critical safety parame- ness, fire safety equipment, and passenger

documentation. During the statewide checks, as many as 289

registered against pri- buses operating without vate travel operators for non-compliance with mandatory safety norms. Authorities also seized 18 buses found to be in serious violation and imposed fines amounting to 7.08 lakh. Eluru district topped the list with 55 cases and three bus seizures, highlighting widespre ad irregularities in the region's private transport sector. East Godavari followed with 17 cases and four seizures. while Konaseema recorded 27 violations.

Chittoor reported 22 cases, Kurnool 12, Visak hapatnam 7, and Nandyal 4, reflecting a pressing need for stronger enforcement statewide. Officials noted several recurring safety lapses during the inspections. These included eight

valid certificates, 13 lacking emergency exits, and 103 without functional fire extinguishers. Another 34 vehicles failed to maintain accurate passenger lists, while 127 other cases were registered for operational and maintenance deficiencies ranging from poor vehicle upkeep to missing documentation.

Transport authorities emphasized that the enforcement drive would continue daily across the state until complete adherence to safety standards is ensured. They reiterated that strict legal and financial action would be taken against any operator who neglects the prescribed guidelines or compromises passenger safety.In a statement, deminded private travel operators of their responsibility to maintain well-equipped vehicles with all mandatory safety gear, update passenger registers accurately, and secure valid fitness and roadworthiness certifications.

They added that negligence or violations would invite severe penalties, given the department's commitment to public safety and accident prevention. The **Transport Department** assured that its intensified checks are not punitive alone, but part of a broader safety reform effort meant to instill accountability among private travel operators and reduce the risk of avoidable road tragedies across Andhra

## RPF VIJAYAWADA EXCELS IN CRIME DETECTION

#### **Passenger** Safety and Rescue Operations.

TPN / Vijayawada, October 25 The Railway Protection Force (RPF) of Vijayawada Division, South Central Railway, has set a remarkable benchmark in crime detection, passenger safety, and humanitarian service through a series of successful operations carried out from October 16 to 23, 2025. The week-long period showcased the RPF's efficiency, vigilance, and commitment to the safety of passengers as well as the protection of railway property. Under Operation Satark, aimed at curbing the transport of contraband and illegal goods through railways, RPF Vijayawada, in co-



ordination with Customs and CPSR officials, intercepted a major smuggling attempt on October 21. The team seized 48,000 foreign brand cigarettes, ESSE Lights of KT&G Korea worth 4.8 lakh.

The consignment, fals ely declared as "Micro Coffee", was booked fro m Dimapur to Vijayawada. The goods were con-



sions of the Customs Act, 1962, marking a significant strike against smuggling activities on railway routes. Safety and crime detection efforts under Operation Yatri Suraksha also produced notable successes across several stations in the division. In Kakinada, a chain-snatching case reported on October 21 was swiftly detected, leading to the arrest of Galeri Dora Babu (37) and recovery of gold worth 16,000. In a separate operation at Tenali on October 18, RPF and GRP teams apprehended four members of the notorious OG Kuppam attention diversion gang, recovering 50 grams of gold and eight stolen mobile phones together valued at 6.6 lakh.

RPF Vijayawada tea ms demonstrated their prompt action again when they solved a chain-snatching case on



Train No. 17209 within just 12 hours. The accused, Ravuri Nagaraju (25), was arrested and gold jewellery worth 1.10 lakh was recovered. At Kavali, two mobile theft cases reported on October 18 were successfully cracked, leading to the recovery of the stolen devices worth 35.000. Beyond crime control, RPF personnel showed exemplary humanitarian service under Operation Nanhe Farishtey, aimed at rescuing and rehabilitating missing or runaway children.

On October 22, Constable P. Venkatamma rescued a nine-year-old mi ssing boy at Tuni, while Constable K. Venkatesh located a 16-year-old runaway boy at Bapatla a day earlier. Both children were safely handed over to child welfare authorities, reflecting RPF's compassionate approach alongside its law

enforcement role.In another major breakthrough, a joint RPF-GRP team at Gudivada nabbed Goriparthi Siva Koteswara Rao (37), a wanted robbery suspect, on October 23rd.

## CS DIRECTS COLLECTORS TO BE VIGILANT DURING 'MONTHA'

tober 25: Andhra Pradesh Chief Secretary K. Vijayanand on Saturday conducted an intensive review with district collect ors and key officials via teleconference to assess the preparedness across coastal districts in view of the approaching Cyclone 'Montha', expected to make landfall near Kakinada on October 28. Addressing the collectors, the Chief Secretary emphasized the need for heightened vigilance and immediate readiness to tackle any emergency situation arising from the impending cyclone.

Calling for proactive and detailed preventive measures, he instructed all district administrations to ensure the protection of human lives

property through timely action and coordination. Vijavanand directed that control rooms be set up in every mandal to coordinate local-level responses, monitor field updates, and act swiftly in case of distress calls. He said that all villagelevel officials and staff must remain on constant alert, particularly in vulnerable coastal and lowlying areas, so that evacuation and relief operati ons can be executed with out delay when requ The Chief Secretary

advised officials to identify and stockpile essential commodities such as milk, vegetables, food grains, candles, and other civil supplies at strategic locations. He underensuring uninterrupted access to these items, es pecially in regions likely to face power disruptions or transportation difficulties once the cyclone approaches land. Vijayanand directed that all cyclone shelters and temporary relief camps be prepared and kept ready to accommodate evacuees safely and comfortably. Local authorities were instructed to ensure that drinking water, sanitation, and firstaid facilities are functional in these shelters. The Chief Secretary

highlighted that special attention must be given to vulnerable populations, including the elderly, children, and pregnant women, particula rly those residing in low-



lying or flood-prone "Lanka" villages. He instructed that such women be shifted to nearby government health centres well in advance as a

precautionary measure. Ensuring infrastructure resilience, Vijayanand called upon officials of the Energy Department to maintain uninterrupt-

critical installations and residential areas. He stressed the need for quick restoration of electricity in the event of diate removal of fallen trees and debris to keep roads clear for emergency vehicles and repair

Coordination with the Roads and Buildings Department and emergency response agencies was deemed essential for maintaining smooth logistics. The Chief Secretary also directed coordination with telecom service providers to ensure continuity in mobile network connectivity, enabling uninterru pted communication during and after the cyclone. Further, water resources officials were instructed to monitor all major and minor water bodies, tanks, canals, and rivers continuously

overflow that might lead to flooding.

Necessary flood control arrangements were to be put in place wherever required. Vijayanan d reiterated that fishermen should not venture into the sea under any circumstances until further notice and urged the general public to restrict unnecessary travel and remain indoors as the cvclone nears landfall. He informed that the State Disaster Management Authority (SDMA) and the India Meteorological Department (IMD) would continue issuing realtime alerts, and all departments must remain on the highest level of preparedness until the cyclone threat fully

## **RUDA Under Fire: Alleged Corruption Sparks Outcry**

Irregularities and **Alleged Corruption** Rajamahendravaram **Urban Development Authority.**

Ch Raju | Rajahmun-dry, East Godavari Oct 25: The Rajamahendravaram Urban Development Authority (RUDA) has recently come under intense scrutiny, with public outcry growing over what many allege is systematic corruption. administrative negligence, and blatant disregard for urban regulations. RUDA, which is supposed to steer development projects and urban planning in various fewparts of East Godavari, is now being called out for allegedly facilitating irregularities that benefit a select while undermining the interests of ordinary citizens.

Repeated complaints suggest that certain officials at RUDA, coupled with the perceived indifference of its chairman, have allowed the agency to devolve into a hub for



malpractice. Common allegations revolve around the issuance of approvals and clearances by bypassing established nor ms, sanctioning layouts and constructions contrary to the master plan, and granting permissions without essential clearances such as the Fire NOC. One glaring example concerns a high-rise building near

Ravulapalem, reportedly

of 21 meters.

According to official regulations, any building exceeding 15 meters must possess a Fire Department NOC. However, RUDA authorities are alleged to have manipulated documentation, declaring the structure's height as 15 meters to expedite approvals. Similarly, approval was reportedly granted to a lo-

mandated Fire NOC. Master plan violations are not limited to highrises. In one instance, a 15-acre private layout near Rajamahendravaram was approved with master plan roads 'omitted' from the sanctioned drawings, effectively converting land earmarked for public infra-

structure into a private

layout. Such practices,

critics say, are clear examples of collusion between RUDA officials and real estate interests.

In Madurapudi, a 14acre layout was greenlit even though the mandatory 'change of land use' process had not been completed. Authorities included the land in the master plan and approved the layout in violation of planning guidelines.Questions have

also been raised about key RUDA positions, particularly the Chief Urban City Planner. Despite the official's deput ation period ending, he allegedly continues to make pivotal decisions, with his signature required for most layout clearances and building permits. Many view this as evidence of undue influence and lack of oversight. These systemic issues have had a direct impact on citizens. While ordinary people wait for months to obtain permissions for individual house plans, large-scale layouts receive overnight approvals. There are also allegations of the authority neglecting government revenue generation by waiving applicable fees and charges, to the benefit of select developers and intermediaries.

Calls are mounting from local residents and urban planning experts for a comprehensive probe into RUDA's operations. They insist that agencies like the Vigi-

ment must intervene to restore public trust. Experts warn that unless RUDA acts transparently and eliminates corruption and political interference, the very prospects of sustainable urban development for Rajamahendravaram and its surroundings cou ld be doomed.In response to these allegations, Chief Urban Planner GVSN Murthy offered inconsistent explanations, claiming ignorance of unauthorized approvals and urging that details be collected from Panchayat offi cials. He insisted that no illegal layouts had received per missions during his tenure. Nonet heless, public perception remains skeptical, especially sin ce major irregularities reportedly escalated after Boddu Venkataramana Chow dary assumed charge as RUDA chairman. As public disillusionment grows, many now view RUD A not as a beacon of urban progress, but as a symbol of compromised integrity in local governance.

"The government will review the committee's recommendations with Chief Minister N. Chandrababu Naidu and take decisions aimed at permanently settling the Service Inam Land issues that have remained unresolved for decades," he said. The GoM meet- noted that the govern-

isters P. Narayana, Payya vula Keshav, and NMD Farooq, along with senior officials from the concerned departments. A separate session of the GoM later focused on the "Houses for All" initiative, which discussed strategies to ensure affordable housing for all eligible families and streamline land allocation for various purposes, including housing, industry, and social de-

ment is also formulating a new and transparent policy for land allocation catering to industrial, infrastructural, and developmental needs. He emphasized that Chief Minister Naidu and Minister Nara Lokesh are making concerted efforts to attract industries and investments to Andhra Pradesh by creating a predictable and investorfriendly environment. "We are also addressing issues related to pre-hold lands and Wagf properties to ensure procedural clarity and avoid future

legal complications," he

Expanding on housing progress, Urban Development Minister P. Narayana highlighted that during the previous TDP government (2014– 19), plans were made to construct seven lakh TIDCO houses equipped with full amenities, and administrative sanction was given for five lakh units. He criticized the subsequent YSRCP administration for scaling down the target to 2.6 lakh houses, many of which remained incomplete. Minister Narayana said that under the current leadership, Chief Minister Naidu has directed officials to complete all 2.6 lakh TIDCO houses by June 2026, reaffirming the government's commitment to providing homes for the

# Injured as TSRTC Bus **Collides** with Lorry in Palnadu

The mishap oc-curred as the bus was traveling from Miryalaguda to-

wards Dachepalli. According to preliminary reports, the TSRTC bus carrying 45 passengers was proceeding on the Miryalaguda, Dach epalli route when a speeding lorry coming from the opposite direction sudden ly lost control and ra mmed into the bus. The impact of the collision caused significant damage to the front sides of both vehicles and left several passengers with minor injuries. Local residents quickly alerted the police and emergency services. Dachepalli police reached the scene promptly, providing initial assis-

and ensuring smooth traffic flow on the busy route.

The injured passengers were immediately shifted to a nearby government hospital for medical treatment. Fortunately, no fatalities were reported, and doctors confirmed that the injuries were not life-threatening. Police officials stated that an investigation is underway to determine the exact cause of

the crash. They suspect that over-speeding and possible negligence by one of the drivers could have led to the collision. ## **AP CM HOLDS EMERGENCY MEETING ON** MONTHA, ORDERS QUICK ACTION

TPN | Vijayawada, Oct 25: Andhra Pradesh Chief Minister N. Chandrababu Naidu on Saturday convened an emergency teleconference with District Collectors, Superintendents of Police, and senior officials to review the state's preparedness for the approaching Cyclone 'Montha'. With the India Meteorological Department (IMD) issuing a Red Alert for the state, the Chief Minister directed all departments to stay fully alert and make arrangements to ensure that there is no loss of life or property. According to the IMD forecast, Cyclone 'Montha' is expected to make landfall near Kakinada on the evening of October 28 as a severe cyclonic sto rm, with wind speeds ranging between 90 to 110 kmph.

The cyclone is likely to have a widespread impact, affecting dis-



tricts from Srikakulam to Tirupati, and is expected to bring heavy rainfall ranging from 80 to 100 mm across coastal and nearby regions. With this prediction, the Chief Minister has instructed officials to take precautionary steps on a war footing. During the high-level

review, Naidu empha-

sized the need for meticulous district-level contingency planning, immediate readiness of disaster response tea ms, and pre-emptive evacuation of residents from vulnerable coastal

He stressed that officials must act swiftly and coordinate seamlessly to minimize dam-

the cyclone crosses the coast. "Our top priority is the safety and security of people. Every measure should be taken to avoid casualties and damage to infrastructure," he said. The Chief Minister directed the district administrations to identify and prepare shelters for evacuees, ensure proper food and water arrangements, and keep emergency services operational round-theclock. He also advised Collectors to declare holidays for educational institutions in cyclone-prone zones if necessary, ensuring student safety.

Naidu instructed the irrigation department to closely monitor reservoir and dam water levels, carry out scientific release of water where needed, and share real-time updates with relevant control rooms. He also told the

power and communication departments to ensure immediate restoration mechanisms in case of disruptions. Department heads of Roads & Buildings (R&B), Power, Irrigation, Panchayat Raj, and Municipal Administration were asked to function uninterruptedly and coordinate with local teams for rapid response.

In an innovative step, Naidu suggested launch ing "Hospital on Whee ls" services in Kakinada to provide essential medical support to people in affected areas, particularly in cases where hospital access may become difficult. He said the deployment of NDRF and SDRF teams must begin immediately to vulnerable stretches, ensuring that rescue and relief efforts could commence without delay once the cyclone system nears the coast. The Chief Minister further directed that in-charge senior officers be stationed in each cyclone-affected district to oversee coordination between departments, streamline relief operations, and supervise post-cyclone restoration activities. He underscored that

maintaining uninterrupted drinking water, electricity, mobile connectivity, and supply of essentials must be treated as top priorities. Naidu concluded the meeting by cautioning officials not to take any chances and to ensure continuous communication between state and district-level control rooms. With Cyclone 'Montha' intensifying in the Bay of Bengal, the Chief Minister's proactive review has set the state machinery in motion for a comprehensive preparedness exercise across Andhra Pradesh's coastal belt.




## Centre Drafts India's First Al Regulation To Curb Deepfakes, Tighten Social Media Oversight

In a landmark move, the Union Government has initiated steps toward enacting India's first substantive Artificial Intelligence (AI) regulation, aimed at curbing the spread of deepfakes and synthetic media on social platforms. On October 22, the Ministry of Electronics and Information Technology (MeitY) issued draft amendments to the Information Technology (IT) Rules, 2021, proposing a detailed framework to govern the creation and circulation of AI-generated content online.

The new draft rules come amid global concerns over the misuse of generative AI tools capable of producing text, images, audio, and videos that mimic real people or events. The amendments propose that social media companies and any digital services facilitating AI-generated content must label, watermark, or embed metadata to help users identify synthetic material.

According to the draft, such content must be visibly labelled, with at least 10% of the display area carrying a clear warning. In addition, major social media platforms would need to obtain and verify user declarations whenever synthetic or AI-altered content is uploaded.

The proposals are in line with international developments — China already mandates clear labels on AI-generated media, while the European Union's AI Act requires disclosure of deepfakes. India's initiative appears to follow a similar model of assertive digi-



tal governance while balancing innovation and accountability.

Erosion of Safe Harbour Protections

The most significant change, however, lies in the redefinition of "safe harbour" — the legal immunity enjoyed by intermediaries for user-generated content. Under the new draft, platforms can remove AI-generated content

based on user complaints, even without a court or government order. This marks a shift from India's long-held "passive conduit" model, where platforms were not responsible for deciding what constituted illegal or harmful content.

Experts warn this could lead to over-censorship, as companies might prefer deleting content to avoid regulatory penalties. The move also dilutes the "actual knowledge" standard established in the 2015 Supreme Court judgment in Shreya Singhal v. Union of India, which placed the responsibility for determining illegality on the government and courts rather than intermediaries.

"This change effectively turns social media platforms into arbiters of free speech," a digital rights lawyer said, adding that it may create tension between government expectations, user freedoms, and corporate accountability.

#### **Implementation Challenges**

While the draft seeks to enhance online transparency, experts caution that labeling AI content at scale will be technologically and operationally complex. Automated systems may fail to detect

some synthetic content or mistakenly label genuine posts, leading to confusion and misinformation.

To address these challenges,

To address these challenges, analysts suggest adopting global technical standards such as those from the Coalition for Content Provenance and Authenticity (C2PA), which establish traceable origins for digital content. Additionally, the government is being urged to complement the labeling mandate with public awareness and media literacy campaigns to help users identify manipulated media.

#### Balancing Regulation and Innovation

The draft's release coincides with India's growing optimism toward AI, highlighted by the upcoming AI Impact Summit 2026. However, critics argue that overly stringent controls could stifle innovation and mimic China's tightly controlled digital ecosystem rather than democratic models of governance.

Policymakers emphasize that the proposed measures are open for public consultation, reflecting an attempt to balance the need for accountability with freedom of expression and technological

If enacted, the new framework would mark India's first major legal step toward AI governance, positioning the country among a select group of nations actively regulating synthetic media — a crucial move as the digital future grows increasingly artificial.

# Pakistan's Decades-Old Terror Playbook: Target Hindus to Divide India



For more than four decades, Pakistan's Inter-Services Intelligence (ISI) has followed a grimly predictable playbook using terrorism as a weapon to weaken India from within. Since the 1980s, the ISI has deployed terror proxies to attack Hindus in India, hoping to provoke communal retaliation and internal instability. The ultimate aim: to vindicate Pakistan's founding ideology, the two-nation theory, by showing that Hindus and Muslims cannot coexist peacefully.

The strategy's origins date back to the post-1979 era, when Pakistan became a key U.S. ally during the Soviet invasion of Afghanistan. The West, along with Saudi Arabia, empowered Pakistan's military and intelligence establishment to use jihad as a tool of warfare. The ISI soon redirected this strategy toward India, framing Hindus as "infidels" and backing extremist groups that would strike at the country's religious and cultural heart.

The first major manifestation of this plan appeared in Punjab in 1980–81 with the rise of Jarnail Singh Bhindranwale. Initially targeting rival Sikh groups and police, his men soon began attacking Hindus. The Dhilwan bus massacre of October 1983, where six Hindus were singled out and killed, marked the first targeted communal terrorist attack in modern India. It shocked the nation and led Prime Minister Indira Gandhi to impose President's Rule in Punjab.

From there, the pattern spread and intensified. Between the 1980s and 2000s, ISIbacked groups—from Khalistani militants to Lashkar-e-Taiba and Jaish-e-Mohammed—launched over a hundred attacks specifically targeting Hindus and Hindu places of worship. These included the Lalru (1987, 38 dead) and Fatehabad (1987, 34 dead) bus massacres, Ludhiana train killings (1991, 125 dead), Coimbatore bombings (1998, 58 dead),

Amarnath Yatra attacks (2000, 21 dead), Raghunath Temple assaults (2002, 26 dead), and the Akshardham Temple attack (2002, 33 dead).

The Indian Mujahideen, formed later with ISI support, carried out serial blasts in Delhi (2005, 62 dead) and Jaipur (2008, 63 dead). The purpose was not merely to kill but to provoke Hindu retaliation against Muslims—pushing India toward internal communal conflict.

Analysts note that the ISI's long-term goal has been to present India as a country divided by religion, thereby justifying Pakistan's creation. This is why Pakistan's leaders, including current Army Chief General Asim Munir, frequently invoke religious narratives and accuse India of persecuting minorities.

India's response, however, has evolved. Leaders across ideological lines, from Prime Minister Narendra Modi to AIMIM chief Asaduddin Owaisi, have avoided communal language even in the face of provocation. The RSS, too, described recent attacks as assaults on "tourists" rather than "Hindus," signaling restraint and unity. Owaisi's harsh condemnation of terrorists as "kameene" and "haramzaade" reflects an effort to show solidarity across communities.

The ISI's strategy—what experts call "Subversion 101"—has repeatedly failed. Despite the pain inflicted, India has resisted turning on its own people. Even during the 1993 Bombay bombings, then Chief Minister Sharad Pawar's quick action in controlling communal tension prevented a nationwide crisis.

As Pakistan's internal stability crumbles, its attempts to export unrest to India continue. But after 45 years of provocations, India's resilience stands firm. The challenge now is to ensure that the old Pakistani playbook—designed to divide—fails yet again.



### Trump Effect: How America's Tough Talk Could Spark India's Next Reform Wave

He has chastised allies in Europe, Canada, Mexico — and India — over trade, defense, and tariffs. For New Delhi, this renewed Trump-era assertiveness feels like a gun pointed at its head. But as history shows, India often reforms best under pressure.

India's two previous waves of deep economic reform were born of crisis. The first came in 1991 when a balance of payments emergency forced Prime Minister P.V. Narasimha Rao and Finance Minister Manmohan Singh to seek an IMF bailout. That external compulsion dismantled decades of socialist controls and opened the Indian economy. The second came after the Pokhran-II

Trump's renewed pressure, particularly on trade and tariffs, could provide the third such moment. For India, this may be a catalyst to confront long-standing inefficiencies, improve competitiveness, and deliver on the "Make in India" promise that has struggled to take off.

Reforms during past crises did not come easily. In the 1990s, powerful corporate lobbies like Rahul Bajaj's "Bombay Club" resisted liberalisation, arguing that Indian industries were not ready to face global competition. Rao held firm, citing the IMF loan as an unavoidable necessity. The result was transformative — creative destruction that cleared space for modern, competitive enterprises. Legacy companies like Hindustan Motors and Premier Automobiles faded, while the likes of Tata and Mahindra

thrived in the new era. Similarly, post-Pokhran reforms — ranging from PSU disinvestment to FDI liberalisation and tariff cuts — unleashed a second wave of growth. India's integration into the global economy deepened, and ordinary citizens benefited from new freedoms such as overseas investment under the Liberalised Remittance Scheme.

Since then, however, reform momentum has slowed. India has often fallen back on slogans of being the "world's fastest-growing major economy" rather than confronting structural bottlenecks. The manufacturing revolution repeatedly promised has yet to arrive.

Trump's economic nationalism, though seemingly hostile, could jolt India's political and bureaucratic establishment out of complacency. Just as past "gunsto-the-head" moments created reform breakthroughs, this one might force India to accelerate trade rationalisation, boost exports, and modernise domestic industry.

In the long run, a tough, transactional America might be exactly the partner India needs — not one that flatters, but one that forces reform. Trump's pressure may sting in the short term, but it could push India toward the next phase of its economic transformation.

## PM Modi Endorses Nitish as NDA CM Face, Slams **RJD's 'Jungle Raj'**

Prime Minister Narendra Modi endorsed Bihar Chief Minister Nitish Kumar as the face of the NDA ahead of the Assembly elections, framing the contest as a choice between the "NDA's good governance" and the "RJD's jungle raj." Modi launched the campaign from Samastipur, the ancestral land of late socialist icon and former CM Karpoori Thakur.

"This time, under the leadership of Nitish Kumar, the NDA is going to break all past records of victory," Modi said,

marking his first public endorsement of Nitish for the upcoming polls. The Prime Minister recalled the BJP-JD(U) alliance formation in 2005, which ended Lalu Prasad's 15-year rule in Bihar, emphasizing NDA's

role in bringing stability

and governance to the

Modi accused the Congress-RJD government at the Centre of obstructing Bihar's development in the years following the NDA's rise in the state, claiming they sought revenge for the RJD's 2005 defeat. "It was in October 2005 that Bihar was liberated from 'jungle raj' and began witnessing good governance under Nitish Kumar," he said.

The campaign launch from Samastipur was symbolic, underlining NDA's claim as the "actual inheritor" of Karpoori Thakur's pro-poor and OBC-focused legacy. Modi highlighted the alliance's focus on development and welfare while contrasting it with the RJD's past governance.

The Prime Minister's announcement ends any speculation over Nitish Kumar's future role in the NDA and comes a day after the INDIA bloc named RJD's Tejashwi Yadav as its CM candidate. The election battle is now clearly framed as a contest between continuity under Nitish Kumar and a potential return of RJD's past regime.

The rally drew significant local attention, with NDA leaders emphasizing governance, development, and social justice as the core themes of their campaign strategy.

### "This Government Doesn't **Hide Reports": Delhi Minister To AAP On Yamuna Revival**

Delhi's political discourse heated up on Saturday after the Delhi Pollution Control Committee (DPCC) released a report indicating worsening water quality in the Yamuna River. just ahead of Chhath Puja, when thousands of devotees are expected

to take a holy dip. The DPCC October 2025 report, based on October 9 water samples, revealed that most stretches of the river remain unsafe for bathing, except at Palla, where the Yamuna enters Delhi. Key pollution sources include the city's 27 major drains, many exceeding safe limits for Total Suspended Solids (TSS), Chemical Oxygen Demand (COD), and Biochemical Oxygen Demand (BOD). The Molarband and Sahiba-

bad drains were the worst offenders, with BOD at 145 mg/l and COD at 416 mg/l, nearly five times the permissible limits. Some drains, including Sweeper Colony and Old Agra Canal, had no flow, while only the Abul Fazal drain approached safe levels

Responding to the report, Delhi Water Minister Parvesh Verma defended the BJP-led government, emphasizing transparency and ongoing cleanup efforts. "The difference between samples taken on the 9th and those taken today is like night and day. Women visiting the ghats say they've never seen the Yamuna this clean. This is the result of seven months of hard work," Verma said. He added that the river's revival is part of a threeto-four-year plan, noting visible improvements compared to the past decade.

In contrast, Delhi Aam Aadmi Party President Saurabh Bhardwaj accused the government of politicizing pollution ahead of the Bihar elections. "The Yamuna is neither fit for drinking nor bathing. The BJP is playing with the lives of Purvanchal residents,

The government has set up temporary ghats and deployed sanitation and safety teams for Chhath Puja. Officials also noted water quality improvement after Haryana increased releases from the Hathnikund Barrage on October 21, boosting river flow.

Despite ongoing challenges, the administration maintains that its efforts have brought measurable improvements and continues to focus on long-term river

### Delhi Air Quality Shows Slight Improvement; Anand Vihar Still 'Severe'



TPN Correspondent | New Delhi Delhi's air quality improved slightly on Saturday, though pollution levels remained a concern across the city. The overall Air Quality Index (AQI) was recorded at 261. placing it in the 'poor' category and showing a marginal drop from 290 the previous day, according to data from the Central Pollution Control Board

Despite the slight improvement, Anand Vihar remained the most polluted area, registering a 'severe' AQI of 415, the highest among all monitoring stations in the capital, as per the Sameer app developed by the CPCB.

Seven monitoring stations in Delhi recorded AQI levels in the 'very poor' range, while the remaining stations stayed in the 'poor' category. Experts warn that such pollution levels continue to pose significant health risks, particularly for children, the elderly, and individuals with respira-

tory conditions. The CPCB categorizes air quality on a scale where 0-50 is 'good', 51-

100 'satisfactory', 101–200 'moderate', 201-300 'poor', 301-400 'verv poor', and 401-500 'severe'. While the slight dip in AQI offers minor relief, authorities caution residents to take preventive measures, including wearing masks outdoors, avoiding strenuous physical activity, and using air purifiers indoors where possible.

In response to rising pollution, Delhi authorities have continued efforts such as deploying anti-smog guns, controlling vehicular emissions, and limiting construction activities. Images from the city show antismog guns spraying water along key areas like Kartavva Path, near Rashtrapati Bhavan, in a bid to reduce dust levels.

Environmental experts emphasize that sustained measures and public awareness are crucial to improving air quality in the coming weeks, as seasonal factors like crop stubble burning in neighboring states and weather conditions continue to influence pollution levels in

Early voting opened on Saturday in New York's high-stakes mayoral race, with Democratic candidate Zohran Mamdani emerging as the surprise frontrunner. The 34-year-old state lawmaker, a self-described socialist, has captured widespread attention and energized young voters across the city, positioning himself as a formidable challenger to the political establishment and potential national figures, including former President Donald Trump, who has repeatedly criticized him.

The mayoral contest has seen dramatic twists. The incumbent mayor chose not to seek re-election, leaving a vacuum that reshaped the race. A once-favored Democratic contender also lost in the primaries, opening the path for Mamdani, whose campaign has gained momentum with grassroots support and extensive engagement on social issues important to younger constituents. Analysts note that his rapid rise reflects a growing appetite among New Yorkers for fresh leadership and alternative voices in city politics.

Mamdani's platform focuses on affordable housing, climate action, and expanding social services, which has resonated particularly with progressive voters. His outsider status and hands-on campaign approach—holding rallies, town halls, and social media outreach have amplified his visibility and appeal.

Political observers are also watching closely to see how the race shapes up in a general election that could carry national implications. Mamdani's potential victory would mark a significant shift in the city's political landscape, challenging both traditional Democratic power structures and drawing attention from Republican figures, including Trump, who has repeatedly weighed in on New York politics.

Early voting is expected to continue through the week, with election day set for early November. Campaign teams from all sides are mobilizing volunteers and final messaging strategies, while polls suggest a highly competitive race, reflecting New Yorkers' engagement and the unpredictable nature of the current political climate.

The outcome of this mayoral election could set the tone for future national contests, with Mamdani's rise signaling a potential new chapter in progressive

## Trump Calls North Korea 'Sort of a Nuclear Power'

U.S. President Donald Trump described North Korea as "sort of a nuclear power" on Friday, as he departed for South Korea to attend the Asia-Pacific Economic Cooperation (APEC) Forum. The comment comes amid speculation that Trump could meet North Korean leader Kim Jong Un during his Asia trip.

Asked whether he would consider recognizing North Korea as a nuclear state, a condition Pyongyang has repeatedly demanded for talks with Washington, Trump said: "Well, I think they are sort of a nuclear power." The remarks suggest a pragmatic acknowledgment of Pyongyang's nuclear capabilities while leaving room for diplomatic engagement.

Trump's statements come at a time of heightened attention on North Korea's missile tests and nuclear ambitions. which have drawn global concern. Analysts note that his comments signal a potential willingness to engage in negotiations

## Russian Strikes Hit Kyiv, At Least Eight Wounded



Russian forces launched a series of missile and drone attacks on Ukraine's capital on Saturday, causing damage to buildings and homes across multiple districts and injuring at least eight people, city officials confirmed. Kyiv Mayor Vitali Klitschko

described the situation on Telegram, stating, "Explosions in the capital. The city is under a ballistic attack." Emergency services were deployed immediately to assess the damage and provide medical assistance to the wounded. Several residential buildings sustained structural damage, and authorities have urged residents to stay in shelters and avoid open

The strikes come as the war in Ukraine enters its fourth winter, with Kyiv's Western allies intensifying pressure on Moscow. Recent months have seen increased military and economic support from

NATO countries to Ukraine, along with diplomatic efforts to hold Russia accountable for its continued aggression. Analysts warn that attacks on major cities like Kyiv may aim to undermine civilian morale and test the limits of Ukraine's air defense capabilities.



Local authorities have confirmed that the casualties include civilians caught in residential areas, and the full extent of damage is still being assessed. Hospitals in Kyiv are reportedly treating those injured, while city officials are coordinating with emergency respond-

ers to ensure essential services continue uninterrupted.

This latest strike adds to a string of attacks on Ukrainian cities in recent months, highlighting the ongoing volatility in the region. Kyiv residents have been urged to remain vigilant and follow safety advisories

issued by local authorities.

The international community has condemned repeated attacks on civilian areas, emphasizing that such actions violate international humanitarian law. The Ukrainian government continues to call for increased global support, including ad-

vanced air defense systems, to protect its population and infrastructure.

The situation in Kyiv remains tense as authorities monitor potential follow-up attacks and work to stabilize the city in the aftermath of Saturday's bombardment.

Officials from Pakistan and Afghanistan convened in Türkiye on Saturday for the second round of talks aimed at easing tensions along their shared border and addressing security concerns, including cross-border terrorist activities. The dialogue comes after a brief period of calm was restored following the first round of discussions in Doha on October 19, which was medi-

ated by Qatar and

Türkiye. The talks are focused on finding a negotiated solution to recurring clashes between Afghan and Pakistani forces that have disrupted trade and daily life along key crossing points. Notably, the Spin Boldak border had been closed for nearly two weeks following violent incidents, affecting the movement of goods and creating economic strain for border communities on both sides. Trucks carrying essential supplies have been reported stranded near the closed crossing, highlighting the urgency of a resolution. Officials emphasized

that the Istanbul talks aim to implement practical measures to prevent further escalation and enhance cooperation on counter-terrorism efforts. Both sides are expected to discuss border management, intelligence sharing, and joint patrol mechanisms to reduce misunderstandings and build

The dialogue reflects broader diplomatic efforts to stabilize relations between Pakistan and Afghanistan, two countries with a history of complex crossborder security challenges. The first round in Doha established a framework for continued engagement, and the Istanbul meeting is seen as a step toward operationalising agreements reached earlier.

Observers note that maintaining peace along the border is crucial not only for bilateral relations but also for regional stability, particularly as trade and civilian movement are directly affected by intermittent border closures. Both governments have expressed optimism that sustained dialogue will create a predictable and secure environment, reducing the risk of future clashes and facilitating coordinated action against militant groups operating along the frontier.

The outcome of these talks could set the tone for longer-term cooperation and help mitigate the security and humanitarian challenges faced by border communities.

## US-China Talks Aim to Salvage Trump-Xi Meeting

Top economic officials from the United States and China met on Saturday in Kuala Lumpur to avert a renewed escalation of their trade war and pave the way for a high-stakes meeting between President Donald Trump and President Xi Jinping next week at the Asia-Pacific Economic Cooperation summit in South Korea.

The talks come after Trump threatened to impose 100% tariffs on Chinese goods starting November 1, in retaliation for China's expanded export controls on rare earths and minerals. The dispute has disrupted a fragile trade truce negotiated over four rounds of talks since May between US Treasury Secretary Scott Bessent, US Trade Representative Jamieson Greer. and Chinese Vice Premier He

Officials are focused on finding a compromise on rare earths and US technology export curbs, which remain the core sticking point. Analysts say the meeting must restore an "intermediate ceasefire" in trade tensions to allow Trump and Xi to meet successfully. The truce, initially brokered in Geneva in May, had lowered tariffs on both sides and ensured the flow of critical magnets, but it frayed after the US expanded its export blacklist in late September, affecting



thousands of Chinese firms. China countered with strict export controls on rare earths in early October.

The Kuala Lumpur talks are being closely watched, as any breakthrough could stabilize global supply chains and prevent tariffs from spiraling to triple-digit levels again. US officials are also pressing China to resume purchases of American soybeans and manufactured goods, commitments from the 2020 Phase One trade deal that

were largely unmet. The outcome remains uncertain, with observers warning

that failure to reach a compromise could trigger harsher trade measures, escalating economic tensions with global repercussions. Meanwhile, details about the Malaysian meetings, including the venue and media briefings, remain tightly controlled, highlighting the high-

discussions.

This session is seen as crucial for maintaining at least a temporary truce before the Trump-Xi summit, which could determine the trajectory of US-China economic relations in the coming months.

Shares of Tata Motors opened nearly 40% lower on Tuesday, triggering concern among investors. However, the company clarified that the sharp fall is a technical adjustment following the demerger of its commercial vehicle business.

The stock opened at 399, significantly down from Monday's close of 660.90, bringing the company's market capitalisation to around 1.45 lakh crore. Despite the steep fall, the move does not reflect any erosion in investor wealth, but rather a realignment due to the demerger.

As part of the restructuring, shareholders as of the record date (October 14) will receive one share of Tata Motors Commercial Vehicles Limited (TMLCV) for every share they held in Tata Motors. This adjustment explains the price



drop in Tata Motors' existing stock, which now represents only the passenger vehicle. electric vehicle (EV), and Jaguar Land Rover (JLR) busi nesses.

The company's restructured entity is now listed as Tata Motors Passenger Vehicles Limited (TMPVL). Meanwhile, the commercial vehicle arm TMLCV, will be renamed Tata Motors Limited after completing regulatory app

TMLCV shares are not yet available for trading and will be listed separately in the coming 45–60 days,

## Markets Dip as Trump's New Tariffs on China Rattle Global Sentiment

Indian equity markets ended lower on Monday, dragged down by IT and FMCG stocks, as global markets reacted negatively to fresh trade tensions between the US and China. The downturn followed US President Donald Trump's announcement of a 100% tariff on Chinese imports starting November

The BSE Sensex slipped 173.77 points, or 0.21%, to close at 82,327.05, snapping its two-day winning streak. Earlier in the session, it plunged as much as 457.68 points to a low of 82.043.14, reflecting investor caution amid global uncertainty.

The broader NSE Nifty fell 58 points, or 0.23%, to settle at 25,227.35. Among the 50 constituents, 30 ended in the red, 19 in green, while one re-

mained unchanged. Sectorally, IT and FMCG stocks bore the brunt of the sell-off. Major laggards included



Tata Motors, Infosys, Hindustan Unilever, Bharat Electronics, ITC, and UltraTech Cement. The renewed tariff threat has sparked fears of a further slowdown in global trade, dampening investor sentiment across Asian and European markets.

"With Trump's announcement of additional tariffs on Chinese exports, markets globally have turned risk-averse," said a market analyst at a domestic brokerage. 'Investors are also booking profits ahead of key US economic data and corporate earnings reports due later this

#### **WPI Inflation Eases to** 0.13% in September on **Lower Food and Fuel Prices**



India's Wholesale Price Index (WPI)based inflation cooled to 0.13% in September 2025, marking a steady decline from 0.52% in August and a significant drop compared to 1.91% in September 2024, according to data released by the government on Tuesday.

The moderation in wholesale inflation was primarily driven by a decline in prices of food articles, fuel, and manufactured goods, offering some relief amid persistent concerns over inflationary pressures in the economy.

Analysts noted that softening prices in key segments — including vegetables, cereals, and cooking gas — played a major role in easing WPI inflation for the month. Crude petroleum prices also remained relatively stable, further contributing to the lower overall index.

The data suggests that supply-side pressures have started to ease, especially in the food and energy sectors, after months of volatility caused by global disruptions and erratic monsoon patterns.

"The decline in WPI inflation reflects im-

proving supply chains and a drop in global commodity prices. This is a positive sign for producers and industries dependent on wholesale inputs, said an economist with a leading financial services firm.

The continued moderation in WPI also bodes well for overall inflation management, as it may eventually translate into lower retail inflation (CPI) in the coming months. However, experts caution that external risks, including global oil price fluctuations and geopolitical tensions, remain potential challe

WPI inflation had been volatile over the past year, touching negative territory for several months before turning positive in recent readings. The September figure reinforces a trend of moderation, which may provide additional space for the Reserve Bank of India (RBI) to maintain a balanced monetary

Further data on sector-wise WPI trends is expected in the detailed release later this week.

#### pending exchange ap-**GST Annual Return Filing for FY25 Begins: Key Rules, Turnover Limits, and Compliance Tips**



The GST portal has officially opened the window for filing the GSTR-9 annual return and GSTR-9C reconciliation statement for the financial year 2024-25. These filings are mandatory for all taxpayers registered under GST and provide a comprehensive summary of the year's tax transactions, including outward and inward supplies, tax paid, and input tax credit claimed.

GSTR-9 must be filed annually, consolidating all monthly or quarterly GST returns filed during the year. GSTR-9C, applicable to taxpayers whose turnover exceeds the prescribed limit, serves as a reconciliation statement and requires certification by a Chartered Accountant or

Cost Accountant. According to Prabhat Ranjan, Senior Director at Nexdigm, while most taxpayers are familiar with GSTR-9 and 9C filings, this year's filing comes with new disclosure requirements and stricter validations on the GST portal. He urged taxpayers to be meticulous while filing to avoid errors and potential penalties.

Important Points to Note: Deadline: The last date for filing GSTR-9 and GSTR-9C for FY25 is December 31, 2025. Taxpayers are advised not to wait for any extensions, as no grace period is expected this year, unlike pre-

vious years when ex-

tensions were somet imes granted due to technical glitches.

Turnover Limits: GSTR-9C filing is mandatory for taxpayers with a turnover exceeding the threshold specified by the government, usually above 5 cror e. Co mpliance Tips: Early preparation, accurate reconciliation of data with annual financial statements, and crossverification of input tax credit claims are essential for smooth filing. The GST portal now enforces stricter validations to minimize discrepancies and improve compliance. Taxpayers should ensure their returns for the entire financial year are correctly filed before attempting the annual return. With the financial year-end appro aching, businesses are urged to prioritize GS T annual return filing to avoid last-minute rush and penal ties.



Rybakina dominated with five aces and 23 winners, compared to Mboko's 17. "It was a very difficult match. I'm glad I managed to win in two sets," she said. "The tiebreak was tight, but I served well and stayed focused."

The second seed will next face Linda Noskova of the Czech Republic in the semifinals, while on the other side of the draw, Belinda Bencic meets Sofia Kenin, who survived four match points to oust third seed Ekaterina Alexandrova.

Rybakina joins Aryna Sabalenka, Iga Swiatek, Coco Gauff, Amanda Anisimova, Madison Keys, Jessica Pegula, and Jasmine Paolini at the WTA Finals. "I'll try to do well there," she said, "but for now, I just want to finish the season healthy."

# Pakistan Withdraws from Junior Hockey World Cup in India

Pakistan has officially withdrawn from the FIH Junior Hockey World Cup, scheduled to be held in India from November 28 to December 10, the International Hockey Federation (FIH) confirmed on Friday. The tournament will take place across Chennai and Madurai, featuring the world's top junior teams.

The FIH, in a statement to PTI, said it will announce Pakistan's replacement team soon. ### Messi Brace Powers Inter Miami Past Nashville SC in MLS Playoffs



Argentine superstar Lionel Messi scored twice as Inter Miami defeated Nashville SC 3-1 in the opening game of their MLS Cup round one playoff series on Friday. The win gives Miami a 1-0 lead in the best-of-three series, with game two set for November 1 in Nashville.

Messi, who was presented with the Golden Boot before the match for finishing the regular season with 29 goals in 28 games, wasted no time showcasing his scoring prowess. In the 19th minute, he opened the scoring with a diving header off a precise pass from Luis Suarez, following a build-up involving Sergio Busquets and Rodrigo De Paul.

Miami doubled their lead in the 62nd minute when Tadeo Allende headed in a cross from Ian Fray, putting the hosts 2-0 ahead. Despite Nashville striker Hany Mukhtar pulling one back late in stoppage time, Messi sealed the win in secondhalf injury time, calmly slotting home after Nashville keep-

er Joe Willis failed to control a Jordi Alba delivery.

The victory comes a day after Messi signed a three-year contract extension, keeping him in Florida until 2028. MLS commissioner Don Garber, who presented the Golden Boot, praised Messi's impact on the club and league, saying, "He has reset the trajectory for Major League Soccer... having three more years is just anoth-

De Paul, who assisted Messi's opener, lauded the team's intensity and focus. "We showed that we are growing as a team, and that's the most important thing," he said. Fellow teammate Javier Mascherano emphasized that Miami must maintain focus despite the win, with the team chasing their first MLS Cup title.




