YSRCP'Coverts'Spark Unease Within Govt and **Alliance Circles**

olitical circles in Andhra Prad esh are abuzz with allegations that covert supporters of the YSR Congress Party (YSRCP) continue to operate within the ruling alliance and opposition ranks. According to reports and political insiders, indivi duals with past or ongoing links to the YSRCP are said to be influencing administrative and political decisions from within the Telugu Desam Party (TDP), Janasena, and even sections of the government mac hinery.

The issue gained traction after the TDP reportedly identified certain individuals as "coverts" who are secretly aiding YSRCP interests. Among them, former TDP candidate from Tamballapalle, ** Jayachandra Reddy**, has been highlighted as a suspected covert figure. Party sources allege his name surfaced following his alleged involvement in an adulterated liquor scam, though official confirmation of these charges remains pending. Whether these suspicions stem from political rivalry or verified intelligence remains unclear, but they have stirred considerable debate within the allia the current governnce. According to politi-



cal analysts, the covert issue goes beyond a few isolated figures. It is believed that certain bureaucrats, including police officials and IAS and IPS officers, may still be operating under YSRCP influence despite the change in government. Observers note that such officers are often exposed only when implicated in scams or disciplinary

Several recent instances have fueled these suspicions. During the previous YS-RCP regime, certain police officials allegedly acted in favor of ruling party leaders, including in controversial cases involving the Pinnelli brothers. More recently, a DSP in Bhimavaram was reportedly accused of working in YSRCP's favor during the previous administration but later managed to secure a preferred posting under ment through a TDP politician's recommendation. Similar claims have surfaced from Raiahmundry, where an inspector allegedly secured a transfer throu gh a TDP MLA's backing despite previously making derogatory remarks against party chief N. Chandrababu Naidu.Sources allege that the current "unofficial posting system", influenced by MLAs' recommendations, has created opportunities for politically aligned officials to maneuver across regimes. While such practices existed in previous administrations, political observers note that the intensity of cross-party alig nment and favoritism seems higher now.

In one notable example, in the Gudivada constituency, a close associate of a former YS-RCP MLA is said to maintain links with an IPS officer who earlier worked closely with YS-RCP leadership. Similarly, a relative of Chief

Minister Jagan Mohan Reddy, who reportedly joined Janasena, is believed to be struggling to integrate within the party and may realign with the YSRCP if the political tide changes again

Analysts argue that the root of the "covert culture" lies in the growing intermixing of politics and money. The influence of financial power, they say, allows individuals to shift loyalties easily, blurring lines between governance, bureaucracy, and party politics. Unless political systems are insulated from monetary interests, such covert operations are likely to persist. Whether these allegations lead to formal inquiries or remain political rhetoric is yet to be seen. But one thing is evident — the shadow of covert politics continues to loom large over Andhra Pradesh's political

CM Naidu responsible for 'man-made agrarian calamity' in Andhra: Jagan

SR Congress Party (YSRCP) president Y. S. Jagan Mohan Reddy on Thu rsday launched a scathing attack on Chief Minister N. Chandrababu Naidu, accusing him of plunging Andhra Prade sh's farming community into severe distress and creating what he termed a "man-made agrarian calamity." Addressing the media through a party press release, Jagan charged that the Telugu Desam Party (TDP)-led National Democratic Alliance (NDA) government had "abandoned" farmers since coming to

He alleged that crucial support systems that once ensured security fo r farmers—such as crop insurance, subsidies, and procurement mechanisms-had been systematically dismantled, leaving cultivators without hope or assura n ce. "Farmers in the state have been left without any guarantee since the coalition government assumed office," Jagan stat ed. "What was once a system of security and support has now become one of neglect and indifference. The Chief Minister has failed to even acknowledge the crisis facing the agricultural sector."The former Chief Minister contrasted the present situation with what he described as the



ed them with more than Rs 7,800 crore through timely claim settlements. Comparatively, he alleged, the current government has brought insurance coverage down to just 19 lakh farmers an d an equal area of 19 lak According to him, only those with agricultural loans now receive coverage as banks are collecting the premium amou nts directly while sanct ioning credit, rather tha n the state paying the pre miums as before."For two years, not a single premium has been paid by this government," Jagan asserted. "What about the remaining farmers who have no

farmers affected by crop losses. The government, he claimed, had failed to follow through on procurement promises mad e to cultivators of chilli, mango, onion, and tobacco—essential crops for farmers in several regio ns of the state. "Naidu has turned his back on the farmers who trusted his promises," Jagan added. "Input subsidies are pending, procurement assurances are forgotten, and crop insurance, which we made universal and free, is now practically nonex istent."In his statement, Jagan also expanded his criticism to the government's handling of public healthcare and edu cation. Reiterating his opposition to the alleged privatisation of government medical colleges established during his regime, he said that his party would continue its protest movement against the state's plans. The YSRCP chief anno unced that rallies would be organised across all

on November 11 to highlight what he described as the government's "anti-public" approach toward public health education. The demonst rati ons were originally sche duled earlier but were postponed due to the impact of cyclone Montha. According to Jagan, the effort to privatise newly set-up government medical colleges, many of which were built betwe en 2020 and 2024, threatens both the accessibility and affordability of medical education. "Government medical colleges are vital to ensuring that poor students can become doctors and serve society," he remarked. "Privatisation would deny opportunities to deserving students and weaken the public hea lthcare netwo rk."Jagan framed his campaign as part of a broader political fight to protect the rights of the poor, farmers, and students in the state. "Our struggle will continue until justice is restored," he said, urging people to actively participate in the scheduled rallies.

The ruling TDP has not yet issued an official response to the YSRCP's allegations. However, political observers expect the government to defend its agricultural policies and challenge the opposition's claims in the coming days, as the political temperature in the state continues to rise ahead of the winter

Addressing a press conference at the State Secretariat on Thursday, the Chi ef Minister presented preliminary estimates detailing the losses sustained in various departments and re

According to the Ch ief Minister, the Road s and Buildings Department bore the hig hest loss at Rs 2,079 c rore, as several stret ches of road networks were eroded, resulting in potholes and connectivity disruptions. The agricultural sector also suffered extensive damage estimated at Rs 829 crore, while the horticulture and sericulture sectors incurred losses of Rs 40 crore and Rs 65 lakh respectively.Nai du further stated that the fisheries sector re-

Losses were also reported in other departments, including the Municipal Administration (Rs 109 cror e). Water Resources (Rs 207 crore), Rural Water Supply (Rs 1.2 crore), Panchayat Raj (Rs 9 crore), and the Women and Child Welfare Department (Rs 1.52 crore). He said these figures are part of the initial assessment and will be revised as updated reports come in from the field."The total loss as per our preliminary estimates is Rs 5,265 crore," Naidu said.

Over 600 drones were deployed to monitor waterbodies and flood-prone zones during the cyclone, while the dedicated "Mana Mitra" app was used to track drone operations and field activities across the state. Naidu mentioned that Cyclone Montha unexpectedly unleashed heavier rains in Nellore, Bapatla, and Pra kasam districts than initially forecast, despite expectations of landfall near Kak

Instead, the system crossed the Andhra Pradesh coast around Antarvedi village in Konaseema district near Narasapuram in West Godavari. Follow ing the cyclone, the sta te's major reservoirs reached nearly 90 percent of their storage capacity, collectively holding around 98.5 TMC of water.Emergency communication channels were activated promptly, with over one crore alert messages sent to citizens.

Naidu said prior planning allowed for early removal of weeds in canals, preventing the submergence of cro ps, while uprooted trees and damaged electric poles were cleared in real time to restore normalcy.

The Chief Minister emphasized that preestablished rehabilitation centres and mobile medical camps provided immediate assistance to families displaced or affected during the storm. Dr awing from the state's previous experiences in handling disasters like Hudhud, Titli, and Budameru, Naidu stressed that continuous technological upgrades and coordination among depart m ents significantly min imized the cyclone's overall impact.

He reiterated that Andhra Pradesh's integrated data-driven disaster management system has proven effective, ensuring swift response, efficient recovery, and strengthened community resilience in the face of natural calamities.

Collective Effort and Tech Helped Minimize Cyclone Damage: CM

ndhra Pradesh Chief Minister N. Chandrababu Na lidu said the state incurred an estim ated loss of 5,265 crore due to Cyclone Montha but credited coordinated teamwork and advanced technology for minimizing the disaster's impact. Addressing the media at the Secretariat on Thursday, Naidu explained how the integration of satellite data, drones, and surveillance systems enabled real-time assessment and quick response, helping to reduce loss of life and property.

The Chief Minister emphasized that the preliminary estimation of losses was completed swiftly through the use of technological tools, marking a significant improvement in disaster management efficiency. "With advanced technology, we continuously tracked the cyclone's movement and issued timely alerts to affected areas. As a result, we were able to significantly reduce losses to life and property. Every department worked



in coordination, and we managed to stabilize the situation within the first day itself," he said. According to the ini-

tial assessment, extensive damage occurred across multiple sectors: Agriculture faced a loss of 829 crore, Horticultu re 39 crore, Sericulture 65 crore, Aquaculture 1,270 crore, Roads and Buildings 2,079 crore, Municipal Administration 109 crore, Irrigation 207 crore, Panchayat Raj 8 crore, Power 16 crore, and Animal Husbandry 71 lakh. A total of 120 cattle deaths were

reported statewide.

Naidu said that a comprehensive report containing sector-wise details and recom menda tions would be submitted soon to the Central Government.He pointed out that real-time satellite imagery and predictive weather analysis enabled authorities to anticipate heavy rainfall zones, potential flooding areas, and vulnerable settlements.

"Natural calamities can't be stopped, but preparedness and proactive measures can minimize their impact," he remarked. The state government's focus, he

said, was not only on temporary relief but also on building a resilient and technologydriven disaster management model for the futu re.Naidu praised ministers, Members of Parliament, MLAs, and local officials who personally visited the affected areas to reassure citizens. "From the Chief Secretary to village secretariat staff, everyone wor ked tirelessly.

Ministers Nara Lokesh and Anitha continuously monitored the situation through RTGS and issued timely directions," he added. Their

round-the-clock supervision ensured that rescue operations, power restorations, and relief measures were executed without delay. The Chief Minister revealed that the government would document the experience gained from managing Cyclone Montha into a disaster management manual, which and relief. Naidu further

would serve as a model guide for future calam ities. "We used real-time data through the State Data Lake to make qui ck and evidence-based decisions," he said, adding that despite attem pts by some to spread misinformation, the administration focused firmly on public safety

AP Adopts Tech-Driven System for Transparent Crop Damage Assessment

OCT 30: In a major step toward ensuring fair and accurate relief for farmers affected by the recent cyclone, the Andhra Pradesh government has mandated a transparent and technology-driven system for assessing crop damage across the state. The initiative aims to deliver timely compensation through databacked and verifiable processes. At a high-level review meeting held on Thursday, Special Chief Secretary (Agriculture) Buditi Rajasekhar, IAS, instructed District Collectors and heads of agriculture and allied departments to conduct swift and precise enumeration of crop losses.

crop damage assessment should begin immediately, without waiting for complete water drainage in inundated regions. Preliminary estimates indicate that nearly 70 percent of the cycloneinduced crop loss occurred in paddy fields across the Konaseema, Kakinada, and Nellore districts, where standing crops were severely affected by flooding and str ong winds. To enhance transparency and accuracy, the government will integrate multiple digital platforms, including the e-Crop portal and the Andhra Pradesh Agri cultural Informatio n Management System (APAIMS), with ad-

ellite imagery, rainfall patterns, and wind-speed analysis. This will be the first time satellite data is officially used at the state level for cross-verifying field-level reports. Officials believe the step will reduce human error and provide a scientifically validated picture of the extent of damage.Dr. Manazir Jeelani Samoo n, IAS, Director of Agriculture, said the initiative reflects Chief Minister Y. S. Jagan Mohan Reddy's vision of technology-driven governance and transparent admi nistration. By adop ting this data-integrated model, the government seeks to minimize discrepancies and ensure

hes genuine beneficiaries swiftly.

According to the guid elines, only those farmers registered as actual cultivators in the e-Crop system will be considere d eligible for relief. Compensation will be sanctioned for losses exceeding 33 percent, as well as for lands impacted by sand casting and soil erosion. This targeted approach, officials noted, will guarantee that relief funds are distributed equitably among genu-ine cultivators. To expedite the process, the government is creating fast-track committees at the Rythu Seva Kendra, mandal, and divisional

These panels, operating under the direct supervision of District Collectors, will include representatives from both the Revenue and Agriculture departments. This multi-layered mechanism is expected to strengthen accountability and streamline data collection from affected regions. A key technological component driving the initiative is APAIMS. developed by Hyderabadbased VASSAR Labs. The system's integration allows real-time synchronization of field-level assessments with satellite and weather data, enabling cross-verification at every stage.

Officials believe this



will significantly reduce delays in relief processing and enhance the reliability of crop damage reports. Senior officials such as Director of Horticulture Srinivasa Rao, IAS, and Director of Fisheries Naik also attended the meeting, con-

tributing to discussions on sector-specific recovery measures.

The Agriculture Department is expected to release district-wise crop damage figures soon, following initial satellite data validation. With this move, Andhra Pradesh

CPI Fumes Over GO 590, Calls PPP Medical Colleges 'Privatisation in Disguise'



TPN | Vijayawada Oct 30: The Communist Party of India (CPI) has launched a strong protest against the Andhra Pradesh government's decision to establish new medical colleges under the Public-Private Partnership (PPP) model, calling it a major step towards the privatization of higher education and public health care.CPI State Secretary K. Eshwaraiah, in a statement released on Thursday, demanded the immediate withdrawal of Government Order (GO) No. 590, which was issued on September 9, 2025. The GO allows the establishment of ten new government medical colleges across the state under the PPP

The proposed institutions are to be set up in Markapuram, Ma danapalle, Adoni, Pu livendula, Penukonda, Palakollu, Am alap uram, Narsipatnam, Bapatla, and Parvathipuram.Eshwaraiah stated that the decision to involve private players in the construction and management of these medical colleges effectively hands over public assets and responsibilities to corporate entities. He argued that the move symbolizes the government's growing inclination to commercialize essential services such as education proximately 376 in

should ideally remain within the public domain to ensure equitable access for all c itizens.

According to the CPI

leader, GO 590 would allow private partners to control the newly established colleges and their infrastructure for almost six decades. He warned that this could lead to long-term damage to the State's interests, as valuable public land, buildings, and medical facilities would be tied up in private hands for 60 years. "This is a clear attempt to sideline public accountability and undermine the purpose of state-run welfare in-stitutions," he remarked. The government has justified the PPP model on the grounds of reducing financial burden on the State. Officials have projected that the model will save around 3,700 crore in constr uction costs and another 500 crore annually

in maintenance. However, Eshwaraia h rejected these claims, arguing that the apparent short-term savings would translate into far greater long-term losses, as the people's access to affordable healthcare and education would be compromised.Highlighting concerns over accessibility, the CPI leader alleged that nearly 20 percent of seats ap-

and healthcare, which number would be allocated under the management quota in PPP run colleges, with fees ranging between 50 lakh and 60 lakh per seat. "This move will make medical education a privilege for the rich, excluding poor and middle-class students," he asserted.

Eshwaraiah also pointed out that the PPP arrangement could eliminate nearly 3,675 potential government jobs that would have been available had these colleges remained under full government control. These positions, he said, include opportunities reserved for Scheduled Castes (SC), Scheduled Tribes (ST), Backward Classes (BC), and Economically Weaker Section (EWS) candidates. leading to a substantial setback in social justice and employment opportunities.

TPN Sattenapalli (Palnadu District), October 30: Senior Telugu Desam Party (TDP) leader and Sattenapalli MLA Kanna Lakshminarayana laun ched a sharp attack on YSR Congress Party chief and former Chief Minister Y. S. Jagan Mohan Reddy, alleging that he has been deliberately attempting to sow discord between the Kamma and Kapu communities in Andhra Pradesh. "Such insensitivity reflects the moral downfall of Jagan's leadership," he remarked. Reflecting on the past five years of YSR Congress rule, Kanna said the period from 2019 to 2024 witnessed rampant lawlessness, corruption, and administrative failure across the state. tober 30: Heavy rains in the upper catchment areas of the Krishna River have led to a sharp incre ase in water levels, pro mpting authorities to issue a second-level danger warning at Prakas am Barrage. The inflow into the barrage has risen dramatically to aro und 5.67 lakh cusecs, ra ising concerns of flooding along the river's ba nks. Officials have urge d residents in low-lying and riverbank areas to remain on high alert as water levels continue to rise steadily.

According to the Irrigation Department, continuous rainfall in Karnataka and Telangana has swollen the upstr eam reservoirs, which are now releasing large volumes of water downstream. With these releases, inflows at Vijayawada's Prakasam Barrage have reached critical levels. Enginee rs are maintaining close vigil over the situation, ensuring controlled outflows to prevent severe flooding in the city and surrounding villages.

District Collector Mal likarjuna reviewed the situation with revenue. irrigation, and disaster management officials. Control rooms have be en activated, and emergency response teams are stationed at vulnerable points along the river. Officials are coordinating with local administration in Ibrahimpatnam, Gollapudi,



and parts of Penamaluru mandal to ensure that precautionary mea sures are implemented without delay.

The district disaster management authority has advised fishermen and residents near the river not to venture clos e to the waters or attem pt any boat operations u ntil water levels subsid e.Meanwhile, a tense si tuation prevailed near Ibrahimpatnam mandal's Tummalapalem village today when a group of local fisherme n stopped a boat heading toward the Praka sam Barrage area. The fishermen, aware of the increased danger and recalling past accidents, promptly alerted auth

With the help of officials, the boat was safely brought back to the shore. Authorities appreciated the swift action of locals, noting that such vigilance is essential in preventing mishaps during flood situations. It may be recalled that in previous vears, similar instances of boats getting stranded near the barrage gates had triggered rescue operations and caused damage to property. At present, the barrage gates are being operated in a controlled manner to manage the massive inflow.

Officials said that water storage levels in upstream reservoirs like Nagarjuna Sagar and Srisailam are nearing their maximum limits, and further releases are likely if rainfall persists. The situation is being monitored hourly, and updates will be issued through official

channels and local me-

dia to keep the public in formed.Citizens are advised to stay away from flooded areas, avoid unnecessary travel across river crossings, and follow instructions from local authorities.

The Vijayawada Municipal Corporation has also alerted its teams to handle potential drainage overflow or inundation within the city limits. Disaster manage ment teams and boats remain on standby in case of emergency evacuation requirements. With forecasts predicting continued rainfall in the catchment regions, the next 24 hours will be crucial. Authorities emphasize that while the current situation is under control, caution and preparedness remain essential to ensure public safety.

Major Mishap Averted at Prakasam Barrage; Swift Action by Authorities Prevents Disaster

OCT 30: A major accid ent was narrowly avo ided on Thursday ev ening near Prakasam Barrage in Vijayawada, after local fishermen and disaster management teams acted quickly to prevent an unmanned boat from colliding with the barrage structure. The timely intervention of the authorities, aided by advanced monitoring and rescue operations, averted what could have been a serious mishap on the Krishna River.According to official sources, local fishermen at Tummalapalem village in Ibrahimpatnam mandal first noticed a boat drifting downstream in the strong river currents. Realizing the potential danger, they immediately alerted the State Disaster Management

Control Room. Responding promptly, the control room dispatched officials who initiated surveillance using drones to locate the drifting vessel. The boat was soon identified near Tummalapalem, heading rapidly toward the Prakasam Barrage. Revenue and police personnel, along with members of the Na-



tional Disaster Response Force (NDRF), were mobilized to the spot. With the help of trained divers, the rescue teams managed to secure the boat and bring it safely to shore before it could cause any damage.

Officials commended the swift thinking of the fishermen and the prompt action of the control room staff for preventing a potentially disastrous incident.Preliminary reports suggest the boat may have broken loose from its moorings upstream due to strong currents following recent rain. Authorities are investigating to determine the owner of the vessel, its point of origin, and whether there were any lapses in safety measures that led to it being adr ift.District officials sta ted that the incident highlighted the importance of continuous monitoring of riverine structures and vessels, especially during rainy periods when water flow increases.

"The coordinated work of the local fishermen, police, and disaster management teams saved us from a serious situation near Prakasam Barrage," an official remarked. In a similar incident earlier in the day, a major crisis was also averted at the Sangam Barrage in Nellore district. A sand boat weighing nearly 30 tonnes had broken its anchor and was carried by the current toward the barrage

Had the vessel hit the gates, it could have caused severe structural damage to the barrage, officials said. Upon receiving the alert, Nellore District Collector Himanshu

Shukla and Superintendent of Police immediately reviewed the situation. Emergency teams from the NDRF, SDRF, fire services, irrigation department, police, and even a patrol unit from Krishnapatnam Port were deployed to handle the crisis. Working under war-footing conditions, the teams successfully diverted the massive sand boat and secured it at the riverbank, avoiding any harm to the barrage infrastructure.Both incidents have underscored the growing importance of using dro ne surveillance and modern river monitoring systems to detect and respond quickly to

Officials have now recommended routine aerial patrols and stricter guidelines for boat mooring along the Krishna River to ensure such nearmisses are avoided in the future. Authorities continue to monitor river conditions closely, emphasizing the need for precautionary measures and community alertness to prevent accidents in and around key water infrastructure across Andhra Pradesh.

Faster OP Services and DiagnosticsOutpatient services experienced a surge with more than 4 crore OP visits during the six-month period, representing a 20 percent increase compared to the previous half-year. The most striking development was the reduction in average

waiting time from 42 minutes earlier to 26 mi nutes now driven largely by the addition of new registration cou nters across hospitals. The number of outpatient registration counters rose from 80 in 2024 to 150 by September 2025.

Heavy Rains Trigger Flooding in Parts of Prakasam



TPN BUREAU, ON- of families to seek shel-GOLE OCT 30: The impact of Cyclone Mon- by elevated locations. destruction across Andhra Pradesh's Prakasam district, with torrential rains submerging several low-lying areas and cutting off road connec tivity to many villages. Continuous rainfall over the past two days caused swollen streams and overflowing reservoirs, leading to widespread inundation and hardship for residents. According to district officials, more than ten villages located downstream of the Gundlakamma Project remain marooned as of Thursday evening.

With floodwaters surrounding the area, access routes have been completely bloc ked, making it difficult for rescue and relief teams to reach stranded people. Villages including Kolasanakota and Rachavaripalem in Maddipadu mandal, and Madiralapadu, Chirvanappalapadu, and Kanaparthi in Naguluppalapadu mandal, are among the worst affected. Communication links have broken down, and people have resorted to make shift boats and temporary arrangements to reach safer areas.Residents report that water levels rose rapidly overnight, inundating homes, agricultural lands, and

In some places, flood waters have entered houses up to window level, forcing hundreds

Local panchayat buildings and schools have been converted into temporary relief shelters to accommodate the displaced population. The situation worsened as power supply to several villages was disrupted since Wednesday night due to fallen electric poles and damaged transformers. Without electricity, residents are struggling to cha rge phones, access lighting, or use essential household equipment. Rural water supplv has also been interrupted, aggravating health and sanitation concerns.

District officials have urged residents not to venture into floo ded areas and to remain in safe shelters until water recedes. Revenue and irrigation department teams have been deployed to monitor water flow from the Gundlakamma Project. Authorities are releasing floodwaters in a controlled manner to prevent further damage to the embankmen s and to manage pressure on the dam. Prakasam District Collector has instructed officials to ensure continuous supervision and coordinate with the electricity and police departments to restore power and maintain safety.

Heavy rainfall is likely to continue in parts of coastal An dhra Pradesh as the cyclonic circulation associated with Montha persists over the Bay of Bengal. The Meteorological Department has warnings for strong winds and further showers in adjoining districts including Guntur, Nellore, and Bapatla. Fishing operations along the coast remain suspended due to rough sea condi

Relief efforts are in progress, with the State Disaster Response Force (SDRF) and local administration distributing food packets, drinking water, and medical supplies to affected families. Boats have been arranged to evacuate people from isolated villages. Officials said restoration of road connectivity will begin once water levels drop and damage assessments are completed.

With agriculture forming the backbone of the region's livelihood, officials fear substantial crop losses in paddy and chili fields, which were ready for harvest. Farmers have urged the government to undertake immediate enumeration and announce compensation for damages.

Local leaders have appealed to the government for urgent relief funds and long-term flood mitigation measures to strengthen embankments and improve drainage systems. As rescue operations continue, the administration remains on high alert to prevent further casualties and minimize property loss across Prakasam district.

MLA Aravind Babu Extends Immediate Relief to **Cyclone-Affected Families**

TPN BUREAU Narasaraopet (Palnadu District), October 30: In the wake of the severe cyclonic storm "Remal" that developed over the Bay of Bengal and its associated heavy rains over the past three days, several low-lying areas in Narasaraopet town have been inundated. Ponds and small reservoirs over flowed due to continuous downpours, flooding residential colonies and cutting off access to essential services. Responding swiftly to the crisis, Narasaraopet MLA Dr. Chadalavada Aravind Babu launched extensive relief operations to support displaced and distressed families. The legislator acted promptly to ensure there was no loss of life in his constituency. He personally supervised precautionary and rescue measures carried out across the flood-affected neighborhoods. Collector Reviews Fisheries Department Activities in Palnadu



TPN BUREAU PAL-NADU Oct 30: A comprehensive review meeting of the Fisheries Department was held in Narasaraopet, Palnadu district, under the chairmanship of District Collector Kritika Shukla. The meeting focused on evaluating the department's ongoing programs, addressing recent challenges faced by fishermen, and reviewing government schemes being implemented to support the fisheries sector.During the meeting, Collector Kritika Shukla instructed department officials to ensure a transparent enumeration of losses suffered by fishermen due to the recent Montha cyclone. She said that any damage to fish-

equipment must be properly recorded and verified to facilitate appropriate compensation or assistance. The Collector emphasized that transparency and accuracy in assessing damages are crucial to ensure the welfare of affected fishermen. The review also discussed the progress of various welfare and development schemes currently being implemented by the Fisheries Department. One major topic was the leasing process of minor irrigation ponds to fisheries cooperative societies. The Collector directed officials to ensure that the lease rates remain affordable and

that the benefits of

these resources reach

small and marginal

fishermen. This step, she said, will help enhance inland fish production while improving the livelihoods of local fishing communities. Officials informed the Collector that the district administration has taken steps to promote aquaculture in the region. Licenses for cultivating fish and prawns have been granted across 3,300 acres in Palnadu district. Technical guidance is also being extended to the license holders to encourage scientific methods of fish and prawn farming, ensuring better productivity and environmental sustain

In addition, the ad-

ministration has decided to issue licenses to 1.500 inland fishermen for freshwater fish culture across different parts of the district. District Fisheries Officer S. Sanjeev Rao, who attended the review meeting, briefed the Collector on the key initiatives being implemented under the Pradhan Mantri Matsya Sampada Yojana (PMMSY). He explained that a variety of subsidy-based programs are being extended to fishermen and fish farmers in the district. These include assistance for pond development, fish seed supply, equipment procurement, and coldchain infrastructure.

The officer stated that these schemes are designed to modernize fisheries operations and increase productivity through better technology and resource support. The meeting also noted that the government is supplying high-quality electricity to fishermen at a highly

subsidized rate of Rs. 1.50 per unit. This provis ion aims to reduce operational expenses in aquaculture activities, particularly in fish and prawn hatcheries and aeration systems used for intensive culture methods.

Collector Kritika Sh ukla appreciated the efforts of the Fisheries Department and urged officials to maintain close coordination with local cooperatives and beneficiaries to ensure the timely implementation of welfare measures. She stressed the need to create greater awareness among fishermen about the available government sche mes so that maximum benefit can reach the grassroots. highlight this concern. Afpress is essential for any thriving democracy. India's Constitution guarantees formal press freedom, but the real challenge today is a media landscape largely captive to partisanship and deference—one that silences scrutiny and stifles meaningful debate. At a time of domestic upheaval and global uncertainty, India urgently needs a press that holds power accountable, encourages honest discourse, and signals when change is necessary. Instead, conformity narrows perspectives, weakens oversight, and blinds the public to critical course corrections. Two recent incidents

ter the tragic Pahalgam massacre and India's subsequent military response under "Op Sindoor," the domestic media narrative was triumphant. However, internationally, the reaction was far less supportive, with global coverage focusing on the loss of Indian jets rather than the strategic impact of the strikes. Unverified reports about strikes deep inside Pakistan circulated without confirmation, projecting jingoism that cost India credibility. Limited government briefings and restricted foreign media access only worsened the situation. Most worrying was the mainstream media's reluctance to question the



government on security failures that led to the massacre. Accountability was noticeably absent.

A similar pattern emerges in coverage of tariff disputes with the U.S. While India must de-

fend its strategic interests firmly, effective diplomacy requires realism and agility. Yet main-

stream media shy away from critically assessing India's handling of negotiations, choosing in-

stead to echo commentary that supports India's stance or criticizes the U.S. This one-sided coverage undermines deeper understanding and reflection.

Though India boasts courageous journalists and independent digital voices working often at personal risk, these are exceptions. Concentrated media ownership, advertising pressures, and threats-both legal and online-discourage investigative scrutiny. Sensationalism often trumps in-depth reporting.

Diaspora communities must also reflect on their role. While enjoying media freedoms abroad, many support narrow, uncritical media consumption about India, fostering echo chambers rather than pluralism. True patriotism means demanding the same high standards of accountability and fact-based reporting for the India we cherish.

A responsible press is not anti-national—it is democracy's watchdog. It highlights both successes and failures, enabling citizens to hold leaders accountable. Without genuine inquiry and independent questioning, public access to information shrinks, and democracy suffers.

For a truly developed India, we need media that informs and challenges, not inflames. Honest reflection-not flattery-is the path forward.

Let the Era of Post-Dollar Power Begin-India Must Lead It

The U.S. dollar, once a symbol of global trade stability, has morphed into a strategic weapon of economic coercion. Instead of tanks or troops, Washington now uses financial sanctions, SWIFT bans, and punitive tariffs to control nations—just ask Iran, Russia, Venezuela, and now India.

Recently, the U.S. imposed a 50% tariff on Indian exports, punishing India for buying cheaper oil from Russia—a country still deeply entwined economically with the U.S. through secret tech deals and uranium trade. This blatant hypocrisy underscores a larger truth: India remains trapped in an economic system designed to sustain American dominance.

Despite being the world's fifth-largest economy and a major geopolitical power, India still settles over 60% of its for-eign trade in U.S. dollars. Whether trading with Russia or importing machinery from China, payments flow through New York's invisible "toll booth," enriching American banks and reinforcing dependence. This system is not about efficiency but control. The dollar's status as the world's reserve currency lets the U.S. print money freely, finance endless military ventures, and impose its will on sovereign nations

Prime Minister Modi's call for "Atmanirbhar Bharat" (self-reliant India) is commendable, but true self-reliance is impossible as long as India's trade remains dollardenominated and SWIFT-dependent. One American bureaucrat can freeze payments to Indian importers or deny liquidity to Russian banks, quietly auctioning India's strategic autonomy.



The solution lies in bold, systematic de-dollarization, starting with India's largest trading partners—China and Russia. With annual trade exceeding \$135 billion with China and critical imports from Russia, India must shift to settling transactions in rupees, yuan, rubles, or even barter arrangements like rare earths for

technology.

Forming a Rupee-Yuan-Ruble triad and championing alternative clearinghouses such as a BRICS+ system would diminish dollar hegemony and establish a truly multipolar financial order one where trade isn't weaponized and national sovereignty respected.

Modi has resisted Western pressure admirably by continuing to buy Russian oil, but this moment demands reinvention. India can lead a new era of economic dignity by building an independent financial ecosystem—one that chips away at the dollar's false supremacy and lights the fuse for a post-dollar world.

The New Battlefield: WhatsApp **Groups and Everyday Conflicts**



In today's digital age, wars are no longer confined to geopolitics or economics—they have found a new, unexpected battleground: WhatsApp groups. Once celebrated as a quick and convenient way to stay connected, WhatsApp has evolved into a zone of social tension, petty conflicts, endless misunderstandings.

Take a simple morning walk and you might overhear heated debates sparked by WhatsApp disputes. In one instance, a group member faced backlash for buying designer outfits on sale but not sharing the news with the group. The irritation? She frequently forwards messages but kept this exclusive. Meanwhile, just a few steps away, another group fumed over a member who constantly flooded chats with mundane photos from feeding her dog to wa-

tering plants—clogging up everyone's phone storage.

These seemingly trivial quarrels underscore a deeper social dilemma: WhatsApp's ease of communication blurs boundaries between private space and public sharing. One delayed reply to a long-lost friend's message was enough to end a friendship, while an acquaintance's persistent calls and follow-up messages turned interactions into a source of stress and

withdrawal. WhatsApp groups span diverse circles—schools, families, apartments—and while they theoretically offer a platform for helpful information and camaraderie, reality often falls short. Apartment groups, for example, start with polite exchanges but quickly devolve into finger-pointing over unpaid maintenance, garbage issues, and disputes about repairs. Just when the tension peaks, someone might innocently ask about a plumber, briefly breaking the hostile

The constant pressure to monitor and respond to messages can be exhausting. Whether engaging enthusiastically or replying with indifference, users risk judgment and criticism. The safest response some suggest, is a neutral one: "Nothing, just WhatsApp.'

This digital battlefield reveals the complexities of modern communication where convenience collides with social expectations, and every notification can become a small war. For many, WhatsApp is less about connection and more about navigating fragile egos and endless drama. In the war zone of instant messaging, sometimes the best defense is simply a quiet retreat.

US Pharma Tariffs: Challenge and Opportunity for India's Drug Industry



Trump recently announced that starting October 1, 2025, a 100% tariff will be imposed on branded or patented pharmaceutical imports into the US—unless foreign companies build drug-manufacturing facilities on American soil. Marketed as a nationalist "produce in America or pay" policy, this move aims to bring supply chains home but effectively acts as a blunt instrument protectionism.

India, known as the 'pharmacy of the world," produces about 20% of global generic medicines, supplies nearly 60% of vaccines worldwide, and hosts the largest number of US FDA-approved manufacturing sites outbillion pharmaceutical exports account for 90% of US prescriptions. This tariff threatens to disrupt this vital trade relationship.

While framed as promoting domestic production, the tariff is essentially a demand for market access through forced relocation. History shows that tariff costs are typically absorbed by consumers and importers, not exporters. The US healthcare system's heavy reliance on affordable Indian generics means any supply disruption or price hikes could severely impact patients, insurers, and government programs. Complex drug manufacturing can't

be quickly shifted to the

vestment, and logistical

Many Indian firms, like Dr. Reddy's and Zydus, derive 30-45% of their revenues from the US market, making this tariff a serious financial threat. Moreover, Indian-made medicines are often rebranded and repackaged abroad, with profits accruing to foreign firms rather than Indian producers.

However, this challenge can become an opportunity if Indian pharma companies act strategically. They should promote their own brands directly in markets like Latin America, Africa, and Southeast Asia to bypass rebranding by foreign companies. Building

US President Donald side the US. India's \$30 US due to regulatory, in-regional manufacturing and regulatory hubs in partner countries can help sidestep US tariffs. Continued focus on regulatory compliance, backed by diplomatic support and export financing, will strengthen India's global pharma presence.

Finally, India must engage multilaterally to challenge protectionist tariff rules at the WTO and other forums, and accelerate R&D investment to move into higher-value drugs like biosimilars and specialty injectables.

If approached proactively, India can turn this tariff threat into a strategic opportunity to reinforce its position as a global pharmaceutical

Speaking at an election rally in Muzaffarpur, Modi described their alliance as "oil and water" — entities that "are in one glass but not merging.

"The real news of this election is not the abuses being hurled at me," Modi said. "It is the scale of differences between RJD and Congress. Their workers are fighting each other for dominance.

Taking aim at opposition leaders Tejashwi Yadav and Rahul Gandhi, Modi called them "two royal scions out on bail," questioning whether voters would "allow these scions to plunder Bihar again." He accused the alliance of underestimating the wisdom of Biharis and said the opposition had united only "to capture

power at any cost.' Predicting a historic win for the ruling National Democratic Alliance (NDA), Modi said the RJD. Congress combine was

defeat" in Bihar. He cited recent surveys indicating strong public support for the NDA, which includes the JD(U), BJP, LJP (Ram Vilas), Hindustani Awam Morcha, and Rashtriya Lok Manch.

India Gets 6-Month US Sanctions Exemption for **Chabahar Port**

India on Thursday confirmed that its investments and operations at Iran's Chabahar Port will be exempt from U.S. sanctions for six months, allowing work on the key strategic infrastructure project to continue uninterrupted.

Affairs (MEA) said the exemption ensures that American restrictions announced in September will not apply to the port.

The announcement comes amid intense India-U.S. negotiations to finalize a major bilateral trade deal. "We continue to re-The Ministry of External main engaged with the

U.S. side on finalising the trade deal. Both sides are continuing to hold discussions," MEA spokesperson Randhir Jaiswal said, noting that the Commerce Ministry is leading talks on trade issues.

India signed a 10-year agreement with Iran in 2024, under which staterun India Ports Global Ltd (IPGL) pledged \$370 million in investments to develop and operate the Shahid Beheshti terminal at Chabahar. The port, located in Iran's Sistan-Balochistan province, is a crucial link for India to Afghanistan and Central

Asia, providing a trade

route that bypasses Pakistan.

This is not the first time Chabahar has received a U.S. waiver. In 2018, the Trump administration issued a similar exemption recognizing the port's importance for regional connectivity and Afghanistan's access to global markets.

The MEA also said India is evaluating the implications of new U.S. sanctions on Russian oil companies. "Our position on energy sourcing is well-known," Jaiswal added. "We are guided by the imperative to secure affordable energy from diverse sources for our 1.4 billion people."

External Affairs Mini ter S. Jaishankar has previously defended India's energy decisions, noting that its Russian oil imports remain modest com-

pared to Europe's. Commerce Minister Piyush Goyal meanwhile said trade talks with Washington are progressing, expressing optimism for a "fair and equitable" deal while emphasizing that India "will not sign any agreement in haste.'

"Don't Trigger Me": 17 **Children Rescued in Mumbai Hostage Incident**

At least 17 children were rescued unharmed on Thursday after a man held them hostage in the Powai neighbourhood of Mumbai, police said. Responding to a circulated video in which the suspect identified himself as Rohit Arya and made chilling threats, authorities mounted a rapid operation that ended with the children being removed and the suspect arrested at the scene.

In the pre-incident video, the man said he had chosen hostage-taking instead of suicide to force conversations with unspecified individuals. "I am Rohit Arya. Instead of dying by suicide, I have made a plan and am holding some children hostage here," he said, listing what he called "simple demands,

moral demands, ethical demands, and a few questions." He warned officials that "the slightest wrong move from you will trigger me," threatening to set the location on fire and insisting he was not seeking money and was "not a terrorist."

Mumbai police said they acted quickly after the video began circulating on social media, deploying tactical teams and negotiators to the Powai site. Officers established a secure perimeter and engaged with the suspect while prioritising the safety of the children. According to authorities, the swift response and coordinated efforts by local law enforcement led to the children being evacuated without physical harm and the perpetrator being taken

Medical teams evaluated the rescued children at the scene and arranged for further care and counselling where needed. Police declined to disclose detailed motives pending further investigation but said Arya's statements suggested he sought attention and engagement rather than

Bihar Assembly Elections | Litmus test for Tejashwi Yadav's 'solo show'

As Bihar heads toward Assembly elections, questions are mounting within the I.N.D.I.A. bloc over the strategy to turn the campaign into a one-man show centered around Rashtriya Janata Dal (RJD) leader Tejashwi Yadav. While he has been projected as the alliance's chief ministerial face, several allies are uneasy about the shift from collective leadership to personality-driven

Tejashwi's emergence as the focal point came after weeks of internal wrangling. The Congress hesitated until the last moment before endorsing him, while Vikassheel Insaan Party (VIP) chief Mukesh Sahani reportedly sought assurances of being named deputy chief ministerial candidate as a bargaining chip.

The official unveiling of Teiashwi as the CM face on October 23 highlighted the alliance's internal imbalance — banners at the event featured only his image, omitting other I.N.D.I.A. bloc leaders. Similarly, the joint manifesto released on October 28 carried Tejashwi's picture prominently under the title "Bihar ka Tejashwi Pran" (Tejashwi's Re-

solve), reducing the

presence of other lead-

ers — including Con-

gress's Rahul Gandhi

and even RJD founder Lalu Prasad — to minor photos.

At rallies, Tejashwi has positioned himself as the youthful, forward-looking leader who can take on Chief Minister Nitish Kumar's NDA. RJD strategists believe his 2020 near-win and image as a former Deputy Chief

Minister give him credibility and voter appeal. However, unease per-

sists among allies over the RJD's dominance in seat-sharing and campaign messaging. Some within the bloc feel sidelined and worry that Tejashwi's personal projection could alienate smaller partners, undermining the alliance's claim of unity.

Despite the dissent, RJD insiders remain confident that Tejashwi's solo pitch will consolidate anti-BJP votes, framing him as the face of Bihar's future generational alternative to the long-standing po-

litical order.

Vietnam Floods Kill 10, River Hits 60-Year High

Severe flooding in central Vietnam has claimed at least 10 lives this week, as rivers swell to levels not seen in six decades, authorities reported on Thursday, October 30, 2025. The disaster has inundated more than 128,000 homes across five coastal provinces, with water depths reaching up to three metres in some

The flooding, triggered by relentless heavy rainfall since the weekend, has wreaked havoc on communities and infrastructure. Some areas recorded a staggering 1.7 metres (5ft 7in) of rain within 24 hours, overwhelming drainage systems and triggering landslides. The ancient town of Hoi An, a UN-ESCO World Heritage site and major tourist destination, was particularly hard hit, prompting emergency

evacuations. Tourists and residents were rescued by boat from submerged streets in Hoi An, with images showing water lapping at historic buildings and disrupting daily life. Local authorities warned that river levels were con-

tinuing to rise, surpassing records last set six decades ago, and called for heightened vigilance in vulnerable

Emergency services and the military have been deployed to assist with evacuations, deliver relief supplies, and support stranded residents. Officials have urged communities to move to higher ground and adhere strictly to safety advisories.

The economic impact is expected to be significant, with agriculture, tourism, and local businesses facing extensive losses due to inundated farmlands, damaged infrastructure, and disrupted commerce. Authorities are assessing the damage and mobilizing national and international aid to provide immediate relief.

Climate experts have noted that extreme rainfall events in the region have been increasing in frequency and intensity, raising concerns about longterm flood resilience. Meanwhile, residents continue to navigate the rising waters, as the government works to prevent further casualties and mitigate ongo-

Trump Cuts China Tariffs After Xi Meeting

U.S. President Donald Trump announced a significant easing of trade tensions with China following a highprofile summit with Chinese President Xi Jinping in Busan, South Korea, on Thursday, October 30, 2025. Trump described the face-to-face meeting as "roaring success," highlighting agreements on trade, rare earth exports, and agricultural purchases.

One of the key outcomes of the summit is the reduction of U.S. tariffs on Chinese goods. Tariffs imposed earlier this year as a punitive measure on China's sale of chemicals used in fentanyl production will be cut from 20% to 10%. This adjustment lowers the overall combined tariff rate on Chinese imports from 57% to 47%, signaling a major step toward de-escalation in the ongoing U.S.-China trade disputes.

Trump also revealed that Beijing had agreed to increase the export of rare earth elements to the United States and to resume buying American soybeans. These developments are expected to boost U.S. agricultural exports while securing critical supply chains for technology and manufacturing

On the technology front, Trump said both leaders discussed the export of advanced computer chips to China, with Nvidia set to enter talks with Chinese officials to facilitate the process. The discussions mark a cautious but notable thaw in technology trade restrictions, which had been a major source of tension between the two countries.

The summit, held at Gimhae International Airport in Busan, drew global attention as both leaders posed for photographs, signaling a willingness to engage directly on economic and strategic issues. Analysts suggest that the measures agreed upon could stabilize trade relations in the near term while leaving room for further negotiations on technology transfers, market access, and intellectual property

protections. Trump framed the summit's outcome as a win for American workers, farmers, and tech industries, emphasizing that the U.S. remains committed to fair trade while pursuing closer cooperation with China.

India's Been "Very Good" On Russian Oil Issue: Trump

U.S. President Donald Trump praised India for significantly reducing its imports of Russian oil, calling New Delhi "very good" on the issue amid his administration's continued efforts to isolate Moscow economically over the war in Ukraine.

Speaking aboard Air Force One on Thursday, following his bilateral meeting with Chinese President Xi Jinping at the APEC Summit in Busan, South Korea, Trump reiterated that India had scaled back purchases of Russian crude. "India's been very good on that front," he said, while noting that China continues to buy large quantities of Russian oil.

Trump added that the two leaders did not discuss oil specifically but focused on working together to bring an end to the war in Ukraine. "It doesn't affect China, it doesn't affect us, but I'd like to see it done," he remarked.

His comments echo previous claims since mid-October that Prime Minister Narendra Modi assured him India would

either halt or drastically cut Russian oil imports, a key source of revenue for Moscow's military

campaign.

Earlier this month, India's Ministry of External Affairs responded to

Trump's remarks, asserting that the country's energy sourcing decisions are guided by national interest and consumer protection. MEA spokesperson Randhir Jaiswal stated that India's energy

policy aims to secure stable prices and diversified supplies while broadening its energy partnerships, including with the United States.

"India is a significant importer of oil and gas,'

Jaiswal said. "Our import policies are guided entirely by the objective of safeguarding the interests of the Indian consumer in a volatile energy scenario.'

India has long defend-

ed its Russian oil imports as essential for maintaining economic stability. even as Washington continues to urge New Delhi to diversify its energy sources amid global sanc-



JD Vance Urges Cuts to Legal Immigration at **Campus Event**

U.S. Vice President JD Vance called for a major reduction in legal immigration during an appearance at a Turning Point USA event held at the University of Mississippi on Wednesday, October 30, 2025. Florida Ends H-1B Visa Hires in State Universities



In a decisive move targeting H-1B visa misuse in higher education, Florida Governor Ron DeSantis has ordered state universities to prioritize hiring American graduates over foreign workers. The directive aims to ensure that taxpayerfunded institutions serve the U.S. workforce rather than relying on imported

"Universities across the country are importing foreign workers on H-1B visas instead of hiring Americans who are qualified and available to do the job," DeSantis stated. He emphasized that Florida leads the nation in higher education, producing thousands of highly-qualified graduates annually.

The Governor has instructed the Florida Board of Governors to strictly enforce this policy. Institutions unable to find suitable American candidates are urged to review their academic programs to align better with job market needs.

DeSantis highlighted specific examples of H-1B hires in Florida universi-

In addition, the Florida Department of Government Efficiency (DOGE) is collaborating with federal authorities, the State University System, and institutional partners to cancel or repurpose over \$33 million in DEI-related grants. ers first. H-1B visas, intended for specialty occupations, have often been used by universities exempt from federal caps, enabling year-round hiring of foreign employees. The Governor's actions mark a significant effort to redirect higher education employment toward domestic talent while reviewing institutional spending priorities.

By enforcing these measures, Florida aims to set a precedent in U.S. higher education, emphasizing accountability, workforce prioritization, and alignment between academic output and local employment opportunities.


Maruti Suzuki Cuts Car Prices by Up to Rs 1.3 Lakh After GST Reduction

Maruti Suzuki India on Thursday announced a price reduction across its entire model range by up to Rs 1,29,600, effective from September 22, to pass on the benefit of the recent GST rate cut to customers. The country's largest carmaker said the move is aimed at making vehicles more affordable and encouraging two-wheeler users to upgrade to cars.

Entry-level models will see significant price drops, with S-Presso reduced by up to Rs 1,29,600, Alto K10 by Rs 1,07,600, Celerio by Rs 94,100, Wagon-R by Rs 79,600, and Ignis by Rs 71,300. Premium hatchbacks and sedans are also included, with Swift down by Rs 84,600, Baleno by Rs 86,100, Dzire by Rs 87,700, Fronx and Brezza by over Rs 1.1 lakh, Grand Vitara by Rs 1.07 lakh, Jimny by Rs 51,900, Ertiga by Rs 46,400, and XL6 by Rs 52,000. Commercial vehicles like Invicto, Eeco, and Super Carry LCV will see reductions of up to Rs 68,000.

Partho Banerjee, Senior Executive Officer (Marketing & Sales) at Maruti Suzuki India, said the company is reducing prices of small cars over and above the 8.5% GST cut to boost motorisation in India, noting the

Sensex, Nifty Rise on US Fed Rate Cut; IT Stocks **Lead Gains**



Indian equity markets extended their positive run on Thursday following global cues after the US Federal Reserve cut interest rates by 25 basis points, bringing the benchmark rate to 4-4.25%. The S&P BSE Sensex surged over 350 points to trade above 83,000, while the NSE Nifty50 crossed 25,400 in early trade. Broader market indices also recorded gains, with volatility

remaining stable. Dr. VK Vijayakumar, Chief Investment Strategist at Geojit Investments, described the Fed's 25 bp rate cut as a "risk management cut," highlighting uncertainties around economic activity, unemployment, and inflation. He added that with the US labor market cooling and GDP growth projected at 1.6% for 2025, further rate cuts are possible, creating a favourable environment for global and domestic markets. Despite this, Indian stocks are largely driven by expectations of corporate earnings revival and positive developments in India-US trade negotiations.

On the domestic front, Nifty50 closed Wednesday at 25.330. marking gains in 11 of the last 13 sessions and recovering over 900 points from its recent low of 24,404 on August 29. Analysts noted that the Nifty remains in an uptrend, with support near 25,150 and resistance levels at 25,550 and

IT stocks led the gains, with Infosys and Wipro seeing notable increases, while investor activity included major insider purchases in Jindal Steel (Rs 997 crore), Indus Towers (Rs 708 crore), Jindal Stainless (Rs 352 crore), Tourism Finance Corporation (Rs 161 crore), and Paisalo Digital (Rs 126 crore).

SEBI Mulls Allowing FPIs in Non-Cash, Non-Agri **Commodity Derivatives**



The Securities and Exchange Board of India (SEBI) is reviewing a proposal to allow foreign portfolio investors (FPIs) to trade in non-cash settled, nonagricultural commodity derivative contracts, SEBI Chairman Tuhin Kanta Pandey said on Wednesday. The move is aimed at committee to suggest measures

participation. Speaking at the MCX Metals and Energy Summit 2025 in Mumbai, Pandey highlighted that SEBI has already set up a for deepening the agricultural commodities segment. "We are actively looking at ways to develop the non-agricultural commodity space, including metals, and a dedicated working group will be constituted for this pur-

pose," he added. The proposed change would tion in commodity derivatives is

enable FPIs to participate in derivative contracts beyond cashsettled agricultural commodities, potentially enhancing market liquidity and offering international investors broader avenues in India's commodities market. Currently, FPI participalargely restricted, limiting foreign inflows and investment opportunities.

Pandey emphasized that expanding FPI access to non-agri commodity derivatives aligns with SEBI's broader goal of deepening financial markets while maintaining robust regulatory oversight. The regulator is also exploring other measures to improve transparency, risk management, and market participation across commodity segments.

Market participants expect the potential approval to provide a boost to metals and energy derivatives trading, attracting foreign capital and increasing comnetitiveness. Analysts say this could also help Indian commodity markets integrate better with global commodity flows, while giving domestic investors more hedging and investment options.

The SEBI chairman reiterated that the proposals are under review and would be implemented with appropriate safeguards to protect market integrity, risk management, and investor interests, signaling SEBI's ongoing efforts to modernize India's commodity derivatives ecosystem.

GST Inversion Eases, But Input-Output Rate Gaps Worry Industry



The recent GST rate rationalisation in India has eased the inverted duty structure (IDS) across many sectors, but wide gaps between input and output tax rates continue to raise concerns for industry, particularly regarding working capital and refund processes. The removal of the 12 per cent slab and consolidation into two main rates of 5 per cent and 18 per cent has addressed most anomalies, yet items such as bicycles, tractors, fertilisers, and certain textiles still face inversion. For example, steel inputs attract 18 per cent GST, while final products like bicycles and e-bicycles are taxed at 5 per cent, creating potential capital blockage.

In the textile sector, GST cuts on manmade fibres and yarn have largely corrected inversion, with about 80 per cent of the value chain now aligned. However, minor inversions remain in polyester fibre raw materials and textile machinery, where input tax at 18 per cent exceeds the final product's 5 per cent rate. A textile industry executive noted that the wide rate difference, though smaller than before, continues to pose working capital challenges and highlighted the importance of a smooth refund mechanism.

Similarly, in the fertiliser sector, GST on key inputs such as sulphuric acid, nitric acid, and ammonia has been reduced from 18 per cent to 5 per cent. Yet packaging costs and government subsidies can still result in inversion, as final product prices may fall below input costs. Officials involved in GST rationalisation acknowledged these transitional issues but emphasized that majority of IDS cases have been corrected, with expected savings for the fertiliser sector reaching Rs 5,000 crore annually due to lower refund outgo.


Industry experts caution that while progress has been made, residual inversions could incentivize evasion if refunds are delayed or capital remains blocked, underscoring the need for efficient implementation and monitoring. Nvidia Invests \$5 Billion in Intel to Boost Al Infrastructure and PCs

Leading chipmaker Nvidia announced on Thursday that it will invest \$5 billion in Intel to develop AI infrastructure and personal computing solutions. The investment involves purchasing Intel common stock at \$23.28 per share, slightly below Intel's Wednesday closing price of \$24.90. Upon completion, Nvidia will become one of Intel's largest shareholders, holding roughly 4% or more of the company. The transaction is subject to customary regulatory approvals.

This move follows increased interest in Intel from major investors, including the US government, which acquired a roughly 10% stake in August, and Japan's SoftBank, which invested \$2 billion. Intel has also been raising funds by selling assets to support heavy investments required for advanced semiconductor development amid declining market share.

The collaboration will integrate Nvidia's AI infrastructure and accelerated computing with Intel's leading CPU technologies and x86 ecosystem. Intel will develop Nvidia-custom x86 CPUs for data centers, which will be incorporated into Nvidia's AI



platforms. For personal computing, Intel will create x86 systemon-chips (SOCs) integrating Nvidia RTX GPU chiplets, enabling high-performance PCs combining top-tier CPUs and

A viral Reddit post has reignited the debate on Bengaluru's traffic crisis, calling it a "hidden tax" that drains time and productivity from lakhs of commuters. Shared in the r/Bengaluru community on Friday, the post narrates the ordeal of an Oracle employee living in JP Nagar, who says the city's gridlock costs him nearly two and a half months of his life every

According to the post, the techie earns Rs 28 lakh annually, excluding stock options. Out of this, he pays Rs 6.5 lakh in income tax and another Rs 1.4 lakh through GST on daily expenses—already surrendering over three months of work to the exchequer. But the bigger loss, he argues, is time. His office, just 14 kilometers away, should be a 30-minute commute. Instead, it takes an exhausting 90 minutes each way. Over the course of the year, this adds up to 2.5 months lost—time he believes is equivalent to another hidden tax paid not to the government, but to the city's poor infrastructure.

The post has struck a chord with thousands of Bengaluru residents who face the same grind daily. Many echoed the frustration that India's "Silicon Valley" may be powering global innovation, but its broken roads, endless traffic jams, and inadequate public transport force professionals to pay with their most valuable resource—time.

Experts say such urban inefficiencies also take a toll on mental health, family life, and the city's economy. While civic authorities have announced metro expansions, road upgrades, and tech-driven traffic management systems, citizens argue change is too slow to match the city's exploding population and vehicle density.

For Bengaluru's workforce, the message is clear: the real tax isn't just in paychecks—it's the endless hours wasted in

These figures not only underline the global gold hierarchy but also signal how countries use gold as a hedge against economic uncertainties. While Western economies dominate the top ranks, nations like Russia have been catching up rapidly, using gold as a shield against sanctions and currency instability. For emerging economies like India, which also features in the top 10, gold reserves remain a crucial part of financial security and

long-term strategy The bottom line: gold is still king, and the countries that hold it the most continue to wield significant influence in the world

Charlie Kirk's Anti-India Visa Remark Resurfaces Amid H-1B Shakeup

Conservative US leader and staunch Trump supporter Charlie Kirk, who was shot dead on September 10 in Utah, is back in the spotlight after his controversial post on Indians and immigration resurfaced. Just days before his death, the 31-year-old Turning Point USA founder declared that America does not need more visas for Indians.

On September 2, Kirk wrote on X that legal immigration from India had displaced American workers more than any other. insisting that America was "full" and should put "its own people first." His remarks were in response to Fox News host Laura Ingraham, who argued that any US trade deal with India would involve more visas. Kirk's post sparked backlash, with critics calling it xenophobic and damaging to innovation and bilateral ties, since most Indians in the



US migrate as skilled professionals in the tech

The controversy has resurfaced now because former President Donald

Trump, back in the headlines, has announced sweeping changes to the H-1B visa programme. From September 21, 2025, expected to drastically reduce Indian tech migration. The H-1B visa has long served as the backbone of Silicon Valley's workforce, powering giants like Google, Microsoft and Amazon with Indian talent.

Kirk, known for his fiery podcasts and youth outreach, built a strong base in conservative circles, aligning with Trump's "America First" agenda. His critics, however, saw his stand as part of a broader push within the MAGA movement to curb legal immigration, even at the cost of America's competitiveness.

With his death, Kirk leaves behind a polarising legacy. But his last words on visas highlight a growing fault line in US politics—whether America should remain open to Indian talent or shut the door in the name of nationalism.

Internet Shocked Over Sky-High iPhone 17 Prices in Pakistan

Apple's latest iPhone 17 series has just hit global markets, but in Pakistan, it's the jaw-dropping price tags that have caught everyone's attention. While Indian fans queued up outside Apple stores in Mumbai and Delhi to grab the new device on launch day, social media in Pakistan is buzzing over how expensive the phones are across the border.

A viral post on X revealed that a resident in Pakistan will need to shell out between PKR 3.65 lakh (Rs 1.14 lakh) and PKR 5.74 lakh (Rs 1.79 lakh) for the new lineup. The iPhone 17 Pro Max alone costs around PKR 547,000—or roughly Rs 1.70 lakh. The iPhone Air comes in at PKR 483,680 (Rs 1.51 lakh), while the iPhone 17 Pro is priced at PKR 531,680 (Rs 1.66 lakh).



The day saw other surprises, including Norwegian eighth seed Casper Ruud's defeat to Daniel Altmaier and a withdrawal by former world number one Grigor Dimitrov due to a shoulder injury,

granting Daniil Medvedev a walkover to the third round. Italy's Lorenzo Musetti fell to compatriot Lorenzo Sonego in three sets, while Canadian ninth seed Felix Auger-Aliassime battled past France's Alexandre Muller in a tight contest.

In other matches, Monegasque Valentin Vacherot defeated Arthur Rinderknech and will face Cameron Norrie, while hometown favorite Corentin Moutet lost in straight sets to Alexander Bublik. Russian tenth seed Karen Khachanov overcame Joao Fon-

seca 6-1, 3-6, 6-3 and will meet Australia's Alex de Minaur in the round of 16.

With top seeds falling early and intense battles continuing, the Paris Masters promises thrilling action as players vie for crucial points and a shot at the prestigious crown.

Legendary Australian fast bowler Glenn McGrath has named Virat Kohli as his top pick among Indian ODI batters, followed by Rohit Sharma in a move that surprised many cricket fans. McGrath placed Sachin Tendulkar third on his list, with MS Dhoni and Yuvraj Singh rounding out his top five. Notably, explosive opener Virender Sehwag was absent from the ranking.

McGrath praised Rohit's incredible numbers in oneday cricket, calling them "unbelievable." "Three double hundreds and the highest score of 264 is just unheard of. 11,370 runs in 276 matches—probably a little bit unfortunately earmarked as a one-day specialist. His stats in Test cricket should have been better because he was a class player," McGrath said. On Kohli, he added, "At No. 1, it's hard to go past Virat. You look at the runs, average, and strike rate—unbelievable."

Rohit Sharma recently made history by becoming the oldest Indian to reach the top spot in the ICC ODI batting rankings at 38 years and 182 days, surpassing India captain Shubman Gill.



His rise came after a stellar performance in the recent ODI series against Australia, where he amassed 202 runs in three matches at an average of 101, earning the 'Player of the Series' award.

Shubman Gill, in contrast, struggled in the series, scoring just 43 runs across three matches. Rohit's consistency and big-match performances in ODIs have now cemented his reputation as one of India's greatest limited-overs batters, a fact recognized even by cricketing legends like McGrath.

WI Clinch 2-0 Lead After 14-Run Win Over **Bangladesh**



A brilliant 61 from Tanzid Hasan went in vain as West Indies secured a 14-run victory over Bangladesh in the second T20I on Wednesday, taking an unassailable 2-0 lead in the threematch series. Three-wicket hauls from Akeal Hosein and Romario Shepherd proved decisive as the visitors restricted Bangladesh to 135/8 while chasing 150.

Hosein (3/22) made history by surpassing Dwayne Bravo's tally, becoming the second-highest wicket-taker for West Indies in T20Is with 81 wickets in 83 matches, including a five-wicket haul. Shepherd complemented the effort with 3/29 and also contributed a quick 13 runs in the lower order, earning him the 'Player of the Match' award.

West Indies, elected to bat first, were powered by Alick Athaneze (52 off 33 balls) and skipper Shai Hope (55 off 36 balls). The duo stitched together a 105-run second-wicket partnership after an early loss of Brandon King (1), setting the platform for a competitive total. Mustafizur Rahman (3/21), Rishad Hossain (2/20), and Nasum Ahmed (2/35) managed to restrict further damage, but late contributions from Roston Chase (17* in 15 balls) and Shepherd (13 in 16 balls) took West Indies to 149/9.

In the chase, Bangladesh struggled to build partnerships despite Tanzid's resilient innings, which included three fours and three sixes. His dismissal at 117/4 in 17.1 overs triggered a collapse as Shepherd, Hosein, and Jason Holder (2/20) took quick wickets. Bangladesh lost four wickets for just 18 runs and ended their innings at 135/8.

With the series now sealed, West Indies can look forward to the final T20I with confidence, while Bangladesh will need a strong performance to avoid a

Oman Replaces Pakistan at Junior Hockey World Cup



Oman will join the lineup for the upcoming FIH Men's Junior World Cup 2025 in Tamil Nadu, following Pakistan's late withdrawal, the International Hockey Federation (FIH) announced on Wednesday. The tournament is scheduled from November 28 to December 10, with matches to be held in Chennai and Madurai.

Oman earned the spot as the next highest-ranked team from the Junior Asia Cup 2024, stepping in after Pakistan decided not to participate despite qualifying through last year's continental championship. The Pakistan Hockey Federation informed the FIH that the team would not accept the invitation, citing internal consultations with their government before

Pakistan had been placed in Group B alongside India, Chile, and Switzerland. With Oman taking their place, the group composition has been updated ahead of the tournament. This late withdrawal marks the second recent instance of Pakistan pulling out from a major hockey event in India, after the Men's Asia Cup in Rajgir, Bihar, where Bangladesh replaced them. The withdrawal also cost Pakistan a chance to qualify for next year's World Cup, as the Asia Junior Cup served as a qualifying event.

The FIH had initially postponed the official draw for nearly a month to accommodate Pakistan's decision-making, eventually holding the ceremony at its headquarters in Lausanne. The Men's Junior World Cup 2025 will feature 24 teams for the first time, alongside the Women's edition, reflecting the FIH's Empowerment and Engagement strategy aimed at promoting wider participation.

Germany enters the tournament as the defending champions, having won the 2023 edition in Kuala Lumpur, Malaysia. The inclusion of Oman ensures the tournament maintains full participation and competitive balance, while giving the Middle Eastern nation an opportunity to showcase its growing hockey prowess on the global stage.
