ROADSARE WAITING FOR REPAIR

Despite nearly two months passing since torrential rains battered the State, leaving roads and culverts severely damaged, the State Government has yet to begin large-scale repair works. Commuters continue to face hardship as connectivity remains disrupted at several locations, while only patchwork measures have been undertaken in some

that lashed the State in August caused extensive destruction. In its first assessment, the Roads and Buildings (R&B) Department drew up a plan for temporary restoration at an estimated cost of Rs. 53.76 crore, while pegging permanent works at Rs. 1,157.46 crore. Following another spell of heavy rains in September, the department revised its estimates to Rs. 72.49 crore

and Rs. 1,263.33 crore for permanent restoration.

However, ground-level progress remains minimal. Save for filling potholes and repairing breaches at a few stretches, no tangible work has been undertaken to mitigate the suffering of the road users. A senior official admitted that the department has been unable to execute works due to lack of participation from contractors.

currently in progress. The DPR being readied will focus on a 55-kilometre stretch of the Musi, running from Narsingi to Godelli, and is expected to be submitted by early next year. Once the report is ready, the government plans to seek a loan of nearly Rs.4,100 crore from the Asian Development Bank (ADB) to begin the works in phases.

According to MRDCI

officials, the project is envisioned not only as a beautification effort but also as an exercise in urban renewal. The DPR is expected to cover multiple aspects including identification and removal of encroachments, rehabilitation of displaced residents, riverfront beautification, and measures to restore ecological balance. Officials argue that such a comprehensive approach will help convert the Musi riverfront into an urhan landmark while also addressing long-standing concerns over flooding, pollution, and lack of civic infrastructure. However, translating these plans into reality is proving difficult, with both social and ecological challenges mounting.

On the ground, residents of several low-lying localities remain skeptical about the government's intentions. Memories of displacement and loss associated with past urban development projects continue to linger. The recent flooding in areas such as Chaderghat only deepened these suspicions. A senior GHMC official recalled how residents refused to move to relief camps despite being surrounded by floodwaters last week. "They chose to remain on rooftops and we had to deliver food and essentials using drones. They did not agree to leave their homes because they feared that once vacated, their houses would be



over by the government," the official said. Such resistance highlights the difficulties the government may face in relocating thousands of families living in encroached zones along the Musi's banks.

Equally vocal are environmental activists and experts who have repeatedly questioned the logic of limiting rejuvenation efforts to a portion of the river stretch. They point out that unless there are strong measures to control sewage inflows and industrial effluents being dumped into the river, cosmetic beautification will serve little purpose. The Musi today functions largely as a carrier of untreated sewage, and activists argue that any attempt to rejuvenate only select portions of the river will be undermined by continuing pollution upstream and downstream. "This is at best a shortterm fix. Unless there is a comprehensive sewage treatment and effluent management plan, the river will remain polluted, and all the beautification works will be washed away," one activist remarked. Others add

Excise Raids Seize 86 Liquor Bottles



The dollar's status as the world's reserve currency lets the U.S. print money freely, finance endless military ventures, and impose its will on sovereign

manirbhar Bharat" (self-reliant India) is commendable, but true self-reliance is impossible as long as India's trade remains dollar-denominated and SWIFTdependent. One American bureaucrat can freeze payments to Indian importers or deny liquidity to Russian

The solution lies in bold, systematic de-dollarization, starting with India's largest trading partners, China and Russia. With annual trade exceeding \$135 billion with China and critical imports from Russia, India must shift to settling transactions in rupees, yuan, rubles, or even barter arrangefor technology.

Forming a Rupee-Yuan-Ruble triad and championing alternative clearing houses such as a BRICS+ system would diminish dollar hegemony and establish a truly multipolar financial order, the one where trade isn't weaponized and national sovereignty respected.

Marketed as a nationalist "produce in America or pay" policy, this move aims to bring supply chains home but effectively acts as a blunt instrument of

protectionism. India, known as the "pharmacy of the world," produces about 20% of global generic medicines, supplies nearly 60% of vaccines worldwide, and hosts the largest number of US FDA-approved manufac-

pharmaceutical exports account for 90% of US prescriptions. This tariff threatens to disrupt this vital trade relationship.

While framing as pro-

moting domestic production, the tariff is essentially a demand for market access through forced relocation. Historv shows that tariff costs are typically absorbed by consumers and importers, not exporters. The US healthcare system's heavy reliance on affordable Indian generics means any supply disruption or price hikes could severely impact patients, insurers, and government programs. Complex drug manufacturing can't be quickly

and logistical hurdles.

Many Indian firms. like Dr. Reddy's and Zydus, derive 30–45% of their revenues from the US market, making this tariff a serious financial threat. Moreover, Indianmade medicines are often rebranded and repackaged abroad, with profits accruing to foreign firms rather than

Indian producers. However, this challenge can become an opportunity if Indian pharma companies act strategically. They should promote their own brands directly in markets like Latin America, Africa, and Southeast Asia to bypass rebranding by foreign companies. Building re-

partner countries can help sidestep US tariffs. Continued focus on regulatory compliance, backed by diplomatic support and export financing, will strengthen India's global pharma presence.

Finally, India must engage multilaterally to challenge protectionist tariff rules at the WTO and other forums, and accelerate R&D investment to move into higher-value drugs like biosimilars and specialty injectables.

If approached proactively, India can turn this tariff threat into a strategic opportunity to reinforce its position as a global pharmaceutical

lenge today is a media landscape largely captive to partisanship and deference, which silences scrutiny and stifles meaningful debate. stream media's reluctance to question the government on security failures that led to the massacre. Accountability was noticeably

absent. A similar pattern emerges in coverage of tariff disputes with the U.S. While India must defend its strategic interests firmly, effective diplomacy requires realism and agility. Yet mainstream media shy away from critically assessing India's handling of negotiations, choosing instead to echo commentary that supports India's stance or criticizes the U.S. This one-sided coverage undermines deeper understanding and reflection

Though India boasts courageous journalists and independent digital voices working often at personal risk, these are exceptions. Concentrated media ownership, advertising pressures, and threats—both legal and online—discourage investigative scrutiny. Sensationalism often trumps in-depth reporting.

Diaspora communities must also reflect on their role. While enjoying media freedoms abroad, many support narrow, uncritical media consumption about India, fostering echo chambers rather than pluralism. True patriotism

means demanding the same high standards of accountability and factbased reporting for the

India we cherish. A responsible press is not anti-national—it is democracy's watchdog. It highlights both successes and failures, enabling citizens to hold leaders accountable. Without genuine inquiry and independent questioning, public access to information shrinks, and democracy suffers.

For a truly developed India, we need media that informs and challenges, not inflames. Honest reflection—not flattery—is the path forward.

and screenshots of women's display pictures, according to police officials. Investigators uncovered numerous chats with women, with allegations that Saraswati used false promises to lure

During the investigation, police confronted Saraswati's aides, who are accused of intimidating the victims to suppress evidence and prevent them from reporting the harassment. Authorities are probing the extent of the aides involvement and their

role in obstructing

Saraswati was taken to the Vasant Kunj police station in New Delhi last Sunday, where the inquiry into the allegations intensified. The case has sparked widespread outrage and calls for strict action against those exploiting positions of trust.

Police have assured that the investigation will be thorough and victims will be provided necessary protection and support. They have urged anyone with additional information to come forward.

India Announces 2 Cross-Border Rail Links With Bhutan

ndia on Monday announced its first cross-border railway connectivity projects with Bhutan, unveiling plans to build two train links at a cost of over 4,000 crore to enhance trade and regional cooperation.

Railway Minister Ashwini Vaishnaw and Foreign Secretary Vikram Misri announced that two new railway lines will connect Kokrajhar in Assam to Gelephu in Bhutan, and Banarhat in West Bengal to Samtse in Bhutan.

The 89-km railway projects are expected to be completed in the next four years. The Kokrajhar-Gelephu line will be 69 km long and cost 3,456 crore. It will include six stations, two major bridges, two viaducts, 29 major and 65 minor bridges, one roadover-bridge, 39 road-under-bridges, and two goodsheds. Around 2.39 km of this line will fall

within Bhutanese Prime Minister Naren-

The second project, Banarhat to Samtse, will cover 20 km and cost 577 crore. It is expected to be completed in three years and will include two intermediate stations.

"This is the first set of rail connectivity projects with Bhutan," Misri said, calling the initiative a sign of "exceptional trust, mutual respect, and shared development goals" between the two nations.

The projects were agreed upon during

dra Modi's visit to Bhutan last year.

Vaishnaw noted that since most of Bhutan's exports and imports flow through Indian ports, the new rail links will significantly boost Bhutan's economic growth

India has also pledged 10,000 crore in development assistance to Bhutan under its 13th fiveyear plan (2024–2029), reinforcing its commitment as Bhutan's largest developmental



"Stalin Taking Revenge?" Vijay Cries **Vendetta Over Stampede, DMK Hits Back**

ctor and Tamilaga Vettri Kazhagam (TVK) chief Vijav. in his first public comments since the tragic stampede in Karur that killed 41 people, strongly criticised Tamil Nadu Chief Minister MK Stalin and the ruling Dravida Munnetra Kazhagam (DMK), hinting at a political conspiracy ahead of the 2026 state elections.

In a somber video message released four days after the incident, Vijay said, "Chief Minister sir, if you have revenge plans, do anything to me. Don't touch my leaders. I will be at home or in office." He alleged that false police cases were being filed against TVK members and supporters, asserting that his party had followed all safety protocols.

"We did nothing wrong except speak at the designated spot. But cases have been filed against our leaders, friends, and social media partners. My political journey will continue with renewed vigour," he said.

Vijay's remarks come amidst mounting political tension following the deadly stampede during a welfare event organised by the TVK in Karur on Sunday. The DMK reacted

sharply, accusing Vijay of deflecting blame. DMK spokesperson A Saravanan said, "It took four days to release a video? This is scripted. He must take responsibility for the deaths because he broke the rules.'

The party also pointed out that Chief Minister



Stalin had rushed to Karur within hours of the incident to oversee relief efforts.

DMK MP A Raja criticised Vijay's decision to leave the scene during the chaos, stating, "Walking away from the tragedy means someone has а conscience.

The tragedy and its political fallout have sparked debate over accountability and safety during political gatherings in the state.

Trump Unveils 20-Point Gaza Peace Plan

Proposes 72-Hour Ceasefire and Hostage Return

n a dramatic diplomatic move, former U.S. President Donald Trump on Monday unveiled a 20-point peace plan aimed at ending the ongoing war between Israel and Hamas and establishing a new governance framework for post-war

The plan, announced at the White House, calls for an immediate ceasefire and the return of all hostages—both living and dead—within 72 hours of Israel publicly accepting the proposal. The conflict, now stretching into its second year, has resulted in thousands of deaths and a humanitarian crisis in the Gaza

According to the proposal, a temporary international gov-

The board would be headed by Donald Trump himself, with former British Prime Minister Tony Blair among the key members. The interim authority would be tasked with overseeing reconstruction, security reform, and the eventual transfer of governance to an elected Palestinian

Canadian Prime Minister Mark Carney has welcomed U.S. President Donald Trump's newly unveiled Middle East peace plan, calling it a "historic" step toward resolving the two-yearlong Gaza conflict.

In a statement posted on X Monday, Carney urged all parties to seize the opportunity: "Canada welcomes President Trump's historic new Middle East peace plan, and we urge all parties to help it realise its full ponext step, Hamas must immediately release all hostages.

He emphasized Canada's continued commitment to humanitarian support: "Canada stands ready to support the sustained, unimpeded, and large-scale delivery of humanitarian aid into and throughout Gaza."

The White House revealed the peace initiative following talks between President Trump and Israeli Prime Minister Benjamin Netanyahu. The plan outlines a ceasefire framework. hostage releases, and

tion efforts in Gaza.

Under the deal, Gaza would be transformed into a demilitarized, terror-free zone. If both Israel and Hamas agree, Israeli forces would withdraw to an agreed line, and hostilities would cease immediately. A full hostage exchange is set to occur within 72 hours of Isra-

Gandhi Statue Vandalised in London Ahead of Jayanti

he iconic bronze statue of Mahatma Gandhi in Tavistock Square, London, was vandalised on Monday, just two days before Gandhi Jayanti, observed globally as the International Day of Non-Violence.

Authorities discovered anti-India graffiti on the plinth of the statue, which depicts Gandhi in a seated, meditative pose. Local police and Camden Council have launched an investigation into the incident, with efforts underway to identify the

perpetrators. The High Commission of India in London strongly condemned the act, calling it "a shameful act of vandalism" and "a violent attack on the idea of non-violence." In a statement on X (formerly Twitter), the Commis-



sion said it had taken up the matter with local authorities and was working to restore the statue's

This is not just vandalism," the statement read, "but an assault on the legacy of Mahatma Gandhi, just days before the International Day of

India League. It commemorates Gandhi's time as a law student at nearby University College London. The inscription on its base reads: "Mahatma Gandhi, 1869-1948.'

Tavistock Square is also known as London's "peace park," home to several other memorials, including a tree for Hiroshima victims and a monument for conscientious objectors.

Each year, Gandhi Jayanti is marked at the site with floral tributes and renditions of Gandhi's favourite bhajans. This vear's celebrations are expected to proceed with increased security and renewed calls to protect global symbols of peace.

The vandalism has drawn criticism from Indian and international communities alike, with many urging swift action and stronger safeguards historical monuments.

IMF Team Begins Review of Pakistan's \$7-Billion Bailout Programme

high-level International Monetary Fund (IMF) mission has begun formal talks with Pakistan's economic team in Islamabad to review the country's performance under the \$7 billion Extended Fund Facility (EFF) and the \$1.1 billion Resilience and Sustainability Facility (RSF). The visit comes amid reports that Pakistan's economic progress is "off the mark" in meeting key programme targets as of June 2025.

The IMF delegation, led by Mission Chief Iva Petrova, met on Monday with Pakistani officials headed by Finance Minister Muhammad Aurangzeb. The opening session included top financial stakeholders such as the State Bank



of Pakistan (SBP) governor, finance secretary, and Federal Board of Revenue chairman.

The IMF team will remain in the country for around two weeks, engaging in extensive technical discussions with Pakistan's ministries and departments. The review aims to assess

progress under the ongoing loan programmes and determine whether Pakistan qualifies for the next tranche of funding.

According to reports in Dawn, the performance under the EFF and RSF as of end-June has been mixed, with several structural benchmarks and fiscal

targets falling short. The current phase of talks will focus on corrective measures, which must be mutually agreed upon to ensure compliance with future biannual disbursement targets.

The IMF has previously emphasised the need for revenue mobilisation, energy sector reform, and fiscal consolidation as key priorities. Analysts believe Pakistan's government will have to make tough policy adjustments to stay on track with the programme, including possible tax reforms and subsidy cuts.

Pakistan entered the \$7 billion EFF agreement in July 2024 to stabilise its fragile economy amid growing external debt, dwindling reserves, and high inflation. The outcome of the ongoing review will be crucial for maintaining economic stability and investor confidence.

India Open to Using Nuclear Energy to Power Al Data Centre Growth

n a strategic move to meet the soaring power demands of artificial intelligence (AI)driven data centres, the Indian government is considering encouraging the use of small modular reactors (SMRs) — a compact form of nuclear energy to supply clean, round-the-clock power.

As AI adoption accelerates, data centres are becoming energy-intensive hubs, and traditional renewable sources such as solar and wind are often unable to provide consistent, baseload electricity. Nuclear energy, particularly

ing globally as a reliable alternative. Now, India is weighing the same path.

Sources told The Indian Express that the Ministry of Electronics and IT has indicated its willingness to support SMR deployment as part of the upcoming National Data Centre Policy. This would be a significant shift in India's energy strategy for digital infrastructure, aiming to provide long-term, carbonfree power to the fast-growing sector.

Globally, big tech players like Google and Microsoft have already signed agreements with nuclear providers to support their AI-powered data centres. These agreements help meet their ambitious net-zero commitments, something Indian firms will also face as pressure builds to decarbonize

operations. According to the International Energy Agency (IEA), data centre electricity consumption could double by 2026, driven by AI workloads. This could make net-zero targets extremely difficult to meet with existing energy mixes.

Although India has traditionally maintained tight controls over its nuclear infrastructure, the government has recently shown openness to allowing private sector involvement under strict regulations, especially for civilian and industrial applications.

If approved, this policy could place India among a small but growing list of countries leveraging next-gen nuclear technology to support digital infrastructure, while advancing clean energy goals. The move is still under discussion, but signals a bold step toward sustainable AI

The lease, valued at 975 crore over five years, marks one of the biggest commercial real estate deals in the city in 2025, according to real estate analytics firm Propstack.

As per the agreement, TCS will pay a monthly rent of 15.37 crore, translating to 87.70 per sq. ft., and has placed a security deposit of 25 crore.

"This lease stands out both in scale and financial commitment. It reaffirms Bengaluru's position as a top IT hub, especially in a year that has seen several key leasing activities by technology firms," said Raja Seetharaman, Co-founder of Propstack.

The new office space is expected to house thousands of

employees and will strengthen TCS's operational base in the city's western corridor, complementing its existing presence

in other tech zones. Earlier, TCS had signed another significant deal in Bengaluru — leasing 1.4 million sq. ft. at 360 Business Park in Electronic City for 2,130 crore over 15 years, spread across Towers 5A and 5B.




