19 Dead, 20 Injured In Bus-Lorry Collision In Telangana's Chevella

TPN BUREAU | Hyderabad, Nov 3:

ineteen people, including 13 women and a girl child, were killed and 22 others suffered injuries when a tipper lorry carrying gravel collided head-on with a public transport bus in Ranga Reddy district of Telangana on Monday, officia ls said. The tipper collided with the Telangana Road Transport Corporation (RTC) vehicle near Chevella, about 50 kms from Hyderabad, on Monday morning, resulting in the gravel falling on the bus.

A district official sai d 22 people suffered injuries in the mishap. Cyberabad Police Commissioner Avinash Mohanty said the drivers of both vehicles died in the accident. Noting that a head-on collision occurs when one of the vehicles is on the wrong side, he said the cause of the accident would be known after the inq uiry. With the gravel falling on the bus, several passengers got trapped inside the vehicle and officials carried out relief measures using ea rthmovers. The passengers of the bus were brought out of it, a police official said.

In a post on X, Prime Minister Narendra Mo di expressed grief over the loss of lives in the accident. He announ ced a compensation of Rs two lakhs to the families of those who died, and Rs 50,000 each to

the injured. "I extend my deepest



time. I pray that the injured recover quickly,' he said. Telangana Transport Minister Ponnam Prabhakar, who visited the government hospital at Chevella, where the accident victims were admitted, said, "19 people were killed in the accident". He said 72 people were in the ill-fated bus , which was proceeding to Hyderabad from Tandur in Ranga Reddy disawake, leaving him trict early Monday mor half-buried in gravel. ning. Chief Minister A Revanth Reddy held a tele-conference with ministers and officials on the accident. The

'Several people were buried under the gravel. The tipper lorry came from the opposite

direction. I was seated on the left side of the bus. We managed to cli mb out, but those who were sitting behind the driver couldn't make it — some of them died. I was seated three rows behind the conductor,' he told mediapersons.

He further said he opened a window and escaped, with six others following. Later, another person broke the window panes to free more passengers. A doctor at the government hospital in Chevella said the accident victims suffered fractures, facial, abdominal and leg injuries. The injured were undergoing treatment, including administration of IV fluid, TT injections and referred to major state-run hospitals in Hyderabad.

According to TV visuals, half the bus was filled with gravel, trapping passengers inside. The authorities deployed heavy earthmoving equipment to clear the wreckage of the ill-fated bus. Meanwhile, Chevella MLA Kale Yadaiah attributed the accident near Chevella to the narrowness of the road.

Chevella Inspector Sridhar sustained minor injuries during a rescue operation after an excavator ran over his leg, a police official

NDA Ahead by A Whisker In **Bihar, Predicts Chanakya**

s Bihar approaches its 2025 Assembly elections, the state appears set for another razor-thin contest reminiscent of the 2020 showdown between the National Democratic Alliance (ND A) and the Mahagathbandhan (MG B). With slender margins likely to decide dozens of constituencies again, political analysts predict an intensely competitive race where youth sentiment, caste equations, and fragmented opposition votes could tilt the balance.

The 2020 Assembly election remains the closest in Bihar's history. The difference in vote share between the NDA and the MGB was barely 0.03% a mere 12,678 votes out of nearly 3.5 crore polled. Forty-three constituencies were decided by less than 2.5% of the votes, including 17 seats with margins under 1%. Yet, the NDA scraped past the majority mark of 122 by just three seats. Smaller parties such as the Lok Janshakti Party (LJP) and AIMIM, with a combined 24% vote share, played spoiler roles in several key constituencies, reshaping the final outcome.

Changing Narratives and Election Themes

Five years later, both alliances are preparing to repeat and refine their strategies. The NDA is expected to bank on nationalistic themes and narratives tied to Operation Sindoor, highlighting the central government's actions under President Donald Trump-aligned global diplomacy and national security cooperation trends that the BJP is amplifying domestically. In contrast, the MGB is keeping its focus on state-level concerns such as unemployment, migration, and development issues that particularly resonate with the youth. Unemployment remains an emotional issue since Tejashwi Yadav's 2020 campaign pledge of 10 lakh government jobs made him a household name among job-seeking youth.

That promise still shapes MGB's messaging, alongside a renewed emphasis on social justice and economic transparency. The Congress bency, the NDA alliance appears and Left parties have joined forces marginally ahead in pre-poll as-

under the MGB umbrella, though seat-sharing disputes persist and could weaken coordination on the ground.

New Players and Vote Division

Adding a twist to this fragile equation is political strategist Prashant Kishor, who has launched the Jan Suraaj Party. While his movement boasts over one crore members and promises clean governance, Kishor's candidates are contesting selectively across constituencies. Analysts suggest Jan Suraaj is unlikely to win any seats but could fracture anti-incumbency votes, inadvertently benefiting the NDA by cutting into the MGB's traditional support base. Similarly, Chirag Paswan's LJP, which had dented JD(U) numbers significantly in 2020, is expected to influence limited pockets this time without altering the overall seat arithmetic. AIMIM's influence, once notable in the Seemanchal belt, appears to have waned considerably after four of its five sitting MLAs defected to the RJD.

Social Composition and Voter

The traditional caste matrix in Bihar continues to influence voter behavior, but a steady shift toward issue-based voting, particularly employment, migration control, and honest governance is increasingly visible. Women voters, who were pivotal in the NDA's 2020 performance, appear to lean once more toward the alliance, influenced by recent welfare payments and targeted development initiatives.

Conversely, the youth remain largely behind Tejashwi Yadav. His leadership continues to evoke sympathy tied to the Lalu Prasad Yadav legacy, particularly among backward and minority communities. Minority voters, concentrated in Purvanchal and Champaran, are projected to play a decisive role, though the absence of AIMIM's previous traction could slightly limit MGB's gains.

According to officials, the arrests were made based on the testimony of Janardhan Rao, the prime accus ed in the case, which led to further investigation and collection of kev evidence implicating Jogi Ram esh and his associates.

In the early hours of Sunday, a joint team comprising the Excise Department, the Special Investigation Te am (SIT) probing the case and local police reached Jogi Ramesh's residence at Ibrahimpatnam in NTR District. After issuing formal search notices, the officials conducted raids and later arrested Jogi Ramesh and

to the Excise Office in Gurunanak Colony, Vijayawada, where SIT officials interrogated Jogi Ramesh. His brot her Ramu was also questioned separately, particularly about their alleged links and communications with Janardhan Rao.

Following the interrogation, both were taken for medical examinations and then produced before the magistrate. The SIT sought judicial custody, citing the need for further investigation, after which the court remanded both till November 13. He chaired a review meeting with AP-TRANSCO and NRED-CAP officials at Vidyut Soudha, Vijayawada on Monday. Committee members Giddi Satyan arayana (MLA, Gannavaram, Konaseema district), Kumar Raja Varla (MLA, Pamarru). TPN Bureau, Nov 3 Amaravati: The Andhra Pradesh gover nment on Monday acco rded administrative sa nction for Rs 2,637 crore payable to power distribution companies as an advance claim of tariff subsidy for the third quarter of the current fiscal, said an official.

Energy Department Special Chief Secretary K Vijayanand said the Member Convenor, An dhra Pradesh Power Coordination Committee

(APPCC) has informed that the distribution companies (DISCOMS) have submitted their advance claims towards tariff subsidy for Q3, FY26, which applies to all categories of power consu mers.

Further, the Member Convenor requested the government to arrange the funds. "Government hereby accord administrative sanction for an amount of Rs 2.637 cr ore to the Member Convenor, AP CC towards



advance claim of tariff subsidy for third quarter of financial year 2025-26 payable to the

APDISCOMS," sa id Vijayanand in a government order. As per Section 65 of the Electricity

Act, 2003, the state governme nt is required to pay the amount of subsi dy in advance to the DI SCOMS every quarter, said Vijayanand, who is also Andhra Pradesh Chief Secretary.

REC Approves 7,500 Crore Funding for Brookfield's 1,040 MW Green Power Project in Andhra Pradesh

VIJAYAWADA: In a major boost to Andhra Pradesh's clean energy ambitions, the Rural Electrification Corporation (REC) has sanctioned 7,500 crore in funding for Brookfield's 1,040 MW hybrid renewable energy project in Kurnool district, marking the largest REC sanction ever extended to a private-sector project.

The project, being developed by Evren—a joint venture between Brookfield and Axis Energy comprises 640 MW of wind and 400 MW of solar capacity, with a total estimated cost of 9,910 crore. Evren has already outlined plans for over 3 GW of renewable projects

across Kurnool and Anantapur, forming part of Brookfield's broader 8,000 MW clean-energy pipeline in Andhra Pradesh. with a total investment of 50,000 crore.

This milestone follows Minister Nara Lokesh's meeting with Brookfield Global President Connor Teskey in London in August 2025, where both sides explored collaboration opportunities in renewable energy, AI-ready data centers, and green infrastructure.

Brookfield, one of the world's largest alternative investment managers with over US\$1 trillion in assets under management, holds a global leadership position in renewable power, boasting 46 GW of installed capacity and a 200 GW development pipeline. Its India portfolio spans renewable energy, infrastructure, data centers, and real estate, with Andhra Pradesh emerging as a key hub in its expanding green footprint across Asia.

According to industry experts, the Kurnool project is the first in India to integrate state-level grid connectivity with a firm and dispatchable renewable power purchase agreement (PPA) under the Firm and Dispatchable Renewable Energy (FDRE) framework. The hybrid wind-solar model, supported by battery storage, will deliver round-theclock green power, enhancing grid stability and reliability.

Speaking on the development, Andhra Pradesh HRD, IT, Electronics and RTGS Minister Nara Lokesh said, "Andhra Pradesh is rapidly emerging as India's renewableenergy hub. We are proud to partner with global leaders like Brookfield to build sustainable infrastructure that creates jobs, drives industrial growth, and strengthens our energy

YS Jagan to Visit Cyclone-Hit Farmers in Krishna District Today

TPN Bureau | Nov 3 | VIJAYAWADA: Former Chief Minister and YSR Congress Party (YSRCP) President YS Jagan Mohan Reddy will visit cyclone-affected areas in Krishna district on November 4 (Tuesday), to assess the extent of damage caused by Cyclone Montha and interact with affected

According to the schedule released by the YSRCP Central Office. Jagan will depart from his residence in Tadepalli at 9:30 a.m., traveling through Penamaluru Center, Vyyuru Byp ass and Pamarru Bypass before reaching Guduru village in the Pedana constituency.

During the visit, the former Chief Minister will inspect cyclonedamaged agricultural fields and speak directly with farmers to understand their challenges and losses following the severe storm. He is also expected to review the relief measures being implemented in the region and gather firsthand feedback from the farming community.

After completing the field visit, YS Jagan will return to Tadepalli via the Avanigadda highway in the afternoon.

Party sources said the visit aims to highlight the plight of farmers whose crops were devastated by the cyclone and to reiterate YSRCP's demand for immediate compensation and comprehensive relief from the state government.

Cyclone Montha, whi ch recently struck coastal Andhra Pradesh, caused extensive damage to paddy and other crops across multiple districts, including Krishna, Guntur and Dr BR Ambedkar Konaseema. The YSRCP leadership has been urging the government to expedite enumeration of losses and provide timely assistance to affected

State turned into a criminal regime targeting Opposition: Sajjala



TPN/VIJAYAWADA Nov 3: YSR Congress Party (YSRCP) State Coordinator Sajjala Ramakrishna Reddy has accused the ruling coal ition in Andhra Pradesh of dismantling democratic institutions and converting the State into a "criminal regim e." Addressing a press conference at the YS-RCP headquarters in Tadepalli on Monday, Sajjala said that since June 2024, constitutional governance has been replaced by a vindictive political system that shields wrongdoers and targets political oppon

He alleged that the ar-

rest of former minister Jogi Ramesh exemplified the regime's vindictive approach. "The government operates on a formula arrest first, script later. Police fabricate evidence, plant devices, force confessions and jail opponents without trial. Officers who refuse to comply are sidelined, while those who act as political agen ts are rewarded," he claimed. Calling the present administration a "political syndicate, not a government," Sajjala said it rules through fear, institutional abuse and fabricated cases rather than democratic principles. He cited the

fake liquor mafia as an example of state-protected organised crime, referring to the illicit factory in Tamballapalle allegedly linked to a TDP candidate. "Over one lakh belt shops are operating across the State. Fake liquor factories run like soda units. The introduction of QR codes is an indirect admission of failure, yet the government turns a blind eye," he said.

Sajjala also accused the government of scripting conspiracies and manufacturing evidence. Referring to the Janardhan Rao case, he questioned the identical clothing seen in airport

and custody videos, the orchestrated return from Africa, and the conveniently "lost" phone in Mumbai. "FIRs today are political stories, not investigative reports," he rem

Condemning the alleged targeting of social media activists, he cited the case of Savindra, where narcotics were allegedly planted, and truth emerged only after High Court and CBI intervention. "Youth are being jailed for criticism, not for crime," he said. On the Tuni minor case. Sajiala accused the government of shield-

ing culprits and punishing whistleblowers. He also blamed the State for ignoring warnings in the Kasibugga temple tragedy, comparing it to previous failures at Tirumala and Simha chalam.He charged Chief Minister N Chandrababu Naidu and Minister Nara Lokesh with running a personal vendetta regime "guided by a Red Book" to silence dissent. "This is tyranny, not democracy. Even dictators did not destroy institutions so blatantly," Sajjala said, urging the media and civil society to expose the "systematic erosion of democracy."

Steel Bridge Works Accelerate to Strengthen Amaravati Seed Access Road Connectivity

Tpn Bureau, Amaravathi Nov 3: Construction activity around the Seed Access Road leading to Amaravati, the state capital, has picked up significant momentum with key infrastruc-

ture projects entering an advanced stage. The Amaravati Development Corporation Limited (ADCL) has launched the construction of a major steel bridge across the Krishna Western Delta main canal near K.L. Rao Colony, with an estimated cost of Rs. 70 crore.

The project aims to provide seamless connectivity between E-3 road and the old National Highway route.Ac-

cording to ADCL officials, the steel bridge, which will stretch for 128 meters and carry four lanes, is being built as part of the route connecting the Prakasam Barrage to Undavalli Centre. The bridge will link the Seed Access Road at K.L. Rao Colony, serving as a crucial alternative for vehicles heading toward Amaravati. Once operational,

vehicles will no longer

need to travel over the Krishna bund (karakatta); instead, they can move directly along the modern bridge structure built over the delta canal. Public Works Department (PWD) engineers have already initiated pillar construction at the PWD workshop site, marking a major milestone in the project. ADCL engineers stated that they are determined to complete the

project within three months, ensuring a faster and safer travel route to the capital zone. In continuation of the improved transport connectivity plan, ADCL has also proposed another overbridge that will emerge from K.L. Rao Colony and connect to National Highway-16. The proposed flyover will need to cross both the Chennai–Kolkata railway line and the Krishna Delta canal, making it a complex yet essential engineering task. Officials have revealed that tenders for this second bridge will be floated soon, and the project is expected to enhance the traffic flow between Undavalli, Penumaka, and the Amaravati capital region. Meanwhile, the construction work on the Seed Access Road itself has gathered pace due to strong cooperation from local farmers. Land acquisition, which had earlier slowed progress, is now moving forward smoothly after farmers from Penumaka

and Undavalli voluntarily provided essential portions of their land for the project.

South Korean Forum to Establish \$480 Million Cancer Center in Donakonda

TPN BUREAU, DONA-KONDA | NOV 3 : In a major boost to Andhra Pradesh's healthcare and investment landscape, the World Smart City Forum (WSCF) of South Korea has announced plans to set up the Chan Jong Un Challa Cancer Center in Donakonda, Prakasam district. The proposed project will be established on a 25-acre site at an estimated cost of 480 million US dollars. from MEPMA, District Thunderstorms Forecast for Andhra Pradesh from **November 4, Says IMD**

TPN | Vijayawada, November 3, 2025: The India Meteorological Department (IMD) has forecast thunderstorms accompanied by lightning across several parts of coastal Andhra Pradesh and Rayalaseema between November 4 and 6. The alert comes as weather conditions in the region indicate a gradual shift influenced by weak northeast monsoon activity.

According to IMD officials, lower tropospheric northwesterly winds are currently prevailing over Andhra Pradesh and Yanam, which could trigger convective weather across multiple districts in the coming days. Despite the onset of the northeast monsoon, rainfall activity so far has remained limited, leading to mild temperature variations and low humidity levels.

On Sunday evening, parts of Visakhapatnam city and nearby districts

experienced brief but to lightning strikes. intense thundershowers, signalling a change in local atmospheric conditions. The department noted that isolated thunderstorms and lightning incidents are expected to continue, particularly during late afternoon and evening hours. Authorities have urged residents to exercise caution during this period, especially in low-lying areas prone to sudden waterlogging

and regions vulnerable

Farmers have been advised to postpone activities such as fertilizer application, irrigation. and open-field work during storm periods to

avoid potential hazards. Disaster management teams have also been placed on alert across key coastal districts. Local bodies have been directed to monitor weather advisories and disseminate updates to the public through official communication

channels. The IMD will continue to issue regionspecific forecasts to assist in preparedness and response measures. Meteorologists added that the upcoming thunderstorm activity could help bring some relief to parts of Andhra Pra desh that have been experiencing dry conditions since late October, though more consistent monsoon rainfall is still awaited to improve overall moisture levels across the region.

Locals Block Bid to Seize Park Land

3 Rajanagaram, East Godavari: Tensions have simmered in the Diwan Cheruvu area after local residents raised alarm over an alleged attempt to encroach upon a common site designated for a public park in the Midhulanagar layout of Palacherla village. The disputed land, measuring about 1,500 square yards and registered under Survey No. 331/2, was approved in 2005 by the Director of Town and Country Planning (DTCP) under Layout Permission No. 20/2005/R1.

According to villagers, a group identified as a local land grabbing syndicate recently erected green screens and began cleaning operations at the site, which was reserved as a community park. Residents suspect that these are initial steps to illegally occupy the property. "Our children's park is being taken over by real estate gangs," said one of the plot owners. "We have lodged a complaint with the panchayat, and we will not allow our public space to be stolen. "Local residents also insisted that putting up a green curtain does not mean an encroachment will succeed. They yowed to protect the land earmarked for the comm

complaint from plot owners, Diwan Cheruvu Panchayat Secretary Koochumanchi Hanumanth Rao visited the site and warned against any illegal activity. From Purdah to IPS: Shaik Shereen Begum's Journey of Courage

(First Muslim Woman IPS Officer in Andhra Pradesh)













Q1: Please introduce yourself and share your early life background.

A: I am Shaik Shereen Begum, born on 1 July 1972 in One-Town, Wynchipet, Vijayawada—a Muslim-majority area in Andhra Pradesh. As the eldest of three daughters in a lower-middle-class family, I grew up amidst illiteracy and rigid conservative ideologies where education, especially for girls, was rarely a priority. Yet, my mother recognized its transformative power, and my father championed our pursuit of higher studies and careers despite fierce societal resistance.



A: The challenges were relentless-enforced purdah, home confinement, and constant discouragement from relatives and neighbors: "Why send her to school? Who will marry educated girls? Where will you find qualified grooms? Too much freedom will make them elope." Even attending university felt like a transgression. These restrictions, however, only fueled my inner fire, transforming obstacles into unyielding

Q3: How did you manage to prepare for competitive exams with limited resourc-

A: Financial constraints left me unable to buy books or magazines. I turned to secondhand markets—Ber Sarai and Munirka in Delhi, Koti and Sultan Bazaar in Hyderabad scouring footpaths on Sundays. The libraries of Andhra University, Osmania University, and JNU became my sanctuaries. With these, I cleared the State Group-I services in my very first attempt, despite falling short in UPSC initially.

Q4: You faced an unjust allocation after selection—what happened, and how did

A: The APPSC wrongly allotted me and a few others to the Department of Employment and Training, far from my calling. Driven by an unshakable desire to serve the public, I fought a 10-year legal battle across all forums, culminating in victory at the Supreme Court. Justice prevailed, and I entered the Police Services as Deputy Superintendent of Police

Q5: How was your training experience, and

what recognition did you earn?

A: My enthusiasm doubled upon joining. I completed probationary training with utmost determination, discipline, and dedication, earning the titles of Best All-Rounder, Best Indoor, and Best Firer in my batch of Dv.S.P.s. Though not assigned a sub-division initially, I excelled across CID, ACB, Crimes, Administration, and Intelligence.

Q6: Walk us through your professional journey and current role.

A: I began as Dy.S.P. in CID (Rajahmundry, 2015), served as Addl. S.P. in Srikakulam (2007–), DCP (Crimes) in Vijayawada, Joint Director in ACB, and Superintendent of Police in the Intelligence Security Wing (2020-). I also held key roles as Competent Authority / Special Officer for A.P. State Waqf Board and VC & MD of A.P. State Minorities Finance Corporation. Currently, I serve as Survey Commissioner of Waqfs (on deputation to Minorities Welfare Department). working to uplift minority communities—especially protection of waqf properties for the welfare & development of the Muslim

Q7: What are your academic and professional milestones?

A: I hold an M.Sc. in Geophysics with Hydrology Specialization (University First Rank, Andhra University). I joined Group-I Services in 2001 and was conferred IPS in 2017. In 2023, I became the first Muslim woman IPS officer in Andhra Pradesh—and earlier, the first Muslim woman Group-I officer in the combined state. I also pioneered water rappelling as the first woman police officer at Khatika Waterfalls, Araku.

Q8: What awards have you received in recognition of your journey?

A:Pratibha Award (8 March 2018) from the Government of A.P. for overcoming hardships as a Muslim woman.

Best All-Rounder, Best Indoor, Best Firer during police training. University First Rank in M.Sc. (Geophysics).

Q9: How does your current work reflect your personal mission?

A: In the Minorities Welfare Department, I focus on breaking cycles of backwardnessespecially among minority girls. By inspiring

parents to prioritize education, I aim to empower the next generation, just as my parents did for me. My journey—from purdah to police service—is proof that determination can

Q10: What message do you have for young women, especially from minority commu-

A: Never let circumstances define your limits. Education is your strongest weapon, resilience your shield, and service your purpose. The path may be tough, but every step forward inspires a thousand others. From a girl in purdah to the first Muslim woman IPS officer in Andhra Pradesh—I stand as living proof: dream fiercely, fight wisely, and rise

Q11: Civil services—especially uniformed services—are largely male-dominated. Coming from a Muslim community with numerous restrictions, why did you choose this path? What inspired you?

A: Becoming a civil servant, particularly a police officer, was my childhood dream—and my father's as well. The first movie I ever watched with him in a theater was Karthavy am. Its powerful portrayal of a woman in uniform left an indelible impact on me. That moment ignited my resolve to join the IPS and serve with honor, breaking barriers in a field dominated by men.

Q12: Who has been your greatest pillar of support throughout this journey?

A: Undoubtedly, both my father and mother. They held a steadfast vision: education alone can transform lives, bring dignity, and command respect. Despite societal pressures, they championed my studies and aspirations, standing firmly by me at every step.

Q13: Preparation and coaching for civil services are often expensive. Given your lower-middle-class background, how did you manage?

A: With my father working in the railways and the responsibility of educating my siblings, resources were extremely limited. moved to Hyderabad, lived in a modest ₹300 rented room, and attended coaching under tough conditions. Every sacrifice was fueled by determination—nothing could deter me from my goal.































PM Modi Launches ₹1 Lakh Crore RDI **Fund to Boost Private R&D**

Prime Minister Narendra Modi on Monday, November 3, 2025, launched the ₹1 lakh crore Research, Development and Innovation (RDI) Fund to spur private sector investment in research and development across India. The launch took place at the inaugural Emerging Science, Technology and Innovation Conclave (ESTIC) 2025 at Bharat Mandapam, New Delhi, which brought together policymakers, innovators, and global

The RDI Fund, to be operated under the Department of Science and Technology (DST), will follow a two-tiered funding structure. The initiative aims to encourage collaboration between industry, academia, and startups, ensuring that India's private sector actively participates in cutting-edge research while advancing the government's Viksit Bharat 2047 vision.

Prime Minister Modi highlighted the importance of private sector engagement in research, stating that innovation-driven growth is essential to achieving global leadership in science and technology. The RDI Fund is designed to support highimpact projects, provide financial incentives, and create an ecosystem where private enterprises can contribute meaningfully to India's research

landscape. Union Minister of State

(Independent Charge) for Science and Technology, Jitendra Singh, emphasized that the fund would enable strategic partnerships and resource-sharing, helping Indian innovators compete on a global scale. The two-tier structure of the fund will include grants for exploratory research and matched funding to leverage private capital for large-scale R&D projects.

The ESTIC 2025 conclave, where the fund was unveiled, aims to serve as a platform for dialogue between government bodies. private enterprises, and international stakeholders to strengthen India's innovation ecosystem. The initiative aligns with India's broader strategy of fostering a knowledge-driven economy, strengthening scientific research, and creating new avenues for technological leadership.

The Chief Minister clarified that any decisions regarding a cabinet reshuffle would be discussed with the Congress high command after the Bihar assembly elections, scheduled for November 6 and 11. Yogi Adityanath's 'Pappu', 'Tappu', 'Akku' Jab At Opposition Leaders In Bihar

As Bihar gears up for its two-phase assembly elections on November 6 and 11, Uttar Pradesh Chief Minister Yogi Adityanath and Prime Minister Narendra Modi launched sharp attacks on the opposition INDIA alliance, targeting Congress, RJD, and Samajwadi Party leaders.

Addressing a rally in Keoti, Darbhanga, Yogi mockingly referred to Congress leader Rahul Gandhi, RJD's Tejashwi Yadav, and Samajwadi Party chief Akhilesh Yadav as "Pappu", "Tappu", and "Appu", calling them "three monkeys" in a jab at Mahatma Gandhi's famous proverb. He alleged that the opposition embraces criminals, compromises state security, and divides people on caste lines. "With guns and pistols, they tainted Bihar's system... these people hug and mingle with family mafias and disrupt security," he said. Yogī further

described them as "blatant Hindu traitors" and accused them of undermining faith and national

Meanwhile, Prime Minister Modi held a massive roadshow in Patna on Sunday, urging voters to support the NDA. Modi slammed Congress over its response to Operation Sindoor, saying the party and its allies opposed India's success while Pakistan celebrated. He also highlighted internal conflicts within the opposition, claiming that Congress and RJD clashed over seat-sharing with the RJD allegedly forcing its candidate as the Chief Ministerial nominee.

The remarks come amid intense campaigning in the 243-member Bihar Assembly elections, where constituencies like Keoti are witnessing multi-cornered battles involving the BJP, RJD, AIMIM, and Prashant Kishor's Jan Suraaj party. Both leaders emphasized the NDA's de-



velopment agenda and accused opposition parties of obstructing governance and security.

SC to Set Norms for Feeding Stray Dogs in Government Premises

The Supreme Court on Monday, November 3, 2025, said it would soon issue directions to regulate the feeding of stray dogs within government buildings and institutional premises. The move comes amid concerns about unregulated feeding of dogs in office and institutional areas. which the court noted could affect hygiene and

A bench comprising Justices Vikram Nath, Sandeep Mehta, and N.V. Anjaria said the guideemployees are supporting and encouraging dogs in that area," the bench observed during of government

the hearing.

The case pertains to broader issues of stray dog management across the country, balancing animal welfare with public safety. While authorities have often faced challenges in controlling stray populations in urban spaces, unregulated feeding in government areas has been highlighted as a concern by the petitioners

The Supreme Court's forthcoming directions are expected to provide a uniform framework. guiding government offices, schools, and other public institutions on responsible practices regarding stray animals. This could include specifying designated feeding zones, timings, and responsibilities to ensure that employees' compassion for animals does not compromise cleanliness, safety, or the functioning premises

Animal welfare activists have welcomed the court's attention to the issue but stressed that any order should also ensure humane treatment of dogs, including regular vaccination drives, sterilisation programs, and the creation of community feeding facilities outside institutional areas.

The bench, headed by Justice Vikram Nath, is set to issue the detailed guidelines on November 7, 2025, offering a clear framework for government institutions to manage stray dog interactions responsibly while maintaining public safety and institutional discipline.

The case reflects the growing focus on coexistence between humans and stray animals in urban spaces, seeking a balance between compassion for animals and practical governance.

Displaced Palestinians Shelter in Gaza Cemeteries

In the southern Gaza Strip, cemeteries have become makeshift homes for displaced Palestinians fleeing ongoing conflict. Families are living among gravestones, using them as seats, tables, and walls for their temporary shelters, as war and destruction have left them

with few alternatives. In Khan Younis, Maisa Brikah and her children have spent the past five months in a dusty, sun-baked cemetery. Around 30 families now reside in the same area, turning solemn resting places into crowded, improvised living spaces. "We have nowhere else to go." Brikah said, highlighting the stark realities

of life in a conflict zone. The situation reflects the severe humanitarian crisis in Gaza, where intense fighting and displacement have overwhelmed official shelters. Cemeteries, normally places of mourning, have become refuges for survival. Residents face extreme challenges, including limited access to food, clean water, and medical care, as well as exposure to the elements in open-air

China Refutes Trump's Nuke Testing Charge: "Beijing Abides By Commitment"

China has firmly rejected former US President Donald Trump's claims that it has been conducting secret nuclear tests, emphasizing that Beijing continues to honor its commitments under international agreements. Speaking at a regular press briefing, Chinese Foreign Ministry spokeswoman Mao Ning said, "As a responsible nuclearweapons state, China has always adhered to the path of peaceful development, pursued a policy of no first use of nuclear weapons, upheld a self-defence nuclear strategy, and abided by its commitment to suspend nuclear testing."

Mao added that China hopes the United States will take "concrete actions to safeguard the international nuclear disarmament and non-proliferation regime and maintain global strategic balance and stability.'

Trump, in a recent interview with CBS's 60 Minutes, claimed that China, Russia, North Korea, and Pakistan have conducted underground nuclear tests



unknown to the public, suggesting that the US should follow suit. He stated, "Russia's testing, and China's testing, but they don't talk about it... They test way underground, where people don't know

exactly what's happening with the test. You feel a little bit of a vibration." His comments sparked

confusion about whether the US intends to conduct its first nuclear explosion since 1992. Trump indicat-

ed plans for nuclear testing akin to other nations, while his Energy Secretary, Chris Wright, clarified on Fox News that any upcoming tests would be "system tests" or "noncritical explosions, which do not involve nuclear detonations but instead assess other components of nuclear weapons.

Experts note that no country besides North Korea is known to have conducted nuclear detonations in recent decades. Russia and China have not tested nuclear weapons since 1990 and 1996, respectively. Both nations remain signatories to the 1996 Comprehensive Nuclear-Test-Ban Treaty (CTBT), which prohibits all nuclear explosions for military or civilian purposes.

China's response underscores its continued commitment to global non-proliferation, countering Trump's unverified allegations and highlighting tensions over nuclear policy discussions amid US-Russia-China strategic

Khawaja Asif Blames India for 'Two-Front War' With Pakistan

Pakistan's Defence Minister Khawaja Asif has once again accused India of orchestrating tensions along Pakistan's eastern and western borders, claiming New Delhi is keeping Islamabad occupied on "two fronts." Speaking to Geo News, Asif linked India to the recent clashes with Taliban forces along the Durand Line and airstrikes on Kabul, suggesting that Afghanistan was acting as a "proxy" for India.

"If there is a need for evidence, then we have it about what involvement India has in terrorism [in Pakistan] and how it wants to keep us busy on two fronts: the eastern and western," Asif said. However, he did not provide any verifiable proof to substantiate his claims, drawing skepticism from observers.

Asif also alleged that the Taliban leadership was being manipulated by New Delhi, asserting, "The people in Kabul pulling the strings and staging the puppet show are being controlled by

Delhi," in remarks to Dawn. His comments come amid ongoing ceasefire talks and mediation efforts by Qatar and Turkey, aimed at stabilizing relations between Pa-

kistan and Afghanistan.

expressed cautious optimism, saying, "Everyone is onboard—politicians, the establishment, and the Pakistani nation that an immediate solution to the Afghanistan issue is very necessary, which is that terrorism from Afghan soil should

be completely stopped." Tensions between the two neighbors have escalated since October 9, when explosions in Kabul

killed over 70 people and injured hundreds. Taliban authorities blamed Islamabad for the violence, though Pakistan has neither confirmed nor denied involvement, instead pointing to groups like Tehreek-i-Taliban Pakistan (TTP) using Afghan territory for attacks on Pakistani

The Defence Minister's statements highlight Pakistan's continuing security concerns, particularly amid a surge in domestic terrorism and several fatalities among security personnel during intelligence-based operations. Analysts note that Asif's repeated claims linking India to Afghanistan may further strain relations in an already volatile regional landscape, even as efforts at dialogue continue to maintain the fragile ceasefire.

Busan Erika Kirk, widow of conservative activist Charlie Kirk and newly appointed CEO of Turning Point USA, has broken her silence following criticism over a viral video showing her hugging US Vice President JD Vance at a recent event. In an emotional interview with Fox News at Turning Point USA headquarters, Erika addressed both the controversy and the ongoing investigation into her husband's murder.

"There were cameras all over my husband when he was murdered. There have been cameras all over my friends and family, mourning. There have been cameras all over me-analysing my every move, my every smile, my every tear," she said. Erika emphasized the need for transparency in the Tyler Robinson case, the man accused of killing her husband. "Why not be transparent? There's nothing to hide. Let everyone see what true evil is. This is something that could impact generations to come," she added.

The controversy over her public appearances intensified after footage emerged of Erika introducing Vice President Vance in Mississippi. During the event, the two shared a close embrace, prompting scrutiny from commentators questioning the timing and appropriateness of the gesture. Erika acknowledged the similarities she sees between her late husband and Vance, stating, "No one will ever replace Charlie, but I do see some similarities of my husband in JD, Vice President JD Vance.'

The interview also revealed deeply personal moments, including Erika breaking down while watching a video of Charlie. "Sorry, guys. Just give me a second," she tearfully told the interviewer, describing it as the longest video she had watched of her late husband. Reflecting on her late

husband's mission to "save Western civilization," Erika said, "I didn't sign up for anything. I just married the love of my life." At Charlie Kirk's memorial on September 21, she delivered an emotional eulogy, expressing forgiveness toward the accused. "He wanted to save young men just like the one who took his life. That man, that young man, I for-give him," she said tearfully, underscoring her commitment to her husband's values even

velopment, Russia has launched its newest nuclear-powered submarine, Khabarovsk, designed to carry the 'Poseidon' nuclear drone - a weapon often described as a "doomsday missile" for its catastrophic potential. The submarine was launched at the Sevmash shipyards in Severodvinsk during a ceremony attended by Defence Minister Andrei Belousov, Naval Chief Admiral Alexander Moiseyev, and senior shipbuilding officials.

"This marks a significant event — the launch of the heavy nuclearpowered missile cruiser Khabarovsk," Belousov stated in his televised address, emphasizing that the vessel would enhance Russia's ability to secure its maritime borders and safeguard national interests across global waters.

Developed by Rubin, the Central Design Bureau of Marine Engineering, Khabarovsk is engineered to deploy advanced underwater weapons and robotic systems. It represents the next generation of Russia's strategic deterrent force, complementing its fleet of nuclear-capable submarines.

The GST portal has officially opened the window for filing the GSTR-9 annual return and GSTR-9C reconciliation statement for the financial year 2024-25. These filings are mandatory for all taxpayers registered under GST and provide a comprehensive summary of the year's tax transactions, including outward and inward supplies, tax paid, and input tax credit

GSTR-9 must be filed annually, consolidating all monthly or quarterly GST returns filed dur-

ing the year. GSTR-9C, applicable to taxpayers whose turnover exceeds the prescribed limit, serves as a reconciliation statement and requires certification by a Chartered Accountant or

Tata Motors Shares Fall 40% After **Demerger**



Shares of Tata Motors opened nearly 40% lower on Tuesday, triggering concern among investors. However, the company clarified that the sharp fall is a technical adjustment following the demerger of its commercial vehicle

The stock opened at ₹399, significantly down from Monday's close of ₹660.90, bringing the company's market capitalisation to around ₹1.45 lakh crore. Despite the steep fall, the move does not reflect any erosion in investor wealth, but rather a realignment due to the demerger.

As part of the restructuring, shareholders as of the record date (October 14) will receive one share of Tata Motors Commercial Vehicles Limited (TMLCV) for every share they held in Tata Motors. This adjustment explains the price drop in Tata Motors' existing stock, which now represents only the passenger vehicle, electric vehicle (EV), and Jaguar Land Rover (JLR)

The company's re-

structured entity is now listed as Tata Motors Passenger Vehicles Limited (TMPVL). Meanwhile, the commercial vehicle arm, TMLCV, will be renamed Tata Motors Limited after completing regulatory

TMLCV shares are not yet available for trading and will be listed separately in the coming 45-60 days, pending exchange approval. Also, derivative contracts for the old Tata Motors expired on Monday. New F&O contracts for TMPVL began trading on Tuesday, while TMLCV will not be available for F&O trading for now.

The BSE Sensex slipped 173.77 points, or 0.21%, to close at 82,327.05, snapping its two-day winning streak. Earlier in the session, it plunged as much as 457.68 points to a low of 82,043.14, reflecting investor caution amid global uncertainty.

The broader NSE Nifty fell 58 points, or 0.23%, to settle at 25,227.35. Among the 50 constituents, 30 ended in the red, 19 in green, while one remained unchanged.

Sectorally, IT and FMCG stocks bore the brunt of the sell-off. Major laggards included Tata Motors, Infosys, Hindustan Unilever, Bharat Electronics, ITC, and UltraTech Cement. The renewed tar-

iff threat has sparked fears of a further slowdown in global trade. dampening investor sentiment across Asian and European markets.

"With Trump's announcement of additional tariffs on Chinese exports, markets globally have turned risk-averse," said a market analyst at a domestic brokerage. "Investors are also booking profits ahead of key US economic data and corporate earnings reports due later this week."

The imposition of new tariffs threatens to disrupt fragile global supply chains already dealing with inflationary pressures and geopolitical uncertainties.

On the domestic front, concerns also linger over the impact of high gold and commodity prices on inflation and consumption, especially ahead of the fes-

tive season. Going forward, investors will closely watch developments around US-China trade talks, inflation data, and commentary from central banks for further cues.

WPI Inflation Eases to 0.13% in September on Lower Food and Fuel Prices

India's Wholesale Price Index (WPI)-based inflation cooled to 0.13% in September 2025, marking a steady decline from 0.52% in August and a significant drop compared to 1.91% in September 2024, according to data released by the government on Tuesday.

The moderation in wholesale inflation was primarily driven by a decline in prices of food articles, fuel, and manufactured goods, offering some relief amid persistent concerns over inflationary pressures in the

Analysts noted that softening prices in key segments - including vegetables, cereals, and cooking gas — played a major role in easing WPI inflation for the month. Crude petroleum prices also remained relatively stable, further contributing to the lower overall index.

The data suggests that supplyside pressures have started to ease, especially in the food and energy sectors, after months of volatility caused by global disruptions and erratic monsoon patterns.

"The decline in WPI inflation reflects improving supply chains and a drop in global commodity

inflation management, as it may

eventually translate into lower retail inflation (CPI) in the coming months. However, experts caution that external risks, including global oil price fluctuations and geopolitical tensions, remain potential challenges.

WPI inflation had been vola-

tile over the past year, touching negative territory for several months before turning positive in recent readings. The September figure reinforces a trend of moderation, which may provide additional space for the Reserve Bank of India (RBI) to maintain

a balanced monetary policy approach.

New research warns that raw milk cheeses may harbor the H5N1 avian influenza virus, even after extended ageing. The study, led by Cornell University and published in Nature Medicine, found that cheeses made from milk contaminated with H5N1 can retain infectious virus particles for up to 120 days double the 60-day minimum ageing period required by the U.S. Food and Drug Administration.

Researchers tested cheeses with varying acidity levels and discovered that those with a pH between 5.8 and 6.6. such as camembert. allowed the virus to survive. Highly acidic cheeses, like feta with a pH of 4.6 or lower, showed no detectable virus, indicating that lower acidity may neutralize H5N1.

"Our study focused on the persistence of highly pathogenic H5N1 in raw milk cheeses," said Diego Diel, professor of virology at Cornell's College of Veterinary Medicine. "Previous work has shown that infected cows shed high levels of the virus in milk, which can survive refrigerated storage for long periods.'

The findings raise concerns for consumers of unpasteurised dairy products and suggest that current ageing standards may be insufficient to eliminate avian influenza risks. Researchers recommend testing milk before use and applying mild heat treatments below pasteurisation levels. These steps could inactivate the virus while maintaining the characteristics of raw milk cheese.

Nicole Martin, assistant research professor and director of the Milk Quality Improvement Program at Cornell, emphasized the study's practical impact: "This research provides data-driven recommendations to help raw milk cheesemakers reduce risk during outbreaks affecting the milk

supply." The study highlights an overlooked pathway for avian influenza transmission and underscores the need for stricter safety measures in the production of raw milk cheeses, especially amid ongoing H5N1 outbreaks in livestock populations.

Two Indian Languages Among World's Most Spoken



While English continues to dominate global communication, two Indian languages— Hindi and Bengalifeature prominently among the most spoken

languages in the world. English tops the list with around 1.5 billion speakers worldwide, though only 390 million are native speakers. The majority use it as a second language, making it the most universal medium of communication today.

Following English, Chinese (Mandarin) is the world's most spoken native language, with an estimated 1.1 to 1.2 billion speakers, mainly in China and neighboring regions. Mandarin's influence continues to grow globally, particularly in business and international diplomacy.

Among Indian languages, Hindi ranks high with roughly 609 million speakers. While most are based in India, the Indian diaspora has contributed to its global reach. Hindi remains the most widely spoken of India's 22 official languages, reflecting its cultural and linguistic significance.

Bengali, the primary language of Bangladesh and India's West Bengal state, has around 280 million speakers. Its rich literary and cultural heritage has helped it maintain prominence both in South Asia and abroad.

Other major languages rounding out the global top list include Spanish, spoken by about 560 million people across Spain. Latin America, and the United States, and Arabic, with 330 to 420 million speakers across North Africa and the Middle East. Portuguese, with approximately 264 million speakers, is noted for its global cultural presence, particularly through Brazil's music, film, and literature.

Experts highlight that these statistics not only reflect native speakers but also account for the growing number of people using these languages as a second or foreign language. As globalization increases, understanding and learning widely spoken languages becomes crucial for cross-cultural communication, trade, and diplomacy.

The prominence of Hindi and Bengali underscores India's linguistic impact on the global stage, joining English, Mandarin, Spanish, and Arabic in shaping the world's communication landscape.

Toddler Dies After Choking on Bubble Tea in China

A three-vear-old toddler in China tragically died after choking on tapioca bubbles in his milk tea while playing on a trampoline, according to the South China Morning Post (SCMP). The incident occurred on October 19 at a shopping mall in Zhejiang province.

Eyewitnesses reported that the child collapsed suddenly while playing after consuming the drink. His parents rushed him to the hospital, where medical staff performed emergency treatment for over an hour. Despite their efforts, the toddler was pronounced dead.

The cause of death was identified as tapioca bubbles, approximately 10 mm in size, which were too large for the child's airway. The sticky texture of the bubbles also prevented successful removal, even when the mother attempted the Heimlich

The child's father, identified as Li. shared security footage from the mall showing the mother giv-



ing the toddler the bubble tea before the incident. Li appealed to the milk tea shop and the shopping center to take responsibil-

ity for the tragedy. The milk tea shop issued condolences to the family and highlighted that its online ordering system included a warning advising that children and elderly individuals consume the drink only under supervision.

The incident has sparked widespread discussion on Chinese social

media about parental responsibility and child safety. Many commentators emphasized that young children should not consume sticky foods or beverages while

playing. "Kids cannot eat tapi-

oca bubbles, jelly, or sticky rice, nor can they eat or drink while playing," one person wrote. Another added, "The parents are responsible for letting him play on a trampoline after drinking bubble tea." hazardous foods.

This heartbreaking event has reignited conversations around food safety and supervision, with many urging caregivers to exercise extreme caution when children consume potentially

Meta Denies Using Porn for AI, Blames Employee **Downloads**

Meta has rejected allegations that it used pornographic content to train its artificial intelligence models, claiming that any downloads of adult material were made by individual employees for personal use. The statement was made in a legal filing urging a US district court to dismiss a copyright infringement lawsuit filed by Strike 3 Holdings, a company producing adult films.

The lawsuit accuses Meta of using Strike 3's copyrighted videos to train an AI model that powers its video generator, Movie Gen. Meta countered that the lawsuit is based on "guesswork and innuendo," and called Strike 3 a "copyright

troll" filing extortive claims. Meta stated that there is no evidence the company instructed employees to download the content or that it had knowledge of the alleged 2,400 downloads. The firm also noted that AI research on "Multimodal Models and Generative Video" began in 2022, four years after the reported downloads, making a connection to AI training "implausible."



According to Meta, activity

es amounted to roughly 22 "disparate individuals downdownloads per year, suggesting loaded adult videos for personal use" rather than for AI purposes. Meta also emphasized that its user terms prohibit generating adult content with AI models, contradicting the claim that such material would be used for AI training.

The lawsuit alleges that Meta used a "stealth network" of 2,500 hidden IP addresses to download the videos and is seeking \$350 million in damages. Meta's filing argued that Strike 3 failed to identify the individuals allegedly involved, their roles at Meta, or whether any content was used in AI training.

The case comes amid heightened scrutiny of Meta's AI practices, following reports that internal AI rules allowed chatbots to engage in inappropriate conversations, spread false medical information, and assist in making racist arguments—issues the company has since addressed.

Meta's spokesperson reaffirmed, "We don't want this type of content, and we take deliberate steps to avoid training on this kind of

Death Industry Booms Amid Ageing, Lonely South Korea

In South Korea, a growing number of people are finding work in the "business of death" as the nation grapples with an ageing population and rising loneliness. With birth rates among the lowest globally and nearly half of the population aged 50 or older, the demand for funeral services and posthumous care is surging.

At the Busan Institute of Science and Technology, students train as future funeral directors, practicing traditional rites on mannequins draped in funeral cloth. "With our society ageing, I thought the demand for this kind of work would only grow," said Jang Jin-yeong, a 27-year-old student. Another, Im Sae-jin, was inspired by his grandmother's funeral to pursue the profession.

Single-person households now make up about 42 percent of South Korean homes, giving rise to specialized cleaners who manage the homes of those who die alone. Former classical musician Cho Eunseok, 47, has handled several such cases, sometimes months after the person's death. He described homes as "like their portraits," often filled with neatly arranged belongings, soju bottles, and dusty gifts.



South Korea also records the highest suicide rate among developed nations, and these "lonely deaths" often leave traces requiring sensitive handling. Cho has even started developing devices to detect unattended deaths, which can cause

environmental hazards and pest infestations if left unaddressed.

The work often goes beyond cleaning. Kim Seok-jung, another professional, turned a late lyricist's unpublished songs into a tribute for the be-

reaved family. Cho recounted helping a teenage girl living alone in a tiny gosiwon, who later took her own life. He rescued her pet hamster, preserv-

ing a fragment of her life. Veterans like Kim Doo-nyeon note increasing recruitment of

young people into funeral services. "When someone dies alone, everything must be cleared away," he said. Despite the challenges, students like Im recognize the importance of this growing yet emotionally demanding profession.




