Top naxal commander Madvi Hidma among 6 Maoists killed in AP encounter

Maredumilli: Top naxal commander Madvi Hidma and his wife were among the six Maoists killed in an encounter with security personnel in Andhra Pradesh's Alluri Sitaramaraju district on Tuesday, police said.

The death of Hidma, an alleged mastermind of several attacks, was described by Chhattisgarh police as the "last nail in the coffin" of insurgency.

Alluri Sitaramaraju district superintendent of police (SP) Amit Bardi said the encounter happened between 6:30 am and 7 am in the forested area of Maredu milli mandal.

"Today morning, between 6:30 AM and 7:00 AM, an exchange of fire (EOF) occurred between Maoists and the police party in the Maredu milli Mandal area. During the encounter, six Maoists were neutralised," an official press release said.

Two women and four men were killed in the exchange of fire.

Based on reliable sources and field verification, police confirmed that Hidma, his wife Ma daka m Raje, Deve, Lakmal (Chaitu), Malla (Mal lalu) and Kamlu (Kamlesh) died. Intelligence inputs over the past few weeks had indicated increased Maoist movement along the Andhra Pradesh-Chhattisgarh-Odisha border, leading to intensified combing operations, police said.

Following the encounter, police seized two AK 47 rifles, one pistol, one revolver and a single bore weapon, a number of electrical and non-electrical detonators, fuse wire, seven kit bags and others. "Combing operations are continuing in

the surrounding areas to ensure complete sanitisation and prevent further Maoist activity," the press release added.

According to the SP, it was a joint operation carried out by various wings of the police department. Addressing a press conference, Andhra Pradesh Intelligence ADGP Mahesh Chandra Ladda said Maoists from a few battalions were planning to shift to Andhra Pradesh due to continuous pressure in Chhattisgarh.

Consequently, police kept a close and continuous watch on their movements. "For the last two days, we had very specific intelligence that a few top Maoist leaders were entering the state and were planning to revive the movement," Ladda said, adding that the bodies of the six Maoists were shifted for post-mortem, and that the necessary action will be taken thereafter.

Further, police monitoring in other districts such as NTR, Krishna, Kakinada and Eluru led to the arrest of 31 more members of the proscri-

bed organisation.

Out of the 31 arrested, nine were security guards of central committee member Devji, while the remaining were from the battalion, Ladda said.

It has also been reported that a few Maoists managed to flee from the encounter site, and combing operations are currently under way, the official added.

Meanwhile, Chhattisgarh Police described Hidma's death as the "last nail in the coffin" of the insurgency. He had masterminded several attacks over the last two decades. A native of Puvarti village in Sukma district in Chhattisgarh, Hidma's age and appearance remained mysterious until his photograph surfaced earlier this year.

He headed the Maoists' People's Liberation Guerrilla Army (PLGA) Battalion No.1, the strongest military formation of the outfit in Dandakaranya, which spans parts of Andhra Pradesh, Odisha, Telangana, and Maharashtra, apart from Bastar, for several years, officials said.

Posed as Labourers

Teams from OCTOPUS and Greyhounds, with the support of Vijayawada police, cordoned off the entire Auto Nagar locality before beginning their searches. Investigators questioned the building's watchman after learning that the owner has been abroad for the last month and a half. Officials suspect the Maoists entered the premises ten days ago claiming to be daily-wage labourers seeking temporary accommodation.

Acting on credible intelligence that the group had taken shelter in a residential building, police launched a joint search operation. Among those arrested were 12 women, four individuals holding key positions and 11 supporters and militia members, according to preliminary information. Police also received in-

the joint operation based on specific inputs regarding Maoist movement in Auto Nagar.

"We acted on accurate information. Searches were conducted not only in Vijayawada but across several locations in the State. The operation is currently underway in five districts, targeting Maoist activity," the SP said.

He added that authorities apprehended a group led by Tippiri Tirupati, a Maoist Central Committee Secretary. The police plan to release more details on the arrested individuals on Wednesday.

Including the arrests made in Vijayawada, Krishna district, and Kakinada, a total of 31 Maoists have been detained so far. Sources indicate that nine Central Committee members are among those taken into custody.

OLX Lists Sale Of Giddalur Tahsildar Office at Rs 20,000

Nellore: In an incident that has triggered widespread discussion across Andhra Pradesh, Giddalur tahsildar's office in Prakasam district had been listed for sale on OLX for 20,000. The unidentified prankster uploaded an image of the government office on the OLX app two days ago, describing it as available for immediate sale — an act that quickly went viral on social media. Giddalur tahsildar Anjaneya Reddy has reportedly filed a formal complaint with



the police, who have started tracing the prankster based on the details provided on OLX. Authorities have not made any statement so far on the matter. When contacted, Marapuram DSP U. Nagaraj

u said they are probing the matter. The unusual listing has sparked equal parts amusement and concern within the public about the misuse of online platforms.

PM Modi to visit Andhra Pradesh tomorrow

New Delhi: Prime Minister Narendra Modi will visit Andhra Pradesh and Tamil Nadu on Wednesday, where he will participate in multiple events and release the 21st instalment of Rs 18,000 crore under the PM-KISAN scheme for nine crore farmers.

PM Modi will arrive in Andhra Pradesh on Wednesday morning and visit the holy shrine and Mahasamadhi of Bhagwan Sri Sathya Sai Baba. He will also address the gathering during the programme.

Thereafter, the Prime Minister will travel to Coimbatore, Tamil Nadu, where he will inaugurate the South India Natural

During the programme, the Prime Minister will release the 21st instalment of PM-KISAN, amounting to more than Rs 18,000 crore to support 9 crore farmers across

HC Orders Protection to Parakamani Theft Accused

Vijayawada: Expressing shock over the alleged murder of Y Satis Kumar, a key witness in the sensational Parakamani currency theft case, the Andhra Pradesh High Court on Tuesday ordered protection for C V Ravi Kumar, the prime accused.

The High Court directed the state police, stating, "Security must also be extended to accused employee Ravi Kumar, given the tense circumstances following Satish Kumar's killing."

Satish Kumar, a former TTD official who initially detected the theft and filed the complaint against Ravi Kumar, was found dead near Komali railway station on Friday. While a political party alleged suicide, the preliminary post-mortem report indicated he was hacked to death.

The judge called the



illing of a crucial court witness a "serious lapse in protection" and also directed full security for all witnesses in the Parakamani theft case.

Meanwhile, police transferred the murder probe to Tadipatri, examining CCTV footage and movements of the train. Satish Kumar was traveling on. Investigators confirmed he left for Tirupati court hearings two hours before his death but never reached the station, prompting a re-tracing of his last movements.

MANGALAGIRI: The long-awaited underground drainage (UGD) system for Mangalagiri is finally inching closer to reality, with the Mangalagiri-Tadepalli Municipal Corporation (MTMC) preparing to invite tenders next month. The Detailed Project Report (DPR), estimating the project cost at 1,167.50 crore, has already been submitted for administrative sanction, which officials expect to receive shortly. Once approved, the corporation will initiate the tendering process—marking the most significant step yet for this long-pending civic project.

The mega UGD project aims to establish a comprehensive sewerage network across the entire MTMC jurisdiction, excluding six villages—Bethapudi, Nowluru, Yerrabalem, Nidamaru,



Penumaka and Undavalalli. The plan includes modern sewage treatment plants (STPs), an extensive pipeline network and full road restoration to minimise public inconvenience during execution.


6 Lakh PMAY Homes to Get BEE-Star Appliances by 2026

TPN/VIJAYAWADA The South-West Regional Conference held in Hyderabad on Tuesday lauded Andhra Pradesh for emerging as a frontrunner in implementing Energy Efficiency (EE) initiatives across housing, urban local bodies, MSMEs and the tourism sector. Delegates and national EE experts appreciated the State's rapid progress, particularly its large-scale collaboration with Energy Efficiency

Services Ltd. (EESL), a joint venture of central public sector undertakings under the Ministry of Power.

The conference acknowledged Andhra Pradesh's pioneering move to distribute BEE star-rated energy-efficient appliances to all beneficiaries of the Pradhan Mantri Awas Yojana (PMAY), following instructions from Chief Minister N Chandrababu Naidu. The programme, executed jointly by the Housing Department and EESL, aims to supply energy-efficient appliance kits to nearly 6 lakh households by the end of 2026.

Special Chief Secretary (Housing & Tourism) Ajay Jain announced



that the initiative, expected to save 10.24 million kWh annually and reduce electricity expenditure by nearly 6.07 crore every year, will become India's largest energy savings project in the housing sector. Over 18,000 households have already received BEE-rated appliances under the first phase. Each PMAY household will now receive a kit comprising 4 LED bulbs, 2 LED tube lights, and 2 five-star BLDC fans. The appliances will be funded through the State's enhanced financial assistance—50,000 for SC and BC families, 75,000 for STs, and 1,00,000 for PVTG beneficiaries.

The EESL will supply

a minimum of 24 lakh LED bulbs, 12 lakh LED battens, and 12 lakh five-star ceiling fans to the Andhra Pradesh State Housing Corporation Ltd. (APSHCL). CM Naidu has set 2026 as the deadline for project completion. The EE efforts of AP Tourism also received high commendation. In partnership with EESL, the department is introducing global-standard geothermal technology in Araku Valley for water heating, space heating and integrated clean

energy applications. The system promises 50-70% energy savings, a payback period of 4-5 years, and a lifecycle exceeding 15 years. Delegates noted that this innovation would further enhance Araku's global identity as a sustainable tourism hub.

During the Centre-State conference, chaired by Union Housing and Urban Affairs Minister Manohar Lal Khattar, senior officials and ministers from southern states, including Telangana Chief Minister A. Revanth Reddy, participated. Representing AP, Municipal Administration & Urban Development Minister P. Narayana, Special CS Ajay Jain, Principal Secretary S. Suresh Kumar, and CMA P. Sampath Kumar briefed the gathering on Andhra Pradesh's progress.

Union Minister Khattar praised the AP government for delivering high-quality urban ser-

vices and implementing India's largest LED street lighting programme. Principal Secretary Surendra Kumar also announced a major upgrade in urban public lighting, with 10 lakh LED streetlights to be installed or modernised in partnership with EESL—positioning AP as one of the best-lit states in the country.

Red book Governance Took Satish Kumar's Life, Says Nani

Vijayawada: Former minister Perni Venkataramaiah (Nani) launched a sharp attack on the Chandrababu Naidu-led government, alleging that a deliberate attempt was being made to suppress facts and engineer a cover-up in the mysterious death of former TTD Assistant Vigilance and Security Officer (AVSO) and Circle Inspector (CI) Satish Kumar. He demanded that the investigation be immediately handed over to the Central Bureau of Investigation (CBI), stating that only an impartial national agency could bring out the truth behind the case.

Speaking to reporters in Vijayawada, Nani described the circumstances surrounding Satish Kumar's death as highly suspicious and accused the state government of obstructing transparency. He expressed shock that only one "fa-



voured" television channel was permitted access to the body for nearly two hours, while the victim's family members and other media outlets were prevented from approaching the scene. "Such selective access and secrecy reflect the government's intention to control the narrative rather than uncover the truth," he remarked.

The former minister alleged that the police acted in an unusually secretive manner — seizing the mobile phone of Satish Kumar's wife and cordoning off the

residence without showing a copy of the FIR. He questioned why the Station House Officer (SHO), Investigating Officer (IO), and Superintendent of Police (SP) had not issued public statements to clarify the situation. Nani further demanded to know why Railway Protection Force personnel, Travelling Ticket Examiners (TTEs), and all 54 co-passengers traveling with Satish Kumar in the A1 coach had not been thoroughly examined.

Highlighting multiple inconsistencies, Nani pointed

out that Satish Kumar reportedly left home around 7 p.m. but reached the railway station only at 12:50 a.m. "What happened during those missing hours? If there was an assault inside the coach, why are there no bloodstains or eyewitness reports? Why did no railway official file a complaint?" he asked. He added that preventing close relatives from identifying the body and keeping them away from the site deepened public suspicion and undermined faith in the ongoing investigation.

Nani also criticised what he called a coordinated propaganda campaign launched by pro-TDP media outlets and the party's official website, which swiftly branded the death as part of a YSRCP conspiracy even before an FIR or post-mortem report was released. He asked why no cases had been filed against those disseminating false and divisive material

on social media. "Party leaders who spread such poisonous narratives must be held accountable under law," he asserted.

Warning that the arrest of opposition leaders, such as the recent detention of Karumuri Venkata Reddy, would not silence dissenting voices, Nani said the people of Andhra Pradesh were witnessing every act of abuse of power. "Whether it is a case of suicide or murder, the truth must come out. Political theatrics and secretive policing cannot be allowed to replace justice," he concluded.

Nani reiterated his demands for a CBI probe, public disclosure of CCTV footage and call data, questioning of all persons linked to the train journey, and the immediate return of the seized phone. "The people are watching," he said, "and they will not forgive those who manipulate the truth."

Centre Responds Positively to Cotton Farmers' Issues: Atchennaidu

Vijayawada: The long-pending concerns of cotton farmers in Andhra Pradesh appear to be moving towards a solution, with the Union Government showing positive intent on several proposals previously submitted by the state government. State Minister for Agriculture, Cooperation, Animal Husbandry, Marketing, Dairy and Fisheries K Atchennaidu announced that significant progress has been made following continuous communication between the state and central governments.

Atchennaidu said that the Centre has responded favourably to six key recommendations earlier sent by the state to resolve the difficulties faced by cotton growers. Of these, three recommendations have already been acted upon, with implementation initiated in phases. This intervention, he noted, has helped clear several hurdles in cotton procurement



across the state, allowing procurement centres to begin operations gradually. However, the Minister highlighted that the recent impact of Cyclone Monsoon has severely affected cotton quality, with moisture levels and discoloration rendering much of the produce ineligible under the Cotton Corporation of India (CCI) standards.

To mitigate this situation, the state government has urged the Centre to swiftly implement the remaining three recommendations that are yet to be approved. These include simultaneous opening of L1, L2, and L3 ginning mills to prevent procurement bottlenecks, allowing the purchase of cotton with 12%-18% moisture content with proportionate price deductions, and permitting procurement of rain-soaked or discoloured cotton with suitable price adjustments. Atchennaidu said these measures would provide much-needed relief to farmers whose yields have been damaged

by heavy rains and cyclonic winds. He informed that he personally briefed Union Textiles Minister Giriraj Singh on these issues in detail, explaining the immediate need for central intervention.

The Union Minister, he said, responded positively, raising expectations of favourable decisions soon. Atchennaidu assured that the state government will continue to follow up with the Centre until all pending concerns of cotton farmers are fully addressed. Providing a detailed overview of the current scenario, the Minister stated that cotton cultivation during the 2025-26 kharif season spanned 5.39 lakh hectares across Andhra Pradesh, with an estimated production of nearly eight lakh metric tonnes.

The state has already issued clear guidelines to ensure that the CCI procures cotton from farmers at the Minimum Support Price (MSP). To ensure effective and transparent operations, district-level procurement committees headed by Joint Collectors and field-level monitoring committees led by Marketing Officials have been constituted. These committees have been tasked with supervising procurement activities and addressing grievances from farmers on the ground.

CII Summit a Grand Success, YSRCP Leadership Under Pressure: Undavalli

Vijayawada: The recently concluded CII Partnership Summit in Visakhapatnam has transformed the investment landscape of Andhra Pradesh, marking a decisive shift towards making the state a global investment hub, said former MLA and AP Madiga Corporation Chairperson Undavalli Sridevi. Addressing the media at the TDP central office on Tuesday, she said that the two-day summit showcased to the world the efforts of Chief Minister N Chandrababu Naidu and Minister Nara Lokesh in attracting unprecedented investor confidence.

Sridevi stated that global corporations coming together on a single platform and expressing strong interest in Andhra Pradesh signaled the beginning of a new investment era. While the government initially projected 9.5 lakh crore in investments, 410 MoUs, and over 7 lakh jobs, the final outcomes exceeded expectations, she said. Vijayawada Gears Up For Bhavani Deeksha Viramana

The NTR district administration has begun large-scale preparations to ensure a smooth and satisfying darshan experience for devotees participating in the Bhavani Deeksha Viramana (Relinquishment), from December 11 to 15. District Collector Dr G Lakshmi-Sha and City Police Commissioner SV Rajasekhar Babu reviewed the arrangements in a coordination meeting held with officials from various departments, including Joint Collector S Ilakkia and Kanaka Durga Temple EO VK Seena Naik.

Speaking at the meeting, District Collector Dr Lakshmi-Sha said that more than six lakh devotees

are expected to arrive this year during the Relinquishment of the 41-day Bhavani Deeksha, significantly higher than last year's 3.2 lakh. He said that devotees from across Andhra Pradesh and neighbouring states undertake the Deeksha with strict discipline, perform daily rituals, and visit Goddess Kana k a Durga to offer Irumudulu and relinquish their vows. With around one lakh devotees expected each day and nearly 1.5 lakh on the final two days, the Collector stressed the need for meticulous planning. Drawing from the successful management of the recent Dasara celebrations—where larger-than-expected crowds

were handled efficiently—he urged all departments to work with the same coordination and dedication.

The district administration has created 36 sectors, each assigned a special officer for continuous monitoring. Key areas such as holding points, tonsure centres, bathing ghats, giri pra dakshina routes, queue lines, irumudulu counters, homa gundams and laddu sale counters will have round-the-clock supervision. Information centres will make regular announcements to guide devotees.

To manage heavy footfall, the administration plans to increase the number of laddu coun-

ters and free food distribution centres. Arrangements are in place to accommodate more than 10,000 devotees offering Kalasha Jyothis. Queue lines will have water-proof tents and coir mats, replaced periodically. Additional temporary toilets will be set up at holding points and along busy routes. Dedicated staff will manage discarded Deeksha clothes at bathing ghats. A special coordination team will function from the Command Control Centre for real-time monitoring.

RPF-GRP Joint Operation Cracks Mobile Theft Network

In a major breakthrough, the RPF-GRP Joint Operation Yatri Suraksha, a joint team of Railway Protection Force, Vijayawada Post and GRP Out Post Gudivada successfully apprehended two mobile phone offenders, leading to the recovery of 26 stolen mobile phones worth approximately ₹5,70,000. The operation was launched in response to a surge in mobile theft incidents within the Gudivada RPS limits.

To tackle the rising cases, Post Commander (Inspector RPF), Vijayawada Post and Inspector Railway Police, Vijayawada formed specialised teams that

carried out discreet surveillance and gathered human intelligence from multiple sources. Their sustained efforts culminated today, 18.11.2025 at around 07:30 hrs, when two wanted offenders were intercepted in the Gudivada local area.

During interrogation, the accused were identified as SK Karimulla, aged 39, from Tenali in Guntur District, and Antony Chinnappa, aged 35, from Dhone in Ananthapur District. A total of 26 mobile phones were seized from their possession, including devices linked to Cr. No. 43/2025 and Cr. No. 34/2025 under Section 303(2) BNS. Notably,

the recovered items included an iPhone 14 and multiple Vivo phones of significant value.

In addition to these identified crime cases, 23 untraced mobile phones related to earlier GRP Gudivada cases were also recovered, providing a significant boost to ongoing investigations. After completion of legal formalities, both accused were released on bail.

This successful operation underscores the commitment of RPF and GRP teams in safeguarding passengers and strengthening security measures across Vijayawada Division.

33 lakh worth of school infra handed over to 13 primary schools

Auto Driver Climbs Cell Tower in Protest Over Missing Welfare Benefit

Echerla, November 18: Tension prevailed at Yatapeta in Kushalapuram area of Echerla mandal on Tuesday afternoon after an auto driver climbed a cell tower, alleging that he had been denied financial assistance under a recently launched government scheme.

According to sources, the Andhra Pradesh government had recently rolled out the 'Auto driver Sevalo' welfare scheme, under which eligible auto drivers were promised financial support of ₹15,000 each. While thousands reportedly received the benefit, Dasari Kalyan Kumar, an auto driver from Bonthala Koduru village in Echerla mandal, claimed that his name was left out and the amount was not credited to his account.

Frustrated over the delay, Kalyan Kumar reportedly climbed a cell tower near Yatapeta around 2.30 p.m. on Tuesday. From atop the structure, he expressed anguish over being excluded from the scheme and demanded immediate sanction of the promised financial


support. He declared that he would not come down until officials assured him that his grievance would be addressed. The dramatic protest lasted for nearly an hour, drawing the attention of locals and passers-by, who gathered at the spot in large numbers.

Upon receiving information, Echerla SI-2 V. Apparao along with a police team rushed to the location and initiated efforts to pacify the auto driver. Police officers engaged him in dialogue, assuring him that they would take up the matter with the concerned auth-

orities and ensure that his application under the scheme was processed without further delay.

After sustained persuasion, Kalyan Kumar finally climbed down from the tower. Police officials later stated that they would forward his issue to the relevant departments for prompt action.

The incident has highlighted the gaps in the implementation of welfare schemes and the growing frustration among beneficiaries who are left out due to technical or administrative lapses.



Andhra Tourists Escape Unhurt in Road Accident Near Aryankavu Temple in Kerala

Vijayawada - Kerala: A group of tourists from Andhra Pradesh narrowly escaped a serious road accident that took place near Aryankavu Temple in Kerala on Tuesday. According to initial reports from local authorities, a passenger van carrying pilgrims from Andhra Pradesh collided with an auto-rickshaw in the vicinity of the temple, a well-known location in the Kollam district. The incident reportedly occurred in the afternoon, creating a brief traffic disruption on the busy hill route connecting Kerala and Tamil Nadu.

Eye-witnesses said the van was proceeding toward Punalur after visiting the Aryankavu



shrine when it accidentally hit an auto coming from the opposite direction. The impact left the front portion of the auto mangled, while the van sustained minor body damage. However, officials confirmed that the occupants of the van identified as pilgrims from Andhra Pradesh were safe and did not

suffer any injuries.

Local residents and other motorists quickly rushed to the site to assist those involved. The injured individuals from the auto-rickshaw, reportedly natives of Kerala, were immediately shifted to a nearby hospital in Thenmala for medical attention. Preliminary reports

suggest that at least one or two passengers in the auto sustained minor injuries, while the vehicle driver is recovering and reported to be out of danger.

Police officers from the Aryankavu Station reached the scene shortly after the accident to clear the traffic and investigate the circumstances. Officers conducted inquiries with both drivers and witnesses to determine if overspeeding or sudden maneuvering led to the crash. Early findings indicate that slippery road conditions caused by light rain may have contributed to the mishap.

The Aryankavu-Punalur route is one of the scenic yet narrow mountain roads that of-

ten see heavy traffic during pilgrimage seasons. Officials have urged motorists to drive cautiously, particularly during evenings and on curves where visibility is low. The local administration has also reiterated its plan to enhance road safety measures in the region, including the installation of warning signs and reflective markers.

While the Andhra Pradesh pilgrims resumed their journey after the formalities were completed, the incident served as a reminder of the need for vigilance on hilly roads connecting state borders. Authorities are continuing their investigation and have assured follow-up safety monitoring in the area.

Special Officers Appointed to Oversee Arrangements For PM

Puttaparthi: Preparations are in full swing in Puttaparthi ahead of Prime Minister Narendra Modi's scheduled visit on November 19 to participate in the centenary celebrations of Bhagawan Sri Sathya Sai Baba. The Andhra Pradesh government has stepped up arrangements to ensure smooth conduct of the event and a hassle-free experience for the thousands of devotees expected to attend. To oversee various aspects of the arrangements, the state government has appointed three senior IAS officers Gopalakrishna, Govindar Rao, and Kalyan Chakravarthy as special officers.

They have been instructed to stay in Puttaparthi until the conclusion of the Prime Minister's visit and co-

ordinate with district officials to ensure that all administrative and security measures run efficiently. In addition to the senior officers, one Joint Collector and nine Deputy Collectors from nearby districts have been given additional responsibilities to assist with logistics, crowd management, and inter-departmental coordination. The appointments were made under orders issued by State Chief Secretary Dr. Neerabh Kumar Prasad (as per recent administrative communication), ensuring a well-defined chain of command for the event's execution.

The government has emphasized that top priority will be given to public safety, transport management, and communication systems during the visit. Traffic control plans, parking arrangements, medical

aid centers, and emergency services are being strengthened. The district police and transport officials have been instructed to maintain round-the-clock monitoring of the movement of devotees and VIP convoys. A team of state ministers held a detailed review meeting on Monday to evaluate the progress of preparations. Ministers Anagani Satya Prasad and Savitha, along with Nodal Officers NT Krishnababu and Veerapandian, chaired the review at the Puttaparthi Collectorate's PGRS conference hall.

Officials from revenue, police, roads and buildings, and health departments briefed the ministers on the status of works related to security, accommodation, sanitation, and cultural arrangements. The committee also reviewed

protocols to be followed during the visit of the Prime Minister, President Droupadi Murmu, Vice-President Jagdeep Dhankhar, and several other dignitaries who are expected to participate in the centenary celebrations. With national and international devotees arriving for the occasion, authorities have been directed to ensure adequate accommodation, clean drinking water, and uninterrupted power supply.

The ministers instructed officials to deploy special teams for crowd control at the Sai Kulwant Hall and surrounding venues where spiritual events and public meetings are planned. They further advised departments to maintain close coordination with the Prime Minister's Office (PMO), the Special Protection

Group (SPG), and district authorities to avoid any lapses in security or logistics. The officials briefed that temporary parking areas and special transport routes have been identified to manage vehicular movement on the day of the visit.

Emergency response units, fire services, and medical teams will be stationed at strategic points in and around Puttaparthi. The administrative machinery has been put on high alert, with continuous monitoring of activities through a centralized command center. Authorities have expressed confidence that all works will be completed on schedule, ensuring that Prime Minister Modi's visit and the Sathya Sai Baba centenary celebrations proceed without any disruption.

The Collector instructed officials to utilize every available open space, including those in educational institutions and office premises, for planting saplings on a large scale. Each department was directed to sub-

mit reports on the plantation targets assigned and achieved. She also advised that plantation activities be integrated with the Mahatma Gandhi National Rural Employment Guarantee Scheme (MGNREGS) to ensure local participation and proper maintenance.

During the meeting, officials reviewed the performance of the Social Forestry Department in Palnadu during 2024-2025, particularly under schemes like NREGS, CAMP, and MP funds.

The plan also includes a five-year action programme (2025-2026 to 2029-2030) involving departments such as Forest, Horticulture, Sericulture, DWMA, and other departments.

Review of Forest Rights Act Implementation

A separate review was conducted on the implementation of the Forest Rights Act (FRA) of 2006 and its rules of 2007. Under this act, land rights were approved for seven beneficiaries in Taduvali village of Achampet mandal and one beneficiary in Venkatasayapalem village of Bellamkonda mandal. The meeting, chaired by District Collector and District Level Committee (DLC) Chairperson Kritika Shukla, also

Can India Turn H-1B Setback into a Brain Gain Revolution?



The United States' latest crackdown on skilled immigration has landed like a thunderbolt on India's middle-class dreams. President Donald Trump's executive order slapping a massive \$100,000 fee on each new H-1B visa application threatens to cripple the once-dependable pathway that connected India's brightest minds to Silicon Valley's innovation hubs.

For decades, this visa wasn't just a work permit — it was a symbol of aspiration. Thousands of In-

dian engineers, doctors, and scientists migrated to the U.S. every year, fueling American growth while sending money and pride back home. With nearly 70% of the annual 85,000 H-1B visas going to Indians, this program was central to India's soft power in global tech. Now, with the cost barrier so high, even big tech may hesitate to hire, while startups, universities, and nonprofits could be shut out completely.

Yet amid the despair lies

a historic opportunity for India.

Much like China in the early 2000s, or South Korea and Taiwan before that, India now stands at a crossroads. Beijing responded to tightening US visa policies with bold action — offering repatriation incentives, fast-track STEM visas, and startup capital. Returnees helped build tech giants like Alibaba and Baidu. South Korea's TSMC rose similarly from the return of overseas

talent.

India must act now to seize this moment. The groundwork exists. India's digital economy is growing, global capability centers are thriving, and cities like Bengaluru and Hyderabad already attract global tech. But talent won't return without compelling reasons. Competitive pay, research freedom, clean governance, and streamlined startup ecosystems are vital. This calls for a bold national policy — perhaps an "India

Return Visa" — backed by both government and industry.

PM Modi's Atmanirbhar Bharat vision aligns perfectly with this opportunity. Trump's move may unintentionally offer India the opening to turn decades of brain drain into a flood of brain gain.

If India acts swiftly and smartly, what started as a setback could spark a new era — one where innovation, talent, and leadership return home to build the India of tomorrow.

and elite professionals, while displacing traditional jobs and increasing income inequality.

Unlike the 1800s, however, the modern world may not need to wait decades to address these imbalances — if policy keeps pace with innovation. Governments and international institutions must prioritize inclusive AI governance frameworks. This means ensuring that the gains from AI are widely distributed through social safety nets, upskilling initiatives, and stronger labour protections.

Karur Tragedy Exposes Dark Side of Tamil Nadu's Star-Struck Politics



The tragic stampede in Karur that claimed 40 lives and injured hundreds during actor-turned-politician Joseph Vijay's rally has triggered a wave of public outrage and political introspection in Tamil Nadu. What was meant to be a grand show of strength for Vijay's new party, Tamilaga Vettu Kazhagam (TVK), turned into a horrific event — one that lays bare the risks of personality-driven politics in the state.

Eyewitness reports and police briefings suggest that between 30,000 to 60,000 people packed a narrow stretch of road meant for less than 10,000. Many had been waiting since morning under the scorching sun to catch a

glimpse of Vijay, who was expected around noon but only arrived close to 7 p.m. The late arrival — eerily reminiscent of his film industry habits — proved catastrophic.

Critics argue that Vijay's nonchalance was not just a failure in time management, but a reflection of deep-seated arrogance. His absence from the hospitals, his silence with the bereaved, and his casual response have angered even some of his supporters. "This isn't just star arrogance—it's a failure of leadership," a senior political analyst said.

The tragedy brings into focus Tamil Nadu's decades-old fascination with film stars in politics — a legacy of M.G. Ramachandran, Jayalalithaa, and others. While their cha-

rism often masked governance shortcomings, Vijay's entry into politics now raises a harsher question: Has the blind worship of celebrity reached a fatal threshold?

The state High Court is now hearing pleas to restrict TVK's future gatherings. Nearly 500 police personnel were deployed for the Karur event, but crowd control was inadequate.

With the 2026 elections looming, the incident may become a turning point for both voters and political parties. The question isn't just about Vijay's fitness to lead — it's about Tamil Nadu's willingness to evolve beyond personality cults and demand accountability from those who seek power.

How India can make an opportunity of the H-1B visa crisis



With the Bihar Assembly election looming, Prime Minister Narendra Modi's latest move — transferring ₹10,000 each to 75 lakh women in the state — has stirred both admiration and criticism. The massive ₹7,500 crore payout dwarfs other recent announcements, including the ₹1,600 crore re-

lief package for flood-hit Punjab. The message is clear: women are now a core constituency for the Bharatiya Janata Party (BJP), and the party is doubling down on its electoral investment.

As Editor-in-Chief Jyoti Malhotra highlights in her op-ed There's something special

about Bihar; this is not an isolated gesture. Across states headed for elections, BJP has systematically launched women-focused welfare schemes — from Lado Lakshmi in Haryana and Ladli Behna in Madhya Pradesh to Mahila Samridhi Yojana in Delhi and Mahtari Vandana in Chhattis-

garh. Modi's strategy appears to be forging a reliable "women constituency" with targeted financial empowerment and social messaging.


However, this calculated outreach raises deeper questions. Is this genuine empowerment or strategic pandering? Critics argue that while cash transfers provide short-term relief, they often lack the structural support needed for long-term gender parity — in education, employment, and safety.

Beyond domestic politics, another shift is reshaping India's global talent landscape: the H-1B visa crisis in the US. With President Trump imposing a staggering \$100,000 fee per application, Indian skilled workers — once the backbone of Silicon Valley — are looking elsewhere. Canada, Australia, and Europe are seizing the moment, offering simpler immigration pathways and greater certainty for skilled migrants.

India, instead of lamenting the loss, could turn this crisis into an opportunity. With strong policy initiatives, it can attract its own global talent back home. The groundwork is present — thriving tech hubs, growing global capability centers, and a youthful workforce. But without reforms in research, innovation, and governance, return migration will remain a missed opportunity.

As India navigates electoral battles and global disruptions, the real test lies in whether policy can rise above politics — delivering not just votes, but vision.

Will AI Trigger a New Engels' Pause?



Can India Deny Dhaka's Request To Extradite Sheikh Hasina? What Rules Say

After Bangladesh's ousted prime minister Sheikh Hasina was sentenced to death in absentia for "crimes against humanity," Dhaka has formally requested India to extradite her. Hasina, who fled Bangladesh on August 5 last year amid a student-led uprising, has been living in exile in India since. Her former home minister, Asaduzzaman Khan Kamal, believed to be in India as well, is also sought by Dhaka authorities.

Hasina was convicted on multiple charges, including ordering the killing of student protesters and using lethal force via helicopters and drones. She has denounced the verdict as "biased and politically motivated," asserting she acted to minimize loss of life. The Awami League has called for a national shutdown in protest, while Hasina cannot appeal the verdict unless she surrenders or is arrested within 30 days.

Bangladesh's Foreign Ministry described India's extradition of Hasina and Khan as a "compulsory responsibility" under the bilateral extradition treaty, warning



that sheltering them could be deemed "unfriendly" and a disregard for justice.

India, however, has responded cautiously. The Ministry of External Affairs (MEA) noted the verdict and assured constructive engagement with all stakeholders, emphasizing peace, democracy, and

stability in Bangladesh, without directly commenting on the extradition request.

Under the India-Bangladesh Extradition Treaty (2013, amended 2016) and India's Extradition Act, 1962, New Delhi retains discretion to deny requests deemed politically motivated, unjust, or not

in the interest of justice. Extradition may also be refused if charges are considered trivial, oppressive, or purely political, or if India can prosecute the accused domestically. Legal experts say Hasina's extradition is highly unlikely, given the potential political overtones and disre-

tion granted to India under both treaty and domestic law.

As tensions rise, India is expected to carefully weigh diplomatic relations with Bangladesh against legal safeguards and the risk of political persecution before taking any decision on Hasina's extradition.

India-Russia Ties Factor Of Stability In International Relations: S Jaishankar

External Affairs Minister S. Jaishankar on Monday emphasized that India-Russia relations have long been a factor of stability in international affairs, noting that their continued growth serves not only the mutual interests of the two nations but also the broader global community.

Jaishankar made the remarks during a meeting with Russian Foreign Minister Sergey Lavrov, highlighting ongoing discussions on several bilateral agreements, initiatives, and projects across multiple sectors. "We look forward to their finalization in the coming days. These will add more substance and texture to our Special and Privileged Strategic Partnership," he said.

The Indian minister also pointed to the importance of regular diplomatic interactions, noting that six meetings had already taken place between



him and Lavrov this year. He described the discussions as vital for advancing bilateral cooperation and exchanging perspectives on key regional, global, and multilateral issues.

Jaishankar highlighted that the talks would also

cover the complex global situation, including the Ukraine conflict, the Middle East, and Afghanistan. "India supports recent ef-

forts towards establishing peace. We hope all parties approach that goal constructively. An early cessation of the conflict and the ensuring of enduring peace is in the interest of the entire international community," he added.

The meeting comes ahead of President Vladimir Putin's visit to India for the 23rd Annual Summit, underscoring the strategic depth of India-Russia relations. Jaishankar described the ties as a model of openness and constructive engagement, asserting that their evolution benefits not just India and Russia but the world at large.

Jaishankar is in Moscow to lead the Indian delegation at the SCO Council of Heads of Government meeting, hosted by Russian Prime Minister Mikhail Mishustin on November 18, 2025, where further collaboration and regional stability initiatives are expected to be discussed.

"Will Quit If JDU Fulfils 2 Lakhs Promise": Prashant Kishor After Bihar Loss

Jan Suraaj chief Prashant Kishor, in his first reaction after his party's disappointing performance in the Bihar Assembly elections, announced a one-day 'maun upvas' (vow of silence), taking full responsibility for the electoral setback.

Kishor's party contested 238 of Bihar's 243 Assembly seats but failed to win a single seat. The ruling NDA alliance, led by BJP and Nitish Kumar's JDU, secured a decisive victory with 202 seats, while Chi-

rag Paswan's LJP (Ram Vilas) won 19 seats.

"We tried very positively from our end. We failed to change this government. The responsibility lies entirely with me," Kishor said, adding that introspection would follow. He acknowledged the

efforts of his team but admitted, "If the public did not show faith in us, the responsibility is mine."

Despite his pre-poll remark that he would quit politics if JDU won over 25 seats, Kishor clarified that he would not resign immediately. However, he reiterated

a new promise: he would retire from politics if the ruling government fulfills its pre-election pledge of giving ₹2 lakh each to 1.5 crore people. "If Nitish Kumar transfers the ₹2 lakh as promised and proves he didn't win by buying votes, I will retire without any ifs or buts," he stated.

Kishor also rejected allegations that voters sold their votes. "For the first time, a government promised to spend ₹40,000 crore for people, which contributed to NDA's majority. People here will not sell their future," he said.

Despite the loss, Kishor affirmed his commitment to Bihar politics, saying, "We will stand again with the same power. You are not defeated until you quit."

The poll strategist-turned-politician's vow of silence and conditional promise to quit politics signal both reflection and resilience, as he navigates the aftermath of Jan Suraaj's historic electoral failure.

Red Fort Blast: Co-Conspirator Sent to NIA Custody

A Delhi court on Tuesday remanded Jasir Bilal Wani, described as an "active co-conspirator" of suicide bomber Umar Nabi, to 10 days of NIA custody in connection with the Red Fort car blast that killed 15 people.

The blast, which occurred near the historic Red Fort, had triggered nationwide security concerns and intensified investigations into the perpetrators and their network.

Wani, a key accused in the attack, was produced before the Patiala House Court, where the National Investigation Agency (NIA) requested custodial interrogation to gather critical evidence.

Principal District and Sessions Judge Anju Ba-

jaj Chandna allowed the NIA plea, emphasizing the necessity of custodial questioning to uncover the full extent of the conspiracy behind the blast. The court proceedings were held almost entirely 'in camera', with media personnel barred from entering the courtroom, reflecting the sensitive nature of the investigation.

NIA officials indicated that Wani's interrogation could provide crucial leads regarding the planning and execution of the blast, as well as the possible involvement of other associates. The agency is expected to question him on logistics, recruitment, and funding networks that may have facilitated the attack.

The Red Fort incident remains one of the most significant terror attacks in Delhi in recent years, prompting enhanced security measures around key landmarks and intensified intelligence operations across the National Capital Region. Investigators are working to piece together the chain of command and identify other operatives linked to the attack.

As the probe continues, authorities have urged the public to remain vigilant and report any suspicious activity. Wani's custodial interrogation marks a key step in the ongoing investigation, as the NIA seeks to prevent further attacks and dismantle the terror network behind the Red Fort tragedy.

Top Naxal Commander Madvi Hidma Killed in Andhra Pradesh Encounter

Top Naxal commander Madvi Hidma, who masterminded multiple deadly attacks over the past two decades, was killed in an encounter in Andhra Pradesh on Tuesday, November 18, 2025.

Security forces also eliminated his wife Raje and four other Naxal cadres in the Maredumilli forest of Alluri Sitaramaraju district, officials confirmed. Chhattisgarh Police described the operation as the "last nail in the coffin" of the Maoist insurgency in Bastar.

Hidma, a native of Puvarti village in Sukma district, had long evaded capture due to his extensive guerrilla tactics and a sophisticated four-layered security ring in forested areas of Chhattisgarh, Andhra Pradesh, Telangana, Odisha, and Maharashtra.

He headed the Maoists' People's Liberation Guerrilla Army (PLGA) Battalion No. 1, the most formidable unit in Dandakaranya, and was recently elevated to the Maoists' Central Committee.

Hidma first came on security forces' radar after the 2010 Tadmetla attack, which killed 76 personnel. He later played key roles in other high-profile strikes, including the 2013 Jhiram Valley ambush, which wiped out senior Congress leaders in Bastar, and the 2017 Burkapur attack, leaving 24 CRPF personnel dead. His wife Raje was also actively involved in the battalion and reportedly participated in major Maoist operations.

In recent years, intensified anti-Naxal operations weakened Hidma's security network, forcing him to retreat deeper into forests along

state borders. Sustained operations in Maoist strongholds eventually led to his elimination, along with several senior Central Committee members.

Chhattisgarh Deputy Chief Minister Vijay Sharma called Hidma's death a significant milestone in eliminating Maoism from the region. With this encounter, nine top Maoist Central Committee members have been killed this year across Chhattisgarh, Jharkhand, and Andhra Pradesh, including Nambala Keshav Rao alias Basavaraju, the general secretary of the outlawed Communist Party of India (Maoist).

Officials said Hidma's elimination marks a decisive blow to the insurgency and weakens the Maoist network's operational capabilities in Bastar and neighboring areas.

UN Adopts US Resolution Backing Trump's Gaza Peace Plan

The UN Security Council on Monday adopted a US-drafted resolution endorsing former President Donald Trump's plan to end the conflict in Gaza and authorising an international stabilisation force for the Palestinian territory. The resolution, seen as key to legitimising a transitional governance body, comes after Israel and Hamas agreed last month to the first phase of Trump's 20-point plan, including a ceasefire and hostage-release deal.

The text allows member states to participate in the Trump-chaired Board of Peace, envisioned as a transitional authority overseeing Gaza's reconstruction and economic recovery. It also authorises the international force to oversee demilitarisation, including dismantling weapons and military infrastructure.

Hamas immediately rejected the resolution, stating it will not disarm, calling the international intervention an "imposed guardianship mechanism" on Gaza. The militant group insists its fight against Israel remains legitimate, raising concerns of potential clashes with the new international force.

US Ambassador to the UN Mike Waltz described the resolution as a "pathway for Palestinian self-determination" and said it aims to replace rockets with diplomacy, dismantle Hamas'

grip, and create a prosperous and secure Gaza.

While Russia and China abstained, their ambassadorships criticised the resolution for giving the US-led initiative control over Gaza with unclear operational details. Russian ambassador Vasily Nebenya argued the UN was sidelined in planning the international stabilisation force.

The Palestinian Authority welcomed the resolution and expressed readiness to cooperate with its implementation, a crucial endorsement that helped prevent a Russian veto. Trump hailed the Security Council's vote as "a moment of true historic proportion," promising further announcements regarding the Board of Peace in the coming weeks.

The resolution also references a potential pathway to Palestinian statehood contingent on reforms by the Palestinian Authority and Gaza's redevelopment. However, Israeli Prime Minister Benjamin Netanyahu reaffirmed opposition to a Palestinian state, pledging to demilitarise Gaza "the easy way or the hard way," reflecting internal political pressure from right-wing factions.

The UN vote marks a significant international step in attempting to stabilise Gaza, though tensions remain high over Hamas' resistance and Israel's opposition.

Japan Issues Safety Warning for Citizens in China

Japan has advised its citizens in China to exercise heightened caution amid a growing diplomatic rift between Beijing and Tokyo over Taiwan. The advisory urges Japanese nationals to avoid crowded areas, stay alert, and watch for suspicious individuals, signaling concerns over potential threats to their safety.

The warning comes after tensions escalated between the two countries, with Chinese media coverage reflecting increasingly negative sentiment toward Japan. Japanese officials describe the advisory as a preventive measure, ensuring citizens remain vigilant during this period of strained relations.

Chief Cabinet Secretary Minoru Kihara emphasized that the advisory is a standard safety measure but reflects the deteriorating atmosphere affecting the bilateral ties between the nations. The advisory also coincides with the suspension of Japanese film screenings in China, a move seen as part of the wider diplomatic friction.

Japanese business leaders have voiced concern over the impact of the dispute on trade and investment, urging both governments to seek a diplomatic resolution. Japan continues to emphasize dialogue while

safeguarding its citizens amid uncertainty in China.

Prime Minister Sanae Takai-chi and government officials have highlighted the importance of monitoring the situation closely, particularly for Japanese nationals living, working, or traveling in major Chinese cities. The advisory underscores the seriousness with which Japan views public safety in the context of international tensions.

The advisory also comes amid ongoing disputes over Taiwan, a sensitive geopolitical flashpoint. Japan's cautionary message reflects broader regional concerns about security, diplomatic stability, and the potential for anti-Japanese sentiment to escalate in China.

Authorities have encouraged Japanese citizens to stay updated with local news, register with embassies, and maintain contact with family members. The advisory signals Tokyo's effort to protect its nationals while navigating an increasingly tense relationship with China.

Japan has not ruled out further measures depending on how the diplomatic situation evolves, highlighting the ongoing uncertainty in bilateral relations.

Trump Blames Hoarse Voice on Trade Dispute Shouting

US President Donald Trump revealed that his raspy voice during a recent White House meeting was the result of a heated confrontation over trade policy with a foreign country. Speaking to reporters during a FIFA World Cup 2026 task force session, Trump said he had "blew [his] stack" while arguing with representatives from a nation attempting to renegotiate an existing trade deal.

Trump declined to specify the country, stating, "A country wanted to try and renegotiate the terms of their trade deal. And I wasn't happy about it." When pressed further, he added, "Why would I say that to you?" He described the exchange as necessary to "straighten it out" but admitted that it left his voice hoarse.

The United States has recently conducted trade discussions with

Japan, Cambodia, Malaysia, and Indonesia, alongside ongoing negotiations with China.

In October, Trump met Chinese President Xi Jinping in South Korea, where both leaders

reported progress on key trade issues. Trump said China agreed to assist the US

in addressing the fentanyl crisis, in exchange for a 10% reduction in tariffs on Chinese im-

ports, lowering the rate from 57% to 47%.

Trump also decided not to impose an additional 100% tariff on Chinese goods scheduled for November 1 after China postponed export restrictions on rare-earth magnets by one year. Commenting on the outcome of the Xi meeting, Trump expressed strong optimism, stating, "Zero, to 10, with 10 being the best, I'd say the meeting was a 12. A lot of decisions were made... and we've come to a conclusion on very many important points."

Trump's candid remarks about losing his voice drew attention to the intensity of the negotiations and reflected his personal style of engagement in high-stakes trade diplomacy. The incident underscores the ongoing US efforts to manage trade relations across Asia while addressing domestic and international economic priorities.

Yunus Wants Civil War: Hasina's Aide After Death Penalty Verdict

Tensions in Bangladesh escalated sharply after a Dhaka-based International Crimes Tribunal sentenced former Prime Minister Sheikh Hasina and ex-Home Minister Asaduzzaman Khan to death over their alleged role in last year's violent crackdown on student protesters. The verdict, delivered in absentia, has triggered a political storm, with top Awami League leaders accusing the Muhammad Yunus-led interim government of running a "kangaroo court".

Awami League leader and former minister Mohibul Hasan Chowdhury, a close aide of Hasina, condemned the judgement as "pre-written" and illegitimate. Speaking to NDTV, he claimed the tribunal was illegally constituted and insisted that Hasina was de-

nied legal representation. Senior lawyers, he said, were barred from appearing in court, rendering the entire trial process "a staged drama".

Chowdhury warned that the interim regime was pushing Bangladesh "towards civil war", alleging it lacked public support and relied instead on

repression. He further accused the Yunus administration of fostering ties with Pakistan and allowing extremist groups such as Lashkar-e-Taiba and

Jaish-e-Mohammad into the country—claims that have not been independently verified.

Despite being banned from elections,

Chowdhury insisted the Awami League still commands majority support. He challenged the interim government to allow the party to contest the February elections, asserting that the public—not an unelected regime—should decide the nation's future.

Hasina, currently in India, denounced the verdict as "biased and politically motivated", saying she and Khan acted "in good faith" during the unrest. India has declined to extradite the two leaders, making the enforcement of the sentence unlikely.

The Awami League has called for a national shutdown to protest the judgement. Under Bangladeshi law, Hasina must surrender within 30 days to appeal—an outcome seen as improbable amid the deepening political crisis.

"Copy Cat": Elon Musk Jabs Jeff Bezos Over New AI Platform Launch

Tech titans Elon Musk and Jeff Bezos have reigned their long-running rivalry, this time over artificial intelligence. Moments after Bezos unveiled his new AI platform, Project Prometheus, Musk took a

jab on X, calling the Amazon founder a "copycat"—a label he has used multiple times when Bezos entered sectors dominated by Musk.

Responding to the announcement, Musk posted: "Haha no way", followed by another message: "copy cat".

The Tesla and SpaceX CEO has previously mocked Bezos using similar remarks—once when Amazon announced its satellite internet project to compete with Starlink, and again when it acquired Zoox to en-

ter the autonomous vehicle race.

Project Prometheus

marks Bezos's first major operational role since stepping down as Amazon CEO in 2021. The ambitious venture aims to create advanced AI systems for engineering, aero-

space, computing, and automotive manufacturing. The company will be co-led by former Google X scientist Vik Bajaj, who has worked closely with Google co-founder Sergey Brin. Bezos will serve as CEO.

Billion Brains Garage Ventures, the parent company of leading stock brokerage Groww, is continuing its impressive run in the stock market, trading at a new high of Rs 168 on Monday, up 13% on the NSE. This marks the fourth consecutive day of gains since its listing last week, pushing the company's market valuation past the Rs 1 lakh crore mark.

The shares of Billion Brains Garage Ventures debuted on the NSE last Wednesday at Rs 112, a 12% premium over the issue price of Rs 100, closing the day at Rs 128.85. India's Q2 GDP Likely to Soar Above 7.5% on GST-Led Festive Sales: SBI



SBI's analysis noted that the upbeat performance in the second quarter reflects a combination of pent-up demand, festive purchases, and improved rural consumption. The report also pointed to continued resilience in manufacturing and services sectors, which have benefited from strong domestic demand.

Economists see the higher-than-expected GDP growth as an indication that the Indian economy is maintaining a robust recovery momentum despite global uncertainties. The GST rate cuts, implemented earlier this year, have lowered prices for key consumer goods, thereby incentivizing spending and stimulating economic activity.

With the festive season extending into November, SBI expects that Q2 numbers could even surpass initial forecasts, marking one of the strongest quarters in recent years. Analysts will be closely watching upcoming data on industrial production, retail sales, and investment activity to gauge the sustainability of this growth trend into the latter half of the fiscal year.

India's real Gross Domestic Product (GDP) growth for the second quarter (July to September) is expected to rise to 7.5% or higher, driven by a surge in consumption following the recent Goods & Services Tax (GST) rate cuts, ac-

cording to a report by the research department of State Bank of India (SBI).

The SBI report highlighted that the GST reduction has spurred festive season sales, boosting consumer spending across sectors such as auto-

mobiles, electronics, and consumer goods. This increase in domestic consumption is likely to be a major driver of economic growth for the quarter.

The Reserve Bank of India (RBI), in its recent projec-

tions, had estimated Q2 GDP growth at 7%, slightly lower than the revised forecast by SBI. The central bank had cited moderating inflation and steady private investment as factors supporting sustained economic expansion.

among public-sector banks (PSBs). Bloomberg News reported on November 14 that SBI Chairman Challa Sreenivasulu Setty suggested that "some further rationalisation might make sense."





Gold, Silver Prices Decline Amid Market Correction



Gold and silver prices fell on Monday, continuing a brief correction after recent upward trends. In Mumbai, 24-carat gold was trading at Rs 1,24,970 per 10 grams, while 22-carat gold was priced at Rs 1,14,700 per 10 grams. Silver also witnessed a sharp drop of Rs 2,000, bringing prices to Rs 1,67,000 per kilogram.

Global markets showed mixed signals as US spot gold rose to USD 4,070 per ounce, reflecting ongoing demand for the yellow metal as a safe-haven asset. Despite this, domestic prices were weighed down by profit-taking and short-term market adjustments.

Ponmudi R, CEO of Enrich Money, said gold and silver are attempting to stabilize after recent sharp corrections. "Price action is showing signs of support at key long-term trend levels," he noted. On the Multi Commodity Exchange (MCX), gold was hovering near Rs 1,23,450, rebounding from its

upward-sloping trendline. Analysts suggest that holding above Rs 1,23,000 is crucial to maintain the broader bullish structure, opening the possibility for an upside move toward Rs 1,24,200-Rs 1,25,000.

The decline in precious metal prices comes amid fluctuating investor sentiment, with traders balancing between safe-haven demand and short-term profit-taking. Seasonal demand from the wedding and festive period also played a role in price volatility.

Market participants are closely watching global economic cues, currency fluctuations, and domestic demand trends for further guidance. With gold and silver holding support at key levels, analysts remain cautiously optimistic about a potential rebound in the coming weeks.

Consumers and investors are advised to monitor daily rate updates, as bullion prices continue to show short-term volatility amid broader economic trends.

China's Longevity Pill Claims 150-Year Lifespan



A Chinese biotech company has stirred global interest with claims that humans could one day live up to 150 years. Lonvi Biosciences, based in Shenzhen, says its new "longevity pill" targets ageing cells, or senescent cells, which stop dividing but trigger chronic inflammation and age-related decline.

The pill's key ingredient, Procyanidin C1 (PCC1), derived from grape seeds, reportedly extended the lifespan of mice by 9.4% in laboratory experiments. The remaining life expectancy of treated mice also increased by over 64%, prompting the company to tout the potential of cell-targeting interventions in significantly slowing ageing.

Lyu Qinghua, Lonvi's chief technology officer, told The New York Times that living up to 150 years is "definitely realistic," suggesting that meaningful progress could emerge in the coming years. The announcement aligns with China's rising interest in longevity research, boosted by public awareness, private investment, and policy support. China's av-

erage life expectancy reached 79 years in 2024, above the global benchmark of 74 years, and experts say longevity-focused innovations could push this further.

Gan Yu, co-founder of Shanghai-based longevity start-up Time Pie, noted a cultural shift: "Earlier, no one in China talked about living longer; it was something only wealthy Americans explored. Now, many Chinese are investing in longevity."

Despite the excitement, experts urge caution. While the mouse data is promising, extensive human clinical trials are essential before assessing the pill's safety or effectiveness in humans. Scientists stress that preliminary lab results cannot directly predict outcomes for people, and that ageing is a complex biological process influenced by genetics, lifestyle, and environment.

Lonvi's claims have sparked both curiosity and skepticism worldwide, highlighting the growing intersection of biotechnology, longevity research, and the human desire to extend life far beyond current limits.

5 Peaceful Nations With Minimal Military



In a world increasingly defined by military might, a few nations have taken a different path — maintaining little to no standing army while remaining remarkably safe for citizens. These countries rely on geography, governance, and efficient security networks rather than large militaries to protect themselves.

1. Singapore

Though Singapore invests around \$11.5 billion annually in defence, roughly 2.8% of its GDP, it is renowned for low crime and a peaceful environment. The city-state relies heavily on a strong security network, strict law enforcement, and advanced surveillance systems to maintain internal safety.

2. New Zealand

New Zealand's defence spending is modest, about \$3.9 billion or less than 1% of GDP. Its isolation and lack of land borders provide natural protection, while transparent governance and a robust judicial system keep defence costs low and socially secure.

3. Austria

Austria, long committed to neutrality, spends \$3.4 billion

yearly on defence. The country's strategic approach includes strict border control and diplomatic neutrality, which together help maintain national safety without a large military force.

4. Iceland

Iceland stands out in Europe for having no standing army, with a total defence budget of only \$40 million. The island's remote location, rugged terrain, and sparse population act as natural barriers, keeping it largely insulated from global conflicts.

5. Ireland

Ireland maintains a defence expenditure of about \$1.3 billion, just 0.3% of GDP. Its strong policy of neutrality, absence of military alliances, and efficient police force make it one of the safest countries in the world.

These nations demonstrate that peace can be safeguarded through strategy, stability, and social trust, proving that a large military is not the only path to national security. Their examples challenge the global assumption that safety is synonymous with heavy militarisation.

Bengaluru Traffic Gridlock Frustrates Commuters



Commuters in Bengaluru faced unusually heavy traffic on Tuesday morning, leaving many stuck in long queues across major roads. Residents described the congestion as "2.5 times worse than usual", highlighting the city's ongoing struggle with weekday traffic.

Social media users shared photos showing streets clogged with two-wheelers, cars, buses, and trucks, all moving at a crawl. One Reddit user captioned a post: "What is this on Tuesday morning," sparking hundreds of comments as people shared their own experiences.

Many commuters blamed the absence of auto-rickshaws for altering the flow of traffic. Others highlighted that mid-week—Tuesday through Thursday—typically sees the worst congestion, while Mondays and

Fridays are comparatively lighter due to work-from-home arrangements or leave.

Local reactions

ranged from humorous to frustrated. One user joked, "Romans called it traffic, Bangaloreans call it social

gathering, BBMP calls it STFU and live." Another shared, "I missed my alarm today, so going WFH instead of

facing traffic," echoing a common coping strategy among office-goers.

The morning grid-

lock impacted thousands trying to reach offices on time, with many reporting long delays on major routes. Users also noted that traffic jams have become an accepted part of city life, often treated with humor or resignation despite the inconvenience.

While BBMP authorities regularly work to ease congestion through traffic management measures, Bengaluru's growing population and vehicle density continue to strain road infrastructure. Residents continue to adapt with flexible work schedules, remote work, or simply patience amid the city's chaotic traffic landscape.

For now, Bengaluru commuters will have to brace themselves for the long, slow-moving lanes that have become a regular mid-week challenge in the Silicon Valley of India.

Ronaldo Set for Record Sixth World Cup as Portugal Thrash Armenia 9-1



Cristiano Ronaldo is officially headed to a historic sixth FIFA World Cup, as Portugal crushed Armenia 9-1 to seal qualification for the 2026 tournament to be held in the United States, Canada and Mexico. The emphatic victory on Sunday ensured Portugal's di-

rect passage from Group F, reaffirming their dominance in the qualifiers.

Ronaldo, who has already appeared in every World Cup since 2006, is now set to become the first men's player in history to feature in six editions of the global event. The Portuguese cap-

tain was at the heart of the action once again, scoring and assisting in a commanding display that showcased his enduring influence even at 40.

The match, played earlier in Yerevan in September but decisive for qualification standings, saw Portu-

gal overwhelm the Armenian defence from start to finish. João Félix, Rafael Leão, Bernardo Silva and others joined Ronaldo on the scoresheet as Portugal delivered one of their biggest wins of the qualifying campaign.

Ronaldo's relentless at-

tacking play left Armenia struggling to cope, with the visitors leading comfortably by halftime. The second half saw the floodgates fully open, as Roberto Martínez's side pushed forward with speed, precision and clinical finishing.

With qualification now secured, Portugal turn their attention to preparing for 2026, where they hope to improve on their quarter-final exit in 2022. For Ronaldo, the tournament offers another chance to chase the one trophy that has eluded him throughout his illustrious career.

The 2026 World Cup will also mark Portugal's first under Martínez at a major finals, and expectations are high as the team blends Ronaldo's experience with a new generation of stars.

For Portugal and for football fans worldwide, Ronaldo's sixth World Cup appearance promises to be one of the defining storylines of next year's tournament.

Mitchell Ruled Out of West Indies ODIs with Groin Injury



New Zealand all-rounder Daryl Mitchell has been sidelined for the remainder of the ODI series against the West Indies after scans confirmed a minor groin tear, the ICC reported on Tuesday.

Mitchell sustained the injury during the opening ODI in Christchurch, where he battled discomfort to score a match-winning century.

The injury requires a two-week rehabilitation period, ruling Mitchell out of the final two ODIs but keeping him in contention for the three-match Test series starting December 2.

New Zealand selector-coach Rob Walter expressed disappointment at losing the in-form player.

"It's always tough being ruled out early with injury, particularly when you're in hot form like Daryl is," Walter said. "He has been our standout performer in ODIs this summer, so he'll be missed for two important matches. The positive is that the injury is only minor, and we expect him fit for the Tests."

Alcaraz aggravated the injury during the ATP Finals, where he lost to Italy's Jannik Sinner in the title clash on Sunday. Following a medical evaluation, he was advised not to compete to prevent further damage. "I have edema in my right hamstring and the medical recommendation is not to compete," Alcaraz wrote.

"Playing for Spain is the greatest thing there is, and I was really looking forward to helping us fight for the Davis Cup."

His withdrawal marks another setback for the Davis Cup organizers, who had also lost Sinner, the world number two, last month. Spain's absence of their top player leaves the team rely-

ing on their remaining squad as they prepare to face the Czech Republic in the quarter-finals on Thursday.

mentum early, allowing the buzz to grow gradually on a global level.


