

# Jagan Appears Before Court After Six Years; Tight Security in Hyderabad

**H**yderabad: After nearly six years, former Andhra Pradesh Chief Minister and YSR Congress Party president Y.S. Jagan Mohan Reddy appeared before the CBI Special Court in Nampally, Hyderabad, on Thursday in connection with the long-pending disproportionate assets case. The court session lasted about 30 minutes, during which proceedings centered on allegations that Jagan had violated bail conditions during his recent foreign trips. Following the CBI's submission, the Nampally court had directed Jagan to appear personally, prompting his visit today.

His previous appearance in the same case was on January 10, 2020. Immediately after the hearing, Jagan left for his Lotus Pond residence in Hyderabad. The court's summons triggered heightened security across key areas of the city. Police implemented extensive traffic diversions around Begumpet Airport and the Nampally Court complex. Anticipating the large crowds, authorities deployed additional personnel and set up barricades to control public access along the route.

flex banners carrying the slogan "Rappa Rappa — 2029" appeared across Hyderabad, inspired by a popular dialogue from actor Allu Arjun's upcoming film Pushpa 2. The slogans were widely interpreted by party followers as symbolic of Jagan's political resurgence and anticipated return in the 2029 elections.

The former Chief Minister flew from Vijayawada's Gannavaram Airport to Begumpet in the morning and then traveled by road to the Nampally Court. Both at the airport and court premises, enthusiastic fans gathered in large numbers to greet him. Some police personnel, assigned for security, were even spotted taking selfies with Jagan, adding a lighter note to the otherwise tense arrangements. Legal Background The disproportionate assets case against Jagan Mohan Reddy has been under investigation for over a decade, involving both the Central Bureau of Investigation (CBI) and the Enforcement Directorate (ED).

The agencies allege that during the tenure of his father, late Chief Minister Y.S. Rajasekhara Reddy, several companies were granted government benefits such as land leases and licenses—in exchange for investing in firms owned or controlled by Jagan. The CBI's charge sheets cite multiple corporate entities, including Dalmia Cements, India Cements, Penna Cements, and Raghuram Cements, alleging quid pro quo investments worth over 150 crore. Investigators claim Dalmia Cements alone invested 95 crore in Jagan-linked enterprises and transferred an additional 55 crore through hawala channels.

Evidence for these transactions was reportedly obtained from a pen drive recovered from a company employee Jayadeep Basu. The Enforcement Directorate pursued related money-laundering charges, freezing assets worth 793 crore linked to Dalmia Cements, including land holdings valued at over 377 crore. The ED's actions were later upheld by the Adjudicating Authority.

One of the notable offshoots of this case involves the Vanpice port and infrastructure project initiated during Y.S. Rajasekhara Reddy's regime. The CBI alleged that rules were violated to allocate over 15,000 acres to the project, managed by industrialist Nimmagadda Prasad. In return, Prasad allegedly made substantial investments in companies associated with Jagan Mohan Reddy.

As the legal process continues, Jagan's personal appearance after such a long gap has once again placed the spotlight on one of India's most closely watched political and financial investigations.

# SIT Questions Former TTD Chief Y.V. Subba Reddy in Adulterated Ghee Scam

**H**yderabad: The Special Investigation Team (SIT) appointed by the Supreme Court has intensified its probe into the adulterated ghee scam at the Tirumala Tirupati Devasthanams (TTD),

questioning former chairman and YSRCP Member of Parliament Y.V. Subba Reddy. The SIT official interrogated him on Thursday at his residence in Hyderabad, in the presence of senior officers overseeing the investigation being carried out under the supervision of the Central Bureau of Investigation (CBI).

The probe pertains to the alleged supply of spurious and adulterated ghee used in preparing the famous Tirumala laddus between 2019 and 2024.

The SIT's preliminary report revealed that large quantities of ghee mixed with synthetic and non-dairy substances had been used, compromising the sanctity and purity of the temple's prasadam. Investigators found that contractors had supplied about 68 lakh kilograms of substandard ghee valued at over 250 crore during the period. The investigation gained momentum after the arrest of Subba Reddy's former personal assistant, Ch-

anna Appanna, on November 11. Appanna reportedly received 4.69 crore in hawala transfers from contractors who had supplied the adulterated ghee. SIT sources said he provided crucial information about money transfers, sources of funds, and possible involvement of top officials in the TTD procurement process. Based on his testimony, the SIT expanded its inquiry, summoning Subba Reddy for a detailed interrogation. During his tenure as TTD chairman from 2019 to 2024, Subba Reddy oversaw key procurement and tender approvals.

Officials are now examining whether he had any direct or indirect role in the selection of contractors or in the clearance of ghee supply bills.

According to SIT members, his responses so far have been "unsatisfactory" and "evasive" on several questions related to financial transactions and the hawala links traced through his close aide. The SIT has already questioned several of her officials, including former Additional Executive Officer A.V. Dharmendra Reddy, who was in service during the same period. The team has reportedly collected crucial documents, bank records, and communication logs to establish a chain of responsibility.

Sources indicate that Reddy had avoided appearing before the SIT on multiple occasions despite being issued summons. He was initially asked to appear on November 13 but cited health reasons and sought more time. Subsequently, officials decided to question him at his Hyderabad home. He has also moved court seeking relief from sharing personal bank account details, a ruling procedural lapses in the SIT's notice.

The SIT has informed the court that Subba Reddy's conduct raised suspicion, particularly his reluctance to cooperate fully with investigators. The team is expected to submit a detailed report to the Andhra Pradesh High Court soon, outlining the financial trail, irregularities in procurement, and evidence linking the suspects involved. Though Subba Reddy maintains that only high-quality ghee was purchased during his administration, forensic and chemical analyses of samples have indicated otherwise. The findings, officials say, point to large-scale manipulation in quality certification and supply contracts. The investigation continues to draw public attention given the global reputation of Tirumala's sacred laddus. The SIT aims to complete the next phase of questioning and file a status report before the end of the month.

## Top Maoists Devuji, Malla Raji Reddy not in our custody: Andhra Police tells HC

**A**ndhra Pradesh Police told the state High Court on Thursday that CPI (Maoist) General Secretary Thippiri Tirupathi, alias Devuji and another to a Maoist leader Malla Raji Reddy were not in custody of the state police.

The police conveyed this to the High Court when it took up hearing on a habeas corpus petition filed by one Gangadhar of Telangana, seeking direction to Andhra Pradesh Police to produce Devuji and Raji Reddy in the court. The police, however, denied that the two leaders are in their custody. It informed the court that Maoists who

were arrested in five districts on November 18 were already produced before concerned courts. The High Court directed the petitioner to submit the evidence in support of his claim that Devuji and Raji Reddy are in police custody.

The petitioner's counsel argued that the police issued a press statement that key Maoist leaders are in their custody. He sought time to submit the statement to the court.

Nine members of the protection team of Devuji were among 50 Maoists arrested in five districts on November 18, hours after an encounter in the forests of Alluri Sitharamaraju district in which top Maoist commander Madvi Hidma, his wife Raje and four

others were killed. A day after Hidma's killing, seven Maoists including explosives expert Metturi Joga Rao alias Tech Shankar and six others were killed in Alluri Sitharamaraju district.

Civil liberties groups have alleged that both the encounters and arrests were fake. They also claimed that Devuji is in police custody. Andhra Pradesh Civil Liberties Committee (APCLC) and the CPI-ML New Democracy alleged that police have taken Devuji into their custody in the operation. APCLC State general secretary Chiluka Chandrashekhar demanded that the police produce Devuji and other Maoist leaders in the court immediately.

## Naxalism Hits Dead End After Op Kagar?

Krishna Kumar, In what appears to be the final phase of Maoist activity in South India, the recent developments under "Operation Kagar" have signaled the nearing collapse of the Maoist movement. The surrender of senior leaders and the death of a top commander have dealt a decisive blow to the insurgent group that once posed a grave internal security challenge in the region.

Senior Maoist State Committee members Kunkut Venkatayya alias Y.V. Vikas, Mogilicherla Venkata Raju alias Erra Raju, and his wife Ganga alias Gangavva surrendered before Director General of Police Shivadher Reddy. The surrender follows a series of setbacks for the Maoists, including the death of the dreaded Chhattisgarh leader Hidma in an exchange of fire and the arrest of nearly 50 cadres in the past few weeks. Several top leaders in Telangana have also recently surrendered, reinforcing the view that Maoism



has now entered its final act.

Historically, Andhra Pradesh was among the worst-affected states during the height of Naxal and Maoist violence. From Duddilla Sri Padma Rao to Kidari Sarveswara Rao, many public representatives fell victim to the extremists who targeted them to preserve their waning influence. Security forces too suffered heavy casualties. But over the years, focused counter-insurgency efforts and social development initiatives gradually weakened the movement, leaving only fringe groups active in parts of the Andhra-Orissa Border (AOB) region.

Operation Kagar, security analysts say, has brought the curtain down

on the decades-long struggle. The remaining Maoists appear to be either surrendering or fleeing their former forest hideouts. Even ideological conviction has eroded, and internal rifts have widened. With modern technology allowing security forces to track movements in real time, the traditional guerrilla tactics that once ensured Maoist survival have become obsolete. The government, with renewed vigor, has set a firm deadline to neutralize all remaining Maoist groups. The Union Home Ministry reportedly aims to complete this by March 2026. Security sources indicate that only a handful of active cadres are still operating, and even their top leadership including the

elusive Devji is said to be on the run, possibly taking refuge far from conflict zones. There are unconfirmed reports suggesting he might already be in police custody. Observers note that while urban sympathizers continue to voice support under the guise of ideology, they have largely lost credibility. Union Minister of State for Home Affairs Bandi Sanjay recently alleged that such sympathizers enjoy luxurious lifestyles while inciting youth to violence. The death of Hidma, once a symbol of Maoist resistance, has shattered remaining morale within the outfit. Experts argue that although "Naxalites can be eliminated, Naxalism cannot" — the fundamental Maoist belief that power flows from the barrel of a gun now appears irrelevant in the modern democratic context. With the combined pressure from law enforcement and disillusionment among cadres, Andhra Pradesh might soon witness the official end of the Naxal era.

## Minister Nadendla Manohar's Timely Intervention Resolves Farmer's Paddy Sale Issue in a Day

Krishna District, A farmer's distress in Krishna district turned into a heartening story of swift governance after Andhra Pradesh Civil Supplies Minister Nadendla Manohar personally intervened to resolve a paddy procurement problem within hours of being informed. The incident took place in Bhatlapenumarru village of Movva mandal, the birthplace of national flag designer Pingle Venkayya. Local farmer Chalasani Chanti Babu, who cultivated paddy on 14 acres, faced major difficulty in selling his harvested grain due to unavailability of gunny bags and transport vehicles.

Officials at the local Rythu Seva Kendra had informed him that procurement would be delayed for want of resources, leaving the farmer worried and helpless. Disheartened, Chanti Babu shared his problem with a local acquaintance, who passed on the details to the Minister's team. The message reached Minister Nadendla Manohar through WhatsApp on Thursday morning. Without delay, the Minister personally called the farmer around 10:15 a.m. to understand his problem. "I couldn't believe the Minister himself was



calling me," said an emotional Chanti Babu.

"I explained everything, and he assured me not to worry—that he would take care of it." Acting on the Minister's instructions, the district administration swung into action immediately. Within half an hour, officials from multiple departments contacted the farmer, informing him they were coming to his village to arrange the procurement of his paddy. By noon, the Mandal Tahsildar and revenue staff reached Bhatlapenumarru, inspected the

harvested grain, and made necessary arrangements to supply gunny bags and begin paddy collection the same day. The quick resolution left the farmer and local community astonished. Villagers said they had never before witnessed such rapid administrative response. They expressed appreciation for the Minister's proactiveness, stating that it showed a new level of government sensitivity toward farmers' issues. "In the past, cases like this would take weeks to resolve. This time, it happened in

a few hours," remarked a local resident.

Overwhelmed with gratitude, Chanti Babu acknowledged the Minister's empathy and timely assistance. "Minister Nadendla Manohar Sir calling a small farmer like me is beyond imagination," he said. "My problem, which seemed unsolvable yesterday, was settled within a day because of his intervention. Whatever I offer will never be enough to repay this help. The incident has sparked discussions in local farming circles, with many appreciating how tec

hnology and quick administrative coordination can bridge the gap between governance and ground-level issues.

Farmers in the region now feel reassured that their concerns are being heard at the highest levels. Minister Nadendla Manohar's direct involvement in resolving a grassroots problem has drawn statewide attention, with observers noting that such responsiveness demonstrates a model of people-centered administration the state aims to uphold.



## Andhra Farmers Can Now Book Paddy Procurement Slots Instantly Through WhatsApp: Minister Manohar

Amaravati: Andhra Pradesh Civil Supplies Minister N. Manohar on Thursday announced a new WhatsApp-based digital service

that enables farmers to instantly book paddy procurement slots, marking a major step toward easing the crop procurement process in the state. Launching the service, the minister said the National Democratic Alliance (NDA) coalition government had introduced the initiative to eliminate delays and waiting times that farmers typically face at procurement centres.

The system, powered by artificial intelligence, aims to make paddy procurement faster, more transparent, and entirely accessible from mobile phones. Explaining the process, Manohar said farmers can begin booking by simply sending a "Hi" message to the dedicated WhatsApp number 7337359375. An AI-enabled voice assistant

will then guide users through each step. Farmers will be prompted to enter their Aadhaar number and verify their name before selecting a preferred procurement centre.

They can then choose from three available dates and pick a convenient time slot for delivering their paddy. The service also allows farmers to specify the variety of paddy and the number of bags they intend to sell. Once the booking is completed, a unique coupon code will be issued as confirmation, which the farmer can present at the procurement centre. Manohar explained that this digital procedure is a simple but transformative step. It brings convenience to lakhs of farmers and enhances efficiency at every level of procurement," Manohar said. The new digital service will remain operational throughout the ongoing paddy procurement season and is expected to handle thousands of bookings daily across all districts of Andhra Pradesh.

SATHYA SAI DISTRICT: Tourism Minister Kandula Durgesh has announced that Lepakshi will be transformed into an international tourism hub, with concrete steps underway to secure permanent UNESCO world heritage recognition for the historic site. On Thursday, the minister visited the ancient town of Lepakshi in Sri Sathya Sai district, where he offered special prayers at the renowned Sri Veerabhadra Swamy Temple before briefing the media.

Durgesh said Lepakshi, celebrated for its extraordinary architecture and sculptural grandeur, has already found a place in UNESCO's tentative list of heritage monuments. Built nearly 450-500 years ago, the temple stands as a shining example of Vijayanagara-era craftsmanship. Its intricate carvings, mythological depictions, and detailed murals offer visitors a profound spiritual and artistic experience, he noted. The minister asserted that such heritage sites must be developed not merely as impressive spots but as immersive cultural desti-

nations. He announced plans to create a Temple Circuit covering Lepakshi's Veerabhadra Swamy Temple, the Lakshmi Narasimha Swamy Temple in Kadri and spiritual centres in Puttaparthi, along with nearby nature attractions. The goal is to encourage tourists to extend their stay from a single day to two or three days.

To support this, the government is introducing hotels and resorts under the PPP model, while strengthening eco, temple, heli, agri and adventure tourism activities to position Andhra Pradesh as a global tourism hub. Durgesh highlighted that Chief Minister Chandrababu Naidu and Deputy Chief Minister Pawan Kalyan are taking special interest in promoting tourism investments. The state attracted 17,000 crore in tourism proposals during the recent CII Summit and another 12,000 crore in the last 15 months, taking the total to nearly 30,000 crore since the coalition government assumed office. He reiterated Lepakshi's architectural and cultural significance, mentioning marvels such as the monolithic Nandi, the wor-

ld-famous hanging pillar and the exquisite ceiling frescoes symbols of India's rich artistic heritage. The government is committed to preserving and promoting these treasures for global recognition, he said.

The government is also organising the centenary celebrations of Bhagawan Sri Sathya Sai Baba in Puttaparthi.

Addressing the meeting, the Minister said that the government aims to groom one entrepreneur from every family, and it is the responsibility of the administrative machinery to take this slogan deep into the grassroots. ## Godavari-Nallamala Sagar Link Project Marks a New Dawn for Backward Regions: Lanka Dinakar

VIJAYAWADA: Lanka Dinakar, Chairman of the Twenty-Point Programme (Viksit Bharat - Swarna Andhra), described the State Government's decision to link Godavari river waters to the Nallamala Sagar (Veligonda Project) through the Bollapalli Reservoir as a "historic and transformative milestone" for drought-prone and fluoride-affected regions of Andhra Pradesh.

He expressed gratitude to Chief Minister N Chandrababu Naidu for approving the project, which promises wide-ranging benefits, including drinking water, irrigation support and industrial water supply for backward areas across Prakasam, Nellore and Kadapa

districts. The project is expected to provide safe drinking water to 60 lakh people and irrigation to nearly 7 lakh acres, while supporting future industrial growth in regions like Dondakonda and Kanigiri.

Dinakar recalled that he had submitted a detailed representation to the Chief Minister on January 1, 2025, highlighting the dire conditions in fluoride-hit mandals such as Kanigiri, Markapuram, Dondakonda and Udayagiri. The next day, he was invited to a high-level meeting by Irrigation

Minister Nimmala Rama Naidu, where he reiterated the urgent need for linking Godavari waters to Veligonda. A Union Government report released the same day identified Palnadu and Prakasam as among India's most fluoride-affected districts.

The Chief Minister's announcement at Markapuram on March 8, 2025, confirming the Godavari-Veligonda linkage, marked a major breakthrough. A subsequent review on May 20, 2025, at Ongole revealed that out of 1,769 villages in

Prakasam, 1,009 were fluoride-affected, with Kanigiri alone accounting for 442 such villages. Officials stressed that a complete and permanent solution would be possible only with the Veligonda Project's completion and river interlinking.

Dinakar also shed light on the shortcomings of the previous government, alleging that former CM YS Jagan Mohan Reddy inaugurated an incomplete tunnel of the Veligonda Project and misled the public. A fact-finding visit on March 11, 2025, reportedly ex-

## Leprosy Detection Survey Must Be Conducted Rigorously: DPH

VIJAYAWADA: Director of Public Health (DPH) Dr K Padmavati stated that the ongoing Leprosy Case Detection Campaign (LCDC) across the state is being carried out systematically, with 66,52,563 people screened by Thursday. Of these, 5,085 individuals have been referred to medical officers for re-examination, she said.

She informed that the household survey, which will continue until the 30th of this month, requires the compulsory participation of ASHA workers and male volunteers from 7 AM to 9 AM every day. Dr Padmavati appealed to the public to cooperate with ASHA workers and ANMs who visit homes for screening. Suspected cases identified during the survey will be referred to the nearest Primary Health Centres



(PHCs) for further medical evaluation. She further explained that once symptoms are detected in an individual, a Focal Leprosy Survey (FLC) will be conducted covering 300 surrounding households. Additionally, Single Dose Regimen (SDR) or Post Exposure Prophylaxis (PEP) will be administered to at

least 30 to 40 people, including family members and immediate neighbours of the suspected patient. Dr Padmavati said that Multi-Drug Treatment (MDT) is being provided free of cost to all leprosy patients to ensure effective treatment and prevention. To intensify public awareness on leprosy, information leaf-

lets are being distributed to every household and banners are being displayed at major junctions. She added that on the 10th of every month, Disability Prevention and Medical Rehabilitation (DPMR) camps are conducted at Primary Health Centres and leprosy colonies. These camps offer

physiotherapy to individuals with disabilities. Issues that cannot be resolved through therapy are corrected through Reconstructive Surgery (RCS). The government provides 12,000 to patients undergoing RCS — 6,000 during treatment, followed by 3,000 each for the first and second follow-ups.

## Seven-Day Outreach to Promote Five Key Agricultural Principles

VIJAYAWADA: The Andhra Pradesh government is preparing to launch a major statewide agricultural awareness initiative titled "Raitanna Meekosam" starting from November 24. Aimed at transforming farming into a profitable and sustainable activity, the programme will focus on the five core principles recently announced by Chief Minister N Chandrababu Naidu, Water Security, Demand-Based Cropping, Agritech, Food Processing and Government Support.

The Chief Minister held a large-scale teleconference on Thursday with nearly 10,000 participants, including officials from the Agriculture and allied departments, Marketing Department and staff of Rythu Seva Kendras (RSKs). During the meeting, he issued clear directions to all departments on implementing awareness activities at the village level.

As per the schedule announced, public representatives and officials will visit every

farmer's household from November 24 to 29. On December 3, workshops will be conducted at all Rythu Seva Kendras to educate farmers on modern farming practices and departmental support systems.

Speaking during the teleconference, the Chief Minister said the government has been consistently prioritizing the welfare of farmers over the past 17 months. He highlighted that under Annadat Sukhibhava and PM-Kisan, 14,000 have already been credited in two installments to more than 46.5 lakh farmers, amounting to 6,310 crore.

He stressed the importance of micro-irrigation, field-level learning initiatives like Polam Pilostondi, and a scientific approach to agriculture to ensure farmers earn better returns. "The five principles are not just for farmers, but also for their families. Along with crop farmers, dairy farmers, poultry farmers, sheep rearers, aquaculture farmers, horticulture and sericulture farm-

ers must also be reached," he said.

The CM directed RSK staff to lead awareness drives and prepare actionable plans for every centre. He also underscored the need to explain the benefits of natural farming, agritech applications and value addition through modern methods. He said natural farming enhances soil health and improves public health and noted that Andhra Pradesh is already promoting certification and traceability for such produce.

Chandrababu Naidu stressed reducing cultivation costs, promoting products through Rythu Bazaars, and setting up food processing units to improve market access.

He called for educating farmers on the dangers of excessive pesticide use, the advantages of organic cultivation, and the strong demand abroad for chemical-free produce. Highlighting the success of water management reforms, he said reservoirs across the state were filled through efficient strategies.

## Online Cricket Betting Racket Busted in Mangalagiri; Police Seize Equipment, Hunt Key Accused

Mangalagiri: A major online betting racket operating under the name "Book.com" has been busted by the Mangalagiri Rural Police, exposing a network allegedly involved in organizing large-scale cricket betting activities. Acting on credible information, the police team carried out a midnight raid two days ago at an apartment flat located behind the NRI Hospital in Mangalagiri. The operation

was conducted under the supervision of Mangalagiri Rural Circle Inspector (CI) A.V. Brahmam and led by Sub-Inspector (SI) Venkat.

During the surprise raid, police officials seized five laptops, 32 mobile phones, 15 ATM cards, and 14 bank passbooks believed to have been used for betting transactions and money transfers linked to online gambling. One individual has been detained for questioning, while efforts are underway to

identify and apprehend other members of the racket who are still at large. Preliminary investigation suggests that the suspects were using online platforms and so-

cial media channels to lure participants into illegal betting activities during ongoing domestic and international cricket matches.

The police suspect that

the key organizers of the racket hail from Machilipatnam and have been coordinating with associates across multiple districts using digital payment channels and

fake bank accounts. Officials revealed that the seized devices and documents contain crucial data that may expose the network's wider operations, including links to

similar online betting syndicates functioning across Andhra Pradesh. Cybercrime specialists have been roped in to assist with data recovery and to trace digital transactions used for placing and collecting bets. Mangalagiri Rural CI A.V. Brahmam stated that the department is determined to crack down on cyber-based gambling, which has been growing in recent years under various digital identities and websites. He added that public awareness

and prompt information sharing are key to preventing such crimes, urging citizens to stay alert and report suspicious online activities.

Police have registered a case and intensified the search for the prime suspects believed to be operating from Machilipatnam and other coastal towns. The investigation aims to uncover the extent of financial transactions and identify the mastermind behind the illegal operation.

# Congress leaders demand for immediate compensation of Polavaram families

Rajamahendravaram: Andhra Pradesh Congress leaders have demanded that the state and central governments immediately compensate nearly 89,000 displaced families affected by the Polavaram project. Addressing a press conference at the local Press Club on Thursday, PCC Vice-President and Chairman of the Polavaram Project Construction and Rehabilitation Study Committee, Martin Luther, said the government must release the due rehabilitation and resettlement (R&R) packages before proceeding further with the project.

Luther explained that as per the original design, the Polavaram project height was fixed at 45.72

meters, which would displace approximately 89,000 people, necessitating the disbursal of about Rs 55,000 crore as compensation.

However, the central government's decision to reduce the project height to 41.15 meters has decreased the official count of displaced families to 38,000 and reduced the compensation amount to Rs 30,000 crore. He alleged that this move aims to evade nearly Rs 25,000 crore in compensation and could deny rightful benefits to around 50,000 displaced residents. He further revealed that only 25.75 percent of eligible families have received their R&R packages so far, leaving nearly three-quarters of the project-affected people uncompensated.

Luther asserted that

the Congress Party would continue its agitation until every displaced individual receives full assistance. He also criticized the reduction in project height, stating that such an adjustment would turn the Polavaram dam into a mere lift-irrigation project rather than a truly multipurpose one. Luther announced that Andhra Pradesh PCC President Y.S. Sharmila would undertake a field visit to the Polavaram project in the first week of December to personally review the conditions and interact with the displaced families.

District Congress President and Study Committee member T.K. Visweshwar Reddy also spoke, emphasizing that with the reduced project height, water cannot naturally reach districts like Visakhapatnam and Krishna without the use of heavy pumping systems.

He noted that while the state government claims the project will be completed by October 2026 or at least before the next Godavari Pushkaralu it is already 80 percent complete. Reddy criticized Andhra Pradesh MPs for their silence on the height reduction issue and reiterated the demand for full compensation to all 89,000 displaced persons. City Congress President Balepalli Muralidhar and other senior leaders including Bezwada Rangarao, Devata Sudhakar, Kowvuri Srinivasarao, Kishore Jain, Nalla Veeraju, Battina Chandrarao, and Suribabu were also present.

British literary magazine Granta's latest India issue delves deep into the complexities of progress—or *vikas*—in the country, presenting a collection of essays that examine how development intersects with culture, politics, and personal lives. The issue resists simple narratives, highlighting instead India's jagged, restless, and often contradictory evolution.

Snigdha Poonam's essay, *The Thin Red Corridor*, introduces *Vikas*, a former Maoist commander from Jharkhand who moves from planting landmines to supervising road construction decades later. *Vikas* becomes both a man and a metaphor, reflecting how India's idea of progress is uneven, improvised, and shouldered largely by those who never asked to become symbols. Through his story, Poonam frames a central question: what does progress truly look like on the ground?

Other contributors explore different facets of this ten-

sion. Raghu Karnad's piece, *Under the Ruins*, examines Prime Minister Narendra Modi's underwater dive off Dwarka, highlighting how spectacle, archaeology, and political imagination intermingle. Villagers in Uttar Pradesh's Barnawa, proudly guiding tourists through a tunnel linked to the Pandavas, exemplify how local communities invest in myth to assert their place in history, echoing *Vikas*'s quiet resilience.

Karan Mahajan's essay on Hardeep Singh Nijjar's killing in Canada extends the conversation globally, tracing the intergenerational grief of Sikhs families alongside the defensive posture of a state grappling with unresolved trauma. Meanwhile, Sarabjeet Garcha meditates on *hukam*, suggesting that progress can be found in acceptance and cultural continuity, and J Devika highlights the persistent, everyday care in Kerala's health system as another form of



slow, attentive development. Salman Rushdie, in conversation with Granta, reflects on India's literary and cultural landscape, emphasizing storytelling as a form of *vikas*. He contends that imaginative territory must be continually reclaimed, not through consensus but friction, suggesting that narrative itself can shape the contours of progress.

Collectively, the essays depict an India where development is neither linear nor uniform. Progress can be a road, a political process, a ruin, or even a deeply personal experience. *Vikas*, both as a person and symbol, threads through the issue, reminding readers that the nation's growth is inseparable from the lives it transforms—and the histories it cannot forget. Granta's India issue does not provide a verdict but rather presents a mosaic of experiences, capturing the contradictions and aspirations of a country moving unevenly toward its future.

A recent White House photograph featuring former US President Donald Trump flanked by Pakistan's Prime Minister Shehbaz Sharif and Field Marshal Asim Munir has become a defining image for India's geopolitical watchers, offering a window into how Pakistan navigates power and survives politically. The photograph highlights the persistent dominance of Pakistan's military in shaping the country's political landscape. Munir, Pakistan's army chief, sits prominently alongside the prime minister, underscoring the army's decisive role even in ostensibly civilian-led governments. This visual continuity reflects a return to what analysts call the "old normal" in US-Pakistan relations, where the military remains central while civilian leadership assumes a subordinate, symbolic role.

Historically, Pakistan's civilian leaders have struggled to assert authority independently. Former Prime Minis-

## India Faces Challenge of Equitable AI Education in Schools



India is at a critical juncture as it prepares to introduce AI education from Class 3 in 2026-27, but experts warn that a rush to replicate global models could deepen existing educational inequalities. While states like Punjab and Odisha are piloting innovative programs, the majority of India's schools remain ill-equipped for such technological leaps.

Punjab's initiative emphasizes immediate, hands-on learning. Its three-year AI curriculum encourages coding exercises, hackathons, and science fairs where students apply machine learning to real-world problems. The state benefits from strong digital infrastructure, with over 95% of government schools equipped with functional computers.

Odisha, in contrast, adopts a long-term, inclusive approach. Its AI Policy 2025 outlines a decade-long roadmap, combining free online courses, AI labs, and teacher training, while promoting lessons in Odia and tribal languages. Both models highlight state-level innovation but also underscore India's uneven preparedness. Nationally, only 57% of schools had computers and 54% had internet access in 2023-24, with figures in poorer states like Bihar and West Bengal dropping below 25%. A 2021 survey indicated less than 27% of Indian youth aged 6-14 had basic internet skills.

China's nationwide AI curriculum sets a global benchmark with its top-down approach, substantial funding, and uniform educational sys-

tem. India, however, faces systemic constraints: fragmented infrastructure, low digital literacy, and wide socio-economic disparities. Experts caution that blindly following China's model risks widening the gap between urban, elite schools and resource-poor government institutions.

Beyond infrastructure, regulatory gaps pose additional risks. India lacks comprehensive frameworks to address student data privacy, algorithmic bias, and ethical use of AI in classrooms. Without safeguards, technological integration could lead to surveillance, profiling, or discrimination, particularly affecting vulnerable students.

Specialists recommend a phased, context-specific rollout emphasizing equity. Key priorities include ensuring nationwide access to electricity, internet, and devices; digitally literate and ethically trained teachers; and national standards for data protection and accountability. Pilot programs to train 10 million teachers under CBSE's framework are a step forward.

India's challenge is not simply teaching AI, but teaching it justly. Initiatives like Punjab's and Odisha's demonstrate that innovation can coexist with inclusion, but scaling these models requires patience, investment, and careful planning. The country must bridge aspiration with capacity to ensure the AI revolution in education empowers all students, rather than leaving the most vulnerable further behind.

interventions, instills public acceptance of army dominance. Citizens often elect leaders only to witness their removal or suppression, yet the cycle of popular unrest followed by military consolidation continues. Strategic crises, particularly with India, are frequently leveraged by the army to reinforce its authority and restore public credibility. Events like 26/11 and repeated skirmishes along the Line of Control exemplify this pattern.

Munir's tenure marks a more explicit intertwining of religion and military ideology. Analysts argue this approach combines religious legitimacy with strategic posturing, using proxy forces and alliances with other powers, notably China, to keep India off balance.

The photograph of Trump, Munir, and Sharif is more than ceremonial. It visually confirms that Pakistan's military, under leaders like Munir, remains the ultimate arbiter of policy, both domestically and internationally. For India, the image underscores the enduring challenge of engaging with a state where civilian authority is conditional and the military operates as a self-reinforcing institution with long-term strategic ambitions.

# Nitish Kumar Takes Oath As Bihar Chief Minister For Record 10th Time

Nitish Kumar was sworn in as Chief Minister of Bihar for a record-extending tenth term on Thursday at the historic Gandhi Maidan, following a decisive victory in last week's Assembly election. His Janata Dal (United) won 85 of the state's 243 seats, contributing to a resounding victory for the BJP-led National Democratic Alliance, which secured 202 seats.

Critics who had questioned Kumar's longevity and fitness for office were silenced as he returned to power, demonstrating his enduring political acumen and ability to forge alliances effectively. With this term, Kumar is set to become India's longest-serving chief minister if he completes the full tenure, surpassing Sikkim's Pawan Chamling, who served 24 years.

sworn in to form the core of the new cabinet. Experienced leaders like Choudhary and Sinha, who served as Kumar's deputies in the previous administration, are expected to reprise key roles. Other notable ministers include Pramod Kumar, Sanjay Kumar Singh,

Lakhendra Raushan, and two-time MLA Shreyasi Singh, the 34-year-old Commonwealth Games gold medallist.

Senior leaders Ram Kripal Yadav, formerly with RJD and JDU, and ex-Roadways Minister Nitin Nabin also took oath. The new government emphasizes a mix of experience and proven leadership, signaling continuity and stability for Bihar's administration.

The NDA's sweeping victory and Kumar's historic return underline both the political strength of the alliance and his enduring influence in the state.

## SC Clarifies It Will Not Overrule TN Governor Case in Presidential Reference

The Supreme Court on Wednesday clarified that its ongoing hearings in the Presidential Reference concerning the Tamil Nadu Governor case are not an appeal against the April 8 verdict, nor do they intend to overrule the two-judge Bench ruling.

The two-month-long proceedings before a five-

Judge Bench headed by Chief Justice of India B.R. Gavai were initiated after the President invoked the advisory jurisdiction of the Supreme Court under Article 143 of the Constitution. The reference seeks the Court's opinion on 14 questions, including whether the apex court can "impose" timelines or prescribe the manner in

which Governors and the President should act under Articles 200 and 201 when dealing with State Bills sent for assent or reserved for consideration.

Incidentally, the Presidential Reference was issued on May 13, barely a month after a Division Bench led by Justice J.B. Pardiwala set a three-month timeline for the

President and the Governors to clear State Bills. The case has drawn attention due to its implications on the balance of power between the state executive and the Centre, as well as the procedural obligations of Governors.

During the hearings, the SC Bench repeatedly emphasized that its role in the Presidential Reference is

advisory and not appellate. "This is a reference, not an appeal. We are not here to overrule the prior judgment but to provide clarity on the broader constitutional questions posed by the President," the Court stated.

Legal experts note that the Presidential Reference is significant in interpreting the discretionary powers of Governors and the President in legislative processes and could shape future interactions between state governments and the Centre. However, the apex court's repeated assurances make it clear that the April 8 verdict, which set guidelines on timelines for Governor and Presidential actions, remains intact.

The Supreme Court is expected to deliver its opinion on the Presidential Reference in the coming weeks, which will provide authoritative guidance on the constitutional provisions governing the legislative assent process in India.

## Why India's AQI Stops at 500 Despite Higher Pollution Readings

As Delhi grapples with hazardous air pollution, a growing question arises: why does India's official Air Quality Index (AQI) stop at 500, even when independent monitors report far higher levels?

On Wednesday morning, Swiss air-quality company IQAir recorded Delhi's AQI at a staggering 506, while India's Central Pollution Control Board (CPCB) reported a lower figure of 399, categorised as "very poor."

The discrepancy highlights differences in methodology rather than accuracy, experts say.

The AQI is a public health tool designed to simplify air pollution data for citizens. It combines readings of eight

major pollutants—PM10, PM2.5, ozone, sulphur dioxide, nitrogen dioxide, carbon monoxide, lead, and ammonia—to generate a single number indicating air quality. According to Mohan George, consultant at the Centre for Science and Environment, the AQI uses color-coded ranges to communicate risk levels to the public.

"An AQI between 401 and 500 falls under the 'severe' category, meaning the air is hazardous even for healthy people, and outdoor activity should be avoided," George explained. "It's designed for the common man to understand and act upon."

CPCB's AQI framework does not report beyond 500, even if pollutant levels are technically higher. This is primarily because the system aims to trigger public health advisories rather than provide exact numerical extremes. Independent monitors like IQAir; however, provide actual calculated readings, which can exceed the official cap.

As Delhi's residents struggle with rising pollution, many are forced to take precautions like masks and air purifiers.

Parents, in particular, express frustration at having to choose between their children's health and daily life. The capped AQI serves as a general warning, but experts stress that actual pollution can be far worse, reinforcing the urgency of mitigation measures.

## Keir Starmer's Leadership Under Threat Amid Political Turmoil

British Prime Minister Keir Starmer faces mounting challenges as his government navigates turbulent political waters barely a year and a half after its landslide victory in July 2024. Despite Labour securing 411 of 650 parliamentary seats—a commanding 174-seat majority—Starmer's position is increasingly precarious due to a combination of electoral paradoxes and policy missteps.

Labour's overwhelming seat count belied the party's low popular vote of just 33.7%, highlighting a fragmented political landscape. The Conservatives trailed with 23.7%, while the resurgent Reform Party and Liberal Democrats captured 14.3% and 12.2%, respectively. This fragmentation means that many Labour MPs occupy constituencies with narrow margins, putting their seats—and the government's majority—at risk in future elections. Polling suggests Labour could be reduced to just over 100 seats if trends continue, creating significant pressure on Starmer's leadership.

Compounding the challenge, the government has faced backlash over a series of controversial policy decisions and perceived U-turns. Starmer's next moves will be closely watched, as the stability of his government—and his own political future—hang in the balance.

## "Whatever You Need": Russia Offers "5th Generation Fighter" Tech To India

Ahead of Russian President Vladimir Putin's visit to India next month, Moscow has extended a landmark defence proposal that could significantly influence the future of India's aerial warfare capabilities. Russia has offered New Delhi unrestricted access to its fifth-generation Su-57 stealth fighter technology—an unprecedented move in India's defence partnerships.

A senior Rosoboronexport representative added that the offer includes transfer of technology, licence production, and integration of Indian weapons, covering next-generation capabilities such as AESA radar, AI systems, low-signature materials and advanced air weapons.

Defence analyst and retired IAF officer Vijayender K. Thakur noted that a potential Su-75 production line in India would fit perfectly alongside the indigenous AMCA project, filling the fifth-generation gap with a cost-effective light/medium stealth fighter.

Reports further indicate that Russia may also offer India its single-engine Su-75 Checkmate stealth fighter. If accepted, India would gain access to cutting-edge aircraft technologies that Western nations have consistently declined to share. The deal could allow India to independently develop upgraded stealth aircraft, boosting its self-reliance and expanding its air-combat capabilities.

Speaking at the Dubai Air

U.S. President Donald Trump said he is prepared to face criticism from his conservative base as he pushes for the country to welcome more skilled immigrants, arguing that America cannot manufacture complex products like semiconductors and missiles without foreign expertise. Speaking at the U.S.-Saudi Investment Forum in Washington on Wednesday, Trump stressed that advanced plants being built across the country will require highly skilled workers from abroad to help train the American workforce.

Trump said industries involved in producing telephones, computers, chips and missile systems demand specialised knowledge that the U.S. workforce has not yet developed at the scale required. "I may take a little heat... from the people that



love me," he said, acknowledging opposition from right-wing supporters who back strict immigration limits. "But companies have to bring people to get those plants opened... and teach our people how to be brought in, and he would "welcome those people," drawing applause from the audience, which included

Saudi Crown Prince Mohammed bin Salman. He added that critics of this approach are "unbelievable patriots" but argued that America

cannot succeed unless workers are trained by experienced specialists from abroad.

Trump cited recent immigration raids, including one at the Hyundai battery plant in Georgia, and noted that such actions could hinder industrial growth. "Batteries are very dangerous to make... they brought in people, spent a billion dollars, and were told to get out. I said, 'Stop it. Don't be stupid,'" he said, claiming foreign experts are now training American workers there.

Defending visa programmes such as H-1B and L1, Trump reiterated that the U.S. lacks certain specialised skills. "You can't take people off an unemployment line and say we're going to make missiles," he said, urging support for immigration policies that bolster technological and manufacturing competitiveness.

## Massive Fire in Japan Destroys 170 Homes, Forces Large-Scale Evacuations

A massive fire swept through a residential neighbourhood in Oita, southwestern Japan, destroying more than 170 homes and forcing over 170 residents to evacuate. The blaze, which began on Tuesday evening near a fishing port amid strong winds, continued burning for nearly 20 hours before authorities managed to bring it partially under control on Wednesday.

According to the Oita prefectural disaster response team, one person—an elderly man in his 70s—was reported missing, and firefighters later discovered a body believed to be his. A woman in her 50s sustained minor injuries during the incident. The fire also spread into nearby forested land, affecting approximately 12 acres, the Fire and Disaster Management Agency (FDMA) reported.



Efforts to contain the blaze involved a large-scale mobilisation of resources, including more than 200 firefighters,

dozens of fire engines, and two UH-1 helicopters dispatched by the Ground Self-Defense Force. Despite

these efforts, the fire remained difficult to control due to strong winds that rapidly carried flames across densely packed wooden homes.

The affected area, located near Oita's mackerel fishing zone, is not close to the region's

owned hot spring resorts or historic thatched-roof structures, but the damage to local residences and infrastructure has been extensive. Around 260 homes remained without electricity by Wednesday afternoon.

Television footage showed thick plumes of smoke rising over charred remains of houses, though flames had subsided by mid-day. Residents described the ordeal as overwhelming, with one woman telling Kyodo News that the fire "spread in the blink of an eye," leaving little time to gather belongings.

Prime Minister Sanae Takaichi expressed her condolences on X and pledged full government assistance to affected families. Authorities are investigating the cause of the blaze and the factors that contributed to its rapid spread.

## Elon Musk's 'Thank You' Note To Trump After "You Are So Lucky" Reminder

After months of public disagreements, former US President Donald Trump and

billionaire entrepreneur Elon Musk appear to have mended fences.

The two reunited at a White House dinner attended by Saudi Crown Prince Mohammed bin

Salman, signalling a renewed camaraderie between the influential figures. During his

business-centered address at the event, Trump referenced Musk three times, even jokingly questioning whether the Tesla chief had ever "properly" thanked him.

"You are so lucky I am with you, Elon," Trump said while highlighting new tax incentives designed to boost domestic car manufacturing. Musk later responded with appreciation, writing on X that he would like to "thank President Trump for all he has done for America and the world," sharing images from the U.S.-Saudi Investment Forum in Washington, DC, where the two were photographed alongside the Saudi Crown Prince and NVIDIA CEO Jensen Huang.

Musk's presence at the event comes months after his stint as the head of the Department of Government Efficiency (DOGE), a role he held from January until the end of May. His departure

from the post had been followed by a sharp public critique of Trump's spending plans, particularly the administration's massive "Big Beautiful Bill."

Despite that tension, signs of reconciliation have grown increasingly visible. According to a report by The New York Times, Musk's allies are organising a large reunion party in Austin to celebrate his time with the DOGE team. Dozens of former staffers are expected to attend the two-day gathering at a luxury hotel, a location Musk frequents. Though Musk is anticipated to join the event, the report notes his plans may still change.

The renewed warmth between Trump and Musk suggests their political and business interests may again be aligning as both continue to wield significant influence across technology, policy and global investment circles.

# Sensex Jumps Over 700 Points, Nifty Regains 26,000 Level in Early Trade

Mumbai: The Indian stock markets opened strong on Thursday, with the benchmark indices Sensex and Nifty posting significant gains in early trade. The Sensex surged over 700 points, while the Nifty reclaimed the psychologically important 26,000 mark, reflecting renewed investor optimism.

The upbeat sentiment was largely driven by positive developments around the U.S.-India trade negotiations, which have sparked hopes of a potential deal that could boost bilateral economic ties. This optimism encouraged fresh foreign fund inflows into the Indian markets, providing additional momentum.

Information Technology (IT) stocks led the rally, with robust buying interest propelling gains in the sector. Investors are optimistic about the growth prospects of IT companies amid improving global demand and increasing digital transformation



initiatives worldwide.

Market analysts noted that foreign institutional investors (FIIs) played a crucial role in the early surge, channelling funds into Indian equities, which helped boost liquidity and confidence. The renewed foreign inflows

come at a time when global markets are cautiously watching geopolitical and economic developments.

Broader indices also followed the positive trend, with mid-cap and small-cap stocks witnessing buying interest. Market partici-

pants remained hopeful that the trade deal and strong corporate earnings could sustain the upward momentum in the near term.

The early session gains reflected a shift in market sentiment after recent volatility, with investors focusing

on favorable policy cues and potential easing of trade tensions. The move above the 26,000 level on the Nifty is seen as a key technical milestone that could pave the way for further upside.

Overall, Thursday's early trade suggested a

bullish start for Indian equities, supported by strong foreign participation and sectoral buying, particularly in IT stocks. Investors will be closely watching developments on the trade front and upcoming economic data for further direction.

## Reliance Industries Recalibrates Russian Oil Imports to Follow India's Guidelines



Reliance Industries Ltd (RIL), one of India's largest importers of crude oil from Russia, has announced that it will recalibrate its Russian oil imports to comply with the Government of India's latest guidelines. This move comes in the wake of fresh sanctions imposed by the United States and European

countries targeting Russian oil firms amid the ongoing conflict in Ukraine.

A company official confirmed that Reliance is adjusting its procurement strategy to align with the directives issued by Indian authorities, ensuring compliance with evolving international and domestic regula-

tory frameworks. The recalibration aims to balance Reliance's operational requirements with India's broader geopolitical and economic considerations.

The U.S. and European sanctions, which target Russia's major oil producers, including Rosneft and Lukoil, have led to increased scruti-

ny and pressure on companies globally to reduce their exposure to Russian oil. India, being one of the largest buyers of discounted Russian crude since the onset of the Ukraine conflict in 2022, has faced significant diplomatic and economic challenges due to these sanctions.

Reliance Industries' deci-

sion to adjust its imports reflects the broader impact of these international sanctions on India's energy sector and highlights the government's efforts to navigate the complex geopolitical landscape while ensuring energy security. The recalibration also indicates India's intent to maintain a balanced approach in its trade relations amid the intensifying global focus on Russia's energy exports.

## Rupee Strengthens by 13 Paise to 87.80 Against US Dollar in Early Trade



The Indian rupee appreciated by 13 paise to trade at 87.80 against the U.S. dollar in early trade on Thursday, October 23, 2025. Market participants attributed the gain to positive developments surrounding the U.S.-India trade deal, coupled with strong for-

eign fund inflows and upbeat domestic equity markets.

## HUL Q2 Profit Rises 3.8% to ₹2,694 Crore



FMCG giant Hindustan Unilever Ltd (HUL) reported a 3.8% rise in its consolidated net profit for the second quarter ending September 2025. The company's net profit climbed to ₹2,694 crore, up from ₹2,595 crore during the same quarter last year, according to a regulatory filing released on October 23.

HUL's revenue for the quarter also saw growth, increasing by 2.1% to ₹16,034 crore compared to the year-ago period. The modest rise in revenue and profit reflects steady performance amid a competitive and inflationary market environment.

The company's board approved an interim dividend of ₹19 per share for the fiscal year 2025-26, underscoring HUL's commitment to rewarding shareholders amid consistent earnings growth.

## Infosys Promoters to Skip ₹18,000 Crore Share Buyback



Infosys Ltd announced that its promoters and promoter group will not participate in the company's ₹18,000 crore share buyback program, the largest buyback the tech giant has undertaken to date. The company revealed this in a stock market filing on Wednesday, October 22, 2025.

Infosys plans to buy back 10 crore shares at an average price of ₹1,800 per share, marking its fifth buyback in the last decade. This significant move reflects the company's strong cash position and confidence in its long-term prospects.

However, the promoters — including Sudha Gopalakrishnan, wife of co-founder Kris Gopalakrishnan, who holds the largest promoter stake with 9,53,57,000 shares — have chosen not to participate in this buyback exercise. The company clarified that promoter-held shares were excluded when calculating the entitlement ratio for the buyback.

This decision means that only non-promoter shareholders are eligible to tender their shares in the buyback, potentially increasing the percentage of shares bought back from the public and institutional investors.

Share buybacks are a common way for companies to return capital to shareholders, often signaling confidence in the firm's future performance and improving key financial metrics like earnings per share (EPS).

Infosys' buyback comes amid a phase of robust business performance and growth in the IT sector, with the company continuously expanding its global client base and digital services portfolio.

Market analysts view the buyback positively, suggesting it could provide support to Infosys' stock price while delivering direct returns to shareholders.

Investors will closely watch the buyback process and its impact on the stock, as well as any further corporate actions from Infosys in the near term.

The company's announcement underscores its commitment to prudent capital management while maintaining flexibility for future investments.

## Microsoft Unveils MAI-Image-1, Its First In-House AI Image Generator



Microsoft has introduced its first natively developed image generation model, MAI-Image-1, marking a significant milestone in its generative AI journey. The announcement was made via the company's official newsroom post on Monday.

MAI-Image-1 is part of Microsoft's MAI (Microsoft AI) initiative, which focuses on building purpose-built models for enhanced integration within its products. The model debuted on the public AI leaderboard LMArena, where it ranked 9th among

top-performing text-to-image models. Although still in pre-release testing, the model's performance has already attracted attention.

This release follows a string of in-house AI developments by Microsoft this year. In July, the company

unveiled MAI Diagnostic Orchestrator (MAI-DxO), designed for medical diagnosis, and in August, it launched MAI-Voice-1, a voice generation model praised for its natural and expressive speech output. While Microsoft hasn't re-

leased technical specifications for MAI-Image-1, it emphasized the model's ability to generate high-quality photorealistic images—including lighting effects, landscapes, and dynamic visuals. The company claims the model is faster than many existing large-scale models, making it more efficient for everyday use.

Microsoft says its goal is not to compete in the race for general-purpose megamodels, but to build AI tailored for real-world applications. MAI-Image-1 is expected to be integrated soon into Microsoft's Copilot and Bing Image Creator, bringing advanced creative tools to a broader audience.

The model was trained using carefully selected datasets and underwent rigorous evaluations, focusing on real-world use cases. Microsoft also incorporated feedback from professionals in the creative industries to refine its performance.

As competition in generative AI intensifies, MAI-Image-1 represents Microsoft's growing independence in AI innovation, moving beyond partnerships and into proprietary development that aligns with its product ecosystem.

# England Aim to End Long Ashes Drought in Australia

As the 2025 Ashes series prepares to kick off on Friday, November 21, in Perth, anticipation is building around whether England can finally break their long-standing drought on Australian soil. The last time England won an Ashes Test series in Australia was during the 2010-11 tour, and since then, Australia has maintained a dominant unbeaten run at home.

Ahead of the first Test, captains Steve Smith and Ben Stokes posed with the Waterford Crystal Ashes Trophy in Perth, marking the beginning of what promises to be a fiercely contested series. The rivalry has been simmering since the dramatic and contentious 2023 Ashes in England, which was marred by heated exchanges, controversial dismissals and intense scrutiny of both teams' tactics.

With experienced campaigners like Smith, Marcus Labuschagne and Pat Cummins still forming the backbone of the team, Aus-

target, India A faltered early as openers Ruturaj Gaikwad (25) and Abhishek Sharma (11) failed to provide stability at the top. Captain Tilak Varma (11) and Riyan Parag (17) also fell cheaply, leaving India A struggling at 82/4 within the first 17 overs.

A resilient fifth-wicket partnership between Ishan Kishan and Ayush Badoni revived hopes. Kishan scored a gritty 53 off 67 balls, while Badoni added an equally impressive 66 off 66 deliveries. Their 88-run stand kept India A in the hunt, but South Africa A struck back with crucial breakthroughs.

South Africa A's disciplined bowling attack proved decisive, bundling out India A for 252 in 49.1 overs. Nqabayomzi Peter led the attack with figures of 4/48, while Tshepo Moreki (3/58), Bjorn Fortuin (2/48) and Delano Potgieter (1/23) contributed effectively to secure a convincing victory.

The actress described the situation as both "hurting" and "irritating" during a press conference in Chennai on Wednesday.

"AI has become a huge issue. It has turned into both a boon and a bane," Keerthy said. "Humans created technology, but we are gradually losing control over it. On social media, I am often shocked to see my photos in suggestive outfits and wonder if I ever wore them because they look that real."

The actress recounted a recent incident where an image of her, taken during a movie puja, was altered using AI to appear vulgar from a different angle. "For a moment, I was confused and then realized I never posed like that. It is definitely irritating and deeply hurting," she added.

Keerthy's statement comes amid growing concerns over AI-powered deepfake content,

which has increasingly targeted celebrities. Leading actors, including Katrina Kaif, Alia Bhatt, and Priyanka Chopra Jonas, have previously fallen victim to similar misuse, with morphed images and videos spreading rapidly online.

In a notable case in November 2023, a deepfake video of Rashmika Mandanna went viral. The actor called the incident "extremely scary," and authorities later arrested the individual responsible in January 2024.

Experts have warned that as AI tools become more sophisticated, the creation of hyper-realistic manipulated content poses serious risks to privacy, reputation, and mental health.

Keerthy's candid remarks highlight the urgent need for stronger regulations and awareness around AI-generated content. Celebrities and ordinary users alike face the challenge of navigating a digital space where technology can distort reality with alarming ease, making legal and social safeguards increasingly critical.

fulfilled life. But I decide the timeline! That's not privilege, it's my right!" she added.

Her initial statement

for women is to freeze their eggs... when you are financially independent"—drew mixed reactions. Some lauded it as empowering, while others criticized it as impractical for

most women. Entrepreneurs like Zoho founder Sridhar Venkateswaran encouraged earlier marriage and parenthood, citing social responsibility. The debate under-

scores ongoing discussions around women's career choices, fertility, and the balance between privilege and practical realities in India's evolving workplace.
