

Pawan focuses on Eluru development

Koyyalagudem: Andhra Pradesh Deputy Chief Minister Pawan Kalyan recently undertook a significant tour of the Eluru district, focusing on the development and welfare activities in Koyyalagudem and Dwarka Tirumala mandals. His visit, marked by a blend of direct public engagement and ceremonial inaugurations, underscores his commitment to expediting governance and infrastructure progress in the region. Pawan Kalyan commenced his journey by arriving at the Rajahmundry Madurapudi air port via a special aircraft. From there, he traveled by road to the Koyyalagudem mandal, reaching the village of Rajavaram.

In Rajavaram, the Deputy CM engaged directly with villagers, listening attentively to their concerns and grievances. The villagers brought to his attention the pressing issue of inadequate road infrastructure in the area. Responding positively, Pawan Kalyan assured the residents that necessary actions would be initiated promptly, directing officials to under-

Ghantasala, Krishna District: In a move aimed at providing lasting solutions to farmers' problems, State Agriculture Minister K. Atchanna Reddy launched the prestigious "Raitanna... During the programme, farmers were guided to download the AP AIMS app on their mobile phones, designed to facilitate easy access to government support schemes and farming resources.

Later, Atchanna Reddy participated in a farmers' meeting at the Kriishi Vigyan Kendra, organized by Avanigadda MLA Mandala Buddha Prasad, where detailed discussions were held on implementing the five-point framework at the grassroots level. The minister criticized former Chief Minister Y.S. Jagan Mohan Reddy for neglecting irrigation and agriculture sectors, accusing him of misleading the public with false claims. In contrast, he said, the current coalition government has been proactive in supporting farmers spending over Rs. 1,000 crore through MARKFED within six

months to assist those facing crop losses, compared to Rs. 900 crore spent by the previous regime in five years.

Special Focus on Effective Grievance Redressal: District In-charge Collector Suraj

Narasaraopet: Public grievances must be handled with greater responsibility and quality, said District In-charge Collector Suraj, emphasizing the need for efficient resolution of petitions under the Public Grievance Redressal System (PGRS) in Palnadu district. He participated in the public grievances programme held on Monday at the District Collectorate in Narasaraopet, the district headquarters. During the event, residents from various mandals across the district submitted a total of 122 petitions concerning different civic and administrative issues.

District Revenue Officer Murali, Revenue Divisional Officers (RDOS), and officials from various departments joined the Collector in receiving and reviewing the applications. Addressing the officials, Collector Suraj instructed that all PGRS petitions should be resolved with special attention and accountability. He directed district officers to complete the grievance audit with top priority and ensure prompt action on pending petitions.

Suraj further advised RDOs and department heads to personally verify at least one or two grievances during their field visits to assess the quality of grievance resolution and provide constructive feedback. He stressed the importance of surprise inspections, stating that previous reviews had revealed shortcomings in the quality of grievance redressal at the field level. To address this, he asked RDOs, tahsildars, MPDOs, and other ground-level officers to pay closer attention to each application and ensure that the grievances reaching their offices are resolved properly and promptly.

The Collector warned

that strict action would be taken against officers who fail to handle petitions efficiently or neglect their responsibilities. He emphasized that grievance redressal is primarily the responsibility of field officials and that maintaining quality and transparency is crucial to public trust. Suraj directed tahsildars and MPDOs to personally visit locations related to their assigned petitions instead of relying solely on reports. He also asked district officers to regularly communicate with their subordinates, instructing them to improve the quality of grievance handling. Additionally, petitions and references received from VIPs and public representatives must be cleared without delay, he said. The Collector noted that official correspondence sent through the office's postal system should be tracked daily and immediate action should be taken on pending matters. Officials from all major departments attended the event and assured their commitment to improving the effectiveness and credibility of the grievance redressal mechanism in the district.

AP has given rural families one last chance to secure a house under the joint Pradhan Mantri Awas Yojana

TPN Bureau | November 24, Amaravati: NTR Housing scheme, with the application and survey deadline set for November 30, 2025. Eligible poor families in villages, whether they currently own a small site or not, are being identified through a special mobile application to ensure that the neediest are prioritized for sanction. Scheme and deadline! This drive is part of the Pradhan Mantri Awas Yojana Gramin (PMAY-G), implemented in Andhra Pradesh through the State Housing Department and Andhra Pradesh State Housing Corporation Limited (APSHCL).

Rural families without a permanent house are being surveyed and registered so they can receive financial assistance for house construction. The state has extended the survey and application window up to November 30, 2025, giving roughly six more days for eligible families who have not yet enrolled to come forward through their village secretariats. Own site or government site under the rural housing programme in Andhra Pradesh, the government is following two models for poor beneficiaries. Families who already possess their own small plot in rural areas can get financial assistance to construct a house

on that site, while those who do not own land are to be allotted around 3 cents of government-provided house site in village areas for construction. Officials are simultaneously recording details of both categories those with sites and those without—to ensure landless poor are included along with small site owners.

Beneficiary identification via Awaas+

To make beneficiary selection transparent and systematic, the Centre has deployed the Awaas+ / AwaasPlus 2024 app for field-level data capture in PMAY-G. Engineering Assistants and Welfare or Housing Assistants attached to Grama and Ward Sachivalayams visit each household, record socio-economic details, and upload geo-tagged photos of the existing dwelling and the proposed house site into the app. Facial recognition and Aadhaar integration allow the system to auto-fetch Aadhaar details, while job card and other eligibility parameters are also captured, creating a verified digital profile for every applicant.

Focus on the poorest

The digital workflow has been designed so that the "poorest of the poor" and those without any liveable house get first preference in the sanction list.

AP GOVT COLLABS WITH CHAGANTI

VIJAYAWADA: "Bringing ethical values into society is a responsibility entrusted to us by Chief Minister Chandrababu Naidu," said State Education, IT and Electronics Minister Nara Lokesh at the State-level Education Conference on Moral Values held at Tummalapalli Kalakshetram in Vijayawada. He noted that renowned scholar Brahmasri Chaganti Koteshwara Rao has been appointed with Cabinet rank to guide this effort, describing it as a sacred responsibility.

Lokesh said that moral values, when integrated into education from an early age, shape responsible citizens just as clay becomes a pot and a stone transforms into a sculpture. He stressed that while scientific advancements like nuclear energy can cause destruction, they can also be used for constructive development—similarly, children must be guided towards the right path through value-based education.

Promoting Gender Respect and Equality

Highlighting the need to respect women and el-

ders, Lokesh recalled the discipline and values taught by his mother Bhuvaneshwari. He emphasized that degrading expressions commonly used in everyday Telugu conversations must be eliminated. He stated that films and web series must avoid content that insults women, and he has already discussed this with the Chief Minister and Deputy Chief Minister. After assuming charge as Education Minister, Lokesh reviewed school textbooks and noticed that illustrations of household chores showed only women. He immediately directed of

officials to revise them to reflect a 50-50 representation, adding images of men performing household tasks. Sharing his personal experience, he noted that during his studies in the U.S., he and his wife Brahmani shared household equally. "This is the change we want to see in society," he said. Combating Drug Abuse and Strengthening the Education System

Lokesh narrated a distressing incident from his padayatra where a mother sought help for her daughter who fell victim to drug abuse. He said that

such incidents moved the government to declare a war on drugs. Speaking about reforms, he said he accepted the challenging Education portfolio with determination. Despite setbacks like his 2019 electoral defeat, he worked hard and returned with a majority of 91,000 votes in 2024. Under his leadership, the government resolved long-standing teacher issues, introduced the Teacher Transfer Act, implemented "One Class - One Teacher" in 9,600 schools, and filled 16,347 teacher posts through the Mega DSC without any litigation.

A no-confidence motion has been formally initiated against Mayor of Nellore

Nellore: With 40 corporators accusing her and her husband of stalling development works and indulging in corruption. The move signals a serious political confrontation within the corporation and could eventually unseat the Mayor if the motion is carried in the council.

Notice to Joint Collector

On Monday, 40 corporators of the Nellore Municipal Corporation submitted a written no-confidence notice against Mayor Sravanti to Joint Collector M. Venkateswarlu. The corporators, cutting across factions, signed the notice and urged the district administration to convene a special council meeting to take up the motion as per municipal rules. The corporators also complained that regular municipal administration has been paralysed and that files are not being cleared without the intervention of the Mayor and her husband, creating administrative bottlenecks. They alleged that this situation has se-

verely slowed down basic civic works and key development projects in the city.

Allegations Against Mayor & Couple

In their complaint, the corporators alleged that the Mayor and her husband, Poturi Jayvardhan, have been creating hurdles at every stage of development works and using their influence to interfere in contract awards and file processing. They claimed that irregularities and corrupt practices by the couple have brought a bad name to the government and the municipal corporation. Corporators further contended that no important file moves in the corporation without the direct involvement of the Mayor's family, resulting in delays and alleged favouritism. Some leaders recalled earlier controversies, including a previous complaint by a former commissioner about alleged forgery involving town planning matters, as part of a pattern of misuse of power.

Complaint to Minister Narayana

Before serving the no-confidence notice, a

group of corporators met Municipal Administration and Urban Development Minister Dr. P. Narayana on Sunday and submitted a detailed representation on the alleged irregularities. They are learnt to have briefed the Minister on stalled works, interference in administrative matters and the political fallout of the Mayor's style of functioning. The corporators requested the Minister to intervene to restore normalcy in civic administration and to ensure that development works in Nellore city are expedited. Following this meeting, the corporators moved ahead with the formal no-confidence notice on Monday, escalating the issue into an open power struggle within the corporation.

Political Background and Shifting Equations In the municipal elections held about four years ago, the YSR Congress Party (YSRCP) had won all 54 divisions in the Nellore Municipal Corporation, securing complete control of the council. The Mayor's



for a Scheduled Tribe woman, went to Potluri Sravanti, who was then aligned with the YSRCP leadership but also known to be close to Nellore Rural leader Kotamreddy Sridhar Reddy. After the subsequent Assembly and Lok Sabha elections, in which the YSRCP suffered a severe setback in the district, dissatisfaction reportedly grew among corporators over the Mayor's "neutral" political posture.

Party leaders and corporators began accusing her of failing to provide clear political and administrative leadership for the city's development during a crucial transition period. Growing Tensions and Next Steps Political tensions around Mayor Sravanti have been simmering for the past few years, with earlier

flashpoints including disputes with YSRCP corporators and allegations that she was targeted for her loyalty to dissident leader Kotamreddy Sridhar Reddy. The latest no-confidence move has brought those underlying conflicts back into sharp focus and opened a new chapter in Nellore civic politics.

With the Telugu Desam Party-led alliance now controlling a majority of corporators in the council, the no-confidence motion is expected to be taken up in a specially convened meeting in the coming days. If passed by the required majority, it could result in the Mayor's removal from office and a complete reshaping of the power structure in the Nellore Municipal Corporation.

YS Jagan begins three-day Pulivendula tour from Nov 25

VIJAYAWADA : Former Chief Minister and YSRCP President YS Jagan Mohan Reddy will begin a three-day visit to Pulivendula from November 25. He will arrive in Pulivendula at 4 PM tomorrow, hold a public darbar at the Camp Office till 7 PM, and stay overnight.

On November 26 at 9 AM, he will attend a wedding at Vasavi Function Hall, proceed to

Brahmanapalli to inspect banana plantations and interact with farmers, return to Pulivendula to console the family of former Lingala sarpanch Mahesh Reddy, and later visit the residence of Lingala Ramalinga Reddy in Velpula.

He will again hold a public darbar at the Camp Office till 7 PM before halting for the night. On November 27 at 8 AM, YS Jagan will depart from Pulivendula, concluding his tour.



Rajahmundry Officer Defies Transfer Orders, Continues in RUDA Post Amid Corruption Row

Rajahmundry (East Godavari): A major administrative controversy has erupted in the Rajahmundry Urban Development Authority (RUDA), where an officer facing corruption allegations has reportedly defied both government and municipal transfer orders, continuing in a deputation post that was officially cancelled several months ago. According to official documents, the Municipal Administration & Urban Development (MA&UD) Department issued orders on June 9, 2025, through G.O.R.No.527, withdrawing the deputation of G.V.S.N. Murthy, who had been serving as Chief Urban Planner (CUP) in RUDA.

The government order clearly stated that his services were being returned to the parent organization, posting him as City Planner at the Rajahmundry Municipal Corporation. Following this directive, the Municipal Commissioner of Rajahmundry reinforced the govern-

ment's decision through an endorsement (Roc.No.2751/2023-C1, dated November 2025), instructing Murthy to immediately assume charge as City Planner. The Commissioner even issued a stern warning that continued defiance could invite disciplinary action. Despite these explicit instructions, the officer has not reported to his new post, continuing to function in RUDA for over five months. This unusual defiance has raised questions across administrative and political circles in Rajahmundry. Officials are openly asking how a government officer can disregard clear orders from both the MA&UD Department and the Commissioner without facing action.

Sources allege that the officer enjoys strong backing from a local legislator belonging to his community group, which may have emboldened him to ignore the directives. These allegations, though unconfirmed, have deepened suspicion in the wake of ongoing cor-

ruption complaints at RUDA. The RUDA office has been under public and media scrutiny for several months amid accusations of irregularities in town planning permissions, layout approvals, and commercial building clearances. The Chief Urban Planner's continued presence in the same post, despite official transfer orders, has fueled concerns of administrative compromise and potential misuse of authority.

City governance experts say this episode is particularly damaging as Rajahmundry prepares for the 2027 Godavari Pushkaralu, a major river festival requiring massive urban planning efforts. The City Planner's role is crucial for master plan updates, traffic management, development of temporary infrastructure, and construction of bathing ghats.

Any delay in assuming the assigned post could directly affect the city's preparedness for the event. Senior officials describe this as more than a routine

transfer issue it reflects a troubling mix of bureaucratic defiance and possible political interference.

Observers warn that ignoring the Commissioner's written orders not only undermines governance discipline but also sets a dangerous precedent for ad-

ministrative functioning in key urban institutions like RUDA.

MLA Somireddy Chandramohan Reddy launched a scathing attack on YSRCP chief Y. S. Cyclone fast approaching

A strengthening weather system over the South Andaman Sea and southeast Bay of Bengal is expected to evolve into a cyclonic storm in the next two days, bringing light to moderate rains to parts of south coastal Andhra Pradesh and Rayalaseema. Under its influence, districts such as Nellore, Prakasam, YSR Kadapa, Chittoor, Annamayya and Tirupati are likely to see intermittent showers and gusty winds as the system moves west-northwest and another low-pressure area develops near Sri Lanka and the Comorin region.

System intensifying over Bay of Bengal

Meteorological agencies report that a



well-marked low-pressure area persists over the Strait of Malacca and adjoining South Andaman Sea and is set to intensify into a depression over the southeast Bay of Bengal. Forecast models indicate further strengthening into a cyclonic storm as it tracks west-northwest over the Bay during the subsequent 48 hours, with the system likely to be named "Senyar" once it attains cyclonic intensity. At the same time, an upper-air circulation over the southwest Bay of Bengal and nearby seas is preparing the

ground for a second low-pressure area around November 25 near the Comorin region, southwest Bay and Sri Lanka.

Impact on Andhra Pradesh districts

Under the combined influence of the Bay of Bengal system and the northeast monsoon flow, southern parts of Andhra Pradesh are expected to experience spells of light to moderate rain and thunderstorms. The Andhra Pradesh State Disaster Management Authority and IMD regional centre have highlighted the

likelihood of showers over south coastal and Rayalaseema districts, particularly SPS Nellore, Prakasam, YSR Kadapa, Chittoor, Annamayya and Tirupati, over the next 24 hours. Localised heavy showers cannot be ruled out in some pockets, especially along the coastal belt and adjoining interior mandals, as the cloud bands expand inland.

Advisory for people and authorities

Authorities have urged fishermen to closely track official weather bulletins and

avoid venturing into the sea as winds over the southwest and southeast Bay of Bengal are expected to strengthen progressively with squally conditions. Residents in low-lying and vulnerable areas of the affected districts have been advised to stay alert for waterlogging, check local forecasts frequently, and follow instructions from district administrations and disaster management teams.

Medical Negligence and Systemic Lapses Haunt Government Hospitals in Andhra Pradesh

fell unconscious and later died during the night. Family members alleged that the doctors threatened them with legal action and post-mortem if they made the issue public.

Preliminary findings by the inquiry team confirmed negligence, leading to the suspension of the PG doctor. The CMO and DME are visiting the hospital for further investigation. In Rajamahendravaram GGH, another controversy erupted when a 55-year-old woman reportedly received expired Amlodipine 5 mg tablets.

However, a drug control inquiry revealed inconsistencies in the complaint. Officials found no stock of that batch after October, and hospital records showed no patient matching the described profile.

Despite showing a written note specifying drugs that caused her allergies, a post-graduate gynecologist reportedly administered a Pantoprazole injection against her objection. Within minutes, Malleswari

hendravaram GGH superintendent and some staff held a press conference claiming they had "done nothing wrong" and accusing the Chief Minister of commenting without context.

Their remarks, viewed as defiance of government authority, have raised concerns about institutional arrogance and a lack of accountability in the healthcare system. These two cases underscore deep-rooted problems—negligence toward patients' medical histories, improper documentation, threats to victims' families, and failure to uphold medical protocols.

They pointed out that irregularities in tenant farmer registration, delay in input subsidies, and lack of access to institutional

loans have left many farmers dependent on private moneylenders at high interest rates.

Aadhaar, Citizenship, and Voting Rights

SC Directive Sparks Legal and Political Debate



The Supreme Court's recent directive asking the Election Commission of India (ECI) to consider Aadhaar as a valid identity proof for voter enrolment in Bihar's Special Intensive Revision (SIR) has reignited a complex and sensitive debate over citizenship, voting rights, and national security.

While Aadhaar serves as proof of identity for accessing welfare schemes and services, it is not a conclusive document for establishing Indian citizenship. This legal distinction, upheld in the 2018

Puttaswamy judgment, lies at the heart of the controversy. The ECI had opposed the move, fearing it could allow illegal migrants—especially in border states—to gain access to the electoral rolls.

Under Article 326 of the Constitution, only Indian citizens can vote. With Aadhaar now being used to validate voter identity, critics argue that the gap between identity and citizenship is being dangerously blurred, particularly in sensitive states like Assam and West Bengal.

Assam's Long History of

Anxiety

Assam has long been wary of demographic shifts due to illegal immigration. Following the Assam Movement (1979–1985), amendments to the Citizenship Act in 1986 and 1992 made it harder to gain Indian citizenship by birth, shifting towards the principle of *jus sanguinis* (citizenship by blood).

Currently, several districts in Assam report Aadhaar holders exceeding projected population figures, prompting the state to halt Aadhaar issuance in those areas. This

has raised alarm over the misuse of Aadhaar by undocumented migrants.

West Bengal & Beyond
In West Bengal, over 2.43 lakh voter enrolment applications were recently rejected, mostly from border districts. Similar fears are growing in Arunachal Pradesh, Manipur, and Nagaland, highlighting the need for a coordinated regional response.

Legal Ambiguity & National Security

India's legal regime, split between the Citizenship Act (1955) and the Foreigners Act (1946), does not

clearly address undocumented citizens or infiltrators. Foreigner Tribunals in Assam attempt to adjudicate these cases, but their processes remain complex and inconsistent.

As the SIR process potentially scales nationwide, unresolved legal questions about Aadhaar's role, citizenship verification, and voting rights could deepen. The judiciary's directive, though well-intentioned, may require broader legal reform to protect the integrity of India's electoral and citizenship systems.

At the centre of this soft-power exchange is Che Guevara, the Argentine revolutionary who became a global leftist icon. Unlike Fidel Castro, Che's internationalism and tragic end made him a cult figure, particularly in Indian university towns like Calcutta in the 1960s. His image, idealism, and anti-capitalist rhetoric deeply influenced India's student Left.

Nonetheless, the symbolic solidarity continues to appeal to sections of India's academia and political Left—despite the region's limited real-world impact on Indian life. Whether this connection leads to fruitful collaboration or ideological quicksand remains to be seen.

Gold's Sharp Rally Triggers FOMO – But Should Investors Jump In?



The recent surge in gold prices has reignited a classic dilemma for Indian investors: Has the best opportunity already passed, or is now still a good time to buy?

With gold touching new highs, the fear of missing out (FOMO) is becoming palpable—especially in a country like India, where gold carries deep emotional and cultural value. However, financial experts are urging caution. History suggests that chasing gold during sharp rallies often leads to disappointment.

Gold is not typically a wealth-creation tool like equities. While it offers strong returns during crises, such as the 2008 financial meltdown or the 2020 COVID-19 shock, it also experiences long periods of stagnation. Between 2011 and 2018, for instance, gold returned a mere 2.5% annually, significantly underperforming the stock

market.

Global Drivers at Play

Gold's price is influenced by global uncertainties, central bank actions, and interest rate movements. As US interest rates drop, the opportunity cost of holding gold decreases, pushing investors toward the metal. With rising geopolitical tensions and a potential economic slowdown looming, many central banks are increasing their gold reserves, reducing reliance on the US dollar.

However, gold's upward momentum is easily reversed. A strengthening dollar, rising bond yields, or easing geopolitical tensions can all deflate gold's appeal. In India, rising prices also dampen jewellery demand, causing consumers to shift toward alternatives like silver or platinum.

Indian Investors and Portfolio Allocation

Over the past 25 years, Indian investors have enjoyed annualised gold returns of 12–13%, aided by a weakening rupee. Still, this historical performance shouldn't be mistaken for a guarantee of future gains. Financial planners caution against treating gold as a primary engine of growth.

The key is disciplined asset allocation. Experts recommend maintaining a gold allocation of 5–15% in one's investment portfolio. This helps hedge against volatility without overexposing to an unpredictable asset.

In conclusion, gold is best viewed as insurance in an investment plan—a stabiliser, not a star performer. While FOMO is understandable amid surging prices, smart investors know that discipline and diversification, not emotion, deliver long-term financial success.

Flood-Hit Punjab Feels Ignored, Old Wounds Reopen Amid Rising Alienation



As Punjab grapples with one of its worst flood disasters in decades, simmering discontent is boiling over into a deeper sense of alienation. Despite the Centre promising support, the absence of Prime Minister Narendra Modi from the state has struck a nerve among many Punjabis—particularly within the Sikh community—who feel abandoned in their hour of crisis.

While PM Modi tweeted condolences for the Afghanistan earthquake upon returning from Tianjin on September 1, his silence on Punjab's floods sparked backlash. Giani Harpreet Singh, former Akal Takht head priest and now a

rising religious-political voice, publicly rebuked the Prime Minister. "Punjab is also part of this country," he wrote, questioning Modi's priorities in a pointed social media post followed by a formal letter.

Though the Prime Minister reportedly spoke to Punjab Chief Minister Bhagwant Mann and promised help, for many affected families across 1,500 villages and 3 lakh displaced people, this fell short of expectations. Union Minister Shivraj Singh Chouhan did visit flood-hit areas, wading through water, but Modi's absence is being perceived as political distancing.

The alienation, observers

note, is rooted in the unresolved trauma of the farm laws movement, where Sikh farmers were at the forefront of the year-long protest against the Centre. That movement fractured already tenuous bonds between New Delhi and Punjab, and today's silence only reinforces old suspicions.

Politically, the BJP's relationship with Punjab has remained complicated. Once a junior partner to the Shiromani Akali Dal, it now contests alone, tripling its vote share in 2024 but winning no seats. Analysts suggest the party may be eyeing a long game—banking on a fragmented Sikh vote

and Hindu consolidation.

However, this gamble is risky. The rise of radical voices like Amritpal Singh's faction, growing online propaganda linking Sikh grievances with broader separatist narratives, and the vacuum in traditional Sikh politics are creating fertile ground for unrest—and for external actors like Pakistan's ISI to exploit.

History reminds us that neglect during crisis breeds discontent. Punjab's flood tragedy, if not met with empathy and urgency, could deepen a dangerous divide. The moment calls not just for aid—but presence, understanding, and political foresight.

PM Modi Holds Bilateral Talks With Japanese PM at G20 Summit

Prime Minister Narendra Modi on Sunday held bilateral talks with Japanese Prime Minister Sanae Takaichi on the sidelines of the G20 Summit, discussing ways to strengthen India-Japan cooperation across multiple sectors.

"Had a productive meeting with Prime Minister Sanae Takaichi of Japan. We discussed ways to add momentum to bilateral cooperation in areas such as innovation, defence, talent mobility and more," PM Modi posted on social media. The leaders also explored measures to enhance trade ties, emphasizing that a strong India-Japan partnership is vital for global progress.

According to the Ministry of External Affairs, both leaders reaffirmed the India-Japan Special Strategic and Global Partnership, grounded in civilizational connect, shared values, mutual goodwill, and commitment to a free and open Indo-Pacific. They highlighted the need to deepen bilateral ties to promote regional and global peace, prosperity, and stability.

The discussions built on the 15th India-Japan An-

nual Summit, focusing on expeditious implementation of agreements across defense and security, trade and investment, SMEs, artificial intelligence, critical minerals, semiconductors, infrastructure, technology, and people-to-people exchanges. They also explored strategic sector collaborations and exchanged views on regional and global issues.

PM Takaichi expressed strong support for the AI Summit to be hosted by India in February 2026. This was the first meeting between the two leaders since she assumed office in October.

The talks followed PM Modi's visit to Japan in August, during which India and Japan finalized 13 key agreements and declarations, launched transformative initiatives, and adopted the India-Japan Joint Vision for the Next Decade. Building on progress toward the 2022-2026 target of JPY 5 trillion in Japanese investments in India, a new goal of JPY 10 trillion (USD 68 billion) in private investment has been set. The vision emphasizes strategic alignment in clean energy, emerging technologies, and infrastructure development.



Justice Surya Kant Sworn in as 53rd Chief Justice of India

Justice Surya Kant, the senior-most judge of the Supreme Court, was sworn in as the 53rd Chief Justice of India (CJI) on Monday. President Droupadi Murmu administered the oath of office at a brief ceremony at Rashtrapati Bhavan at 10 am.

Justice Kant succeeds Justice BR Gavai, who retired on November 23 after serving just over six months. Justice Gavai had recommended Justice Kant's name as his successor on October 27, and the President appointed him on October 30. Elevated to the Supreme Court on May 24, 2019, Justice Kant will serve as CJI for nearly 15 months, retiring on February 9, 2027.

The swearing-in ceremony was attended by Vice President CP Radhakrishnan, Prime Minister Narendra Modi, Lok Sabha Speaker Om Birla, Defence Minister Rajnath Singh, Home Minister Amit Shah, several Union ministers, Haryana Chief Minister Nayab Singh Saini, outgoing CJI Gavai, former Vice President



Jagdeep Dhankhar, and judges from the Supreme Court and High Courts. Chief justices and judges from countries including Nepal, Bhutan, Sri Lanka, Mauritius, Malaysia, Brazil, and Kenya were also present.

Justice Kant outlined his priorities as CJI, focusing on reducing the massive pendency of cas-

es in the Supreme Court, which currently stands at around 90,000. He emphasized the importance of mediation as an alternative dispute resolution mechanism and highlighted plans to set up Constitution Benches to dispose of key constitutional matters, which could help clear hundreds of cases in high courts.

Born on February 10, 1962, in Hisar, Haryana, Justice Kant graduated in law from Maharishi Dayanand University, Rohtak, and earned his Master's degree in law from Kurukshetra University, standing first in his class. He became the youngest Advocate General of Haryana in 2000, was appointed judge of the Punjab and

Haryana High Court in 2004, and served as Chief Justice of Himachal Pradesh High Court in 2018 before elevation to the Supreme Court.

Justice Kant brings over two decades of judicial experience, with landmark judgments on Article 370, free speech, corruption, environment, and gender equality.

Delhi HC Seeks Response on Christian Michel's Extradition Challenge

The Delhi High Court on Monday sought responses from the Centre, the CBI, and the Enforcement Directorate (ED) on a plea filed by British national Christian Michel James, accused in the ₹3,600-crore AgustaWestland VVIP chopper scam, challenging a provision

of the India-UAE extradition treaty.

A bench comprising Justices Vivek Chaudhary and Manoj Jain directed the Home Ministry, the Ministry of External Affairs, the CBI, and the ED to submit their objections regarding the maintainability of Michel's petition. The

court's notice marks the next step in a legal battle that has spanned several years.

Michel's lawyer highlighted that the accused will complete seven years in Indian custody on December 4, 2025, and has not been granted release even once during this period. The plea contends

that certain provisions of the extradition treaty are arbitrary and seek relief from continued detention, raising questions about procedural safeguards and legal rights under the treaty framework.

The court will review submissions from the government and investigative agencies before deciding on the maintainability of Michel's petition and the next course of action, which could include hearings on his release or modifications to his detention conditions.

15 Arrested For Using Pepper Spray On Delhi Cops During Air Pollution Protest

'Madvi Hidma Amar Rahe' Slogans Raised

Fifteen individuals were arrested during a protest against rising air pollution in the Delhi-NCR region, after allegedly using pepper spray on police officers, officials said on Monday. The detentions followed Sunday's demonstration at the C-hexagon, where protesters reportedly refused repeated warnings to disperse.

The arrested were taken to the Parliament Street Police Station for medical examination. Delhi Police confirmed an FIR has been registered under multiple sections, including obstruction of government work. Some of the protesters were apprehended near India Gate, while others were detained outside the police station.

Authorities said the pepper spray caused irritation to three to

four officers, who were treated at a hospital.

Officials explained that several demonstrators attempted to cross barricades meant to regulate traffic and allow ambulance movement.

When asked to step back, the protesters allegedly became agitated, sat on the road, and disrupted traffic, forcing police intervention to restore order.

This is the latest in a series of "clean air protests" in the capital. Earlier, on November 9, demonstrators were detained at India Gate demanding stricter government action to address the "air emergency" in Delhi.

Meanwhile, Delhi and neighbouring NCR cities are facing severe air quality issues. Current AQI readings include Gurugram at 370, Noida at 372, Faridabad 358, and Ghaziabad 355, with

several areas in Delhi breaching 400, entering the 'severe' category. Low wind speeds are expected to worsen conditions.

In response, the Commission for Air Quality Management (CAQW) has revised the Graded Response Action Plan, enforcing measures previously meant for Stage IV under Stage III. These include uninterrupted power supply to curb diesel generator use, deployment of additional traffic personnel, alerts via media, and expanded CNG and electric public transport with differential fares.

The Delhi government has directed private offices to operate with 50% on-site staff and allow the rest to work from home, as authorities continue to urge caution amid hazardous air quality.

Indian Navy Commissions Indigenous ASW Vessel INS Mahe

The Indian Navy on Monday commissioned INS Mahe, the first of the Mahe-class anti-submarine warfare (ASW) shallow water crafts, at the Naval Dockyard in Mumbai. The vessel is designed to hunt submarines, conduct coastal patrols, and secure India's vital maritime deal.

Legal experts said the High Court's examination of the extradition treaty provisions could have broader implications, including the interpretation of bilateral agreements and the procedural rights of foreign nationals facing long-term detention in India.

and agile shallow-water combatants. The vessel is equipped with advanced sonar systems, torpedoes, and other anti-submarine warfare weaponry, enabling it to detect and neutralize underwater threats efficiently. Its design also allows for rapid deployment along India's extensive coastline, safeguarding strategic maritime routes.

The ship is expected to play a crucial role in coastal security, surveillance, and intelligence gathering, complementing larger fleet units in safeguarding India's maritime interests. Indian Navy officials emphasized that the induction of INS Mahe strengthens the country's self-reliance in defense manufacturing while significantly boosting anti-subma-

rine capabilities in the shallow water environment.

The Mahe-class vessel is part of a broader program aimed at modernizing the Indian Navy with indigenous, state-of-the-art platforms capable of operating in diverse maritime conditions. Its commissioning aligns with the government's "Make in India" initiative, reflecting India's growing emphasis on homegrown defense technology and strategic maritime preparedness.

With INS Mahe joining the fleet, the Indian Navy now possesses enhanced capability to monitor and counter potential underwater threats, ensuring the security of India's coastline and safeguarding the nation's strategic maritime interests.

Bangladesh Seeks Extradition of Sheikh Hasina from India

The interim government of Bangladesh has formally requested the extradition of former Prime Minister Sheikh Hasina from India, following her death sentence by the International Crimes Tribunal in Dhaka. The letter was sent to the Indian Ministry of External Affairs, and Bangladeshi authorities are currently awaiting a response, according to Foreign Affairs Adviser Touhid Hossein.

Sheikh Hasina, who fled Bangladesh on August 5, 2024, amid widespread protests against her government, has been living in India since her departure. Prior to her flight, the tribunal had declared her a fugitive, and she now faces multiple charges, including alleged involvement in the enforced disappearance of political activists and critics during her 16-year tenure as Prime Minister.

Mr. Hossein stated that the extradition request follows the tribunal's latest verdict and comes at a time when the court continues to hear cases related to Hasina's alleged role in suppressing dissent and human rights violations. "The interim government is committed to ensuring ac-

countability for crimes committed during the previous administration," he added.

The request underscores the growing diplomatic and legal tensions between Dhaka and New Delhi, as India has historically provided refuge to political figures facing turmoil in neighbouring countries. Legal experts suggest that extradition could become a complex process, requiring careful consideration of international law, bilateral treaties, and humanitarian concerns.

Observers note that this development will test India's diplomatic balancing act between respecting Bangladesh's judicial process and safeguarding individuals residing within its territory. Meanwhile, Bangladesh has reiterated its commitment to upholding the tribunal's decisions and pursuing all legal avenues to ensure that Hasina faces trial for alleged crimes committed during her administration.

The situation continues to evolve, with both countries expected to engage in diplomatic consultations in the coming weeks over the handling of the extradition request.

South Africa Passes G20 Baton to U.S. Amid Debt Concerns

South Africa has formally handed over the G20 presidency to the United States, concluding a year in which it pushed to highlight debt sustainability challenges facing developing nations. The transition marks the end of a four-nation leadership stretch by emerging economies, including Indonesia, India, Brazil, and South Africa, which collectively focused on elevating the Global South's priorities on the global stage.

Speaking on the handover, Finance Minister Enoch Godongwana emphasised that South Africa aimed to institutionalise debt relief mechanisms and push forward recommendations agreed upon by the G20 over the past year. "Debt sustainability remains a critical issue for emerging economies and low-income countries," he said, noting that global debt across developing nations has now surpassed \$100 trillion.

The G20's debt agenda under South Africa's leadership sought to strengthen coordinated approaches to sovereign debt restructuring, promote financing for development, and prevent debt crises from escalating in vulnerable economies. Analysts

have described these efforts as an important step in bridging inequalities between the Global South and advanced economies.

However, the shift to a U.S.-led presidency raises questions about whether the momentum on debt relief will be maintained. Historically, priorities under advanced-economy leadership have leaned toward global financial stability and regulatory issues, while debt relief and development finance have received comparatively less focus.

Observers note that the United States will face pressure to translate G20 ambitions into concrete action, especially as economic stress in poorer nations threatens to intensify. Emerging economies have warned that rising debt levels, coupled with inflationary pressures and slower global growth, could trigger new crises without robust international coordination.

As the G20 prepares for its next summit, all eyes will be on Washington to see whether the commitments and frameworks developed under South Africa's leadership will be sustained, ensuring that debt relief remains a priority for the world's most vulnerable countries.

Trump's Evolving Rhetoric on Zelenskyy and Putin

President Donald Trump's rhetoric toward Ukrainian President Volodymyr Zelenskyy and Russian President Vladimir Putin has shifted dramatically over the first 10 months of his second term, reflecting changing dynamics in the Russia-Ukraine conflict.

During his 2024 campaign, Trump repeatedly claimed he could end the war "in 24 hours" if re-elected. Initially conciliatory toward Putin, whom he has long admired, Trump over time expressed growing frustration with the Russian leader. Conversely, after a February Oval Office confrontation, Trump softened his criticism of Zelenskyy, though tensions remained evident.

In recent months, Trump endorsed a peace plan seen by some as favorable to Russia. Democratic



senators criticized it as a "wish list" from Moscow, while Secretary of State Marco Rubio insisted it was drafted by the U.S. Allies in Eu-

rope expressed concern the plan could be overly lenient toward Russia.

Trump has alternated between criticizing

and praising both leaders. At times, he slammed Zelenskyy for allegedly failing to show sufficient gratitude for U.S. military support, recalling the Oval Office spat with Vice President JD Vance that temporarily paused aid to Ukraine. He also rebuked Euro-

pean nations for not applying more economic pressure on Russia.

At the same time, Trump has occasionally defended Putin, expressing trust that the Russian leader would honor potential peace commitments. After Russian attacks on Kyiv, Trump publicly condemned the strikes, highlighting the human toll, while signaling his continued willingness to negotiate directly with both leaders.

Trump's fluctuating tone—ranging from admiration and trust toward Putin to occasional harsh criticism of Zelenskyy—illustrates the complex balancing act of U.S. diplomacy. Analysts note that his statements have had significant domestic and international repercussions, influencing both bipartisan support for Ukraine and the broader trajectory of U.S.-Russia relations.

"Arunachal In China": Indian Woman's Post On Shanghai Airport Harassment

A woman from Arunachal Pradesh, India, was detained and harassed by Chinese authorities at Shanghai Pudong Airport after officials refused to recognise her Indian passport during a transit stop on November 21. Pema Wang Thongdok, who was traveling from London to Japan, said in posts on X that she was held for over 18 hours because immigration officers claimed her birthplace, Arunachal Pradesh, is Chinese territory.

Thongdok stated that officials repeatedly told her that her Indian passport was invalid, confiscated it, and prevented her from boarding her onward flight, despite having a valid Japanese visa. She was also denied access to food, airport facilities, and updates on her status. Officers reportedly mocked her and suggested she should "ap-



ply for a Chinese passport."

To resume her journey, Thongdok had to purchase a new ticket exclusively on China Eastern Airlines, resulting in financial losses from missed

flights and hotel bookings. Confined to the airport transit area, she was eventually able to leave after contacting the Indian Consulate in Shanghai, with consular intervention.

Calling the incident a "direct insult to India's sovereignty," Thongdok appealed to Prime Minister Narendra Modi and Indian authorities to raise the issue with Beijing, seek accountability and compensation, and ensure the protection of all Indian citizens from Arunachal Pradesh while traveling abroad.

The episode has sparked strong reactions in diplomatic circles and among Indian citizens, highlighting the sensitive territorial dispute between India and China. Beijing claims Arunachal Pradesh as part of "Zangnan" or southern Tibet, a position consistently rejected by New Delhi.

India has maintained that Arunachal Pradesh is an integral part of the country. In May, the Ministry of External Affairs criticized China's attempts to rename 27 locations in the state, calling them "vain and preposterous" and reaffirming that naming changes cannot alter the reality that Arunachal Pradesh "was, is, and will always remain" part of India.

The incident underscores the challenges faced by citizens of Arunachal Pradesh amid ongoing India-China tensions and the importance of consular support for Indians abroad.

TTAP Launches Three-Day Drive Against 27th Amendment



The opposition alliance Tehreek Tahafuz Ayeen-i-Pakistan (TTAP) has announced a three-day public mobilisation campaign in early December to intensify its resistance to the proposed 27th Constitutional Amendment. The movement will begin in Kamo-

Shaheed, Ghotki, and conclude in Karachi, according to a report by Dawn.

The decision was finalised during a crucial meeting of TTAP's Sindh chapter, chaired by Syed Zain Shah and attended by senior representatives from PTI, Majlis Wahdat-i-Muslimeen, Sindh United

Party, PkMAP, and other coalition partners. The session reviewed the ongoing political and constitutional situation in Pakistan and approved several organisational measures to strengthen the alliance's outreach.

A statement released after the meeting noted that the TTAP leader-

ship had mapped out the route for the mobilisation, which will pass through multiple towns before reaching Karachi.

The participants also commended the people of Sindh for marking Black Day on November 21, and praised the legal fraternity for its continued opposition to the amendment.

Speaking to the media, Zain Shah highlighted growing public frustration over unemployment, inflation, and economic instability. He asserted that the 27th Amendment "undermines constitutional supremacy and the rule of law." Shah also criticised the Sindh

government for imposing Section 144 shortly after TTAP announced a rally in Hyderabad, calling it proof that the ruling PPP had "lost its popular support."

He warned that attempts to suppress dissent or impose government through "fabricated mandates" would no longer be tolerated.

PTI leader Haleem Adil Sheikh echoed these concerns, alleging that the amendment "strips the judiciary of its independence." He stressed that only a strong, people-powered movement could counter what he described as a system built on a "stolen mandate," while condemning the government for introducing "anti-people" changes and keeping PTI founder Imran Khan in "unjust imprisonment."

The TTAP expects significant public participation in its December mobilisation as it continues its campaign against the proposed constitutional reforms.

India's Exports Fall for First Time in 14 Months: CRISIL

India's merchandise exports recorded a decline in October 2025, marking the first drop in 14 months, according to a report by CRISIL. Exports fell 11.8% year-on-year to \$34.38 billion, reversing the growth trend seen since August 2024.

The slowdown was broad-based, affecting key sectors such as petroleum products, gems and jewellery, and other core industrial segments. CRISIL attributed the decline to subdued global demand and lingering supply-side constraints that affected production and shipment timelines.

Petroleum exports, which have historically contributed significantly to India's merchandise trade, saw a marked reduction amid fluctuating crude prices and weaker overseas demand. Gems and jewellery, another major export segment, also experienced a drop due to subdued international



al consumption and ongoing market volatility.

Chemicals, and textiles, witnessed slower growth, reflecting challenges in the global

trade environment. Analysts noted that while domestic production remains strong, external

factors such as weakening global demand, inflationary pressures in importing countries,

and currency fluctuations have impacted export performance.

Despite the decline, CRISIL emphasized that the long-term fundamentals of India's export sector remain intact, supported by ongoing diversification of export markets and the government's focus on promoting value-added manufacturing. Efforts to enhance competitiveness in sectors like electronics, pharmaceuticals, and engineering goods are expected to gradually offset the near-term challenges.

The report suggests that while October's numbers indicate a temporary setback, policy measures to incentivize exports and strengthen supply chains could help stabilize growth in the coming months. Experts anticipate a cautious rebound if global demand improves and domestic industries maintain production efficiency.

Stock Markets Rebound on IT Rally, Strong Global Trends



Benchmark indices Sensex and Nifty rebounded in early trade on Monday, November 24, 2025, led by gains in IT stocks and supportive global market trends.

The 30-share Bombay Stock Exchange (BSE) Sensex

climbed 218.44 points to 85,450.36, while the 50-share National Stock Exchange (NSE) Nifty rose 69.4 points to 26,137.55 in early trading. Market analysts attributed the recovery to optimism in the technology sector and

newed investor confidence in IT and banking stocks. Broader sectoral movements indicated firm buying in financial services, automobile, and engineering stocks.

Global trends also supported the rally, with major indi-


ces in the US and Europe recording gains overnight amid easing concerns over interest rates and encouraging corporate earnings. Analysts said that the positive global cues helped offset domestic market uncertainties, prompting early buying interest among investors.

Market participants are closely watching macroeconomic data, corporate results, and global developments to gauge the sustainability of the rebound. Short-term trading activity is likely to remain volatile, with investors cautiously optimistic about further upside potential in select sectors.

Overall, Monday's early session indicated a positive start for Indian equities, fueled by IT sector momentum and firm global cues, suggesting that investors are regaining confidence after recent bouts of market consolidation.

Government to Propose 100% FDI in Insurance Sector: Sitharaman



The government is set to introduce a Bill in the upcoming Winter Session of Parliament to raise foreign direct in-

vestment (FDI) in the insurance sector to 100%, officials said on Friday. The session is scheduled to begin on December 1

and run until December 19, spanning 15 working days.

The proposed legisla-

broader effort to modernize India's insurance regulatory framework. As part of the exercise, the Life Insurance Cor-

poration Act, 1956, the Insurance Regulatory and Development Authority Act, 1999, and the Insurance Act, 1938, are expected to be amended to facilitate full foreign ownership in the sector.

Union Finance Minister Nirmala Sitharaman highlighted that allowing 100% FDI is aimed at attracting greater foreign capital, enhancing technology adoption, and expanding product offerings in the insurance industry. She emphasized that this step would boost competitiveness, improve customer service, and strengthen India's insurance market in line with global best practices.

Currently, foreign investors can hold up to 74% stake in insurance companies, subject to regulatory approvals. The proposed hike to 100% would make India one of the few major

economies with full foreign participation allowed in its insurance market.

Industry analysts said the move is likely to attract global insurers seeking a foothold in one of the world's fastest-growing insurance markets. Increased FDI could also support the government's broader objectives of financial inclusion and deepening penetration of life and non-life insurance products across urban and rural India.

The Winter Session is expected to see detailed debates on the Bill, with both opposition and ruling parties discussing regulatory safeguards, consumer protection, and the potential impact on domestic insurers. If passed, the amendments would mark a historic milestone for India's insurance sector, paving the way for enhanced foreign collaboration and investment.

fiscal year. The government's 2025-26 Budget raised the income tax rebate to ₹12 lakh from ₹7 lakh, providing around ₹1 lakh crore in relief to the middle class.

The Reserve Bank of India (RBI) had cut key policy rates by 50 basis points in June, bringing the repo rate to a three-year low of 5.5%. Additionally, GST rates on approximately 375 items were reduced from September 22, making essential consumer goods more affordable.

S&P noted that the spike in effective US tariffs on Indian products is weighing on export-oriented manufacturing, though signs suggest potential tariff reductions in the future. The agency added that current US trade policies are diverting time and resources toward negotiating exemptions, which could impact productivity gains.

The RBI has projected India's GDP growth for FY26 at 6.8%, slightly above S&P's estimate, reflecting strong domestic consumption and resilient economic fundamentals.

SEBI to Review Mutual Fund, Broker Rules on Dec 17



The Securities and Exchange Board of India (SEBI) plans to undertake a comprehensive review of its mutual fund and stock broker regulations at its upcoming board meeting, officials said on Friday. The meeting is scheduled for December 17, 2025, and will discuss proposed reforms aimed at making regulatory frameworks more relevant, transparent, and efficient.

In October, SEBI had issued a consultation paper proposing an overhaul of mutual fund rules. Key recommendations included a clearer definition of the Total Expense Ratio (TER), revised limits on brokerage charges, and enhanced disclosure requirements for investors. The regulator had sought public feedback on these proposals to ensure that the new framework aligns with evolving market practices and investor interests.


The board will also examine changes to stock broker regulations, focusing on improving risk management, operational efficiency, and investor protection. This initiative comes amid growing market complexities, rising trading volumes, and increased participation of retail investors in equities and

mutual funds. SEBI officials emphasized that the review aims to simplify existing rules, address ambiguities, and strengthen governance practices within the mutual fund and brokerage sectors. Analysts said the proposed reforms could enhance transparency, lower costs for investors, and make mutual funds a more attractive investment avenue.

Market participants are closely watching the developments, as any changes in TER norms, brokerage limits, and compliance requirements could significantly impact fund houses and stock brokers. Investor advocacy groups have welcomed SEBI's review, noting that a modernized regulatory framework could boost confidence in India's capital markets and promote long-term sustainable growth.

The board meeting on December 17 is expected to provide clarity on the timeline for implementing these reforms and finalizing the regulatory amendments. SEBI's move reflects its ongoing commitment to safeguard investor interests while fostering a dynamic and resilient capital market ecosystem..

iOS 26.1 Lets Users Tone Down Liquid Glass Effect



Apple's iOS 26.1 update brings a new option to adjust the controversial Liquid Glass effect, which debuted in iOS 26 last September. The Liquid Glass effect adds a high-translucency, glass-like finish across iPhone interfaces. While visually striking, many users found it distracting and inconsistent across different wallpapers. iOS 26.1 addresses these concerns by allowing users to reduce transparency and gloss with the Tinted option, making menus and app backgrounds easier to read.

To adjust the Liquid Glass effect, users should first ensure their device is updated to iOS 26.1. Then, navigate to Settings > Display & Brightness > Liquid Glass. Selecting Clear preserves the original glossy look, while Tinted tones down the effect, giving the interface a more opaque and neutral appearance.

This makes text and icons clearer, improving usability without losing the modern aesthetic.

The update is available for iPhone 11 and newer models, including the second-generation iPhone SE. While the change may seem minor, it reflects Apple's willingness to respond to user feedback, a shift from the company's typically cautious approach to design changes.

iOS 26.1 also includes several security fixes and other enhancements, but the Liquid Glass toggle has emerged as the most talked-about feature. For users who struggled with the overly reflective interface, the update offers a simple solution to restore readability while maintaining the stylistic appeal of Apple's bold visual choices.

With the Tinted setting, Apple balances visual innovation and practical usability, allowing users to enjoy a modern interface without compromising on clarity—a move likely to win over critics of the original design.



WhatsApp May Soon Let Users Call Others via Username

WhatsApp is reportedly developing a new feature that will allow users to call or message others using usernames, eliminating the need to exchange phone numbers. This functionality, spotted in recent beta releases for iOS and Android by feature tracker WABetaInfo, could significantly simplify connecting with new contacts while maintaining privacy.

The feature will let users search for a person's username in the Calls tab. If a match is found, users can tap on voice call or video call buttons to initiate a conversation. Depending on privacy settings, the caller may also see the person's profile photo before connecting. While the feature is still in development, it promises to offer a more streamlined way of communication, similar to Signal's existing username-based calls.

To prevent misuse



by spammers or scammers, WhatsApp plans to introduce a "username key" system. Unknown users attempting to place a call would need to enter the correct username key to connect. This feature is expected to be optional

but could play a crucial role in enhancing security while enabling easier communication.

Apart from username-based calls, WhatsApp is actively testing several other features. These include cover photos for chats, in-chat storage

management, media and sticker filters, message limits for new chats, and a channel quiz feature. Users may also soon be able to reply and react to messages from Apple Watch and secure chat backups with passkey encryption.

No official timeline

has been shared regarding the rollout of these features. They are expected to first appear on the beta channel, where WhatsApp will test them before making them available to all users. Once released, these updates could mark a significant shift in

how WhatsApp handles privacy, contact discovery, and user interaction.

This development indicates WhatsApp's growing focus on enhancing usability while balancing security and privacy for its over 2 billion global users.

comeback win over Leeds, thanks to a brilliant brace by Morgan Rogers, lifting Villa to fourth place, while Leeds slipped into the relegation zone after a fifth loss in six games.

Bandini (1963) and later achieved superstardom with the blockbuster Phool Aur Patthar (1966). His portrayal of Veeru in the 1975 clas-


sic Sholay remains etched in the history of Indian cinema, with the iconic friendship anthem "Yeh Dosti Hum Nahi Todenge"

Directed by Ugandhar Muni, the film has opted out of the Dasara competition and instead locked a strategic Christmas release date—25 December 2025. The makers aim to capitalise on the extended holiday season and ensure a wider reach without box-office crowding.

Well ahead of its theatrical debut, Shambhala has closed several major business deals, placing the project in a strong financial position. According to industry buzz, Aha has acquired the OTT streaming rights, marking a significant early win for the film. Additionally, reports suggest that the satellite rights for the Telugu version have been picked up by the Zee network. Though an official announcement from the team is awaited, trade circles confidently indicate the same.

Selling digital and satellite rights in advance has provided the producers with a solid safety net. Even if theatrical performance varies, these early deals ensure that the makers recover a substantial part of the investment. Should the film perform strongly at the box office, the pre-release revenue will only add to its overall commercial success, giving the team a comfortable advantage.

Content-wise, Shambhala promises a refreshing departure from conventional thrillers. Set in the early 1980s, the film blends mystery, horror, and a period backdrop to deliver a distinctive cinematic mood. The vintage atmospherics, combined with supernatural elements, aim to draw in audiences seeking a unique and gripping experience.

With a calculated release strategy, promising genre mix, and already secured business deals, Shambhala is shaping up to be more than just another thriller. The combination of content strength and smart distribution planning suggests that the film may emerge as a noteworthy holiday release this December.
