

## Top Naxal Commander Madvi Hidma Among 6 Maoists Killed in AP Encounter

Top Naxal commander Madvi Hidma, along with his wife and four other Maoists, was killed in a significant encounter with security personnel in the Maredumilli mandal of Alluri Sitamaraju district, Andhra Pradesh, on Tuesday morning. The encounter took place between 6:30 AM and 7:00 AM in the forested area. Police confirmed that a total of six Maoists were neutralized—four men and two women. Those killed were identified as Madvi Hidma, his wife Madakam Raje, Deva, Lakmal (Chaitu), Malla (Mallalu), and Kamlu (Kamlesh). The death of Hidma, the alleged mastermind behind several major attacks over the last two decades, was hailed by the Chhattisgarh police as the "last nail in the coffin" of the insurgency. Hidma, a native of Puvarti



village in Chhattisgarh's Sukma district, headed the Maoists' strongest military formation, the People's Liberation Guerrilla Army (PLGA) Battalion No. 1, which operates in the Dandakaranya region spanning parts of Andhra Pradesh, Odisha, Telangana, and Maharashtra. Andhra Pradesh Intelligence AD GP Mahesh Chandra Ladda confirmed the exchange of fire, stating that intelligence had indicated increased Maoist movement along the AP-Chhattisgarh-Odisha border and plans by top leaders to enter the state to revive the movement due to pressure in Chhattisgarh. Following the operation, police seized two AK 47 rifles, one pistol, one revolver, detonators, and other essential equipment. Combing operations are ongoing in the surrounding areas. The police operation was a joint effort, and simultaneously, monitoring in districts like NTR, Krishna, Kakinada, and Eluru led to the arrest of 31 more members of the proscribed organization, including nine security guards of central committee member Devi.

### 15 Maoists Arrested in Eluru Following Encounter Clues

Police have reportedly arrested 15 Maoists in Eluru as part of intensified combing and search operations across Andhra Pradesh, triggered by key evidence collected following the encounter that resulted in the death of top Maoist leader Hidma. Under the supervision of Eluru District SP Pratap Siva Kishore, Special Party police arrested the individuals from a house within a gated community in Green City, on the outskirts of Eluru. The arrested persons, believed to be from Odisha, were reportedly taking shelter in the building for the past week. They have been transported to the Eluru Rural Police Station for questioning. The police are currently interrogating the suspects to determine the duration of their stay in Eluru, their reasons for choosing the area as a shelter zone, and the extent of the Maoist sympathizer network within the Eluru district limits. Information is also being collected from the owner of the building where they were found. This operation is part of a wider statewide crackdown: police also took 32 individuals into custody in Vijayawada and two in Kakinada on the same day.

## CM Revanth Reddy Seeks Central Aid for Hyderabad's \$3 Trillion Economic Vision

Chief Minister Revanth Reddy strongly pitched for accelerated economic growth in Telangana by actively seeking the Union Government's assistance for several "game-changing" infrastructure projects. Participating in the Regional Meeting of Urban Development Ministers from the South West States, chaired by Union Minister of Housing and Urban Development Mahesh Lal Khattar in Hyderabad, the Chief Minister outlined the State's vision to develop Hyderabad into a premier global city. He stressed that many critical development projects are currently pending Central approval, and he requested Minister Khattar to grant immediate permissions and extend full support to works including the Metro Rail Phase Two expansion, the Musi River rejuvenation project, the scheme to lift Godavari river water to Hyderabad, and the construction of the Regional Ring Road (RRR).



The Chief Minister asserted the State's lofty economic ambitions, stating, "We are not competing with other states in the country. Our competition is with Singapore, Tokyo, and New York cities." Achieving this global competitiveness necessitates substantial Central cooperation. He revealed the State's ambitious targets: to achieve a \$1 trillion US dollar economy by 2034 and a \$3 trillion US dollar economy by 2047. He

further stated that the government expects Telangana to contribute 10% of the country's total economy, aligning with Prime Minister Modi's vision of developing India into a \$30 trillion economy by 2047 (Vikas Bharat 2047). The Chief Minister also briefed Minister Khattar on the State's commitment to zero carbon emission measures, including the promotion of Electric Vehicles (EVs) and the plan to introduce 3,000 electric buses in Hyderabad in the coming year. Discussions also focused on the proposed 'Bharat Future City' project, attracting global investments to the new city, and the establishment of a Dry Port to bolster the State's economy. Finally, CM Revanth Reddy announced that the official "Telangana Rising 2047 Vision Document" will be released on December 9.

## ED Enters iBomma Piracy Case Over Money Laundering Suspicions

The Enforcement Directorate (ED) has officially entered the investigation into the iBomma movie piracy case, following up on suspicions of money laundering connected to the illicit operation run by Immadi Ravi. The ED has formally written to the Hyderabad Police Commissioner, requesting all case details to launch a full-scale probe into the financial trail of the accused. Already, the police have frozen 3.5 crore across Ravi's bank accounts, and further investigations by the police have revealed critical financial details.

It was found that Ravi earned crores by displaying advertisements for betting applications on the iBomma site. The investigation uncovered


that funds were regularly transferred to Ravi's non-resident Indian (NRI) account from a cryptocurrency wallet, with approximately 15 lakh per month being moved. Police have identified 20 crore in transactions across four of Ravi's bank accounts. The proceeds from the betting app advertisements and piracy allowed Ravi to purchase property in Hyderabad and the Caribbean Islands and fuel an extravagant lifestyle, including traveling to a different country almost every two months. The focus has now shifted to popular Biryani restaurants, with officials working to uncover their business transactions and alleged financial irregularities. The Income Tax Department's investigation wing launc



hed these surprise inspections on Tuesday, acting on suspicions of massive tax evasion involving crores of rupees in sales. The raids were conducted simultaneously across 30 locations in Hyderabad

## Telangana to Introduce Gig Workers Act

The Telangana Labour Minister Vivek Venkatswamy announced on Tuesday that the state government is set to introduce the Gig Workers Act, a crucial piece of legislation designed to provide protection and benefits to the rapidly growing gig workforce. The Minister stated that extensive work has been done on the proposed bill, which is expected to be passed in the Assembly shortly. The Act will ensure that all gig workers are registered and will protect them from unfair

terminations, making arbitrary dismissals impossible unless necessitated by "serious mistakes." The legislation aims to address the vulnerabilities faced by workers in the gig and platform economy, a sector that NITI Aayog projects will employ over 2.35 crore workers by 2029-30. The government plans to form a dedicated board to oversee the implementation of the Act and the welfare of registered gig workers, complementing the Central Government's Code on Social Security, 2020, which already defines gig and platform workers and provides for social security benefits like life cover and health benefits.

In a separate but related announcement, Minister Venkatswamy confirmed that the State Cabinet has decided to provide an ex-gratia payment of 5 lakh to the families of the Indian Umrah pilgrims who tragically

# Telangana Aims for \$3 Trillion Economy by 2047: Deputy CM Bhatti Vikramarka

TPN Bureau | Nov 18, 2025, Deputy Chief Minister Bhatti Vikramarka Mallu announced that the Telangana Government is preparing for massive '2047 Telangana Rising' celebrations on the 8th and 9th of next month, where several new policies will be unveiled. Addressing the 47th Quarterly Bankers Meeting (SLBC) in Begumpet, he urged bankers to actively participate and partner in this major event, which will feature the launch of the 2047 Roadmap. This roadmap sets an ambitious target of achieving a 13% GDP growth rate to build a three-trillion-dollar economy for the State by 2047. The Deputy Chief Minister highlighted that the Government's long-


term vision and plans will be showcased during these celebrations, moving from showcasing completed programs in the first year to highlighting continuing initiatives in the second year. He stressed the State's determination to build a modern, inclusive, and future-ready Telangana. Key infrastructure projects, including the Regional Ring Road, the connection of industrial corridors, and the Musi River rejuvenation, are central to attracting global investments. He affirmed that the entire State, and not just Hyderabad, possesses immense potential due to its strategic location, favorable climate, skilled human resources at lower costs, and strong pow-

er supply, which the Government is committed to maintaining despite the anticipated 10% annual increase in electricity demand. The Deputy Chief Minister issued a strong call to the banking sector, urging them to shift from transactional engagement to a transformational partnership by significantly boosting support for Self-Help Groups (SHGs) and Micro, Small, and Medium Enterprises (MSMEs). Promoting these two sectors is crucial for large-scale wealth creation and employment generation, which, in turn, will drive GDP growth. He noted that while the banking sector achieved strong figures in the first half of the year (49.45% Priority

Sector Lending and a Credit-Deposit Ratio of 130.18%), there are still critical gaps. Specifically, he urged banks to bridge the gap in agricultural term lending—which limits farmers' modernization—and to increase support for diversification crops like oil palm to secure future incomes, moving the State from volume to value in agriculture. The transformative plan includes the construction of 13,000 km of internal roads through the HAM model, which he asked banks to treat as a priority sector lending opportunity. He concluded by calling for bold credit expansion and innovative financial solutions to match Telangana's ambition for the next transformative decade.



## Telangana Launches MeeSeva Services on WhatsApp; Aims for Digital Governance Model

partnership with Meta and MeeSeva, is one of the largest government-WhatsApp service integrations in the country, providing citizens access to more than 580 services from 38 government departments directly through the popular messaging platform, without requiring additional applications. Speaking at

the launch event, Minister Sridhar Babu highlighted the government's commitment to transforming governance into a participatory, transparent, and citizen-led process. He asserted that technology should be viewed as an instrument of equality, ensuring that digital benefits reach "even the last per-

son in remote corners of Telangana.

"He emphasized that "Governance should not happen within closed walls. It must integrate citizens as active participants, with technology bringing services directly to their doorstep." As part of this comprehensive digital governance vision, the

government has set an ambitious target of training 10 lakh youth every year in Artificial Intelligence (AI) to prepare a future-ready work force. The Minister noted that Telangana is advancing rapidly with other major AI initiatives, including the AI-powered Telangana Digital Exchange (TGDeX), AI City, AI University, and the Telangana Innovation Hub. The new GenAI-driven, mobile-first model is set to reshape citizen service delivery. Plans are underway to soon make the WhatsApp-based MeeSeva services available in Telugu and Urdu and to develop voice-command features for hands-free access. The service will also be expanded to include more government departments in the coming months. Minister Sridhar Babu confirmed that Telangana's innovative digital governance models are already attracting attention from other States looking to adopt similar technology-driven service delivery systems.

# KTR Vows BRS Fight Until Cotton Farmers' Issues Are Resolved

TPN Bureau | Nov 18, 2025. The Working President of the Bharat Rashtra Samithi (BRS), K.T. Rama Rao (KTR), along with senior party leaders, met with officials from the Cotton Corporation of India (CCI) in Adilabad to submit a comprehensive representation detailing the grievances of cotton farmers. He expressed severe dissatisfaction that the State Cabinet meeting failed to discuss the distress of cotton farmers, including issues of moisture content, crop damage, and challenges facing the cotton crop grown over 50 lakh acres in the state.

KTR presented three key demands: the immediate withdrawal of the 'Kapas App', the removal of the arbitrary rule limiting procurement to only seven quintals per acre, and the mandatory purchase of cotton with a moisture content of up to 20 per cent. He stated that



the abrupt introduction of the Kisan Kapas App, without proper training or awareness, is causing unnecessary delays in procurement.

He highlighted that many farmers in Adilabad do not own smartphones, connectivity is poor, and due to a lack of training, the app causes more harm than good. Farmers claim that the CCI, which usually procures 5 lakh quintals by this time of year, has not even procured one lakh

quintal, necessitating a return to the old system where farmers can sell directly at market yards. He suggested that if the app is to continue, it should be implemented next year only after giving farmers two to three months of training. The second major issue KTR raised was the Moisture Content (MC) norm. He explained that due to heavy rainfall and the minimum temperature dropping to 6°C by November 18 in Adilabad, the cotton grown in black soil naturally has higher

moisture. He recalled that the previous KCR government ensured CCI purchased cotton even with 20-22% MC, criticizing the current State government's indifference. He expressed concern that the Central government's agreements to import cotton are hurting domestic farmers. Due to the CCI rule to buy cotton only if the moisture is between 8% and 12%, and reducing the price as moisture increases, farmers who should receive 8,110 per quintal are receiving only 5,000 to 6,200, resulting in a loss of around 3,000. Furthermore, KTR criticized the procurement limit, demanding it be raised from seven quintals to 13 quintals per acre, as areas like Jainath and Bela produce 15-18 quintals per acre. He pointed out that cotton and soy farmers in Adilabad are facing an "impossible" situation, as CCI is delaying purchases while private traders have also shut down mills and gone on an indefinite strike. He noted incidents

where farmers lost their stored cotton due to fire accidents. KTR also lashed out at the State government for failing to implement any of its promises, such as the PM Fasal Bima Yojana, input subsidy, or 20,000 per acre compensation for rain-affected crops. He was deeply unhappy that the Cabinet meeting failed to discuss the plight of cotton farmers. He called on the State government to immediately respond and pressure the Centre. KTR announced the BRS's full support for the National Highways Blockade planned by the farmers in Adilabad on November 21st, stating that the party is ready to unite across party lines to approach the Central government on the farmers' behalf. He also demanded the removal of the biometric (fingerprinting) rule for older farmers who have difficulty with authentication.



## BRS Alleges Congress Betrayal on BC Reservations

TPN Bureau | Nov 18, 2025. Former Minister V. Srinivas Goud, addressing a press meet at Telangana Bhavan, accused the Congress government of deceiving the Backward Classes (BCs) regarding reservations in local body elections.

He questioned whether it was reasonable to stop the implementation of 42 per cent BC reservations for the sake of 3,000 crores in funds, suggesting that the government could stop funds for major projects but not for this. He urged BC leaders within the Congress and BJP to fight for the 42 per cent reservation and called for all BC associations to unite. He announced that a BC JAC meeting would be held soon to decide the future course of action.

Former MLA Jaipal Yadav supported the claims, calling the Congress government's failure to finalize the 42 per cent reservation seats an outrage. He warned that the BC reservation would fall from 42 per cent to 23 per cent. He stated that the decision to proceed with reservations below 50 per cent is a betrayal of the BC community. He affirmed that the BRS would fight for the legal right of 42 per cent reservation for the BCs.

## Harish Rao Reaches Out To Farmers

Former Minister Harish Rao inspected cotton crops in Mogilicherla village of Parkal constituency, Warangal district, where he interacted with farmers to understand their difficulties and issues firsthand. A farmer named Shobha shared her deepest distress with the former minister. Farmer Shobha explained that they are losing the subsequent crop due to lack of water. She lamented that cotton, which should fetch a Minimum Support Price (MSP) of 8,100 per quintal, is being sold to middlemen for only 4,500. She stated that they cannot even recover the expenses, let alone pay for labour. The promised bonus for paddy sold during

fronts, including fertiliser, seed, and lack of power. If they go to the market, they are told they haven't registered online, and if they can't sell, they are forced to sell cotton to middlemen for 4,500 per quintal.

She also raised the issue of erratic power supply. When the lineman is asked, he directs them to the officials, and the officials claim they are not coming. She fondly recalled that during the KCR regime, there was 24 hours of current and plenty of water. Since the Congress came to power, farmers have been reduced to begging.

She highlighted the severe shortage of fertilisers, saying that despite being in line for three days, she could not get even one bag of urea. She questioned how a single bag of urea could suffice for five acres of land. She strongly criticised Chief Minister Revanth Reddy, saying he has virtually given a bowl to farmers and asked them to beg. She also pointed out that the government is ignoring the rampant sale of duplicate seeds. She reiterated that the government is not paying attention despite farmers suffering losses on all

## Bandi Sanjay Warns Maoists: Don't Fall for 'Urban Naxals'

Union Minister of State for Home Affairs, Bandi Sanjay Kumar, made sensational remarks in Vemulawada, warning Maoists not to be deceived by 'Urban Naxals' and urging them to immediately abandon their weapons and join the mainstream society.

Bandi Sanjay alleged that Urban Naxals are enjoying a luxurious life in cities, indulging in pleasure with their families. He claimed they amass wealth through lobbying, regardless of which party is in power, and travel in cars. He said that innocent people who believe their words take up arms and wander in the forests, without food or shelter, eventually losing their lives. He stated that Urban Naxals say one thing and do another,

and are responsible for the deaths of Maoists.

Addressing the media, he mentioned that the Central government allocates significant funds to hospitals through the National Health Mission. He urged young doctors to apply for the 89 medical posts for which the Collector has issued a notification, and to serve the poor in government hospitals. Responding to the encounter of Maoist leader Hidma, he asserted that state power cannot be achieved through the barrel of a gun, saying, "What have you achieved with the gun? All you have done is kill innocents and get killed yourselves." He stressed that the BJP, under PM Modi, came to power for the third time through the ballot, while Maoists have achieved nothing with the bullet but death.

## Harish Rao: Congress Rule Plagued by Issues From Electricity to Weighing Scales

Former Minister Harish Rao, addressing the media after visiting the Enumamula Agricultural Market, launched a scathing attack on both the Congress and BJP, stating that under Congress rule, everything from electricity (current) to weighing scales (kanta) is mired in problems.

He listed the failures, addressing Chief Minister Revanth Reddy directly: "No fertilisers, no seeds, no proper electricity, no Rythu Bandhu, no loan waiver, defaulting on bonus, no crop insurance. Isn't this your governance, Revanth Reddy?" He questioned if the Congress government had implemented even a single promise made in the Warangal Declaration.

He criticised the BJP for its policy of lifting import duties and imposing restrictions on farmers, asking who benefits from the removal of duty on cotton and palm oil imports, and why they are placing a noose around the farmers' necks. He accused the BJP of helping big contractors and corporates by harming farmers.

Harish Rao strongly condemned the CCI's "Fuglaq-like crazy decisions" such as the L1, L2, L3 system, the Kapas App, and the 8 to 12% moisture norm, stating these rules have put farmers on the road. He noted that all ginning mills across the state have been closed for two days, leaving cotton farmers in confusion.

With no market access, farmers are forced to sell to middlemen at exploitative rates. Against an MSP of 8,100, farmers are selling for around 6,000, losing 2,000 per quintal. He accused the Central and State governments of showing farmers 'heaven in their palms' verbally, but delivering 'hell' in reality.

He questioned if the Chief Minister, who has visited Delhi 60 times, did not get a chance or patience to present the cotton farmers' issues to the Centre. He taunted that since Revanth Reddy has good relations with Bade Bhai (referring to the Central leadership), why is he not speaking up for the cotton farmers? He demanded the Central government immediately

## KTR Slams State and Central Governments Over Cotton Procurement Crisis

Bharat Rashtra Samithi (BRS) Working President K.T. Rama Rao (KTR), accompanied by senior party leaders, conducted an extensive tour of Adilabad district to understand the hardships faced by farmers, particularly those cultivating cotton and soybean. During his visit to the Adilabad Market Yard, KTR interacted with several farmers who expressed deep distress over the ongoing procurement crisis. They alleged that both the Central and State governments have completely ignored their pleas and failed to provide any form of support. Farmers complained that despite Congress promising major relief for the agriculture sector, the government has not honoured any assurances. Even basic assistance required to sell their harvested crops has not been provided. After meeting farmers, KTR addressed the media and

questioned the State government's intentions. "If there is no problem for farmers, why is the Adilabad Market Yard shut today? Why did the government obstruct our visit to meet farmers?" he asked.

He condemned the severe decline in cotton and soybean procurement systems, stating that such a situation has never been witnessed in history. KTR criticised the "Kisan Kapas Mobile App," pointing out that many farmers do not own smartphones and several regions in Adilabad still lack proper mobile network connectivity. KTR highlighted that due to unseasonal rains and extreme cold, the moisture content in cotton has naturally increased. He recalled that during the previous BRS government, even cotton with 20-22% moisture was procured after mounting pressure on the Centre. "But today, they refuse to buy even 12% moisture. Farmers are left with no option and are being pushed to despair," he said. He stated that not even one lakh quintals of cotton have been procured so far. KTR alleged that the government appears to be colluding with private traders to exploit farmers.

The BRS leader criticised the arbitrary rule

limiting cotton procurement to only seven quintals per acre, despite Adilabad's fertile lands producing 10-15 quintals per acre. "Where should farmers sell the remaining produce?" he questioned.

He slammed the State government for indulging in "political drama," claiming that they scheduled a video conference with the Centre on the 21st because BRS leaders were visiting the farmers. He also pointed out that the recent Cabinet meeting failed to discuss the cotton crisis affecting more than half of Telangana's districts.

KTR further blamed the Congress government for the crisis across every stage of agriculture—power supply, fertiliser distribution, and now crop procurement. He also attacked the BJP-led Central government for allowing cotton imports and removing import duties, thereby damaging domestic farmers' prospects. He warned that without mounting pressure on the Centre, the

# Brilliant College Heist Solved: Over 1 Crore Stolen, Three Arrested



TPN Bureau | Nov 18, 2025, The Rachakonda Police achieved a major success in solving the massive theft case at Brilliant Engineering College (Abdulapurnet Police Station limits) that had shocked the

city on October 10th. LB Nagar DCP Anuradha announced the decisive breakthrough, confirming that the culprits forced the office lock, used a screwdriver to break into an internal cup-

board, and stole 1.07 crore in cash, primarily comprising student fees. Following a prompt complaint by Principal Puligadda Veeranna, the police formed specialized teams, leading to the apprehension of three members of the sophisticated interstate gang, notably including a minor boy. The arrested individuals were identified as Raj Manohar Pawar (22) from Gujarat and Rithik @ Rithik Mohit (24) from Madhya Pradesh, though three key members—Dinesh Mohit (27), Arun Mohit (18), and Vilas Chauhan (22)—are still at large.

Police successfully recovered 37 lakh in cash, along with the burglary tools. This highly specialized gang is known for exclusively targeting educational institutions near highways across states like Maharashtra, Gujarat, Karnataka, and Haryana. They meticulously utilize Google Maps for location scouting, operate in large groups (5-6 members), use crude tools to force entry, and meticulously plan their escapes via public transport. The investigation revealed they had initially surveyed Shreyas College but abandoned the

The arrests were a result of the tireless efforts of 20 special police teams who physically scoured Gujarat, utilizing over 1,000 CCTV camera feeds to meticulously track and eventually apprehend the accused.

## Father Ends Life After Twin Babies Pass Away

A profoundly tragic and deeply emotional incident unfolded within the jurisdiction of the Shamshabad RGI Airport Police Station, leading to a dual tragedy for one family. Muthyalu Vijay, a young man working at a private company and originally from Bengaluru, Karnataka, committed suicide, utterly devastated by the news that the twin babies his wife was carrying had passed away while undergoing critical medical treatment. ## Ragging Chaos Erupts at Shamshabad College: Assaults and Injuries

The situation became critical when the day-scholar students allegedly escalated the conflict further by attempting to involve external individuals—a local gang—to attack the hostel students, forcing an immediate intervention by police to prevent mass violence. The college management immediately responded to the crisis by summoning the parents of all involved students to the campus. Compounding the seriousness of the situation, the entire student confrontation was reportedly captured vividly on the college's CCTV cameras, but the administration is under suspicion of actively attempting to suppress this critical video evidence. Adding to the college's woes, strong local accusations claim the institution operates without the required official permissions from educational authorities. Moreover, one of the most serious allegations is that the college warden is implicated in the illegal activity of supplying cigarettes to the minor students. Parents confirmed previous similar incidents, noting two students were issued Transfer Certificates (TCs) last year due to unresolved ragging issues. Police are now conducting a thorough investigation into the conflict's origins, the extent of the ragging, and the alleged involvement of the outside gang. They confirmed that prompt and stringent legal action will be initiated based on the formal complaints filed by the students' parents, ensuring accountability for the violence and the reported illegal conduct.

## 6.5 Lakh Hash Oil Seized: Odisha Accused Arrested

Despite the parents' desperate attempts to intervene and mediate the issue multiple times with community elders, Bhanu remained unrepentant, refusing to alter his abusive conduct, which intensified his demands for money and his physical har-

# Seethakka Vows to Resolve Egg Supply Issues for Anganwadis and Hostels



She made a fervent appeal to all parties involved, urging them to act with profound humanitarian responsibility and diligence when delivering essential services and supplies to Anganwadi children and pregnant women, demanding that not a single day's egg

supply is missed. The egg contractors, in turn, clearly articulated several major and complex operational challenges they face daily. They pointed out the severe coordination issues arising from having contracts that involve supplying the wildly fluctuating demands of welfare hostels alongside the fixed requirements of Anganwadi centers simultaneously. A major hurdle is the lack of clarity in meeting hostel demands because they never receive clear, consistent, or specific schedules detailing "when and how many eggs are needed," unlike the straightforward fixed numbers required for Anganwadis. Critically, they highlighted the intense pressure to divert stock, where hostel administrators often exert significant pressure on them to unload fresh eggs originally intended for Anganwadi centers, inevitably leading to sub-

stantial supply delays at the centers. Furthermore, the logistical uncertainty—specifically the unpredictability of when hostel administrators will suddenly demand eggs or, conversely, arbitrarily reject and return eggs—causes immense disruption, unnecessary loss,

and severe complications in their logistics management. Recognizing the systemic severity of these operational difficulties that impact the delivery of nutrition, Minister Seethakka promised to immediately take the specific issue to the attention of the Chief Minister and assured the contractors that the government is committed to finding a viable, long-term solution to structurally streamline the dual supply system for both welfare hostels and Anganwadi centers, ensuring efficient delivery and accountability.



## Eight Injured as Private Bus Collides with Truck in Andhra Pradesh

Eight people sustained injuries, with three classified as seriously hurt, when a private bus violently rammed into the back of a slow-moving truck near Nandigama in the NTR district of Andhra Pradesh, a local police official confirmed on Tuesday morning. As a severe consequence of the collision, the entire left side structure of the bus was extensively and severely damaged, requiring external assistance for passenger extraction.

## 31 Maoists Hiding as Labourers Arrested in Andhra's Vijayawada, Kakinada

TPN Bureau | Nov 18, 2025, A significant, intelligence-led security operation was executed across Andhra Pradesh, culminating in the major arrest of 31 suspected Naxals, including individuals believed to be acting as crucial security personnel for top command, with a large number belonging to Chhattisgarh cadres, creating a major security stir in Vijayawada and surrounding regions on Tuesday. The bulk of the arrests—27 Maoists—were efficiently made at a four-storey building complex located in the New Autonagar neighbourhood of Kanuru, Vijayawada. Highly sensitive intelligence sources strongly suggest that nine members of the Central Committee of the CPI(Maoist) were amongst those targeted in the joint

operation conducted by elite OCTOPUS and Greyhounds personnel, working closely with local police forces. It was revealed that most of the detained individuals were women who had meticulously taken shelter in the urban environment under the guise of migrant labourers, blending into the large workforce. The entire operation was launched following a specific and validated intelligence alert indicating that a large contingent of Maoist elements had covertly moved into the city and were attempting to establish urban cells. Additional Director General (Intelligence) Mahesh Chandra Laddha confirmed the total number of arrests (31) spanning Krishna district, Vijayawada, and Kakinada. Since the Vijayawada Autonagar

area employs a large, rotating number of migrant workers from states like Chhattisgarh, the Maoists exploited this massive transient workforce to effectively conceal their presence and not arouse any local suspicion.

This extensive and highly successful large-scale arrest operation is believed to be directly and strategically linked to a major counter-insurgency effort carried out just hours earlier on Tuesday in the deep forests of the Alluri Sitalamaraju district in the crucial Andhra-Odisha border (AOB) region, which had resulted in the confirmed killing of six Maoists, including top commander and CPI(Maoist) Central Committee member Hidma and his wife Raji.

## MP Urges Union Minister to Protect Telangana Cotton Farmers from Yield Reduction

Peddapalli MP Gaddam Vamsi Krishna has taken a resolute and proactive step to bring the severe and pressing issues faced by Telangana's vast cotton farming community directly to the attention of the Central Government. In an official and strongly worded letter addressed to the Union Minister for Textiles, Shri Giriraj Singh, the MP meticulously outlined several critical suggestions concerning the procedures for the ongoing 2025-26 cotton procurement season and urged immediate, corrective action from the Centre to ensure justice for the farmers. The most contentious point raised was his categorical opposition to the Cotton Corporation of India (CCI) proposal to drastically cut the state's average

cotton yield estimate from 11.74 quintals to a mere 7 quintals, a reduction he deemed arbitrary and unacceptable. The MP stressed that this severely reduced estimate is fundamentally and factually inconsistent with the verified ground data officially submitted by the Collectors of all 33 districts across the state, as well as the reports provided by the State Director of Agriculture. He issued a solemn warning that proceeding with the decision to lower the yield estimate at this critical juncture would inflict immense further financial hardship on thousands of farmers who are already struggling profoundly to recover from significant crop damage and economic setbacks caused by the recent severe Monsoon cyclone. The current season's initial procurement data indicates that a total

of 6,680 Metric Tons (MTs) of cotton have been purchased to date, successfully benefiting 3,175 farmers, with the overall value of the cotton procured standing at a considerable 52.25 crore, of which 15.04 crore has already been accurately disbursed into the growers' bank accounts, demonstrating the pace of the ongoing procurement effort.

MP Vamsi Krishna concurrently drew the Centre's attention to several critical operational hurdles and underlying policy issues that have been repeatedly raised by the Cotton Millers & Traders Welfare Association, whose smooth operation is vital for the procurement process. These include the restrictive nature of current moisture norms, complicating

three key and non-negotiable demands raised by MP Vamsi Krishna that the state's average cotton yield estimate must be maintained at the original 11.74 quintals; the maximum permissible moisture limit must be immediately relaxed up to 20%; and all legitimate operational issues raised by the Millers & Traders Association must be resolved immediately. MP Vamsi Krishna unequivocally stated that the implementation of these specific, time-bound corrective measures by the Central Government is absolutely essential to ensure that Telangana's cotton farmers not only receive fair market pricing but also benefit from a smooth, transparent, and timely procurement process that protects their livelihoods throughout the duration of the season.

# Can India Turn H-1B Setback into a Brain Gain Revolution?



The United States' latest crackdown on skilled immigration has landed like a thunderbolt on India's middle-class dreams. President Donald Trump's executive order slapping a massive \$100,000 fee on each new H-1B visa application threatens to cripple the once-dependable pathway that connected India's brightest minds to Silicon Valley's innovation hubs.

For decades, this visa wasn't just a work permit — it was a symbol of aspiration. Thousands of In-

dian engineers, doctors, and scientists migrated to the U.S. every year, fueling American growth while sending money and pride back home. With nearly 70% of the annual 85,000 H-1B visas going to Indians, this program was central to India's soft power in global tech. Now, with the cost barrier so high, even big tech may hesitate to hire, while startups, universities, and nonprofits could be shut out completely.

Yet amid the despair lies

a historic opportunity for India.

Much like China in the early 2000s, or South Korea and Taiwan before that, India now stands at a crossroads. Beijing responded to tightening US visa policies with bold action — offering repatriation incentives, fast-track STEM visas, and startup capital. Returnees helped build tech giants like Alibaba and Baidu. South Korea's TSMC rose similarly from the return of overseas

talent.

India must act now to seize this moment. The groundwork exists. India's digital economy is growing, global capability centers are thriving, and cities like Bengaluru and Hyderabad already attract global tech. But talent won't return without compelling reasons. Competitive pay, research freedom, clean governance, and streamlined startup ecosystems are vital. This calls for a bold national policy — perhaps an "India

Return Visa" — backed by both government and industry.

PM Modi's Atmanirbhar Bharat vision aligns perfectly with this opportunity. Trump's move may unintentionally offer India the opening to turn decades of brain drain into a flood of brain gain.

If India acts swiftly and smartly, what started as a setback could spark a new era — one where innovation, talent, and leadership return home to build the India of tomorrow.

and elite professionals, while displacing traditional jobs and increasing income inequality.

Unlike the 1800s, however, the modern world may not need to wait decades to address these imbalances — if policy keeps pace with innovation. Governments and international institutions must prioritize inclusive AI governance frameworks. ## Karur Tragedy Exposes Dark Side of Tamil Nadu's Star-Struck Politics



The tragic stampede in Karur that claimed 40 lives and injured hundreds during actor-turned-politician Joseph Vijay's rally has triggered a wave of public outrage and political introspection in Tamil Nadu. What was meant to be a grand show of strength for Vijay's new party, Tamilaga Vettu Kazhagam (TVK), turned into a horrific event — one that lays bare the risks of personality-driven politics in the state.

Eyewitness reports and police briefings suggest that between 30,000 to 60,000 people packed a narrow stretch of road meant for less than 10,000. Many had been waiting since morning under the scorching sun to catch a

glimpse of Vijay, who was expected around noon but only arrived close to 7 p.m. The late arrival — eerily reminiscent of his film industry habits — proved catastrophic.

Critics argue that Vijay's nonchalance was not just a failure in time management, but a reflection of deep-seated arrogance. His absence from the hospitals, his silence with the bereaved, and his casual response have angered even some of his supporters. "This isn't just star arrogance—it's a failure of leadership," a senior political analyst said.

The tragedy brings into focus Tamil Nadu's decades-old fascination with film stars in politics — a legacy of M.G. Ramachandran, Jayalalithaa, and others. While their cha-

rism often masked governance shortcomings, Vijay's entry into politics now raises a harsher question: Has the blind worship of celebrity reached a fatal threshold?

The state High Court is now hearing pleas to restrict TVK's future gatherings. Nearly 500 police personnel were deployed for the Karur event, but crowd control was inadequate.

With the 2026 elections looming, the incident may become a turning point for both voters and political parties. The question isn't just about Vijay's fitness to lead — it's about Tamil Nadu's willingness to evolve beyond personality cults and demand accountability from those who seek power.

## How India can make an opportunity of the H-1B visa crisis



With the Bihar Assembly election looming, Prime Minister Narendra Modi's latest move — transferring ₹10,000 each to 75 lakh women in the state — has stirred both admiration and criticism. The massive ₹7,500 crore payout dwarfs other recent announcements, including the ₹1,600 crore re-

lief package for flood-hit Punjab. The message is clear: women are now a core constituency for the Bharatiya Janata Party (BJP), and the party is doubling down on its electoral investment.

As Editor-in-Chief Jyoti Malhotra highlights in her op-ed There's something special

about Bihar; this is not an isolated gesture. Across states headed for elections, BJP has systematically launched women-focused welfare schemes — from Lado Lakshmi in Haryana and Ladli Behna in Madhya Pradesh to Mahila Samridhi Yojana in Delhi and Mahtari Vandana in Chhattis-

garh. Modi's strategy appears to be forging a reliable "women constituency" with targeted financial empowerment and social messaging.

However, this calculated outreach raises deeper questions. Is this genuine empowerment or strategic pandering? Critics argue that while cash transfers provide short-term relief, they often lack the structural support needed for long-term gender parity — in education, employment, and safety.

Beyond domestic politics, another shift is reshaping India's global talent landscape: the H-1B visa crisis in the US. With President Trump imposing a staggering \$100,000 fee per application, Indian skilled workers — once the backbone of Silicon Valley — are looking elsewhere. Canada, Australia, and Europe are seizing the moment, offering simpler immigration pathways and greater certainty for skilled migrants.

India, instead of lamenting the loss, could turn this crisis into an opportunity. With strong policy initiatives, it can attract its own global talent back home. The groundwork is present — thriving tech hubs, growing global capability centers, and a youthful workforce. But without reforms in research, innovation, and governance, return migration will remain a missed opportunity.

As India navigates electoral battles and global disruptions, the real test lies in whether policy can rise above politics — delivering not just votes, but vision.

## Can India Deny Dhaka's Request To Extradite Sheikh Hasina? What Rules Say

After Bangladesh's ousted prime minister Sheikh Hasina was sentenced to death in absentia for "crimes against humanity," Dhaka has formally requested India to extradite her. Hasina, who fled Bangladesh on August 5 last year amid a student-led uprising, has been living in exile in India since. Her former home minister, Asaduzzaman Khan Kamal, believed to be in India as well, is also sought by Dhaka authorities.

Hasina was convicted on multiple charges, including ordering the killing of student protesters and using lethal force via helicopters and drones. She has denounced the verdict as "biased and politically motivated," asserting she acted to minimize loss of life. The Awami League has called for a national shutdown in protest, while Hasina cannot appeal the verdict unless she surrenders or is arrested within 30 days.

Bangladesh's Foreign Ministry described India's extradition of Hasina and Khan as a "compulsory responsibility" under the bilateral extradition treaty, warning



that sheltering them could be deemed "unfriendly" and a disregard for justice.

India, however, has responded cautiously. The Ministry of External Affairs (MEA) noted the verdict and assured constructive engagement with all stakeholders, emphasizing peace, democracy, and

stability in Bangladesh, without directly commenting on the extradition request.

Under the India-Bangladesh Extradition Treaty (2013, amended 2016) and India's Extradition Act, 1962, New Delhi retains discretion to deny requests deemed politically motivated, unjust, or not

in the interest of justice. Extradition may also be refused if charges are considered trivial, oppressive, or purely political, or if India can prosecute the accused domestically. Legal experts say Hasina's extradition is highly unlikely, given the potential political overtones and disre-

tion granted to India under both treaty and domestic law.

As tensions rise, India is expected to carefully weigh diplomatic relations with Bangladesh against legal safeguards and the risk of political persecution before taking any decision on Hasina's extradition.

## India-Russia Ties Factor Of Stability In International Relations: S Jaishankar

External Affairs Minister S. Jaishankar on Monday emphasized that India-Russia relations have long been a factor of stability in international affairs, noting that their continued growth serves not only the mutual interests of the two nations but also the broader global community.

Jaishankar made the remarks during a meeting with Russian Foreign Minister Sergey Lavrov, highlighting ongoing discussions on several bilateral agreements, initiatives, and projects across multiple sectors. "We look forward to their finalization in the coming days. These will add more substance and texture to our Special and Privileged Strategic Partnership," he said.

The Indian minister also pointed to the importance of regular diplomatic interactions, noting that six meetings had already taken place between



him and Lavrov this year. He described the discussions as vital for advancing bilateral cooperation and exchanging perspectives on key regional, global, and multilateral issues.

Jaishankar highlighted that the talks would also

cover the complex global situation, including the Ukraine conflict, the Middle East, and Afghanistan. "India supports recent ef-

forts towards establishing peace. We hope all parties approach that goal constructively. An early cessation of the conflict and the ensuring of enduring peace is in the interest of the entire international community," he added.

The meeting comes ahead of President Vladimir Putin's visit to India for the 23rd Annual Summit, underscoring the strategic depth of India-Russia relations. Jaishankar described the ties as a model of openness and constructive engagement, asserting that their evolution benefits not just India and Russia but the world at large.

Jaishankar is in Moscow to lead the Indian delegation at the SCO Council of Heads of Government meeting, hosted by Russian Prime Minister Mikhail Mishustin on November 18, 2025, where further collaboration and regional stability initiatives are expected to be discussed.

## "Will Quit If JDU Fulfils 2 Lakhs Promise": Prashant Kishor After Bihar Loss

Jan Suraaj chief Prashant Kishor, in his first reaction after his party's disappointing performance in the Bihar Assembly elections, announced a one-day 'maun upvas' (vow of silence), taking full responsibility for the electoral setback.

Kishor's party contested 238 of Bihar's 243 Assembly seats but failed to win a single seat. The ruling NDA alliance, led by BJP and Nitish Kumar's JDU, secured a decisive victory with 202 seats, while Chi-

rag Paswan's LJP (Ram Vilas) won 19 seats.

"We tried very positively from our end. We failed to change this government. The responsibility lies entirely with me," Kishor said, adding that introspection would follow. He acknowledged the

efforts of his team but admitted, "If the public did not show faith in us, the responsibility is mine."

Despite his pre-poll remark that he would quit politics if JDU won over 25 seats, Kishor clarified that he would not resign immediately. However, he reiterated

a new promise: he would retire from politics if the ruling government fulfills its pre-election pledge of giving ₹2 lakh each to 1.5 crore people. "If Nitish Kumar transfers the ₹2 lakh as promised and proves he didn't win by buying votes, I will retire without any ifs or buts," he stated.

Kishor also rejected allegations that voters sold their votes. "For the first time, a government promised to spend ₹40,000 crore for people, which contributed to NDA's majority. People here will not sell their future," he said.

Despite the loss, Kishor affirmed his commitment to Bihar politics, saying, "We will stand again with the same power. You are not defeated until you quit."

The poll strategist-turned-politician's vow of silence and conditional promise to quit politics signal both reflection and resilience, as he navigates the aftermath of Jan Suraaj's historic electoral failure.

## Red Fort Blast: Co-Conspirator Sent to NIA Custody

A Delhi court on Tuesday remanded Jasir Bilal Wani, described as an "active co-conspirator" of suicide bomber Umar Nabi, to 10 days of NIA custody in connection with the Red Fort car blast that killed 15 people.

The blast, which occurred near the historic Red Fort, had triggered nationwide security concerns and intensified investigations into the perpetrators and their network.

Wani, a key accused in the attack, was produced before the Patiala House Court, where the National Investigation Agency (NIA) requested custodial interrogation to gather critical evidence.

Principal District and Sessions Judge Anju Ba-

jaj Chandna allowed the NIA plea, emphasizing the necessity of custodial questioning to uncover the full extent of the conspiracy behind the blast. The court proceedings were held almost entirely 'in camera', with media personnel barred from entering the courtroom, reflecting the sensitive nature of the investigation.

NIA officials indicated that Wani's interrogation could provide crucial leads regarding the planning and execution of the blast, as well as the possible involvement of other associates. The agency is expected to question him on logistics, recruitment, and funding networks that may have facilitated the attack.

The Red Fort incident remains one of the most significant terror attacks in Delhi in recent years, prompting enhanced security measures around key landmarks and intensified intelligence operations across the National Capital Region. Investigators are working to piece together the chain of command and identify other operatives linked to the attack.

As the probe continues, authorities have urged the public to remain vigilant and report any suspicious activity. Wani's custodial interrogation marks a key step in the ongoing investigation, as the NIA seeks to prevent further attacks and dismantle the terror network behind the Red Fort tragedy.

## Top Naxal Commander Madvi Hidma Killed in Andhra Pradesh Encounter

Top Naxal commander Madvi Hidma, who masterminded multiple deadly attacks over the past two decades, was killed in an encounter in Andhra Pradesh on Tuesday, November 18, 2025.

Security forces also eliminated his wife Raje and four other Naxal cadres in the Maredumilli forest of Alluri Sitaramaraju district, officials confirmed. Chhattisgarh Police described the operation as the "last nail in the coffin" of the Maoist insurgency in Bastar.

Hidma, a native of Puvarti village in Sukma district, had long evaded capture due to his extensive guerrilla tactics and a sophisticated four-layered security ring in forested areas of Chhattisgarh, Andhra Pradesh, Telangana, Odisha, and Maharashtra.

He headed the Maoists' People's Liberation Guerrilla Army (PLGA) Battalion No. 1, the most formidable unit in Dandakaranya, and was recently elevated to the Maoists' Central Committee.

Hidma first came on security forces' radar after the 2010 Tadmetla attack, which killed 76 personnel. He later played key roles in other high-profile strikes, including the 2013 Jhiram Valley ambush, which wiped out senior Congress leaders in Bastar, and the 2017 Burkapur attack, leaving 24 CRPF personnel dead. His wife Raje was also actively involved in the battalion and reportedly participated in major Maoist operations.

In recent years, intensified anti-Naxal operations weakened Hidma's security network, forcing him to retreat deeper into forests along

state borders. Sustained operations in Maoist strongholds eventually led to his elimination, along with several senior Central Committee members.

Chhattisgarh Deputy Chief Minister Vijay Sharma called Hidma's death a significant milestone in eliminating Maoism from the region. With this encounter, nine top Maoist Central Committee members have been killed this year across Chhattisgarh, Jharkhand, and Andhra Pradesh, including Nambala Keshav Rao alias Basavaraju, the general secretary of the outlawed Communist Party of India (Maoist).

Officials said Hidma's elimination marks a decisive blow to the insurgency and weakens the Maoist network's operational capabilities in Bastar and neighboring areas.

## UN Adopts US Resolution Backing Trump's Gaza Peace Plan

The UN Security Council on Monday adopted a US-drafted resolution endorsing former President Donald Trump's plan to end the conflict in Gaza and authorising an international stabilisation force for the Palestinian territory. The resolution, seen as key to legitimising a transitional governance body, comes after Israel and Hamas agreed last month to the first phase of Trump's 20-point plan, including a ceasefire and hostage-release deal.

The text allows member states to participate in the Trump-chaired Board of Peace, envisioned as a transitional authority overseeing Gaza's reconstruction and economic recovery. It also authorises the international force to oversee demilitarisation, including dismantling weapons and military infrastructure.

Hamas immediately rejected the resolution, stating it will not disarm, calling the international intervention an "imposed guardianship mechanism" on Gaza. The militant group insists its fight against Israel remains legitimate, raising concerns of potential clashes with the new international force.

US Ambassador to the UN Mike Waltz described the resolution as a "pathway for Palestinian self-determination" and said it aims to replace rockets with diplomacy, dismantle Hamas'

grip, and create a prosperous and secure Gaza.

While Russia and China abstained, their ambassadorships criticised the resolution for giving the US-led initiative control over Gaza with unclear operational details. Russian ambassador Vasily Nebenya argued the UN was sidelined in planning the international stabilisation force.

The Palestinian Authority welcomed the resolution and expressed readiness to cooperate with its implementation, a crucial endorsement that helped prevent a Russian veto. Trump hailed the Security Council's vote as "a moment of true historic proportion," promising further announcements regarding the Board of Peace in the coming weeks.

The resolution also references a potential pathway to Palestinian statehood contingent on reforms by the Palestinian Authority and Gaza's redevelopment. However, Israeli Prime Minister Benjamin Netanyahu reaffirmed opposition to a Palestinian state, pledging to demilitarise Gaza "the easy way or the hard way," reflecting internal political pressure from right-wing factions.

The UN vote marks a significant international step in attempting to stabilise Gaza, though tensions remain high over Hamas' resistance and Israel's opposition.

## Japan Issues Safety Warning for Citizens in China

Japan has advised its citizens in China to exercise heightened caution amid a growing diplomatic rift between Beijing and Tokyo over Taiwan. The advisory urges Japanese nationals to avoid crowded areas, stay alert, and watch for suspicious individuals, signaling concerns over potential threats to their safety.

The warning comes after tensions escalated between the two countries, with Chinese media coverage reflecting increasingly negative sentiment toward Japan. Japanese officials describe the advisory as a preventive measure, ensuring citizens remain vigilant during this period of strained relations.

Chief Cabinet Secretary Minoru Kihara emphasized that the advisory is a standard safety measure but reflects the deteriorating atmosphere affecting the bilateral ties between the nations. The advisory also coincides with the suspension of Japanese film screenings in China, a move seen as part of the wider diplomatic friction.

Japanese business leaders have voiced concern over the impact of the dispute on trade and investment, urging both governments to seek a diplomatic resolution. Japan continues to emphasize dialogue while

safeguarding its citizens amid uncertainty in China.

Prime Minister Sanae Takai-chi and government officials have highlighted the importance of monitoring the situation closely, particularly for Japanese nationals living, working, or traveling in major Chinese cities. The advisory underscores the seriousness with which Japan views public safety in the context of international tensions.

The advisory also comes amid ongoing disputes over Taiwan, a sensitive geopolitical flashpoint. Japan's cautionary message reflects broader regional concerns about security, diplomatic stability, and the potential for anti-Japanese sentiment to escalate in China.

Authorities have encouraged Japanese citizens to stay updated with local news, register with embassies, and maintain contact with family members. The advisory signals Tokyo's effort to protect its nationals while navigating an increasingly tense relationship with China.

Japan has not ruled out further measures depending on how the diplomatic situation evolves, highlighting the ongoing uncertainty in bilateral relations.

## Trump Blames Hoarse Voice on Trade Dispute Shouting

US President Donald Trump revealed that his raspy voice during a recent White House meeting was the result of a heated confrontation over trade policy with a foreign country. Speaking to reporters during a FIFA World Cup 2026 task force session, Trump said he had "blew [his] stack" while arguing with representatives from a nation attempting to renegotiate an existing trade deal.

Trump declined to specify the country, stating, "A country wanted to try and renegotiate the terms of their trade deal. And I wasn't happy about it." When pressed further, he added, "Why would I say that to you?" He described the exchange as necessary to "straighten it out" but admitted that it left his voice hoarse.

The United States has recently conducted trade discussions with

Japan, Cambodia, Malaysia, and Indonesia, alongside ongoing negotiations with China.

In October, Trump met Chinese President Xi Jinping in South Korea, where both leaders

reported progress on key trade issues. Trump said China agreed to assist the US

in addressing the fentanyl crisis, in exchange for a 10% reduction in tariffs on Chinese im-

ports, lowering the rate from 57% to 47%.

Trump also decided not to impose an additional 100% tariff on Chinese goods scheduled for November 1 after China postponed export restrictions on rare-earth magnets by one year. Commenting on the outcome of the Xi meeting, Trump expressed strong optimism, stating, "Zero, to 10, with 10 being the best, I'd say the meeting was a 12. A lot of decisions were made... and we've come to a conclusion on very many important points."

Trump's candid remarks about losing his voice drew attention to the intensity of the negotiations and reflected his personal style of engagement in high-stakes trade diplomacy. The incident underscores the ongoing US efforts to manage trade relations across Asia while addressing domestic and international economic priorities.

## Yunus Wants Civil War: Hasina's Aide After Death Penalty Verdict

Tensions in Bangladesh escalated sharply after a Dhaka-based International Crimes Tribunal sentenced former Prime Minister Sheikh Hasina and ex-Home Minister Asaduzzaman Khan to death over their alleged role in last year's violent crackdown on student protesters. The verdict, delivered in absentia, has triggered a political storm, with top Awami League leaders accusing the Muhammad Yunus-led interim government of running a "kangaroo court".

Awami League leader and former minister Mohibul Hasan Chowdhury, a close aide of Hasina, condemned the judgement as "pre-written" and illegitimate. Speaking to NDTV, he claimed the tribunal was illegally constituted and insisted that Hasina was de-

nied legal representation. Senior lawyers, he said, were barred from appearing in court, rendering the entire trial process "a staged drama".

Chowdhury warned that the interim regime was pushing Bangladesh "towards civil war", alleging it lacked public support and relied instead on

repression. He further accused the Yunus administration of fostering ties with Pakistan and allowing extremist groups such as Lashkar-e-Taiba and

Jaish-e-Mohammad into the country—claims that have not been independently verified.

Despite being banned from elections,

Chowdhury insisted the Awami League still commands majority support. He challenged the interim government to allow the party to contest the February elections, asserting that the public—not an unelected regime—should decide the nation's future.

Hasina, currently in India, denounced the verdict as "biased and politically motivated", saying she and Khan acted "in good faith" during the unrest. India has declined to extradite the two leaders, making the enforcement of the sentence unlikely.

The Awami League has called for a national shutdown to protest the judgement. Under Bangladeshi law, Hasina must surrender within 30 days to appeal—an outcome seen as improbable amid the deepening political crisis.

## "Copy Cat": Elon Musk Jabs Jeff Bezos Over New AI Platform Launch

Tech titans Elon Musk and Jeff Bezos have reigned their long-running rivalry, this time over artificial intelligence. Moments after Bezos unveiled his new AI platform, Project Prometheus, Musk took a

jab on X, calling the Amazon founder a "copycat"—a label he has used multiple times when Bezos entered sectors dominated by Musk.

Responding to the announcement, Musk posted: "Haha no way", followed by another message: "copy cat".

The Tesla and SpaceX CEO has previously mocked Bezos using similar remarks—once when Amazon announced its satellite internet project to compete with Starlink, and again when it acquired Zoox to en-

ter the autonomous vehicle race.

Project Prometheus marks Bezos's first major operational role since stepping down as Amazon CEO in 2021. The ambitious venture aims to create advanced AI systems for engineering, aero-

space, computing, and automotive manufacturing. The company will be co-led by former Google X scientist Vik Bajaj, who has worked closely with Google co-founder Sergey Brin. Bezos will serve as CEO.

The startup has al-

ready raised \$6.2 billion, including a major investment from Bezos himself, making it one of the most heavily funded early-stage AI companies globally. The team has quickly expanded to nearly 100 employees, with several top researchers hired from OpenAI, DeepMind, and Meta.

Musk, whose xAI recently launched the Grok model, is competing aggressively against OpenAI and Google in the global AI race. Bezos's entry into the field intensifies the competition, adding a new battleground to their rivalry, which already spans space exploration, satellite internet, and autonomous tech.

With Project Prometheus positioned to challenge xAI and other industry leaders, the Musk-Bezos feud shows no signs of cooling—and the AI sector may be its fiercest arena yet.

# Groww Parent Billion Brains Garage Ventures Hits New High, CEO Becomes Billionaire

Billion Brains Garage Ventures, the parent company of leading stock brokerage Groww, is continuing its impressive run in the stock market, trading at a new high of Rs 168 on Monday, up 13% on the NSE. This marks the fourth consecutive day of gains since its listing last week, pushing the company's market valuation past the Rs 1 lakh crore mark.

The shares of Billion Brains Garage Ventures debuted on the NSE last Wednesday at Rs 112, a 12% premium over the issue price of Rs 100, closing the day at Rs 128.85. Since listing, the stock has surged nearly 46%, reflecting strong investor demand. The initial public offering (IPO), which closed on November 4, raised Rs 6,632 crore, with a price band set at Rs 95-100 and a total subscription of 17.6 times.

Founded in 2016, Groww has grown to become India's largest stock broker with a



market share of over 26% as of June 2025. The company's strong growth trajectory and robust listing performance underscore its dominance in the retail investment space.

With the rise in

Groww's stock price, CEO and co-founder Lalit Keshri has officially joined the ranks of billionaires. Hailing from a small village called Lipa in Madhya Pradesh, Lalit holds a

9.06% stake in the company, amounting to 55.91 crore shares. At the current share price of Rs 169, his holdings are valued at around Rs 9,448 crore, surpassing the \$1 billion mark.

An IIT Bombay alumnus, Lalit began

his career at Flipkart before co-founding Groww in 2016. His journey from a farmer's son to a billionaire entrepreneur is being celebrated as a remarkable success story in India's startup ecosystem.

The company's continued market momentum highlights growing investor confidence in digital brokerage platforms and the broader retail investment sector in India.

## India's Q2 GDP Likely to Soar Above 7.5% on GST-Led Festive Sales: SBI



SBI's analysis noted that the upbeat performance in the second quarter reflects a combination of pent-up demand, festive purchases, and improved rural consumption. The report also pointed to continued resilience in manufacturing and services sectors, which have benefited from strong domestic demand.

Economists see the higher-than-expected GDP growth as an indication that the Indian economy is maintaining a robust recovery momentum despite global uncertainties. The GST rate cuts, implemented earlier this year, have lowered prices for key consumer goods, thereby incentivizing spending and stimulating economic activity.

With the festive season extending into November, SBI expects that Q2 numbers could even surpass initial forecasts, marking one of the strongest quarters in recent years. Analysts will be closely watching upcoming data on industrial production, retail sales, and investment activity to gauge the sustainability of this growth trend into the latter half of the fiscal year.

India's real Gross Domestic Product (GDP) growth for the second quarter (July to September) is expected to rise to 7.5% or higher, driven by a surge in consumption following the recent Goods & Services Tax (GST) rate cuts, ac-

cording to a report by the research department of State Bank of India (SBI).

The SBI report highlighted that the GST reduction has spurred festive season sales, boosting consumer spending across sectors such as auto-

mobiles, electronics, and consumer goods. This increase in domestic consumption is likely to be a major driver of economic growth for the quarter.

The Reserve Bank of India (RBI), in its recent projec-

tions, had estimated Q2 GDP growth at 7%, slightly lower than the revised forecast by SBI. The central bank had cited moderating inflation and steady private investment as factors supporting sustained economic expansion.

## SBI Shares Near Record High After 286% Five-Year Surge



Analysts remain bullish on SBI shares, citing both its robust fundamentals and potential for further gains. Phillip Capital has maintained a "Buy" rating on the stock with a revised target price of ₹1,100, indicating room for upside from current

levels. Market participants note that the stock may face resistance near ₹1,000, but the broader trend remains positive.

SBI has also been in focus due to reports of potential consolidation

among public-sector banks (PSBs). Bloomberg News reported on November 14 that SBI Chairman Challa Sreenivasulu Setty suggested that "some further rationalisation might make sense."





## Gold, Silver Prices Decline Amid Market Correction



Gold and silver prices fell on Monday, continuing a brief correction after recent upward trends. In Mumbai, 24-carat gold was trading at Rs 1,24,970 per 10 grams, while 22-carat gold was priced at Rs 1,14,700 per 10 grams. Silver also witnessed a sharp drop of Rs 2,000, bringing prices to Rs 1,67,000 per kilogram.

Global markets showed mixed signals as US spot gold rose to USD 4,070 per ounce, reflecting ongoing demand for the yellow metal as a safe-haven asset. Despite this, domestic prices were weighed down by profit-taking and short-term market adjustments.

Ponmudi R, CEO of Enrich Money, said gold and silver are attempting to stabilize after recent sharp corrections. "Price action is showing signs of support at key long-term trend levels," he noted. On the Multi Commodity Exchange (MCX), gold was hovering near Rs 1,23,450, rebounding from its

upward-sloping trendline. Analysts suggest that holding above Rs 1,23,000 is crucial to maintain the broader bullish structure, opening the possibility for an upside move toward Rs 1,24,200-Rs 1,25,000.

The decline in precious metal prices comes amid fluctuating investor sentiment, with traders balancing between safe-haven demand and short-term profit-taking. Seasonal demand from the wedding and festive period also played a role in price volatility.

Market participants are closely watching global economic cues, currency fluctuations, and domestic demand trends for further guidance. With gold and silver holding support at key levels, analysts remain cautiously optimistic about a potential rebound in the coming weeks.

Consumers and investors are advised to monitor daily rate updates, as bullion prices continue to show short-term volatility amid broader economic trends.

A Chinese biotech company has stirred global interest with claims that humans could one day live up to 150 years. Lonvi Biosciences, based in Shenzhen, says its new "longevity pill" targets ageing cells, or senescent cells, which stop dividing but trigger chronic inflammation and age-related decline.

The pill's key ingredient, Procyanidin C1 (PCC1), derived from grape seeds, reportedly extended the lifespan of mice by 9.4% in laboratory experiments. The remaining life expectancy of treated mice also increased by over 64%, prompting the company to tout the potential of cell-targeting interventions in significantly slowing ageing.

Despite the excitement, experts urge caution. While the mouse data is promising, extensive human clinical trials are essential before assessing the pill's safety or effectiveness in humans. Scientists stress that preliminary lab results cannot directly predict outcomes for people, and that ageing is a complex biological process influenced by genetics, lifestyle, and environment.

Lonvi's claims have sparked both curiosity and skepticism worldwide, highlighting the growing intersection of biotechnology, longevity research, and the human desire to extend life far beyond current limits.

While BBMP authorities regularly work to ease congestion through traffic management measures, Bengaluru's growing population and vehicle density continue to strain road infrastructure. ## Ronaldo Set for Record Sixth World Cup as Portugal Thrash Armenia 9-1



Cristiano Ronaldo is officially headed to a historic sixth FIFA World Cup, as Portugal crushed Armenia 9-1 to seal qualification for the 2026 tournament to be held in the United States, Canada and Mexico. The emphatic victory on Sunday ensured Portugal's di-

rect passage from Group F, reaffirming their dominance in the qualifiers.

Ronaldo, who has already appeared in every World Cup since 2006, is now set to become the first men's player in history to feature in six editions of the global event. The Portuguese cap-

Ronaldo's relentless at-

tacking play left Armenia struggling to cope, with the visitors leading comfortably by halftime. The second half saw the floodgates fully open, as Roberto Martínez's side pushed forward with speed, precision and clinical finishing.

With qualification now secured, Portugal turn their attention to preparing for 2026, where they hope to improve on their quarter-final exit in 2022. For Ronaldo, the tournament offers another chance to chase the one trophy that has eluded him throughout his illustrious career.

The 2026 World Cup will also mark Portugal's first under Martínez at a major finals, and expectations are high as the team blends Ronaldo's experience with a new generation of stars.

For Portugal and for football fans worldwide, Ronaldo's sixth World Cup appearance promises to be one of the defining storylines of next year's tournament.

## Mitchell Ruled Out of West Indies ODIs with Groin Injury



New Zealand all-rounder Daryl Mitchell has been sidelined for the remainder of the ODI series against the West Indies after scans confirmed a minor groin tear, the ICC reported on Tuesday. The injury requires a two-week rehabilitation period, ruling Mitchell out of the final two ODIs but keeping him in contention for the three-match Test series starting December 2.

Alcaraz aggravated the injury during the ATP Finals, where he lost to Italy's Jannik Sinner in the title clash on Sunday. Following a medical evaluation, he was advised not to compete to prevent further damage. "I have edema in my right hamstring and the medical recommendation is not to compete," Alcaraz wrote.


