
Centre Implements Four New Labour Codes Replacing 29 Old Laws

The Central Government has announced a historic decision, declaring that the four newly formulated Labour Codes, which replace 29 older and often complex labour laws, are being implemented and brought into effect immediately from Friday. Union Labour Minister Mansukh Mandaviya officially confirmed this landmark development, stating clearly, "We have notified the four Labour Codes. These have now become the laws of this country." This is a significant move marking a monumental reform in India's labour and employment landscape, fulfilling a long-pending commitment to modernize the legal framework governing workers' rights and working conditions.

The Central Government released an official statement emphasizing

that this pivotal action is expected to significantly enhance labour regulations and improve the overall welfare of workers across various sectors. Furthermore, it is projected that this simplification and consolidation of laws will substantially strengthen domestic industries by creating a more predictable and conducive legal environment for business operations. The government clarified that the core objective of these comprehensive reforms is to prepare the labour system for the rapidly evolving dynamics of the modern work environment, aligning with the broader national mission of 'Aatmanirbhar Bharat' (Self-Reliant India). Many of the country's previous labour laws were formulated during the 1930s to 1950s, a period when the economic structure and working practices were drastically different from the contemporary scenario.



The four new codes that have come into immediate effect are:
1. The Code on Wages, 2019
2. The Industrial Relations Code, 2020
3. The Code on Social Security, 2020
4. The Occupational Safety, Health and Working Conditions Code, 2020

The central government highlighted that while many countries globally have already simplified and integrated their labour laws, India continued to operate under a complicated and outdated set of 29 different old statutes, often resulting in legal complexities and implementation hurdles. The government ex-

pressed confidence that these new, integrated labour codes will effectively resolve the issues of fragmentation and obsolescence. While the parliamentary approval for the four new Labour Codes was received back in 2020, their implementation was pending as various states were yet to finalize and notify the ac-

companying rules necessary for their practical application at the state level. The central government's decision to implement them now signals a major step towards uniformity and modernization of labour governance across the nation. The government believes this reform will ensure greater compliance, better social security coverage, and improved safety standards for the entire workforce, including those in the unorganized sector.

Five Cases Filed Against iBomma Ravi For Piracy and Betting App Promotion

The police have registered a total of five cases against 'iBomma Ravi' concerning film piracy and other related illegal activities. The initial case was filed following a complaint lodged by the piracy cell, and Ravi has been arrested by the police in connection with this specific case and is currently undergoing intense interrogation. In addition to the piracy charges, a separate case has also been filed against him relating to the promotion of illegal betting applications. Furthermore, the police have registered additional cases based on formal complaints received from several film directors, indicating a broad scope of illegal activities allegedly committed by him within the entertainment ecosystem.

In an ongoing development, the Cyber Crime police have taken iBomma Ravi into custody for the second consecutive day as part of their five-day custodial interrogation period. The primary focus of the police investigation is to unearth the full scale of the operation and determine who else might be involved. Investigators are working on multiple angles, specifically questioning whether he received assistance from any accomplices, who might be operating behind the

scenes, or if he independently managed the entire piracy and promotional network. The police are determined to expose the complete operational structure, including the technical enablers and financial beneficiaries of the large-scale film piracy racket. Given the sensitive nature of the case, which directly impacts the revenues of the Telugu film industry, the police are employing advanced cyber forensic techniques to trace digital footprints, financial transactions, and communication logs to identify all individuals and entities involved in facilitating the illegal dissemination of copyrighted content. The betting app promotion charges further complicate the investigation, suggesting potential links between organized crime, illegal gambling, and film piracy, which could be part of a larger, interconnected criminal enterprise. The interrogation is crucial for dismantling the network that causes massive financial losses to filmmakers and producers. The cooperation of in-

Betting Apps Case: CID SIT Probes Actors Nidhhi Agerwal, Sreemukhi

The investigation conducted by the CID Special Investigation Team (SIT) into the high-profile case involving the promotion of illegal betting applications is gaining rapid momentum. As part of this accelerated probe, authorities on Friday questioned several prominent actors and television personalities. The celebrities summoned and interrogated by the officials today included actress Nidhhi Agerwal, anchor and actress Sreemukhi, and actress Amrutha Chowdary. According to available information, the CID officials meticulously questioned the three celebrities regarding various financial and contractual details related to their association with the illegal betting applications. The interrogation focused keenly on the specific details of



the agreements they entered into for promoting the betting apps, the exact amount of remuneration or fees they received for these endorsements, and the precise timeline, detailing the period during which they actively participated in the promotional campaigns for the illegal apps.

This round of questioning is part of a larger, ongoing investigation that has already seen several other major figures from the Telugu film and media industries being interrogated by the CID SIT. Previously, the investigating team has questioned notable personalities such as actors Rana, Vijay Deverakonda, and Prakash Raj, as well as anchor and YSR Congress Party official spokesperson Syamala, and anchor Vishnupriya, among others. The case against celebrities who promoted these illegal betting applications was registered several months ago, following mounting con-

cerns over the widespread proliferation and adverse social impact of illegal online gambling across the state. In response to the growing menace and the need for a focused, high-level inquiry into the operations of these betting apps, the state government took the initiative to establish a dedicated Special Investigation Team (SIT) under the direct supervision of the Crime Investigation Department (CID). The formation of the SIT underscores the government's commitment to thoroughly investigate the large-scale network of illegal betting operations and the role played by public figures in endorsing these unlawful platforms. The CID SIT is tasked not only with investigating the cele-

KTR Responds to Governor's Sanction, Challenges Government on Land Scams

Former Minister and Bharat Rashtra Samithi (BRS) Working President, K.T. Rama Rao (KTR), has issued a strong statement following the news that Governor Jishnu Dev Varma has sanctioned his prosecution in connection with the Formula-E car case. Responding to the development, KTR maintained that the law will take its own course. He asserted his innocence vigorously, claiming that the entire state knows there is no merit in the case and strongly challenged the current government, stating, "The government does not have the courage to arrest me." He reaffirmed his claim of innocence a hundred times over regarding the Formula-E car case and declared his readiness to undergo a Lie Detector Test to prove his truthfulness, signaling his lack of fear regarding the official investigation. KTR went on to allege that a "Joint Venture Government" is currently operating in



the state, composed of the Congress and BJP parties, claiming that such an "unlawful alliance" is unprecedented in the country's political history. He criticized the government's handling of legislators who defected from the BRS, accusing them of allowing defected MLAs to resign to avoid the political embarrassment of being disqualified on technical grounds, citing the example of Danam Nagender who will be made to resign. He further speculated that the government might be looking for "technical excuses" to protect Kadriam Srihari from disqualification.

Shifting his focus to policy, KTR launched a

scathing attack on the current Revanth Reddy government, accusing it of initiating a major "land scam." He claimed that during his ten-year tenure as a minister, he had rejected numerous requests for land conversion, even those involving significant financial offers, but the present government has now officially approved a huge land scam through a Cabinet decision. He referenced the regularization of Azamabad lands, noting that the BRS government had introduced a law for regularization with a 100% fee, or 200% if the land was in the hands of others. He alleged that the current government is attempting to hand over these lands

Maoist Movement Faces Severe Setbacks, More May Surrender

The Maoist movement, which traces its origins back four and a half decades to the erstwhile People's War group, is currently experiencing one of its most severe periods of turbulence and setbacks. The party is being severely hampered by a continuous series of encounters, where senior leaders have been killed, and high-profile surrenders, which have demoralized the rank and file. Faced with increasingly untenable conditions in Dandakaranya, the long-standing stronghold of the Maoists, several sen-

ior leaders are now abandoning their armed struggle and choosing to return to the mainstream way of life. Furthermore, reports indicate that several other key figures currently holding important positions within the party have also developed plans to leave the movement and integrate them selves into civil society. This decisive shift is perceived to be the result of a collective realization within the party that, given the relentless pressure and difficult circumstances they have been facing for some time, there is very little realistic chance of the movement achieving any significant forward momentum. This

sense of despair was dramatically intensified following the encounter death of the party's General Secretary, Basavaraj, in the core of Abujhmad on May 21st.

The current year has proven particularly devastating for the Maoist leadership. The party has suffered the deaths of several Central Committee members, including Chalapathi, Balakrishna, Ganesh, Katta Ramachandra Reddy, Kadari Satyanarayana Reddy, and Hidma. Simultaneously, other senior leaders such as Mallajula Venugopal and Ashanna have chosen to surrender to the authorities. Separately, leaders like Chandranna and Bandi Prakash have ab-

andoned the armed path due to severe health issues and rejoined the mainstream, collectively dealing a near-irreversible blow to the party's organizational structure and morale. Against this backdrop, intelligence suggests that two senior key leaders, four members of the Telangana State

Committee, and dozens of party cadres have finalized a plan to surrender and join the mainstream under the supervision of the Telangana Police. Reports indicate that the State Committee members are already under police observation, and there is a high likelihood that they will be presented before the media soon. The Telangana Special Intelligence Branch (SIB) is reportedly deeply engaged in strategizing the execution of this massive surrender operation.

The SIB is also intensely focused on tracing three other senior leaders from Telangana who are currently serving on the Central Committee. Pas-



unuri Narahari alias Santosh, who hails from Hanumakonda, is the in-charge of the Bihar-Jharkhand Special Area Committee (BJSAC), while Paka Hanumanthu alias Ookey Ganesh from Pullmla in Nalgonda district's Chandur mandal, guides the South Regional Bureau. Narahari is operating in the Giridih area of Jharkhand, and Hanumanthu in the Kandhamal region of Odisha, according to Telangana intelligence. Recent efforts by Hanumanthu's family to meet and convince him to surrender in Kandhamal failed. While the Telangana State Committee is opting for surrender, there remains uncertainty regarding the where-

The Telangana Government, through the General Administration (SPLB) Department, has issued a formal order, G.O.Rt.No.16 32, dated 21. 11.2025, notifying the transfer and posting of 32 Indian Police Service (IPS) officers across various key roles and jurisdictions within the state. This comprehensive reshuffle affects officers ranging from the rank of Additional Director General of Police (ADGP) to Assistant Superintendent of Police (ASP) and newly-promoted officers waiting for postings. The move is aimed at re-energizing the administrative and security apparatus, filling crucial

vacancies, and aligning the policing strategy with the government's priorities. The large-scale transfers cover postings in city commissions, district headquarters, specialized units like CID and the Anti-Narcotics Bureau, and training institutions.

A notable transfer is that of Sri Devendra Singh Chauhan, IPS (1997), the current Additional Director General of Police (Admn), Hyderabad City, and in-charge Joint Commissioner of Police, TGC. She is now posted as the Deputy Inspector General of Police (DIG), CID, in Hyderabad, a crucial role in criminal investigations.

The reshuffle also sees several officers moving between district and city postings. Sri K. Narayana Reddy, IPS (2013), Superintendent of Police (SP) of Vikarabad, has been transferred and posted as the Deputy Commissioner of Police (DCP), Maheshwaranagar Zone, Rachakonda. In a reciprocal move, Ms. Sneha Mehra, IPS (2018), who was the DCP, South Zone, Hyderabad City, is transferred and appointed as the SP, Vikarabad, filling the vacancy created by Sri Reddy's move. Dr. Patil Sangram Singh Ganapathrao, IPS (2015), SP, CID, has been posted as the SP, Nagarkurnool District, replacing Sri Gajkwad Vaibhav Raghu, IPS (2018).

The Telangana Anti-Narcotics Bureau (TAN

B) also sees changes in its leadership. Sri Chenuri Rupesh, IPS (2017), SP, TG Anti-Narcotics Bureau, is now posted as the DCP, SM&IT, Hyderabad City. Replacing him at the Anti-Narcotics Bureau is Sri R. Giridhar, IPS (2017), who was previously the SP of Wanaparthy District. Smt. P.V. Padmaja, IPS (2013), DCP, Malkajgiri, Rachakonda, is transferred to the TANB as the Superintendent of Police (Admn). The transfers also involve a large group of junior officers from the 2020 to 2023 batches, including those serving as Sub-Divisional Police Officers (SDPOs) and those from the Greyhounds special forces, who are being posted to new roles as

Additional Superintendents of Police (Addl. SPs) or ASPs in various districts, including Adilabad, Bhongir, Jagital, Mulugu, and Eturunagaram, reflecting the government's investment in strengthening policing at the grassroots level. The order also includes the first postings for three officers who were waiting for placement, including Ms. D. Sunitha, IPS, who is now posted as SP, Wanaparthy, and Sri S. Sreenivas, IPS, who is posted as SP, TG TRA NSCO. The order was issued by K. Ramakrishna Rao, the Chief Secretary to the Government, marking a significant administrative action in the state's police hierarchy.



Deputy CM Outlines Vision 2047 Focus at JNTU Diamond Jubilee

Deputy Chief Minister Bhatti Vikramarka Mallu declared that Telangana must become a Global Growth Engine, asserting that JNTU will be the essential engine that drives this transformation.

The Deputy CM acknowledged JNTU's consistent partnership with the state, particularly in conducting entrance exams with integrity, guiding its affiliated colleges, and supporting the government's innovation mission. He pointed out the vast scale of the institution, with 215 colleges and 3.5 lakh students belonging to the JNTU family. Shifting focus to Educational Reforms in Telangana, he stated that under CM Revanth Reddy's leadership, work is underway to restore trust, transparency, and dignity in recruitment exams. Technical education is undergoing modernization through the establishment of the Young India Skills University, and 65 ITIs have already been upgraded to Advanced Technology Centres, with all 104 set to be transformed soon. He also announced the establishment of a Bharat Skill University equivalent to JNTU. Mallu emphasized that "Education is not a cost – it is an investment in the future."

Addressing specific university needs, he assured that all legitimate demands of JNTU—including the resolution of land lease issues, exemption from lease rent and property tax, and the request for 800 crore for infrastructure renewal—will be positively considered by the government.

He provided a strong message to students, urging them to pursue curiosity and innovation beyond mere marks, and to focus on becoming job creators, not just job seekers. He highlighted India's potential to reach over 1,000 unicorn startups by 2027 and stated that Telangana is prepared to lead this revolution. He cautioned students against distractions, advising them, "If your screen time is higher than your study time, your degree is in danger," urging them to

Minister Vows 1,000 Cr for Handloom Sector and Inaugurates IIHT Lab

Telangana Handlooms and Textiles Minister Tummalai Nageswara Rao announced his commitment to developing the Indian Institute of Handloom Technology (IIHT) in Telangana to a standard capable of competing globally. He made this declaration on Friday while inaugurating the institution's laboratory at the Nampally Handloom Bhavan.

During his address, Minister Tummalai recalled that the IIHT for the undivided state was previously located at Venkatagiri. He credited Chief Minister A. Revanth Reddy for successfully negotiating with the central government after the state's bifurcation to secure the IIHT's establishment within Telangana, thereby ensuring benefits for the state's handloom sector. To honour the respected leader, Konda Laxman Bapuji, the IIHT has been named after him. Minister Tummalai directed officials to ensure

that the Konda Laxman Bapuji IIHT achieves a reputation as one of the finest institutes in the country, thereby further enhancing the former leader's legacy.

Minister Tummalai expressed confidence that under the visionary leadership of CM Revanth Reddy, the handloom sector is set to experience a golden era of progress. He highlighted a significant financial commitment made by the current administration, stating that a substantial sum of 1,000 crore has been released for the handloom sector within just one and a half years of the government taking office. He contrasted this with the previous government, which he accused of hastily launching schemes for political gain only to abandon them later. He confirmed that the 'Indira Mahila Shakti' saree order has effectively provided a continuous stream of work for handloom workers, ensuring their hands are full and eliminating the need for them

to search for work. This is a crucial step towards stabilizing the livelihoods of thousands of weavers.

Further supporting the sector, he mentioned the establishment of a Yarn Depot at Vemulawada with an investment of 50 crore, through which 2,368 metric tonnes of yarn have already been supplied to power loom societies. Additionally, the government is implementing the 'Nethanna Abhayastham' scheme with an allocation of 168 crore, encompassing the 'Nethanna Podupu' (weavers' savings) and 'Nethanna Bharosa' (weavers' assurance) sub-schemes. Under these programs, 304 crore has been released for handloom workers' savings and 68 crore for power loom workers' savings. The government has also settled pending dues of 40 crore under the yarn subsidy scheme for power loom workers. Moreover, personal loans amounting to 33 crore for handloom workers have been waived, pro-

viding significant financial relief.

Regarding the flagship 'Indira Mahila Shakti' saree distribution, Minister Tummalai detailed the massive scale of the program, stating that 65 lakh sarees are being distributed in rural areas and 35 lakh sarees in urban areas, totalling one crore sarees. CM Revanth Reddy is overseeing this distribution as a 'Puttiinti Kanuka' (gift from the maternal home). Minister Tummalai concluded by emphasizing that the handloom sector stands as a proud symbol reflecting India's culture and traditions, and that the "People's Government," led by CM Revanth Reddy, is resolutely working with the core objective of ensuring the happiness and prosperity of both the farmer (Raitanna) and the weaver (Nethanna). The event was attended by Principal Secretary of Handlooms and Textiles, Smt. Shailaja Ramaiyari, and other senior officials.

KTR Demands Immediate Withdrawal of HILTP, Alleges Rs 5 Lakh Crore Land Scam

BRS Working President K.T. Rama Rao (KTR) on Friday strongly criticized the Congress-led Telangana government's newly announced Hyderabad Industrial Lands Transformation Policy (HILTP), labeling it as a mechanism for what he termed "India's biggest land scam" and demanding its immediate withdrawal. KTR alleged that the policy, which aims to convert industrial lands located inside the Outer Ring Road (ORR) into multi-use zones, could result in a massive loss of up to 5 lakh crore to the state's exchequer. Speaking to reporters in Hyderabad, KTR directly accused Chief Minister Revanth Reddy of attempting to transfer thousands of acres of highly valuable industrial land into lucrative real estate assets at "throwaway rates." He claimed this was primarily for the direct benefit of "politically connected middlemen, relatives, and specific real estate groups." The BRS leader contended that the policy, which the government markets as a transformation and regularization initiative, is, in reality,

"a blueprint for a 5 lakh crore scam." He specified that the HILTP seeks to regularize nearly 9,292 acres of prime industrial clusters located in key areas like Balanagar, Jeedimetla, Sanathnagar, and D Azamabad.

KTR presented his calculation, estimating the open-market value of these lands at between 40 crore and 50 crore per acre, which places their total cumulative value between 4 lakh crore and 5 lakh crore. He claimed that at Chief Minister Revanth Reddy is attempting to hand over these lands for just 30 per cent of the outdated Statutory Register Office (SRO) rate, a rate which he further alleged is "four to five times lower than the actual market value." The BRS leader expressed strong skepticism about the "unusual haste" exhibited in implementing the HILTP, pointing specifically to the policy's provisions, which include a remarkably short 7-day application window, a 7-day approval period, and the entire process of full regularization being completed within just 45 days. KTR firmly alleged that "pre-arranged deals" had already been finalized eve-

along the Musi riverbed, key Metro Rail corridor, and University of Hyderabad lands. He concluded with a personal attack, claiming that Revanth Reddy's only true vision is "real estate" and that the Chief Minister is "surrounded by land dealers." The BRS leader issued a stern warning to industries and developers, advising them against participating in any transactions under HILTP, asserting that any such deals would inevitably face intense legal scrutiny in the near future. He promised that a future BRS government would decisively reverse the policy, legally recover the land, and initiate strict criminal proceedings against all those involved. He suggested that the state should reclaim 50 per cent of the land for public use and auction the remaining plots, following the best practices of other metropolitan cities, in order to maximize revenue for the state. He further challenged the opposition BJP to actively oppose the policy and urged all citizens to remain highly alert to what he described as the "daylight robbery of Telangana's public assets

Sridhar Babu Rejects KTR's Claims on HILTP Policy as Misinformation

Telangana Minister Sridhar Babu held a press meet at the Secretariat to counter the allegations made by BRS Working President K.T. Rama Rao (KTR), accusing the previous BRS government of financial anarchy and stating that KTR's mindset remains unchanged. The Minister strongly refuted KTR's claims regarding the Hyderabad Industrial Lands Transformation Policy (HILTP), characterizing them as "untruths" and "misinformation." Sridhar Babu clarified that the policy, which KTR is aggressively campaigning against, is based on Government Orders (GOs) that were initially introduced by the previous BRS government itself to convert leased industrial lands into free-hold properties. The Minister asserted that the current Congress government is merely attempting to implement an impact fee on the free-hold lands, an initiative that was not properly executed by the BRS regime.

Sridhar Babu specifically addressed KTR's major allegation that the government is handing over land for only 30% of its value. The Minister clarified that the "30 per cent" KTR mentioned is not the land's value, but rather the conversion fee required to change the



land status. He accused KTR of deliberately making misleading comments and creating a political link between the conversion fee and the total land value, which are two separate concepts. He termed KTR's comments as "unjust" and noted that only the BRS party is capable of speaking such "untruthful words." He pointed out the hypocrisy, stating that the previous BRS government itself carried out numerous land conversions during its tenure. Sridhar Babu accused BRS leaders of actively resorting to threats and intimidation tactics, which he believes are aimed at preventing potential investments from coming into the state. He defended the HILTP, stating clearly that only those who genuinely wish to retain their industries and convert their land will apply under the policy.

Responding to KTR's allegations about pre-arranged deals with politically connected individuals, the Minister challenged KTR to provide proof. He declared that no individual mentioned by KTR is currently part of the government, and if KTR could prove that any person with the alleged name has entered into a Memorandum of Understanding (MOU) with the government regarding the land, the administration would take immediate action. He advised KTR to refrain from making "baseless allegations" without providing concrete evi-

Congress Hits Back at KTR, Claims BRS Leader Has 'Lost His Mind' After Jubilee Hills Loss

MLC Dr. Balmoor Venkat held a press meet at Gandhi Bhawan to strongly counter K.T. Rama Rao's (KTR) recent statements, suggesting that the BRS leader has "lost his mind" following the party's defeat in the Jubilee Hills constituency. Venkat criticized KTR's style of speaking, comparing him to the fictional character Pulakeshi (known for irrational behavior). The MLC clarified the legal procedure regarding the investigation of public officials, stating that the state government is proceeding strictly according to the law by seeking necessary permissions, such as the Governor's approval to investigate an MLA and the De-

partment of Personnel and Training's (DOPT) permission to investigate IAS officers. He asserted that KTR's reckless statements are not a valid answer to the serious allegations he faces. Instead of diverting the issue and making counter-allegations against Chief Minister Revanth Reddy, Venkat demanded that KTR directly address the accusations brought against him.

Venkat reminded KTR of his overconfident political claims during the Jubilee Hills election, where KTR had framed the contest as a battle between the "car" (BRS symbol) and the "bulldozer." The MLC asked KTR what happened to that prediction, accusing the Jubilee Hills electorate of re-

jecting the BRS party. Venkat used strong language, stating that KTR is speaking "shamelessly" despite the defeat. He further admonished KTR for invoking the Lie Detector Test when questioned about the Formula-E case, challenging him to hold a press meet and provide clear public clarification on the accusations he faces if he has the courage. Venkat presented two options to KTR: either clarify the allegations or simply admit that "as Minister, I did everything, and the officials only acted on my instructions." The MLC warned that the public is closely observing the discrepancy between KTR's statements in the ACB (Anti-Corruption Bureau) investigation and his public comm

ents. Venkat stated that KTR and Harish Rao are primarily responsible for answering the serious allegations recently made by their party colleague, K. Kavitha, a reference to internal BRS disputes. He warned KTR that if he does not change his behavior, the BRS might not even secure the deposit amount in the upcoming general elections, unlike the small win he achieved in Jubilee Hills. Venkat escalated the warning, cautioning KTR that if the situation continues, he might have to flee to America again. He challenged KTR and the Leader of the Opposition, K. Chandrashekhar Rao (KCR), to initiate a discussion in the Assembly on the two years of the Congress pa-

BRS Slams Formula-E Case, Calls Governor Sanction a Political Witch-Hunt

BRS leader and former MLA Jeevan Reddy strongly criticized the Formula-E car race case against K.T. Rama Rao (KTR), labeling it as a "worthless case" and a "rumor of corruption" spread by the Congress party, highlighting the government's failure to defeat KTR in the public arena. He adamantly stated that KTR is and will remain as pure as a "washed pearl," a truth that time will prove. Speaking at a press conference in the BRS party office in Nizamabad city on Friday, Jeevan Reddy asserted that the Formula-E case is merely a pretense, and the real target of both the Congress and BJP is the BRS party's "car" symbol.

He accused the Congress and BJP of jointly presenting the Formula-E case as a "fictional serial," sarcastically comparing it to drawn-out television dramas like Mogalirekulu and Karthika Deepam, and claimed they are conspiring to weaken the BRS. He named Chief Minister Revanth Reddy, Kishan Reddy, Bandi Sanjay, and C.M. Ramesh as the "actors and masterminds" behind this conspiracy. Jeevan Reddy asserted that the case against KTR is the epitome of Revanth Reddy's frustration, accusing the Chief Minister of resorting to "diversion politics" due to his inability to govern effectively. He stated that the recent political process involving the Governor's sanction for KTR's prosecution is merely a "political spectacle" and a "magic act" orchestrated by the Congress-BJP alliance. He questioned the Governor's quick approval for cases against political rivals, contrasting it sharply with the delay in approving pro-people bills, such as the 42% reservation for BCs. He criticized the Governor for following the directions of "BJP bigwigs" to suppress political opponents. Jeevan Reddy openly accused the Governor's sanction of proving the "Fevicol bond" between the Congress and BJP once again.

The former MLA hailed KTR as a genuine leader who fought for the achievement of Telangana state and a "fighter son" who strived for the state's freedom. He described KTR as "Mr. Clean" in the public sphere, clarifying that KTR sought to elevate Hyderabad's brand image globally through the Formula-E event, not to loot assets for his brothers and in-laws, unlike CM Revanth Reddy. He pointed out that KTR has no criminal history of being caught trying to buy MLAs, as Revanth Reddy does, and stated KTR has not committed even "half a paisa" of corruption. Jeevan Reddy strongly condemned the government for intentionally filing a false case with the specific conspiracy to defame KTR politically and personally by branding him as corrupt. He stated that the case is an ultimate act of revenge by Revanth Reddy, asking if "people's rule" means filing false cases against those fighting for the people. He warned that the BRS family comprises "fighters," while the Congress consists of "cheaters."

BRS Alleges 340 Crore Manakin Bio Investment is Bogus and Linked to Black Money

BRS Chief Spokesperson Manne Krishank rai posed a severe question concerning the authenticity of a recently announced investment, asking how the Telangana government could announce a 340 crore investment five months ago, in June 2025, when the company in question, Manakin Bio, was only formally established just five days ago. Manne Krishank highlighted that the company, whose directors hail from Eluru, possesses a meager paid-up capi-

tal of only 1 lakh. This sharp accusation suggests the Congress government is publicizing "bogus investments." The Chief Spokesperson emphasized the beneficial outcomes brought by the BRS-era policies, citing that the progressive EV policy and robust industrial policies successfully attracted genuine investments, resulting in actual factories on the ground from reputable companies such as Bility Electric, Attero, Amara Raj, and ALLOX, which invested thousands of crores. In sharp contrast, Kris-

hank alleged that the investments announced by the new Congress government are "bogus" and exist only on paper. He cited companies like Godi India, Swachh Bio, Wals Karra, and Ursula Cluster as examples of entities with nothing tangible on the ground. The most recent and damning example, according to the BRS, is the 340 crore investment announced for Manakin Bio. Krishank highlighted the highly unusual timeline: the investment was announced by the state government in June 2025, but the com-

pany was registered with the Ministry of Corporate Affairs only on November 12, 2025. This, he argued, represents an extremely rare incident of announcing a massive investment before the company was even legally registered. He pointed out that the company's paid-up capital is an insignificant 1 lakh, and its only two directors are Yathirajam Madhushesh and Yathirajam Anusooja, both from Eluru. Krishank stated clearly that the announcement of 340 crores under such dubious circumstances is

HYDRAA Saves 700 Crore Government Land in Kondapur from Encroachers

The HYDRAA has successfully intervened to safeguard approximately four acres of prime government land in Konda pur of Serilingampally Mandal, Rangareddy Dis trict, halting attempts by po werful individuals to illegally encroach upon it. This land, originally earmarked for public utili ties and parks, is valued at an estimated 700 cro re, with property rates in

the area reaching up to 200 crore per acre. HYDRAA acted decisively by erecting a fence around the four acres and installing official signboards designating the areas as park lands, putting a clear check on the activities of the land grabbers. The core issue traces back to the 1980s, when the Sri Venkateswara HAL Colony was developed over 57.20 acres, comprising 627 plots. During this develop

ment, specific areas were allocated for two parks (1.20 acres each), another two-acre park, and 1,000 yards for public use. Over the years, these designated public spaces became targets for encroachment, with park lands being illegally subdivided into individual plots and sold off using by-numbers.

The Sri Venkateswara HAL Residents Welfare Association had been fighting this encroachment for decades and eventually approached HYDRAA through the Prajvani grievance system, submitting all relevant documentation. Following the complaint, HYDRAA officials conducted a meticulous on-site inspection, confirming that the designated park lands had indeed been illegally converted into residential transactions.

Furthermore, they stated that subsequent purchasers, including Simha Developers, Vasavi Co

investigation revealed that a layout was created in the 1980s through a General Power of Attorney (GPA) executed by Abbineni Anasuya and others to YBK Rao. The buyers of the subsequent plots and constructed buildings had even managed to regularize their properties through LRS and BRS schemes. Specifically, the 1.20-acre park was illegally split into three parts and sold as 11 plots. Other park areas were similarly partitioned and sold using by-numbers to multiple parties. The Association representatives informed HYDRAA that Non-Resident Indians (NRIs) were frequently targeted as buyers in these fraudulent transactions.

Two Killed, Five Injured in Car Collision Near Rangareddy

Two people lost their lives and five were injured in a tragic road accident on Friday morning near Kankamamidi, which falls under the Moinabad police station limits in Rangareddy district. The accident involved a severe collision between two cars on the highway. A police officer confirmed the details, stating that the incident occurred early in the morning. Immediately after the collision was reported, the police rushed to the scene to manage the situation and provide assistance. Their initial action involved promptly shifting the injured individuals to a local hospital for urgent medical attention. Simultaneously, the bodies of the deceased were transported to the police mortuary (PME) for post-mortem examination. According to an official statement, the collision occurred at approximately 7:30 a.m. on Friday. The officer confirmed that two individuals were killed and five sustained injuries in the impact. The police have taken necessary legal action by registering a formal case concerning the accident. A thorough investigation is currently underway to determine the exact circumstances, the primary cause of the col



ision, and to identify any potential negligence that might have contributed to the tragic outcome. The investigation will examine factors such as speed, driving behavior, road conditions, and adherence to traffic rules by the drivers of both vehicles involved.

In a separate, though similar, incident earlier on Thursday, a major disaster was narrowly averted on the Hyderabad-Bengaluru National Highway (NH 44) near Macharam in Jachherla mandal, Mahabubnagar district, Telangana. In this incident, a passenger bus carrying an estimated 32 to 45 passengers collided with a tanker carrying chemicals. Fortunately, all passengers and the bus crew had a narrow escape, with no casualties reported. The collision, which occurred early in the morning, caused a leak of hydraulic acid from the

container, creating a large, visible plume of smoke. The police confirmed that two fire tenders were immediately dispatched to the scene, and they successfully controlled the smoke and mitigated the chemical hazard. A Jachherla police official confirmed that the collision involved a private travel bus and a tanker carrying the acid, both of which were traveling from Kurnool towards Hyderabad. The quick response of the fire department and police ensured that the chemical spill was contained and all passengers were safely evacuated, preventing a much larger disaster involving hazardous materials. The series of accidents underscores the need for increased road safety measures and stricter enforcement of traffic laws on major national highways in the region.

41 Liquor Bottles Seized, Two Booked for Non-Duty Paid Smuggling

The STF-A Team, led by Excise Superintendent Anji Reddy and his staff, successfully confiscated a total of 41 bottles of liquor during a road inspection operation. The seizure was made on Friday as the liquor was being transported without the necessary permits. The confiscated alcohol was identified as NDPL (Non-Duty Paid Liquor), which had been illegally brought into Telangana State via airline routes from other states, specifically Goa and Delhi. The specialized team carried out detailed vehicle inspections on the road, a tactic which led to the interception and eventual seizure of the illicit consignment.

The liquor, which was being illegally brought in from other states without any requisite permits or payment of state excise duties, was formally handed over to the Sarnoor Nagar Excise Station. Superintendent Anji Reddy confirmed the details of the operation, including the seizure and the subsequent legal action taken by the department. He further stated that a case has been registered against two individuals involved in the illegal transport and smuggling of the

non-duty paid liquor. The operation highlights the ongoing efforts by the Excise Department and the Special Task Force (STF) to curb the illegal trade of alcohol, which results in significant revenue loss for the state and undermines legitimate businesses. Smuggling liquor from states like Goa and Delhi, where prices or taxes may be lower, is a common route for illicit trade, and the use of air travel followed by road transport suggests an organized network is involved in moving the goods. The use of Non-Duty Paid Liquor typically indicates evasion of local taxes, making the goods illegal for sale or distribution within the state. The Excise Department's focus on these types of inter-state smuggling cases is a critical part of its mandate to enforce excise laws and protect state revenues. The investigation will now focus on identifying the source of the liquor in Goa and Delhi, the network of smugglers operating between the states, and the intended destination and distribution chain within Telangana. The two booked individuals are likely facing charges under relevant sections of the Telangana Excise Act.

Rachakonda CP Reviews Security for Telangana Rising Global Summit

Treasure Hunt Drama Unfolds in Mangapet

A sensational incident involving the digging for hidden treasures has come to light, with the news slowly emerging from the Mangapet Mandal in Mulugu District. The issue of Gupta Nidhulu (hidden treasure) digging has caused a stir not only in Telangana but also in the neighboring state of Maharashtra. The entire episode came into focus after a video allegedly showing the digging activities began to circulate and go viral on social media platforms.

The details that emerged point to an operation involving four individuals who are residents of the Mangapet Mandal. These four individuals were reportedly engaged in digging for hidden treasure on the premises of a house near Sirivancha in Maharashtra.

According to the local rumors and unconfirmed reports, the group successfully unearthed a hidden treasure from the site in Maharashtra and subsequently transported it back to their native village in Mulugu District, where

they allegedly buried it again. The entire affair came tumbling out into the open when a dispute arose over the sharing and division of the unearthed treasure among the four members of the group. The internal conflict led to the information being leaked, catching the attention of local authorities.

The police have now stepped in and are actively investigating the matter. Following the directives of the District SP Shabarish, an investigation has been launched into the allegations of illegal treasure dig-

ging. The investigation will focus on confirming the exact location and nature of the digging, whether any treasure was indeed found, and the veracity of the viral video. Crucially, the police will also investigate the inter-state dimension of the activity, as the initial digging reportedly took place in Maharashtra before the supposed treasure was brought to Telangana. Illegal treasure hunting often involves trespassing, property damage, and violation of archaeological and historical preservation laws, which

the police will be looking to enforce. The spread of the video and the subsequent rumors have caused considerable excitement and anxiety in the area, highlighting the enduring belief in hidden wealth in certain rural regions. The involvement of the District SP indicates the gravity with which the authorities are treating this case, ensuring a thorough investigation into the claims and the actions of the four individuals involved in the highly secretive and now public affair. Major Ganja Seizure in Khammam: 30.5 Kg Confiscated, Three Arrested

The Khammam Enforcement staff, led by CI Srinivas, achieved a significant breakthrough in the crackdown on drug trafficking by successfully intercepting and seizing a large quantity of Ganja (cannabis). The operation took place near Rallavagu in the Adlapuram Municipality. The Excise staff noticed three individuals acting suspiciously, carrying sacks near the location. Upon approaching and inspecting the sacks, the enforcement team confirmed the presence of Ganja and immediately took the three individuals into custody.

Following the arrest, the seized narcotic substance was weighed. The Assistant Commissioner, G. Ganesh, confirmed that the total weight of the confiscated Ganja amounted to 30.5 kilograms. The estimated



market value of the seized drugs is approximately 16 lakh. CI Srinivas revealed that the drug consignment was being transported from Odisha and was destined for Maharashtra. The three arrested individuals were identified as residents of Maharashtra: Rahul Ashok Anwal, Sanket Bala Saheb Lodwal, and Harichandra Kishore Lonkar. All three were arrested on the spot and subsequently handed over to the Khammam Two Town Excise Station for further legal proceedings and investigation.

The successful operation highlights the continuous and inter-state nature of drug smuggling routes, with Khammam often serving as a transit point for narcotics moving from the source areas in Odisha towards consumption centers in states like Maharashtra. The Enforcement Department's vigilance in pa-

trolling and surveillance was key to the seizure. The enforcement team involved in the apprehension included CI Srinivas, along with staff members Sudheer, Venkat, Vijaykumar, Hanumanth Rao, Upender, and Veerababu. The team's successful effort was recognized and commended by high-ranking officials.

The Director of Enforcement, Shanawaz Qasim, Khammam Deputy Commissioner Janardhan Reddy, Assistant Commissioner Ganesh, and Excise Superintendent Tirupati all offered their congratulations to CI Srinivas and his team for their commendable work in curbing the drug trade. The

The incident occurred on Thursday night. According to reports, the Tanda residents were arguing with Ramaswamy, and his wife approached Mo-

hammad, requesting him to mediate and send the group away, suggesting they could discuss the matter the next morning.

Mohammad acted as a peacemaker, asking the group why they were quarreling so late at night and advising them to return in the morning. Instead of heeding his advice, the group turned on him, angrily challenging him, saying they would "advise" him on why they were fighting. They then forcibly put Mohammad on a bike and took him to the outskirts of Anantagiri Palli. Before reaching the location, they had apparently informed other Tanda residents. A car arrived at the spot carrying five



Modi's G20 Defiance: Why The Global South Is Done Waiting For America



Prime Minister Narendra Modi arrived in Johannesburg for the first G20 summit held on African soil, signaling a strong message that multilateralism cannot be stalled by one nation's absence. While former US President Donald Trump boycotted the summit over unverified claims about South African farmers, Modi's attendance underscored that global challenges cannot wait for American approval.

Trump's boycott reflects a broader retreat from multilateralism. Since returning to office, his administration has exited the Paris Climate Agreement, UNE-

SCO, and WHO, and reviewed other global treaties with the intention of abandoning them. In contrast, the Johannesburg summit has proceeded effectively, demonstrating that multilateral cooperation is possible without US participation.

South African President Cyril Ramaphosa insisted on a joint declaration despite Washington's pressure, reinforcing that smaller or emerging economies will not be coerced into weakening their agendas. Leaders from France, Germany, the UK, Brazil, China, Russia, and other major economies actively engaged in discussions on

debt relief for developing countries, climate finance, disaster resilience, and inequality reduction, showcasing the summit's continued relevance.

Modi's leadership during India's 2023 G20 presidency strengthened the voice of the Global South by securing the African Union's permanent membership, representing 55 African nations and expanding the G20's global representation to 80 percent of the world population. This move amplified previously marginalized perspectives in global economic governance.

India's presidency also achieved consensus on the New Delhi Leaders' Decla-

ration, covering development, climate action, digital infrastructure, and multilateral reforms. South Africa's current presidency continues this legacy, prioritizing debt sustainability, climate finance, disaster risk reduction, and critical minerals governance—issues vital to developing nations disproportionately affected by global crises.

Modi's presence in Johannesburg highlights India's commitment to bridging North-South divides and ensuring that global forums address real-world challenges rather than political posturing. By contrast, the US absence illus-

trates a growing divergence in priorities between the Global South and traditional Western powers.

The summit demonstrates that multilateralism does not depend on a single country. India's active role affirms the rising influence of developing nations in shaping global agendas, while America's retreat signals a potential long-term decline in its unilateral influence within international institutions. The Johannesburg G20 reinforces a multipolar reality where global cooperation continues despite geopolitical tensions.

As India accelerates its 'Make in India' and self-reliance initiatives, experts are calling for a comprehensive Atmanirbharta (self-reliance) Index to measure, assess, and incentivize domestic industry and innovation at the company level.

India's Atmanirbharta Bharat mission has prioritized indigenous production, technological independence, and innovation, but current metrics—primarily trade-based—fail to capture the full picture. A multidimensional index would provide granular insights into which companies are driving true self-reliance, highlight best practices, and identify areas needing policy intervention.

Unlike previous sector-level indices, the proposed framework would focus on company-specific performance, enabling targeted strategies rather than one-size-fits-all solutions. This could foster healthy competition, pushing firms to strengthen local capabilities while remaining globally competitive.

Key pillars of the proposed index include:

Technology Independence: Measures domestic R&D investment, patent ownership, and adoption of locally developed technologies. Companies collaborating with Indian research institutions or creating proprietary intellectual property would score higher.

Supply Chain Resilience: Evaluates local sourcing, contingency planning, and the ability to withstand global disruptions. Resilient firms can

maintain operations even amid international market volatility. International Competitiveness: Rewards companies that export, innovate, and adhere to global standards, ensuring India produces not just substitutes but products that succeed globally.

A suggested scoring system could allocate 40 points for technology independence, and 30 each for supply chain resilience and global competitiveness. Data could be sourced from audited reports, industry databases, and verified company submissions. Annual publication of scores via a national Atmanirbharta Dashboard would offer transparency, drive accountability, and encourage firms to enhance performance.

Linking index performance with policy incentives—such as access to Production-Linked Incentive (PLI) schemes, tax benefits, or government procurement priority—could transform self-reliance from a policy aspiration into actionable business strategy. Firms investing in local technology, reducing import dependence, or boosting exports would gain tangible advantages, promoting long-term capability building over short-term cost-cutting.

The Atmanirbharta Index, by quantifying self-reliance and rewarding innovation, could serve as a strategic compass for India's industrial future, helping the country move towards enhanced autonomy, global competitiveness, and sustainable growth.

Why Freebies Alone Don't Decide Bihar Elections



Patna: The Bihar Assembly elections have reignited discussions on the role of freebies in shaping voter behavior, raising questions about whether such incentives alone can secure electoral victory. While promises of free electricity, subsidized food, household goods, and other largesse are a familiar feature in Indian politics, analysts argue that they are no longer a guaranteed route to power.

Freebies have a long-standing history across Indian states. The Aam Aadmi Party (AAP) in Delhi captured attention with free bus rides and subsidies for water and electricity. In Tamil Nadu, both the DMK and AIADMK have offered items like TVs, laptops, and mobile phones during elections. Free power to farmers has been a consistent promise in multiple states. Bihar, too, witnessed a barrage of assurances during its recent polls, continuing this tra-

dition of populist measures.

Yet, experts caution that such incentives cannot substitute for effective governance, social development, and economic opportunities. Bihar's economy, though growing rapidly, does so from a low base. The state faces deep structural challenges, including low per capita income, high unemployment, and limited industrialisation. Voters are increasingly aware that one-time perks do not address long-term concerns such as education, healthcare, job creation, and infrastructure development.

In conclusion, while freebies remain a tactical tool in election campaigns, Bihar's experience underscores that long-term development, governance quality, and social welfare play a more decisive role in shaping electoral outcomes. Politicians seeking durable support must balance immediate incentives with policies that address the structural and socio-economic needs of the population.

Delhi's Toxic Air: A Public Health Emergency



Delhi's air pollution has reached crisis proportions, severely affecting the health and well-being of its residents. Scientists estimate that prolonged exposure to toxic air in the capital shortens life expectancy by nearly a decade, with children and vulnerable populations bearing the heaviest burden.

Recent data reveals the gravity of the situation: in 2023 alone, ambient particulate matter accounted for over 17,000 deaths in Delhi, roughly one in seven. Fine particles, particularly PM2.5, penetrate deep into the lungs, enter the bloodstream, and trigger inflammation, increasing the risk of chronic obstructive pulmonary disease (COPD), asthma, cardio-

vascular ailments, stroke, lung cancer, and even neurological disorders. For children, exposure is linked to developmental delays, lower academic performance, and early cognitive decline.

Surveys indicate that 62% of families report burning eyes, 46% nasal congestion, 31% breathing difficulties, and 15% sleep problems—all pollution-related.

The causes are well-known and recurring: vehicular emissions, construction dust, industrial pollution, biomass burning, and crop residue burning in neighbouring states. Seasonal temperature inversions trap pollutants close to the ground, turning Delhi into a "bowl of stagnation." Despite this clarity,

long-term systemic solutions remain elusive. Temporary fixes are deployed annually, but they fail to address the root causes.

Experts argue that tackling Delhi's air crisis requires coordinated, inter-state action involving Delhi, Punjab, Haryana, Uttar Pradesh, and Rajasthan. The central government must lead with a time-bound action plan, measurable targets, regular audits, penalties for non-compliance, judicial oversight, and the full-time involvement of environmental experts.

Strengthening emission controls, transport reforms, crop-burning mitigation, and urban green infrastructure are essential, yet fragmented state-level efforts cannot suffice.

The crisis is compounded by political finger-pointing. Governments alternately blame each other, while citizens continue to suffer. Delhi's residents should not have to endure polluted air as a fact of life. Instead, collective, conscious, and courageous action from both administrators and policymakers is needed.

The capital has the potential to become a model for air-quality management, demonstrating that even the most entrenched smog can be dispelled.

Breathing clean air should not be a privilege—it is a fundamental right. The question is no longer why Delhi suffers, but why society tolerates it. Immediate systemic reform is the only path forward.

DK Shivakumar Loyalists Push for CM Change in Karnataka

The political drama in Karnataka escalated Friday as Ramanagara MLA Iqbal Hussain, a staunch supporter of DK Shivakumar (DKS), claimed that Congress chief Mallikarjun Kharge offered "assurance" regarding the party's internal Chief Minister debate. Hussain said Kharge sought a week's time to consult the party's high command before deciding on the leadership issue.

Hussain told NDTV that Shivakumar had played a key role in revitalising the Congress in Karnataka and deserved a chance to be Chief Minister. "DK Shivakumar has struggled and put effort to bring the party to power... we requested the high command, and Siddaramaiah, to give him a chance," Hussain said, adding that they are hopeful justice will be done.

The Shivakumar camp's push comes as Siddaramaiah completes the half-way mark of his five-year term. Reports suggest that an informal agreement might exist for Siddaramaiah to step down mid-term, although the Chief Minister has repeatedly



denied such claims, stating, "my power hasn't gone... it has only gotten stronger... I will complete my term."

The factional rivalry has split Congress lawmakers in Karnataka. The DKS camp includes Agriculture Minister N Chaluvayayam and Iqbal Hussain,

while Siddaramaiah's supporters include Home Minister G Parameshwara and Public Works Minister Satish Jarikholi. The latter group cites a 2023 letter from Congress HQ confirming Siddaramaiah's full five-year tenure.

Despite this, DKS loyalists continue lobbying in

Delhi, with at least a dozen more lawmakers expected to meet party leaders in the coming days. Hussain emphasized discipline within the party but hinted at expectations of a favorable outcome: "We have some discipline in Congress and we have to obey the high command... But

we hope we will get justice."

As Karnataka approaches a potential leadership crossroads, whispers of a mid-term transition persist, keeping both camps on edge in what observers describe as a high-stakes "Game of Thrones" within the state Congress.

Amit Shah Says Bihar Polls Mandate Against Infiltrators

Union Home Minister Amit Shah on Friday described the BJP-led NDA's resounding victory in the Bihar assembly elections as a clear mandate against infiltrators in India. Addressing the BSF Diamond Jubilee (61st Raising Day) celebrations in Bhuj, Gujarat, Shah emphasized that citizens do not support parties that advocate for or protect illegal immigrants.

Shah highlighted the ongoing Special Intensive Revision (SIR) of electoral rolls, calling it a "purification" of the voters' list. He accused some political parties, including the Trinamool Congress in West Bengal, of opposing the SIR process to ensure that infiltrators remain on the electoral rolls. "Stopping infiltration is essential not only for national security but also to protect the democratic system from being polluted," he said.

The Home Minister as-



serted the government's commitment to deporting every infiltrator and said that only Indian citizens have the right to influence democratic decisions.

"Who will be the Chief Minister of any state or the Prime Minister is a decision solely for Indian citizens. Infiltrators do not have the right to pollute our democracy," Shah added.


He also warned political parties attempting to shield illegal immigrants, saying the Bihar election results reflected the public's opposition to such practices. In the recent assembly elections,

the NDA won over 200 seats in the 243-member House, defeating the Mahagathbandhan alliance of Congress, RJD, and others.

Shah urged all citizens to support the SIR process as a step toward safeguarding and purifying India's democracy. "Those

working to secure infiltrators' place on voter lists should know that the people of the country will never support such intentions," he said, reinforcing the government's firm stance against illegal immigration and efforts to strengthen electoral integrity.

Delhi HC Quashes Case Against Gautam Gambhir in Covid Drugs Row



eter and current Indian cricket team head coach Gautam Gambhir, his foundation, and family

members in connection with the alleged illegal stocking and distribution of COVID-19 drugs during the pandemic.

Justice Neena Bansal Krishna pronounced the order, stating, "criminal complaint quashed," in response to a plea challenging the summons issued by the trial court against Gambhir, his wife Seema Gambhir, his mother Natasha Gambhir, and the Gautam Gambhir Foundation. The plea sought the quashing of the criminal complaint filed by the Delhi government's Drug Control Department.

The complaint had named Gambhir, then MP from East Delhi, along with his foundation, its CEO Aprajita Singh, and family members, alleging violations under Section 18(c) read with Section 27(b)(ii) of the Drugs and Cosmetics Act. Section 18(c) prohibits the manufacture, sale, and distribution of drugs without a valid licence, while Section 27(b)(ii) prescribes imprisonment of three to five years and fines for offences.

The legal proceedings

began when Gambhir and his family challenged the trial court's summons. On September 20, 2021, the High Court had stayed the trial proceedings and sought a response from the Drug Control Department. The stay was vacated on April 9, 2025, prompting Gambhir to file a fresh application seeking its recall.

The Drug Control Department's counsel opposed the plea, arguing that Gambhir should have approached the revisional court before moving the High Court.

The prosecution maintained that the petitioners had indeed distributed drugs without a valid licence, and their defense rested solely on the claim that no sale had occurred.

With the High Court's quashing of the criminal complaint, Gambhir and his family are cleared of legal liability in the case, ending a long-standing legal battle linked to the pandemic-era distribution of medicines.

PM Modi Begins South Africa Visit for G20 Summit

The visit also underscores India's continu-

ing efforts to elevate the African Union's role in global forums, following its membership in the G20 during India's presidency in 2023—a milestone widely regarded as a landmark achievement for India-Africa relations.

Through his participation, the Prime Minister aims to emphasize sustainable development, equitable growth, and strengthened global partnerships while representing India's commitment to multilateralism and inclusive solutions to global challenges.

Modi's visit to Johannesburg reflects India's growing engagement with the Global South and its commitment to fostering dialogue on pressing international issues ranging from climate action to technological innovation.

India, Australia Vow for Free & Secure Indo-Pacific

External Affairs Minister S. Jaishankar on Thursday highlighted the deepening ties between India and Australia, emphasizing their shared commitment to a free, open, and secure Indo-Pacific during the 16th India-Australia Foreign Ministers' Framework Dialogue in New Delhi.

Welcoming Australian Foreign Minister Penny Wong, Jaishankar described the dialogue as a cornerstone of the Comprehensive Strategic Partnership (CSP) between the two nations. He noted that bilateral ties have expanded across trade, investment, defence, education, research, science, technology, space, and energy, with particularly strong growth in people-to-people connections over the past five years.

The minister pointed to recent high-level vis-

its, including Australia's Deputy Prime Minister and Defence Minister to India, as well as India's Defence Minister visiting Australia, reflecting growing defence and security cooperation. He highlighted joint exercises, interoperability initiatives, maritime domain awareness, and cybersecurity collaboration as key indicators of trust and coordination between the countries.

Jaishankar expressed optimism over the ongoing Comprehensive Economic Cooperation Agreement (CECA) negotiations, expected to conclude soon, further strengthening trade and investment relations. The pageant, one of the "big four" global beauty contests, saw over 120 contestants competing for the prestigious crown, with finalists from Ivory Coast, the Philippines, Thailand, and Venezuela joining Bosch on stage.

The climax of the event was overshadowed by a tense incident involving the host, who reportedly insulted Bosch, sparking widespread debate and criticism. The moment created a chaotic atmosphere as judges reportedly expressed displeasure, with some stepping down in protest. Despite the turbulence, Bosch maintained her composure, impressing the panel with poise and confidence to ultimately secure the crown.

Bosch's victory is celebrated as a triumph of resilience and grace under pressure, with fans and observers praising her ability to rise above the controversy. The Mexican contestant's per-

formance throughout the pageant, including the evening gown and final question rounds, was highlighted as a key factor in her success.

The 2025 edition of Miss Universe will be remembered not only for the crowning of Bosch but also for the unprecedented behind-the-scenes drama. Allegations of mismanagement, contestant dissatisfaction, and on-stage flops added a layer of unpredictability, making the event one of the most talked-about editions in recent years.

Organisers stated that the pageant aimed to celebrate diversity, talent, and global representation, and despite the controversies, they lauded Bosch's win as a reflection of excellence and resilience. Her victory adds to Mexico's growing legacy in international beauty contests, inspiring a new generation of participants.

Fans worldwide have taken to social media to congratulate Bosch, emphasizing her composure amid adversity as a defining feature of her Miss Universe journey.

Four Killed as 5.7-Magnitude Quake Jolts Bangladesh; Tremors Felt in West Bengal

A 5.7-magnitude earthquake struck Dhaka and several parts of Bangladesh on Friday morning, leaving four people dead, including a newborn baby, and injuring at least 50 others across the country. The quake, which triggered panic and caused structural damage, was also felt across West Bengal, including in Kolkata.

According to Bangladesh's meteorology department, the tremor occurred at 10:38 am with its epicentre at Narsingdi, located on the northeastern outskirts of Dhaka, at a shallow depth of 10 kilometres. The site lies just 13 km from the seismic centre in the capital's Agargaon area.

In Old Dhaka's Armanitola locality, three people were killed after a railing, bamboo scaffolding, and debris from a five-storey building collapsed during the tremor. Dhaka's Deputy Police Commissioner Mallik Ahsan Uddin Sami confirmed the deaths, adding that a medical student was among the victims while his mother sustained critical injuries and required emergency surgery.

old child.

The fourth fatality occurred in Narayanganj, where a newborn died after a wall collapsed near the infant and her mother as they walked by.

Several buildings across Dhaka showed signs of structural distress. An eight-storey structure in Swamibagh, Sutrapur, leaned onto a neighbouring building, while a seven-storey building in Kalabagan appeared tilted, though firefighters later assessed it as structurally stable.

Multiple fires were also reported soon after the quake, including incidents in Baridhara and Munshiganj's Gazaria area. Fire crews responded promptly, though the cause of the blazes remains under investigation.

Experts warned that the tremor should serve as a wake-up call. Professor Mehedi Ahmed Ansary of BUET said that a stronger quake—of magnitude 6 or above—could cause widespread structural collapse in the country.

Across the border, residents in Kolkata and other districts of West Bengal rushed out of buildings as tremors were felt. No casualties or damage have been reported in India so far.

Trump Unveils 28-Point Peace Plan to End Russia-Ukraine War

A 28-point peace plan aimed at ending the ongoing Russia-Ukraine war has been drafted by the United States and Russia, with Ukrainian President Volodymyr Zelensky agreeing to review the proposals. The plan, which Kyiv has said includes several unacceptable concessions, outlines measures that could force Ukraine to cede large parts of its territory captured by Moscow and cap its military size, while also lifting sanctions on Russia over time.

The proposals include US security guarantees for Ukraine, economic cooperation between Washington and Moscow, and the establishment of a joint Peace Council headed by former US President Donald Trump to monitor compliance. The plan also suggests holding elections in Ukraine within 100 days and enshrining in the

constitution that the country will not join NATO. Key Russian-held regions including Crimea, Luhansk, and Donetsk would be recognised as de facto Rus-

sian, while Kherson and Zaporizhzhia would remain frozen along the line of contact.

Other provisions in-

clude limitations on Ukraine's armed forces to 600,000 personnel, the reintegration of Russia into the global economy, and the creation of a Ukraine Development Fund for

post-war reconstruction. Economic partnerships between the US, Russia, and Europe are also outlined, including the use of \$100 billion in frozen Rus-

sian assets to rebuild Ukraine, with the US receiving half the profits.

The plan additionally addresses humanitarian issues, including prisoner exchanges, civilian repatriation, and family reunification. Both countries are expected to adopt educational programs promoting tolerance and cultural understanding. Nuclear safety measures, including the supervision of the Zaporizhzhia Nuclear Power Plant by the IAEA, are also included.

Zelensky is scheduled to discuss the plan with Trump in the coming days, evaluating whether it offers a viable path to a just and sustainable resolution of the conflict. While diplomacy remains ongoing, critics argue the plan's territorial and military concessions may be politically and strategically challenging for Ukraine.

Pakistan's soaring violence against women exposes institutional collapse

A biannual assessment by the Sustainable Social Development Organisation (SSDO) has highlighted the alarming scale of gender-based violence in Punjab, Pakistan, revealing that at least 85 women suffer violence daily, including nine who are sexually assaulted on average. The findings, obtained through the Right to Information (RTI) Act from the Punjab Police, underscore the systemic and widespread abuse across the province.

The Violence Against Women Punjab 2025 factsheet categorises incidents into sexual assault, domestic violence, honour crimes, kidnapping, trafficking, cyber harassment, and workplace sexual harassment. Between January and June 2025, daily averages recorded nine sexual assaults, 51 kidnappings, and 24 do-

mestic violence cases. Lahore emerged as the worst-hit district, leading in sexual assault, kidnapping, domestic violence complaints, and honour killings.

Other high-incidence

districts include Multan, Gujranwala, Sialkot, and Kasur.

The report also highlighted uneven cyber harassment reporting, with only five dis-

tricts—Okara, Shekhpura, Layyah, Pakpattan, and Gujarat—documenting incidents, largely due to limited access to digital reporting platforms. Muzaffargarh and Pakpattan saw the highest

trafficking cases. Alarming, several districts, including Bahawalpur, Chakwal, Faisalabad, Narowal, Rahim Yar Khan, Sahiwal, and Rawalpindi, provided no data, de-

spite repeated RTI reminders, raising concerns about transparency and accountability.

SSDO warned that data gaps weaken public trust and fuel misinformation. While improved reporting may have increased the numbers, the organisation stressed that robust reporting mechanisms, faster judicial processes, stronger police investigations, and enhanced survivor support services are urgently needed.

The report concluded that reliable data, accountable governance, and sustained community awareness are essential to confront the deep-rooted crisis of violence against women in Punjab. Without structural reforms, experts fear the violence will remain widespread and underreported, perpetuating cycles of abuse and impunity.

HSBC Predicts Sensex to Touch 94,000 by End-2026

Global brokerage HSBC expects India's benchmark BSE Sensex to rise roughly 10% by the end of 2026, setting a target of 94,000 points for the 30-share index. The firm highlighted that Indian equities currently offer better valuation support compared to Chinese markets, despite lagging other Asian peers this year due to softer corporate earnings and heavy foreign selling.

In 2025, foreign portfolio investors have offloaded \$16.8 billion of Indian equities, marking a record year of outflows. However, the selling trend has moderated since October amid signs of earnings recovery. Both the Sensex and Nifty are up about 10% year-to-date, trading slightly below their September 2024 highs.

HSBC analysts, led by Herald van der Linde, noted that India is regaining appeal as earnings strengthen and valuations ease after a 14-month pause. Key sectors expected to



benefit include banks, as margins expand, and consumption-driven industries, such as automobiles, which stand to gain from GST reductions and lower interest rates.

The brokerage also highlighted that India

is well-positioned to attract renewed emerging market inflows, as global investors seek growth opportunities in Asia beyond artificial intelligence-driven sectors. HSBC emphasized that ongoing fiscal and monetary sup-

port could boost growth in early 2026.

Alongside India, HSBC remains overweight on mainland China, Hong Kong, and Indonesia, while staying underweight on Taiwan, South Korea, Japan, Singapore, and

Thailand. The firm had upgraded Indian equities to "overweight" from "neutral" in September, making it one of the first major global brokers to turn bullish on India's economy. HSBC's outlook sug-

gests optimism for the Indian stock market, driven by improving earnings, favorable valuations, and renewed investor interest, signaling a potential strong year ahead for equities in the country.

Tata Motors PV Q2 Profit Soars 2,065% on One-Time Gain



Tata Motors Passenger Vehicles Ltd (Tata Motors PV) reported a staggering 2,065% jump in profit for the quarter ended September 2026, posting Rs 76,248 crore, driven largely by a one-time notional gain of Rs 82,616 crore following the company's de-

merger into passenger and commercial vehicle units. For comparison, the same quarter a year ago saw a profit of Rs 3,521 crore, while the June quarter of FY26 recorded Rs 4,003 crore.

Despite the sharp rise in profit, revenue fell 13.5%

year-on-year to Rs 72,349 crore, affected primarily by a cyber incident at Jaguar Land Rover (JLR). The company noted that domestic sales remained steady, with performance rebounding after recent GST reductions.

The quarter also saw a no-

table 60% surge in electric vehicle (EV) sales, highlighting Tata Motors PV's growing focus on EVs amid rising consumer demand. This increase underlines the company's strategic push toward electrification and innovation in passenger vehicles, a seg-

ment expected to drive future growth.

Tata Motors' strong one-time gain comes as part of broader corporate restructuring and strategic realignment, designed to separate passenger and commercial vehicle operations. Analysts said that while the profit spike is exceptional, the underlying operational numbers suggest a stable domestic market performance despite challenges at the global subsidiary, JLR.

The company emphasized that it remains focused on expanding EV offerings, strengthening domestic market share, and navigating international headwinds. With the demerger providing clearer business visibility, Tata Motors PV is well-positioned to leverage its EV growth momentum and enhance long-term shareholder value.

This quarter's results underscore the impact of strategic corporate moves, demonstrating how one-time gains and restructuring can significantly influence reported profitability, even amid operational challenges.

Tata Projects, ASI Global Join Hands for Aircraft Maintenance Facilities



Tata Projects Ltd (TPL) and ASI Global have signed a Memorandum of Understanding (MoU) to jointly design and construct aircraft maintenance facilities in India, positioning

themselves as integrated solution providers for hangar and MRO infrastructure.

The alliance brings together Tata Projects' engineering, procurement, and construction (EPC)

expertise with ASI Global's global experience in aircraft hangar design and fabrication. Together, the companies aim to cater to growing demand from commercial airlines, third-party

MRO operators, business aircraft operators, and the defence sector.

Under the MoU, Tata Projects and ASI Global will jointly identify and pursue opportunities across India for the de-

velopment of hangars and related maintenance infrastructure. The partnership is expected to streamline project execution and provide end-to-end solutions for aviation

clients, from design and engineering to construction.

Industry experts note that India's aviation sector is witnessing increased demand for modern maintenance, repair, and overhaul (MRO) facilities, driven by the expansion of commercial airlines and rising defence requirements. The collaboration between Tata Projects and ASI Global is seen as a timely move to strengthen domestic capabilities and reduce reliance on foreign infrastructure providers.

The MoU reflects a strategic effort to enhance India's aerospace infrastructure, supporting both civil and defence aviation growth. With the partnership in place, the companies are set to play a key role in shaping the country's MRO ecosystem while leveraging their combined technical and operational expertise.

Reliance Halts Russian Oil Imports at SEZ Refinery



Reliance Industries Limited (RIL) has stopped importing Russian crude oil into its Special Economic Zone (SEZ) refinery, effective Thursday, November 20. The company confirmed that all pre-committed Russian crude shipments as of October 22 will be honoured, ensuring no disruption to ongoing operations.

Starting December 1, 2025, all products exported from the SEZ refinery will be sourced exclusively from non-Russian crude oil, marking a strategic shift in RIL's supply chain. According to a company spokesperson, this transition has been completed ahead of schedule to ensure full compliance with upcoming product-import restrictions, which are set to come into force on January 21, 2026.

The move aligns with broader geopolitical and regulatory pressures, as several nations tighten restrictions on Russian oil amid ongoing global tensions. Reliance's proactive adjustment is aimed at avoiding potential disruptions to its export operations and maintaining smooth refinery output.

Industry experts note that this early compliance also allows Reliance to stabilize sourcing logistics and maintain customer confidence in international markets. Analysts say the SEZ refinery, a key part of Reliance's export-oriented strategy, will now increasingly rely on alternative crude suppliers, diversifying its supply chain to mitigate geopolitical risks.

This development comes at a time when global oil markets are closely watching supply realignments and sanctions compliance, and RIL's decision is expected to set a precedent for other private refiners managing Russian crude dependencies.

By moving swiftly ahead of the mandated restrictions, Reliance aims to ensure uninterrupted refinery operations, safeguard exports, and demonstrate its commitment to regulatory adherence and global trade norms.

Rupee Inches Up 2 Paise to 88.58 Against Dollar



Mumbai: The Indian rupee closed 2 paise higher at 88.58 against the U.S. dollar on Wednesday, supported by buying momentum in domestic equities and softer global crude oil prices.

Forex traders noted that despite these domestic positives, gains were limited due to a firm U.S. dollar and continued foreign capital outflows. The dollar index, which measures the greenback's strength against a basket of six currencies, was trading 0.18% higher at 99.63.

Market participants also cited cautious investor sentiment ahead of developments on the proposed India-U.S. trade deal, which has been closely monitored by businesses and foreign investors alike.

"While the rupee saw modest gains, broader global factors and the strength of the U.S. dollar kept any sharp appreciation in check," said a senior forex dealer.

Analysts expect the rupee to remain sensitive to both domestic equity trends and international cues, including crude oil prices, dollar movement, and foreign fund flows, in the near term.

NASA Spots Mysterious 80cm Rock on Mars



NASA's rover Perseverance has discovered an unusual 80-centimeter rock in the Verneyden area of Mars' Jezero Crater, sparking excitement among scientists. The rock, named "Phippsaksla," stood out due to its size and structured appearance compared to surrounding stones.

Images captured by Perseverance's Left Mastcam-Z camera on September 19, 2025, show Phippsaksla both up close and from a distance, revealing details that prompted the team to investigate further.

To analyze its composition, the rover used its SuperCam instrument, which fires laser pulses at targets and examines the reflected light. Preliminary findings indicate that the rock contains iron and nickel, elements uncommon in typical Martian geology but often found in asteroids, suggesting that the rock may have formed elsewhere in the solar system.

"This could be a meteorite," NASA scientists noted, though further study is required to confirm its origin and how long it has been on the Martian surface.

Phippsaksla joins a growing

list of metal-rich rocks identified on Mars by previous missions. The Curiosity rover documented several iron-nickel meteorites, including the one-meter-wide "Lebanon" in 2014 and "Cacao" in 2023. Earlier rovers, Spirit and Opportunity, also recorded similar findings, offering valuable insights into materials that have traveled across the solar system to reach Mars.

Each metallic discovery enhances understanding of the diverse composition of objects impacting Mars, helping scientists piece together the planet's history and its interactions with space debris.

For Perseverance, Phippsaksla represents a new chapter in exploring extraterrestrial meteorites. The research team will continue analyzing data to determine its precise origin, composition, and the story it tells about Mars' cosmic neighborhood.

This discovery highlights how even a single rock can provide profound insights, reinforcing the importance of ongoing robotic exploration in expanding humanity's knowledge of the solar system.

Ancient Gold, Silver Coins Unearthed in Polish Forest



Archaeologists have made a remarkable discovery in northeastern Poland's Knyszyńska Forest Landscape Park, unearthing 69 ancient coins, including one gold and 68 silver pieces, dating back to the 16th-17th centuries.

The excavation, led by archaeologist Hubert Lepionka, highlights the region's historical significance as a hub of trade. During this period, large quantities of timber and forest products, including wood, tar, honey, and iron, were exported to Dutch merchants, primarily for shipbuilding. The coins were likely buried along these trade routes, possibly hidden for safekeeping during times of war or instability, and never retrieved.

Among the findings, the latest coin dates to 1634, while the gold coin is a Dutch ducat from 1633. The silver coins include small Polish and Swedish denominations such as poltorak, trojak, and szóstak, reflecting active trade between dif-

ferent regions and currencies. This combination of coins underscores the cross-cultural economic interactions in Europe during the

era. Archaeologists believe the treasure may have belonged to a trader or someone engaged in forest-relat-

ed commerce. The discovery not only provides insights into local trade but also sheds light on historical practices of hiding wealth


amid uncertain times.

Next, scientists plan to clean the coins and examine their dates and markings, alongside analysing soil and ash layers to understand the timing and circumstances of the burial. Additional metal artifacts found nearby will help reconstruct activities in the area during the 17th century.

This find emphasizes the historical connection between Poland's forests and European trade networks, offering a tangible link to the past. As research progresses, the coins are expected to provide further insights into economic, social, and cultural life in early modern Europe, enriching our understanding of regional and international commerce.

The discovery has captivated historians and archaeologists, serving as a reminder of the hidden treasures that continue to lie beneath Europe's historic landscapes.

New Study Shows Tiled Patterns Are Common in Nature



A recent scientific study has revealed that tiled or repeating patterns, long admired in nature, are far more widespread across life on Earth than previously recognized. These patterns, where surfaces are divided into repeated units, appear

in organisms ranging from plants and animals to fungi.

Researchers have focused on patterns known as "cellular foams," commonly found in bone, wood, and plant tissues, where thin walls enclose numerous

small chambers. These structures are lightweight yet strong, providing rigidity without adding excess mass—an efficient design nature has repeatedly used. The study, described in the weekly *Science for All* newsletter, emphasizes that

tiling patterns are not limited to microscopic structures. They are observed in scales, shells, leaves, and even insect wings, showing that evolution often converges on modular designs to optimize strength, flexibility, and efficiency.

Scientists used a new atlas of tiling patterns, classifying them across species and materials. The classification highlights variables such as shape, orientation, connectivity, and symmetry of tiles, helping biologists understand how these structures form and function.

Beyond biology, these insights have implications for engineering and design, inspiring lightweight and resilient materials for architecture, robotics, and aerospace. By studying natural tiling, researchers hope to replicate nature's solutions to balance strength, weight, and adaptability.

The findings underscore that tiling is a universal strategy employed across diverse life forms, from the microscopic to the macroscopic. Whether in bones that support a giraffe's neck, honeycombs that house bees, or leaves that capture sunlight efficiently, tiling demonstrates how repeated modular units can achieve structural excellence and efficiency.

This new atlas and classification of tiled structures provide a framework for future studies, bridging biology, physics, and design, and showing that some of nature's most elegant patterns are both functional and beautiful.

Lakshya Sen Reaches Australian Open Semis; Satwik-Chirag Exit

India's Lakshya Sen delivered a strong performance to enter the men's singles semifinals of the Australian Open Super 500 tournament on Friday, overcoming fellow Indian shuttler Ayush Shetty in straight games. However, it was a disappointing day for India in men's doubles, with the top-seeded pair Satwiksairaj Rankireddy and Chirag Shetty bowing out of the competition.

Lakshya, seeded seventh, showcased excellent composure as he defeated 20-year-old Ayush Shetty 23-21, 21-11. This marks Lakshya's second victory over Shetty at the semifinal stage this year, following their clash at the Hong Kong Open. The tightly contested opening game saw Lakshya trailing 6-9 before he rallied to take an 11-10 lead at the interval. In a tense back-and-forth finish, Ayush earned the first game point but could not convert it, allowing Lakshya to close the game with solid nerve.

The second game turned one-sided, with Lakshya



racing to a 6-1 start. His dominance grew as he extended the lead to 15-7, ultimately sealing the match in 53 minutes. With this win, Lakshya becomes the only Indian remaining in men's singles, following early exits from senior players HS Prannoy and

Kidambi Srikanth.

Lakshya will next face Chou Tien Chen of Chinese Taipei, the second seed and world No. 9. Chou earned his semifinal berth after a grueling 1 hour 23-minute battle, defeating Farhan Alwi 13-21, 23-21, 21-16.

In men's doubles, the Indian challenge ended as Satwik and Chirag fell to Indonesia's fifth-seeded duo Fajar Alfian and Muhammad Shohibul Fikri. Despite recent strong form, including finals appearances at the Hong Kong Open and China Masters,

Satwik-Chirag were outplayed 21-19, 21-15.

As Lakshya continues his pursuit of a title, expectations remain high for the 2021 World Championship bronze medallist, who is still seeking his first tournament win of the year.

India Names 23-Man Squad for AFC U17 Asian Cup Qualifiers



India has announced a 23-member squad for the 2026 AFC U17 Asian Cup Qualifiers, with head coach Bibiano Fernandes unveili-

ing the list on Friday. The qualifiers begin on Saturday at the EKA Arena in Ahmedabad, where India will compete in a challeng-

ing group featuring Palestine, Chinese Taipei, Lebanon, and Iran.

India opens its campaign against Palestine on No-

vember 22, followed by matches against Chinese Taipei (November 26), Lebanon (November 28), and Iran (November 30). With only the group winners earning direct qualification to the final tournament in Saudi Arabia next year, the young Blue Colts face a crucial test. The 2026 AFC U17 Asian Cup will also serve as the qualifying pathway to the FIFA U17 World Cup in Qatar, adding further weight to the competition.

Coach Bibiano Fernandes, known for shaping India's youth football structure with past U17 successes, expressed confidence in the squad's preparation. The team has undergone multiple training camps and exposure matches, aiming to put up a strong performance in front of home supporters.

Australian pace spearhead Mitchell Starc produced a sensational spell, claiming a career-best 7 for 58, as Australia bowled out England for just 172 on Day 1 of the first Ashes Test in Perth. The dramatic collapse came despite England winning the toss and opting to bat.

Starc wasted no time asserting dominance, striking in the very first over of the series. He removed Zac Crawley for a duck with the sixth delivery of the match, caught by Usman Khawaja at slip. The wicket marked yet another milestone for the left-arm pacer — it was the 24th time he has taken a wicket in the first over of a Test. More notably, he reached 100 Ashes wickets after dismissing England's key batter Joe Root, a breakthrough that further tilted momentum Australia's way.

England's batting lineup struggled to cope with Starc's pace, swing, and accuracy. While a few batters attempted to stabilize the innings, frequent breakthroughs kept Australia firmly in control. No England player managed a substantial score, with the mid-

dle order faltering under relentless pressure.

Starc's fiery spell was well-supported by the rest of the Australian bowling unit, who maintained tight lines to keep England contained. The disciplined at-

tack ensured there was no room for recovery, as wickets continued to fall at regular intervals.

The pitch offered some assistance early on, but it was Starc's execution and rhythm that defined the in-

nings. His ability to strike early and return for crucial breakthroughs later in the session left England reeling.

With England dismissed for 172, Australia entered a commanding position in the

series opener. The hosts will now look to capitalize on the strong start as they begin their first-innings reply, aiming to build a significant advantage in the opening Test of the 2025 Ashes series.

Jaismine, Nikhat Advance to World Boxing Cup Finals



Greater Noida: India's boxing stars Jaismine Lamboria and Nikhat Zareen booked their spots in the finals of the World Boxing Cup 2025 with dominant performances in their respective semifinal bouts at the Shaheed Vijay Singh Pathak Indoor Stadium on Wednesday.

Jaismine, the reigning world champion in the 57kg category, faced Kazakhstan's Ulzhan Sarsenbek, a former Asian youth gold medallist. Despite starting her campaign later than most, Jaismine showcased her class and experience, defeating Sarsenbek convincingly with a 5-0 scoreline. Her precise combinations, swift footwork, and tactical control of the ring left little room for her opponent to mount a challenge.

Premante : Priyadarshi's New Romantic Drama

The film unfolds around how their relationship copes with this truth, the choices they make, and what becomes of their marriage.

On the performance front, Priyadarshi shines with a nuanced portrayal of a conflicted man, while Anandi steals the show as a devoted wife whose love pushes her into unexpected territory. Their chemistry is one of the film's strongest pillars. Suma and Vennela Kishore add value, though their comedic tracks feel stretched.

Technically, Viswanath Reddy's visuals and Leon James' music elevate the film. However, some subplots—especially involving friends—could have been tighter.

Overall, Premante is a heartfelt family drama with fresh narrative elements, strong performances, and emotional depth.

Allari Naresh's 12A Railway Colony – Only for a few twists



Allari Naresh teams up with debutant director Nani Kasaragadda for the suspense thriller "12A Railway Colony," which released today. The film also stars Dr. Kamakshi Bhaskarla, Sai Kumar, Viva Harsha, Jeevan Kumar, Anish Kuruvilla, and others, with music by Bheems Ceciroleo and cinematography by Kushendar Ramesh Reddy.

Set in 12A Railway Colony, Warangal, the story follows Karthik (Allari Naresh), an orphan working for politician Tillanna (Jeevan Kumar). The first half focuses on world-building and character introductions, which some viewers may find slow and dragging. However, Allari Naresh impresses in his role, smoothly transitioning from a carefree young man to someone entangled in suspense. Kamakshi's performance is

satisfactory, and supporting actors adequately fulfill their roles.

The second half is where the film gains momentum. The narrative shifts into a whodunit-style thriller with unexpected twists and a crime that drives the story forward. The screenplay, penned by Dr. Anil Vishwanath (Polimera fame), keeps the audience engaged as mysteries unravel.

On the technical front, Bheems Ceciroleo's songs fit the narrative, and the background score complements tense sequences. Kushendar's cinematography is neat, but the VFX work is inconsistent, particularly in scenes using green screens. Editing, handled by the director himself, could have been tighter to avoid the drag in the first half.

Verdict: "12A Railway Colony" attempts to be a gripping suspense thriller but delivers a mixed experience. While the second half offers twists and engagement, the slow-paced first half and a setup for a potential sequel dilute the overall impact.
