**Andhra Pradesh CM Chandrababu Naidu Joins
Sankranti Festivities in Native Village Naravaripalle**

Chandragiri: Andhra Pradesh Chief Minister N. Chandrababu Naidu immersed himself in the vibrant Sankranti celebrations at his native village, Naravaripalle, in Chandragiri constituency on Tuesday. The festivities, marked by traditional pomp and community spirit, brought together Naidu's family and locals in a display of cultural heritage and familial bonding amid the state's ongoing development push.

The event unfolded with great enthusiasm, drawing hundreds of villagers and Naidu's close family members. Accompanying the Chief Minister were his wife, Nara Bhuvaneswari; son and IT Minister Nara Lokesh; daughter-in-law Nara Brahmani; grandson Devansh; and other relatives including Basavarajam Satyanarayana Raju's wife Vasundhara, Tejaswini, and Sri Bharath. The gathering highlighted the Naidu family's deep-rooted connection to their ru-

ral origins, even as Naidu leads the state's ambitious governance agenda from Amaravati.

A key highlight was the traditional muggu (rangoli) competitions, meticulously inspected by Bhuvaneswari and Brahmani. Women from the village showcased intricate designs using colored powders and rice flour, symbolizing prosperity and good fortune a staple of Sankranti traditions in Andhra Pradesh. "These competitions foster creativity and community spirit," Bhuvaneswari reportedly remarked, appreciating the participants' efforts. The celebrations extended to various sports events organized for the youth, where young Devansh actively partici-

pated, adding a personal touch. Naidu and family members keenly observed the competitions, cheering on the contestants in kabaddi, kho-kho, and tug-of-war. The Chief Minister's presence energized the crowd, with villagers erupting in applause as Devansh competed spiritedly.

In a ceremonial moment, Naidu and Bhuvaneswari presented prizes and certificates to the winners, underscoring the event's focus on rewarding talent and participation. Cash awards, trophies, and sweets were distributed amid chants of "Jai Telugu Nadu" and "Chandrababu Garu Zindabad."

"Before the festivities peaked, Naidu made time for public grievances. He

received a steady stream of petition letters (vinitipatralu) from residents, promising prompt attention through administrative channels. Sources close to the CM indicated that these inputs would feed into ongoing welfare schemes like the TDP government's flagship 'Amma Vodi' and infrastructure projects in Tirupati and Chittoor districts.

Sankranti, known locally as Pedda Panduga, holds special significance in Andhra Pradesh, blending harvest joy with family reunions. Naidu's participation aligns with his "Swa Gramam" (my village) outreach, a strategy he has employed since returning to power in 2024. Last year, similar events in Naravaripalle focused on youth skill development, tying into the state's Super Six promises free education, jobs, and investments. Villagers expressed delight at Naidu's accessibility.

"The CM remembers every corner of our village; this boosts our morale," said local farmer Ramaiah. Lokesh, addressing the gathering, emphasized the TDP-JSP-BJP alliance's commitment to rural revival, hinting at upcoming announcements for Chandragiri's tourism and irrigation projects.



**Major Fire Guts Namburi Wine Shop in Anantapur;
Arson Suspected Amid Conspiracy Claims**

Anantapur: A massive fire broke out early Tuesday morning at the bustling Namburi Wine Shop opposite D-Mart in Anantapur city, sparking widespread panic and allegations of foul play. The incident, which occurred around 4:00 AM in one of the area's most crowded commercial hubs, destroyed property worth lakhs of rupees and raised fears of a deliberate arson plot. The fire started abruptly with thick smoke billowing from inside the shop, alerting the on-duty watchman.

Acting swiftly, he informed owner Namburi Venkataramana, who immediately contacted the fire department and local police. Fire tenders rushed to the scene and battled the blaze for about

1.5 hours, preventing it from spreading to nearby commercial establishments and residential areas. "If the fire team hadn't arrived on time, the damage would have been catastrophic," said local residents, relieved at the narrow escape.

Preliminary police estimates peg the losses at around 4 lakh. Bottles of various liquors were completely gutted, heavy refrigerators used for storage were wrecked, and the front portion of an autorickshaw parked outside suffered partial damage. The shop's prime location amplified the risk, but firefighters' rapid response contained the inferno. In a sensational twist, owner Namburi Venkataramana lodged a complaint alleging sabotage.

He dismissed suggestions of a short circuit, claiming rivals with a grudge orchestrated the

attack. "This isn't an accident it's a conspiracy by those who've had issues with me lately," Venkataramana told police, pointing to ongoing disputes. His accusations have fueled speculation in the community. Anantapur police have registered a case and launched a probe. A crime scene team combed the site for evidence, while CCTV footage from the wine shop and surrounding D-Mart premises was seized.

Electricity department officials are also investigating potential electrical faults. "We're examining all angles, including technical causes and foul play," a senior officer said. The incident has shaken Anantapur residents, highlighting safety concerns in high-density zones. Authorities urge shop owners to enhance fire safety measures amid rising urban risks.

Amaravati Land Pooling Gains Momentum: 25% Achieved in Three Villages on Day One

OneAmaravati, January 13, 2026: Andhra Pradesh Municipal Administration Minister Narayana announced brisk progress in land pooling for multiple projects in Amaravati, highlighting the scheme's early success. On the first day, farmers from three villages in Amaravati Mandal contributed 1,000 acres, achieving 25% of the targeted land pooling in those areas, he revealed during an event in Karlapudi village.

The minister, accompanied by local MLA Bashyam Praveen, laid the foundation stone for roadworks in Karlapudi on Tuesday. This followed requests from farmers whom Narayana

na met the previous day during the land pooling launch. Responding swiftly to their demand for improved roads, he directed estimates to be prepared immediately and assigned the contract to a firm.

The 2.9-kilometer stretch from Karlapudi to Anantavaram received its foundation stone, with strict instructions to complete the work within a week. Praising the farmers who surrendered their land, Minister Narayana extended special congratulations. He credited MLA Praveen for convincing them to participate enthusiastically. "For Amaravati's development, an inner ring road and an Inter-



national Sports City are essential," Narayana emphasized.

He disclosed that MLA Praveen assured acquiring 80% of the required land through pooling within a month. Once that milestone is reached, a master plan will be designed, and

tenders called promptly. To build trust, the government plans to prioritize two-row roads in the plots allotted to farmers. Narayana recounted how, during Monday's gram sabha in Karlapudi, residents flagged the poor condition of a 3.9-kilometer

road. "We laid the foundation stone for its reconstruction right away and will complete it as quickly as possible," he assured.

This renewed push for land pooling revives hopes for Amaravati's revival as the state's capital city, a vision

championed by the TDP-led alliance government. Stalled under the previous YSRCP regime due to farmer protests and legal hurdles, the scheme now sees active farmer buy-in, buoyed by promises of annuities, developed plots, and infrastruc-

ture perks.Minister Narayana underscored the Sports City's urgency, noting its potential to position Amaravati as a global hub for athletics, training, and events.

The inner ring road, meanwhile, would decongest traffic and connect key development zones. MLA Praveen, speaking on the occasion, reiterated his commitment: "We'll secure 80% pooling in 30 days, kickstarting tenders and master planning."Farmers present expressed optimism, citing the government's responsiveness. One participant said, "The quick action on our road request shows

they're serious. We're ready to give more land for Amaravati's growth." Officials aim for full pooling across 33,000 acres, enabling phased construction of government buildings, residential zones, and commercial hubs.With a week-long deadline for the initial road, authorities monitor progress closely.

This momentum could accelerate other infrastructure like water systems and power grids, long demanded by stakeholders. As Andhra Pradesh eyes sustainable urban growth, Amaravati's land pooling drive sets a template for farmer-inclusive development.

Minister Mandipalli Ramprasad Reddy Issues Key Guidelines for Sankranti Travelers

Vijayawada: Transport Minister Mandipalli Ramprasad Reddy on Tuesday assured passengers heading home for Sankranti that no additional bus charges would be levied, emphasizing the Andhra Pradesh government's commitment to seamless festival travel. Releasing a statement from his office, the minister outlined several passenger-friendly measures amid the anticipated festival rush.Highlighting the state's proactive steps, Reddy confirmed that free bus services for women a flagship initiative will continue uninterrupted during the Sankranti season.

"The government has taken key decisions to ensure the comfort of passengers traveling to their native villages," he stated. Crucially, there will be no hike in AP-

SRTC fares this year, providing relief to millions planning festive journeys. In a direct message to the public, the minister urged commuters using private or personal vehicles to exercise utmost caution. "Travel safely by adhering to all traffic rules and reach your villages without mishaps," he advised, underscoring road safety as a priority during the high-traffic period.

He described these measures as the government's "Sankranti gift" to the people of Andhra Pradesh.Turning to private bus operators, Reddy issued a stern warning against exploitation. "Private buses hiking fares or indulging in illegal collections will face severe consequences, including vehicle seizure," he declared.

The minister made it clear that any violation of regulated charges

would trigger strict enforcement actions. "We will not tolerate overcharging that burdens passengers during the festival," he added, signaling a zero-tolerance policy.The announcements come at a time when Sankranti, marking the harvest festival, sees massive migrations across the state.

Roads, bus stations, and railway platforms swell with families heading to rural hometowns for traditional celebrations involving kite-flying, bonfires, and feasts of freshly harvested rice, sugarcane, and sweets. Last year, similar directives helped manage crowds effectively, and officials expect even higher footfall this season. Reddy's statement also reflects the TDP-led government's focus on public welfare post its return to power. By maintaining stable RTC fares and

cracking down on private operators, the administration aims to prevent the fare gouging seen in previous years under the YSRCP regime.

Transport department officials have been instructed to deploy special teams for monitoring and rapid response. In his concluding remarks, the minister extended warm wishes: "Let the people celebrate Sankranti with joy and safety." He called on citizens to embrace the festival spirit responsibly, fostering community bonds while prioritizing well-being.

These guidelines are poised to ease travel logistics for lakhs of Andhra Pradesh residents, ensuring a hassle-free Pongal season. With enforcement mechanisms in place, passengers can look forward to equitable and secure journeys home.



Andhra Pradesh Government Scraps Additional Excise Tax on Bars, Ensures Price Parity with Retail Shops

Ongole/ Amaravati, January 13, 2026: In a major relief to bar operators across Andhra Pradesh, the state government has completely abolished the Additional Retail Excise Tax (ARET) imposed on bars since November 2019. The decision, announced through Government Order (GO) Ms. No. 24 issued by Excise Department Principal Secretary Mukesh Kumar Mee-na on Tuesday, aims to level the playing field between retail liquor shops and bars by ensuring uniform pricing for the same liquor brands.

This sweeping reform addresses long-standing grievances of bar owners, who faced higher procurement costs due to the special ARET on Indian Made Foreign Liquor (IMFL) and Foreign Liquor (FL) supplied from Andhra Pradesh State Beverages Corporation Limited (APSBC) depots. Previously, bars had to purchase liquor at elevated prices compared to retail outlets, squeezing profit margins and hampering business viability.

With the tax now revoked, IMFL and FL supplies to bars from APSBC depots will no longer attract any additional levy, restoring price parity effective immediately from January 13, 2026.Key changes outlined in the

GO include:Uniform Pricing: Retail shops and bars will now procure the same liquor at identical rates, eliminating the dual-price system that disadvantaged bars.No Additional Taxes: Explicit orders prohibit any extra taxes on IMFL/FL supplies to bars from APSBC depots.

New Notifications: Fresh notifications under excise laws to formalize these provisions.License Rule Amendments: Revisions to the 2025 bar license regulations to align with the policy.Excise Department officials hailed the move as a "game-changer" for the hospitality sector. "This will significantly reduce operational costs for bar operators, boost viability, and promote fair competition," said a senior official from the Director of Excise and Distilleries.

The Director of Excise, Distilleries Commissioner, and APSBCL authorities have been tasked with implementing these changes seamlessly statewide.Bar associations welcomed the decision with enthusiasm. "For years, we've struggled with inflated costs that made survival tough amid rising competition and regulations. Price equality is a big relief," remarked a representative from the Andhra Pradesh

Bar Owners' Association. Industry experts predict the reforms could lower expenses by 10-15% for bar businesses, potentially stabilizing jobs in a sector employing thousands.

The policy shift comes under Chief Minister N. Chandrababu Naidu's TDP-led government, which has prioritized business-friendly measures since assuming power. It builds on earlier excise reforms, signaling a broader push to streamline liquor regulations while boosting state revenues through volume sales rather than punitive taxes.

No immediate impact on retail shop pricing or overall excise collections is anticipated, as the focus remains on equity.Implementation begins today, with district excise officers directed to monitor compliance. Stakeholders must adhere to existing excise laws, with penalties for violations.

This decision underscores the government's commitment to supporting small businesses hit hard by past policies under the previous YSRCP regime.As Andhra Pradesh eyes economic revival through infrastructure and tourism, a thriving bar sector integral to hospitality stands to gain momentum.

Andhra Pradesh Surpasses Paddy Procurement Targets, Rs 10,000 Crore Payments by Sankranti: Minister Manohar

Tenali: In a major boost to farmers ahead of Sankranti, Andhra Pradesh Civil Supplies Minister Nadendla Manohar announced that the state has procured 41.27 lakh metric tonnes of paddy from 6,76,848 farmers during the Kharif season, exceeding the Centre's target of 50 lakh metric tonnes.

Speaking at a media conference in his camp office here, the minister revealed that Rs 9,789 crore has already been directly credited to farmers' accounts. This milestone underscores the TDP-led NDA government's commitment to farmer welfare under Chief Minister N. Chandrababu Naidu and Deputy CM Pawan Kalyan's guidance. "For the first time in state history, paddy procurement payments will

cross Rs 10,000 crore by Sankranti festival," Manohar declared, highlighting the unprecedented speed and transparency of the process.

The procurement drive, launched efficiently post-Kharif harvest, has ensured seamless operations across mandal and district levels. Procurement centres have been equipped with digital platforms for real-time tracking, minimizing delays and ensuring minimum support prices (MSP) as per central guidelines.

"Our alliance government is conducting paddy procurement with utmost transparency, leaving no farmer behind," the minister emphasized. Manohar credited the success to Naidu's visionary leadership and Pawan Kalyan's proactive oversight, which prioritized farmer-centric policies



from day one. The state has mobilized adequate storage facilities and logistics to handle the influx, preventing any spillage or losses.

Over 1,000 procurement centres are operational, with teams working round-the-clock to meet the festive deadline. Farmers have hailed the initiative, noting quicker pay-

ments compared to previous regimes. One farmer from Tenali mandal said, "Last year, we waited months for payments; this time, money hit our accounts within days." CM Chandrababu Reviews Fire Accident in Kakinada's Sarlankapalle; Orders Comprehensive Aid for Victims



Amaravati, January 13, 2026: In a swift response to the devastating fire that razed 38 thatched homes in Sarlankapalle village of Kakinada district, Chief Minister N. Chandrababu Naidu held a high-level review meeting with ministers and officials on Tuesday evening. The tragedy struck during the auspicious Sankranti festival season, plunging the rural community into grief

and leaving dozens homeless. CM Naidu expressed profound sorrow over the incident, terming it a "heartbreaking mishap" that marred the festive spirit.

"The state government stands firmly with the affected families. Officials must provide every possible support without delay," he directed during the virtual meeting from Amaravati. Home Minister Vangalapudi Ani-

tha and other senior officials briefed him on the immediate relief measures underway.

According to officials, the blaze, which erupted late on Monday, gutted the entire cluster of thatched huts in the village. Preliminary investigations point to an electrical short-circuit or cooking fire as the likely cause, though a detailed probe is ongoing. No casualties were reported, but the loss of

homes, belongings, and essential documents has left residents in dire straits. Immediate Relief Packages Announced

Tangible aid has already kicked off. Each of the 38 affected families will receive Rs 25,000 in cash as ex-gratia relief, disbursed on the spot. "We are ensuring no family is left out," Home Minister Anitha assured, adding that temporary shelters, food, clothing, and medical check-ups are being arranged at relief camps. Going further, CM Naidu instructed the construction of new pucca houses for every impacted household under government housing schemes. "Until permanent homes are ready, provide safe accommodation and all necessities," he emphasized.

Andhra Pradesh Receives 567 Crore Health Grant from Centre, Tops in 15th Finance Commission Fund Utilization

Amaravati: In a significant boost to Andhra Pradesh's healthcare infrastructure, the Central Government has released 567 crore as the final installment of grants recommended by the 15th Finance Commission for the health sector. This announcement came from State Medical and Health Minister Satya Kumar Yadav during a high-level review meeting here on Tuesday.

Minister Yadav highlighted that over the past 19 months, his department has effectively utilized 48% of the allocated funds, channeling them into critical areas like hospital upgrades, primary health centers, and public health initiatives. The meeting focused on budgeting and expenditure plans for the 2025-26 financial year, with senior officials presenting detailed progress reports. Speaking to reporters afterward, Yadav directed his team's top officials to immediately engage with the

Union Finance Ministry to secure the release of any remaining funds.

"We must ensure full utilization of Central assistance," he emphasized, underscoring the NDA coalition government's commitment to maximizing every rupee for public welfare. The Centre has expressed satisfaction with the state's performance in utilizing 15th Finance Commission grants during this administration, recognizing Andhra Pradesh's proactive approach. Notably, Andhra Pradesh ranks third among states in fully securing and spending these grants, a milestone that has filled the minister with pride.

"The NDA government's efforts in health have been acknowledged by the Centre," Yadav stated, crediting the collaborative push under Chief Minister N. Chandrababu Naidu's leadership. The 15th Finance Commission, chaired by N.K. Singh, recommended 2.77 lakh crore in health grants to states from 2021-22 to 2025-26

to strengthen post-pandemic healthcare systems. Andhra Pradesh's share has been pivotal in initiatives like the Aarogya scheme expansion, rural clinic renovations, and emergency response upgrades.

The latest tranche will support ongoing projects, including equipment procurement for district hospitals and telemedicine networks in remote areas. This development comes amid the state's broader push for fiscal efficiency. Since the TDP-led NDA alliance assumed power in June 2024, disbursements from the Centre have accelerated, reflecting improved Centre-state coordination. Yadav pointed out that previous delays under the YSRCP regime had hampered progress, but the current setup has turned the tide. Officials revealed that the funds will prioritize maternal and child health programs, infectious disease control, and infrastructure in underserved districts like Vizianagaram and Prakasam.

Vijayawada Kanaka Durga Temple Launches Online Services for Devotees

The initiative primarily aims to reduce waiting times in queues, making the spiritual experience smoother and more efficient. Announcing the launch, department officials emphasized that these digital services align with the Andhra Pradesh government's push towards a cashless economy. By promoting online payments, the measures seek to minimize cash transactions and curb malpractices. "Our goal is to provide seamless access to devotees while encouraging digital adoption," a senior

official stated. The temple authorities have also introduced 'Mana Mitra' WhatsApp services to further simplify inquiries and bookings.

WhatsApp Integration for Quick Access

Devotees are advised to use the official WhatsApp number 9552300009 for instant information on darshan timings, prasad availability, and pooja details. Queries can be resolved in real-time through this channel, reducing the need for physical visits to counters. For advance bookings, the official website : www.aptemples.ap.gov.in—serves as the primary portal.

Here, pilgrims can secure tickets for quick darshan and special darshan options, ensuring priority entry during peak hours. The website also facilitates Arjita Sevas, the temple's special ritual offerings performed on behalf of devotees.

Accommodation in devasthanam guest houses can now be booked online, allowing visitors to plan

their stay in advance. This is particularly beneficial during festivals like Dasara, when footfall surges. Digital Counters and Payment Options

To support the transition, special digital counters have been set up across the Indrakeeladri premises. These feature QR code scanning, card payments, and net banking facilities for hassle-free transactions. Temple officials have cautioned devotees against touts and unauthorized agents, urging everyone to rely solely on official channels.

"Beware of fraudsters offering fake tickets or services. Use only government-provided platforms to avoid exploitation," they warned in a public advisory. This development builds on the state government's broader digitization efforts in temple administration. Similar online portals have been successful at other major shrines, cutting down queues by up to 50% and boosting revenue through transparent

Vijayawada: Tension at Sri Durga Malleshwara Swamy Temple Over Parking Dispute

Vijayawada, January 13, 2026 (TPN Bureau) – A tense situation erupted at the Sri Durga Malleshwara Swamy Temple on Indrakeeladri hill on Wednesday following a dispute over car parking between a devotee and temple security personnel. Eyewitnesses reported that the disagreement escalated quickly, with allegations that a security staff member lost control and physically assaulted the devotee. The incident caused momentary unrest among the crowd of devotees present at the temple.

According to sources, the altercation began when the devotee reportedly raised concerns about the allocation of parking space.

Temple security staff attempted to manage the situation but were accused of using excessive force, prompting criticism from other visitors. Several devotees expressed outrage over the incident, emphasizing that temple personnel are expected to maintain decorum and treat worshippers respectfully. “Temples are sacred spaces where devotees come to seek blessings in peace. Such behavior from security staff is completely unacceptable,” said one witness.

The incident has renewed calls for stricter supervision and better training of temple security personnel. Devotees have urged the temple administration to



implement clear guidelines for crowd and vehicle management, particularly during peak hours and festival periods when large numbers of people visit the shrine. While no official statement has yet been released regarding the status of the devotee or

any disciplinary action against the security staff, local authorities have reportedly begun investigating the matter. Sources indicate that the temple administration is reviewing security arrangements and considering reforms to prevent future confrontations.

The Sri Durga Malleshwara Swamy Temple, a prominent pilgrimage site in Vijayawada, has previously faced criticism over parking management and crowd control. Devotees have repeatedly demanded proper infrastructure, including designated parking zones and adequately trained personnel, to ensure safety and convenience for visitors.

This incident highlights the need for temples to balance effective security with courteous treatment of devotees. Experts suggest that regular training, clear protocols, and accountability mechanisms can prevent such incidents and enhance the overall experience for visitors. Temple authorities are expected to issue a formal statement soon, detailing corrective measures to address the incident. Meanwhile, devotees have appealed for calm and urged the administration to take immediate action to maintain peace and ensure that worshippers can continue to offer prayers in a safe and respectful environment.

Accused Arrested in Vijayawada Hit and Run Case; Police Investigate Incident



Vijayawada, January 13, 2026 (TPN Bureau) – The Vijayawada police have arrested an accused in connection with a hit and run case that occurred recently, officials said on Tuesday. The arrest follows a focused investigation after the victim was struck by a vehicle that fled the scene, sparking concern among local residents over road safety and enforcement of traffic laws.

According to police sources, the incident took place within the city limits when a vehicle collided with a pedestrian and fled the scene. Police immediately registered a case under relevant sections of the Indian Penal Code related to hit and run and traffic violations and launched a search to track down the vehicle and driver responsible.

During the investigation,

officers combed through CCTV footage from nearby cameras, interviewed witnesses, and coordinated with traffic and law and order units to identify the suspect. Following verification of evidence, the police apprehended the accused and took them into custody for further questioning.

Senior police officials said that hit and run incidents pose a serious threat to public safety and that the department is committed to ensuring that those responsible are brought to justice. “We urge commuters and vehicle owners to strictly follow traffic rules and to immediately report any accident incidents to authorities so that prompt action can be taken,” a police spokesperson said.

Hit and run cases have been a growing

concern in urban areas, drawing attention to the need for stricter enforcement, better road safety measures, and increased public awareness. Both pedestrian victims and motorists are reminded of the risks associated with negligent driving, and authorities emphasize that fleeing the scene of an accident is a punishable offense which endangers lives and hampers justice.

Local residents noted that such incidents undermine road safety confidence and have called for enhanced surveillance and traffic policing, especially in busy city zones. Vijayawada police have assured the public that further arrests are possible as the investigation continues and culls additional leads from ongoing evidence collection.

Vijayawada: Sankranti Celebrations Marred by Deadly Chinese Manja

Vijayawada, January 13, 2026 (TPN Bureau) – As Sankranti festivities fill the skies with colorful kites, a hidden danger continues to threaten lives across the city. Chinese manja, a lethal synthetic kite string, remains openly available in local markets despite a government ban, putting citizens—especially children and two-wheeler riders—at serious risk.

Chinese manja is far more dangerous than traditional cotton threads. Coated with powdered glass and chemical substances, this nylon or synthetic string can cut through skin, causing severe injuries to the neck, hands, and limbs. Over the years, numerous accidents have been reported during kite-flying festivities, some even resulting in fatalities.

Authorities have imposed a strict ban on the manufacture, storage, and sale of Chinese manja, yet enforcement remains weak. Illicit sales continue both online and in local markets, including secretive stalls and footpaths, making it easy for children and amateur kite flyers to come into contact with the

dangerous material.

Residents express alarm at the lack of oversight. “Kite flying is meant to be fun, a way for families to celebrate together, but Chinese manja has turned this tradition into a deadly risk,” said a local resident. “Every year, many are severely injured, and some even lose their lives. These are not just accidents—they are a failure of the system.”

Experts and activists urge the government and law enforcement agencies to take strict, immediate action, including cracking down on illegal vendors and raising public awareness. Families are advised to ensure that children use only traditional cotton threads while flying kites.

“If a single kite string can ruin a life or an entire family, the authorities cannot remain passive. Enforcement must match the laws in place,” said a local safety advocate.

As celebrations continue, the call is clear: strict vigilance and enforcement are essential to ensure that the joy of Sankranti does not come at the cost of human lives.



QR Code-Based Footwear Counters Launched at Tirumala to Ease Pilgrim Rush

In a major step towards improving pilgrim convenience and streamlining crowd management, the Tirumala Tirupati Devasthanams (TTD) has introduced a modern QR code-based footwear management system at Tirumala. The initiative aims to eliminate confusion and inconvenience faced by devotees while collecting their footwear after darshan at the Sri Venkateswara Temple.

The new system was inaugurated by TTD Additional Executive Officer C.H. Venkaiah Chowdary and has been rolled out at eight key footwear counters across Tirumala. Following its successful trial run at the Vaikuntha Queue Complex-2, the facility has now been expanded to other high-footfall locations,

including the Matrusri Tarigonda Vengamamba Annaprasadam Complex. Under the upgraded arrangement, devotees depositing their footwear at designated counters are issued a QR code slip instead of the conventional token. The slip contains complete details such as the number of footwear items deposited, size, rack number, box number and exact storage location. Upon return, the QR code is scanned, enabling staff to quickly identify and retrieve the footwear without delay.

TTD officials stated that the new system has significantly improved efficiency and accuracy. While earlier methods resulted in frequent complaints of misplaced or mixed-up footwear, the QR code mechanism has reportedly ensured nearly error-free retrieval.



al. Officials estimate that successful return rates have increased to nearly 99 per cent, greatly enhancing pilgrim satisfaction.

The project has been implemented with the support of Coromandel International Limited as part of its corporate social responsibility initiative. TTD authorities noted that the system not only saves valuable time for devotees but also contributes to better organisation, cleanliness and security at footwear counters.

Speaking on the occasion, the Additional Executive Officer urged pilgrims to use only the officially designated footwear counters and avoid leaving shoes and sandals at random locations around the temple premises. Such practices, he said, create inconvenience, hygiene concerns and additional

burden on sanitation staff. Tirumala witnesses lakhs of devotees every day, particularly during weekends, festivals and peak pilgrimage seasons. Managing footwear for such massive crowds has long been a challenge for the temple administration. The introduction of technology-driven solutions like QR code tracking reflects TTD's continued efforts to modernise pilgrim services while maintaining the sanctity of the holy shrine.

With the successful launch of the QR code-based footwear counters, TTD is expected to further expand similar technology-enabled facilities in other areas of pilgrim management, reinforcing its commitment to providing a smooth and hassle-free darshan experience for devotees from across the country and abroad.

Minister Gunda Appala Suryanarayana Laid to Rest with Full State Honors in Srikakulam

Thousands of mourners lined the streets of Srikakulam as his mortal remains were taken in a procession from Arasavalli through the city's main thoroughfares to the local crematorium. The procession, which lasted several hours, drew massive crowds, turning the urban streets into a sea of grieving people. TDP cadres, party workers, and admirers raised slogans like "Appala Suryanarayana Amar Rahe" (Long Live Appala Suryanarayana), their chants echoing through the city. gunfire salutes into the air. Suryanarayana's son then lit the funeral pyre, marking the end of an era for Srikakulam politics. The 78-year-old leader passed away on Monday evening at 6:40 PM while undergoing treatment at a private hospital in Srikakulam. On Sunday afternoon, he slipped and fell at his residence in Arasavalli, sustaining a severe head injury. Family members rushed him to the hospital, where he was placed on a ventilator. Despite medical efforts, he breathed his last, leaving behind a legacy of dedicated public service. Chief Minister N. Chandrababu Naidu expressed profound shock over Suryanarayana's demise. In a heartfelt condolence message, Naidu recalled his close bond with the leader and praised his simple lifestyle despite holding ministerial office. "Suryanarayana's clean politics and contributions to the party and state are exemplary," Naidu said, assuring the family of the



TDP's unwavering support. He directed district officials to conduct the funeral with full state honors and urged TDP ministers, MLAs, and leaders to attend. Born on January 16, 1948, in Srikakulam, Suryanarayana entered politics in 1981 by winning a municipal election as a councillor. He joined the Telugu Desam Party (TDP) and went on to secure victory as MLA from Srikakulam four consecutive times from 1985 to 2004. In 1987, he was inducted as a minister, serving with distinction. His wife, Gunda Lakshmi Devi, carried forward the family legacy as TDP MLA from 2014 to 2019. Suryanarayana's death has cast a pall of gloom over Srikakulam and the TDP ranks. Known for his grassroots connect and unwavering loyalty to the party, he leaves an indelible mark on Andhra Pradesh politics. Condolences have poured in from across the political spectrum, underscoring his stature as a principled leader.

TDP Leader Chintamaneni Prabhakar Predicts Long NDA Rule in Andhra Pradesh

Iran on the Brink: Unrest, Regime Survival, and India’s Strategic Dilemma

India’s Foreign Secretary Vikram Misri’s understated remark on Monday that New Delhi is “closely watching developments in Iran” masks the gravity of the situation unfolding in West Asia. The unrest sweeping across Iran is not merely another episode of internal dissent. It threatens the survival of the 47-year-old Islamic Republic and carries the potential to trigger a regional crisis with far-reaching economic and strategic consequences for India.

What began two weeks ago as protests in Tehran has rapidly snowballed into a nationwide movement. Demonstrations have now spread to more than 100 cities across all 31 provinces of Iran. As in previous crises, the regime led by Supreme Leader Ayatollah Ali Khamenei has responded with brute force. Human rights organisations report that over 600 protesters have already been killed, while warning that the true toll may be significantly higher due to a nationwide internet blackout that has made verification difficult.

Iran has witnessed waves of anti-government protests ever since the 1979 Islamic Revolution that toppled Mohammad Reza Shah Pahlavi. Yet the current unrest stands out for both its scale and intensity. It has already surpassed the 2022 protests that followed the custodial death of Mahsa Amini, which left at least 550 people dead. That movement was largely feminist in character and centred on opposition to compulsory hijab laws. The present protests are broader, faster-spreading, and socially more diverse, drawing in young men and women, older citizens, and crucially, or-

ganised economic actors.

A Protest or an Uprising?

One of the most striking features of the current unrest is the participation of traders—something not seen since the 1979 revolution itself. The protests were triggered on December 28 in Tehran after the Iranian currency, the rial, collapsed sharply against the US dollar. Traders shut shops and took to the streets, soon joined by students, workers, and other sections of society. Their involvement gives the movement an economic backbone that earlier protests often lacked.

Still, it may be premature to describe the situation as a full-fledged uprising. Despite reports of limited defections within the security forces, there are no definitive signs of an imminent regime collapse. The state’s coercive apparatus remains largely intact.

Years of crippling Western sanctions had already eroded living standards for ordinary Iranians. The situation worsened dramatically after last summer’s conflict with Israel, during which the United States joined in bombing Iranian targets. Inflation crossed 50% last month, unemployment remains stubbornly high, and the rial’s collapse has wiped out savings. The ground for unrest was fertile long before the first slogan was shouted.

Ayatollah Khamenei has blamed foreign powers—primarily the United States and Israel—for orchestrating the protests. Yet the sheer scale and intensity of the demonstrations suggest a deep reservoir of domestic anger. Protesters have openly chanted slogans



against the Islamic regime itself, a rare and risky act in Iran. Exiled crown prince Reza Pahlavi, based in the United States, has urged Iranians to take to the streets, but while his lineage is undeniably Iranian, his influence inside the country remains limited.

Why US Military Action May Backfire

President Donald Trump has been vocal since the unrest began. He warned Iranian authorities that US military action would follow if demonstrators were killed. Despite repeated threats, however, Trump has so far refrained from ordering strikes—even as hundreds of protesters have died. For a leader known for swift and often unilateral military decisions, including the recent US raid on Venezuela and the seizure of President Nicolás Maduro, this hesitation is noteworthy.

Iran, unlike Venezuela,

is a far more formidable adversary. It is nearly the size of Western Europe and retains significant military capabilities despite degradation from Israeli and US strikes last year. Iranian retaliatory attacks on Israel in 2025 forced Tel Aviv into an unusual ceasefire—something Israel has rarely done in conflicts with non-state actors such as Hamas or Hezbollah.

Timing also matters. The US military had months to prepare for the Venezuela operation. Events in Iran have unfolded far more rapidly, leaving little scope for similar logistical and intelligence preparation.

Trump is also likely mindful of America’s disastrous 1980 Operation Eagle Claw, when an attempt to rescue US diplomats held hostage in Tehran ended in failure and humiliation. This does not rule out US military action altogether, but it explains the caution. Any decision would

require careful calibration of targets, timing, and potential escalation.

Moreover, while many Iranians despise the Islamic regime, foreign military intervention—particularly by Israel or the United States—could provoke a surge of nationalist sentiment. Last summer’s US strikes rallied public opinion around the regime rather than weakening it. Trump himself declined Israel’s request at the time to extend military operations aimed at toppling the government.

This context lends weight to Monday’s statement by White House Press Secretary Karoline Leavitt, who said airstrikes were “one of many options” but that “diplomacy is always the president’s first choice.” Simultaneously, Trump announced a punitive 25% tariff on any country conducting business with both Iran and the United States—a move aimed at isolating Tehran economically rather than militarily.

The Pivotal Role of the Revolutionary Guards

The single most important pillar of regime survival is the Islamic Revolutionary Guard Corps (IRGC). Founded shortly after the 1979 revolution by Ayatollah Ruhollah Khomeini, the IRGC was initially tasked with protecting the nascent Islamic state from internal dissent and external threats, particularly from the United States.

Over time, it evolved into a parallel military and economic empire. With nearly 200,000 personnel, its own navy and air force, and an elite external operations wing—the Quds Force—the IRGC exerts enormous influence at home and abroad. It has played a central role in building Iran’s regional proxy network, including Hezbollah in Lebanon and the Houthis in Yemen.

Like Pakistan’s military, the IRGC has entrenched itself deeply in

Iran’s economy, controlling or influencing major sectors. Its institutional survival is inseparable from that of the Islamic regime, making it unlikely to abandon the leadership without a violent struggle. Security personnel accused of firing on protesters are widely believed to belong to IRGC units. The pro-regime rallies organised on Monday would have been impossible without its backing.

Any Western military intervention would inevitably target the IRGC, just as Israel did last year—raising the risk of a wider regional war.

India’s Stakes Could Not Be Higher

For India, the unrest in Iran comes at an especially precarious moment. Unlike Venezuela, Iran is geographically close and strategically vital. It has long been an important trading partner. In the last financial year, India exported goods worth £1.24 billion to Iran and imported roughly a third of that value. India has also cautiously resumed oil purchases from Iran after reducing imports from Russia under US pressure. Trump’s new tariff threat now puts that fragile arrangement at risk.

Military conflict could also prompt Iran to close the Strait of Hormuz, through which more than half of India’s oil and gas imports pass. Any prolonged disruption would severely undermine India’s energy security and economic stability.

Beyond energy, India has invested heavily in Iran’s Chabahar Port, a cornerstone of its strategy to access Afghanistan and Central Asia while bypassing Pakistan. Continued unrest—or regime collapse—

would place that project in limbo. The same applies to the International North–South Transport Corridor linking India to Russia via Iran and Azerbaijan, and the ambitious India–Middle East–Europe Economic Corridor announced at the G20 summit in New Delhi in 2023.

Strategically, instability in Iran could embolden Pakistan. Shortly before last year’s US strikes on Iran, Pakistan’s Army Chief Asim Munir was briefed in Washington. This time, Islamabad could offer logistical support for US action to curry favour with Trump and secure arms deals.

A collapse of the Islamic regime would likely usher in a prolonged period of chaos. There is no clear successor. Reza Pahlavi’s aspirations to lead a transitional government lack broad domestic support and are complicated by his perceived proximity to Israel. Notably, Trump himself has shown little interest in engaging with him.

The Middle East may be heading toward a long phase of instability, with ripple effects across the Gulf. That would threaten oil and gas production, destabilise economies, and imperil the livelihoods of millions of Indian expatriates.

Trump’s caution, therefore, may have less to do with concern for Iranian democracy than with fear of economic and geopolitical blowback. As Venezuela demonstrated, Trump will always prioritise instinct and self-interest. Should Iran’s protesters succeed, he will undoubtedly claim credit. If they fail, the region—and countries like India—will still pay the price.

Trump’s America Unbound: Power, Force, and the Rejection of Global Rules

Barely days into 2026, President Donald Trump has unleashed a series of actions that have shaken the foundations of international politics and alarmed allies and adversaries alike. What has unfolded is not a collection of isolated decisions, but a coherent—and deeply unsettling—worldview: one in which American power is unconstrained by institutions, treaties, or even traditional notions of legality, and where force is regarded as a legitimate and routine instrument of statecraft.

The shock began on Saturday, January 3, when Trump ordered a full-scale US military invasion of Venezuela. The operation culminated in the seizure of President Nicolás Maduro and his wife, their forcible removal from office, and a unilateral declaration that the United States would assume control of the oil-rich South American nation. Within hours, Trump announced that Venezuela would remain under US authority for as long as he deemed necessary.

Before the international community could absorb the implications of this extraordinary move, the White House escalated further. On Monday, senior adviser Stephen Miller appeared on television to assert that Greenland “rightfully belonged” to the United States. He openly suggested that Washington could seize Danish territory if it wished, brushing aside concerns about



NATO or international law. When asked whether the US would rule out the use of force, Miller replied bluntly: “Nobody’s going to fight the United States militarily over the future of Greenland.”

By Thursday, Trump had widened his assault from individual states to the very architecture of global governance. He ordered the US to withdraw from 66 international organisations—35 non-UN bodies and 31 affiliated with the United Nations—on the grounds that they were contrary to American interests. Among the most consequential exits were the UN Framework Convention on Climate Change (UNFCCC), the 2015 Paris Agreement, UN Women, the UN Population Fund, and the UN Conference on Trade and Development (UNCTAD).

‘My Own Morality’

Perhaps most revealing was Trump’s demeanor amid the upheaval. On Wednesday, in a two-hour interview with The New York Times—a publication he frequently denounces—he appeared calm, confident, and unapologetic. Responding to criticism that the Venezuela invasion amounted to imperialism, Trump declared that his powers as Commander-in-Chief were constrained only by his “own morality.” International law, congressional oversight, and multilateral norms, he said, had no meaningful effect on his ability to invade, coerce, or

dominate other nations.

The remark was striking not only for its candor, but for its irony. Trump’s invocation of personal morality comes from a president who has faced multiple allegations of sexual misconduct linked to his association with Jeffrey Epstein. Yet in Trump’s telling, personal judgment—not law—was the ultimate arbiter of legitimacy.

Trump confirmed in the interview that the US planned to extract and refine between 30 and 50 million barrels of Venezuelan oil, worth an estimated \$2.8 billion. He said he would personally oversee the proceeds, claiming the money would be used for the benefit of both Venezuelans and Americans. He offered no explanation of the legal basis for this appropriation,

nor how long the occupation would last—only that it could continue “many years.”

On Greenland, Trump was equally blunt. While acknowledging that the US already operates a military base on the island and could expand its presence through agreements, he insisted that anything short of outright ownership was insufficient. Physical possession, he argued, was “psychologically needed for success,” something a lease or treaty could never provide.

He doubled down on this position over the weekend, declaring, “If it affects NATO, then it affects NATO—but you know, they need us much more than we need them.” As for Iran, Trump suggested that while no immediate action was planned, the option of

military force remained firmly on the table.

A Worldview of Power

Taken together, these statements and actions reveal Trump’s core belief: that national strength—not laws, treaties, or institutions—determines outcomes in global politics. In his worldview, the United States alone decides the limits of its authority, and every tool—military, economic, or political—is fair game to entrench American supremacy.

This philosophy has been evident for some time. Over the past year, Trump has imposed sweeping tariffs on much of the world, weaponising trade policy as a blunt instrument of coercion. He has also openly boasted of joining Israel in military operations against Iran, claiming to have destroyed

its nuclear programme.

The latest withdrawals from international organisations fit neatly into this pattern. Many of the bodies the US is exiting are marginal or long-dormant, suggesting a symbolic gesture aimed at Trump’s MAGA base. Indeed, a significant segment of that base has expressed discomfort with the Venezuela intervention, and with midterm elections approaching, Trump has openly worried that major losses could expose him to indictment.

But the list also includes institutions that matter deeply—to climate action, development finance, human rights, education, renewable energy, counterterrorism, anti-piracy efforts, and global trade governance. These organisations form a crucial part of America’s soft power

and its ability to shape global norms. That Trump appears willing to discard them so casually underscores how little value he places on influence that does not flow directly from coercion.

The Organisations Trump Left Behind

Trump’s hostility to multilateral institutions is not new. In 2020, he withdrew the US from the World Health Organization, accusing it of mishandling the COVID-19 pandemic. That decision was reversed by the Biden administration in 2021, but Trump reinstated the withdrawal immediately upon returning to office in January 2025, citing similar grievances.

In February 2025, the US also exited the UN Human Rights Council, UNESCO, and the UN Relief and Works Agency for Palestine Refugees (UNRWA). Among the most recent withdrawals is the International Solar Alliance (ISA), an intergovernmental body headquartered in Gurugram and championed by India and France following the 2015 Paris Climate Summit. The ISA aims to scale up solar energy and reduce costs globally—goals fundamentally at odds with Trump’s renewed push for fossil fuels. In any case, the US was only an observer, not a full member, making the withdrawal largely symbolic.

India remains an active participant in many of the organisations the US is abandoning. New Delhi’s

foreign policy continues to emphasize multilateralism, particularly on climate change, development, trade, and environmental governance—placing it increasingly at odds with Washington’s unilateral turn.

Selective Multilateralism

Despite his rhetoric, Trump has been careful not to abandon institutions that deliver tangible power. The US remains firmly entrenched in the UN Security Council and the General Assembly, as well as in the World Bank, the International Bank for Reconstruction and Development, and the International Monetary Fund. These bodies grant Washington outsized influence over global finance, development, and security—advantages that far outweigh the political costs of MAGA discontent.

This selective approach reveals the true nature of Trump’s “America First” doctrine. Multilateralism is rejected when it constrains US action or requires compromise, but embraced when it reinforces American dominance. Rules are acceptable only when written by Washington, enforced by Washington, and aligned with Washington’s immediate interests.

In this vision of the world, international law is a fiction, global governance a nuisance, and consent irrelevant. What matters is power—and Trump has made clear that he alone believes he should decide how it is used.

Jaishankar Outlines India’s Priorities for BRICS 2026 Amid Global Uncertainties

External Affairs Minister S. Jaishankar on Tuesday outlined India's vision and priorities for its BRICS 2026 presidency, emphasizing the importance of resilience, innovation, cooperation, and sustainability in navigating a complex and uncertain global landscape. Speaking in New Delhi during the launch of the official logo and website for the 18th BRICS Summit, Jaishankar highlighted the challenges facing the international community, including geopolitical tensions, economic volatility, climate risks, technological shifts, and persistent development gaps.

“BRICS remains an important forum that encourages dialogue, cooperation, and practical responses, while respecting national priorities at different stages of development,” Jaishankar said. He stressed that the grouping, now comprising 11 member countries, serves as a platform for countries to address shared challenges collectively and promote global welfare.

The remarks come at a time when the United States has imposed a 25 per cent penalty tariff on countries trading with Iran, affecting India and Brazil, both BRICS members. Jaishankar reiterated that India's presidency of BRICS would focus on delivering practical solutions while strengthening institutional capacities to withstand global shocks.

India's year-long BRICS chairship will adopt a model



similar to its 2023 G20 presidency, with meetings and delegations spread across all 28 states and nine Union Territories. In addition to the leaders' summit in New Delhi, officials said around 100 ministerial meetings, forums, and working group sessions will be held across 60 cities, including Bangalore, Hyderabad, Chennai, Chandigarh, Ahmedabad, and Lucknow. These gatherings will cover political and security, economic and financial, and cultural and people-to-people exchanges.

Jaishankar highlighted that BRICS cooperation will prioritize agriculture, health, disaster risk reduction, energy, and supply chain resilience.

He also emphasized the role of emerging technologies, startups, and MSMEs in fostering inclusive growth and addressing socio-economic challenges, particularly for developing nations. Sustainability was described as another key pillar, ensuring long-term benefits from collective efforts.

The newly unveiled BRICS logo, a lotus incorporating the colors of all member nations, reflects India's approach to its chairship, combining tradition with modernity. “The petals represent unity in diversity and a strong sense of shared purpose,” Jaishankar said, noting that the design symbolizes the collective strength of BRICS while re-

specting each member's unique identity.

Alongside India, the BRICS summit will see participation from Russia, China, Brazil, South Africa, Egypt, the UAE, and Iran, with partner countries including Saudi Arabia, Ethiopia, Indonesia, Belarus, Bolivia, Kazakhstan, Cuba, Malaysia, Nigeria, Thailand, Uganda, and Uzbekistan expected to engage in dialogue and cooperation initiatives.

India aims to use its presidency to strengthen the grouping's institutional framework and foster practical, sustainable solutions to global challenges, ensuring that BRICS remains relevant in a rapidly changing world.

Rahul Gandhi Backs Vijay Amid Jana Nayagan Controversy, Sparks Speculation on Congress-TVK Political Tie-Up in Tamil Nadu

Senior Congress leader Rahul Gandhi's vocal support for actor Vijay amid the controversy surrounding his film Jana Nayagan has added a new dimension to Tamil Nadu politics. His recent post not only defended Vijay at a critical moment but also fueled speculation that the Congress could consider a political understanding with Vijay's party, the Thalapaty Vijay Katchi (TVK), even as it maintains its longstanding alliance with the DMK.

Rahul Gandhi, the Leader of Opposition in the Lok Sabha, framed the delay in the film's certification by the Central Board of Film Certification (CBFC) as an attack on Tamil culture. He further asserted that Prime Minister Narendra Modi would not be able to silence the voice of the Tamil people. The timing of the post was significant, coinciding with Gandhi's Pongal visit to Gudalur in the Nilgiris, marking his first public appearance after returning from Vietnam. The message carried both cultural symbolism and political weight.



The Jana Nayagan controversy has evolved beyond a film issue. The movie has faced certification delays, legal scrutiny, and disputes over its content, turning it into a flashpoint. Earlier, Congress leaders had defended the filmmakers' creative freedom, while Tamil Nadu Chief Minister M.K. Stalin also criticized political interference in artistic expression. Gandhi's intervention, therefore, heightened the po-

litical stakes of the debate.

Within the Congress, the post has sparked fresh strategic discussions. Some leaders believe forging ties with TVK could give the party an edge, particularly with young and first-time voters drawn to Vijay's popularity. They suggest that joint campaigns led by Vijay and Rahul Gandhi could resonate strongly at the grassroots level and potentially reshape the political mood in the state.

However, not all in the party share this view. Senior leaders caution against straying from the long-standing DMK alliance, which has provided stability, political relevance, and electoral benefit over the years. They argue that experimenting with a new political formation carries risk and that the current situation could instead be leveraged to secure greater influence within the existing alliance.

Tamil Nadu's political landscape has been evolving since the passing of J. Jayalalithaa and M. Karunanidhi, creating space for new players. Vijay, with his star power and growing political assertiveness, is emerging as a figure who can sway voters and shape discourse.

The Congress plans to conduct surveys to assess public sentiment, alliance preferences, and ground realities. These findings will likely determine whether Rahul Gandhi's post was merely symbolic support for a popular actor or an early indicator of a strategic recalibration in Tamil Nadu.

Operation Sindoor Ongoing, India Ready to Respond to Any Misadventure: Army Chief Gen Dwivedi

Army Chief General Upen-dra Dwivedi on Tuesday reaffirmed India's strong stance on national security, stating that Operation Sindoor remains ongoing and any misadventure by adversaries will be met with decisive action. Speaking at a press conference, he emphasized that the Indian Army continues to maintain high alert along multiple fronts, sending a clear message to Pakistan about India's preparedness to counter threats.

“Operation Sindoor remains ongoing, and a future misadventure will be resolutely responded to,” Gen Dwivedi said, highlighting the operation's strategic significance in India's counter-terrorism and national defense posture. He explained that the operation has been instrumental in re-setting strategic assumptions, targeting cross-border terror infrastructure, and challenging Islamabad's longstanding nuclear rhetoric.

Elaborating on the operational objectives, the Army chief described Operation Sindoor as a calibrated, precise, and resolute response to



cross-border terrorism, demonstrating India's strategic clarity and military readiness. The operation has not only neutralized threats but also showcased India's ability to undertake deep-strike actions when necessary, reinforcing the country's deterrence capabilities.

On the northern front, along the Line of Actual Control (LAC) with China, Gen Dwivedi said the situation remains stable but requires continuous vigilance. “Renewed contact and confidence-building measures are contributing to the gradual normalization of

the situation,” he noted, emphasizing that the Army is prepared for any eventuality while working to strengthen trust and communication with its counterpart forces.

The Army chief also underlined ongoing efforts to enhance capabilities and infrastructure through a whole-of-government approach, ensuring that the armed forces remain equipped to respond effectively to both conventional and unconventional threats. He stressed that readiness and capability development are integral to India's security strategy.

Kerala CM Pinarayi Vijayan Leads Sit-In Protest Over Union Government’s Financial Restrictions



Kerala Chief Minister Pinarayi Vijayan, along with his Cabinet colleagues, MLAs, and leaders of the ruling Left Democratic Front (LDF), staged a sit-in at the Martyrs' Column in Thiruvananthapuram on Monday, protesting what they described as severe financial restrictions imposed on the state by the Union government. The demonstration was organized to draw attention to what the state views as arbitrary curbs on its constitutional financial rights.

Addressing the protesters, Vijayan accused the Centre of attempting to “financially strangle” Kerala. He said, “Many of Kerala's constitutional rights as a state in this country are being taken away. This is an extraordinary situation where we are compelled to protest in order to safeguard our rights, which are being snatched away by rulers at the Centre who believe they hold excessive

power.”

The Chief Minister highlighted the latest restrictions on state funds, noting that Kerala was entitled to receive Rs 12,000 crore from the Centre in the last quarter of the financial year. However, the Union government has released only Rs 6,100 crore, effectively denying Rs 5,900 crore without any justification, he said. Vijayan emphasized that these funds were crucial for the state to meet various expenditures during the critical final three months of the fiscal year.

“This is not about seeking handouts from the Centre,” Vijayan clarified. “We are demanding what is rightfully owed to Kerala. The state stands firm in its resolve and will resist every attempt to undermine its constitutional rights.” He reiterated that the LDF government would continue to defend the state's interests, both politically and legally, against any perceived

overreach by the Union government.

The sit-in at the Martyrs' Column drew widespread attention, with several LDF leaders highlighting Kerala's contributions to the national exchequer and the disproportionate nature of the cuts. The protest also sought to underline the importance of federalism and the constitutional principle that states should have autonomy in managing their finances without undue interference from the Centre.

The Kerala government has indicated that it will continue to pursue the matter through legal and political channels while mobilizing public opinion. By staging a day-long protest, the LDF aims to send a strong message that the state will not accept arbitrary financial restrictions that threaten its ability to deliver essential services and maintain fiscal stability.

AAP MP Raghav Chadha Applauds Centre’s Move to Remove “10-Minute Delivery” Branding from Quick-Commerce Platforms



Aam Aadmi Party (AAP) MP Raghav Chadha on Tuesday welcomed the central government's intervention to remove the controversial “10-minute delivery” branding from quick-commerce platforms, calling it a much-needed step to protect delivery agents from exploitative work conditions.

Chadha, who has been vocal about the pressures faced by gig workers, expressed his gratitude on X (formerly Twitter), highlighting the constant and dangerous stress imposed on riders by the unrealistic promise of ultra-fast deliveries. “I am deeply grateful to the Central Government for its timely, decisive and compassionate intervention in enforcing the removal of the ‘10-minute delivery’ branding from quick-commerce platforms. This is a much-needed step because when ‘10 minutes’ is printed on a rider's t-shirt, jacket, or bag, and a timer runs on the customer's screen, the pressure is real, constant, and dangerous,” Chadha

wrote.

The MP further emphasized that the working conditions of many delivery partners are exploitative. Over the past months, he said, he had interacted with hundreds of riders who are overworked, underpaid, and often risking their lives to meet impossible delivery deadlines. Chadha thanked citizens who supported the campaign, saying their solidarity stood for human life, safety, and dignity.

Chadha has repeatedly raised the issue in Parliament, urging the government to regulate the gig economy and protect delivery agents. In the Rajya Sabha, he described gig workers as the “invisible wheels of the Indian economy,” highlighting that they often work under conditions worse than daily wage labourers while adhering to strict and unrealistic timelines set by algorithms.

In December, Chadha shared a tweet highlighting the plight of a Blinkit delivery agent who earned only

Rs 763 for 15 hours of work, calling it “systemic exploitation hidden behind apps and algorithms.” Following this, Chadha invited the delivery partner, identified as Thapliyal Ji from Uttarakhand, to his residence for lunch, further demonstrating his commitment to engaging directly with workers to understand their challenges.

The removal of the “10-minute delivery” branding is seen as a significant step in addressing safety and labour concerns in India's rapidly growing quick-commerce sector. The move underscores the importance of prioritizing the welfare of gig workers, who form a critical part of the country's economy, over unrealistic business-driven timelines.

Chadha's advocacy highlights a growing focus on labour rights in India's gig economy, emphasizing that fast delivery promises should never come at the cost of human life, safety, and dignity.

US Revokes Over 100,000 Visas in 2025, Including 8,000 Student Visas Amid Tougher Immigration Screening



The United States revoked more than 100,000 visas in 2025, including roughly 8,000 student visas, as part of a heightened effort to tighten immigration and ensure public safety, the US State Department announced on Tuesday. The number marks a significant increase from 2024, when around 40,000 visas were cancelled, highlighting a more aggressive approach under the current administration, according to a report by Fox News.

In a statement posted on social media, the State Department noted that approximately 2,500 specialized visas were also revoked for individuals who had encounters with US law enforcement due to criminal activities. “We will continue to deport these thugs to keep America safe,” the department said, emphasizing the government’s zero-tolerance stance toward foreign nationals involved in criminal offenses.

State Department Principal Deputy Spokesperson Tommy Pigott explained that the majority of revocations involved foreign nationals who had been charged with or convicted of crimes. “That includes revoked visas from thousands of foreign nationals charged or convicted with crimes, including assault, theft, and driving under the influence,” he said. The action extended beyond routine visa over-stays to include serious legal infractions by visitors.

While most of the cancelled visas were held by business and tourist travelers who had overstayed their permitted duration, a significant number also included students and

specialized workers. Among specialized workers, about half of the revocations were linked to drunken driving arrests, with the rest involving assault, theft, child abuse, drug offenses, and fraud. Meanwhile, nearly 500 student visas were revoked due to drug possession or distribution charges.

Pigott underscored that the administration would maintain what he described as an “aggressive” enforcement approach, supported by the establishment of a new “continuous vetting center” to monitor visa holders. He reiterated the government’s message that a US visa is a privilege, not a right, and that all available information—including criminal records—is considered during the screening process.

The move reflects a broader effort by the administration to prioritize national security and public safety amid increasing concerns over foreign nationals committing crimes in the US. By expanding visa revocations to include both students and specialized workers, the government signals that no category of foreign national is exempt from scrutiny.

As the US continues to tighten immigration enforcement, officials emphasize that revocations are part of a broader strategy to deter criminal activity and ensure that visa holders adhere to the laws and regulations governing their stay. The action is expected to continue as the administration reinforces the message that compliance with legal and safety standards is mandatory for all foreign visitors.

Venezuelan Opposition Leader María Corina Machado to Visit White House, Meet Trump Amid Political Uncertainty



Venezuelan opposition leader María Corina Machado, winner of the 2025 Nobel Peace Prize, is scheduled to visit the White House on Thursday and meet US President Donald Trump, a senior White House official confirmed on Monday. The meeting comes amid deep political uncertainty in Venezuela following a dramatic U.S. military operation that resulted in the capture of Venezuelan President Nicolás Maduro.

Machado’s visit is closely watched as Trump has so far declined to endorse her as Venezuela’s leader despite her international recognition and Nobel accolade. After U.S. forces carried out the operation in Caracas on January 3 and detained Maduro and his wife, Trump said it would be difficult for Machado to lead Venezuela because, in his view, she lacks widespread support and respect among her own people.

Machado, who was awarded the Nobel Peace Prize in 2025 for her longstanding advocacy for democratic change in Venezuela, has publicly expressed gratitude for U.S. support. In recent weeks, she suggested she would like to present or share her Nobel Peace Prize with Trump in appreciation of his role in ousting Maduro — an idea Trump described as “a great honour.” However, the Norwegian Nobel Institute has clarified that the Peace Prize cannot be transferred, shared, or revoked once

awarded.

In a statement to international media, Machado described her planned White House visit as an opportunity to personally thank the U.S. president and discuss Venezuela’s path forward. Meanwhile, Trump has signaled openness to the meeting without committing to support her political leadership. In past remarks, he said, “She’s a very nice woman, but she doesn’t have the respect or support within the country,” indicating hesitancy to back her as the nation’s transitional leader.

The political landscape in Venezuela remains highly fluid. After Maduro’s capture, Delcy Rodríguez, his former vice president, was sworn in as acting president, complicating the opposition’s plans for a democratic transition. Many opposition leaders, including Machado, are currently in exile or under pressure, even as they seek international backing for elections and political reform.

Machado’s scheduled visit to Washington underscores both her international stature and the ongoing diplomatic efforts to shape Venezuela’s future. As she engages with U.S. leadership, observers will be watching closely to see whether the meeting produces heightened support for democratic transition efforts or clarifies Washington’s position on leadership in post-Maduro Venezuela.

Iran Acknowledges Over 2,000 Deaths Amid Nationwide Protests, Blames “Terrorists”

Iran has confirmed that more than 2,000 people, including security personnel, have died in the ongoing nationwide protests, marking the first official acknowledgment of the high death toll since the demonstrations began in late December. The confirmation came from an Iranian official speaking to Reuters on Tuesday, highlighting the scale of the unrest that has now entered its third week. However, the official did not provide a breakdown between protesters and security forces killed, instead attributing the fatalities to “terrorists.”

This admission contrasts with earlier reports from activist groups based in the United States, which indicated that hundreds of protesters had been killed and thousands more arrested during the widespread demonstrations across major Iranian cities. Security forces have been engaged in an intense crackdown, using lethal force to suppress the unrest, which has drawn international attention and criticism.

The protests initially erupted due to the country’s worsening economic conditions, including rising prices, unemployment, and inflation. However, they rapidly evolved into a broader movement against the theocratic re-



gime led by Supreme Leader Ayatollah Ali Khamenei and President Masoud Pezeshkian. Citizens have voiced grievances not only over economic hardship but also over systemic political and social issues, making this one of the most significant internal challenges the Iranian government has faced in the past three years.

The unrest comes at a time when Iran is already under heightened international pressure following

US and Israeli strikes in June of the previous year. The combination of domestic dissent and external geopolitical pressures has intensified the sense of crisis within the country’s leadership.

In response to the protests, Iran’s clerical authorities have taken a dual approach. While they have recognized that citizens have legitimate concerns over economic struggles, they have simultaneously enforced strict crackdowns on dem-

onstrators. Security forces have been deployed extensively, and numerous arrests have been made to quell the unrest. Iranian officials have also accused the United States and Israel of instigating the protests, claiming that foreign-backed “terrorists” have hijacked peaceful demonstrations to destabilize the country.

President Masoud Pezeshkian’s administration faces mounting criticism both at home and abroad as it navigates the twin

challenges of public discontent and international scrutiny. Despite the government’s attempts to control the narrative, the protests have shown resilience, indicating widespread frustration among Iranians over economic and political grievances.

As the unrest continues into its third week, the situation in Iran remains tense, with growing fears of further violence and international concern over the government’s handling of the protests.

China Condemns Trump’s Threat of 25% Tariffs on Countries Trading with Iran

China has voiced strong opposition to U.S. President Donald Trump’s threat to impose a 25 per cent tariff on countries doing business with Iran, describing the move as coercive, unilateral, and counterproductive, according to a report by Reuters. The warning came after Trump announced on social media that the United States would levy the tariff on all goods and services imported from any nation maintaining trade relations with Iran.

In a statement posted on X, a spokesperson from the Chinese embassy in Washington said Beijing “firmly opposes any illicit unilateral sanctions and long-arm jurisdiction.” The spokesperson further emphasized China’s longstanding position against the “indiscriminate imposition of tariffs,” adding that “tariff wars and trade wars have no winners, and coercion and pressure cannot solve problems.”



Trump’s directive, which he described as “final and conclusive,” aims to penalize countries that continue to engage economically with Iran. The order is global in scope and is expected to particularly affect major trading partners of Iran, including China, India, Turkey, the United Arab Emirates, and the European Union, due to their strong commercial and

energy ties with the Islamic Republic.

China is Iran’s largest trading partner, accounting for nearly 30 per cent of Iran’s total foreign trade and the bulk of its oil exports. However, official Chinese customs data released in late December 2025 indicated that trade between the two nations fell by 24 per cent during the first eleven months of the year.

Beijing’s response highlights its concern about the potential economic impact of Trump’s tariff threat, which could disrupt established trade flows and increase geopolitical tensions.

Trump has linked the tariffs to Iran’s ongoing internal crackdown on anti-government protests, during which hundreds of protesters and security personnel have

reportedly been killed. The protests, along with severe restrictions on internet access, have drawn international condemnation, and Trump’s tariff threat is seen as a further measure of economic pressure on Iran and its trading partners.

The U.S. president plans to use his executive authority to impose the tariffs without requiring congressional approval. However, the broader scope of his tariff powers is currently being challenged in the U.S. Supreme Court, which is expected to issue a ruling this week. The outcome of the court case could influence the enforceability of Trump’s directive and shape the future of U.S.-Iran trade sanctions.

Beijing’s firm objection reflects ongoing tensions between the U.S. and China over global trade policies and underscores the challenges that unilateral sanctions pose for international economic cooperation.

Canadian Police Arrest Key Suspect in 2023 Toronto Airport Gold Heist



Canadian authorities have arrested a 43-year-old man in connection with the 2023 gold heist at Toronto Pearson International Airport, which investigators have described as the largest theft of its kind in the country’s history.

Arsalan Chaudhary was taken into custody on Monday after arriving in Toronto on a flight from Dubai. Peel Regional Po-

lice confirmed that Chaudhary coordinated his surrender through his lawyers upon landing. He faces multiple charges, including theft over C\$5,000, two counts of possession of property obtained by crime, and conspiracy to commit an indictable offence. Chaudhary remains in custody pending a bail hearing.

Peel Regional Police Chief Nishan Duraipapp

highlighted the role of international cooperation in the arrest, emphasizing that law enforcement partners across borders played a crucial part. “No matter where you try to run or hide, we will find you,” he said, according to ABC News.

The heist occurred on April 17, 2023, when a flight from Zurich, Switzerland, landed in Toronto carrying approximate-

ly 400 kilograms of gold, valued at over \$20 million (around ₹1,660 crore at the time), alongside about \$2.5 million in foreign currency (around ₹207 crore). The cargo was transferred to a holding area at the airport and was reported missing the following day.

Investigators have said the theft involved coordination between airport insiders and external actors. Some Air Canada employees are alleged to have facilitated the theft by diverting the shipment, while Chaudhary is accused of belonging to the external group. According to court documents cited by ABC News, he allegedly played a central role in planning the heist and coordinating the movement and sale of the stolen gold outside Canada. These allegations, however, have not yet been tested in court.

Police identified another

key suspect, former Air Canada employee Simran Preet Panesar, who is believed to be in India. A Canada-wide warrant has been issued for his arrest. Additionally, two other suspects from Brampton, Ontario, remain at large.

The investigation, named Project 24K, is ongoing, and authorities have indicated that further arrests may be forthcoming. The case has drawn attention for the scale of the crime, the involvement of airport personnel, and the international efforts required to apprehend suspects and recover the stolen assets.

The successful arrest of Chaudhary underscores the ability of Canadian law enforcement to track suspects across borders and coordinate with international partners, sending a strong message to others who might consider engaging in similar high-value crimes.

Sensex, Nifty End Lower After Early Gains as Profit Booking, FII Outflows Weigh



Benchmark equity indices Sensex and Nifty erased early gains and closed lower on Tuesday after a volatile trading session, as investors booked profits across major sectors amid continued foreign fund outflows and selling pressure in heavyweight stocks.

The Sensex declined 250.48 points, or 0.3 percent, to close at 83,627.69. During the session, it had slipped as much as 615.38 points, or 0.73 percent, to an intraday low of 83,262.79. The Nifty50 also ended lower, shedding 57.95 points, or 0.22 percent, to settle at 25,732.30.

Markets had opened on a positive note, extending Monday's rebound when both indices gained around 0.4 percent, snapping a five-session losing streak that had dragged benchmarks down nearly 2.5 percent. Sentiment was initially lifted by optimism over renewed momentum in India-US trade talks after comments from a US envoy suggested discussions on trade issues were likely.

However, the rally proved short-lived as selling pressure emerged in auto, IT and pharmaceutical stocks, dragging the indices into the red by mid-session.

Among Nifty50 stocks, Larsen & Toubro, Dr. Reddy's Laboratories and Cipla were among the top laggards, falling up to 2 percent. On the other hand, ETERNAL and Oil & Natural Gas Corporation gained up to 3

percent, providing limited support to the index.

Key Reasons Behind the Market Decline

Profit booking:

Investors locked in gains after the indices rose nearly 0.5 percent in early trade. On Monday, both Sensex and Nifty had staged a sharp intraday recovery of about 1.2 percent from their lows following comments by US envoy Sergio Gor, which led to unwinding of bearish positions.

Sustained FII selling:

Foreign institutional investors (FIIs) remained net sellers, offloading equities worth Rs 3,638.40 crore on Monday. This marked the sixth consecutive session of net selling after a brief pause on January 2, keeping pressure on domestic markets due to continued capital outflows.

Rupee weakness:

The rupee weakened by 5 paise to 90.22 against the US dollar in early trade, pressured by a stronger greenback, rising crude oil prices and persistent foreign fund outflows. A weaker currency typically dampens market sentiment, particularly for import-heavy sectors.

Trump's tariff announcement:

US President Donald Trump announced a 25 percent tariff on countries "doing business" with Iran. The move raised concerns over global trade disruptions, es-

pecially for countries such as India, China and the UAE, which maintain trade ties with Iran.

Commenting on the development, Dr. VK Vijayakumar, Chief Investment Strategist at Geojit Investments, said geopolitical developments and President Trump's policy actions would continue to influence markets. He noted that the "weaponisation of tariffs" has already impacted global trade and that the latest announcement reinforces the continuation of this strategy.

Nifty weekly expiry:

Tuesday was also the weekly expiry day for Nifty derivatives contracts, which often leads to heightened volatility as traders roll over or square off positions.

Muted IT earnings:

IT stocks came under pressure after Tata Consultancy Services reported a 13.91 percent year-on-year decline in December quarter profit to Rs 10,657 crore, largely due to a one-time impact of new labour codes. HCL Technologies reported an 11.2 percent drop in consolidated net profit to Rs 4,076 crore.

Shares of HCL Technologies fell over 2 percent as brokerages remained cautious. HSBC and CLSA reiterated 'Hold' ratings, with CLSA flagging the risk of sequential revenue decline in the March quarter due to seasonal weakness. TCS shares also slipped amid concerns over a

subdued demand outlook, despite stable margins.

Higher crude oil prices:

Brent crude rose 0.3 percent to USD 64.06 per barrel. Elevated oil prices tend to strain India's trade balance and inflation outlook, weighing on equity sentiment.

Weak global cues:

Asian markets remained subdued, with Shanghai's SSE Composite trading marginally lower. US futures were also down up to 0.3 percent, signalling a weak start for Wall Street.

Technical Outlook

Nagaraj Shetti, Senior Technical Research Analyst at HDFC Securities, said Nifty failed to sustain early gains after opening with an upside gap and slipped into weakness during the early-to-mid session. However, buying interest emerged near the 25,600 level, helping the index recover from intraday lows and close off the bottom.

He noted that a long bearish candle with a long lower shadow formed on the daily chart, indicating strong resistance around the 25,900-26,000 zone. At the same time, buying near support levels is a positive sign. According to Shetti, the short-term trend remains positive, and a higher-bottom formation on the intraday chart suggests the possibility of a breakout above the 25,900-26,000 range in the coming sessions, with immediate support seen at 25,600.

Infosys Q3 Results Preview: Modest Growth, Margin Stability in Focus



Information technology major Infosys Ltd. is scheduled to announce its December quarter (Q3FY26) earnings on Wednesday, January 14, 2026. Market participants will closely track revenue momentum, margin performance, and any potential changes to the company's full-year guidance amid a seasonally weak quarter for the IT sector.

According to estimates compiled by Business Standard, Infosys is expected to report an average net profit of ₹7,315.83 crore for Q3FY26, reflecting a year-on-year growth of about 7 percent compared with ₹6,822 crore in the same quarter last year. On a sequential basis, however, profit is likely to edge down marginally by 0.64 percent from ₹7,364 crore reported in Q2FY26.

Revenue for the quarter is projected to rise nearly 8 percent year-on-year to ₹45,206.68 crore, up from ₹41,764 crore in Q3FY25. Sequentially, revenue is expected to increase by around 2 percent from ₹44,490 crore in the September quarter, supported by deal ramp-ups, though furloughs and fewer working days are likely to cap growth.

Brokerage Expectations

Nomura expects Infosys' revenue to decline 0.5 percent quarter-on-quarter in constant currency terms, citing seasonal weakness. On a year-on-year basis, pass-through revenues may remain subdued, while discretionary demand in the financial services segment is seen improving modestly. The brokerage anticipates a 40 basis point sequential improvement in Ebit margin to 21.4 percent, driven largely by currency benefits. Nomura expects Infosys to narrow its FY26 revenue growth guidance to 2.5-3 percent year-on-year, while maintaining an Ebit margin band of 20-22 percent.

Kotak Institutional Equities expects a gradual improvement in margins, aided by benefits from the company's cost optimisation initiative, Project Maximus. The brokerage forecasts a strong total contract value (TCV) of \$4.5-5 billion—nearly double year-on-year—driven by a £1.2 billion mega deal with NHSBSA. Ebit is estimated at ₹9,513 crore versus ₹9,353 crore in Q2FY26. Kotak expects Infosys to revise its FY26 revenue growth guidance to 2.5-3 percent from the earlier 2-3 percent range. Its estimates do not factor in the pending Versent Group acquisition.

Motilal Oswal Financial Services anticipates flat sequential revenue growth in constant currency terms due to seasonal furloughs, with second-half growth expected to trail the first half. Operating margins are projected to remain stable in the absence of wage hikes and lower third-party costs. Ebit is pegged at around ₹9,500 crore, with margins seen at 21.1 percent. The brokerage expects US BFSI demand to remain resilient, while retail demand stays muted amid tariff-related uncertainties.

Axis Direct projects a 2.7 percent sequential revenue increase to ₹45,679 crore, with Ebit margins improving 14 basis points to 21.2 percent, driven by ongoing cost optimisation efforts.

Overall, the focus will remain on margin resilience, deal pipeline strength, and any tweaks to Infosys' FY26 guidance.

IFCI Shares Surge for Second Day as NSE IPO Buzz Fuels Heavy Buying and Technical Breakout Hopes



IFCI share price extended its rally for the second straight session on Tuesday, rising as much as 5.6 per cent intraday amid exceptionally high trading volumes. Over the past two sessions, the stock has jumped 17.53 per cent, drawing strong interest from market participants.

Trading activity in IFCI surged sharply, with volumes on the National Stock Exchange (NSE) reaching nearly 17 times the stock's 30-day daily average. According to Bloomberg data, the relative strength index (RSI) stood at 65.47, indicating strong momentum without yet entering overbought territory. During the session, the stock touched an intraday high of ₹59.60, its highest level since October 31, 2025.

In the previous session, IFCI shares had surged over 19 per cent on heavy volumes, prompting stock exchanges to seek clarification from the company regarding the unusual price and volume movement. IFCI has yet to respond to the exchange query. On a year-on-year basis, the stock has gained 11.83 per cent over the past 12 months, broadly in line with the Nifty 50 index, which has risen 11.22 per cent during the same period.

Market participants attribute the recent rally to optimism surrounding the long-awaited initial public offering (IPO) of the National Stock Exchange (NSE). Shares of capital market-related companies and exchange-linked entities have seen increased buying interest following reports that the Securities and Exchange Board of India (Sebi) may soon clear the IPO. According to a Reuters report, NSE Ltd is planning to file its draft red herring prospectus by the end of March.

IFCI's connection to the NSE has further fueled investor enthusiasm. The company holds a 52.68 per cent stake in Stock Holding Corporation of India, which in turn owns a 4.4 per cent stake in the NSE, as reported by the Financial Express. Adding to the optimism, Sebi Chairman Tuhin Kanta Pandey recently stated that the regulator would soon issue a no-objection certificate (NOC) to NSE, after which the exchange would begin preparations for its public listing.

From a technical perspective, analysts note that IFCI has been trading in a broad consolidation range of ₹46-₹60 for over six months. Vipin Kumar, assistant vice president of derivatives and technical research at Globe Capital Market, said the stock has now reached the upper end of this range on strong volumes. A decisive close above ₹60 could pave the way for a move towards ₹70 and higher levels in the near term.

Jigar S. Patel, senior manager for equity technical research at Anand Rath Share and Stock Brokers, advised investors to consider accumulating the stock in a staggered manner in the ₹56-₹58 range, with a stop loss below ₹54 on a daily closing basis. He sees a potential target of 70 over a two-to-three-month timeframe, adding that the overall technical setup continues to support further upside.

Shadowfax Flags Franchisee Dependence, Client Concentration, and Cash Flow Risks in UDRHP

Logistics solutions provider Shadowfax has flagged multiple operational and financial risks in its Updated Draft Red Herring Prospectus (UDRHP), including its reliance on third-party franchisees, leased infrastructure, client concentration, and persistent losses.

A key risk highlighted by the company is its dependence on third-party franchisees for a portion of its last-mile delivery operations. Shadowfax warned that any failure on the part of these franchisees or disruptions in its business relationships with them could adversely affect service quality, financial performance, and brand reputation.

"We depend on third-party franchisees for a portion of our last-mile deliveries, and any failure in their performance or disruptions in our business relationships with them could adversely impact our service quality, financial performance, and reputation," the company said in the UDRHP.

Shadowfax also pointed to risks stemming from its infrastructure strategy, noting that it operates entirely out of leased logistics facilities as of September 30, 2025. Some of these lease agreements contain irregularities, and the company cautioned that any failure to renew existing leases or secure suitable alternatives could materially and adversely impact its business operations.

In addition, the company disclosed a history of losses and negative cash flows. Shadowfax



incurred losses of ₹142.64 crore in FY23 and ₹11.88 crore in FY24, and reported negative cash flows from operating, investing, and financing activities during certain periods. The company warned that losses and negative cash flows could persist as it expects expenses to rise in the future.

While revenue from operations increased significantly—from ₹1,415.12 crore in FY23 to ₹2,485.13 crore in FY25—Shadowfax cautioned that historical growth rates may not be indicative of future performance. Any failure to manage growth effectively or execute its business strategy could hinder expansion and negatively affect future prospects.

The UDRHP also underscored the company's reliance

on a large and unified logistics network. As of September 30, 2025, Shadowfax operated 4,299 touchpoints across first-mile and last-mile centres and sort centres, supported by over 3.50 million square feet of operational space and covering 14,758 pin codes. Disruptions to this network could materially impact operations, financial condition, and cash flows.

Operational risks related to delivery execution were also highlighted. The company warned that mishandling of goods by delivery partners could result in inefficiencies and client dissatisfaction, potentially affecting business performance and results.

Shadowfax further disclosed significant customer

concentration risks. Its largest client accounted for 48.91 per cent, 51.23 per cent, 48.00 per cent, 59.23 per cent, and 59.52 per cent of revenue from operations for the six-month periods ended September 30, 2025 and 2024, and for FY25, FY24, and FY23, respectively. The loss of any major client could have a material adverse impact on the business.

Finally, the company flagged risks associated with cash-on-delivery transactions. Some clients prefer this payment method, requiring Shadowfax to act as a limited agent for brands, merchants, and quick-commerce platforms. This exposes the company to operational complexities and potential cash-handling risks, the UDRHP noted.

Canadian Influencer Questions ‘Silicon Valley of India’ Tag, Sparks Identity Debate Online



A Canadian tech influencer who has lived in India for more than eight years has triggered a lively debate on social media after questioning the logic behind calling Bengaluru the “Silicon Valley of India.” Caleb Friesen, in a video shared online, argued that such comparisons are not only geographically inaccurate but also culturally limiting, urging Indians to stop benchmarking their cities and industries against foreign counterparts.

Friesen pointed out that Bengaluru is often compared to Silicon Valley in the United States despite the obvious difference in geography. “Bengaluru isn’t even a valley—it’s a plateau,” he noted, adding that the label feels forced and unnecessary. According to him, India’s cities should be recognised for what they are, rather than being framed as versions or replicas of places elsewhere in the world.

Expanding on the idea, Friesen criticised a broader trend among vloggers and content cre-

ators who market Indian destinations through foreign comparisons. He cited examples such as Pondicherry being called “India’s Thailand” or Gulmarg being likened to Switzerland. While such labels may grab attention, Friesen argued that they ultimately reduce India’s rich and diverse locations to imitations, stripping them of their unique character and cultural depth.

He also took aim at India’s film industries for adopting Hollywood-inspired names like Bollywood and Tollywood, calling it an unnecessary search for external validation. In contrast, he pointed out that countries such as South Korea have globally successful film and entertainment industries without referencing Hollywood in their naming conventions.

Friesen further highlighted how China brands its tech hubs with original identities, citing cities like Shenzhen rather than borrowing names from the West. He also mentioned a recurring social media trend

in Bengaluru, where the annual blooming of pink trumpet trees is often compared to Japan’s cherry blossoms. Calling it a “bad habit,” he wrote on X that derivative descriptions weaken India’s individuality.

Supporting his argument, Friesen referenced an interaction on X where a user suggested to Zomato CEO Deepinder Goyal that India needs a local version of American entrepreneur Bryan Johnson. Goyal replied that India should focus on being its authentic self—a sentiment Friesen strongly endorsed.

The influencer’s comments struck a chord with many users, who echoed his views on mental colonisation and the need to reclaim India’s identity. Several agreed that India’s cities, people, and achievements deserve appreciation on their own terms, without Western comparisons.

As the debate continues, Friesen’s message remains clear: India does not need to resemble anything else to be remarkable—it already is.

From Parking Lot to Podcast Studio: How One Question Transformed a Mumbai Security Guard’s Life



Sometimes, life-changing opportunities emerge from the most ordinary moments. In Mumbai, a brief conversation in an apartment parking lot set the stage for a remarkable transformation in the life of Aniket Katkar, proving that curiosity, courage, and a willingness to learn can open unexpected doors.

Two years ago, Aniket Katkar was working as a security guard in a residential building when he crossed paths with digital creator and podcaster Kushal Lodha. Rather than letting the moment pass, Katkar gathered the courage to approach Lodha and share his long-held interest in videography. He expressed a strong desire to learn how to create videos and politely asked if he could meet Lodha at a later time to understand the craft better.

Lodha later shared this inspiring journey on social media, revealing how

that simple interaction marked the beginning of Katkar’s professional growth. Impressed by Katkar’s enthusiasm and sincerity, Lodha agreed to meet him the following Sunday. Meta Engineer Slams Traditional Job Applications After 670 Rejections, Sparks Online Debate

A software engineer at Meta has ignited widespread discussion online after openly criticising the traditional job application process and sharing how a change in strategy transformed his career prospects. Marmik Patel, who is based in San Francisco, described applying for jobs as “the dumbest thing” after submitting 670 applications and reaching out to more than 1,000 recruiters—without landing a single opportunity.

Patel shared his experience in a detailed post on X (formerly Twitter), highlighting the frustration many job seekers face in today’s highly competitive tech market. Despite having strong credentials, he found that mass applications and cold messages yielded little to no response. The experience prompted him to rethink how hiring works in modern tech ecosystems.

Instead of continuing with the conventional approach, Patel decided



to invest his energy in building products, creating content, and networking in person. He began attending tech meetups and events in major hubs such as San Francisco and New York City, where direct interactions allowed him to showcase his skills and ideas more effectively.

The shift, Patel said, led to dramatic results. “Between January and May, 83 recruiters mes-

saged me,” he wrote, adding that he heard back from leading AI labs, Y Combinator-backed startups, and several unicorn companies. According to Patel, the job market increasingly favours a small group of highly visible and differentiated candidates, making it essential to stand out beyond a résumé.

Summing up his philosophy, Patel re-

marked, “It’s a winner-takes-all world. You have no choice but to become the winner.” His post quickly gained traction, amassing over two lakh views and resonating with job seekers, entrepreneurs, and professionals across industries.

The responses reflected a growing scepticism about traditional hiring methods. One user commented, “It’s right—help

yourself first before applying to help others,” emphasising the importance of self-development. Another compared job hunting to product building, saying, “You can cold email 1,000 users or build something people actually talk about. One takes forever, the other compounds.”

Others shared actionable advice for career growth in today’s landscape. A popular comment outlined a four-step approach: acquire skills, stack those skills, teach what you learn publicly, and build credibility over time. Many agreed that personal branding, visibility, and value creation are increasingly critical in a world where opportunities often flow to those who are seen and remembered.

Patel’s experience underscores a broader shift in how careers are built—away from mass applications and toward initiative, creativity, and authentic engagement.

Wesley So Criticizes Multiple ‘World Champion’ Titles, Says D Gukesh Alone Holds Official Chess Crown

The 2026 chess calendar is shaping up to crown multiple “world champions,” but American Grandmaster Wesley So believes there should be only one official titleholder: India’s D Gukesh, the reigning classical World Champion.

So, who recently won the blitz segment at the Tata Steel Chess tournament in Kolkata, expressed concern over what he sees as the dilution of the World Chess Championship. This year alone, players could claim multiple titles — from the classical championship to rapid, blitz, Freestyle, and the newly announced Total Chess World Championship, which will be piloted in 2026 and fully launched in 2027.

“It’s weird that you have a ‘Total Chess World Champion’ title, but we all know Gukesh is the official World Champion. There should only be one World Champion in chess, and that’s Gukesh for now because he really earned it,” So told The Indian Express. “All these new titles like Freestyle World Champion, or even Rapid and Blitz, or the Total... I think they are just secondary titles.”

So criticized FIDE, the



sport’s governing body, for prioritizing politics and business over tradition. “FIDE is very political. They run it as a business, so they do what’s good for them financially and politically, and everything else is secondary,” he said.

While acknowledging that some fans, particularly in the United States, question the relevance of the classical World Championship, So remains committed to the traditional format. “I’m more old-fashioned. Growing up with all the official World Champions like Fischer, Karpov, Kasparov, I still like the idea that you have

to play a 14-game classical match and go through the process. The champion should have the advantage to wait for the challenger to come,” he said.

The upcoming FIDE Freestyle Chess World Championship, set to be held in Germany in February, has also raised questions about fairness. Neither So nor the previous champions of the format, Hikaru Nakamura and So himself, were invited. The eight-player event will include six qualifiers from the 2025 Freestyle Chess Grand Slam Tour, one player recommended by the organisers, and a final

participant determined through an online qualifier.

So criticized the hand-picking of participants, saying, “To call it a World Championship, and then handpick seven out of eight players, does not seem like a World Championship. Every spot should go through a qualifier.”

He also questioned the accessibility of Freestyle Chess for fans, calling it difficult to follow despite claims of simplicity. “For fans to follow Freestyle is difficult. I myself don’t really follow the games. They have a lot of books about Chess960 and Free-

style, but I wonder who actually reads those,” So said.

While So remains focused on classical chess, he also acknowledged the uncertain future of Freestyle events, suggesting the Weissenhaus tournament in Germany could be the format’s final edition.

In the meantime, So celebrates his first title at the Tata Steel event in Kolkata, achieved on his sixth appearance, while keeping faith in the traditional World Championship as the sport’s ultimate measure of excellence.

Bangladesh Refuses to Play T20 World Cup Matches in India, ICC-BCB Talks Yield No Breakthrough

The deadlock between the International Cricket Council (ICC) and the Bangladesh Cricket Board (BCB) over the venue of Bangladesh’s matches at the ICC Men’s T20 World Cup 2026 continued on Tuesday, with no breakthrough achieved after a video conference between the two sides. Despite detailed discussions, both parties remained firm on their respective positions.

During the meeting held on Tuesday afternoon, the BCB once again reiterated its refusal to send the national team to India, citing security concerns for players, officials, and support staff. The Bangladesh board renewed its request to the ICC to shift Bangladesh’s matches to venues outside India. However, the ICC maintained that the tournament schedule has already been finalised and urged the BCB to reconsider its decision.

In an official statement, the BCB said, “During the discussions, the BCB reaffirmed its position regarding the decision not to



travel to India, citing security concerns. The Board also reiterated its request for the ICC to consider relocating Bangladesh’s matches outside India. While the ICC highlighted that the tournament itinerary has already been announced and requested the BCB to reconsider its stance, the Board’s position remains unchanged. Both parties agreed that discussions will continue to explore possible solutions. The BCB remains

committed to safeguarding the well-being of its players, officials and staff while engaging constructively with the ICC to address the matter.”

The standoff follows a series of formal exchanges between the ICC and the BCB in recent weeks. It is understood that the ICC has shared a detailed security assessment with the Bangladesh board, stating that there is no specific or heightened threat to the Bangladeshi

team while playing in India. Despite this, the BCB has not shifted its stance.

Bangladesh have been placed in Group C of the T20 World Cup 2026 and were scheduled to play their first three matches in Kolkata — against West Indies on February 7, Italy on February 9, and England on February 14. The team was then set to travel to Mumbai to face Nepal in their final group match on February 17.

While the ICC has not is-

sued an official public statement, it is understood that the global body held an internal meeting on Tuesday before conveying its position to the BCB.

Tensions between the two boards escalated earlier after the Board of Control for Cricket in India (BCCI) directed Indian Premier League franchise Kolkata Knight Riders to release Bangladesh pacer Mustafizur Rahman from its 2026 squad. The directive, issued without a public explanation, came amid strained diplomatic relations between India and Bangladesh. Mustafizur, who was bought by KKR for 9.5 crore, was the only Bangladeshi player to be picked at the IPL auction and remains part of Bangladesh’s T20 World Cup squad.

Following his release, Bangladesh’s Information and Broadcasting Ministry banned the telecast of IPL matches in the country, stating that the decision had “hurt and angered” Bangladeshi citizens, further intensifying the dispute.

Ayush Shetty Set for India Open Debut, Eyes Win Over Lakshya Sen in First-Round Clash

Ayush Shetty is gearing up for his debut at the India Open Super 750 tournament, and the young Indian shuttler couldn’t hide his excitement. “It’s my first time at the India Open. I have always wanted to play here. I will be looking for home support even though I’m playing home favourite Lakshya Sen,” Ayush said ahead of Tuesday’s first-round clash at the Indira Gandhi Indoor Stadium.

Currently ranked 32 in men’s singles, Ayush enjoyed a breakthrough season in 2025, capturing the US Open Super 500 title and registering wins against established stars like Chou Tien Chen, Loh Kean Yew, and Kodai Naraoka. Most recently, he defeated local favourite Lee Zii Jia at the Malaysia Open Super 1000, giving him confidence as he prepares to face Lakshya.

Ayush’s journey from a promising junior to a competitive senior player has been challenging. Since winning a bronze at the 2023 Junior World



Championships, he has steadily climbed the ranks. “You have to play so many good players and stay consistent, but I’ve managed to do pretty well. My consistency helped me break into the top 30, and the plan is to enter the top 20 or top 15 in the world,” he said.

Reflecting on his recent quarter-final loss to world number one Shi Yuqi in Malaysia, Ayush noted the lessons learned. “Play-

ing a top player like Shi is very challenging. I had a lead in the first game but he won it. I fought back hard in the second and pushed it to a decider. Physically, he is much stronger, and that made the difference. After that match, I have clarity that I need to improve a lot to compete against the world’s best,” he said.

Alongside competing against top players, Ayush is also adjusting to the

mental demands of high-profile tournaments. “It’s a mental challenge and a new one for me. But I am excited to play in events like the All England and the Super 1000s. Having faced top players already, I know the intensity and how to navigate my way,” he added.

Ayush has also been focusing on building his physical strength, training under Danish legend Peter Gade alongside two-

time Olympic champion Viktor Axelsen. Gade emphasized the need to improve endurance and power. “Ayush is the next Indian shuttler in line. His defence is good, and attack comes naturally. He needs to build a strong base physically to move from top 30-20 into the top 10,” Gade said. Ayush agreed, stating, “There is a lot of room for improvement in endurance and the power part of my game. I’ve been working with Peter and will keep improving over time.”

Tuesday’s clash against Lakshya Sen is set to be a treat for fans, as both come from the Centre for Badminton Excellence (formerly PPBA). “It’s a bit unfortunate that Indian fans will see two of us clashing in the very first round. But I am excited to face him—it’s going to be a good match,” Ayush said. Though Lakshya has won their previous encounters at the Australian and Hong Kong Opens, Ayush is determined to turn the tables this time.

India vs New Zealand 2nd ODI: Rajkot Set for Another Run-Fest on Batting-Friendly Pitch



After an opening ODI that saw the scores push close to the 300-run mark, batting fireworks could be taken to another level when India and New Zealand lock horns in the second One Day International at the Niranjan Shah Stadium in Rajkot on Wednesday. Known for its flat, batter-friendly surfaces, the venue promises another high-scoring contest, especially with two strong batting line-ups in action.

The Rajkot stadium has built a reputation over the years as a paradise for batters, not just in international cricket but also in domestic competitions. India will be playing their first ODI at this venue since September 2023, and all signs point towards another run-fest. With short boundaries and true bounce on offer, bowlers are likely to have a tough time containing runs, particularly in the middle and death overs.

Niranjan Shah Stadium Pitch Report

The pitch at the Niranjan Shah Stadium is widely regarded as one of the flattest tracks in the country. Historically, it has heavily favoured batters, and the numbers back this up. Only four ODIs have been played at the venue so far, but an interesting pattern has emerged — the team batting first has won all four matches since the inaugural ODI in 2013.

In three of those four games, the side batting first posted totals in excess of 300 runs. The lowest first-innings score at the venue remains South Africa’s 270/7 against India in 2015, which still proved enough to

be competitive. The most recent ODI at Rajkot, played just before the 2023 World Cup, saw Australia register a venue-record 352/7 before defeating India by 66 runs. These figures underline the advantage of setting a big target on this surface.

Rajkot Weather Report

Weather conditions on Wednesday are expected to be pleasant, but they could play a subtle role as the match progresses. According to AccuWeather, daytime temperatures are forecast to hover around 28 degrees Celsius, dropping sharply to about 13 degrees in the evening. This significant dip in temperature increases the possibility of dew setting in later in the match, potentially making it tougher for the team bowling second to grip the ball and control their lines.

Alyssa Healy to Retire from International Cricket After India Series, Citing Loss of Competitive Edge



Australia captain and star wicketkeeper-batter Alyssa Healy has announced that she will retire from international cricket following the upcoming India series in February, citing a loss of her “competitive edge” after more than a decade at the highest level.

The 35-year-old, who has had a decorated career with Australia, said that while she has cherished every moment on the field, the constant drive to compete had gradually left her feeling drained. Speaking to reporters in Sydney on Tuesday, Healy reflected on the toll that long-term international cricket can take on a player’s mind and body.

“The timing’s right. I lost a little bit of my competitive edge ... I’ve been doing it a long period of time,” Healy said. “I’ve loved every minute of it, but I felt like every contest I wanted to be a part of, I wanted to compete, and it’s probably drained me a little bit more over the years.”

Healy said she had discussed her decision with her parents and husband, Australia fast bowler Mitchell Starc, before reaching the conclusion that it was the right time to step away from the game. She also acknowledged that while the upcoming T20 World Cup in England

in June offered an opportunity to end her career on a high note, playing when her heart and mind were not fully committed would not have been fair to her teammates or to the country.

“To be completely honest, if I had fought my way through to the World Cup, it’s probably not doing the right thing by my teammates and probably the country as well, to half-ass that opportunity,” Healy said.

Despite her personal achievements on the field, Healy said that witnessing the growth of women’s cricket over the years has been more rewarding than any individual milestones. “It’s probably only today that that’s really hit me, that actually probably means more to me than the runs on the board or the dismissals. It’s about growing the game and inspiring the next generation,” she added.

Healy will finish her international career after the series against India, which will include three T20Is, three ODIs, and one Test match, starting with the first T20I at the Sydney Cricket Ground on February 15. Her retirement marks the end of an era for Australian women’s cricket, but her legacy as a player and ambassador for the game is set to continue.
